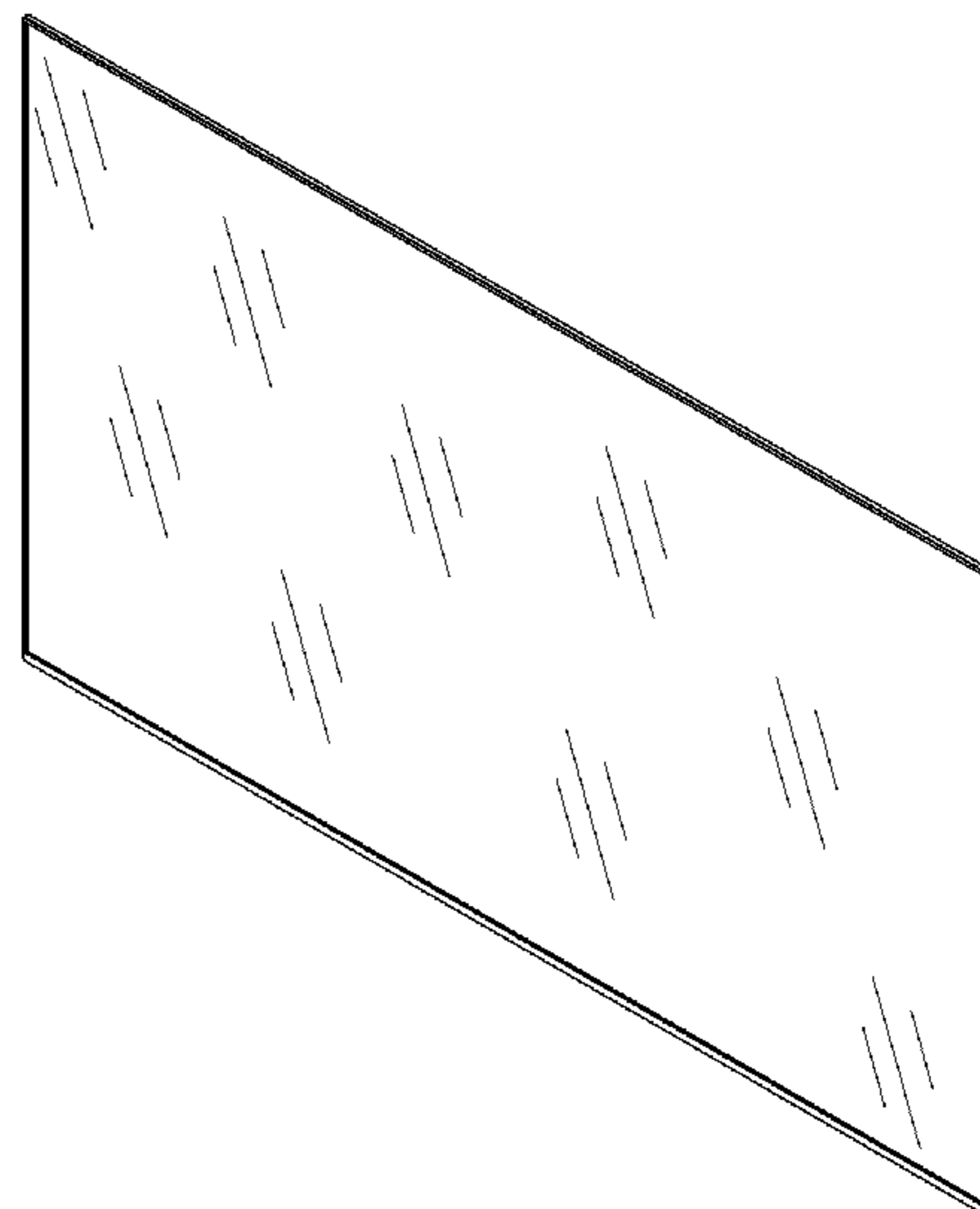
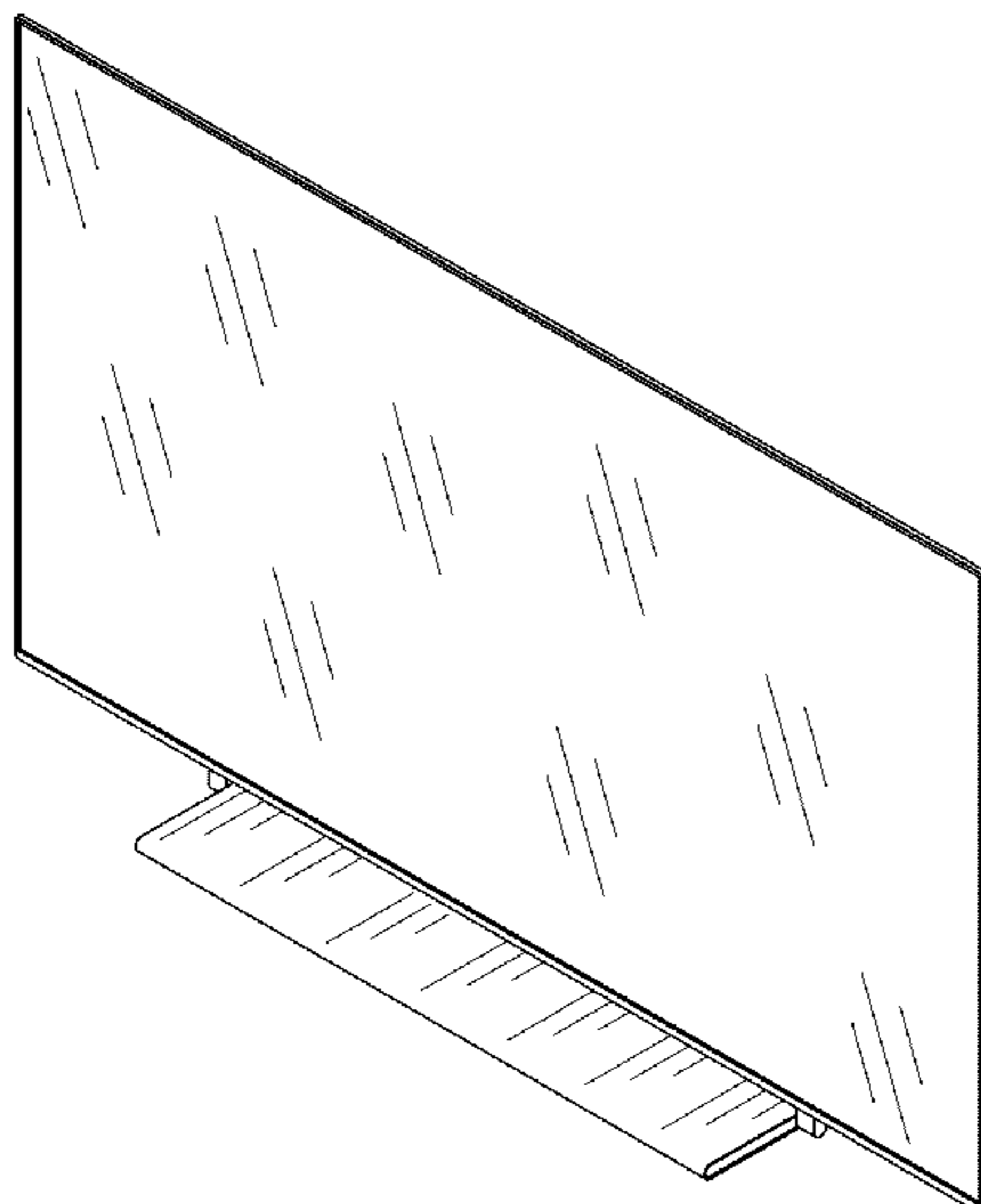
(57) **CLAIM**

The design for a television, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first state of the television; FIG. 2 is a front elevated view of the first state of the television; FIG. 3 is a rear elevated view of the first state thereof; FIG. 4 is a left side elevated view of the first state thereof; FIG. 5 is a right side elevated view of the first state thereof; FIG. 6 is a top plan view of the first state thereof; FIG. 7 is a bottom plan view of the first state thereof; and FIG. 8 is a perspective view of a second state of the television; FIG. 9 is a front elevated view thereof; FIG. 10 is a rear elevated view thereof; FIG. 11 is a left side elevated view thereof; FIG. 12 is a right side elevated view thereof; FIG. 13 is a top plan view thereof; and, FIG. 14 is a bottom plan view thereof.

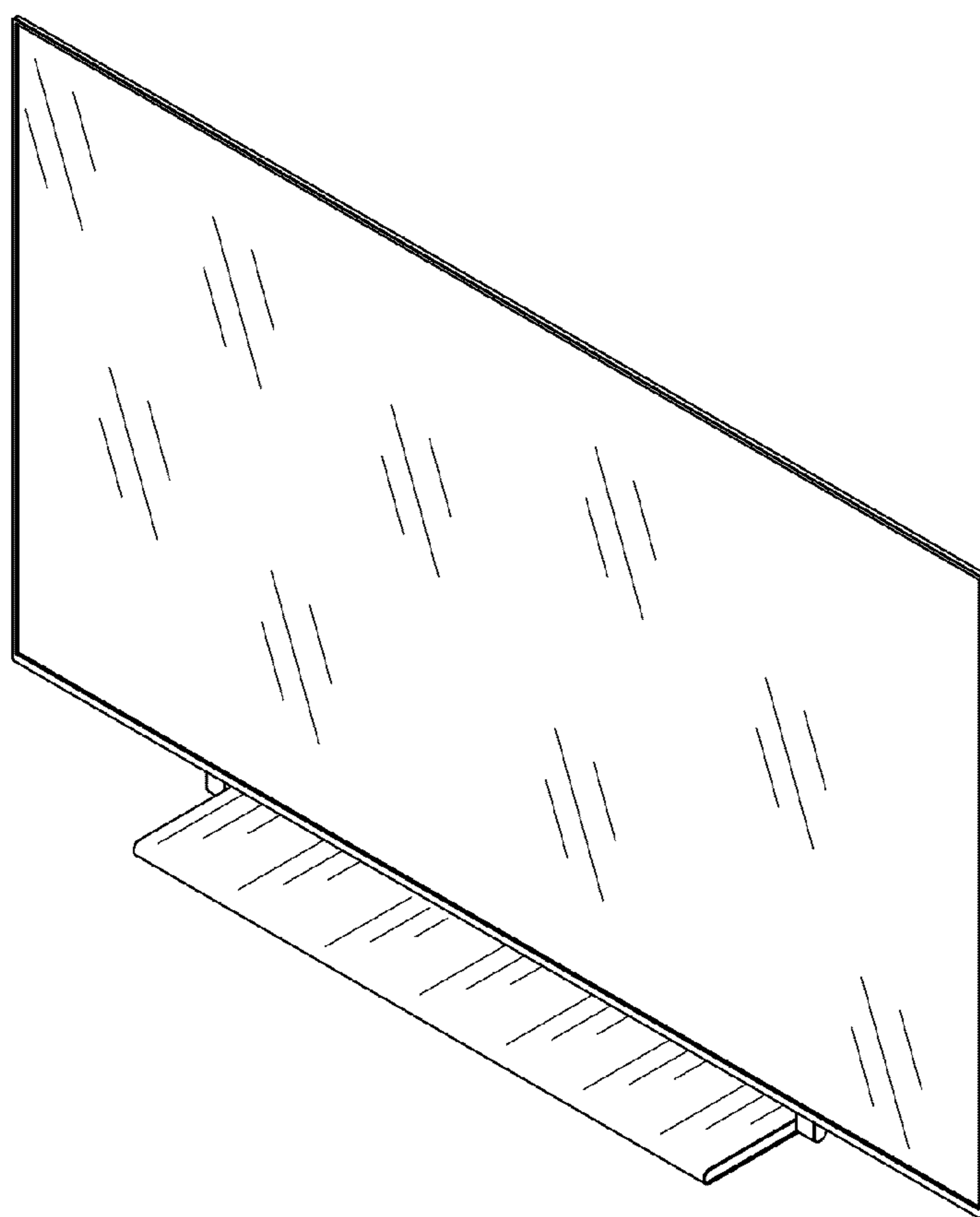

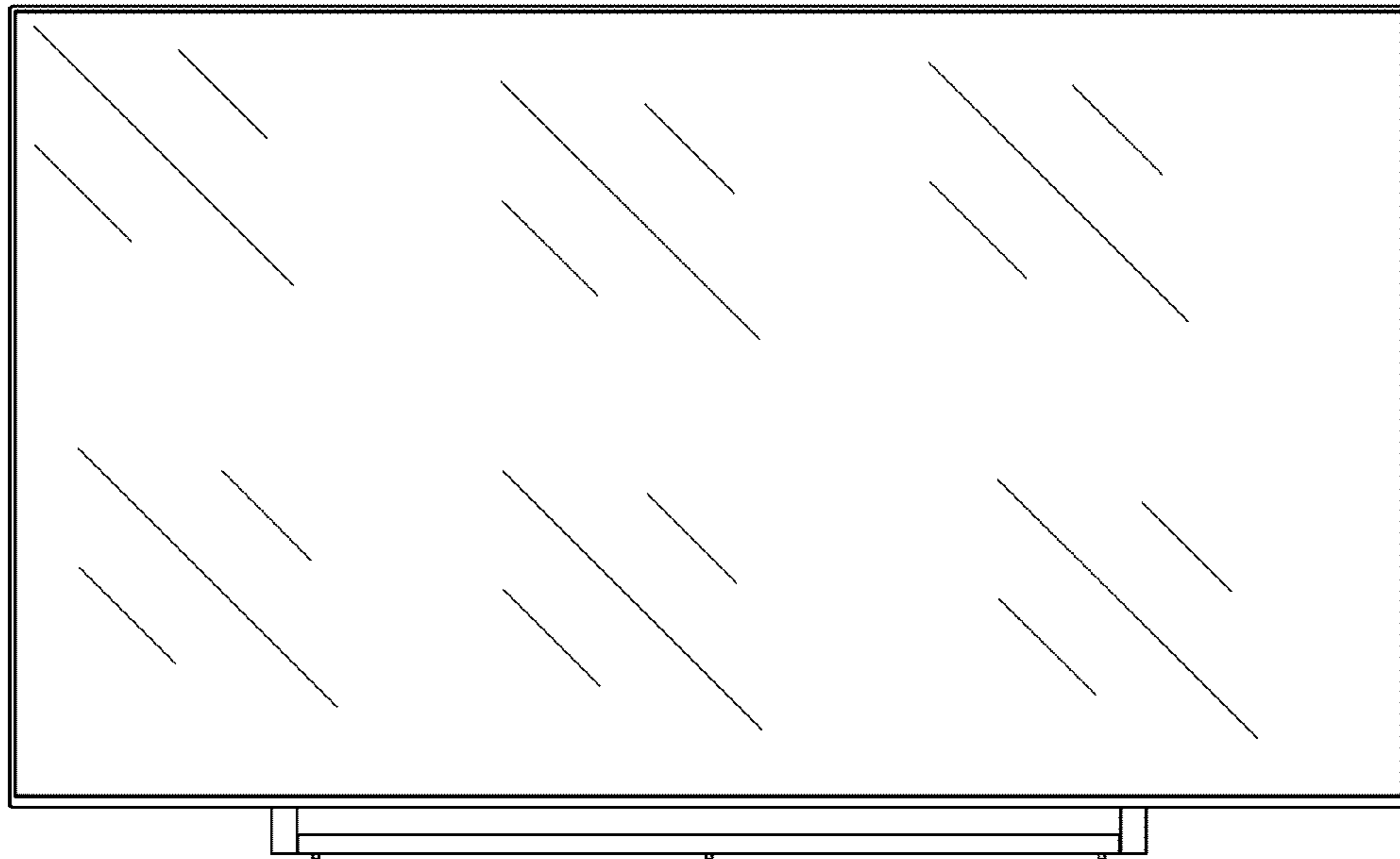

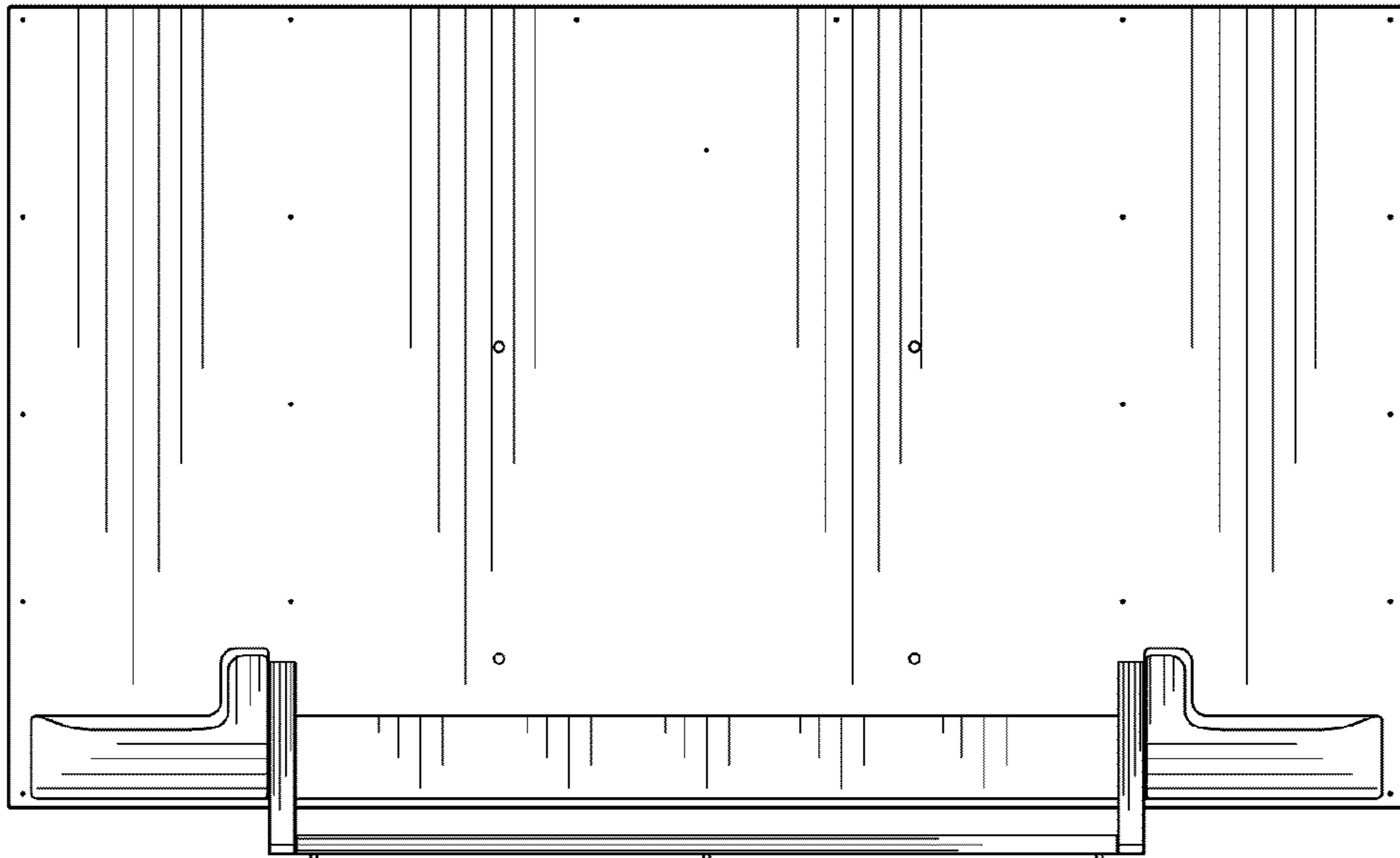

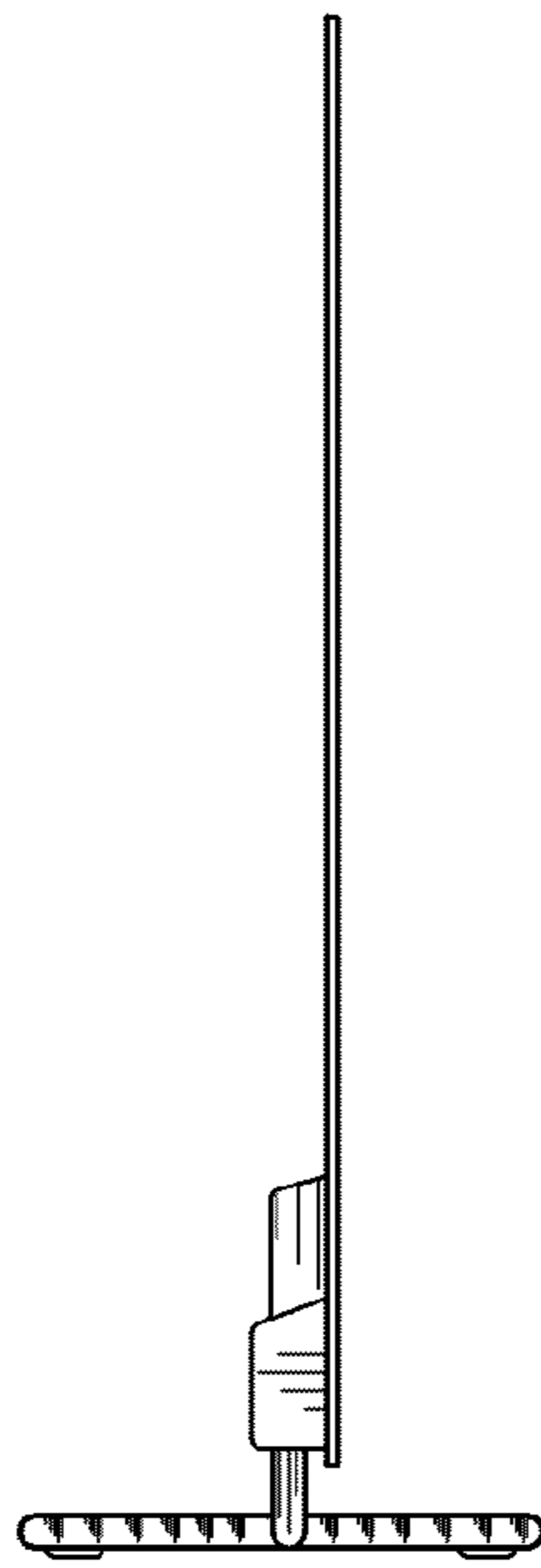

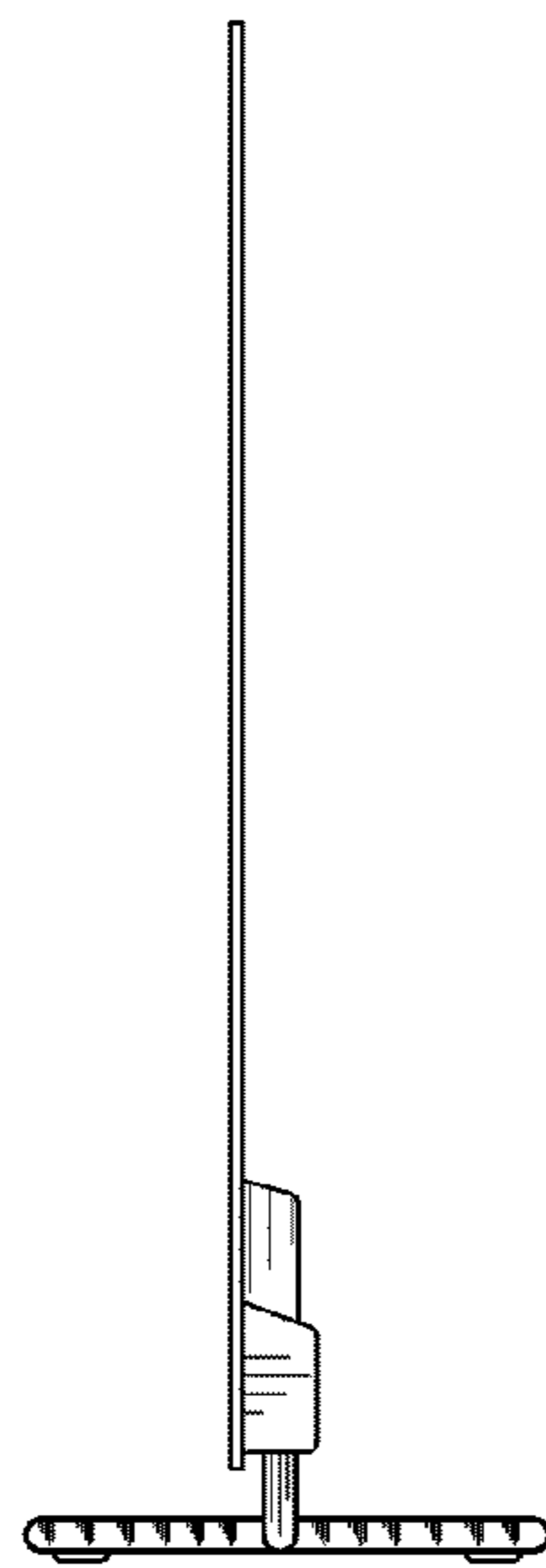

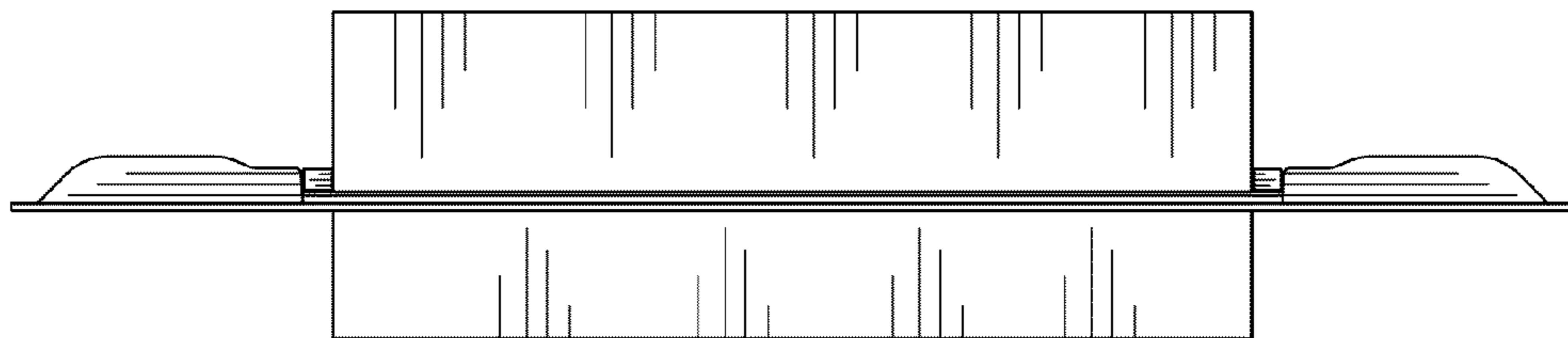

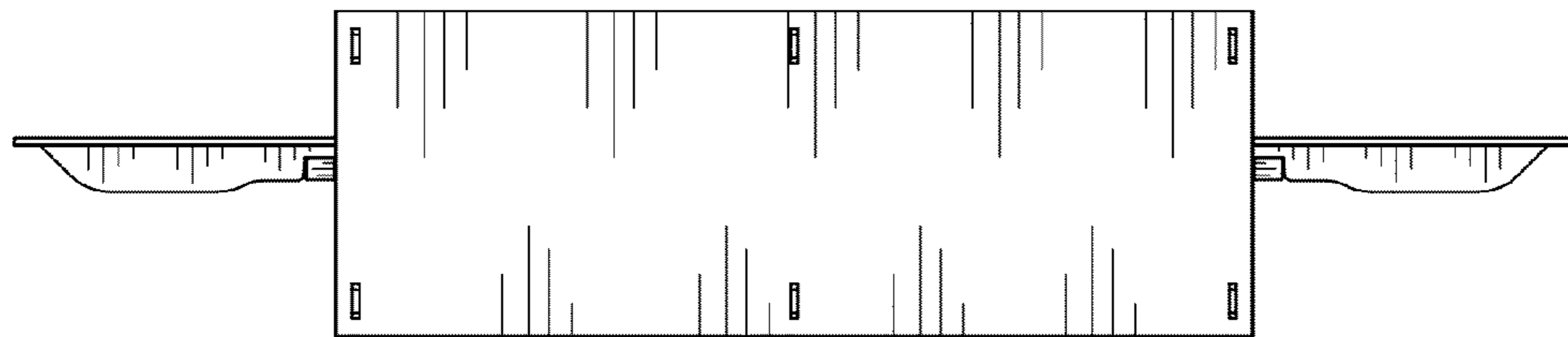

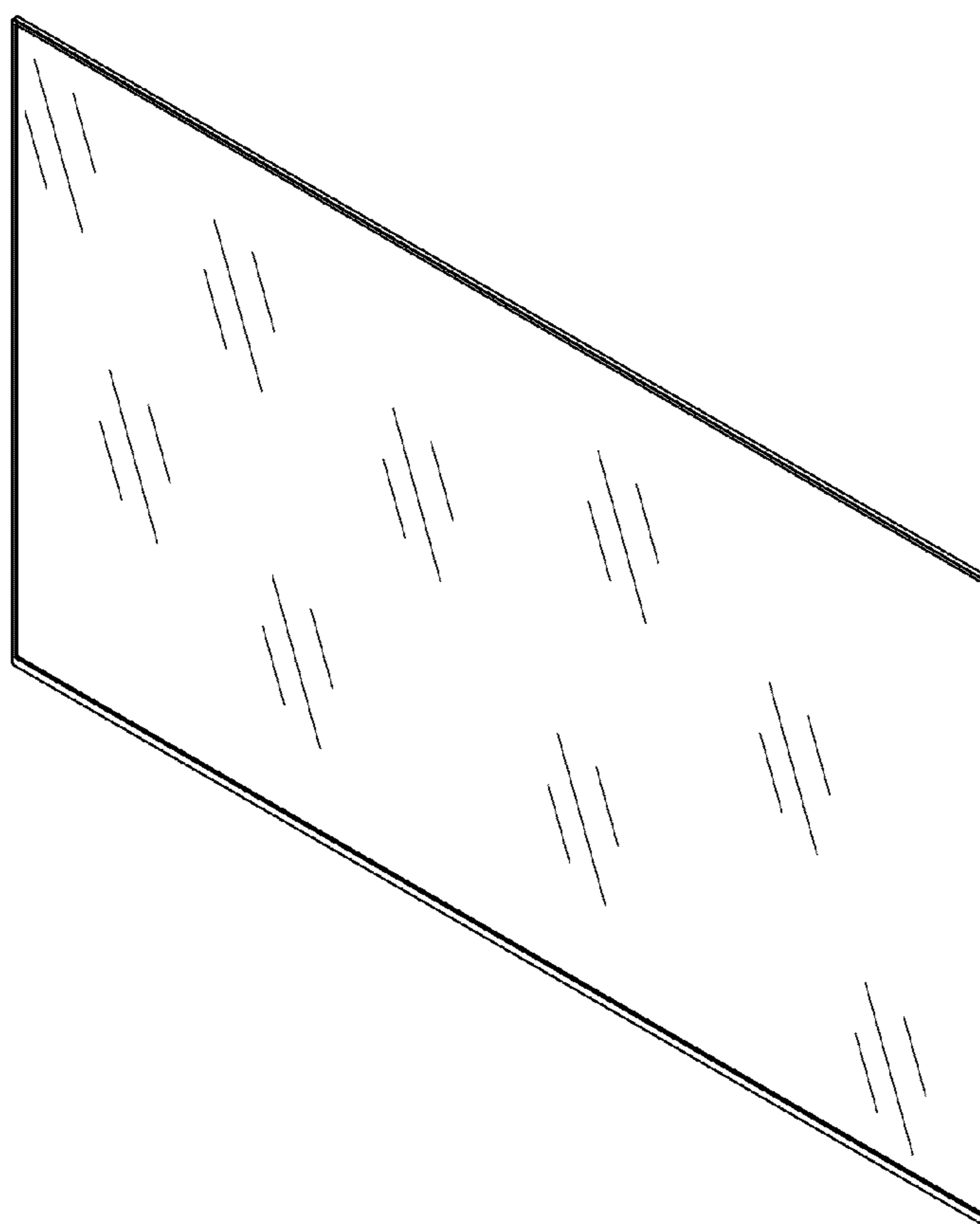

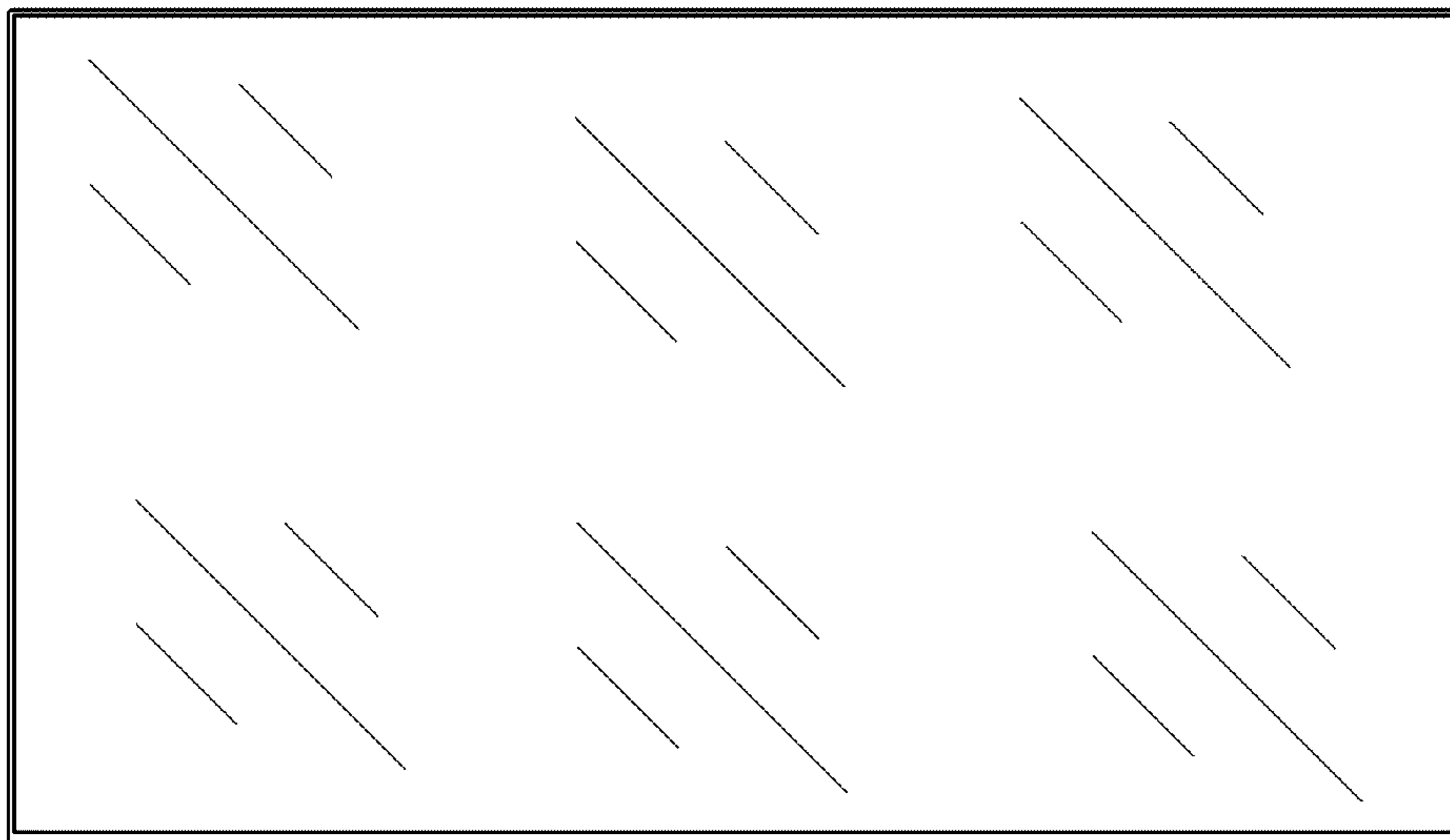

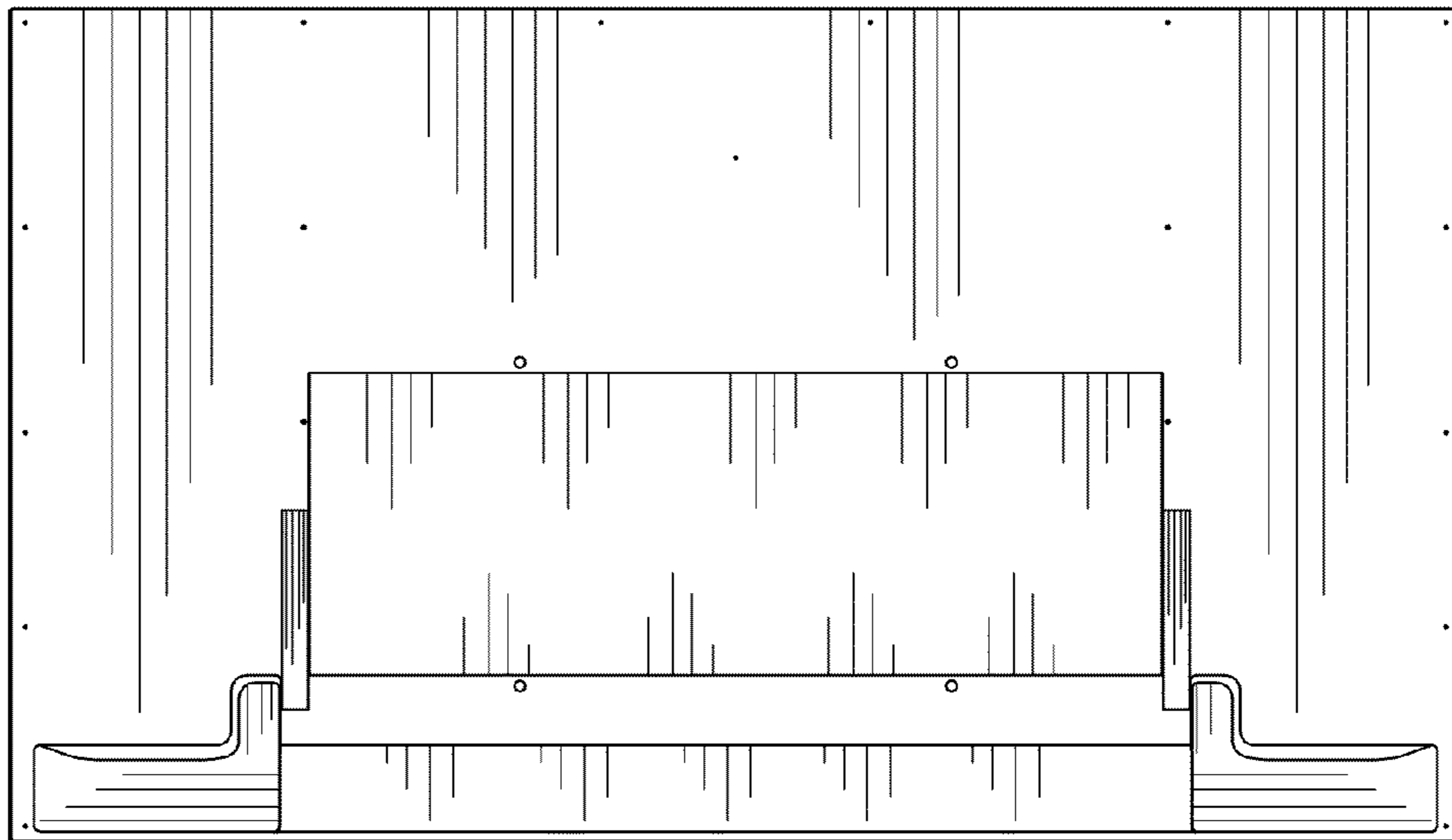

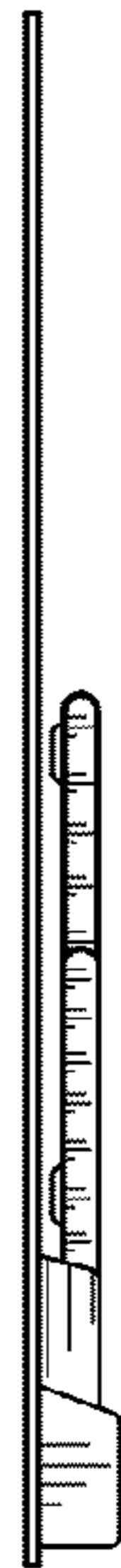

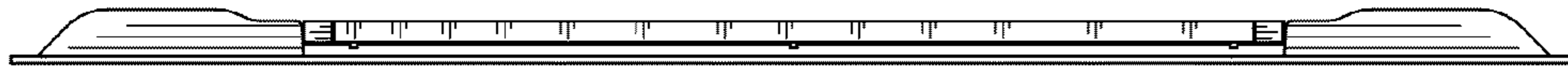

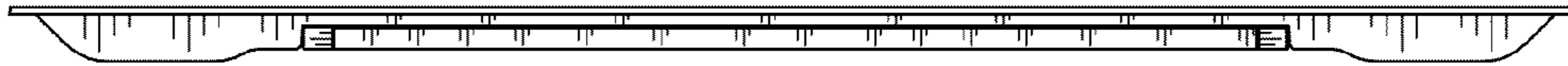
