(57) **CLAIM**

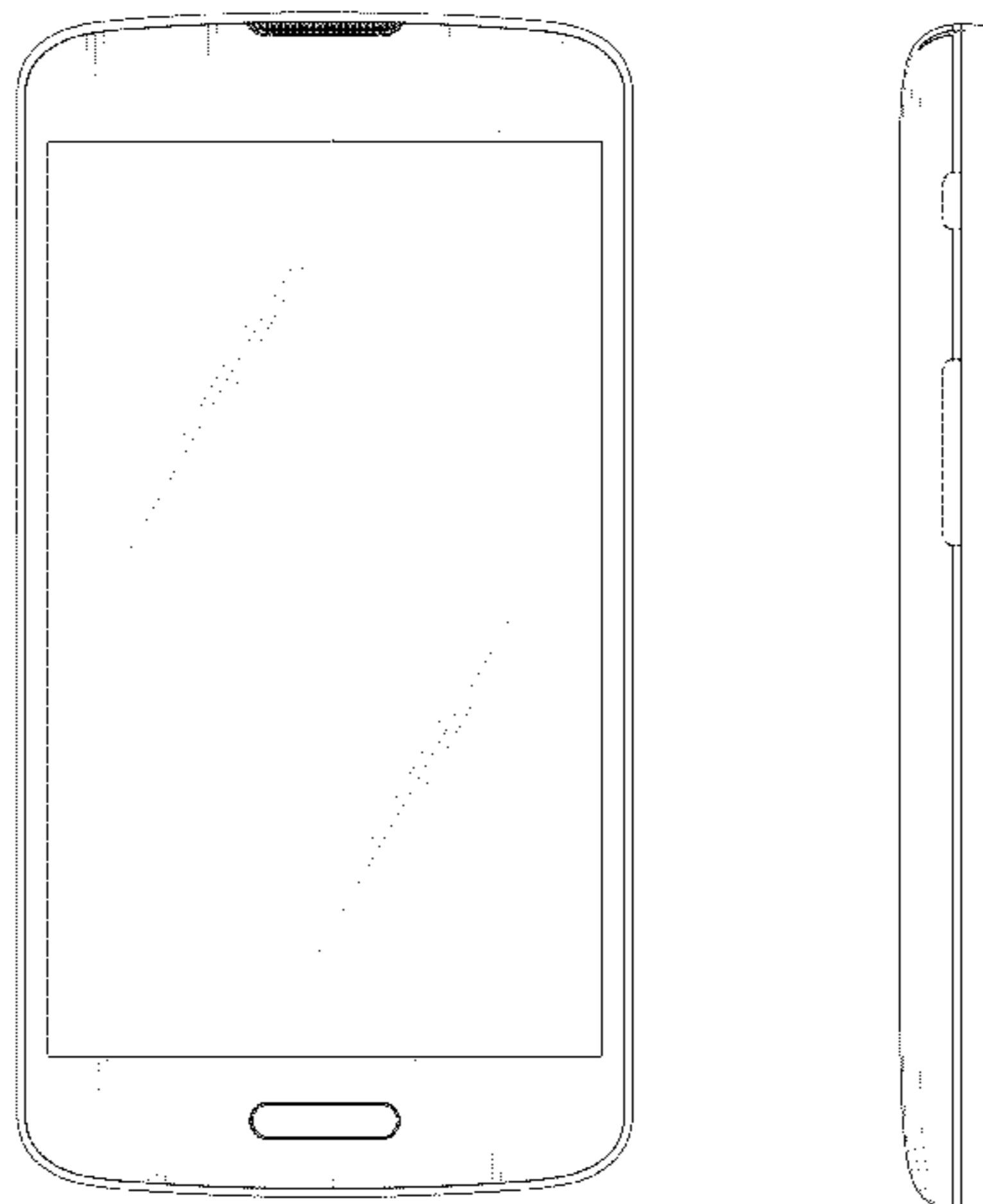
The ornamental design for a cellular phone, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side, perspective view of a cellular phone showing our new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top view thereof; and; FIG. 7 is a bottom view thereof; and, FIG. 8 is a front, right side, perspective view thereof showing the state of using.

The broken lines shown in the figures that are immediately adjacent to the shaded areas and define unshaded regions represent the bounds of the claim. All other broken lines, including the features within broken line boundaries and the broken lines on the front surface to the right and left of the speaker are directed to environment. The broken lines form no part of the claimed design.

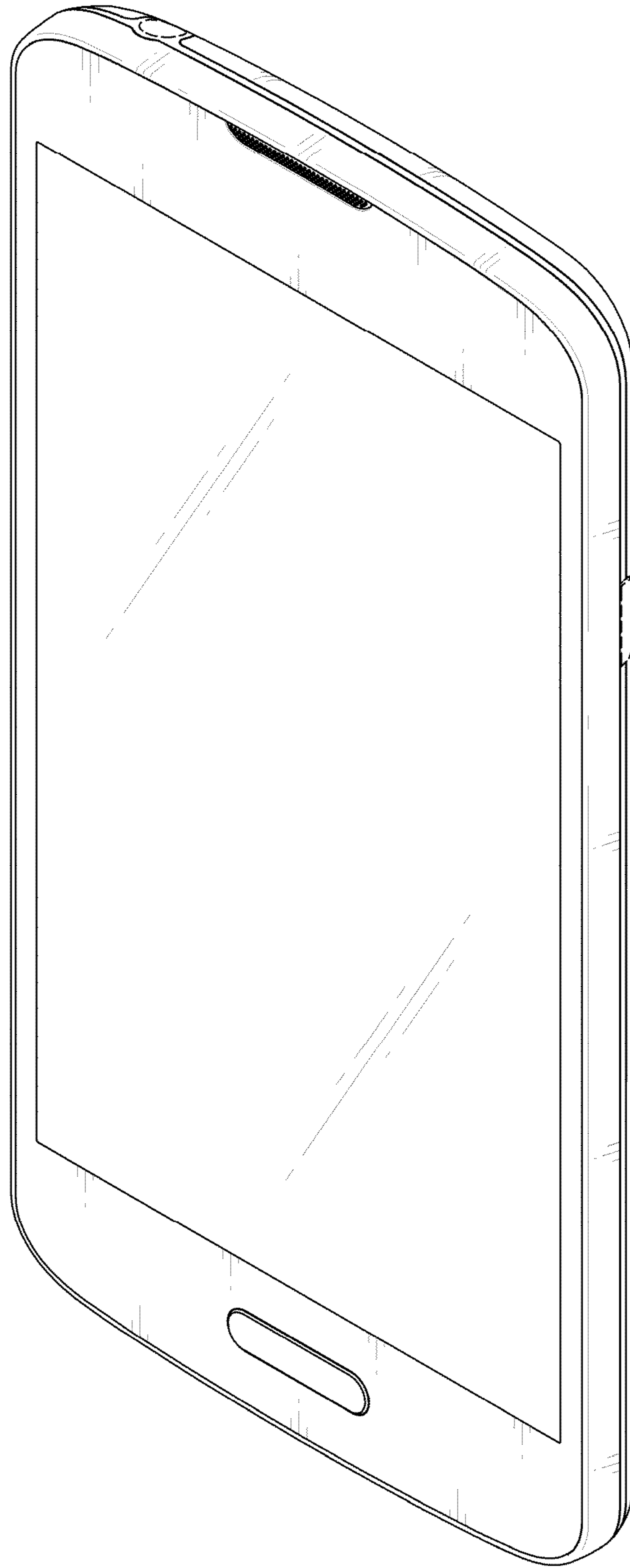

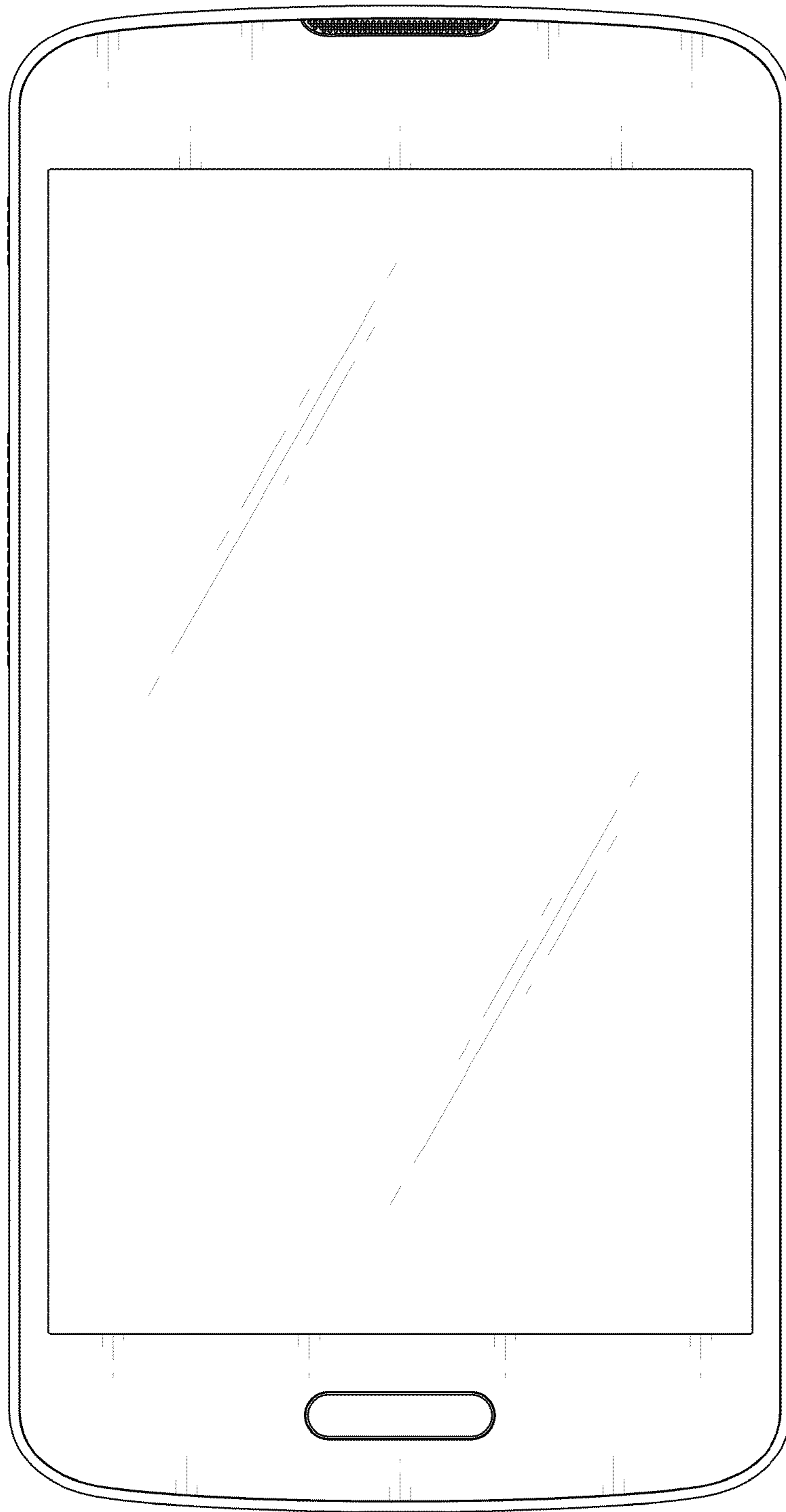

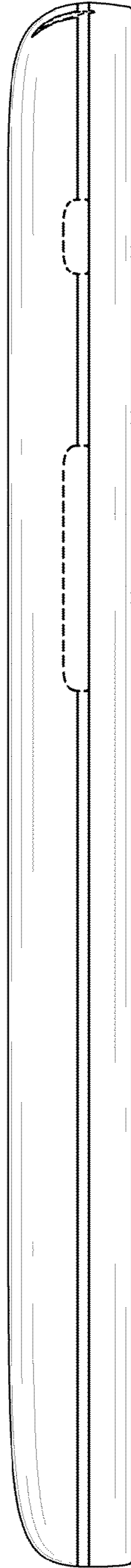

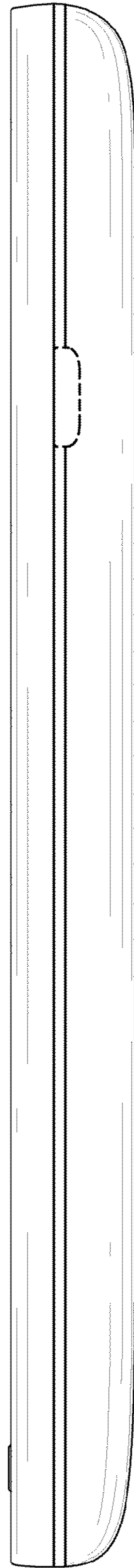

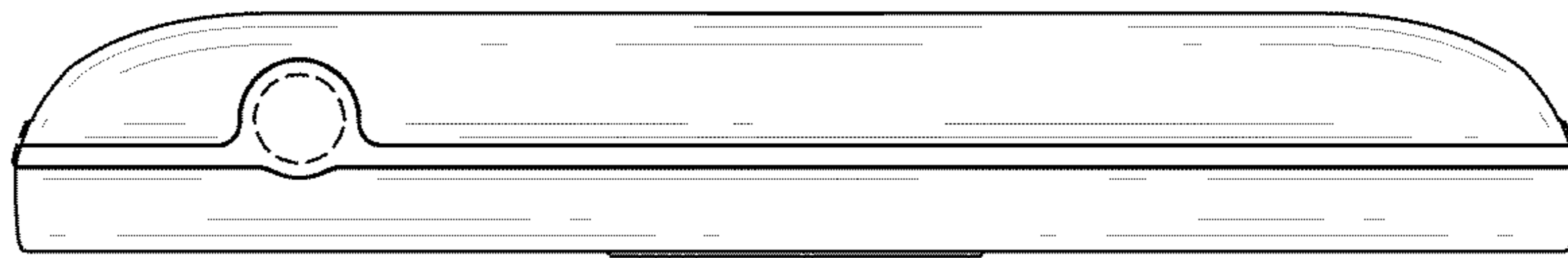

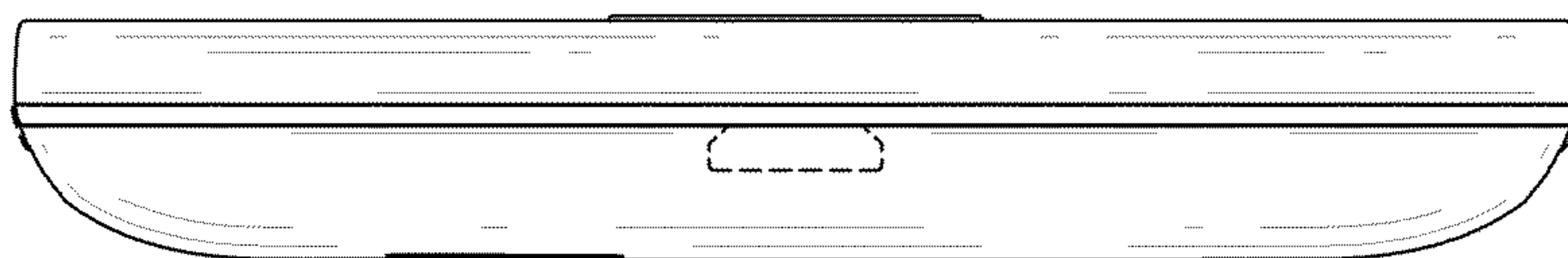
