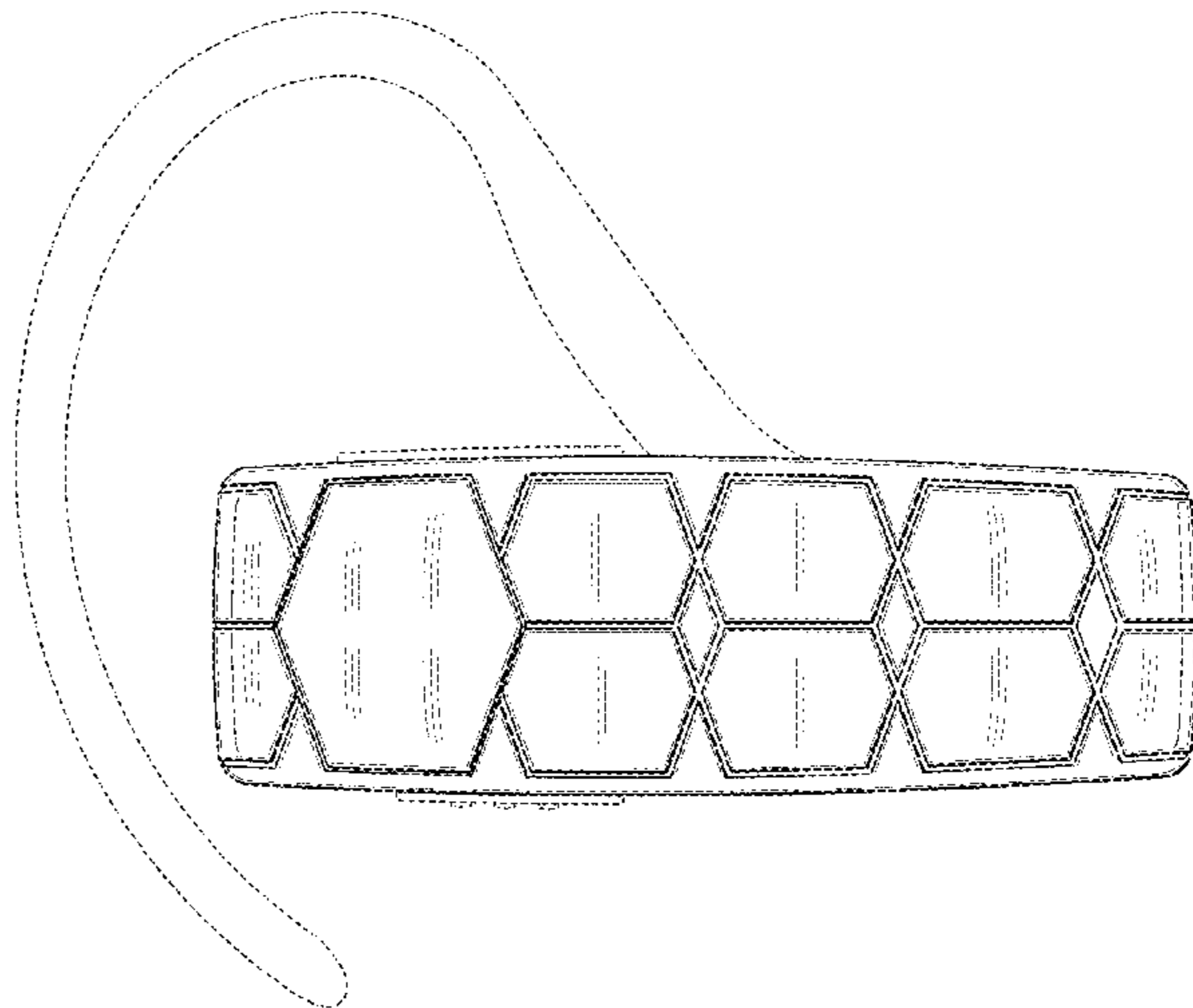
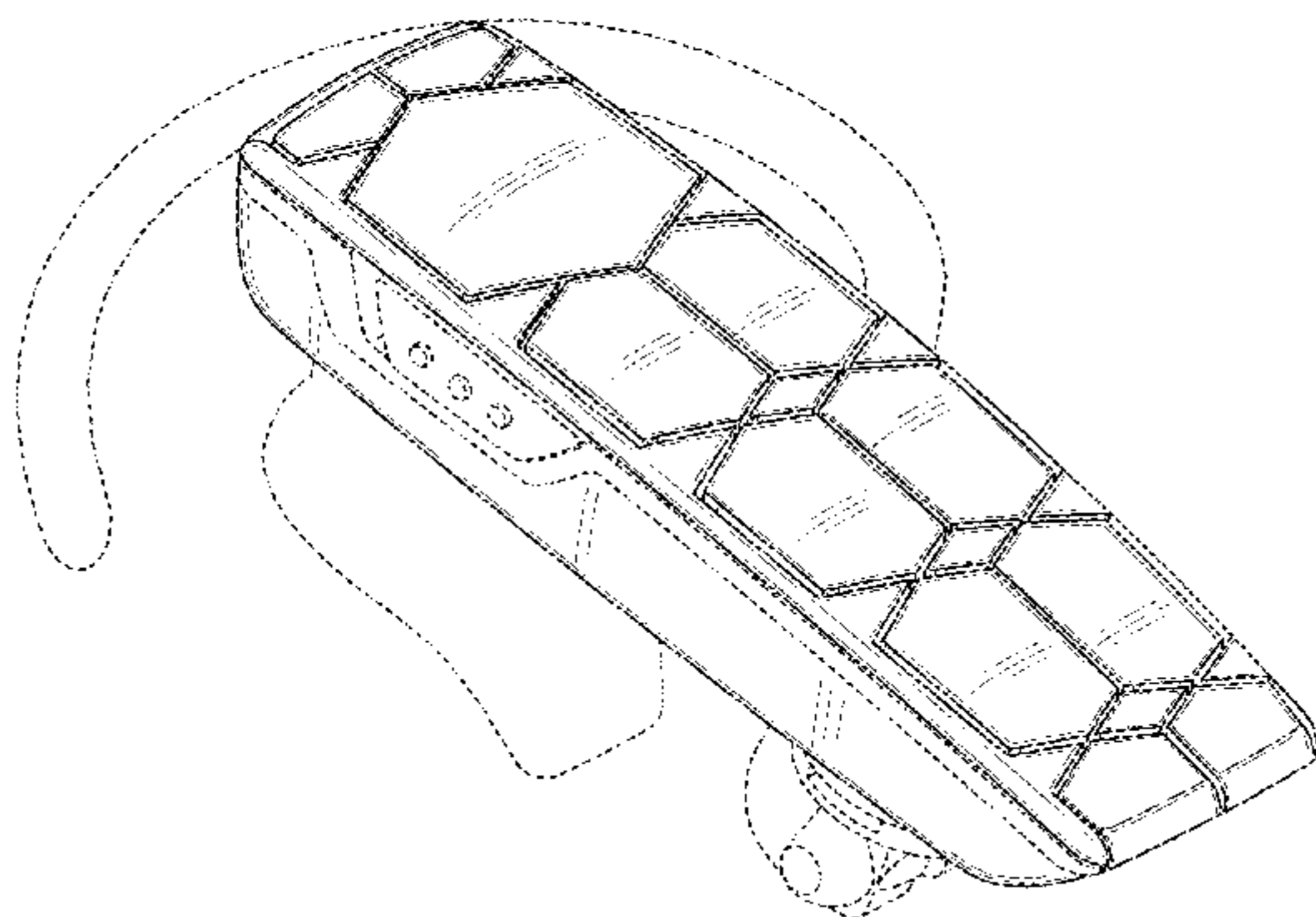
The ornamental design for a communications headset, as shown and described.

**DESCRIPTION**

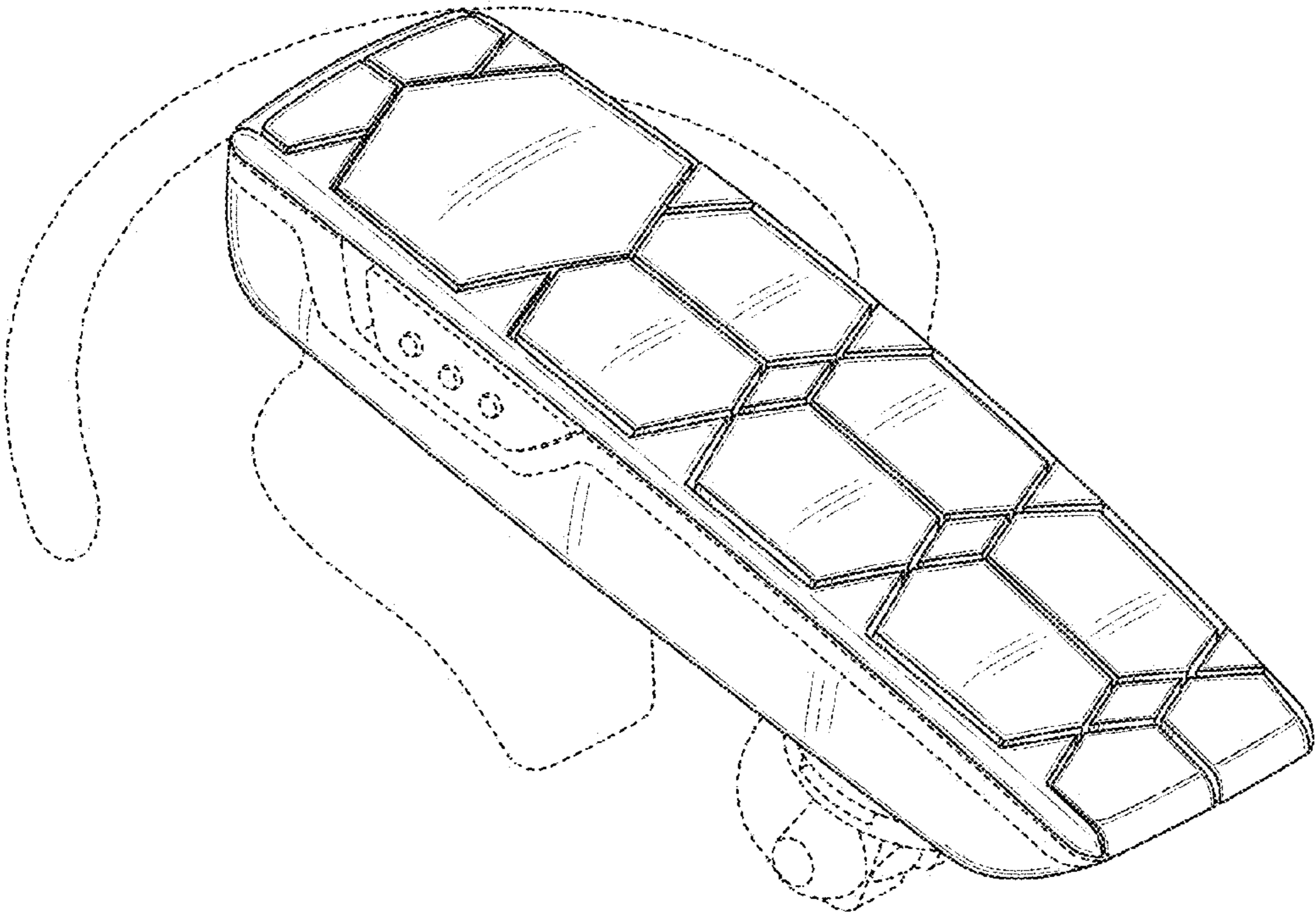

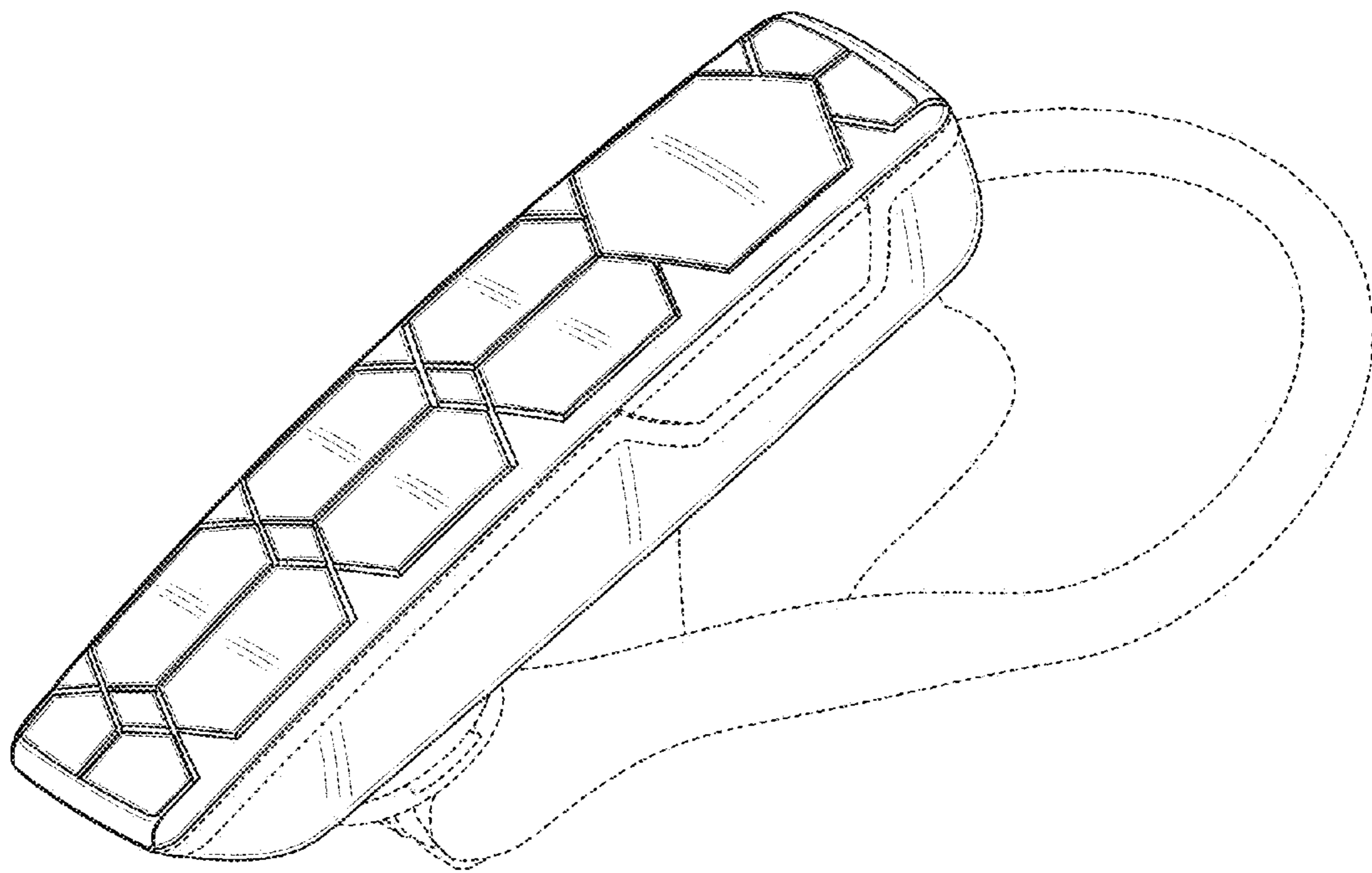

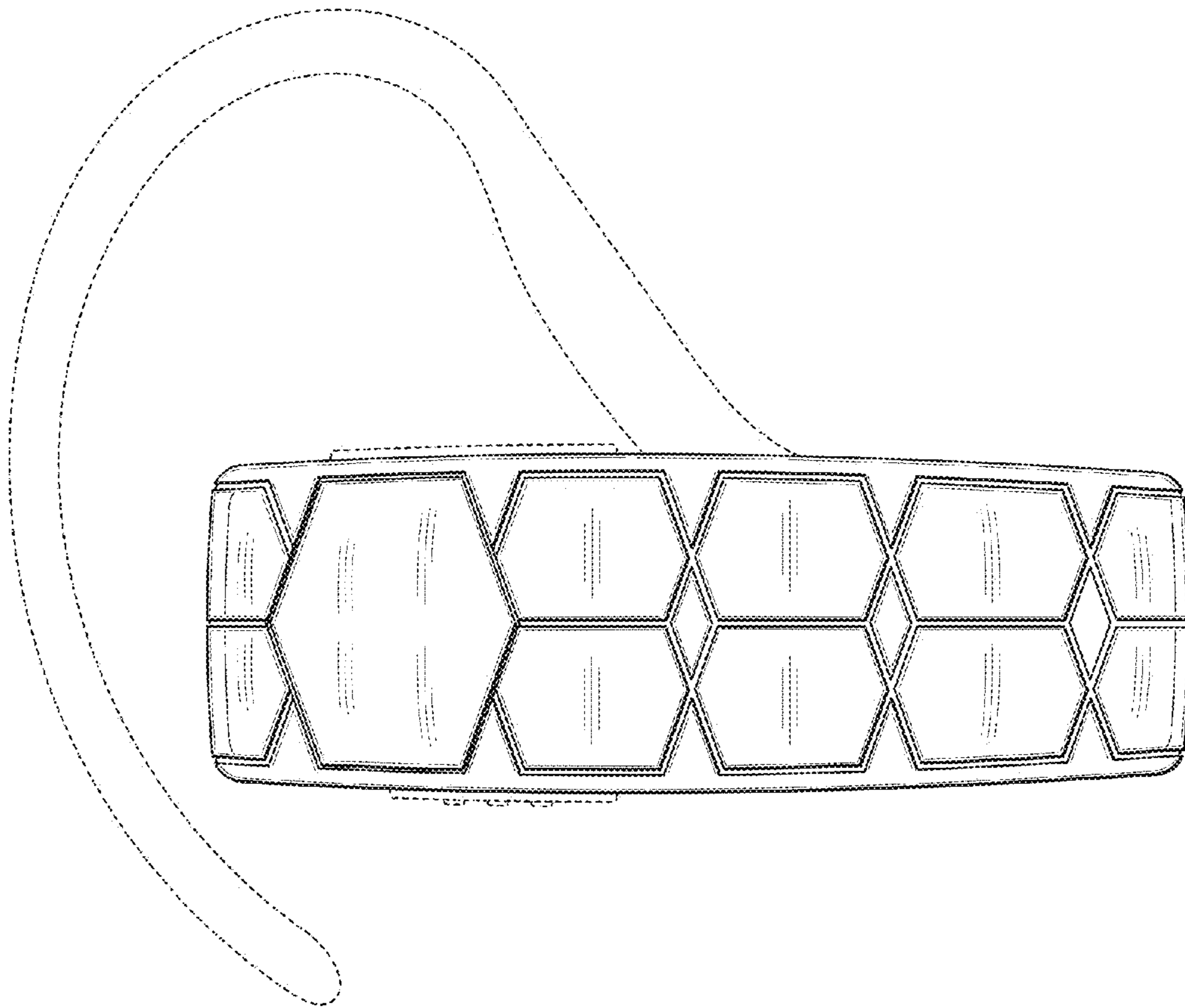

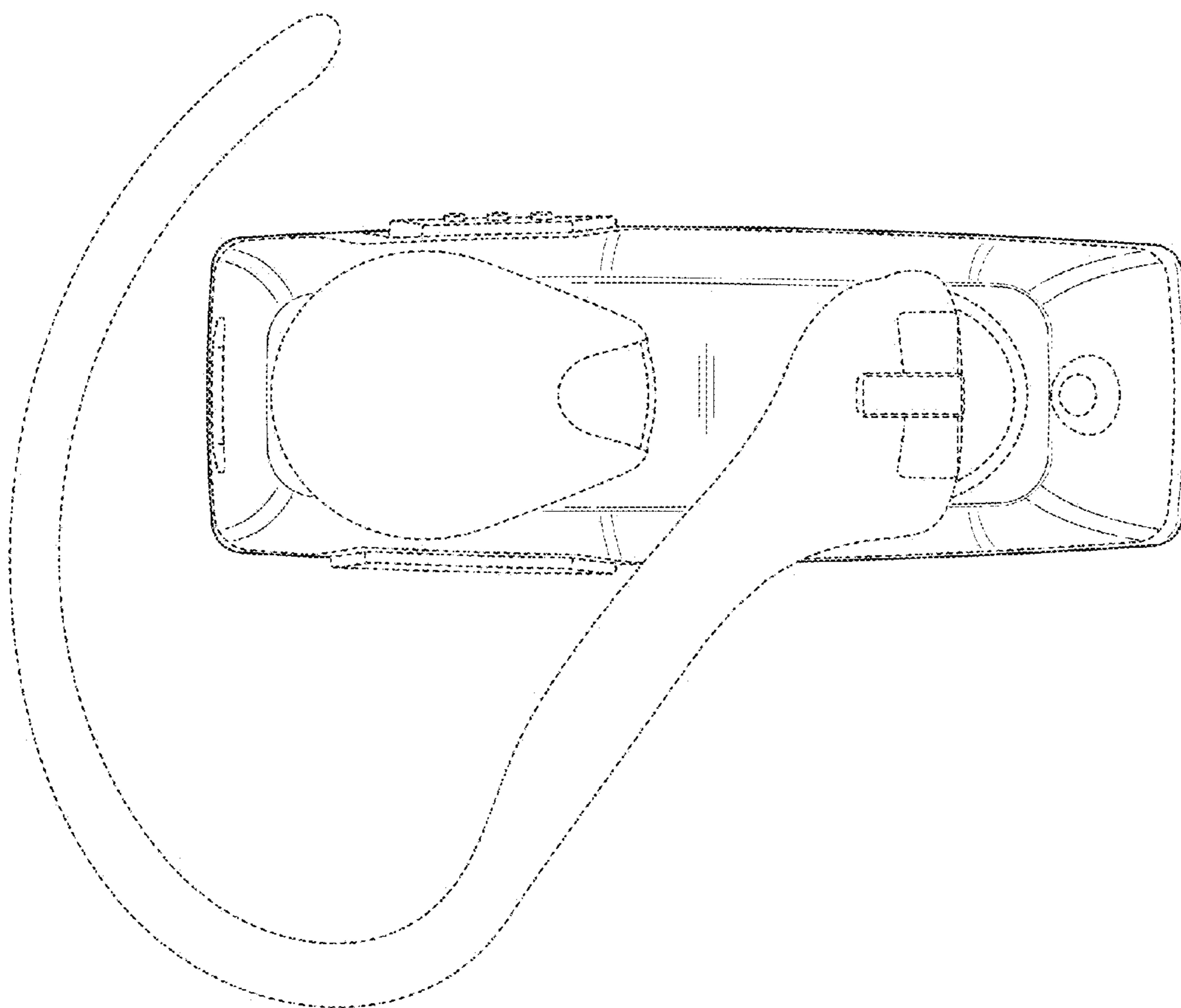

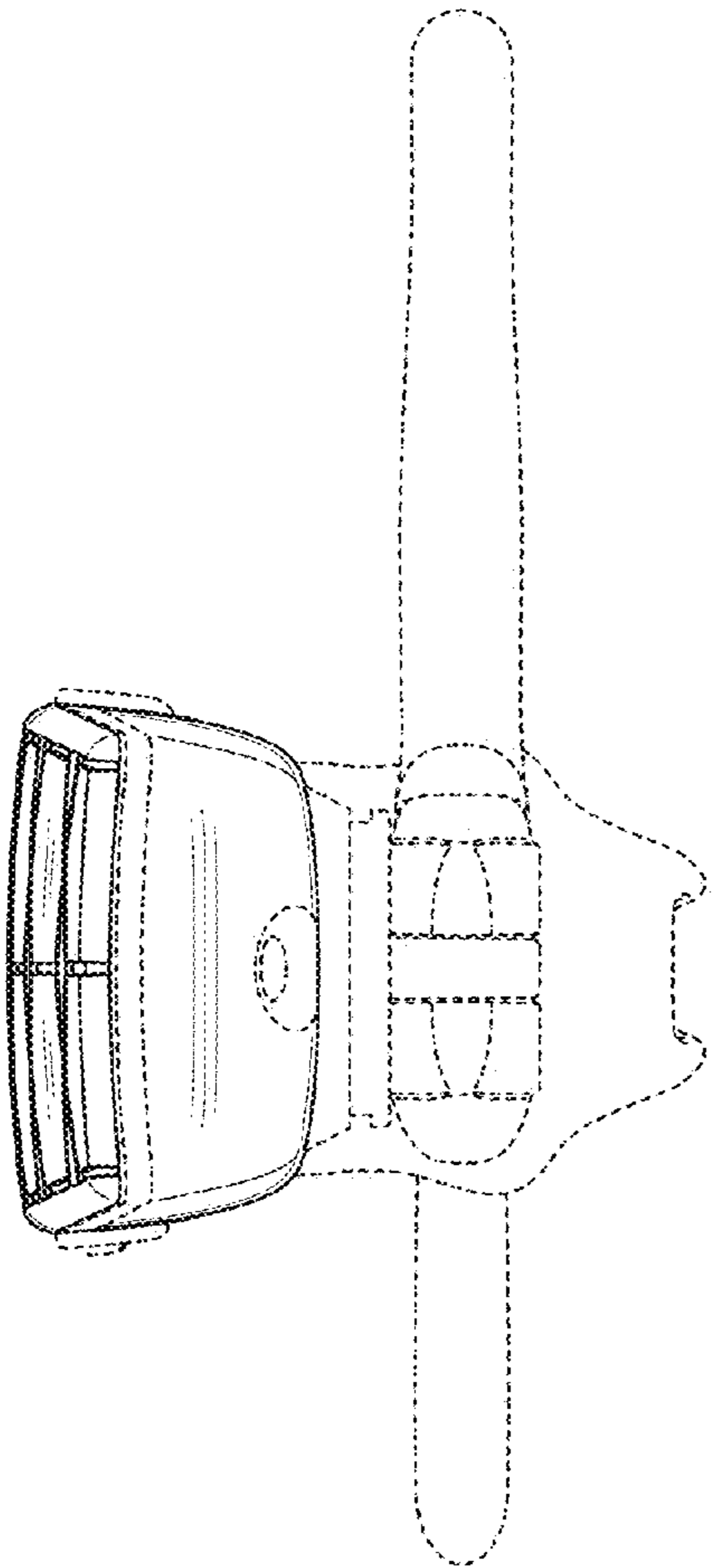

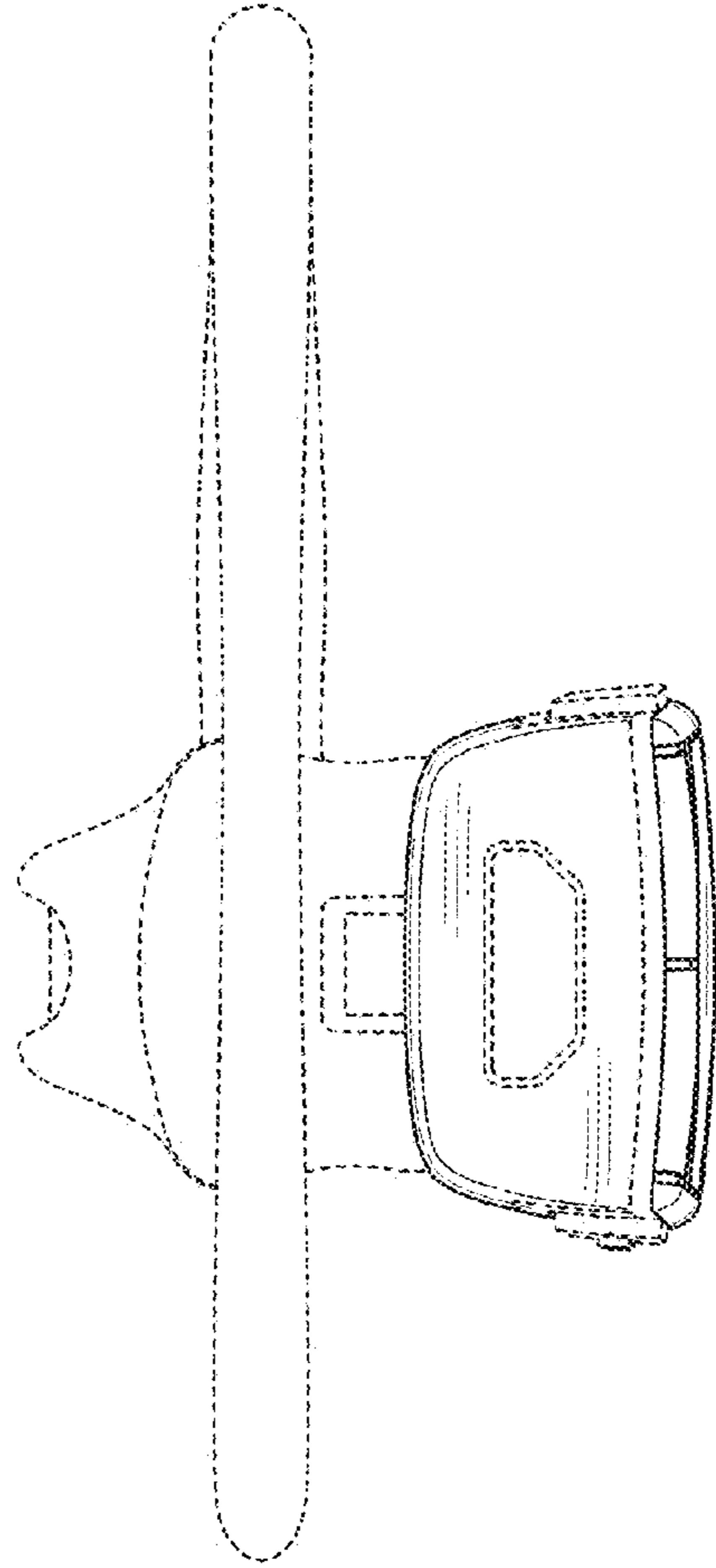

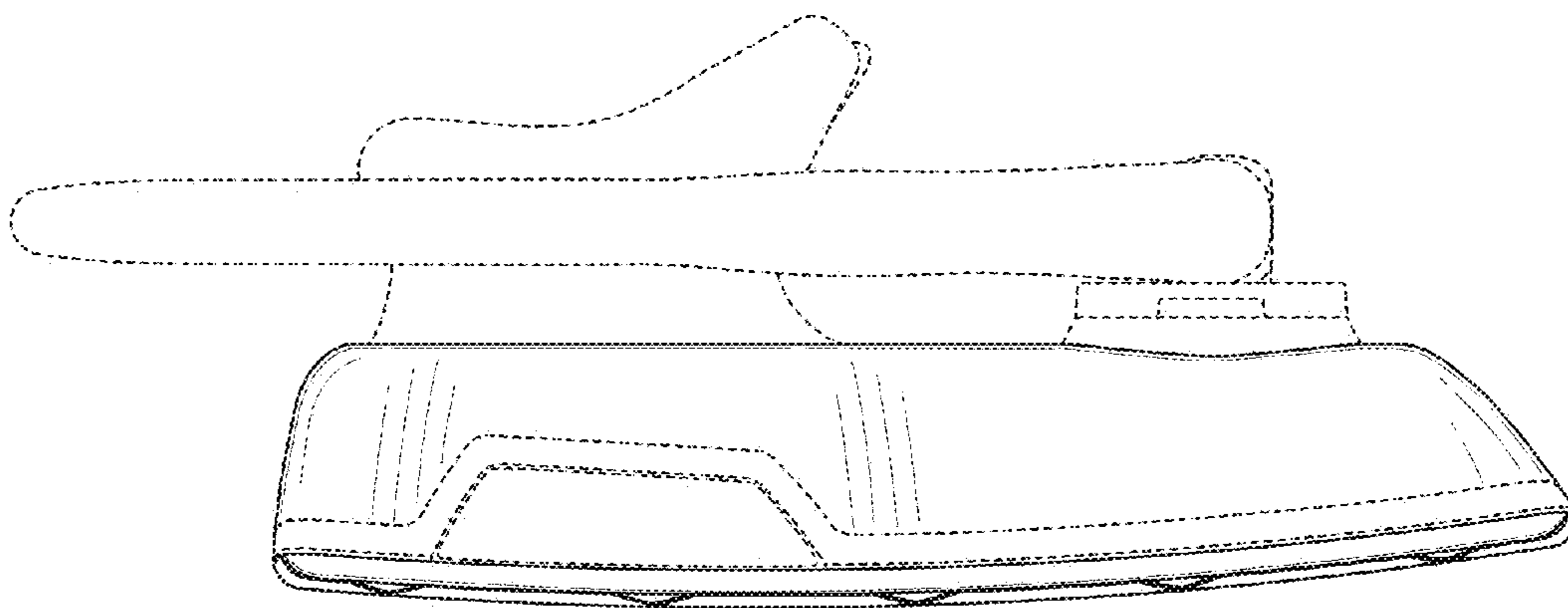

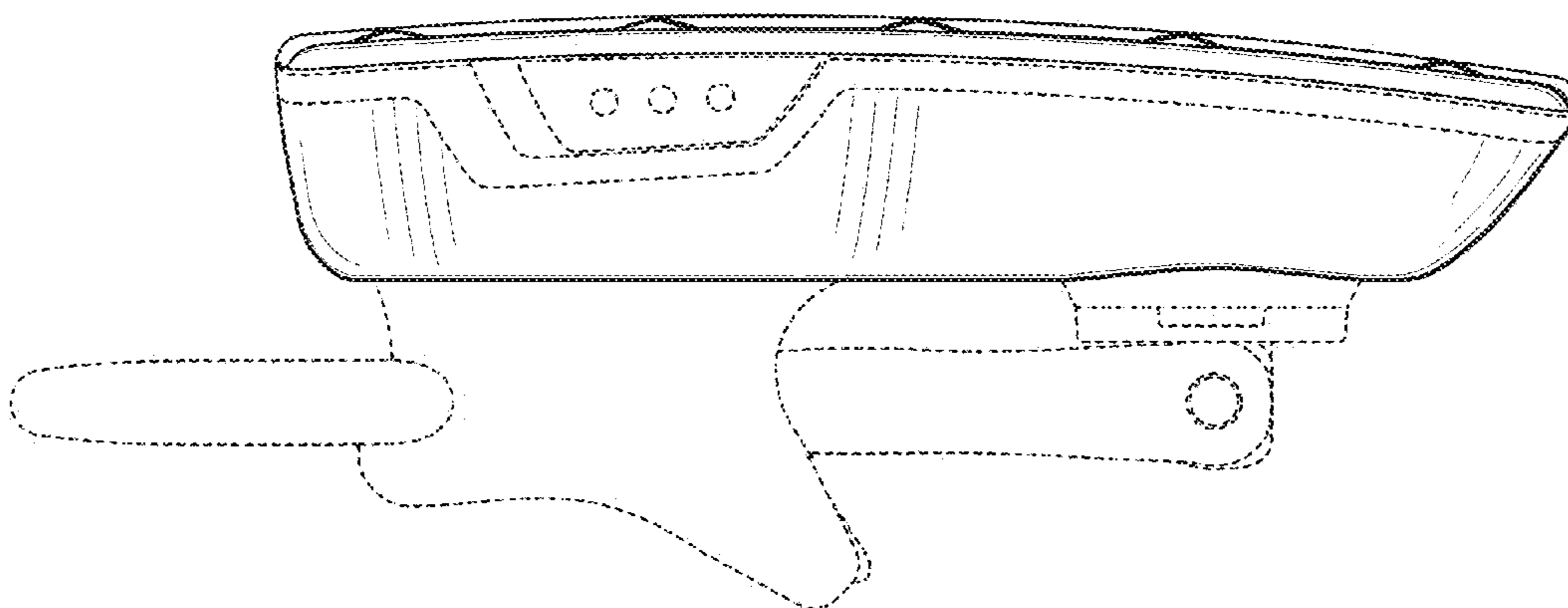
