DESCRIPTION

FIG. 1 is a front perspective view of a cover for mobile phone showing our new design;

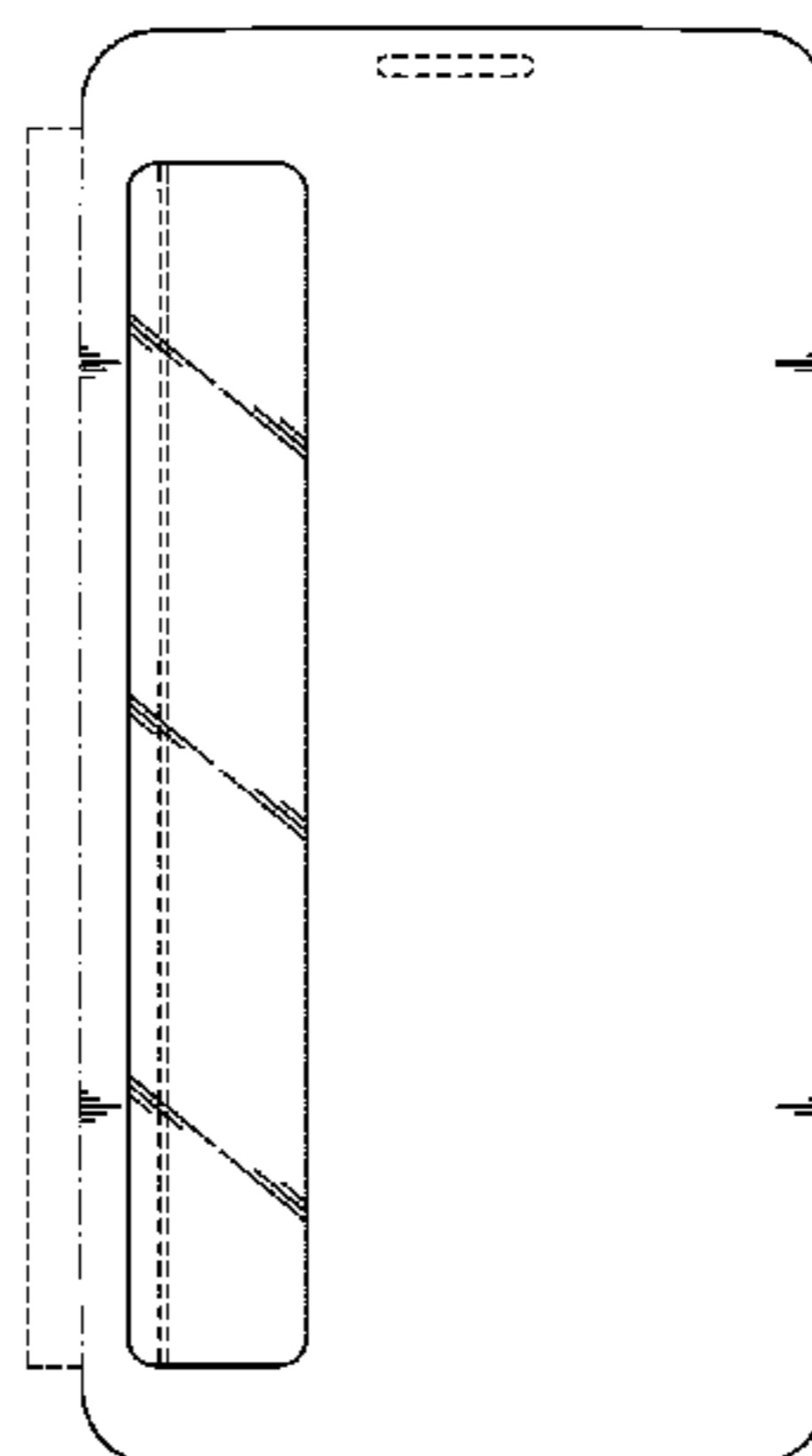
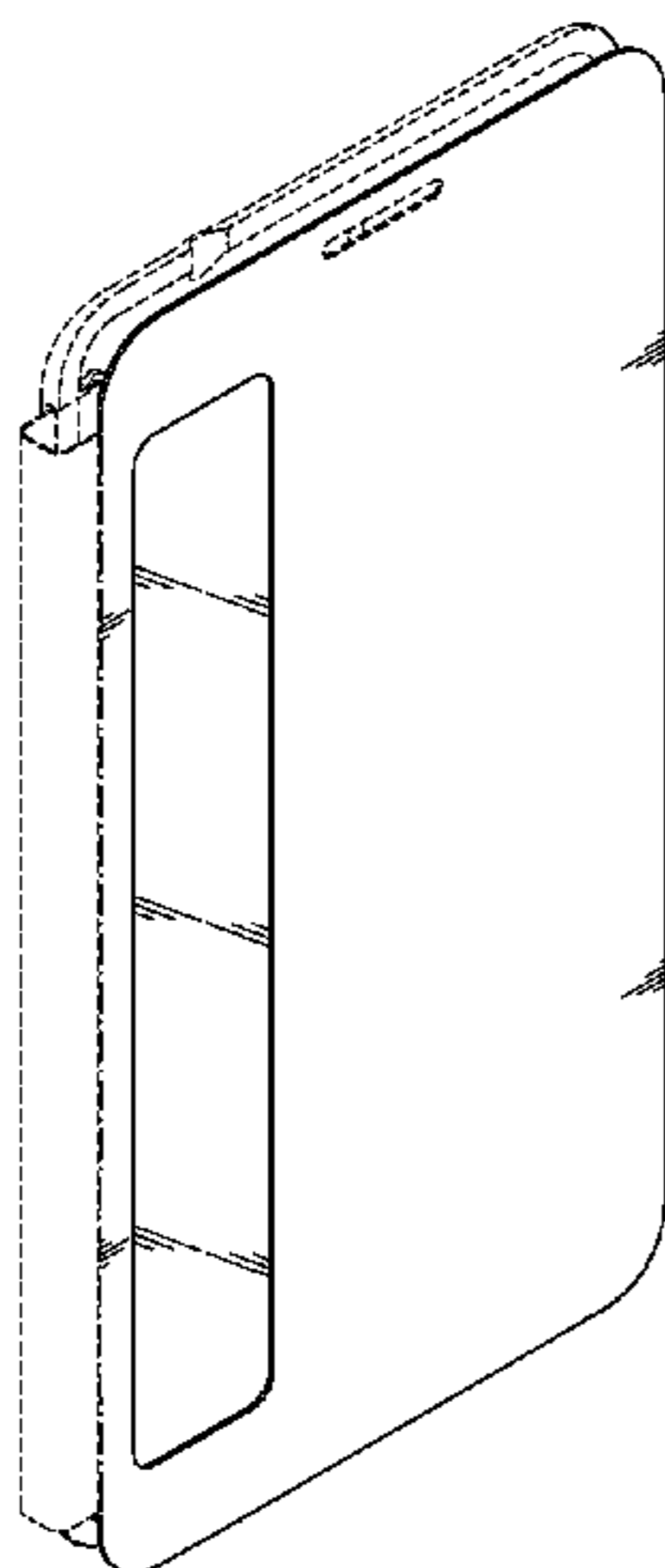

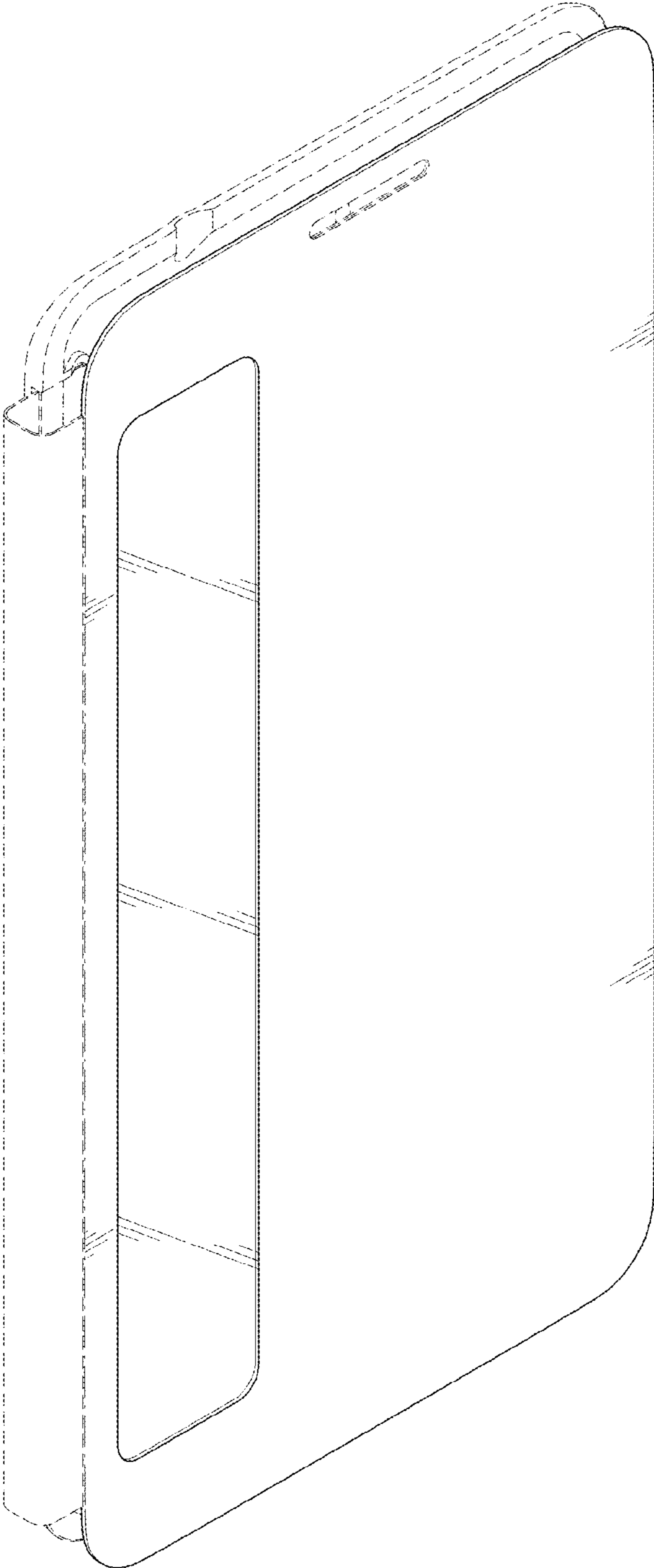

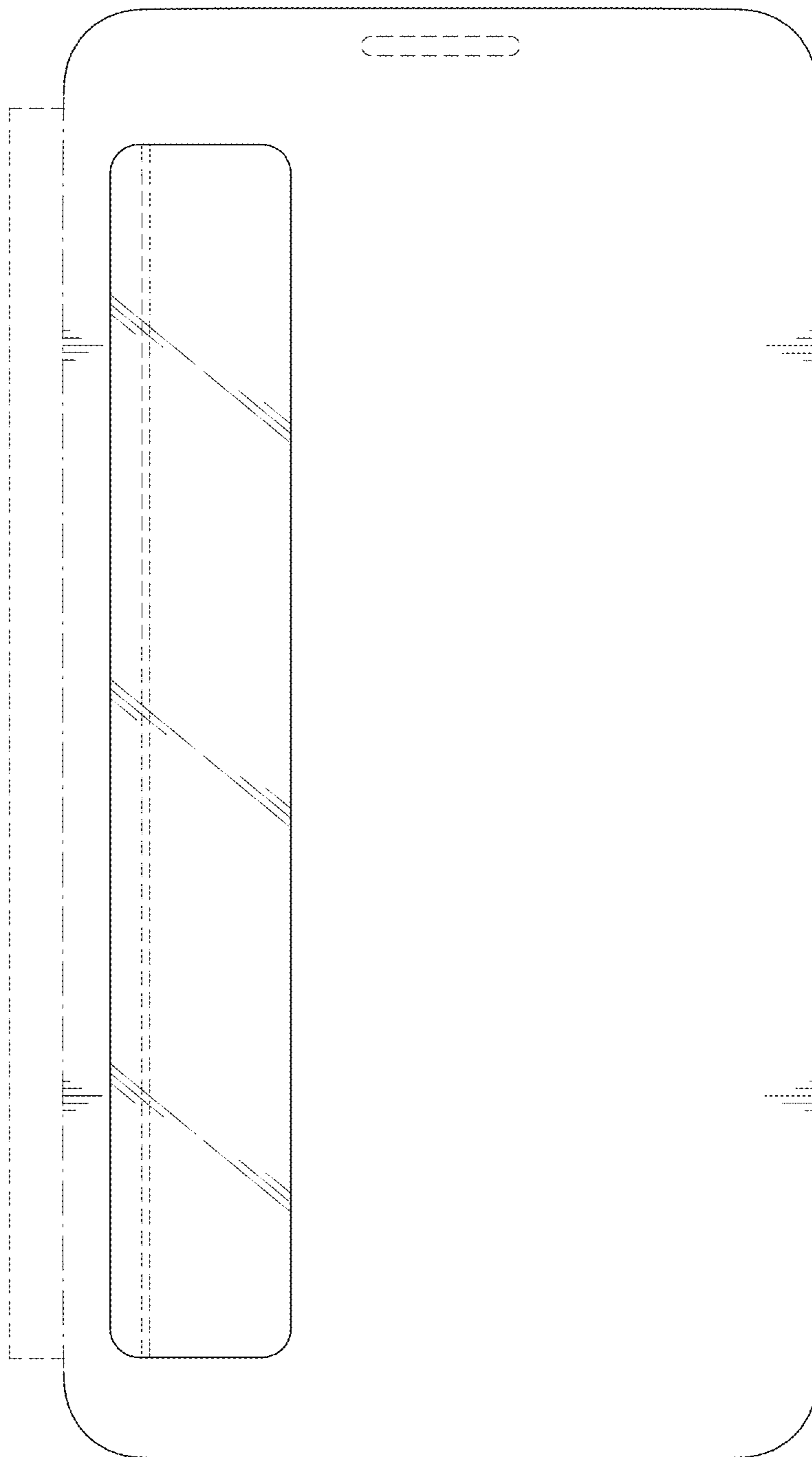

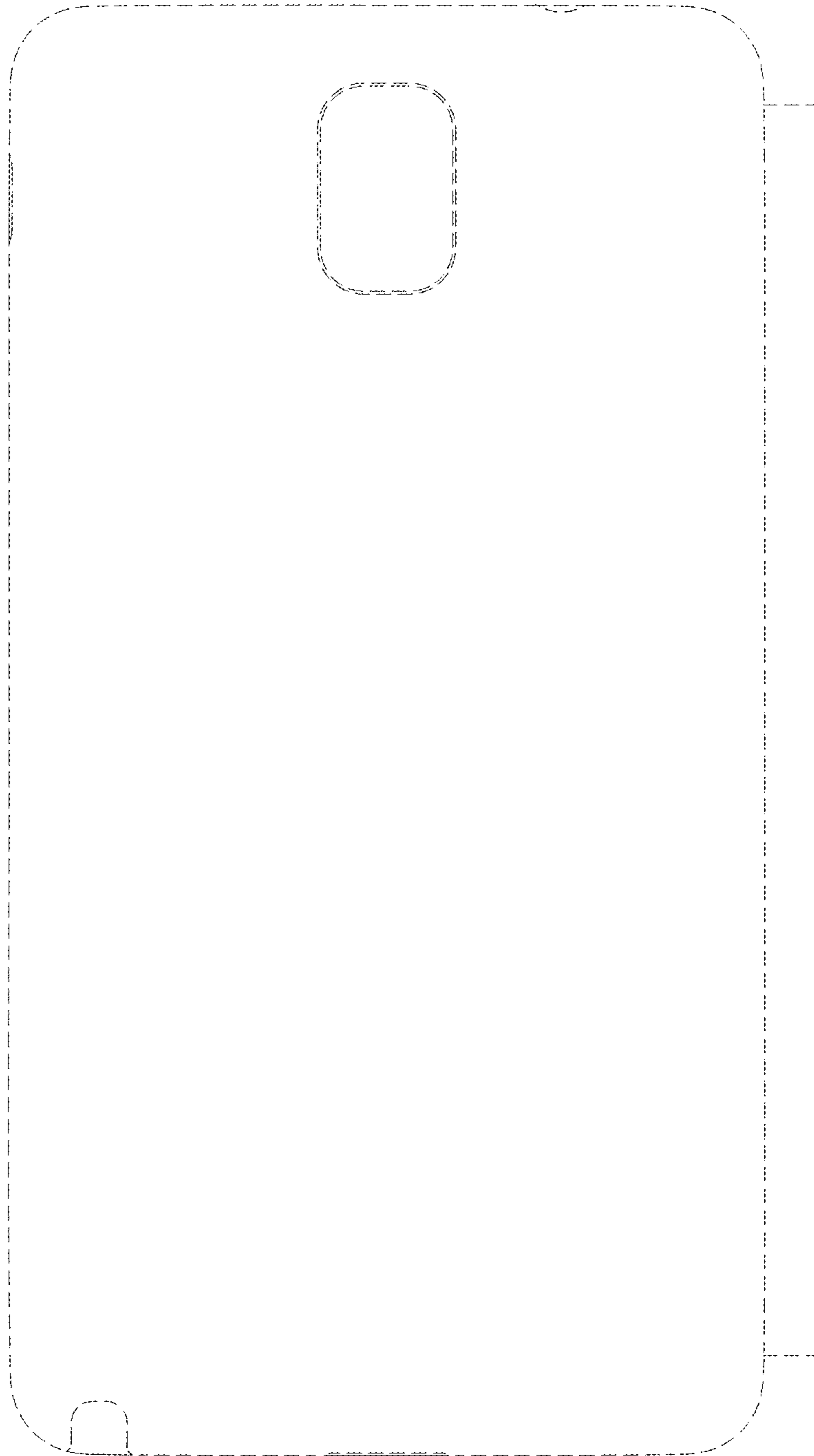

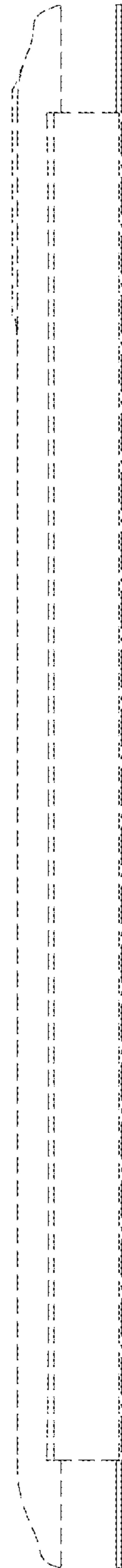

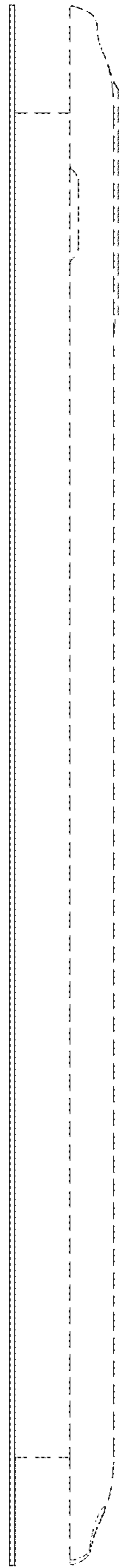

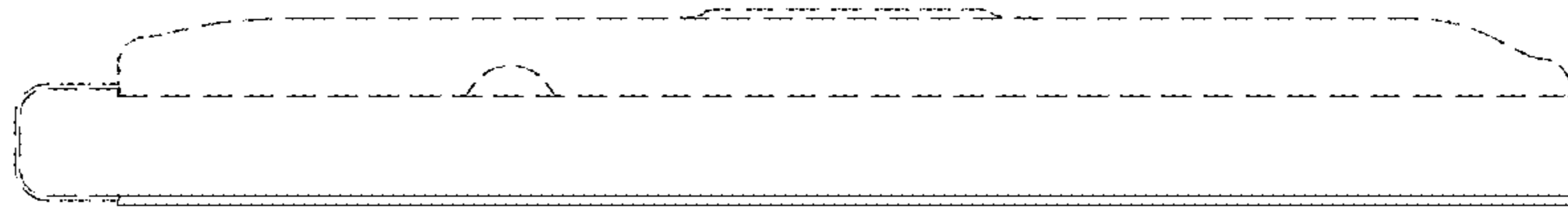
