(57) **CLAIM**

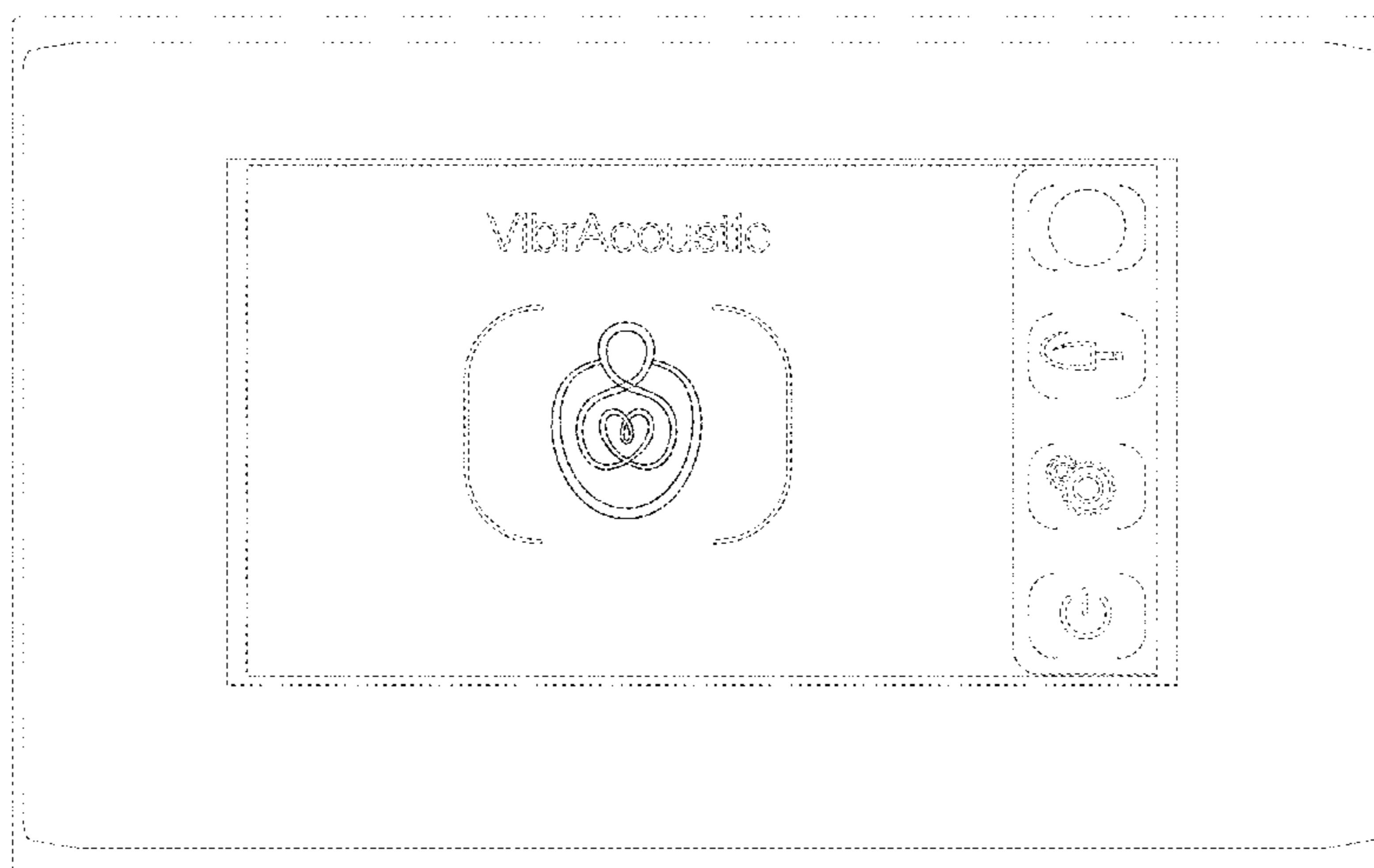
We claim the ornamental design for a display screen with graphical user interface, as shown and described.

**DESCRIPTION**

The FIGURE is a front view of an embodiment of a display screen with graphical user interface.
