(57) **CLAIM**

The ornamental design for a display screen with animated graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a first image of a display screen with animated graphical user interface showing the new design; FIG. 2 is a front view of a second image thereof; FIG. 3 is a front view of a third image thereof; FIG. 4 is a front view of a fourth image thereof; FIG. 5 is a front view of a fifth image thereof; and, FIG. 6 is a front view of a sixth image thereof.

The appearance of the image transitions sequentially between the images shown in FIGS. 1-6. The process or period in which an image transitions to another forms no part of the claimed design.

The broken lines illustrate a display screen and the environment of the display screen with animated graphical user interface, and form no part of the claimed design.

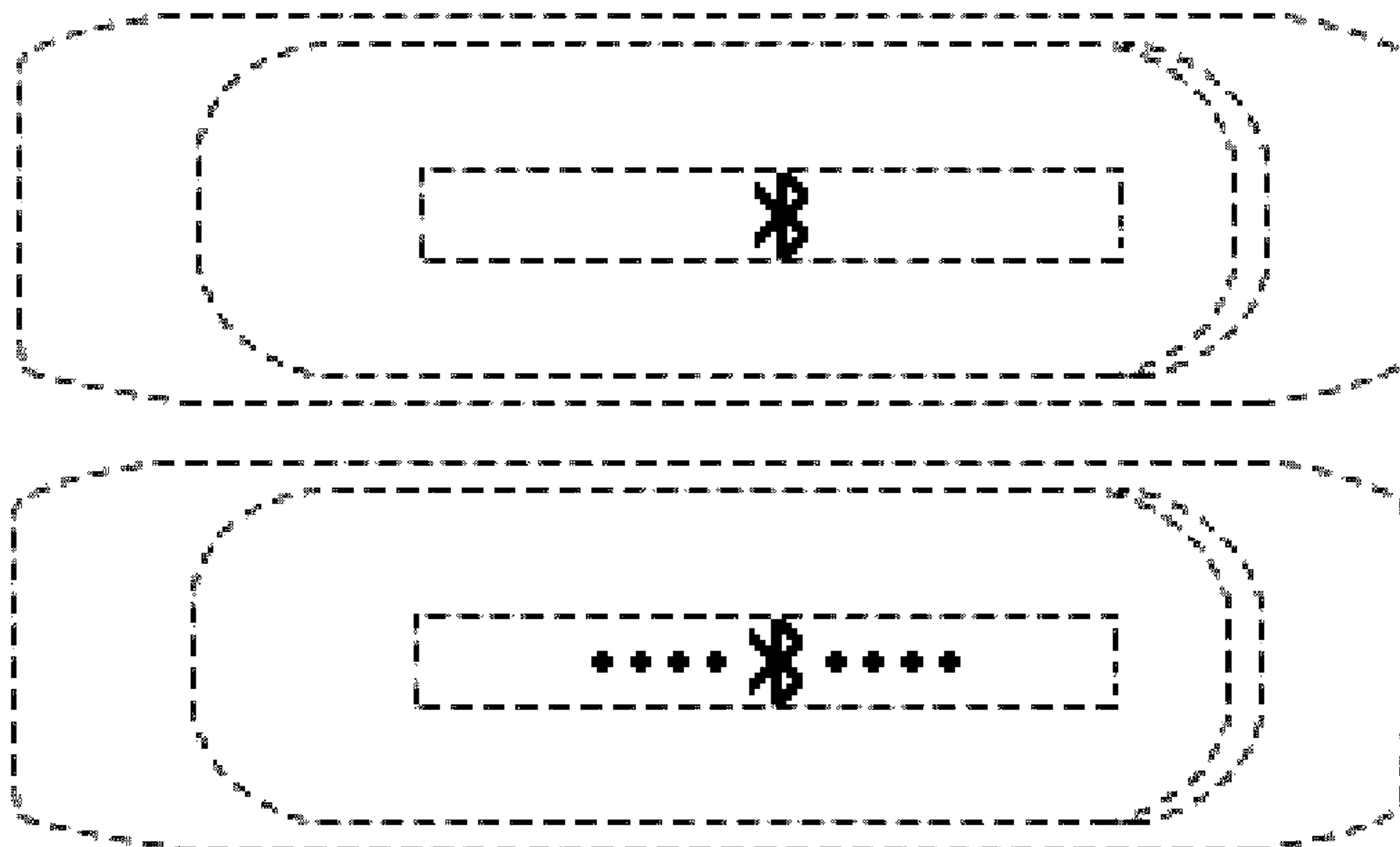

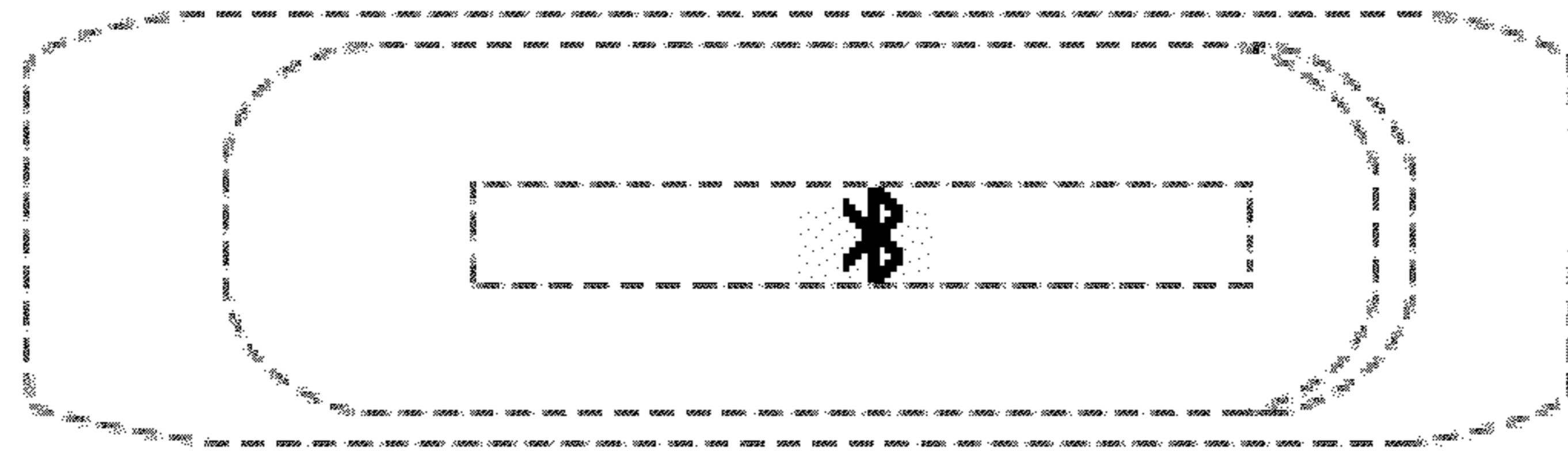

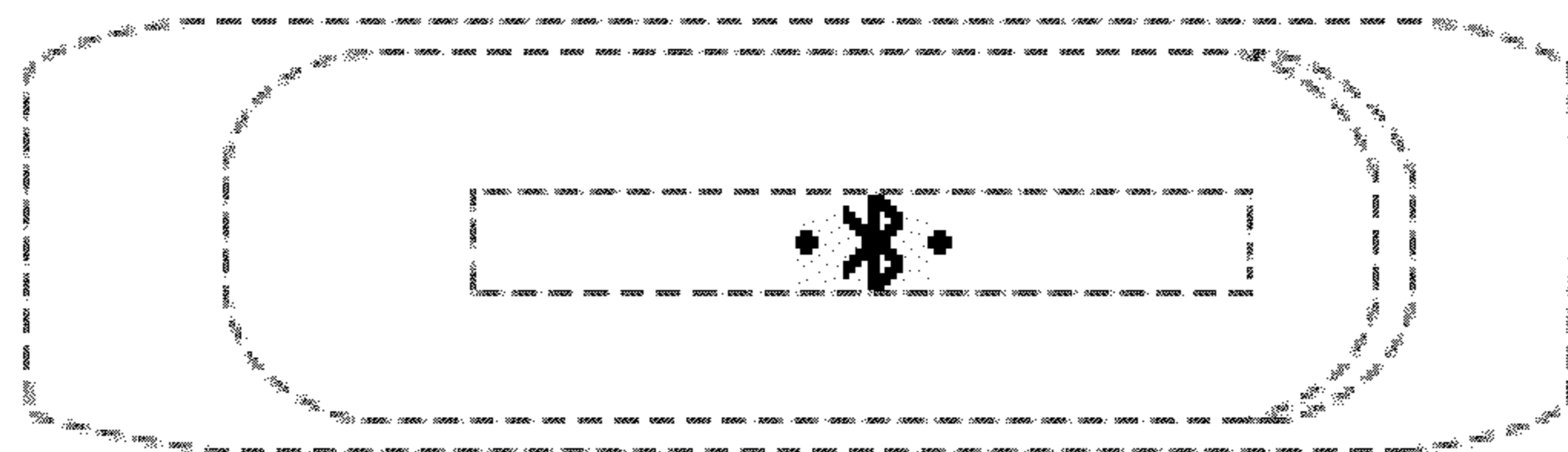

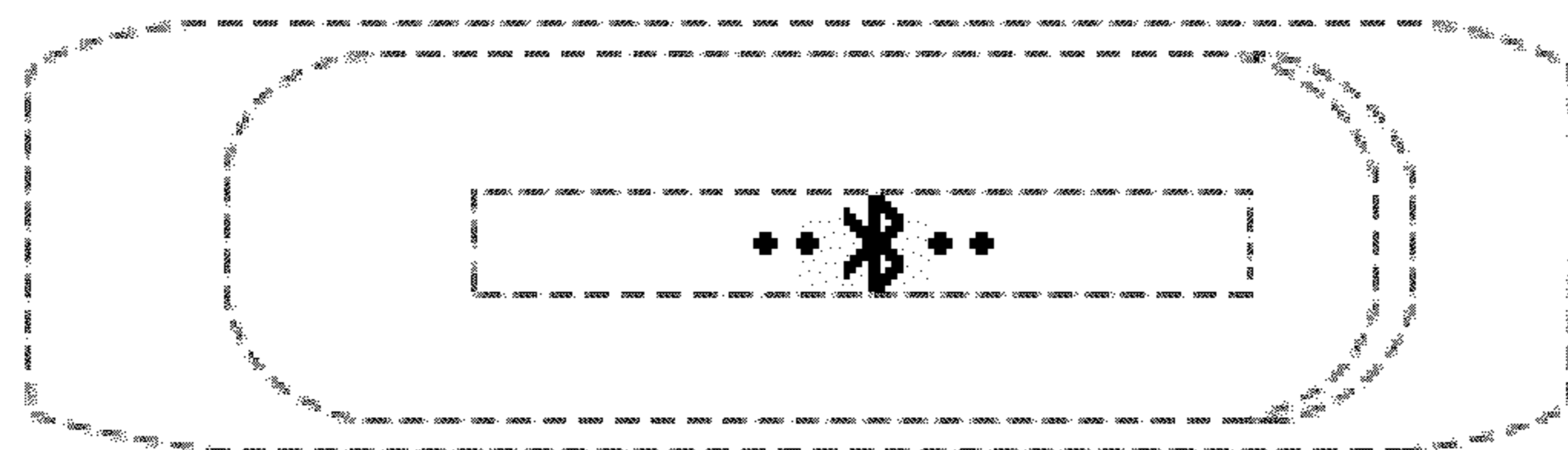

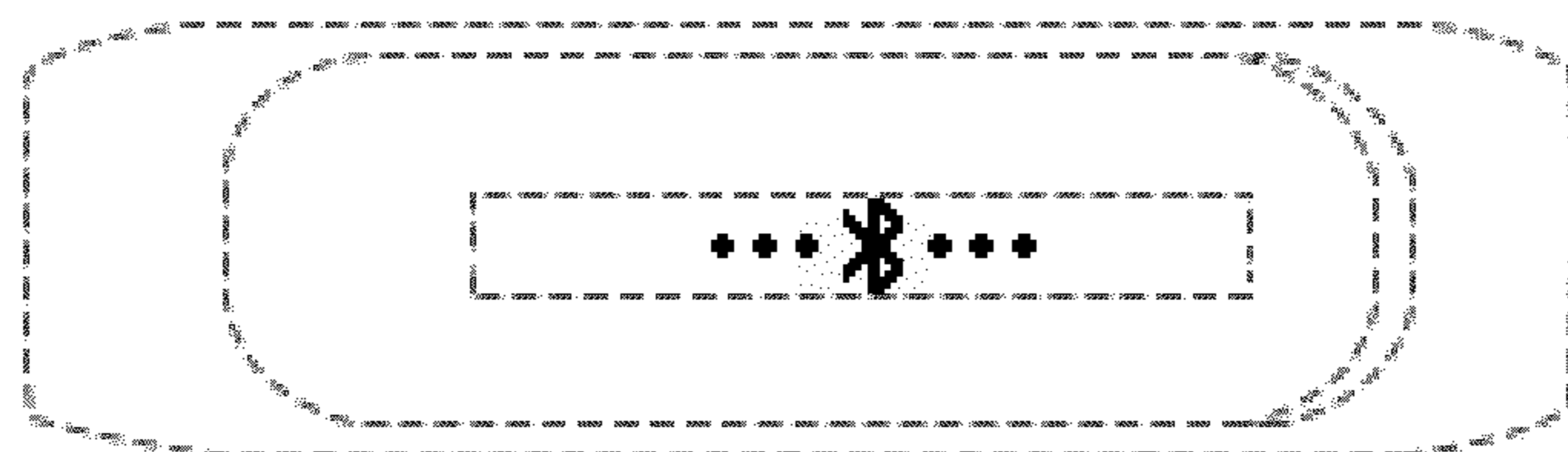

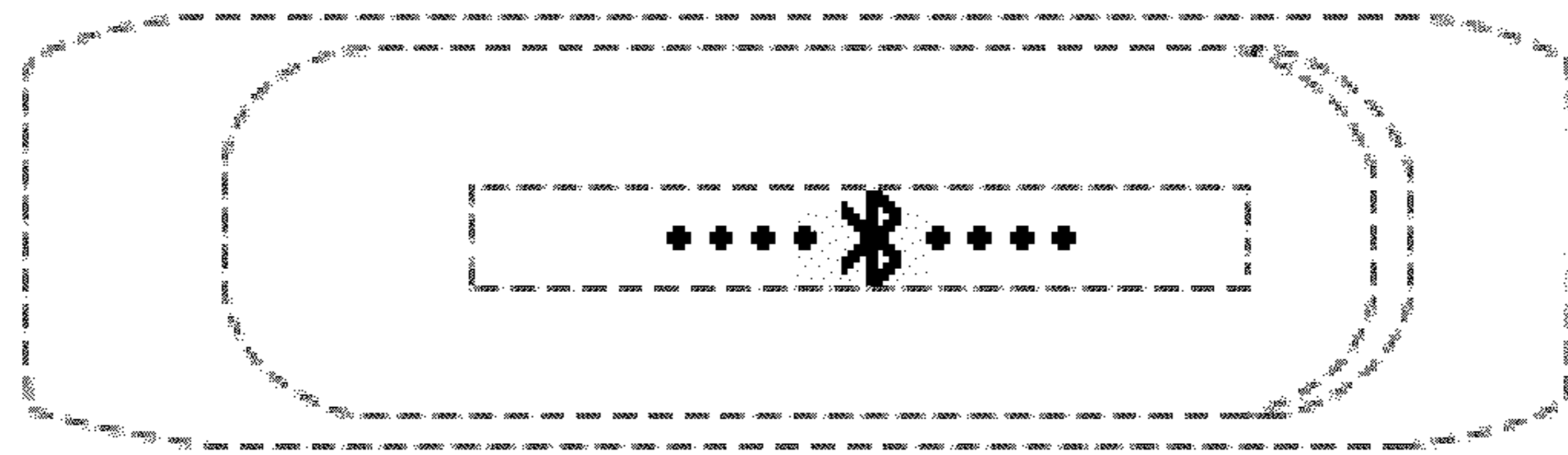
