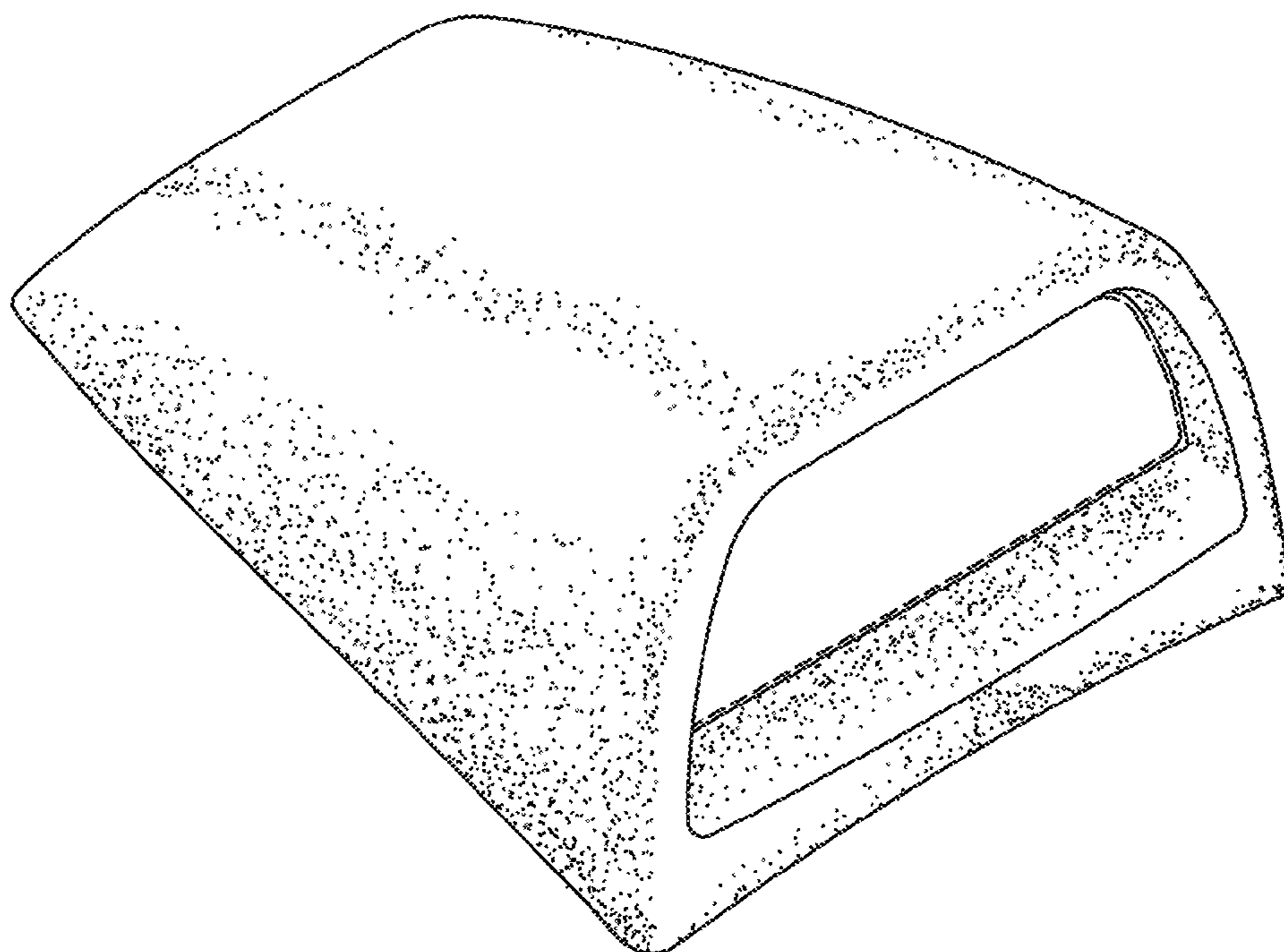
(57) **CLAIM**

We claim the ornamental design for a camera mount, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a camera mount of the present disclosure;
FIG. 2 is a front elevational view of the camera mount of FIG. 1;
FIG. 3 is a rear elevational view of the camera mount of FIG. 1;
FIG. 4 is a side elevational view of the camera mount of FIG. 1;
FIG. 5 is a top plan view of the camera mount of FIG. 1; and, FIG. 6 is a bottom plan view of the camera mount of FIG. 1. The broken lines in the drawings depict a portion of the camera mount that forms no part of the claimed design.

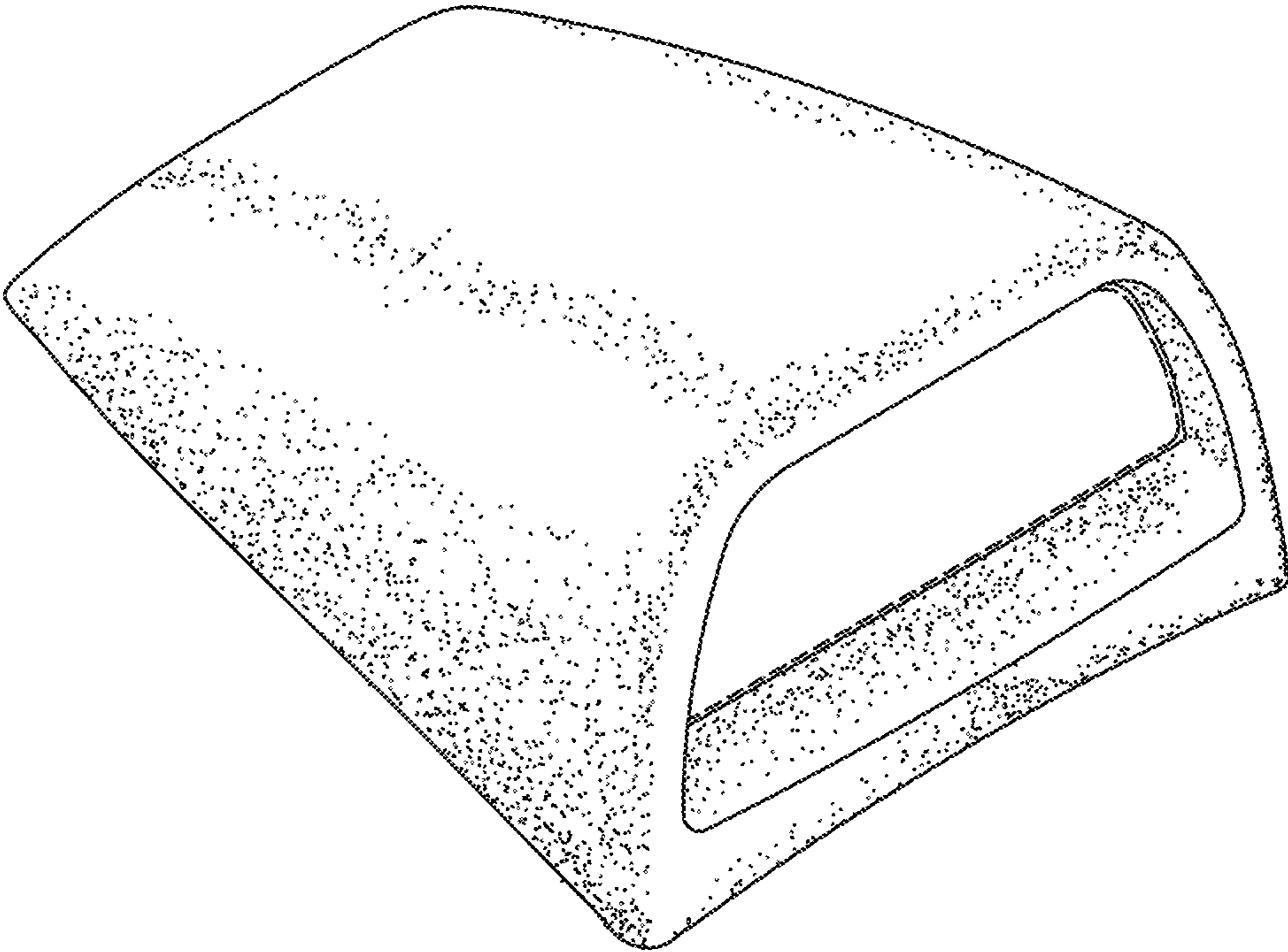

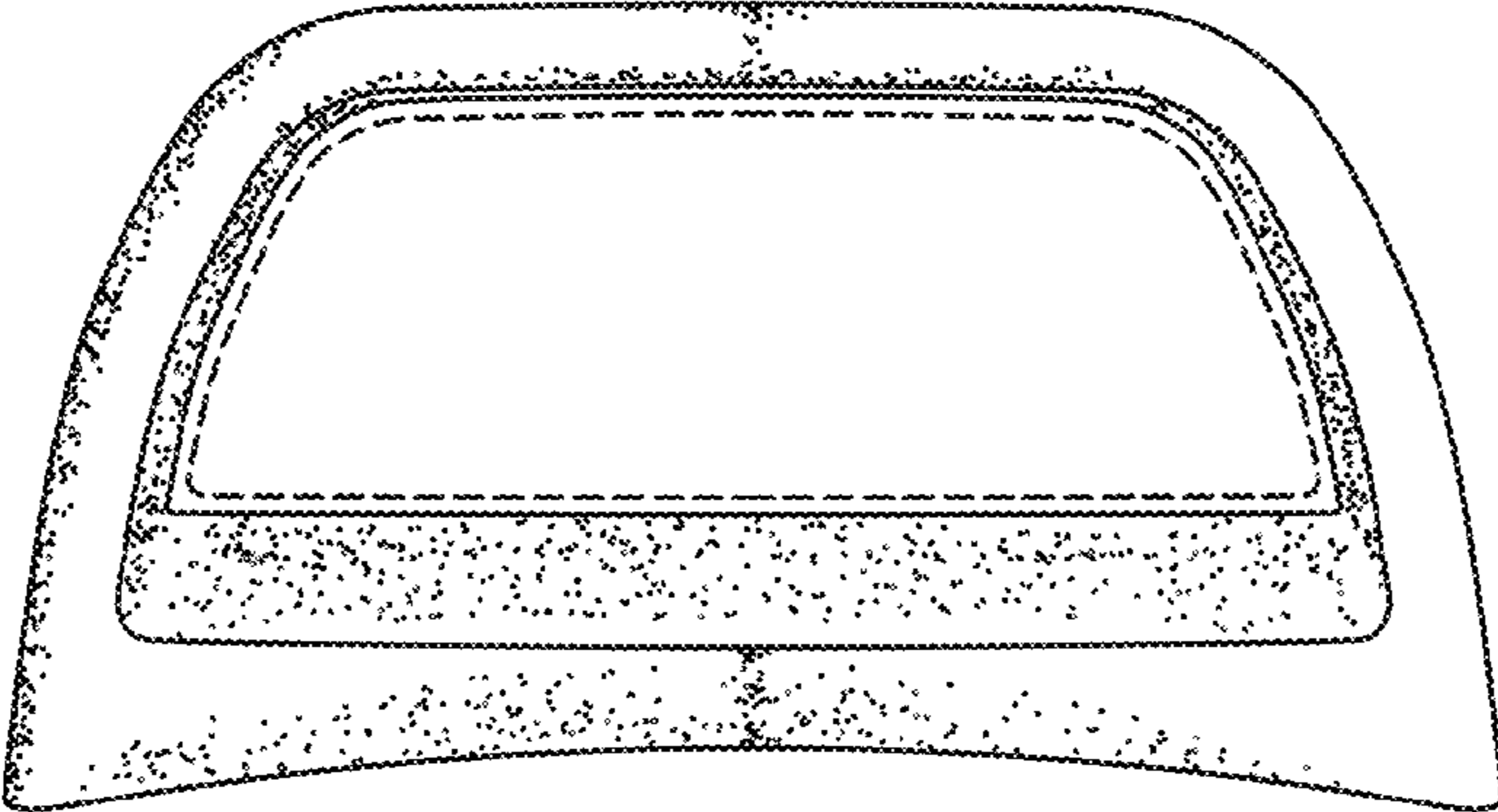

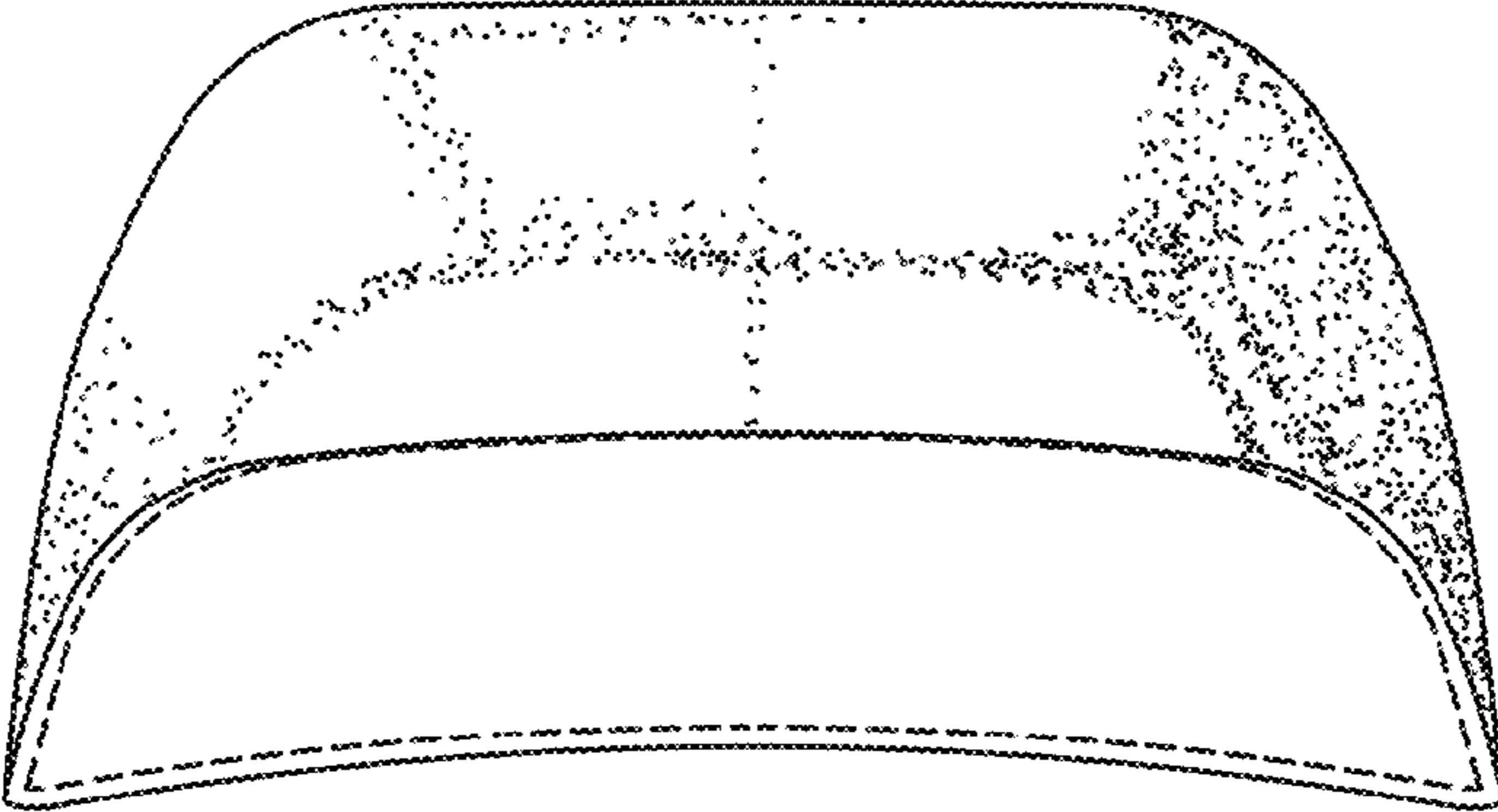

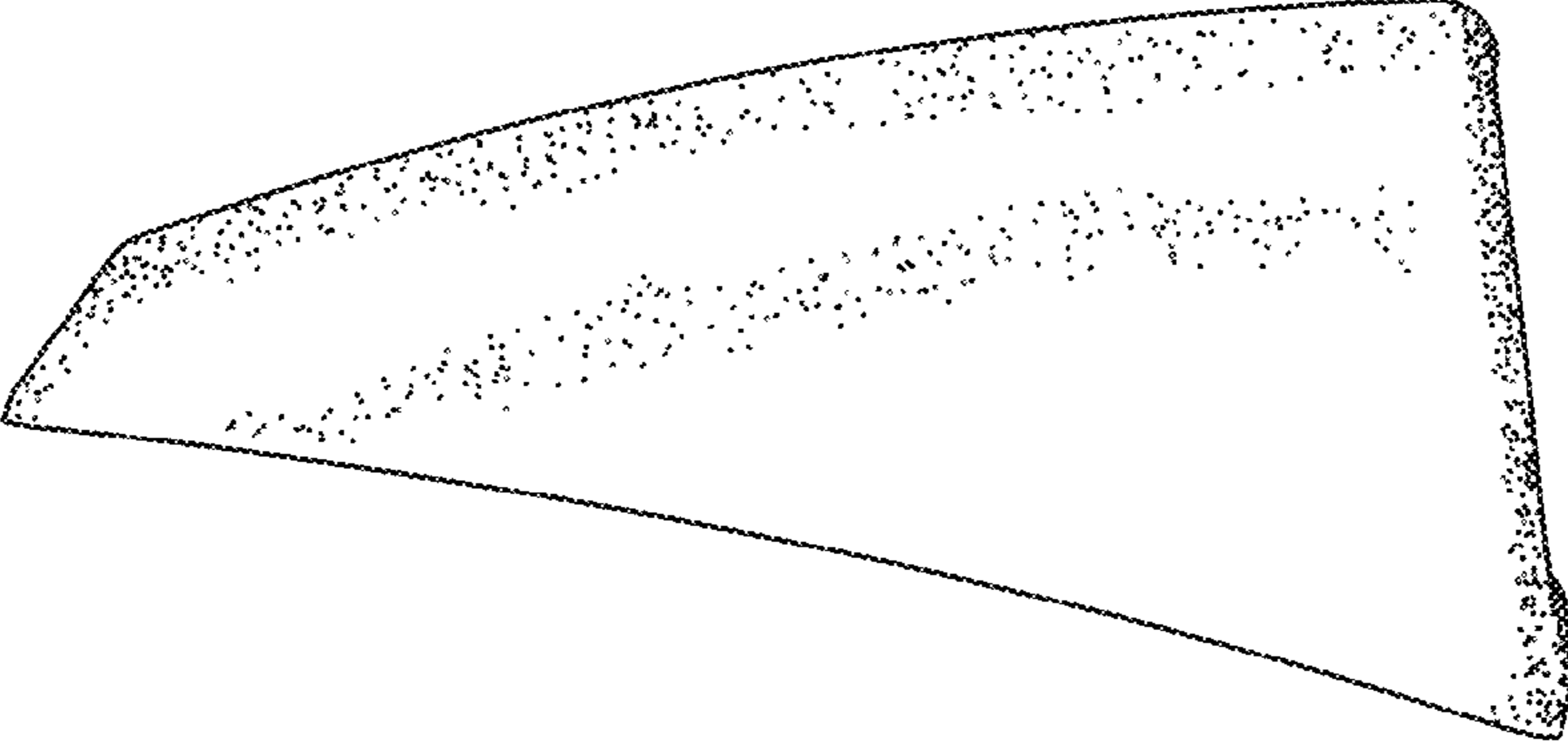

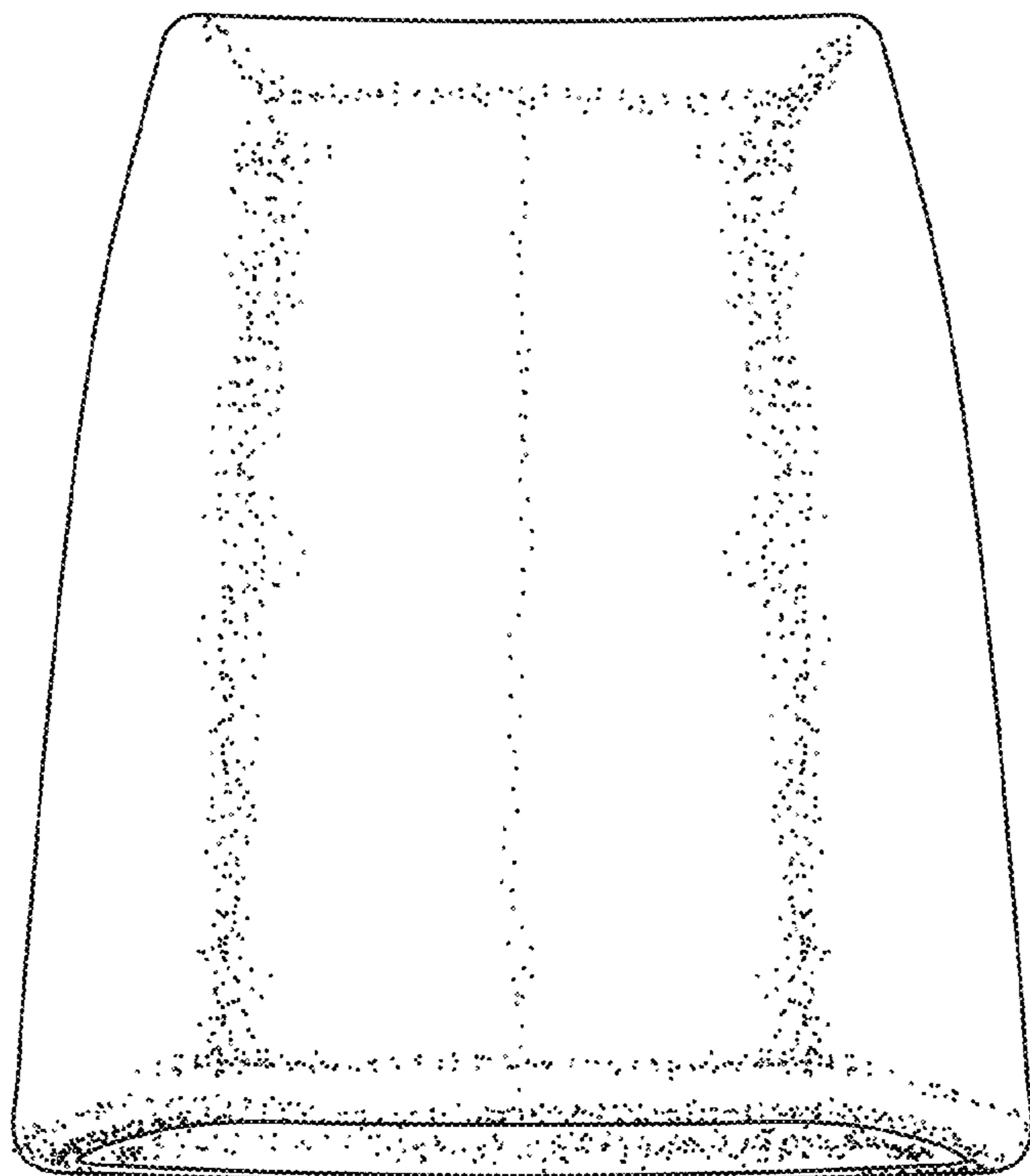

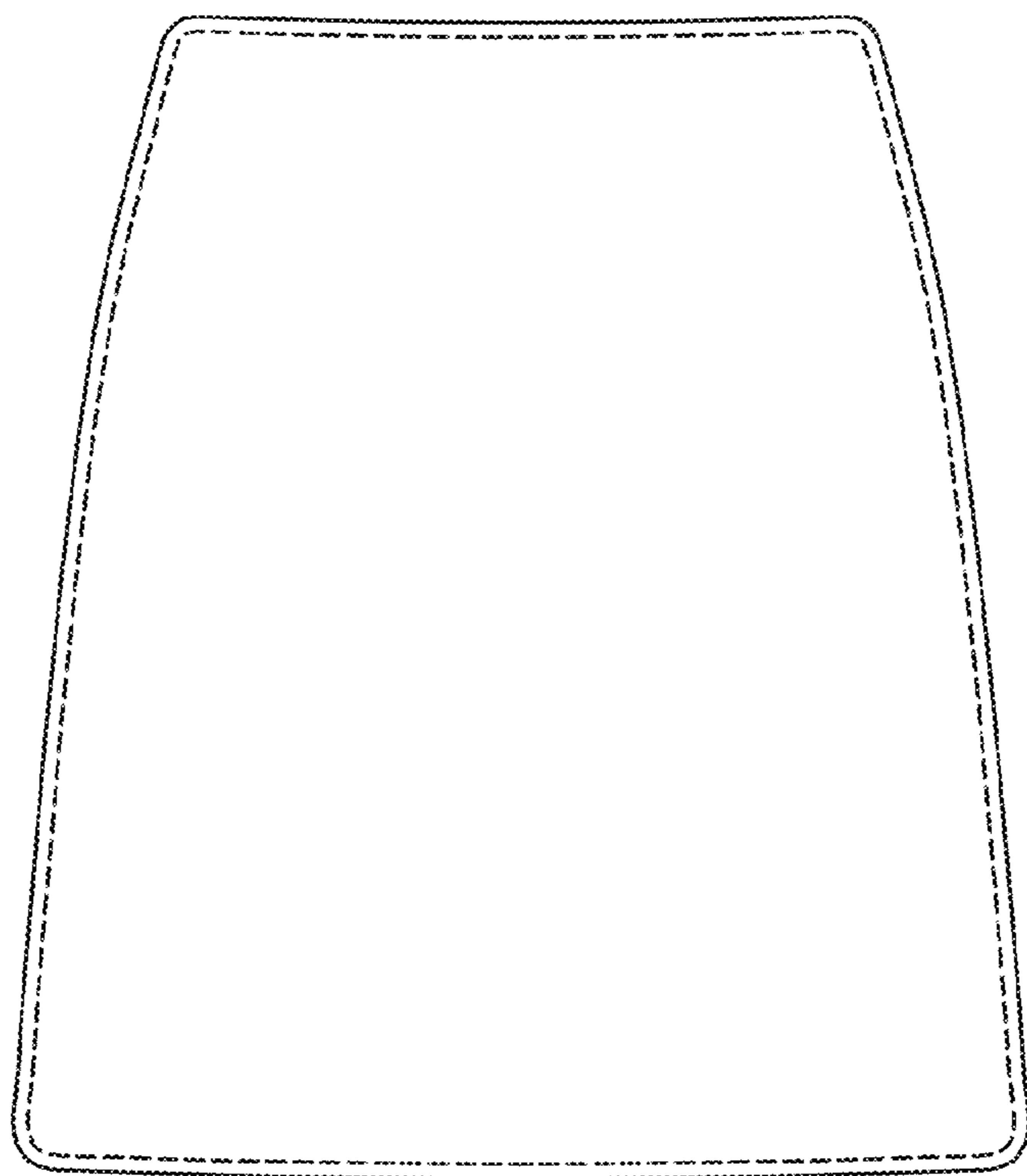
