The ornamental design for a fluid applicator, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a first embodiment of the fluid applicator;

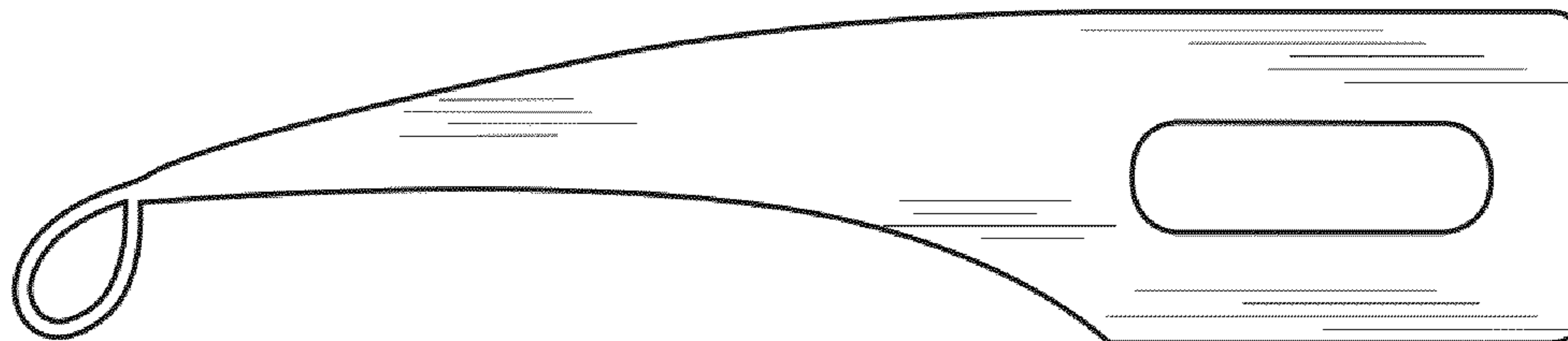
FIG. 25 is a front elevation view of a fifth embodiment of the fluid applicator;

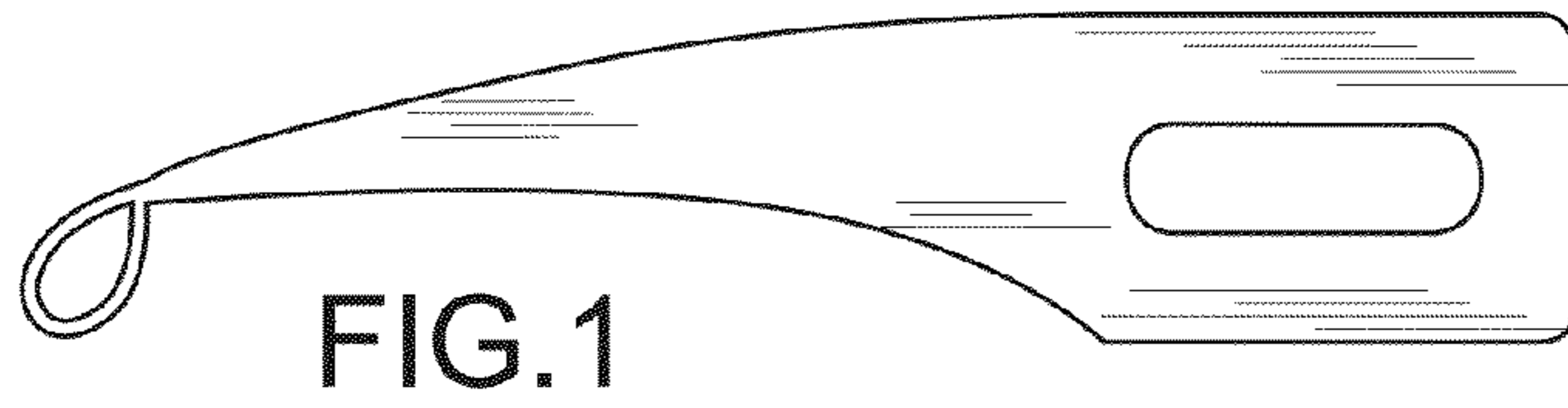

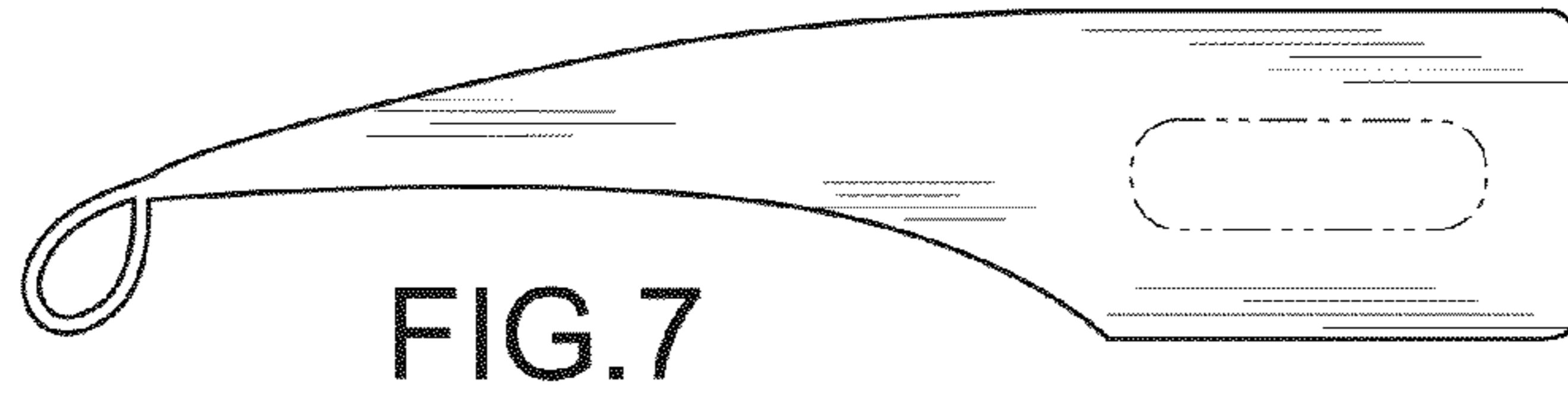

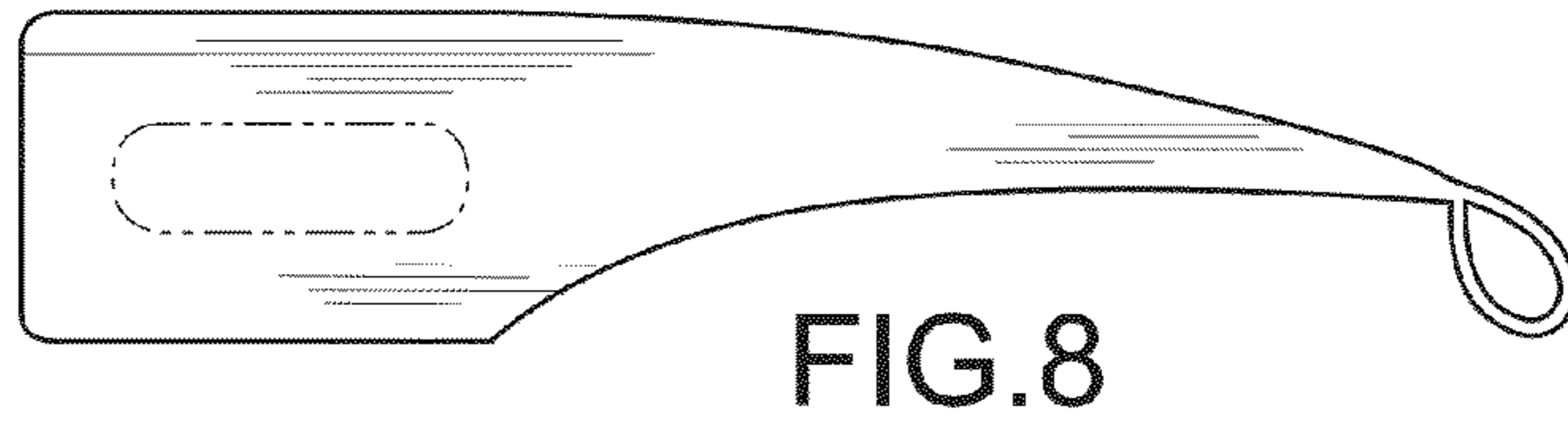

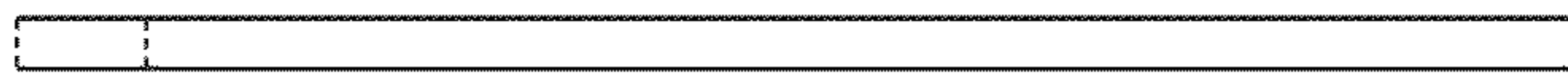

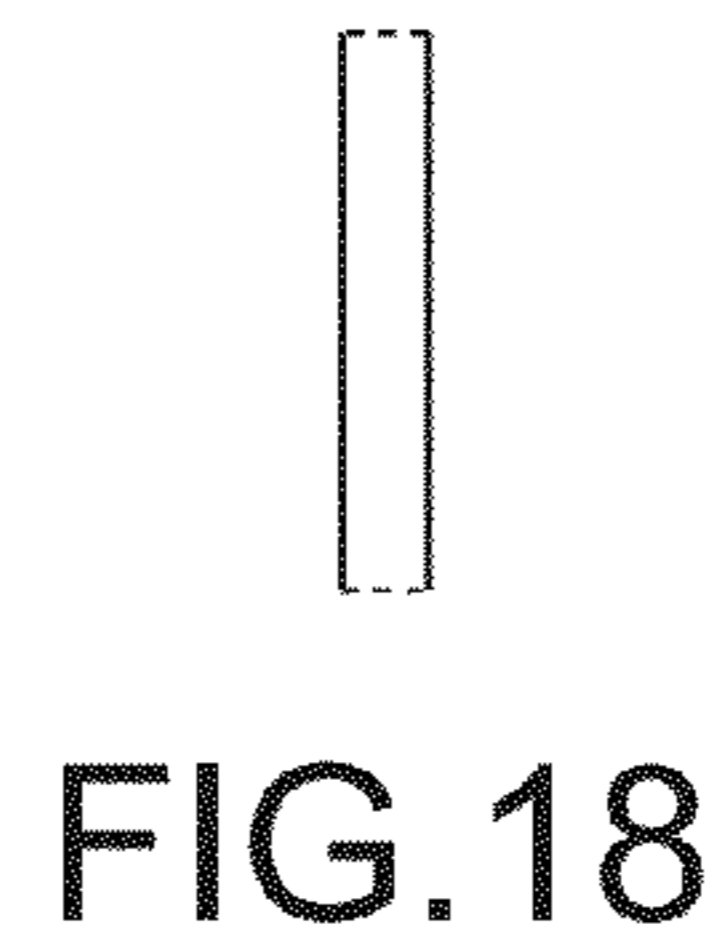
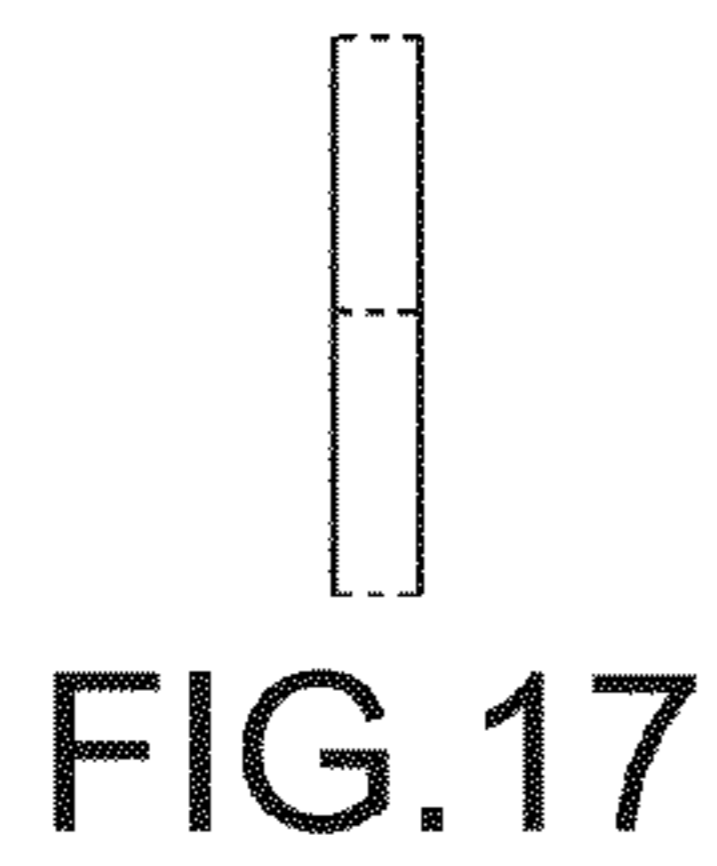
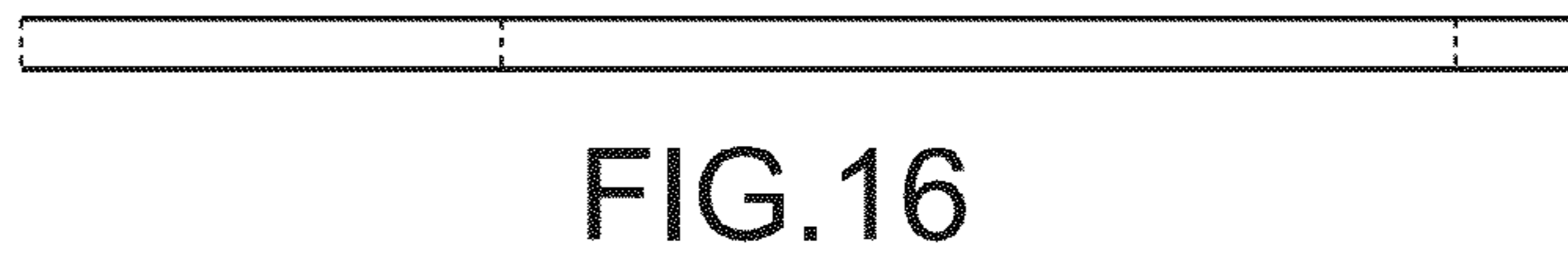
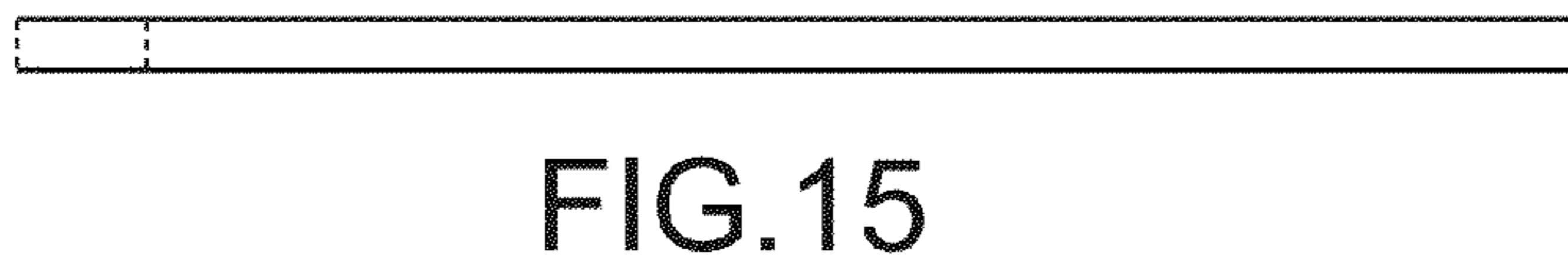
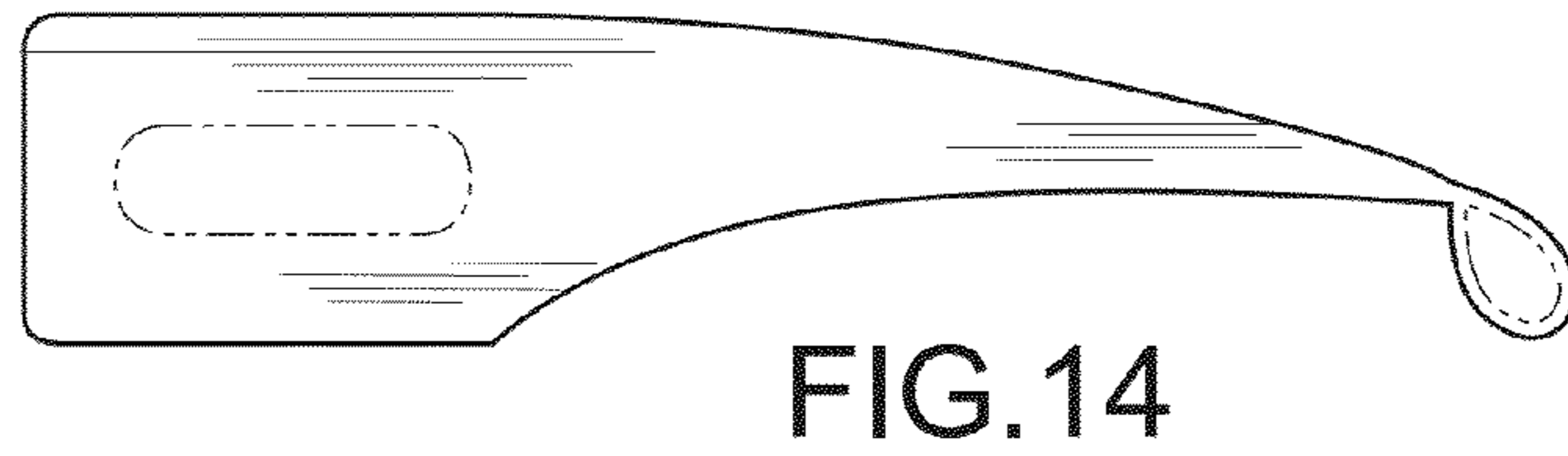
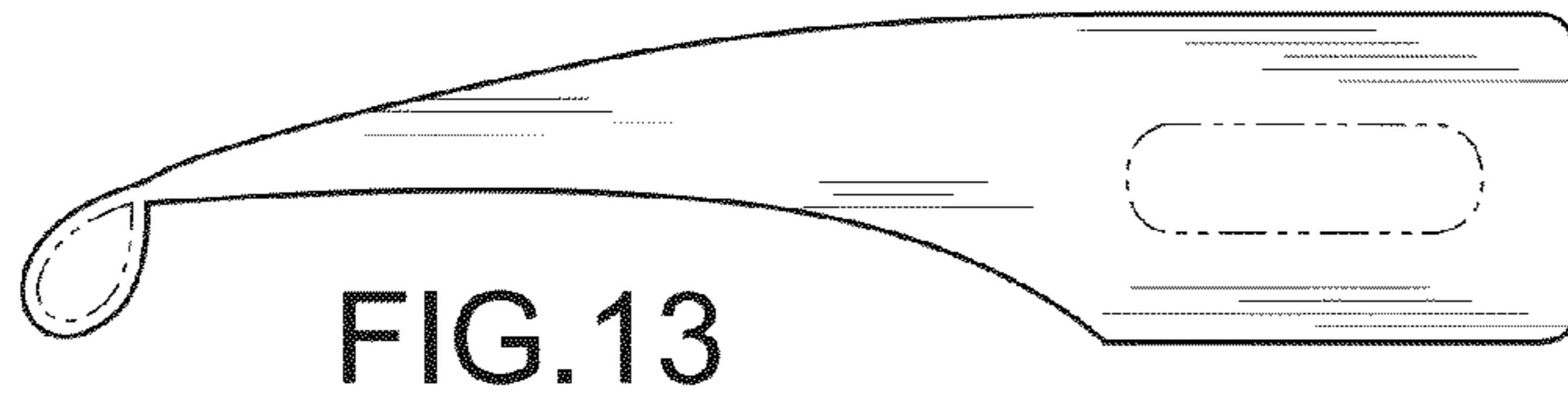

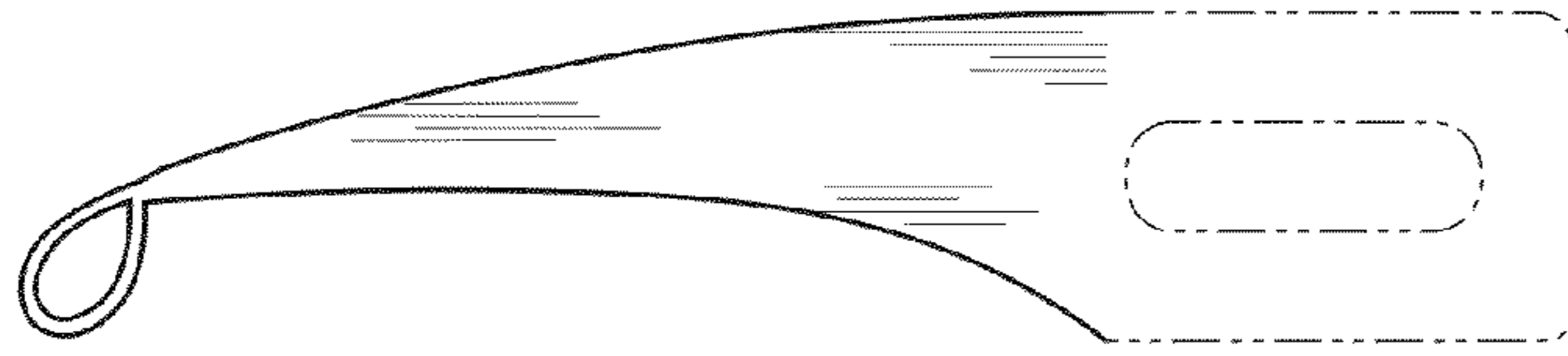

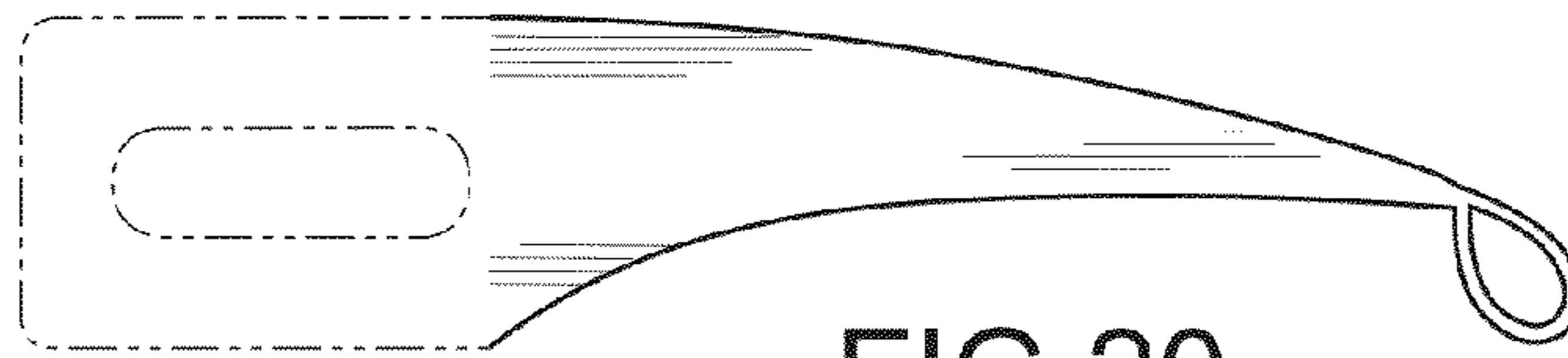

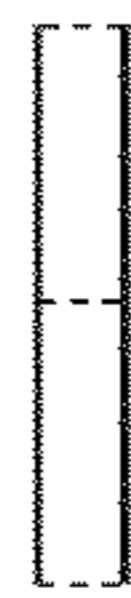

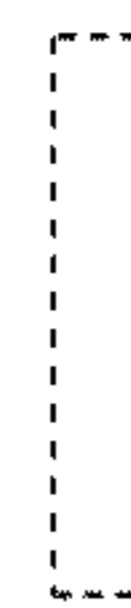

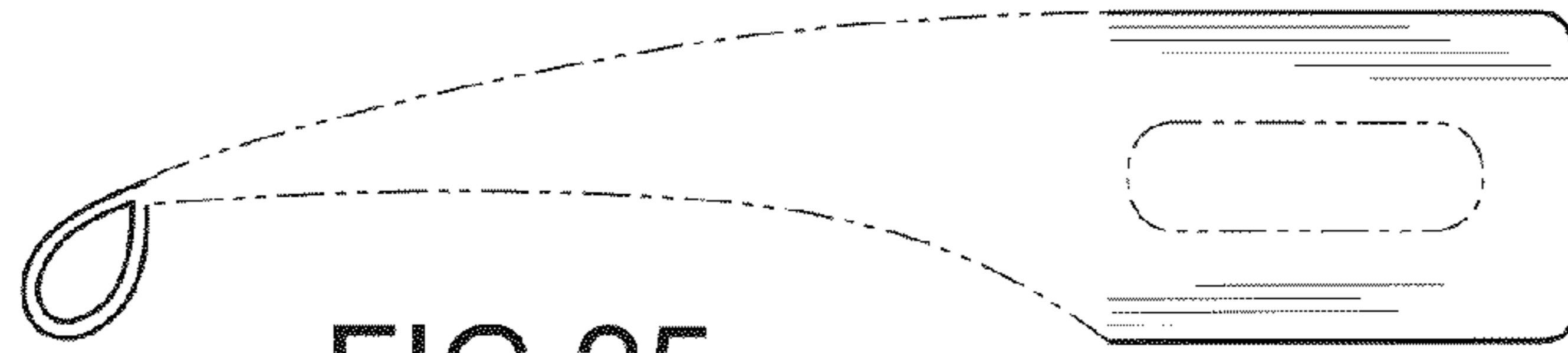

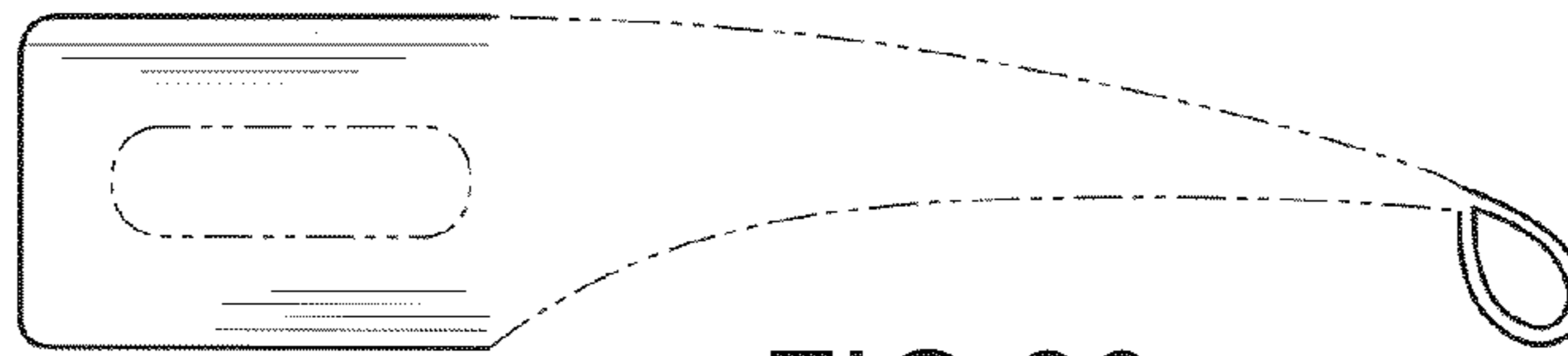

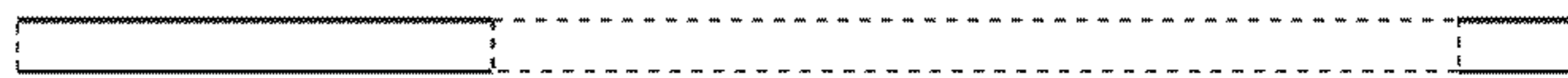

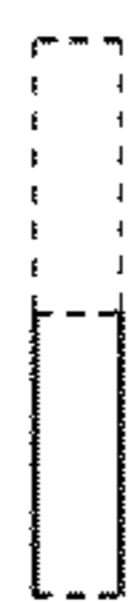
