(57) **CLAIM**

The ornamental design for an air deflector for ceiling air conditioner, as shown and described.

DESCRIPTION

FIG. 1 is a front, left side, perspective view of an air deflector for ceiling air conditioner showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a bottom, perspective view thereof showing an environmental state.

The portions of the article shown in broken lines is for the purpose of showing environmental structure only and form no part of the claimed design.

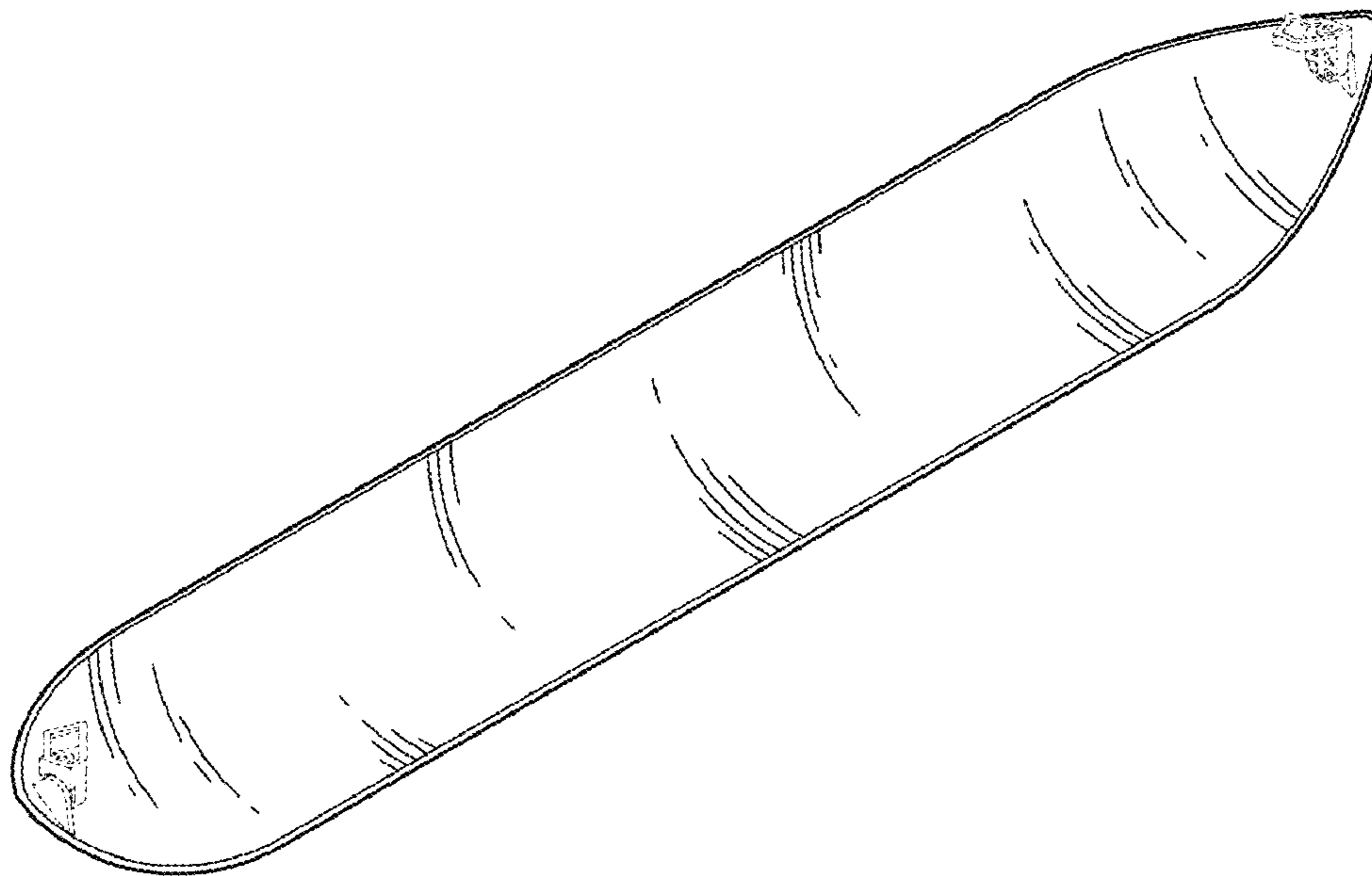

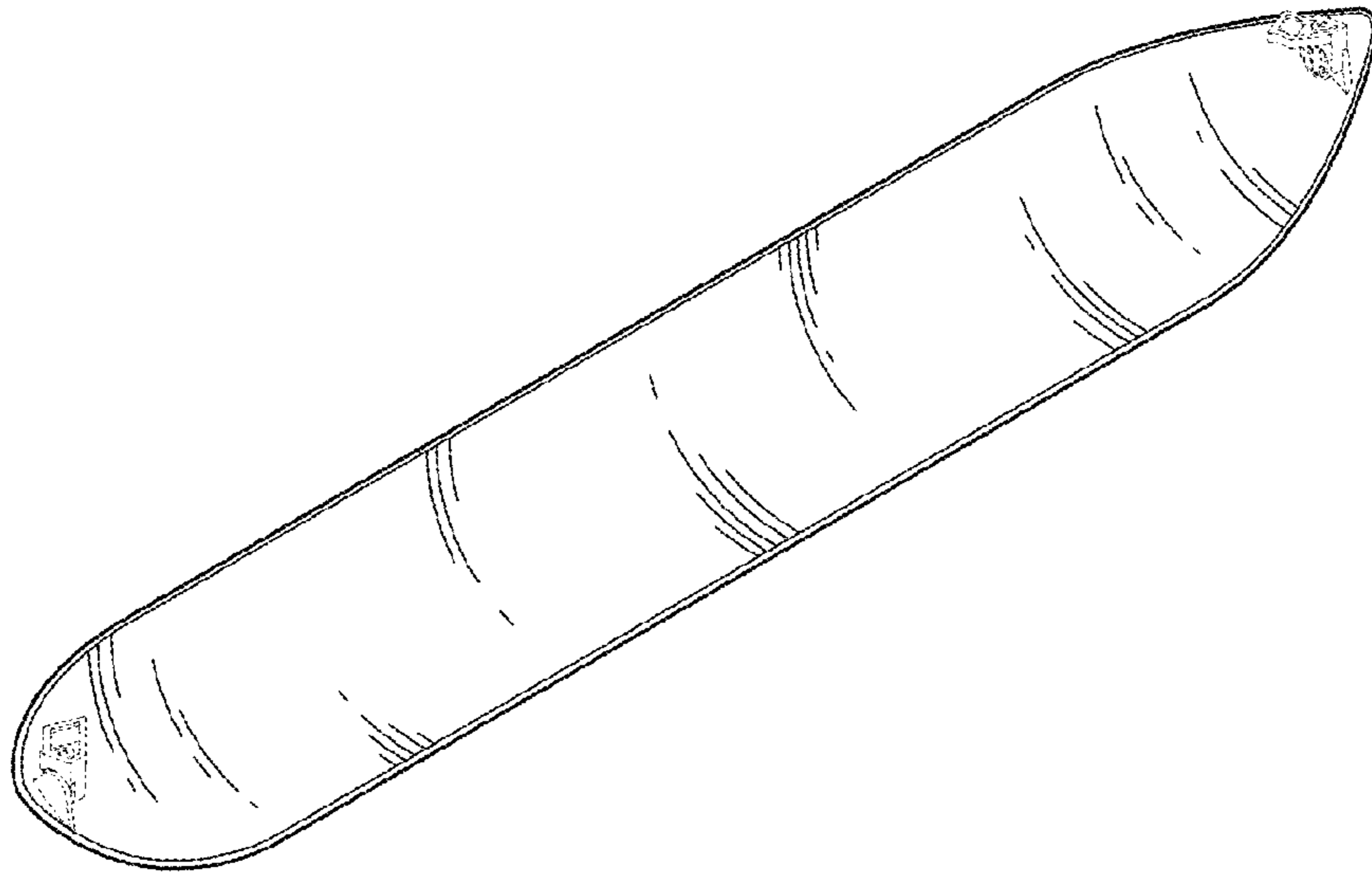

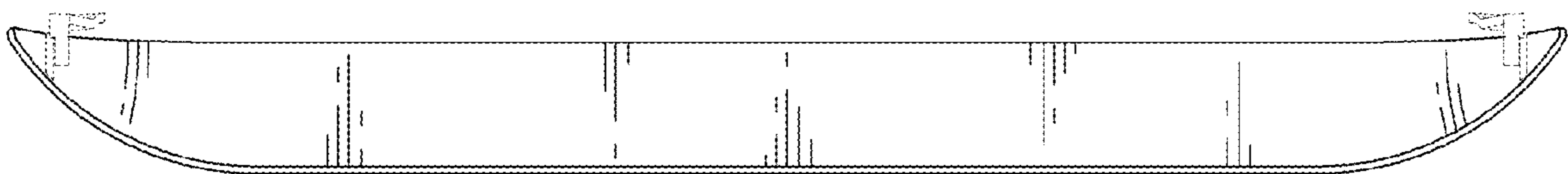

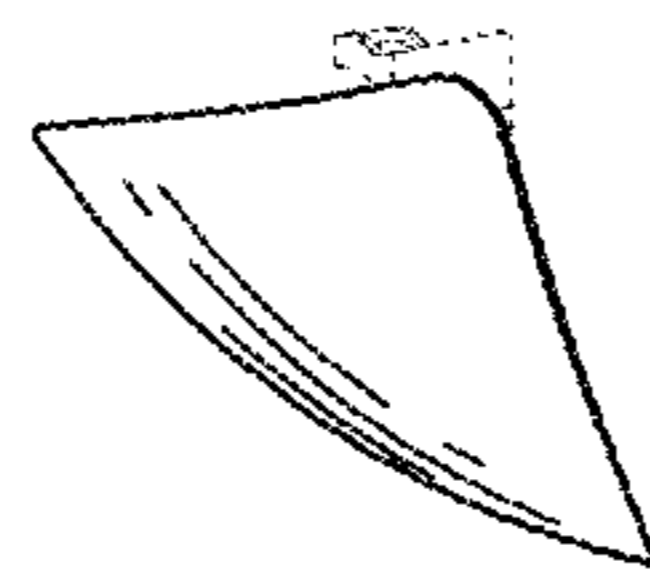

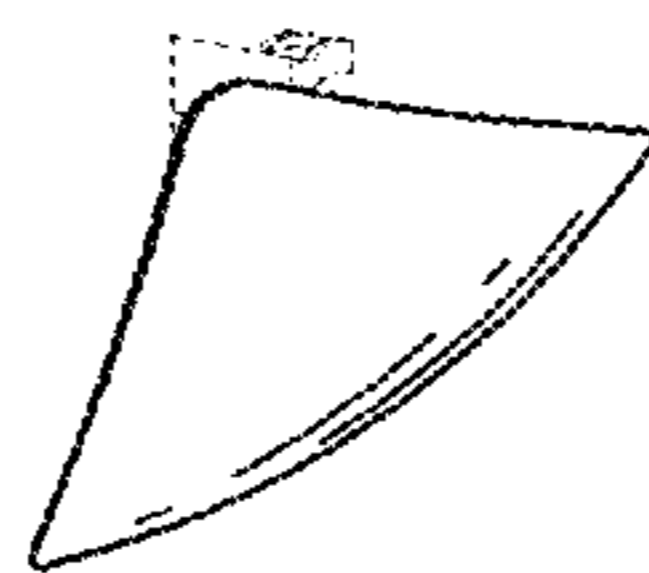

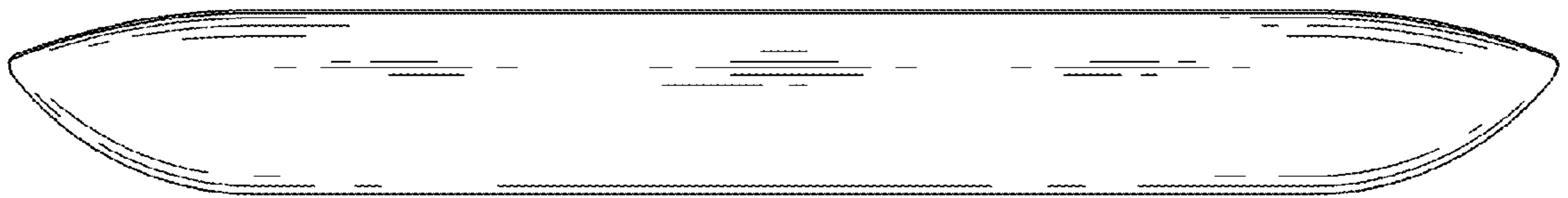
