(57) **CLAIM**

The ornamental design for an oral dosage form, as shown and described.

DESCRIPTION

FIG. 1 is a front right bottom perspective view of an oral dosage form, showing our claimed design;

FIG. 27 is a top end view of FIG. 24, the bottom end view being a mirror image thereof;

FIG. 29 is a front plan view of FIG. 28;

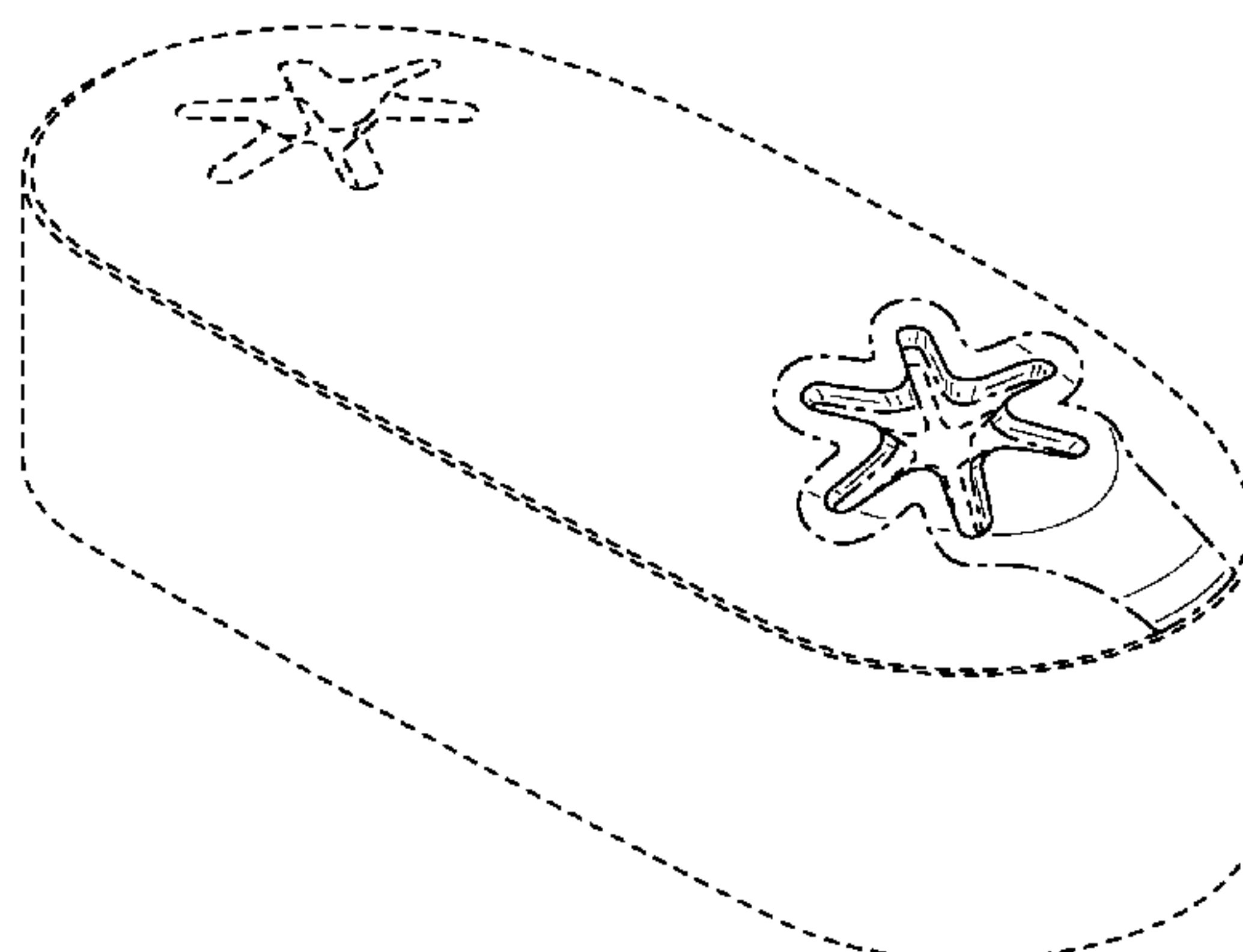
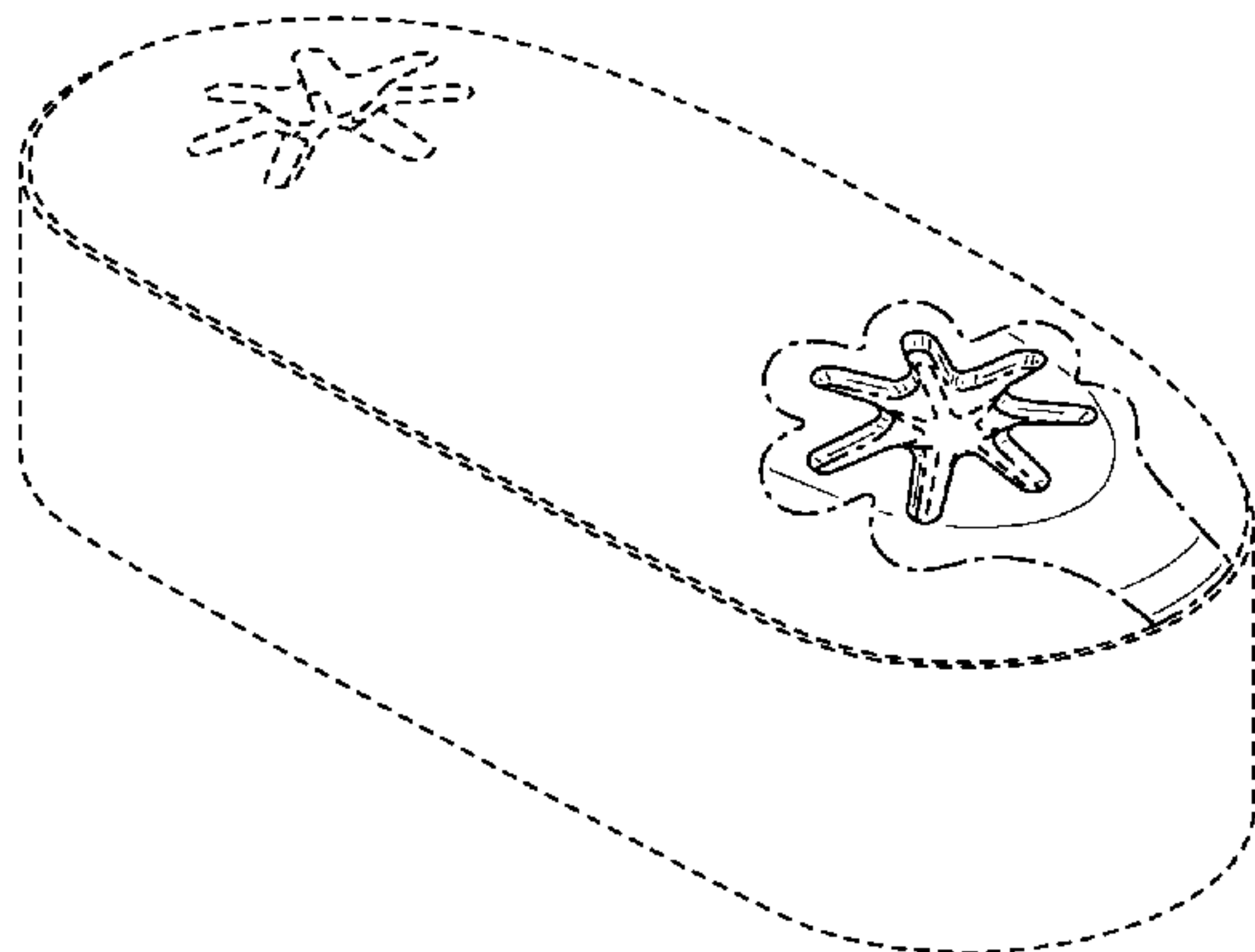
FIG. 30 is an end view of the oral dosage form of FIG. 28, the other end view being a mirror image thereof;

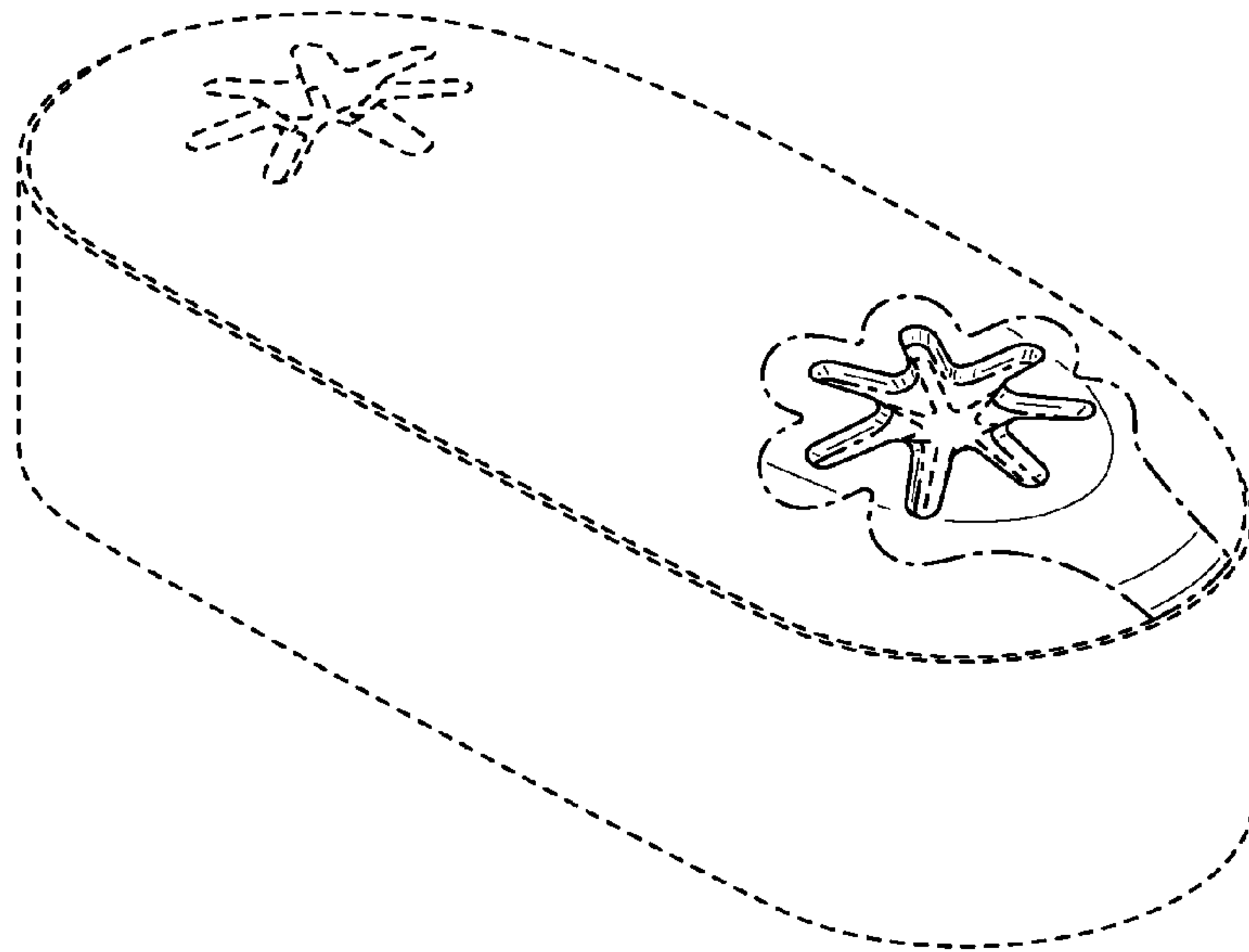

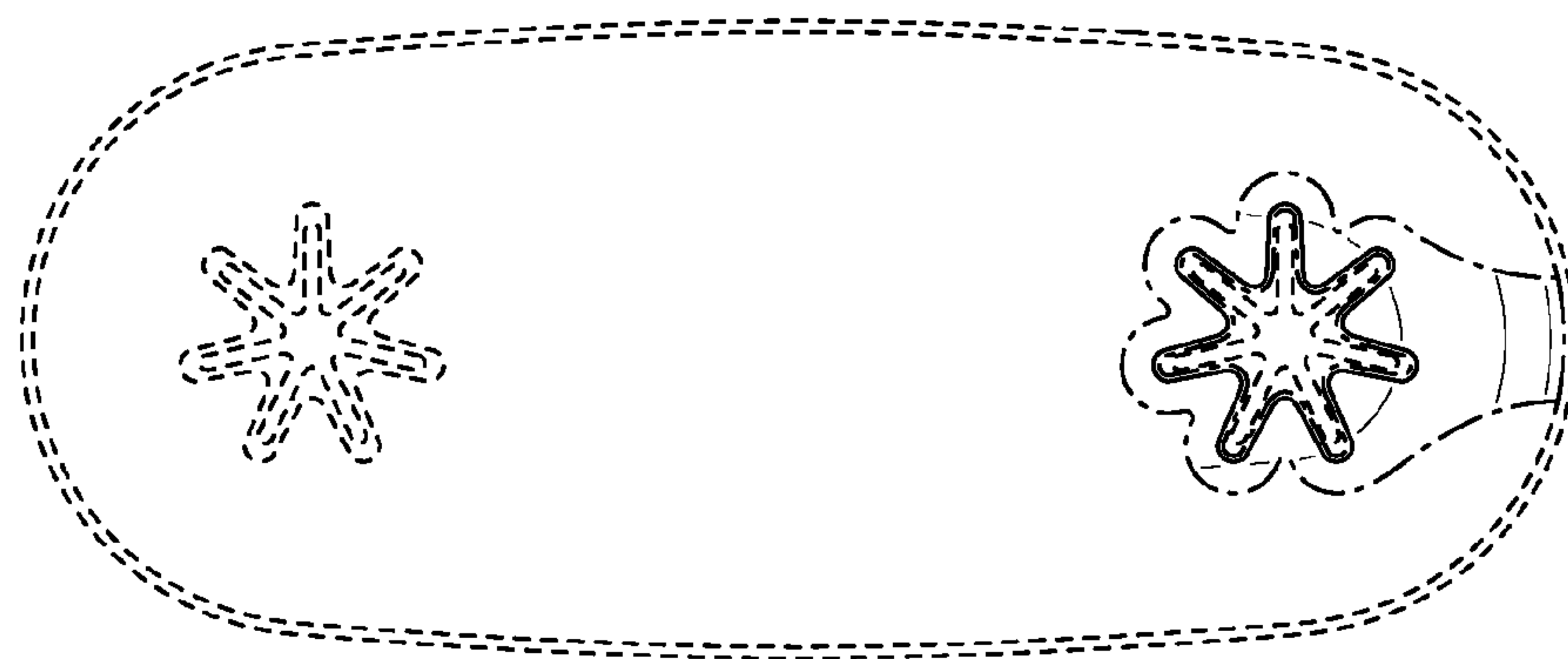

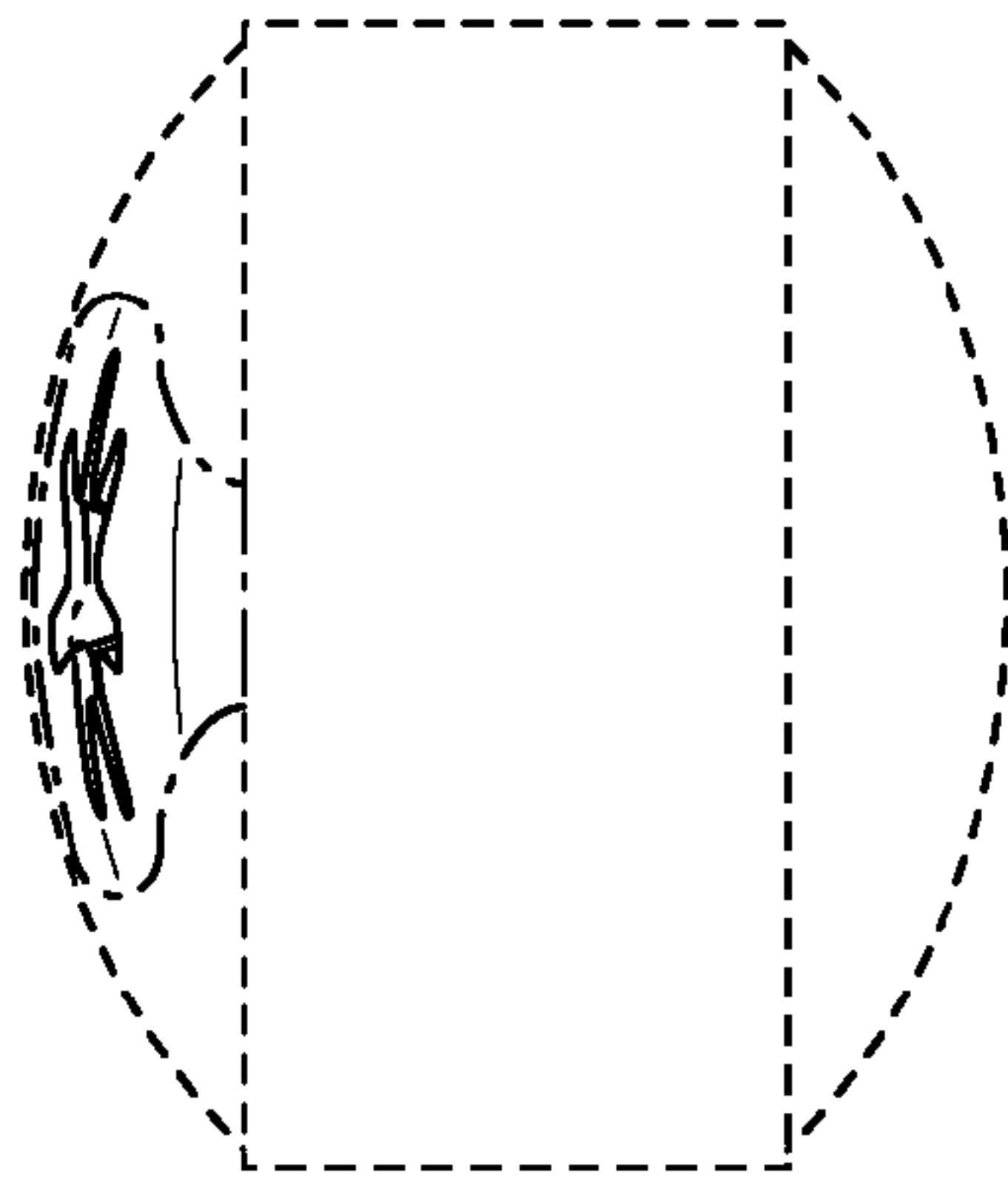

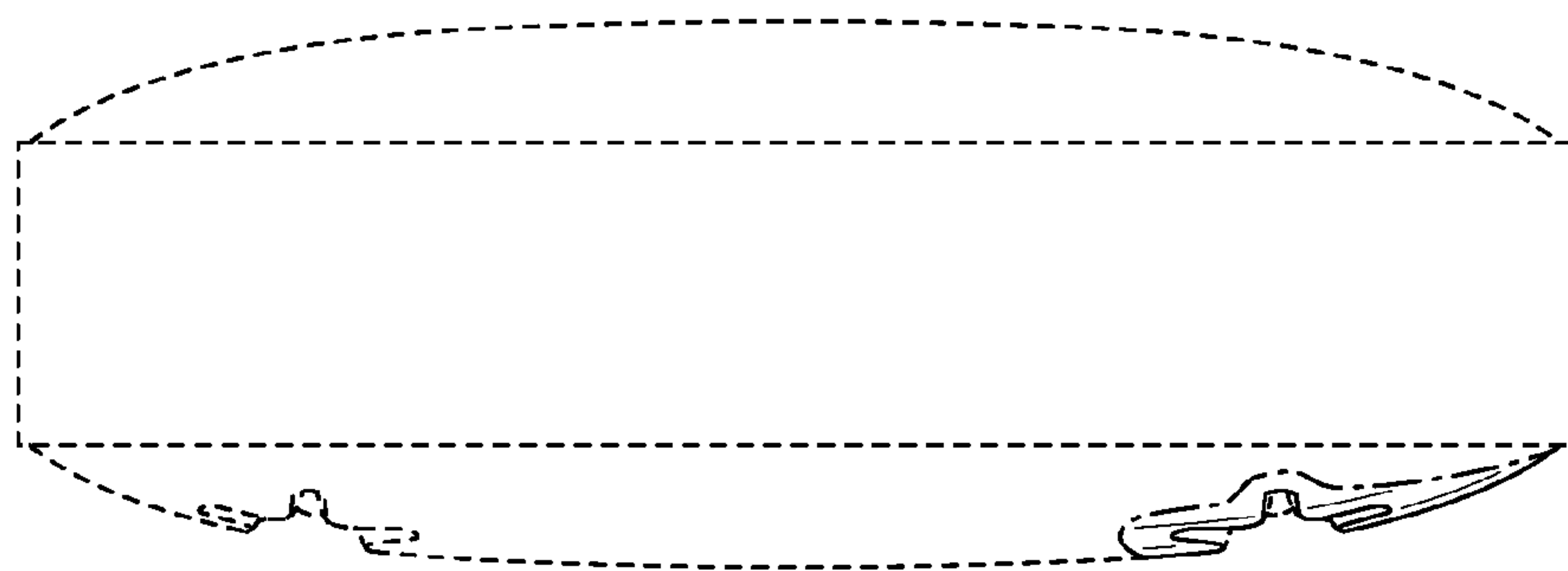

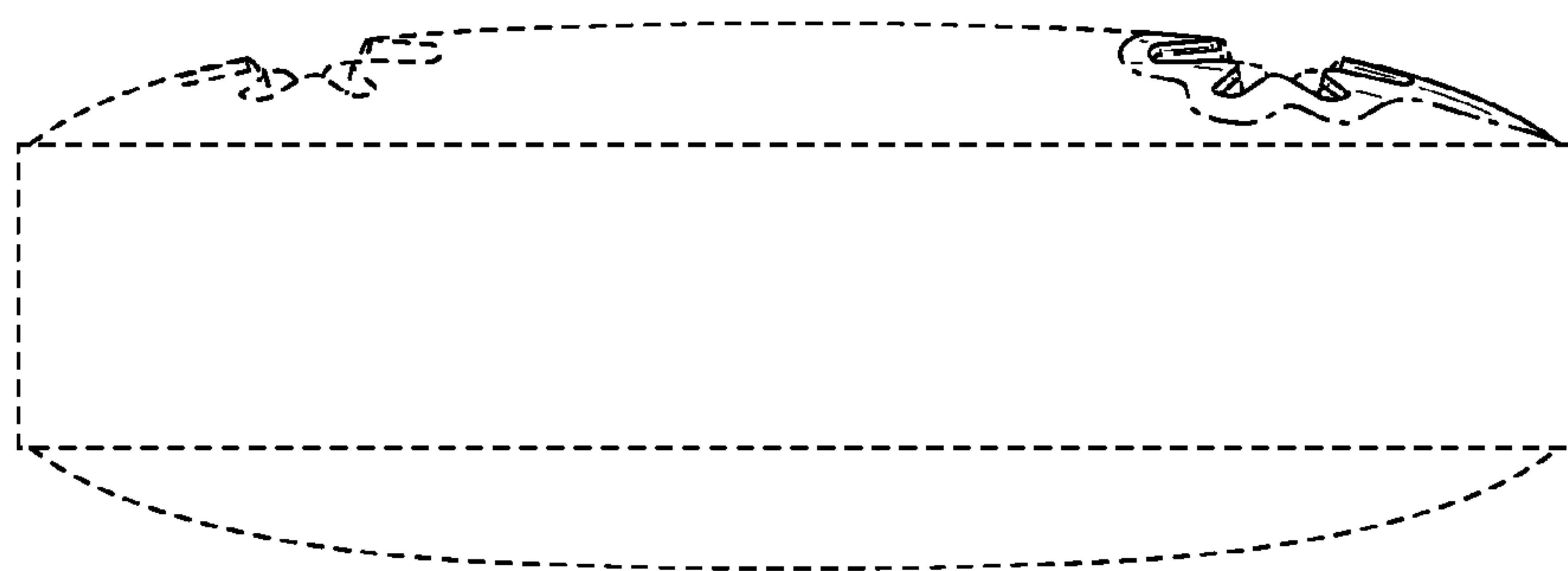

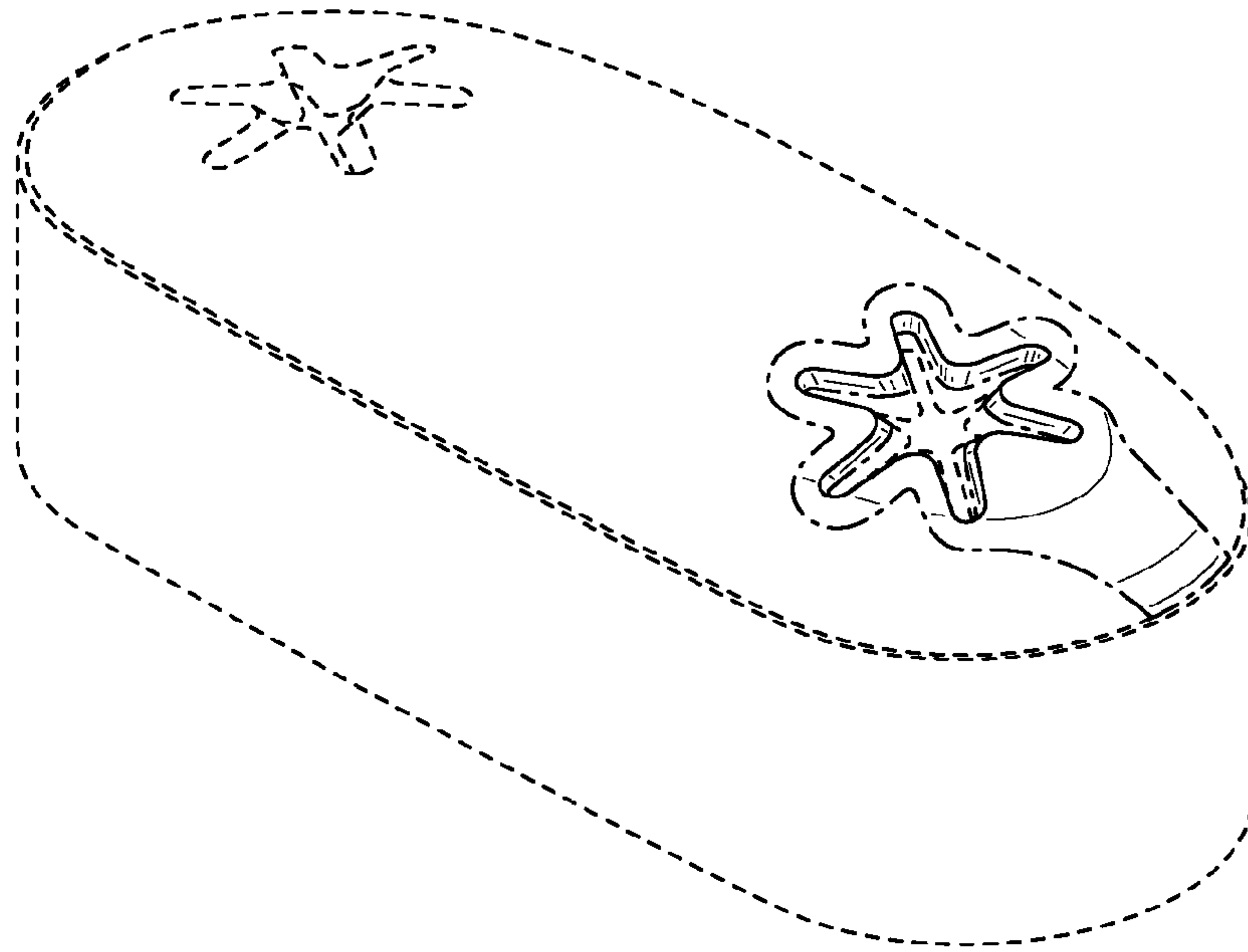

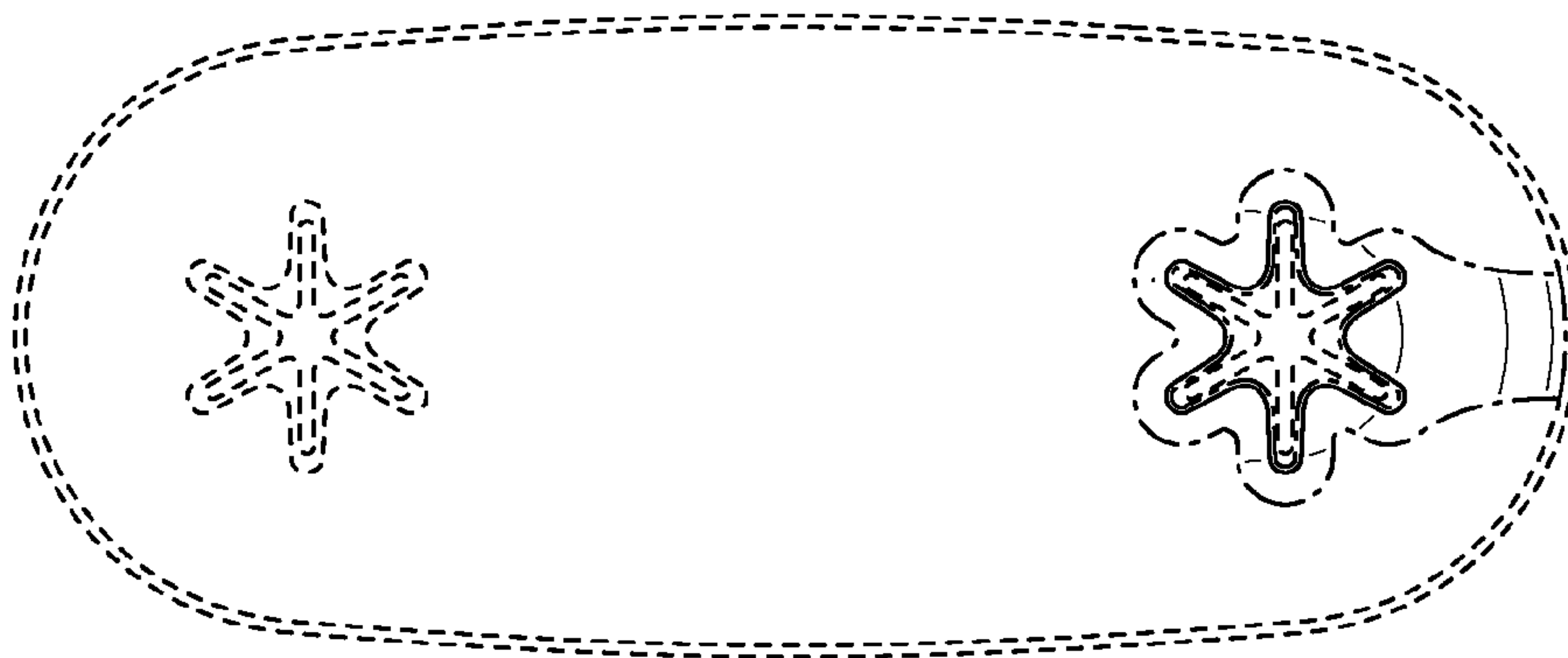

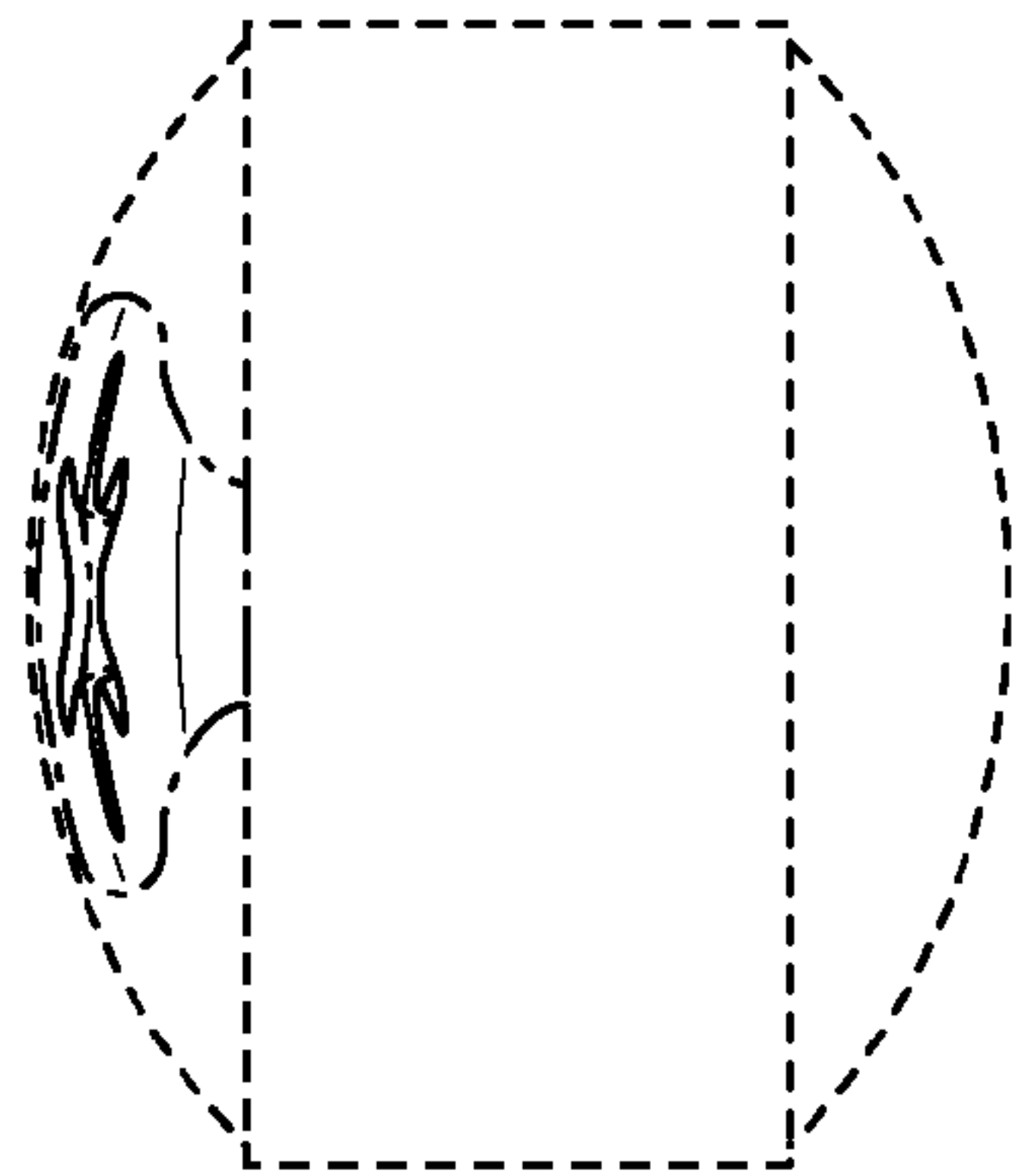

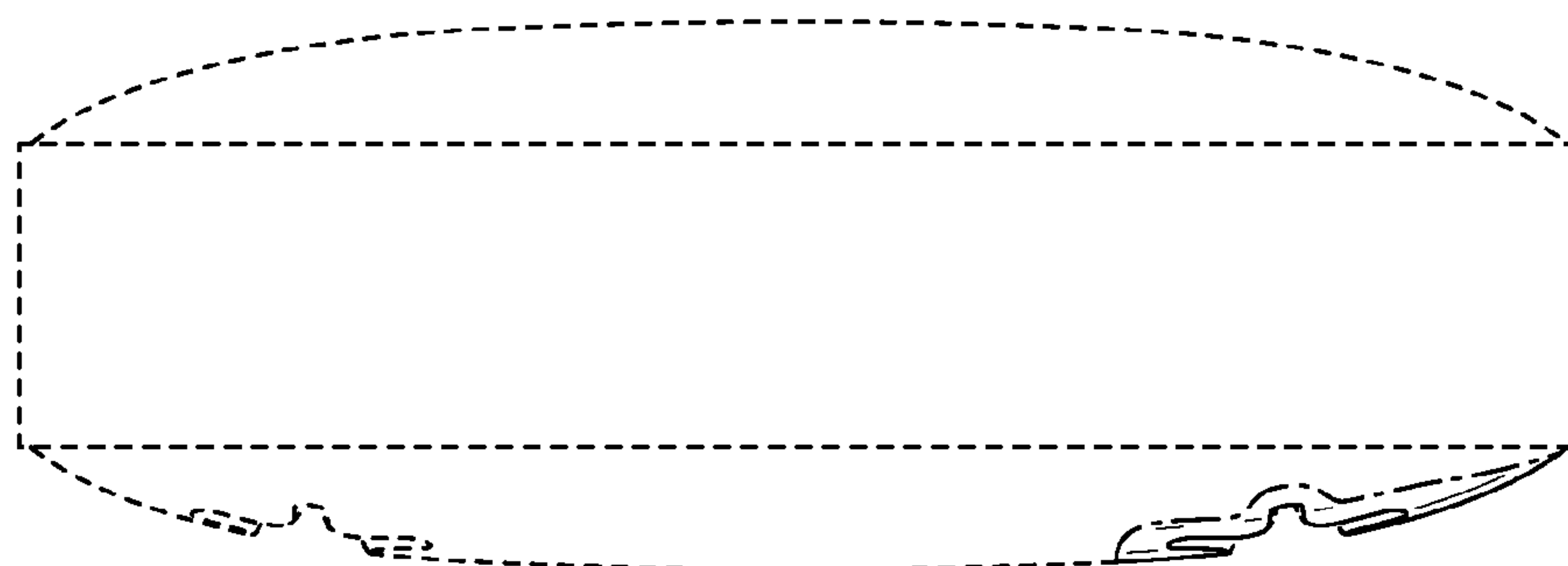

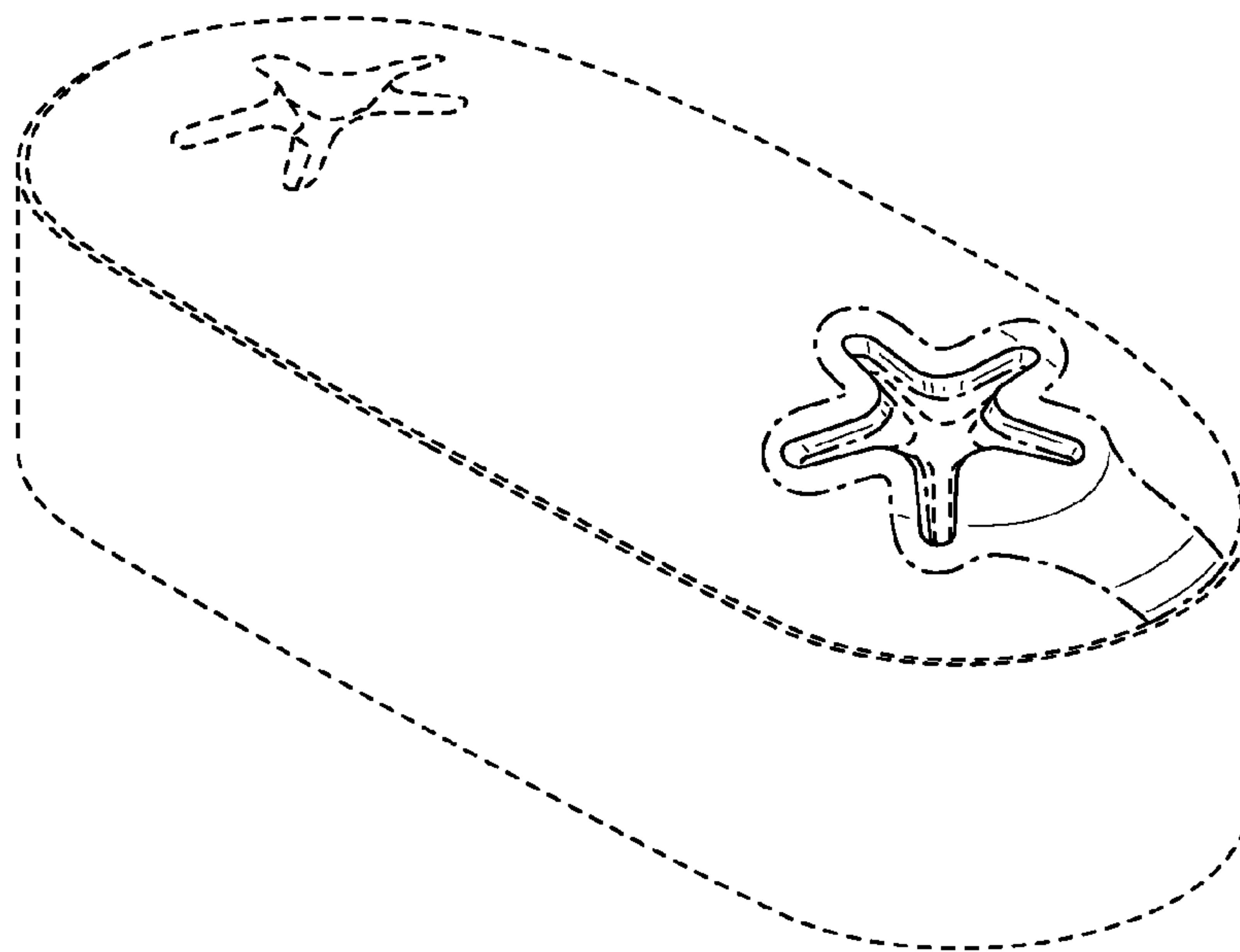

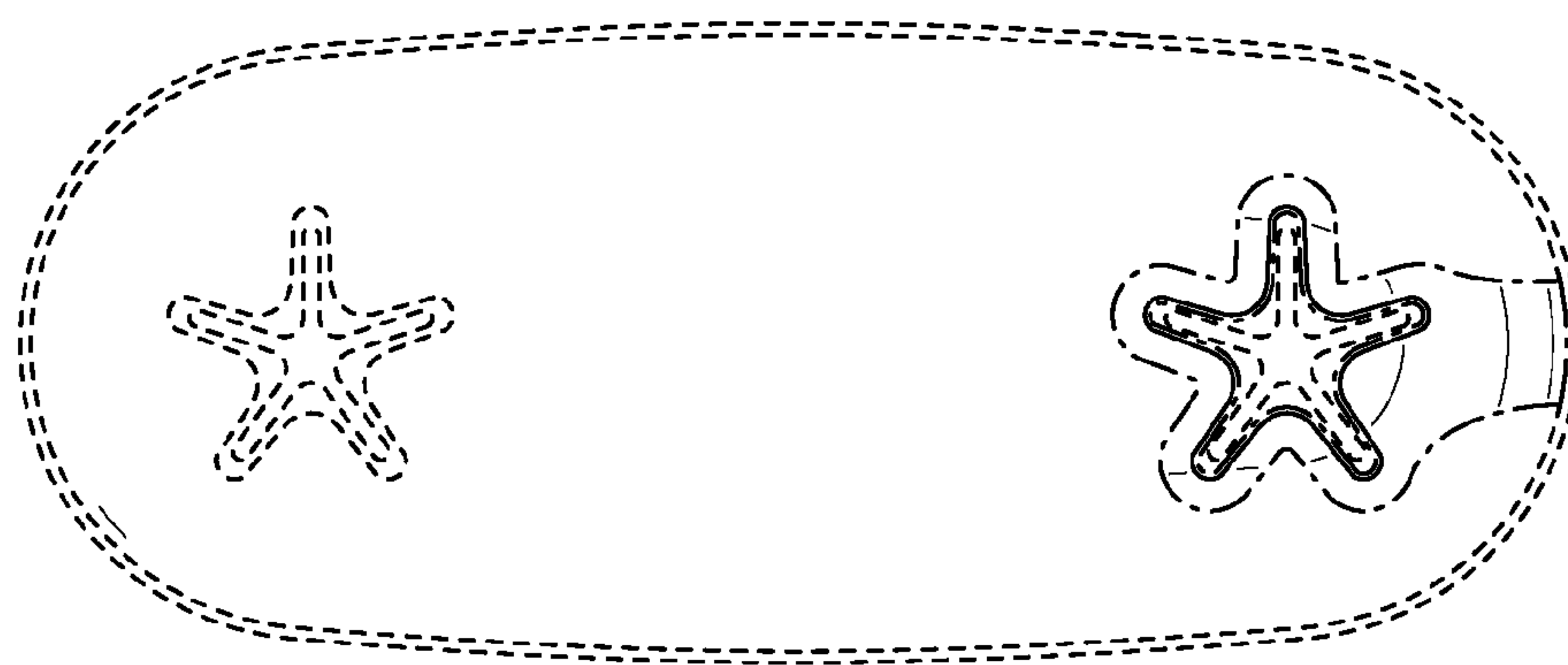

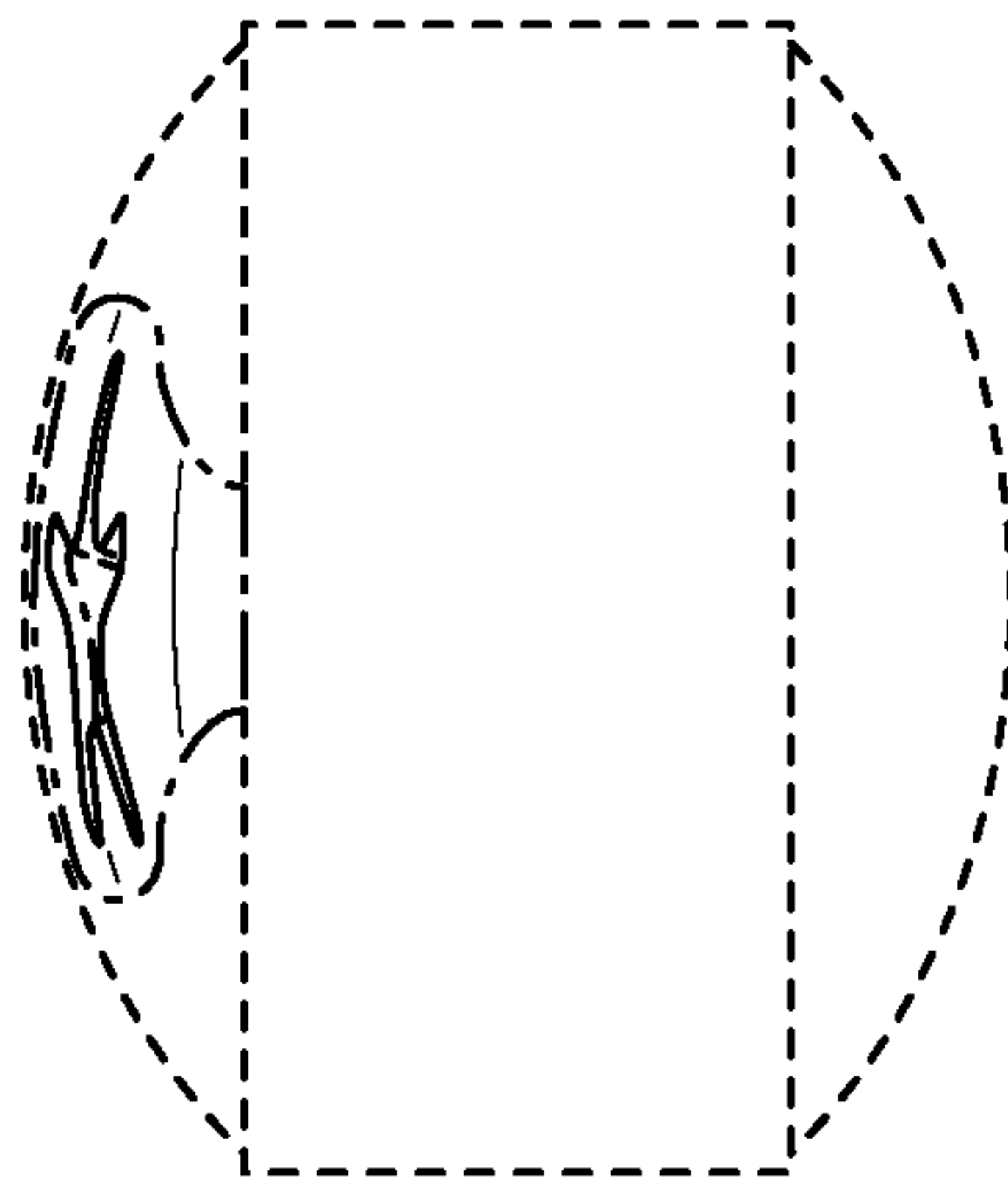

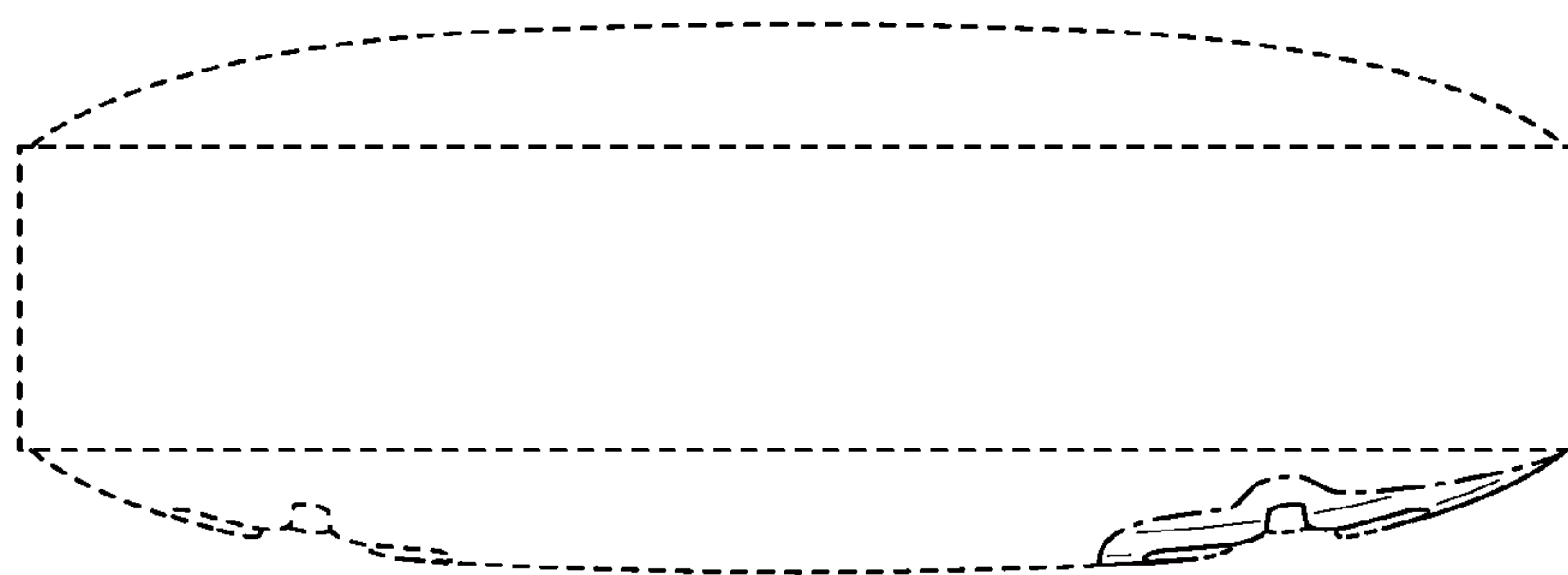

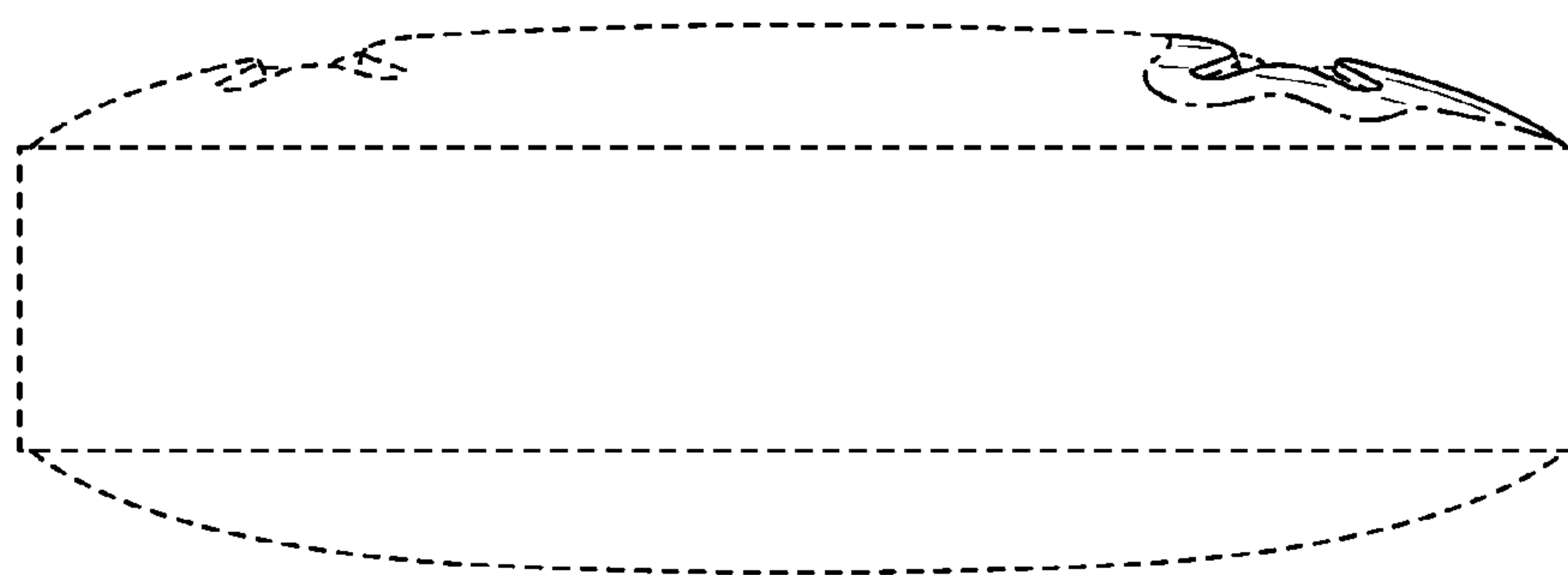

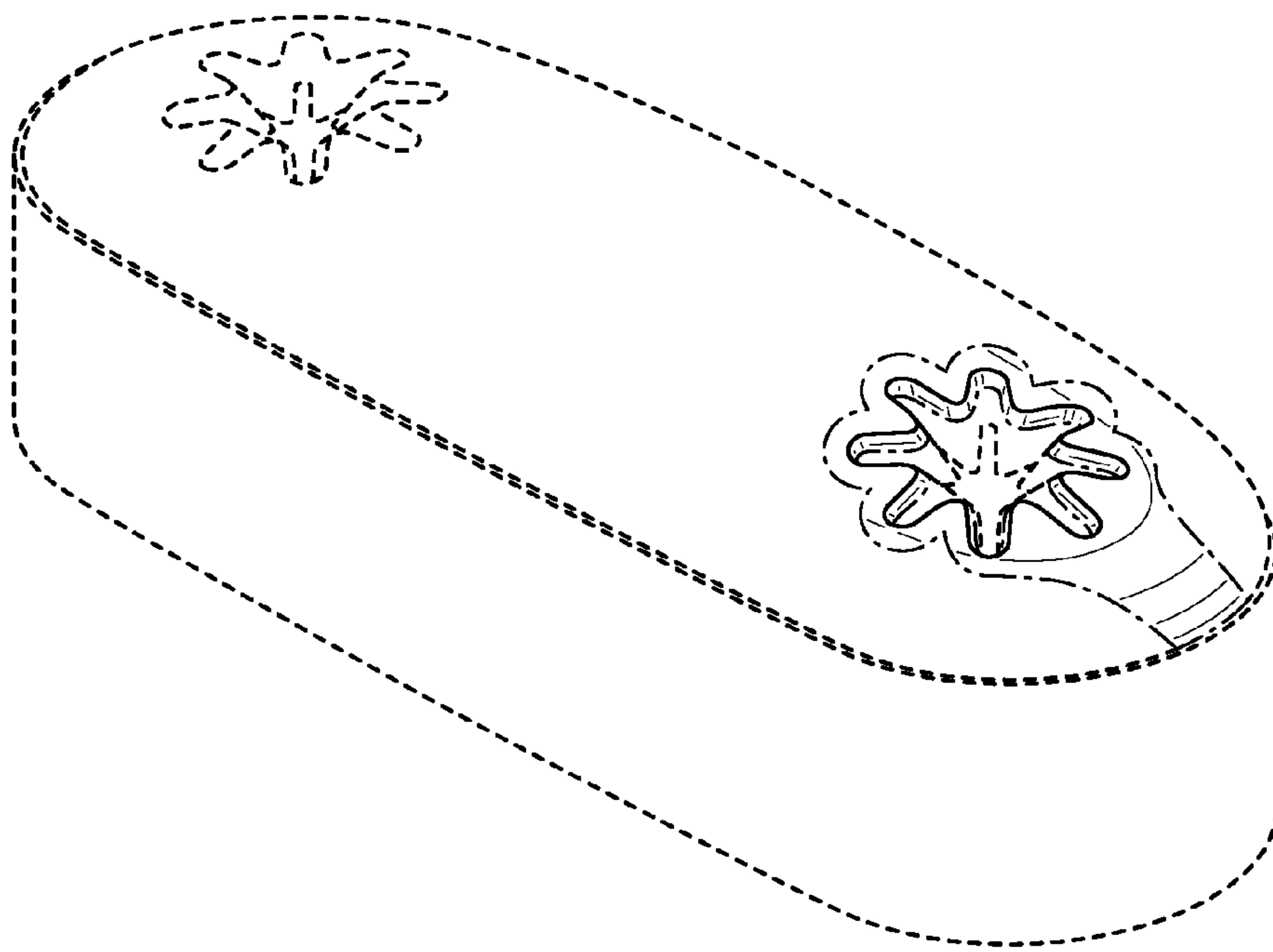

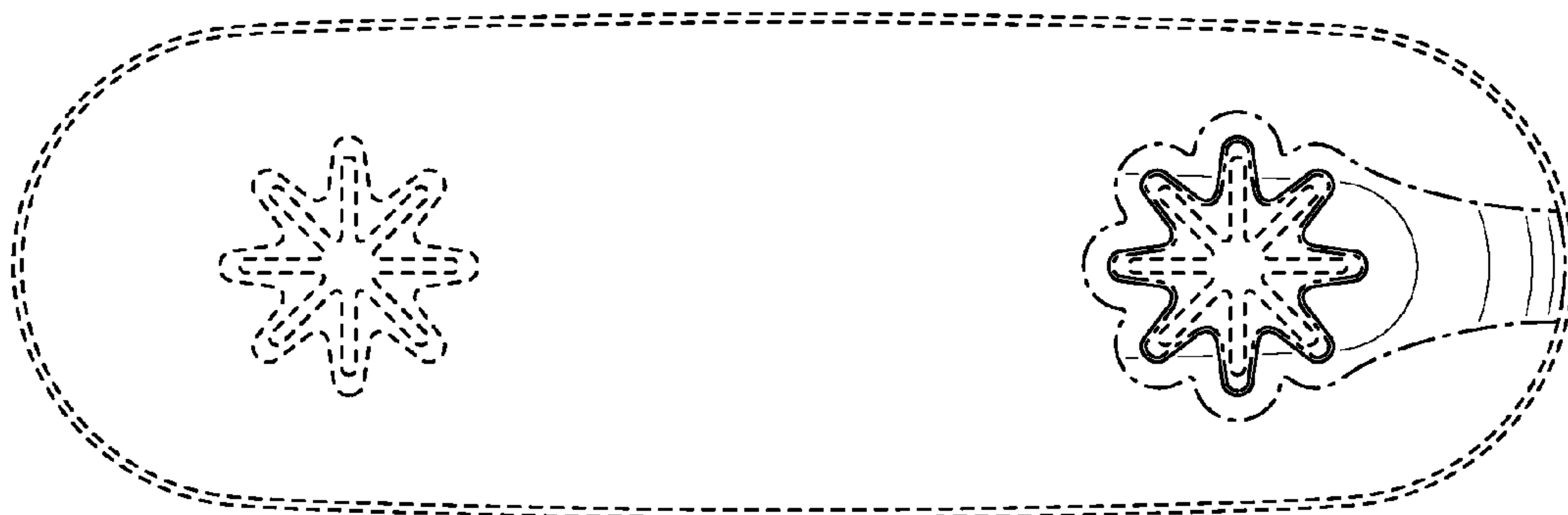

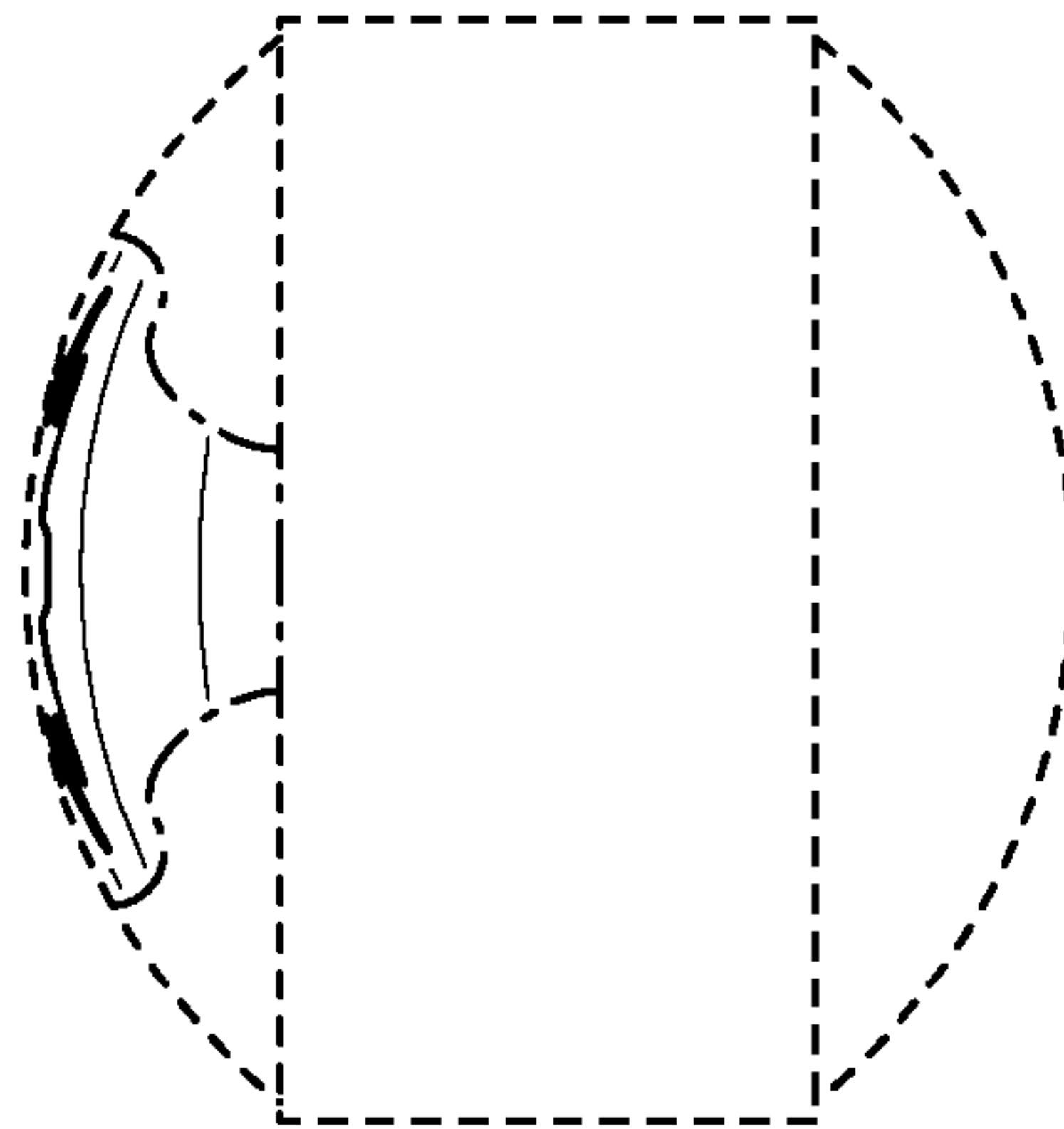

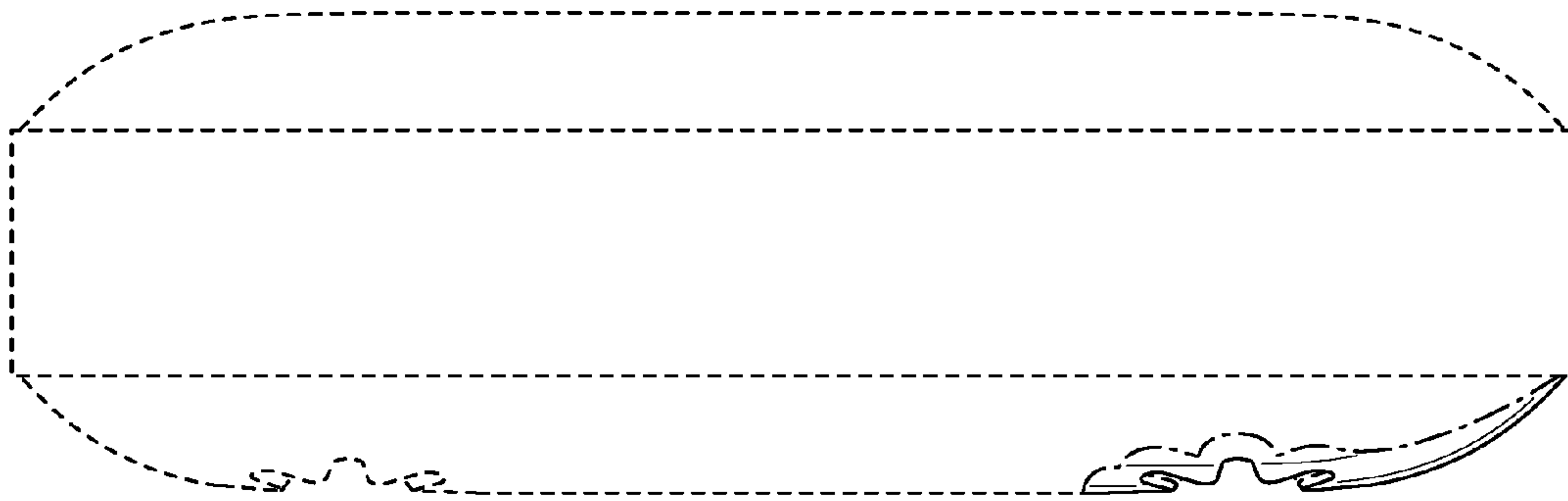

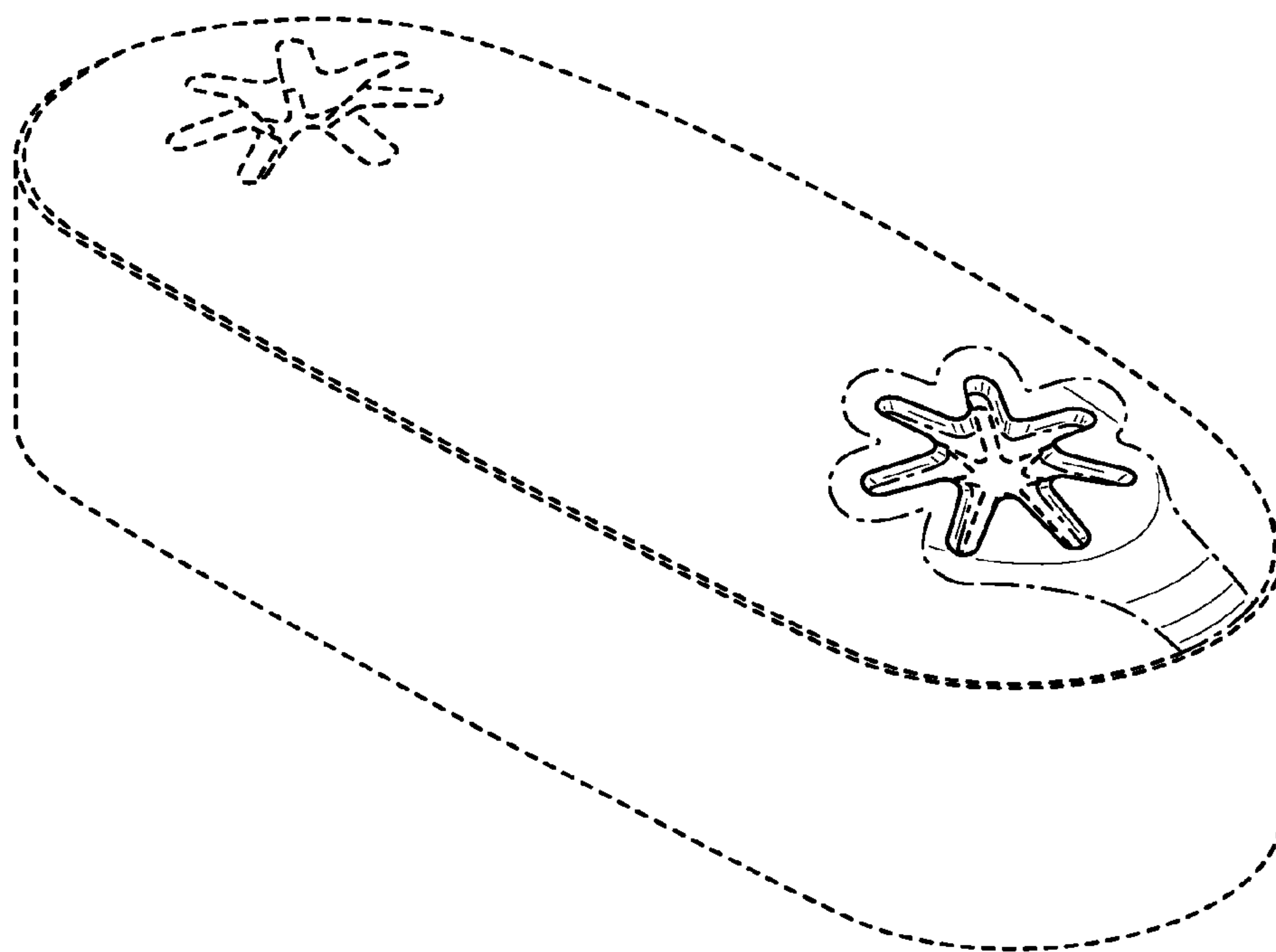

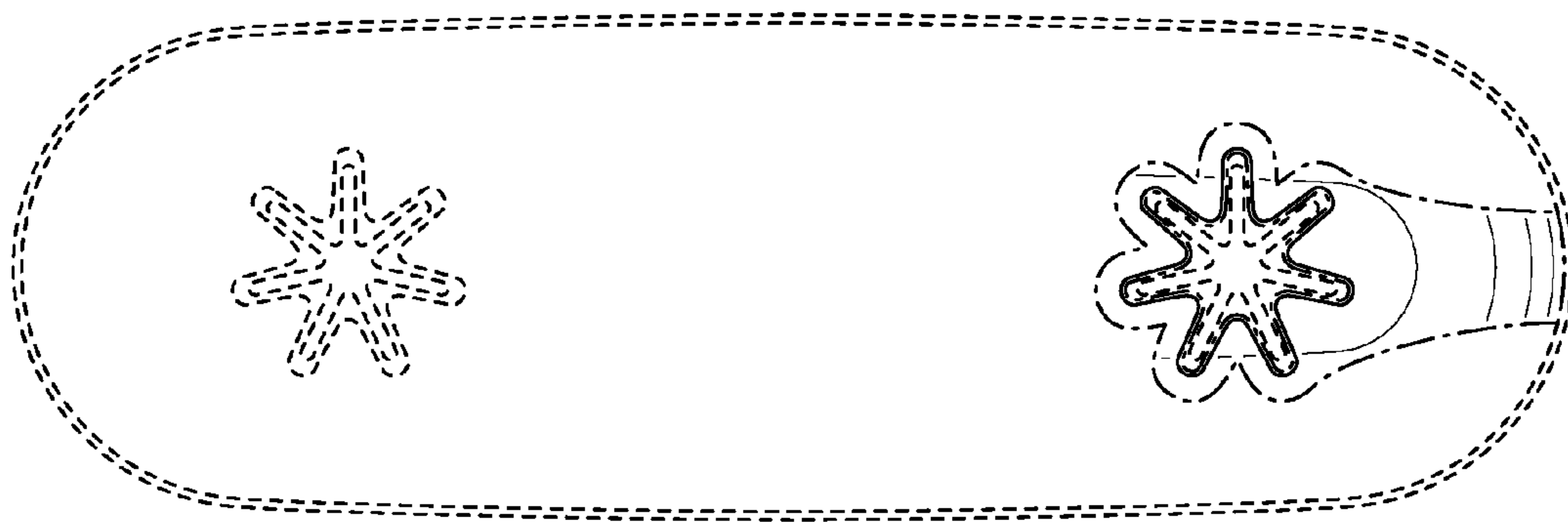

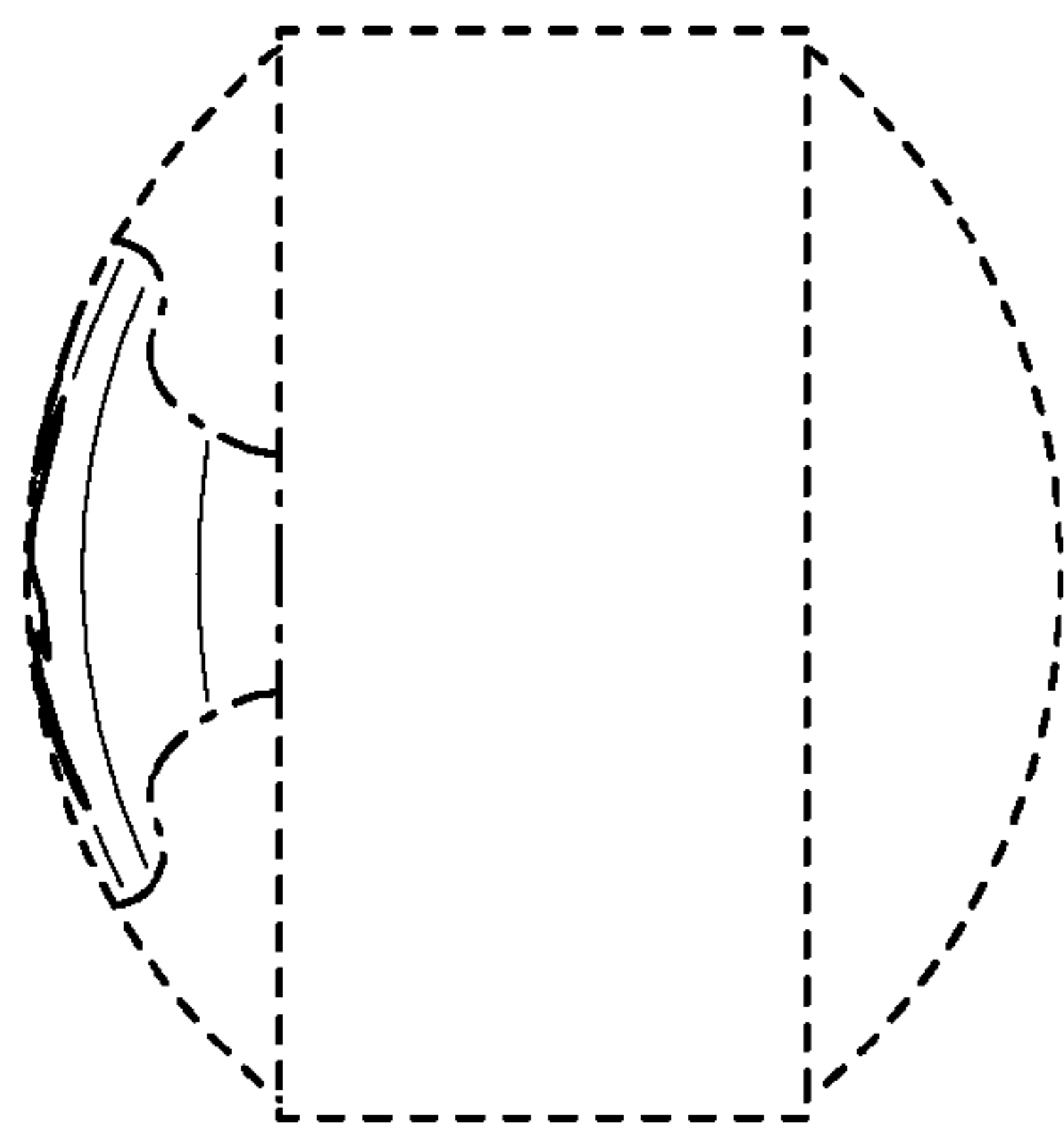

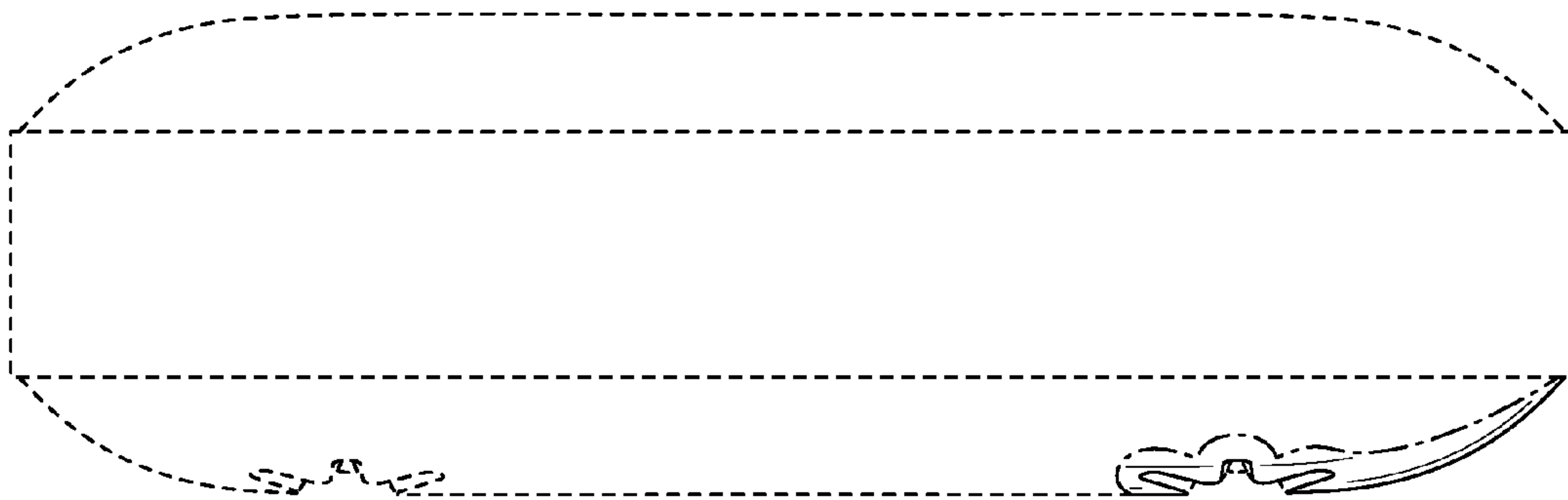

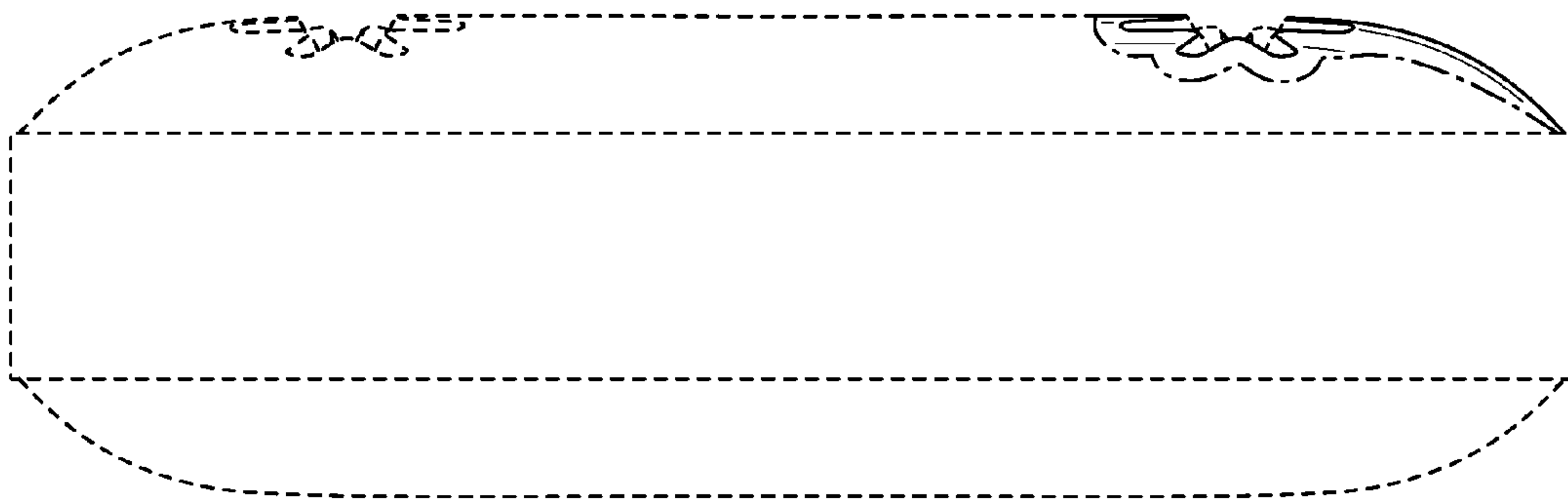

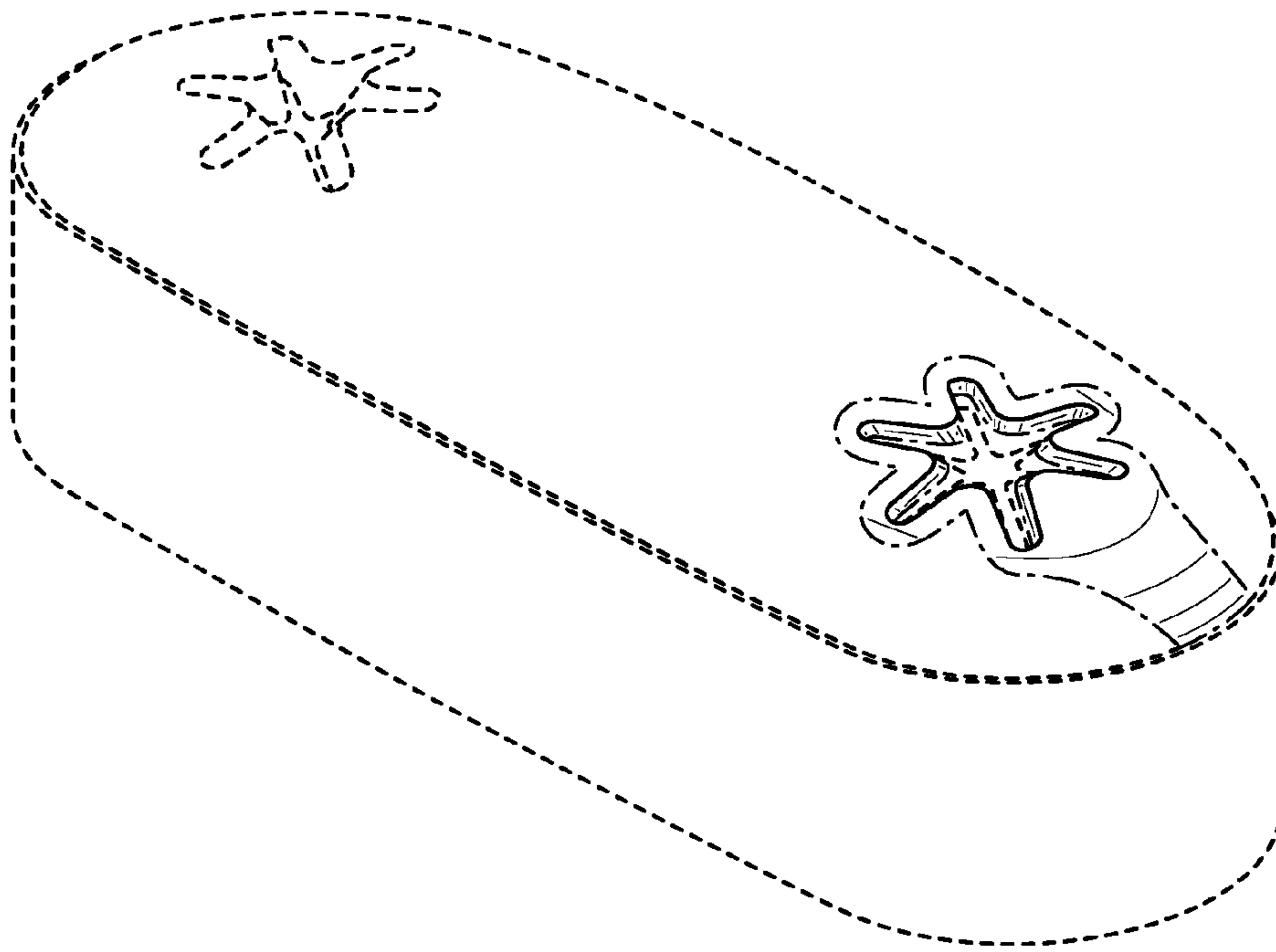

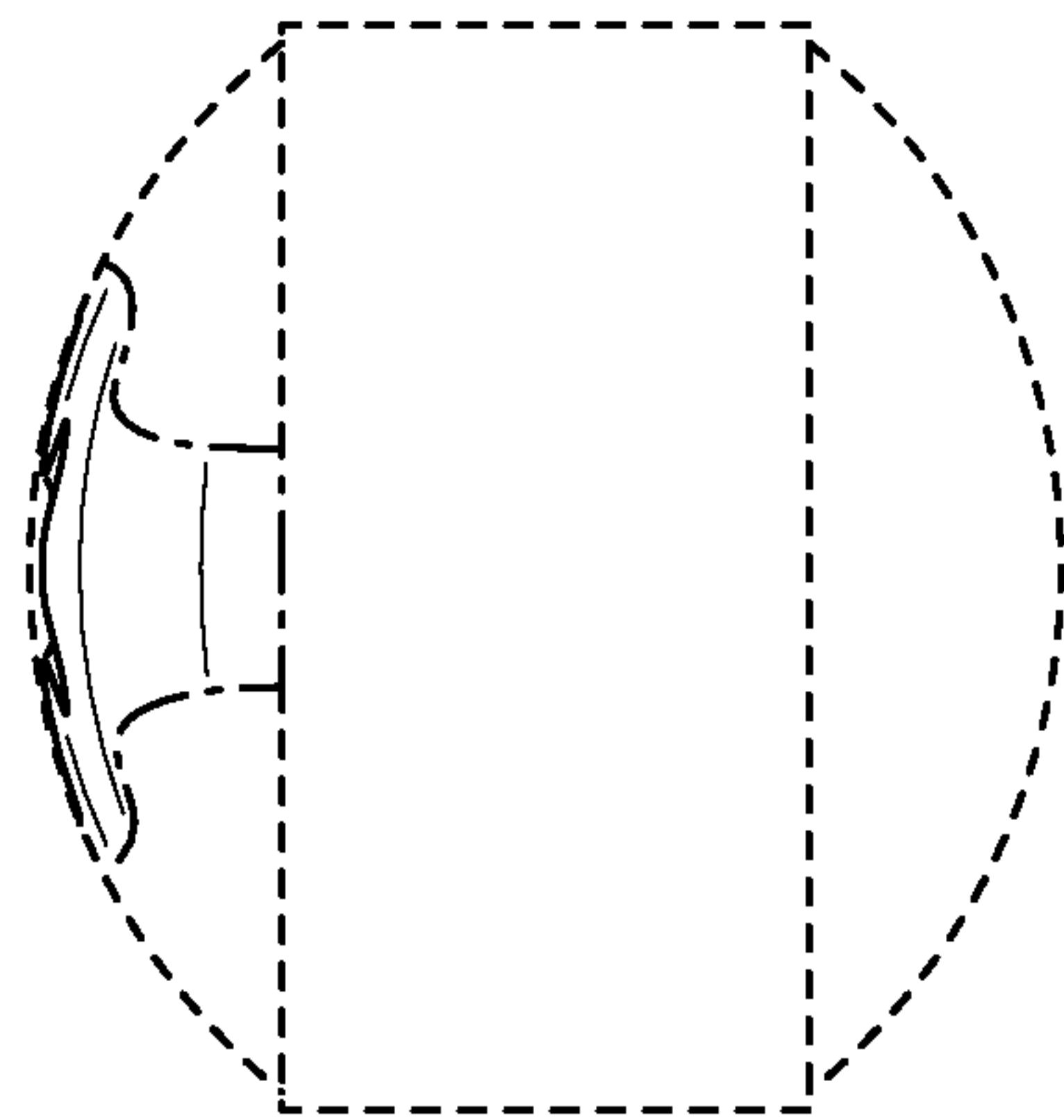

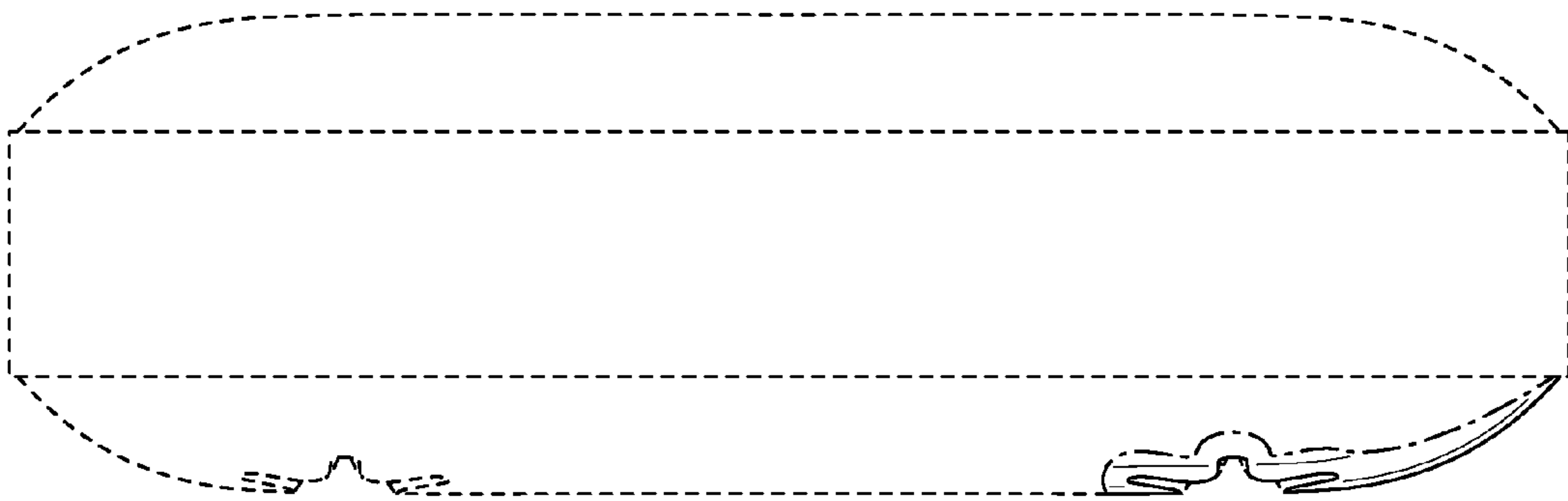

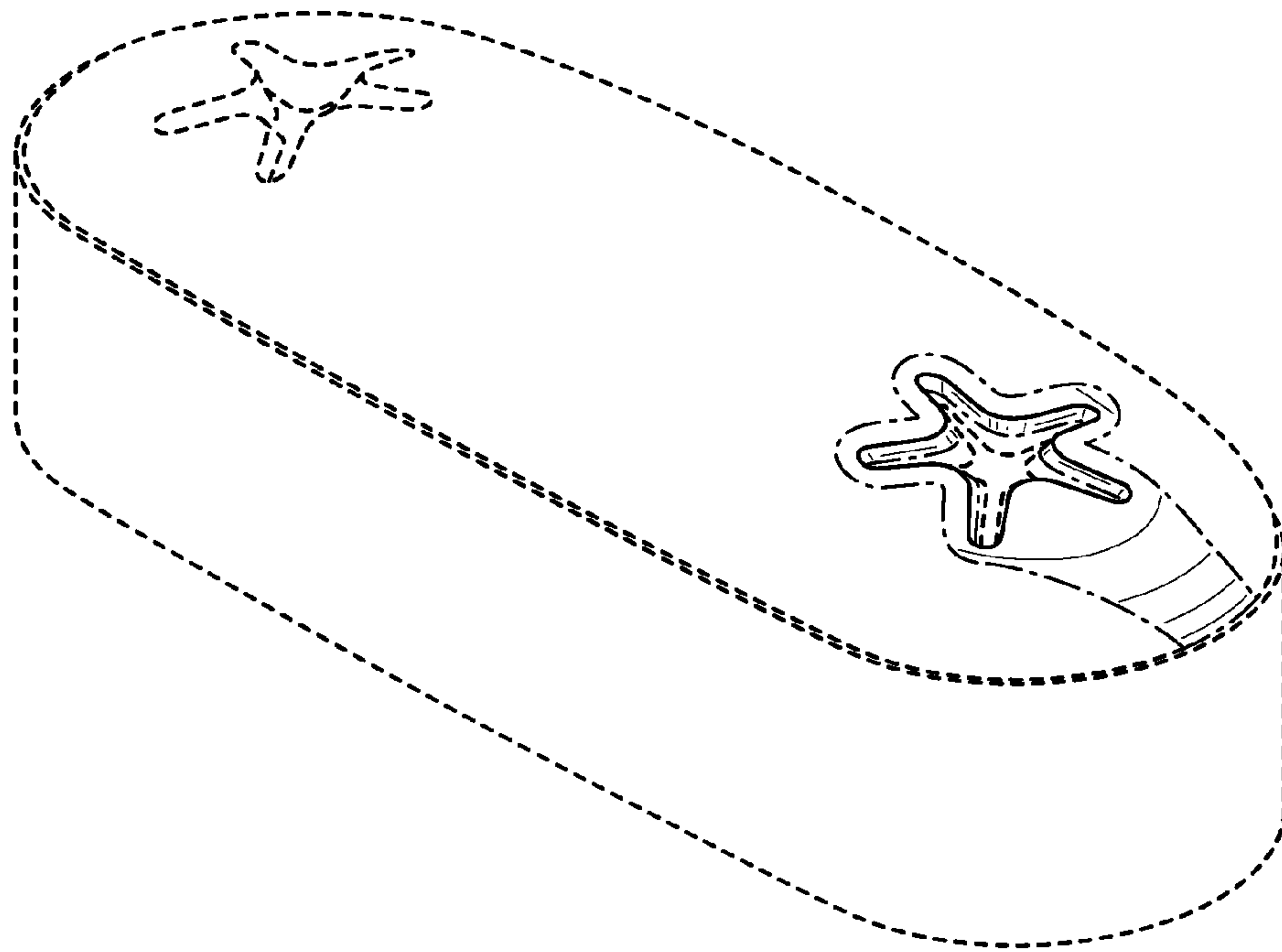

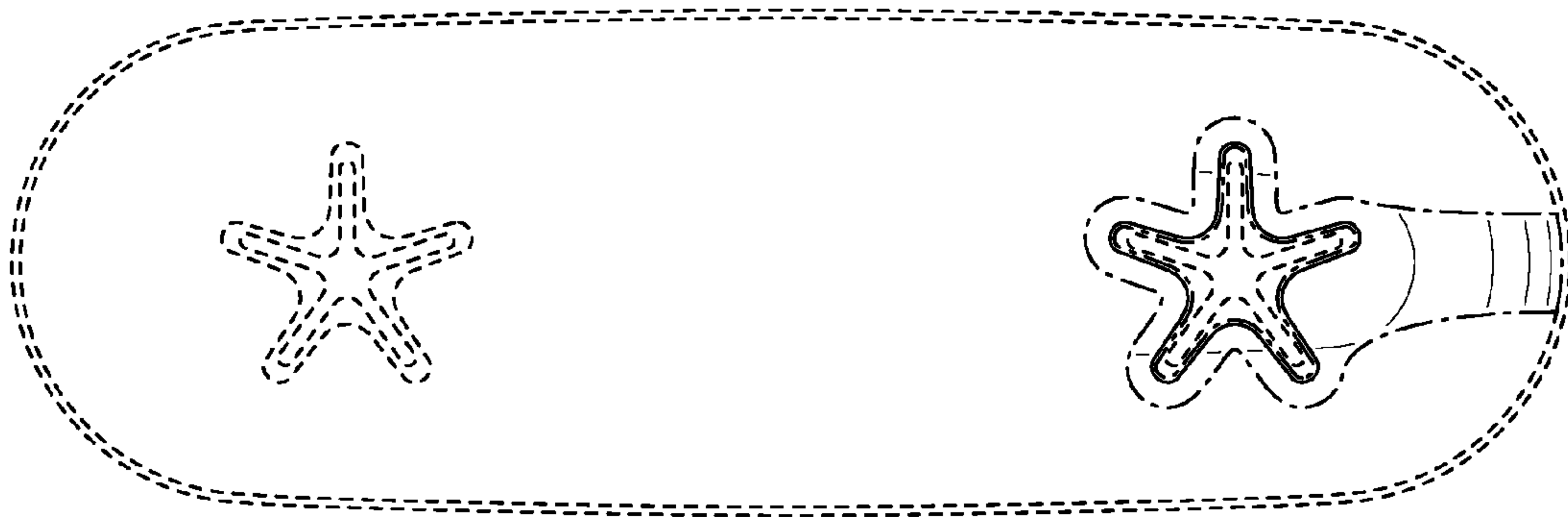

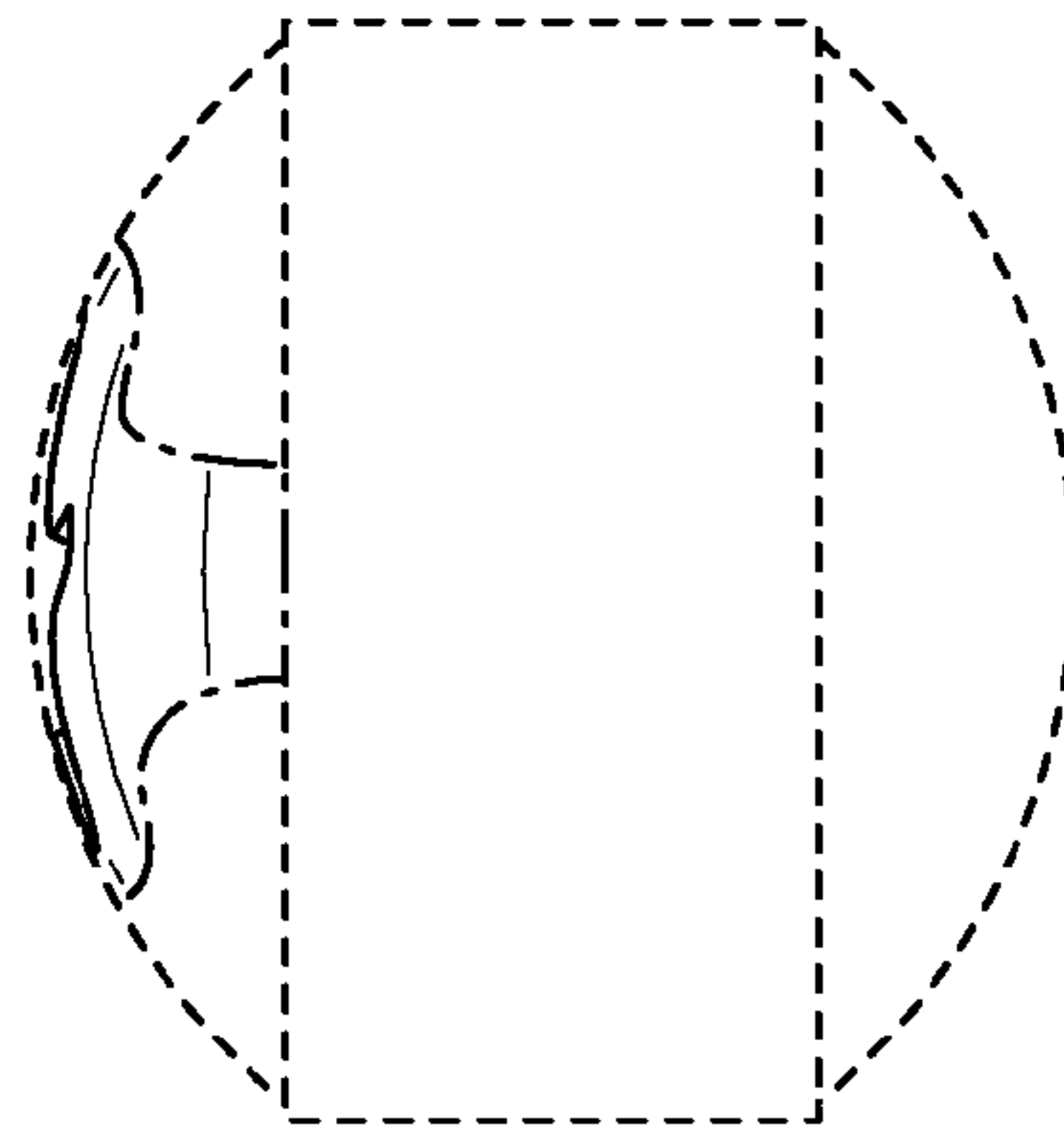

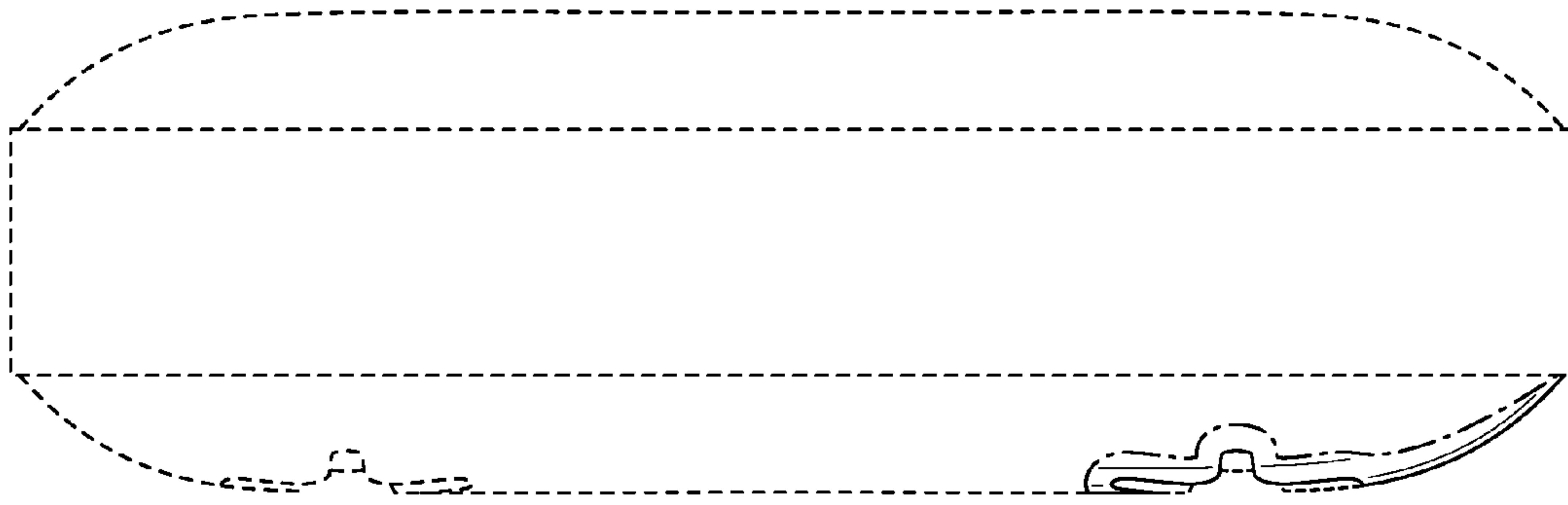

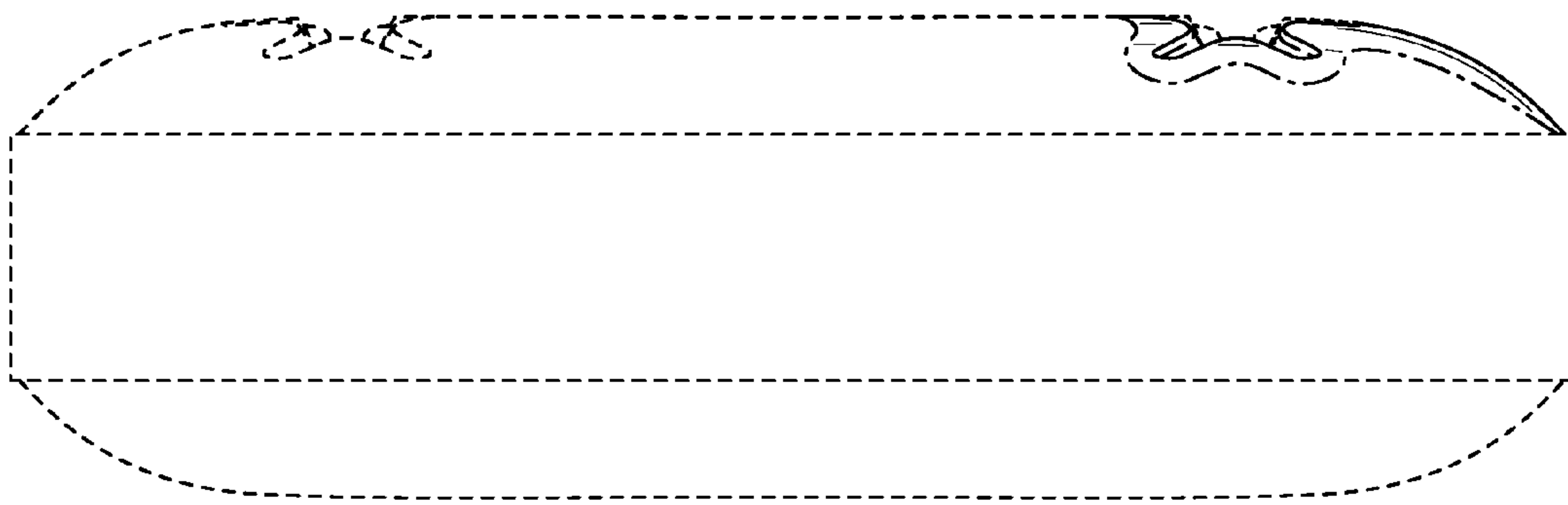
