(57) **CLAIM**

The ornamental design for a medical bite block, as shown and described.

DESCRIPTION

FIG. 1 is a rear view of a medical bite block showing our new design;
FIG. 2 is a front view of the medical bite block shown in FIG. 1;
FIG. 3 is a right side view of the medical bite block shown in FIG. 1, the left side view being a mirror image of the right side view;

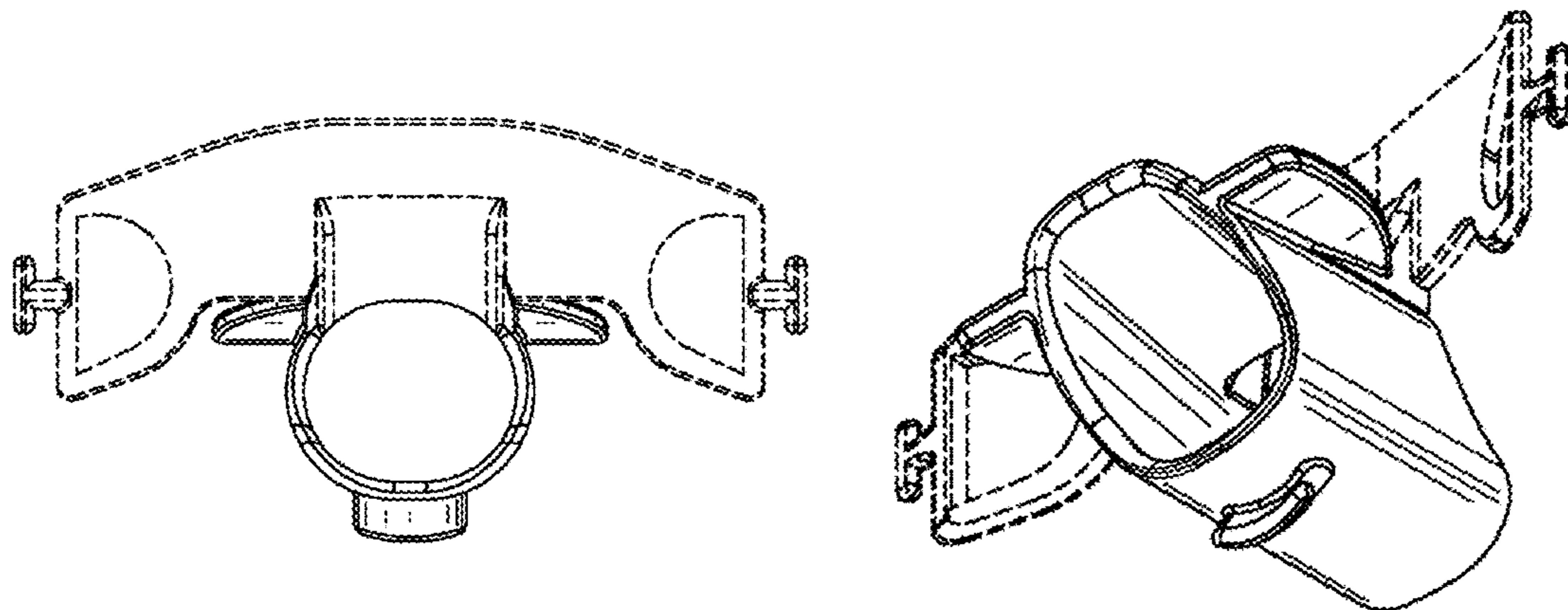


FIG. 4 is a top view of the medical bite block shown in FIG. 1;

FIG. 5 is a bottom view of the medical bite block shown in FIG. 1;

FIG. 6 is a top right perspective view of the medical bite block shown in FIG. 1; and,

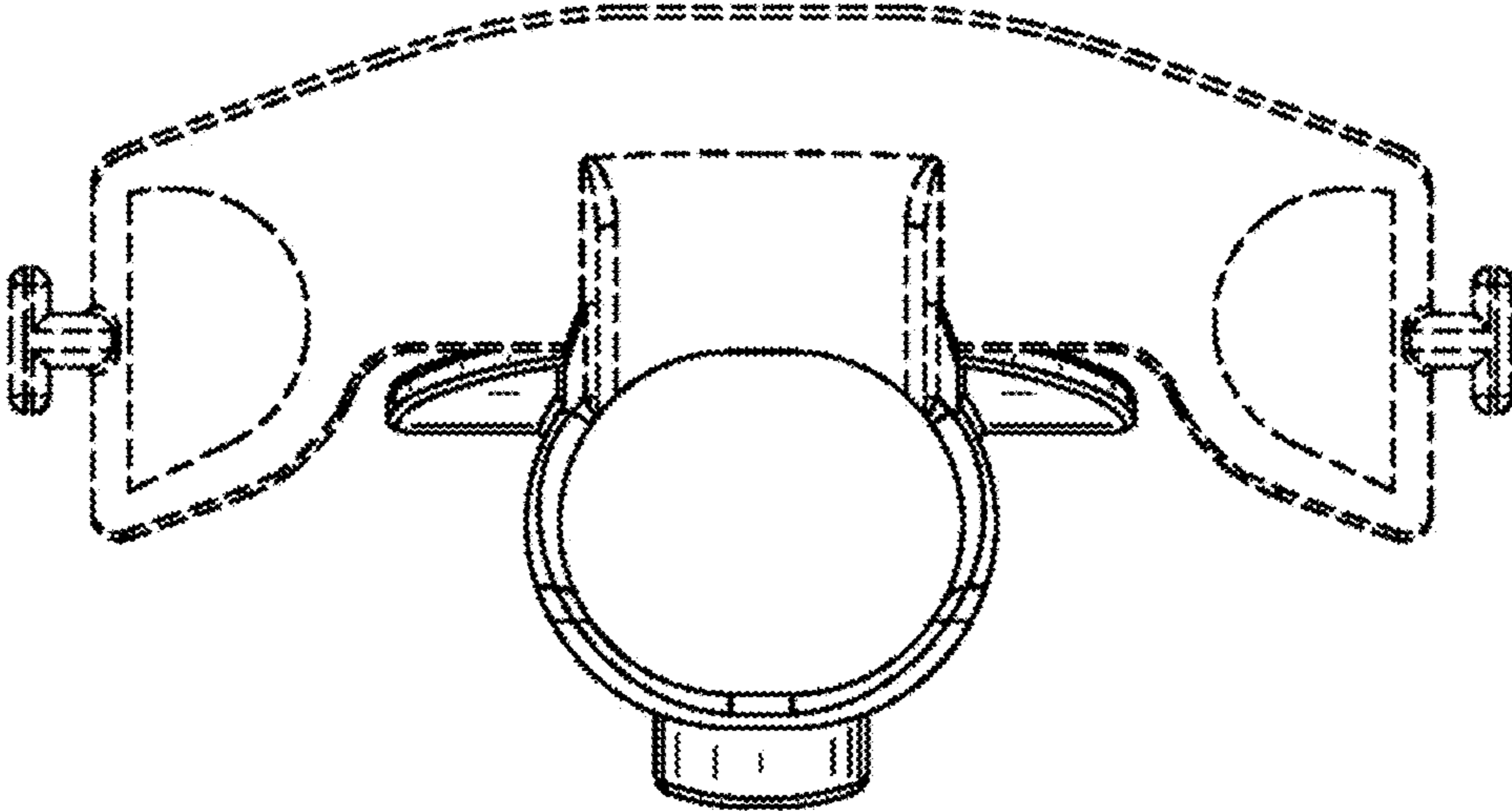

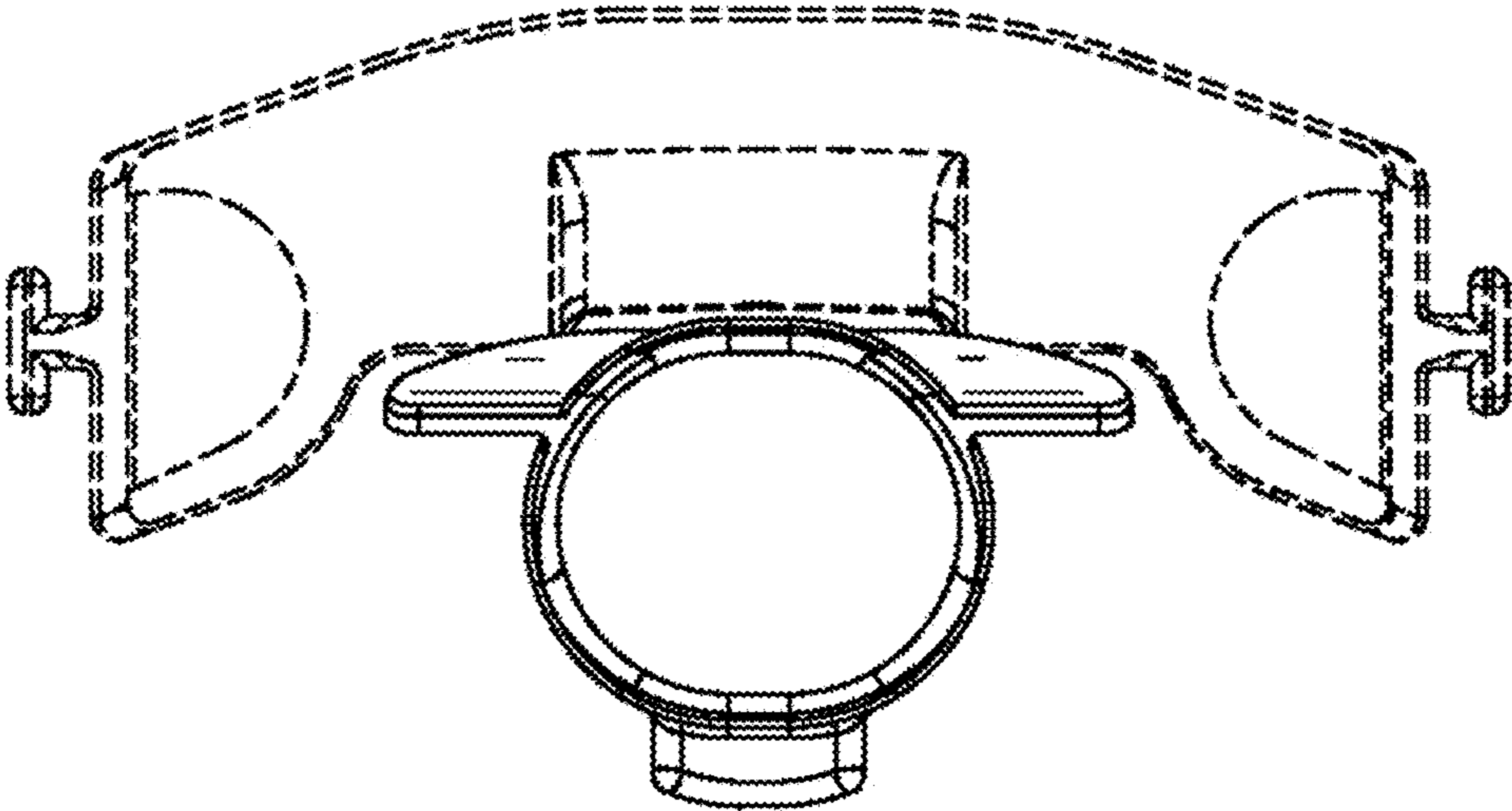

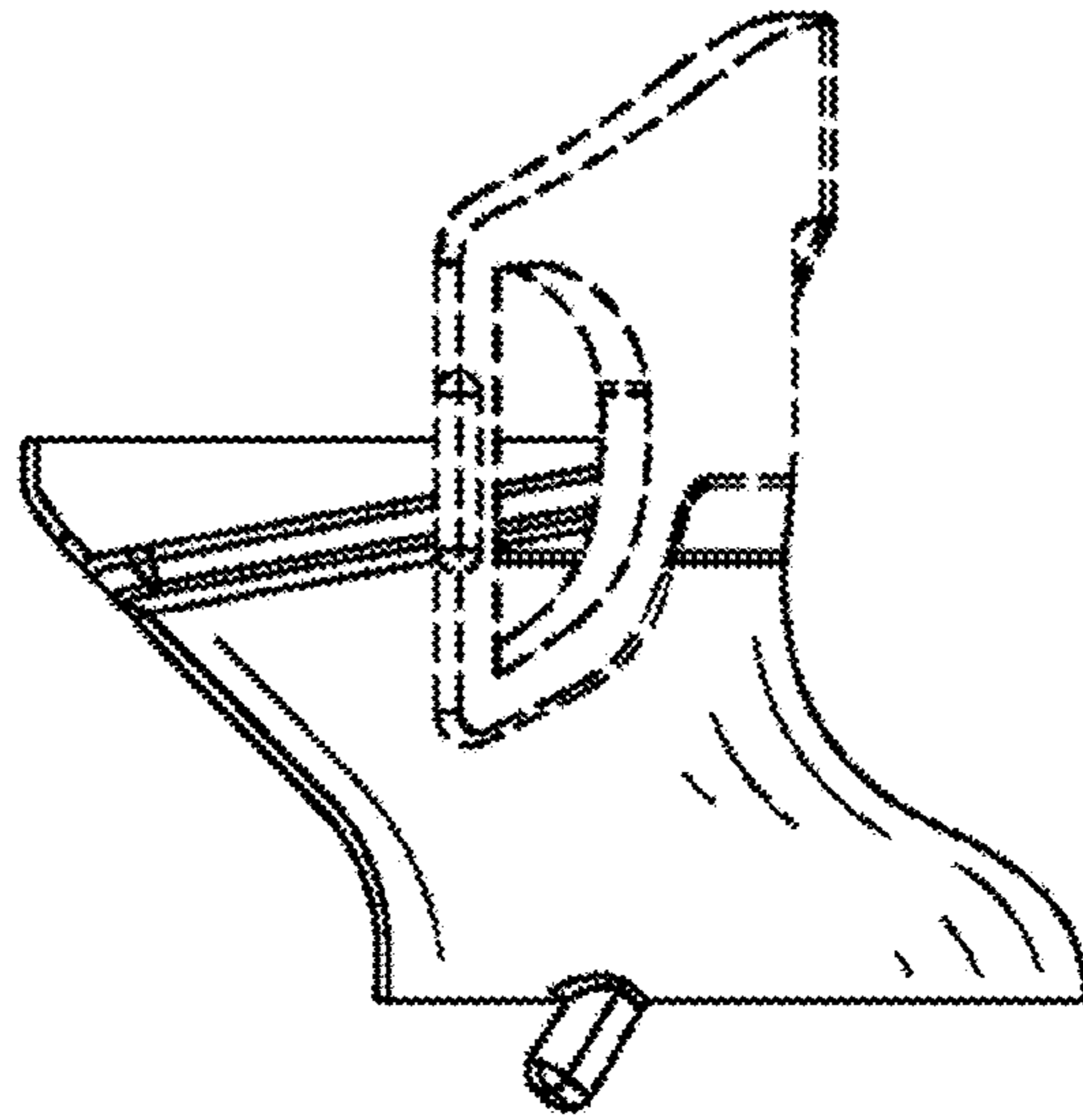

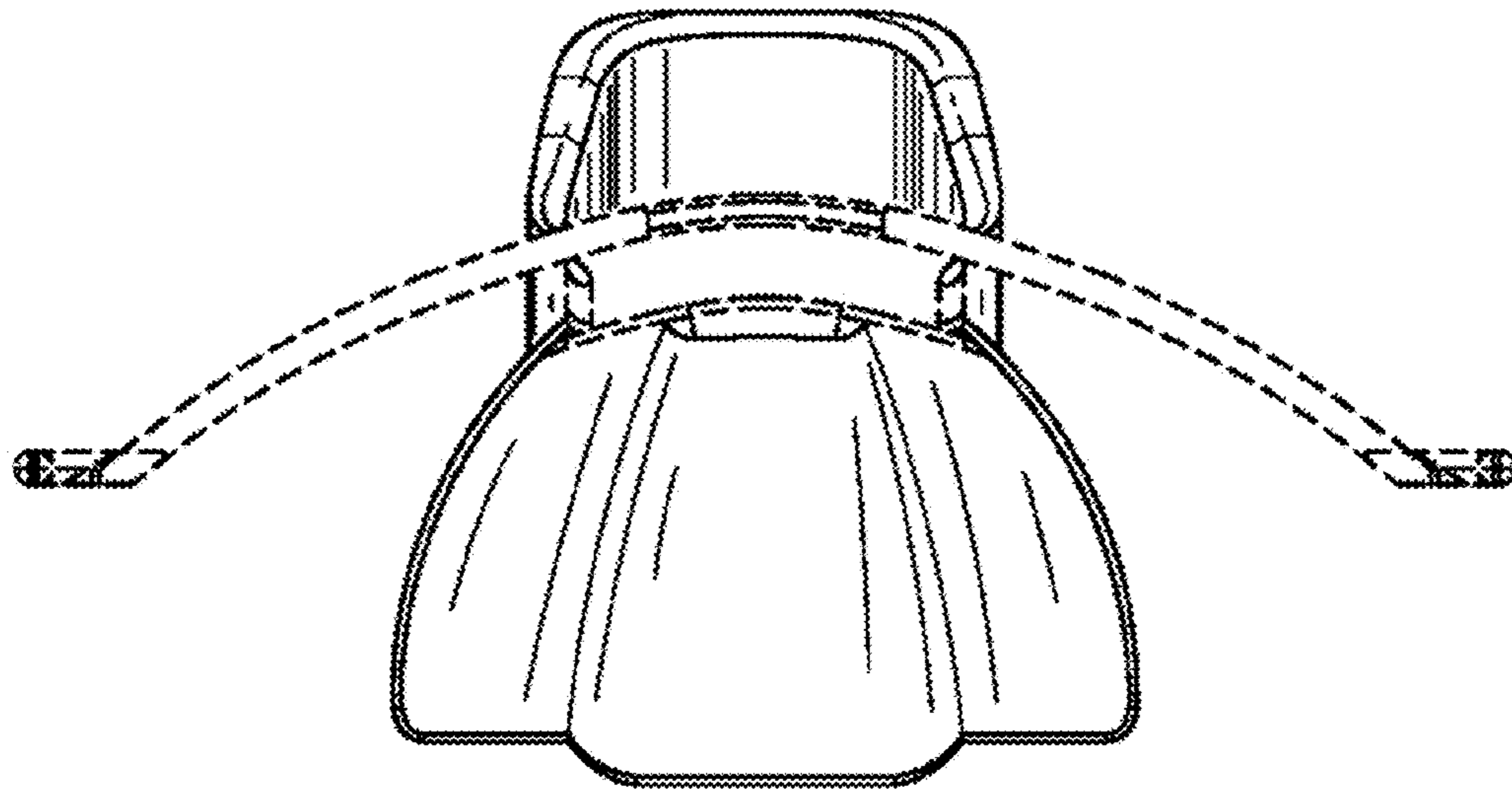

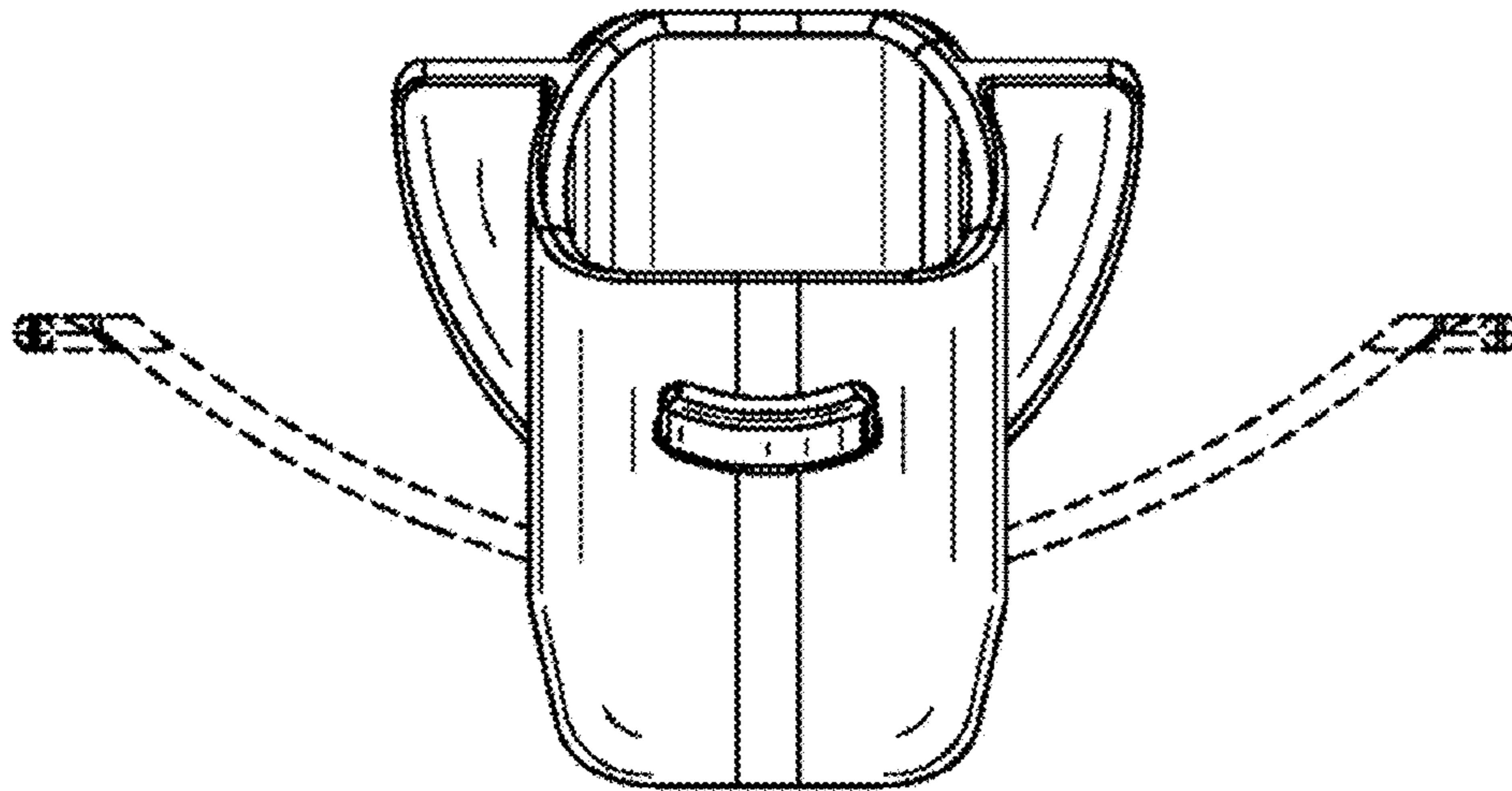

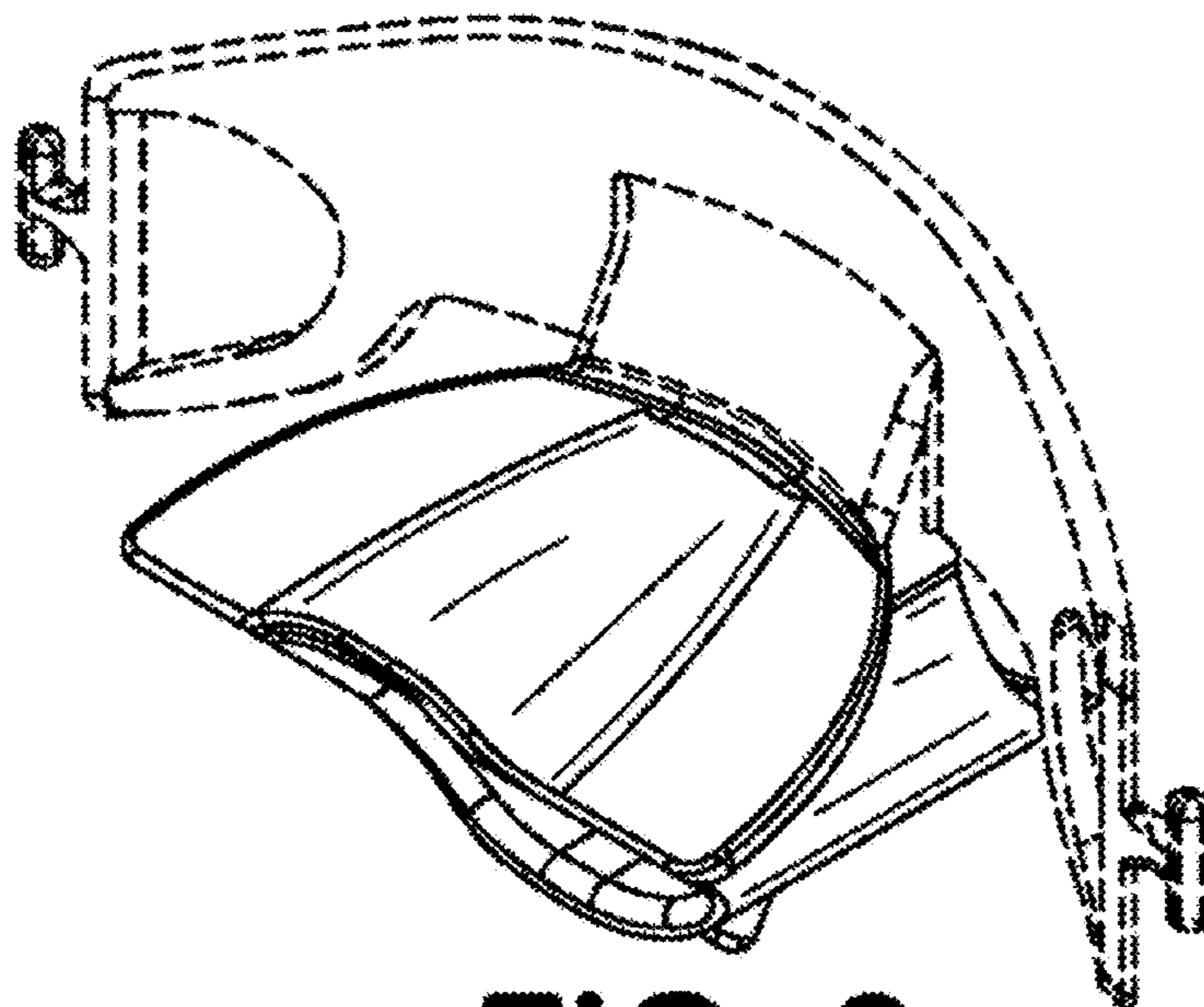

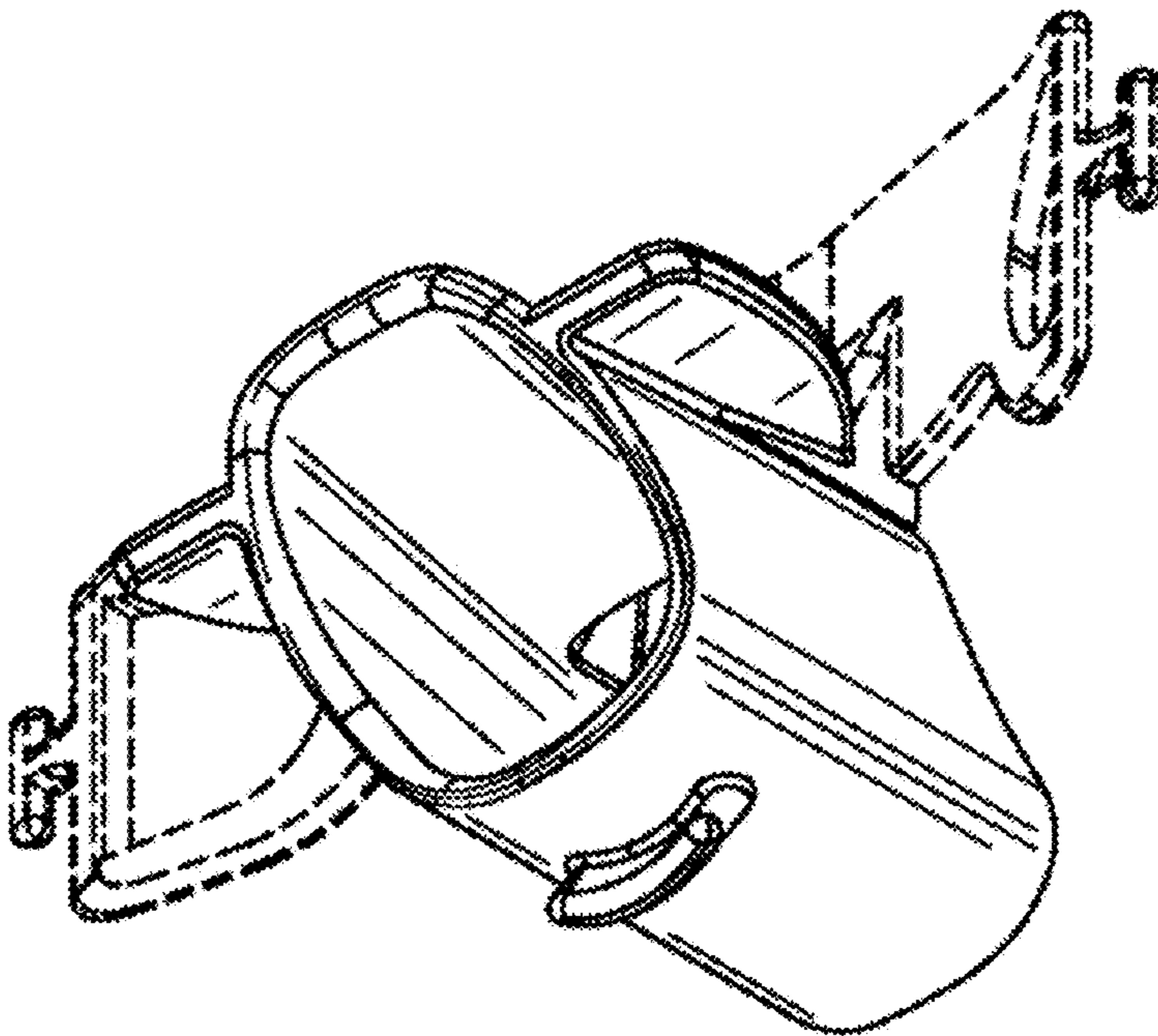
