DESCRIPTION

FIG. 1 is a right, front perspective view of a free-standing deck;

FIG. 2 is a left, rear perspective view thereof;

FIG. 4 is a left side elevational view thereof;

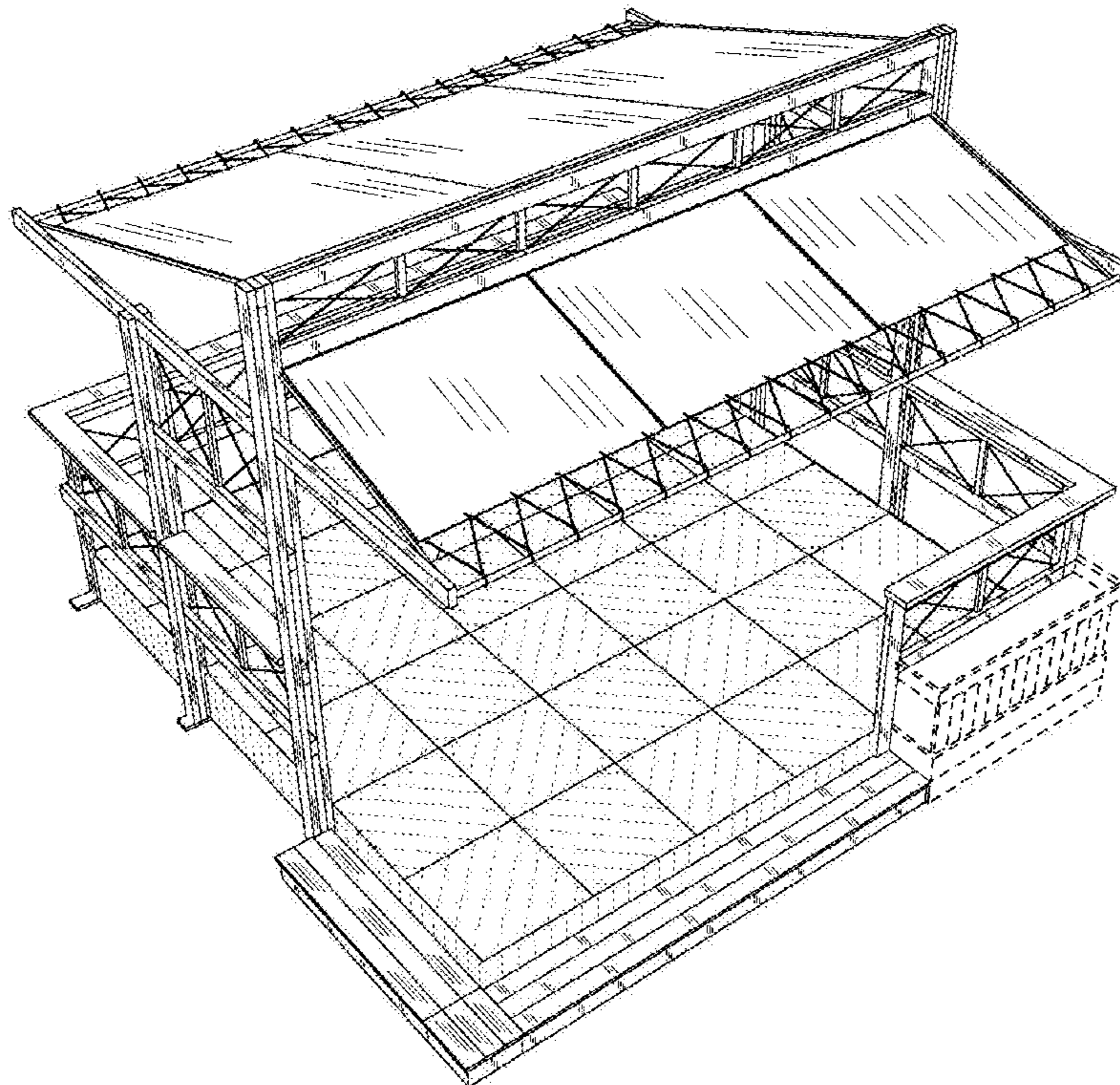
FIG. 5 is a right side elevational view thereof;

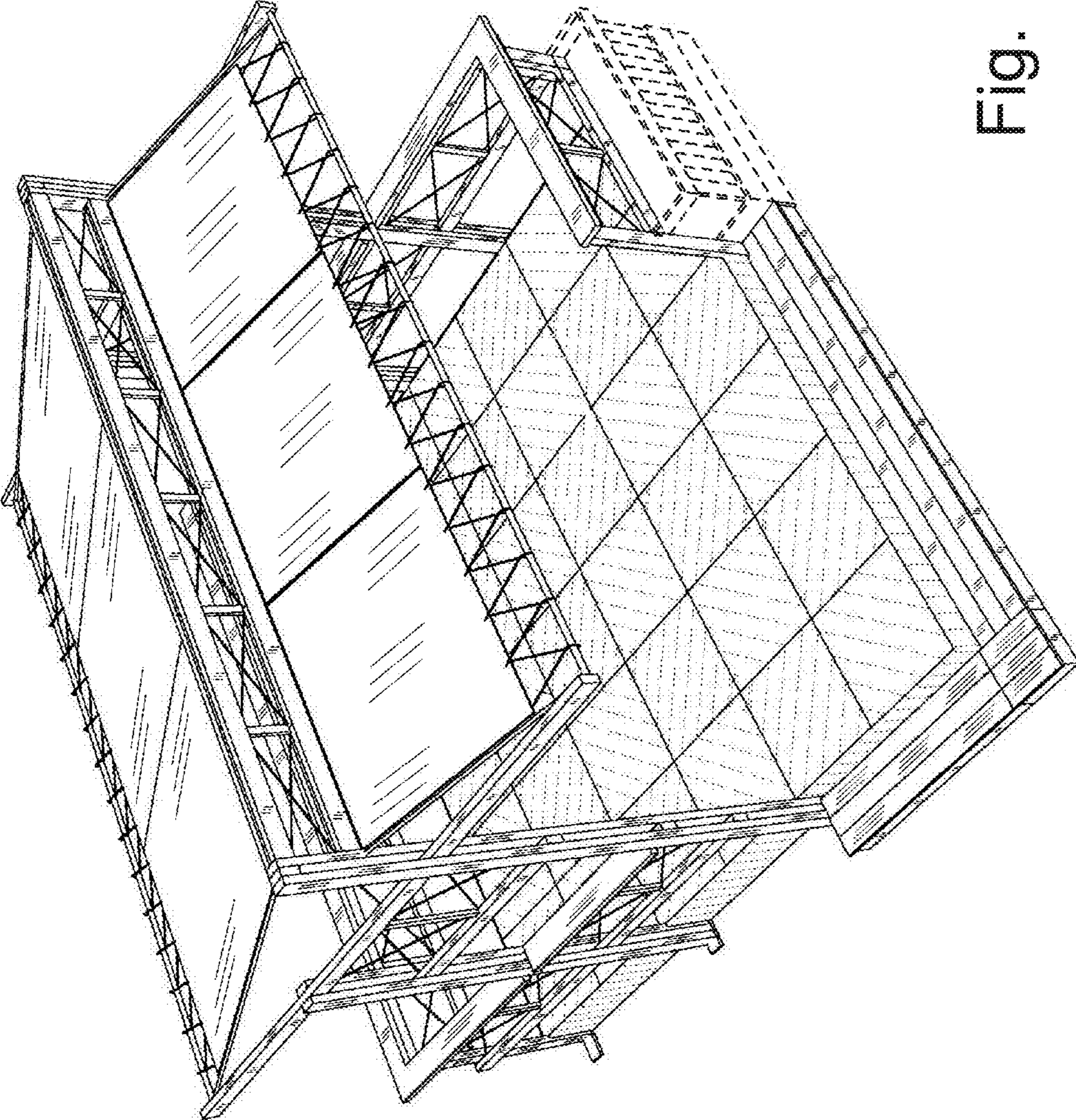

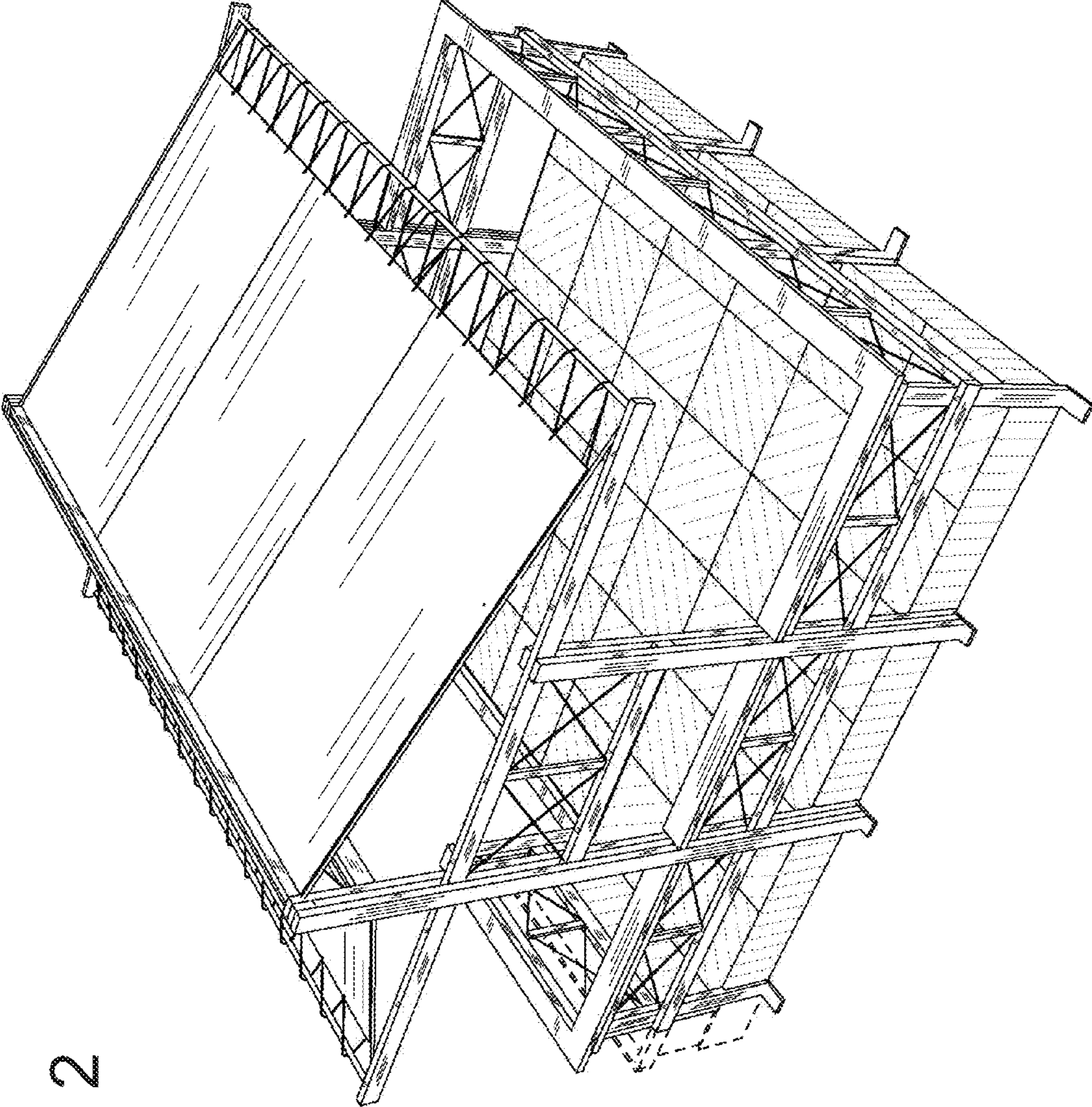

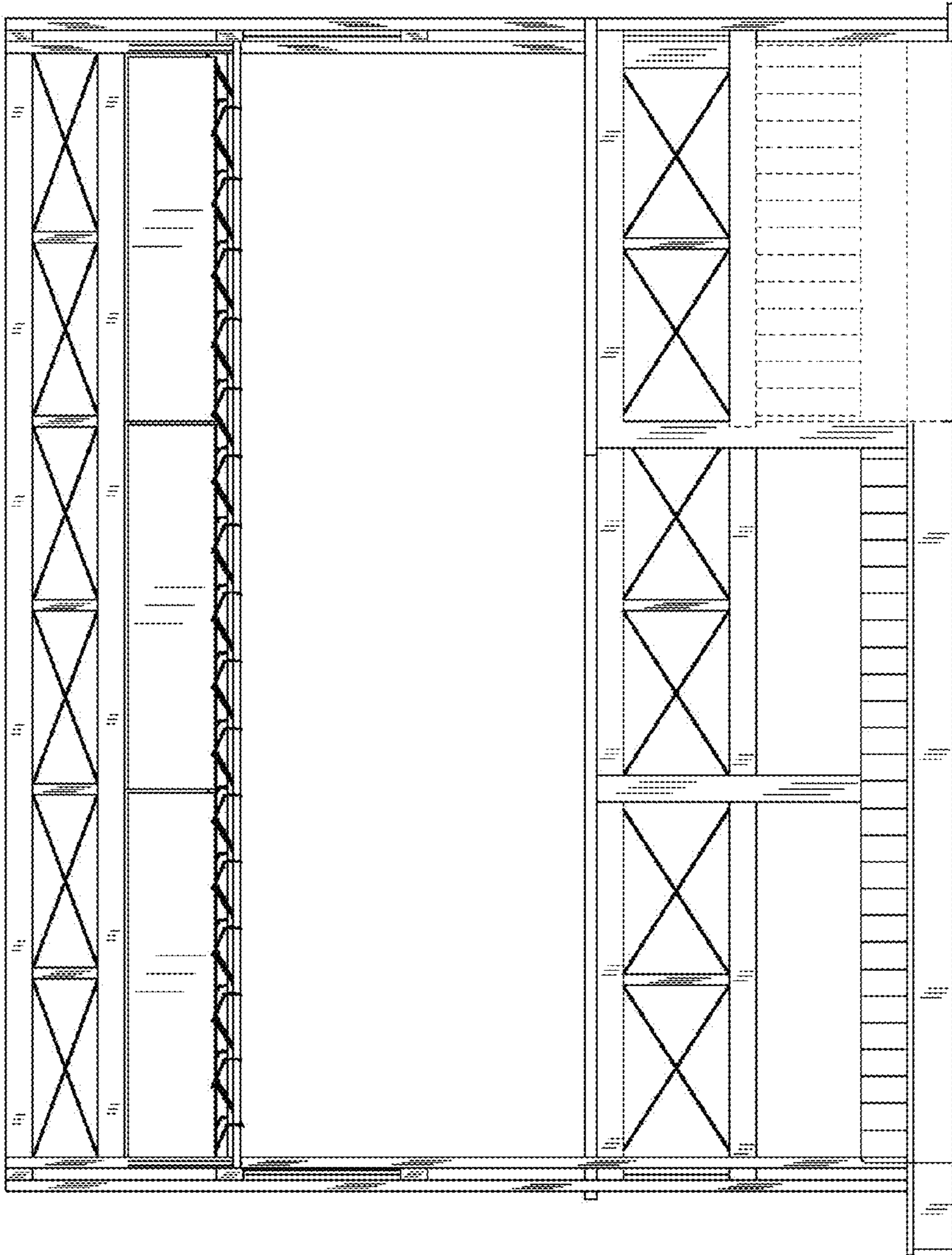

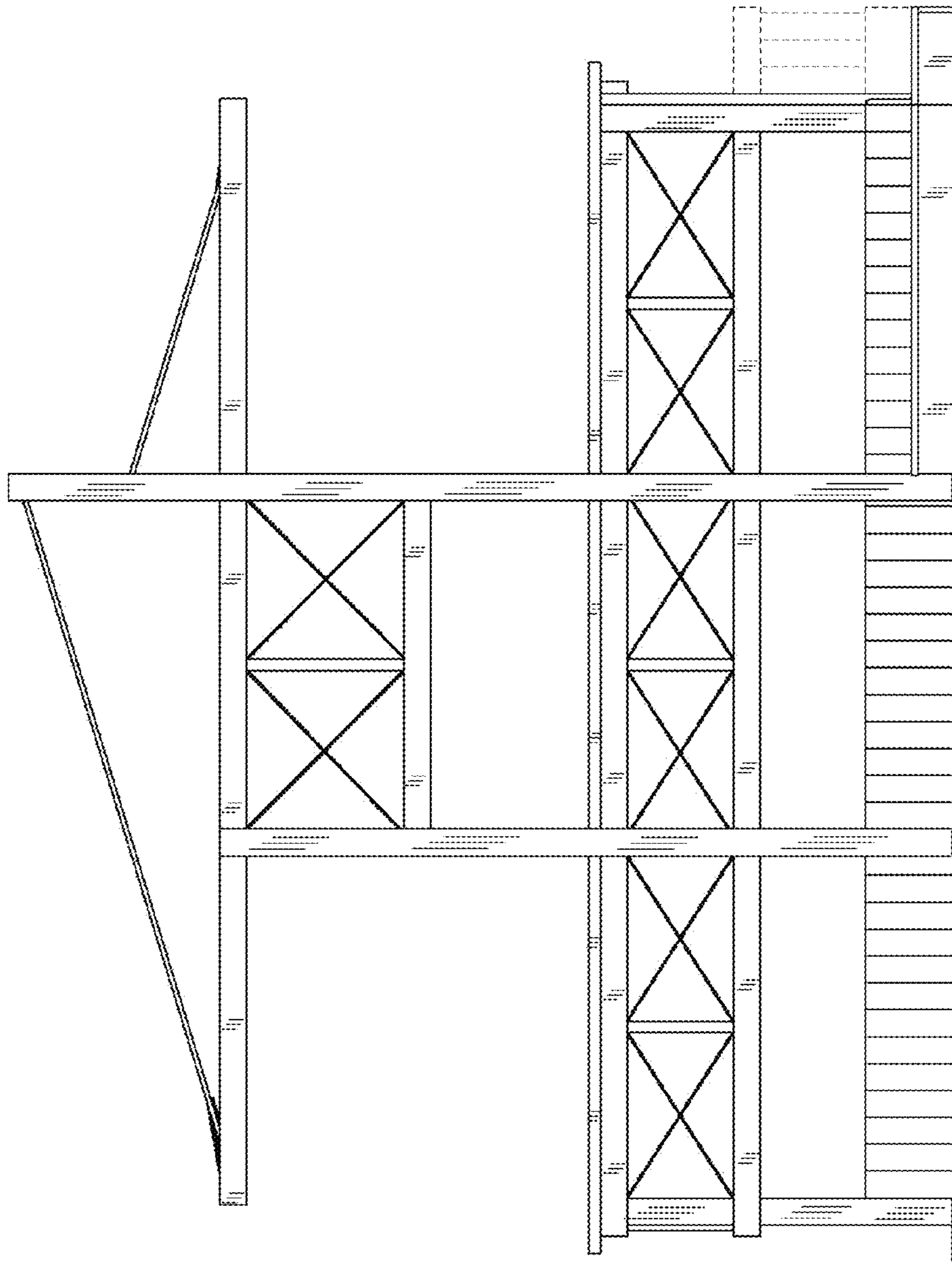

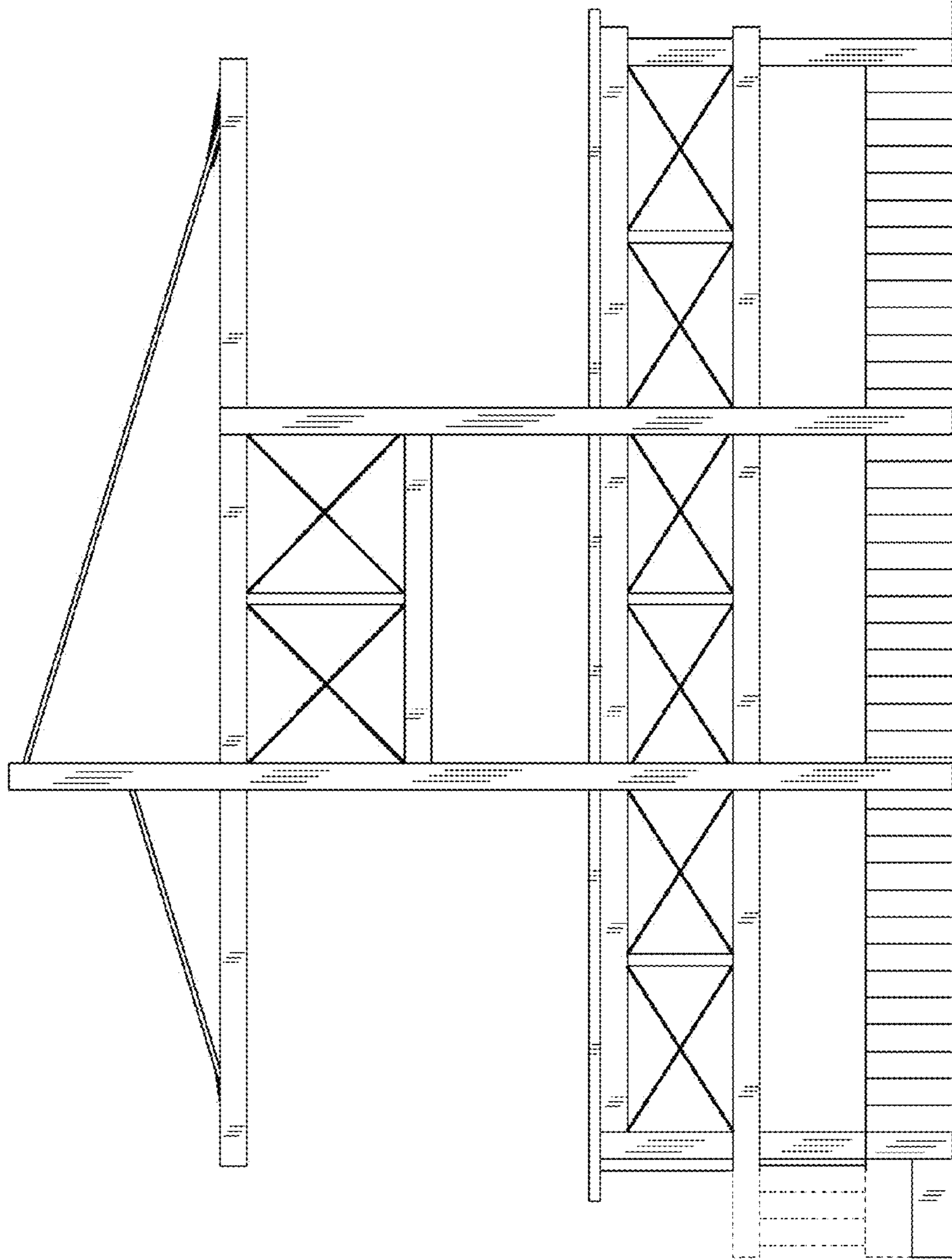

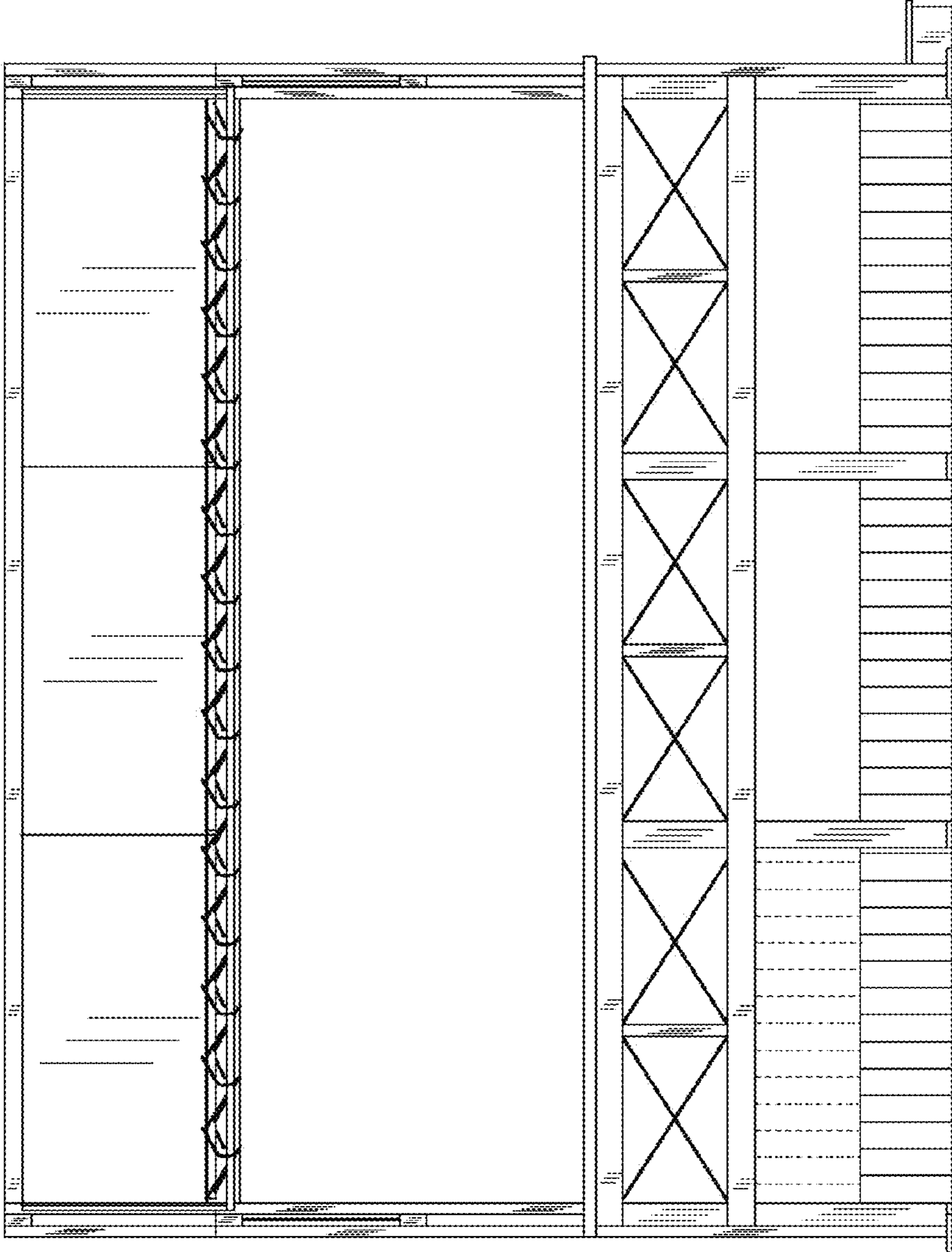

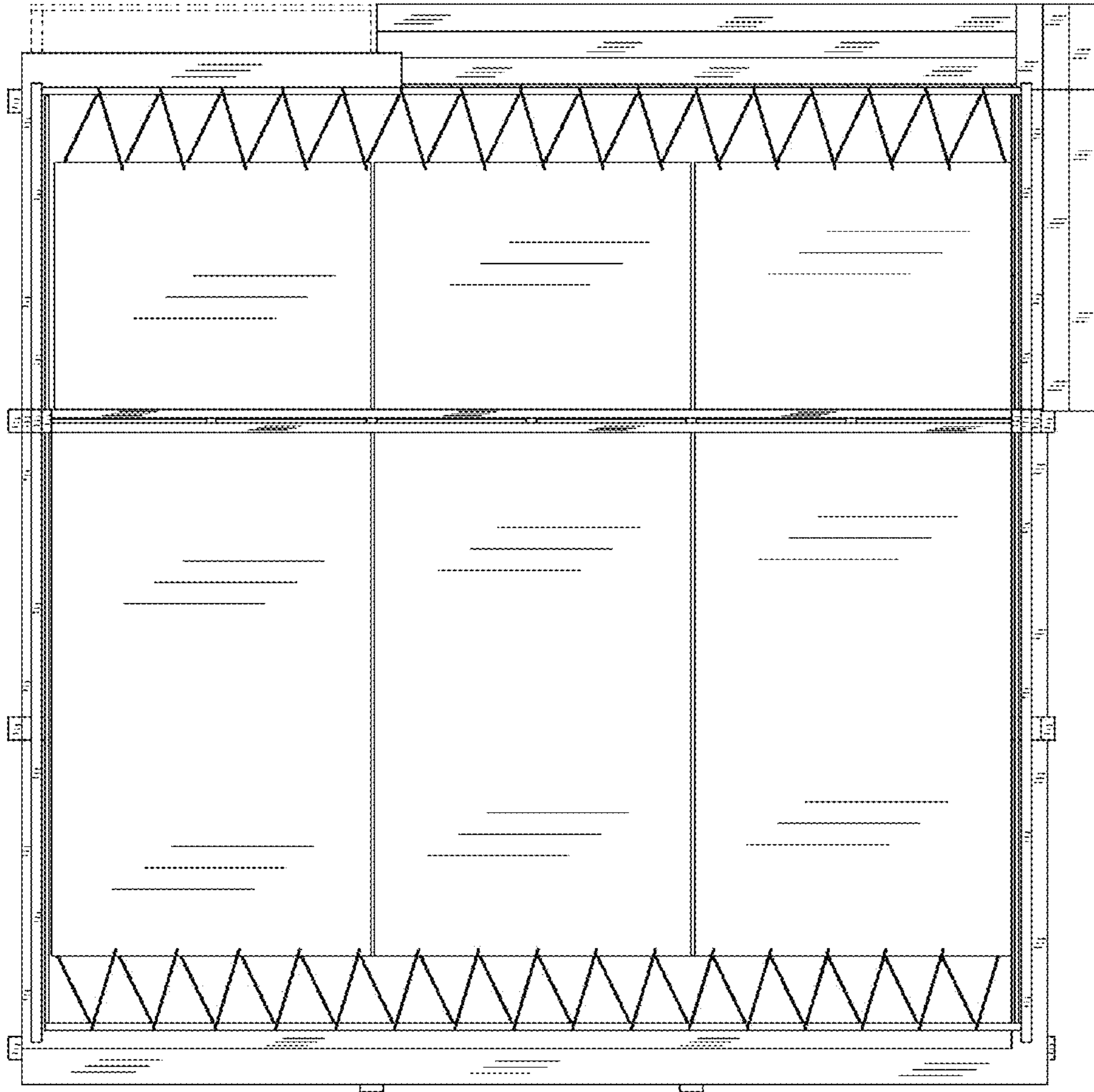
