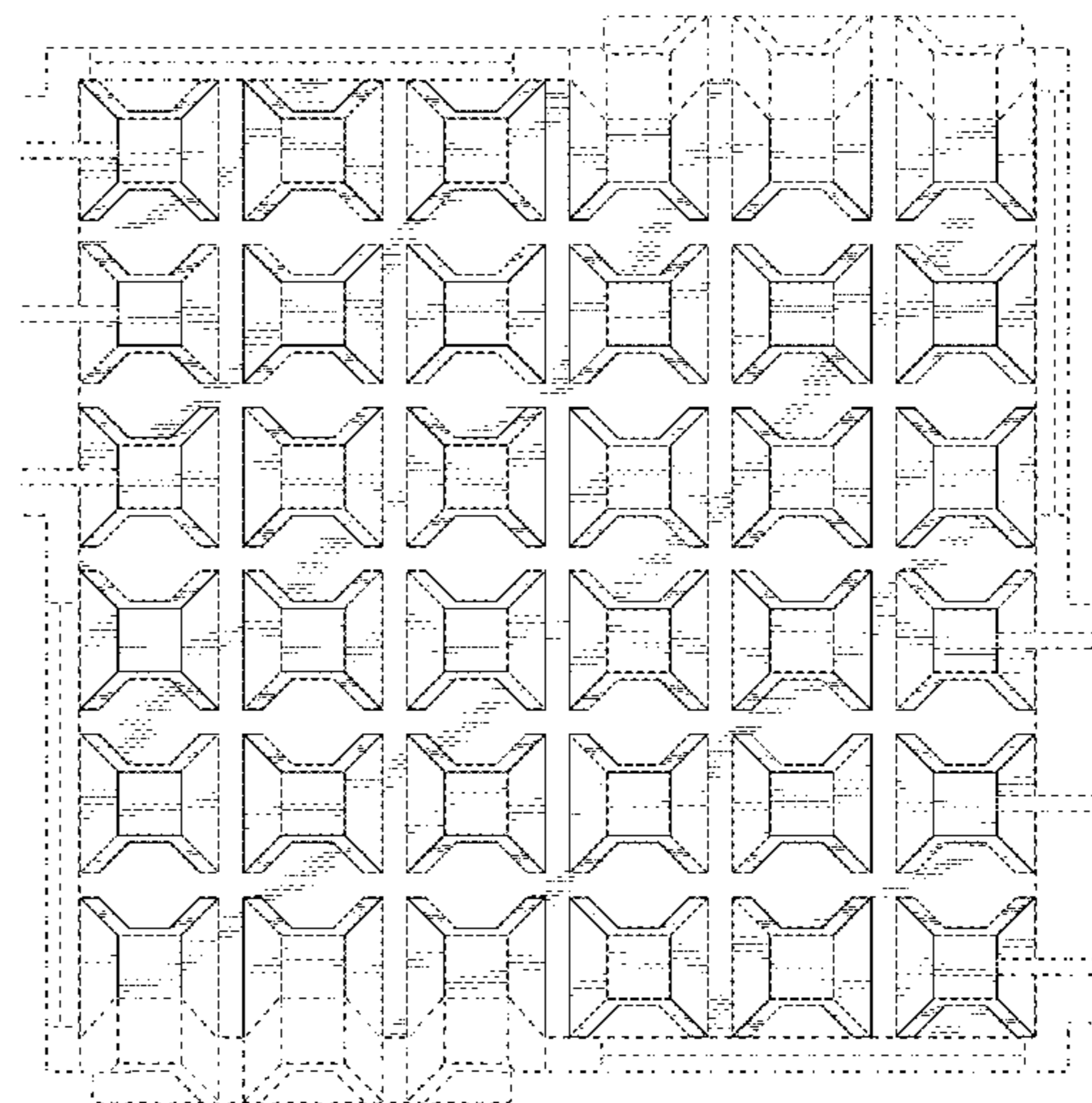
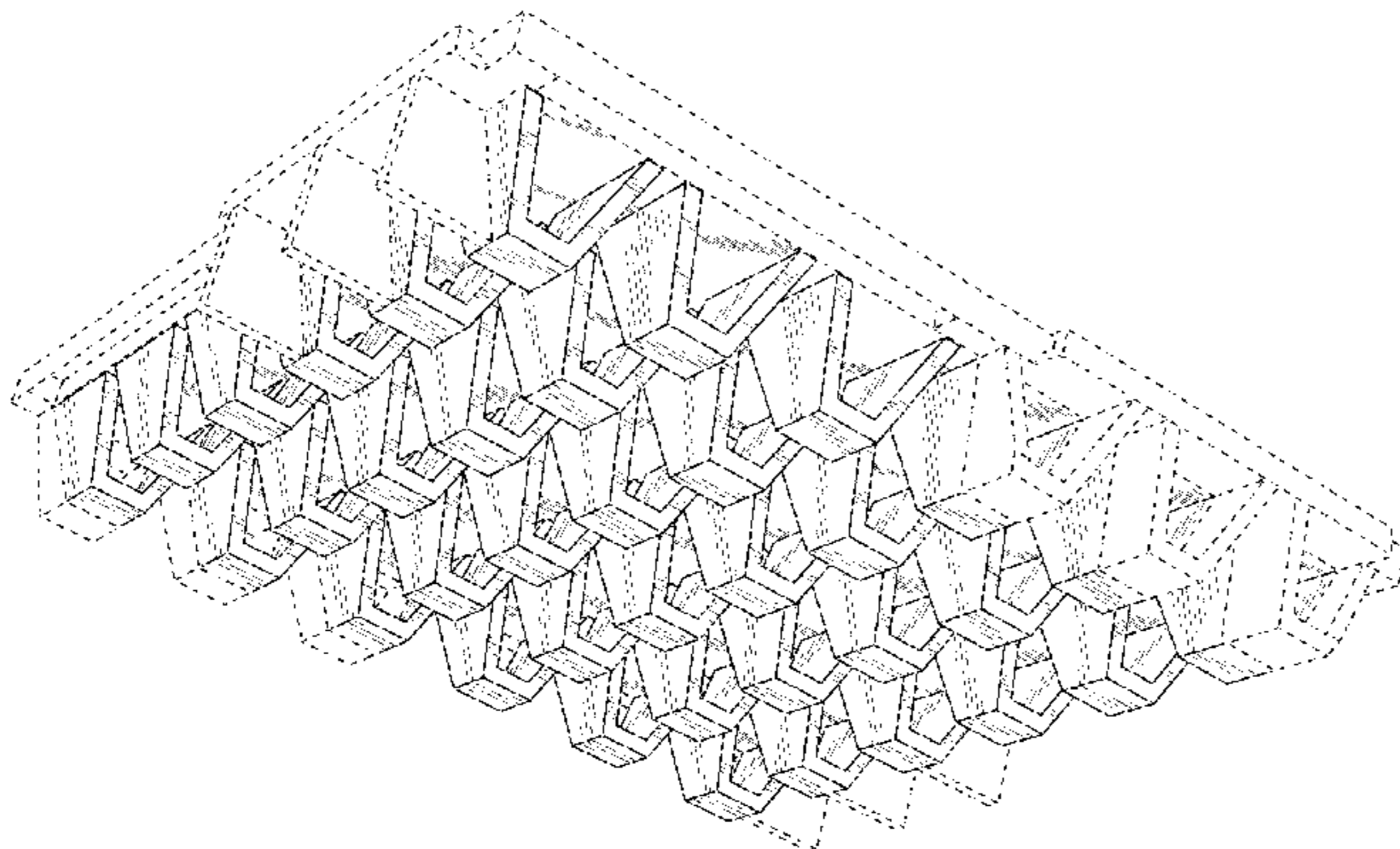
(57) **CLAIM**

The ornamental design for a unitary safety surface tile, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom perspective view of a unitary safety surface tile showing my new design;  
FIG. 2 is a top perspective view thereof;  
FIG. 3 is a front elevational view thereof, being a mirror-image of a back elevation view thereof;  
FIG. 4 is a right elevational view thereof, being a mirror-image of a left elevation view thereof;  
FIG. 5 is a top plan view thereof; and,  
FIG. 6 is a bottom plan view thereof.  
The broken line showing of the environment in FIGS. 1-6 is for illustrative purposes only and forms no part of the claimed design.

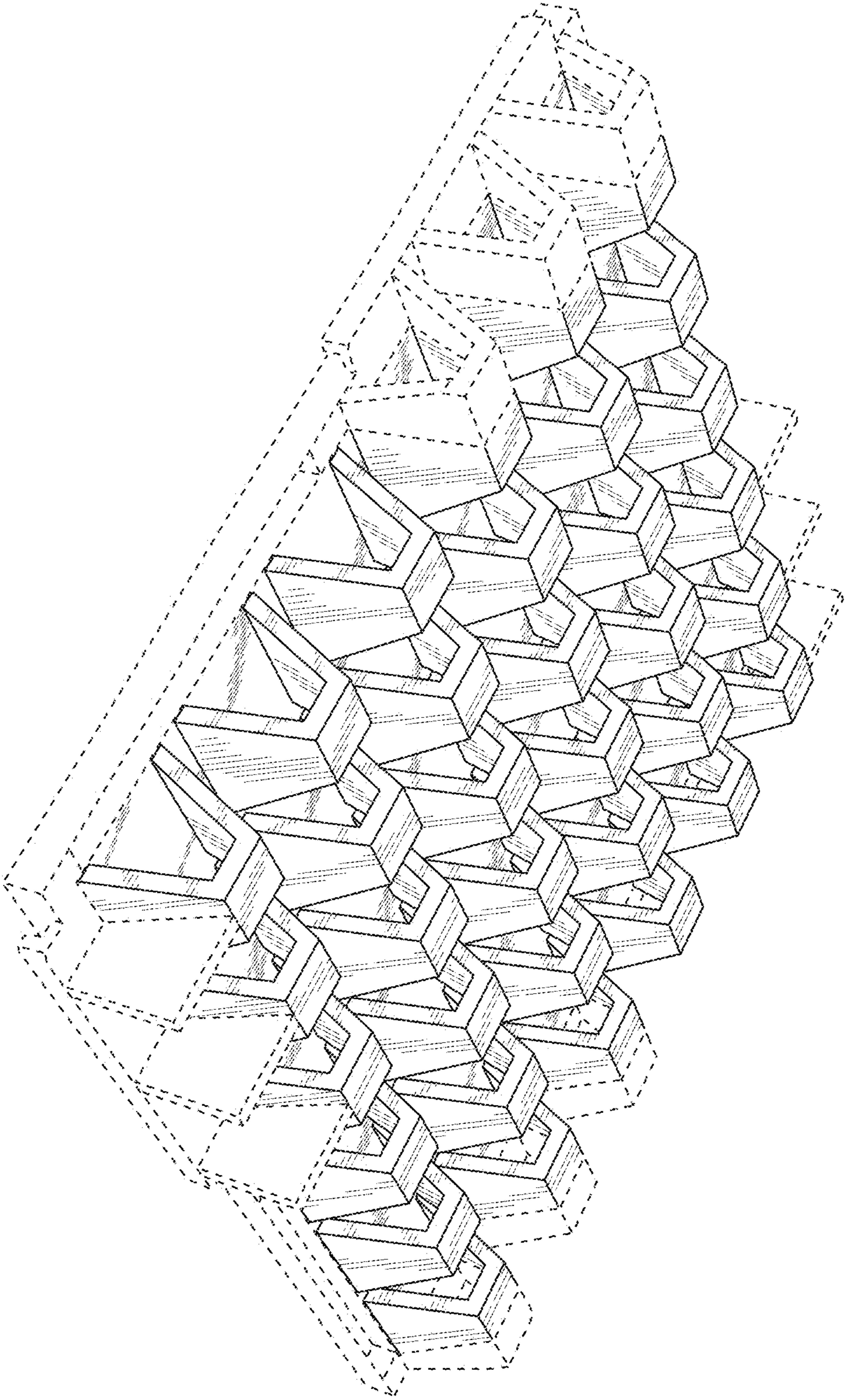

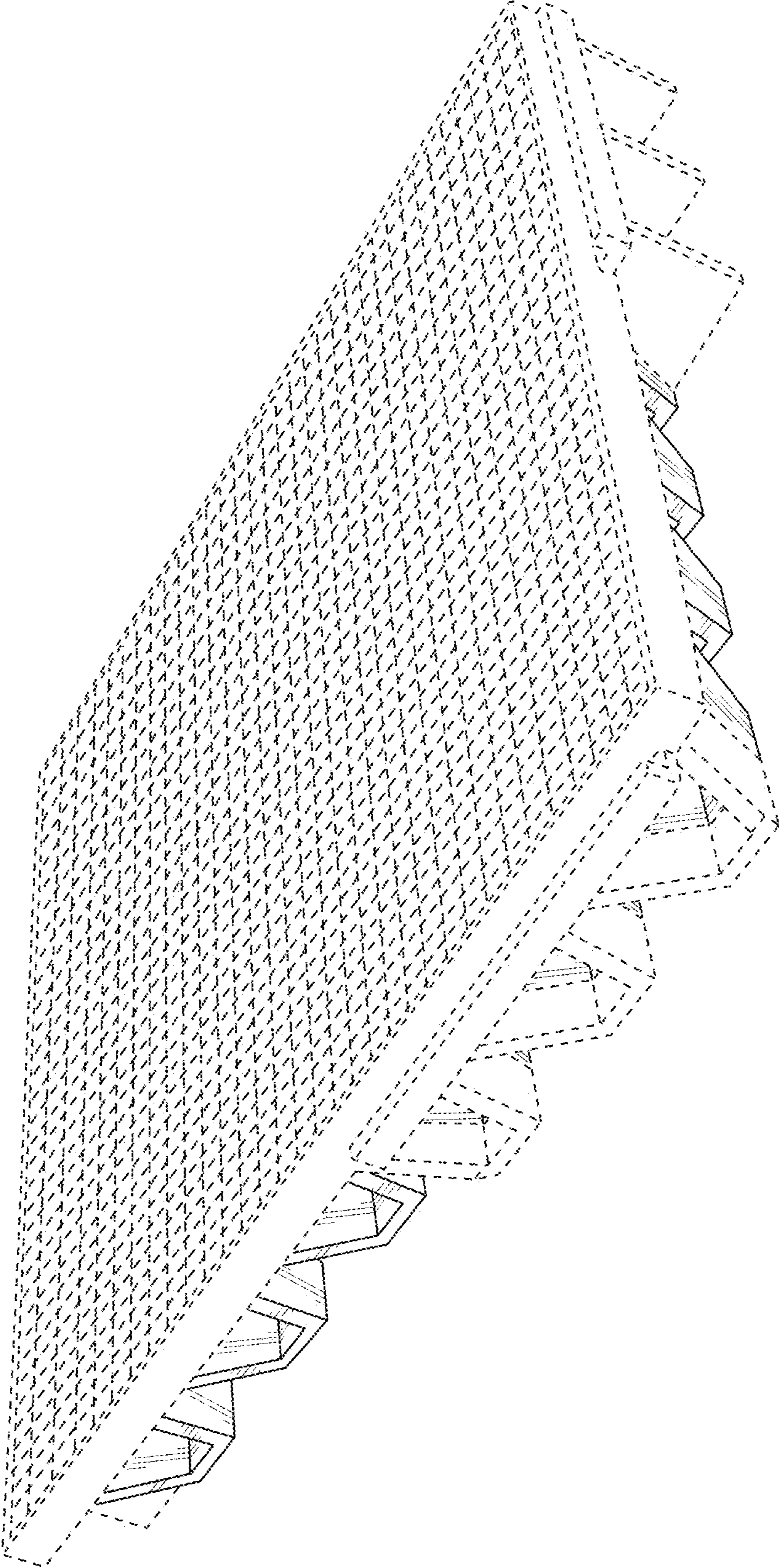

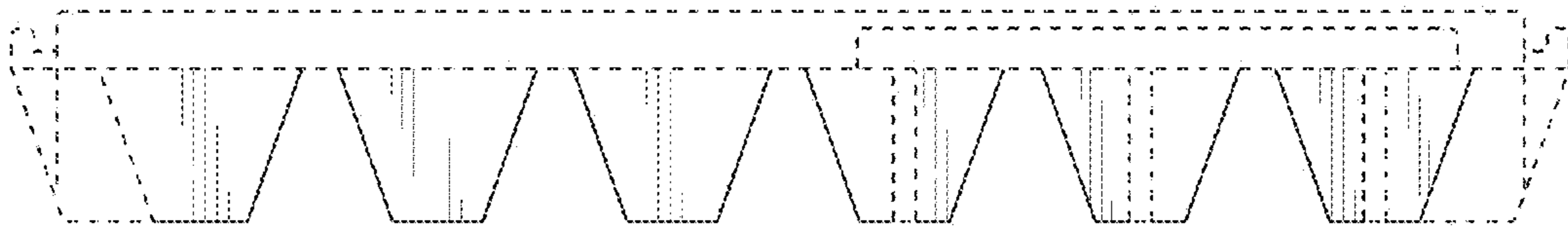

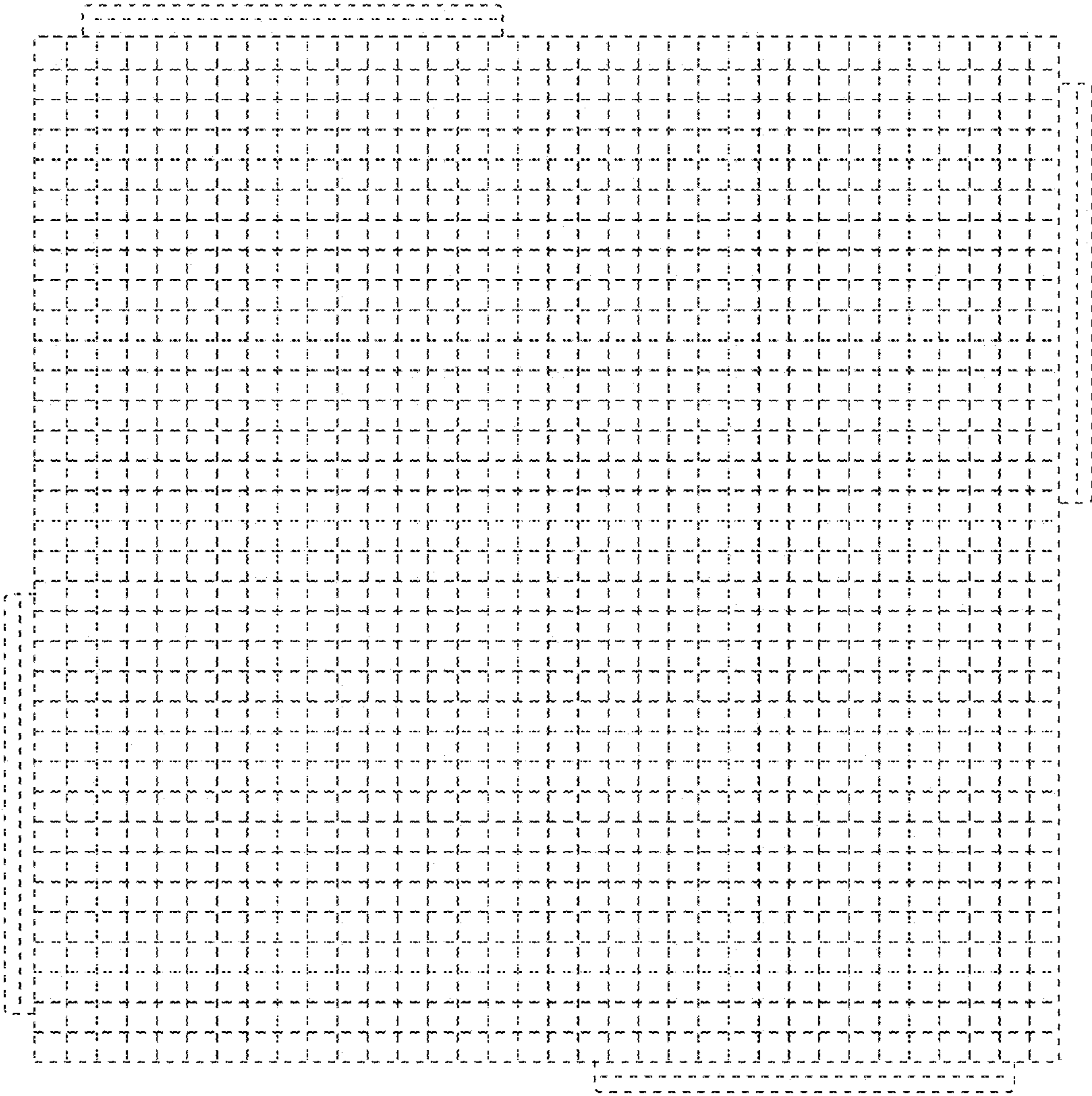

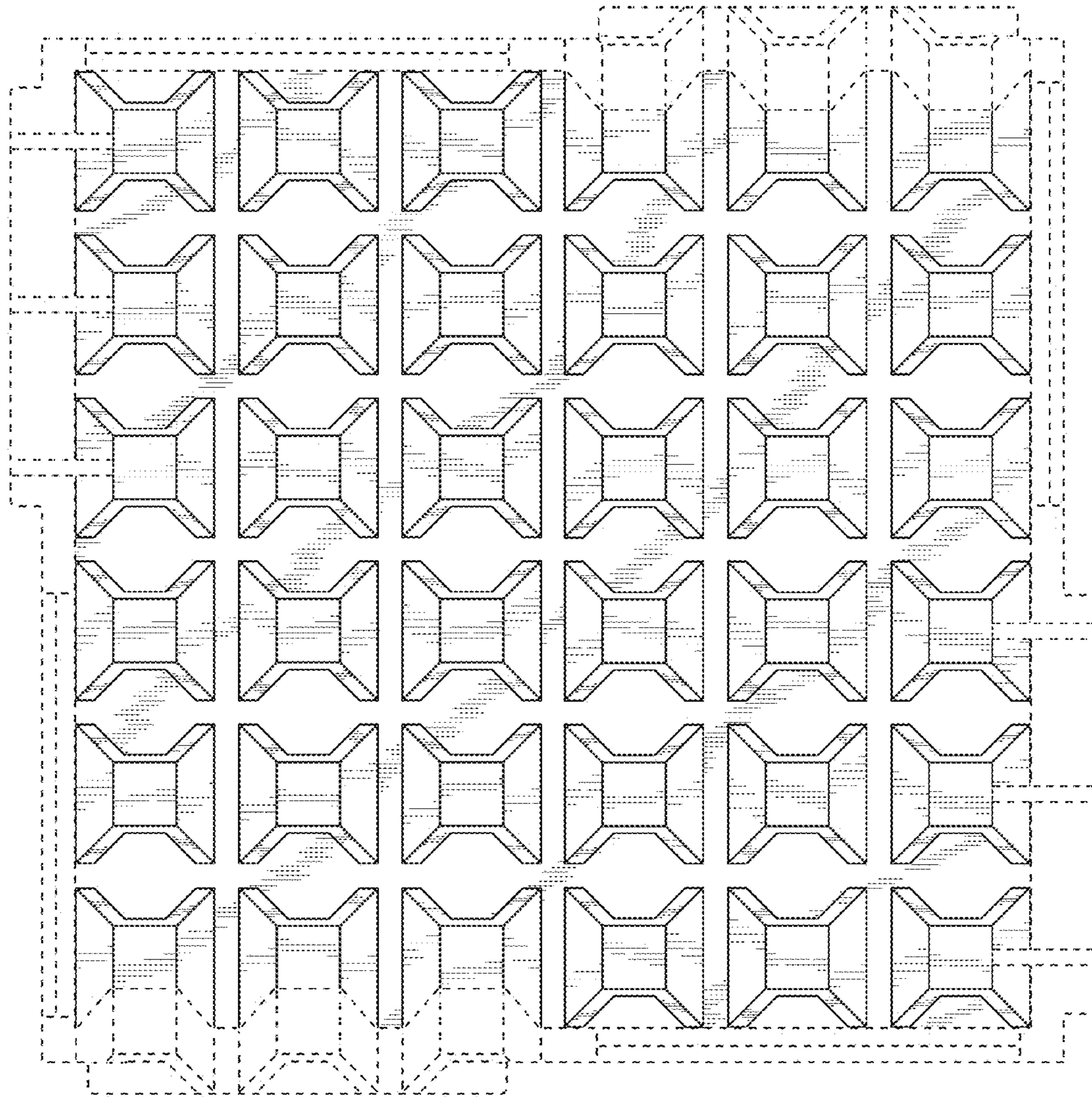
