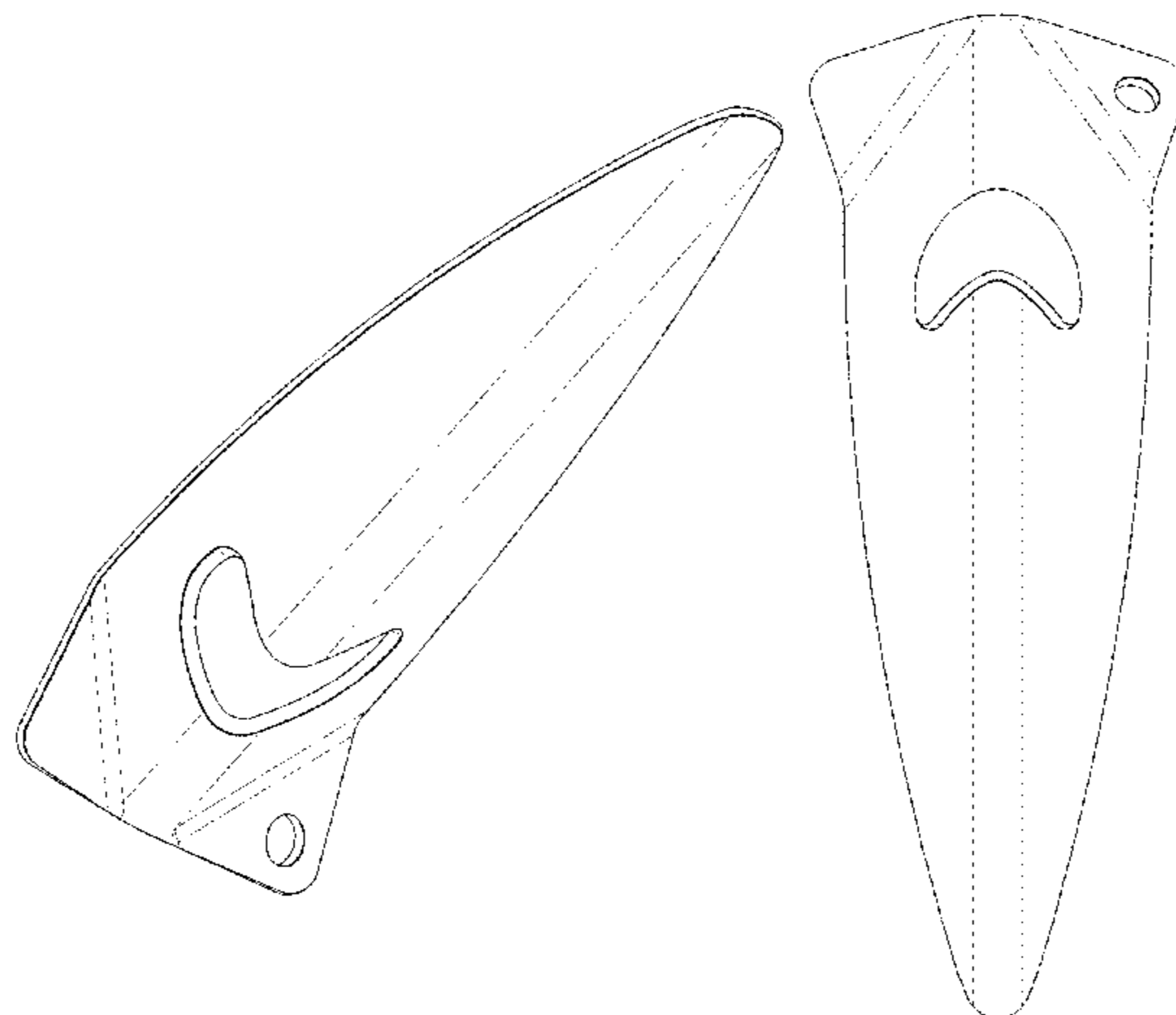

(57) **CLAIM**  
I claim the ornamental design for a holder for cigarette paper, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a holder for cigarette paper, showing my new design;  
FIG. 2 is a top plan view of the holder for cigarette paper of FIG. 1;  
FIG. 3 is a bottom plan view of the holder for cigarette paper of FIG. 1;  
FIG. 4 is a right side elevational view of the holder for cigarette paper of FIG. 1;  
FIG. 5 is a left side elevational view of the holder for cigarette paper of FIG. 1;  
FIG. 6 is a rear elevational view of the holder for cigarette paper of FIG. 1; and,  
FIG. 7 is a front elevational view of the holder for cigarette paper of FIG. 1.

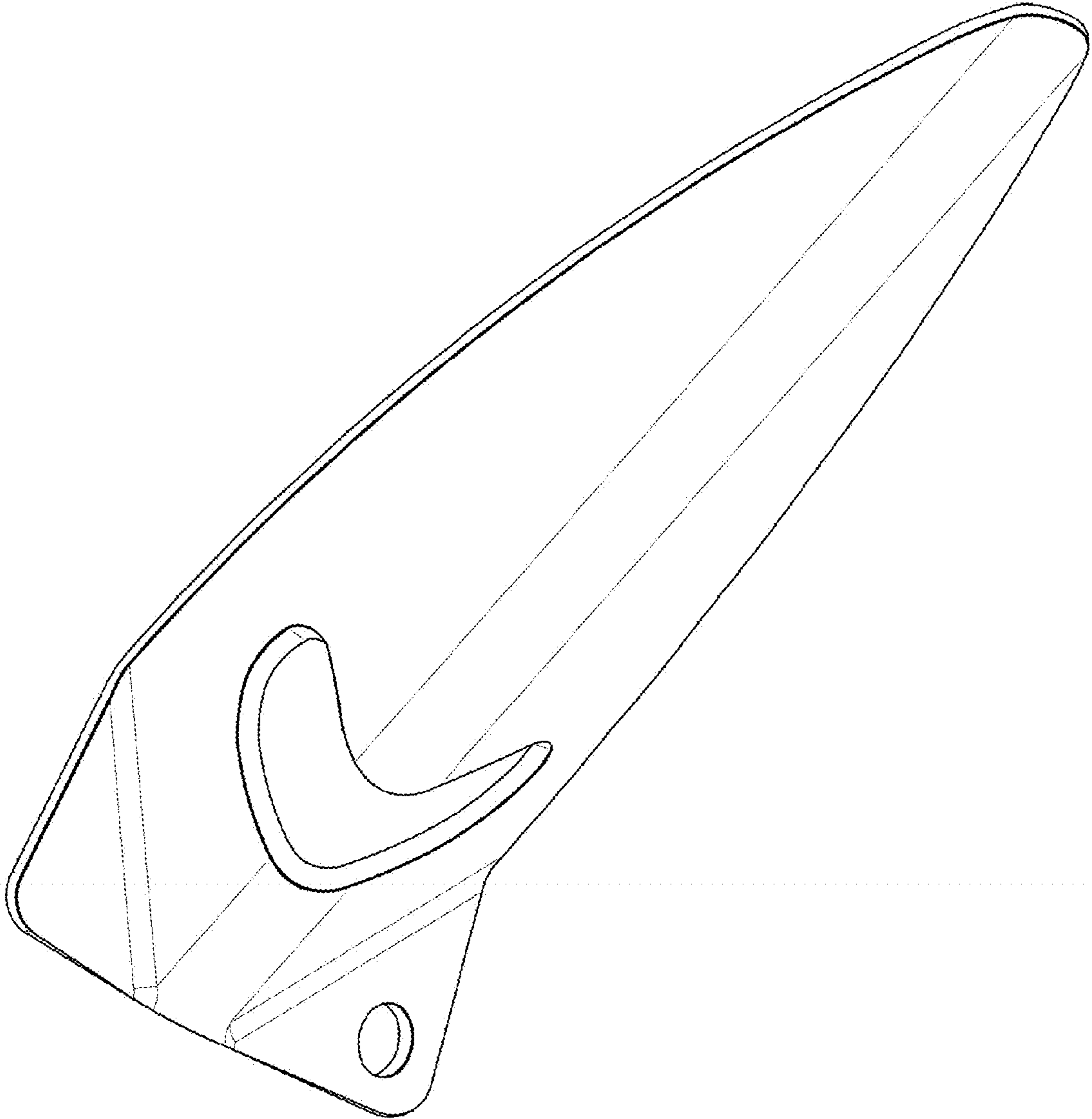

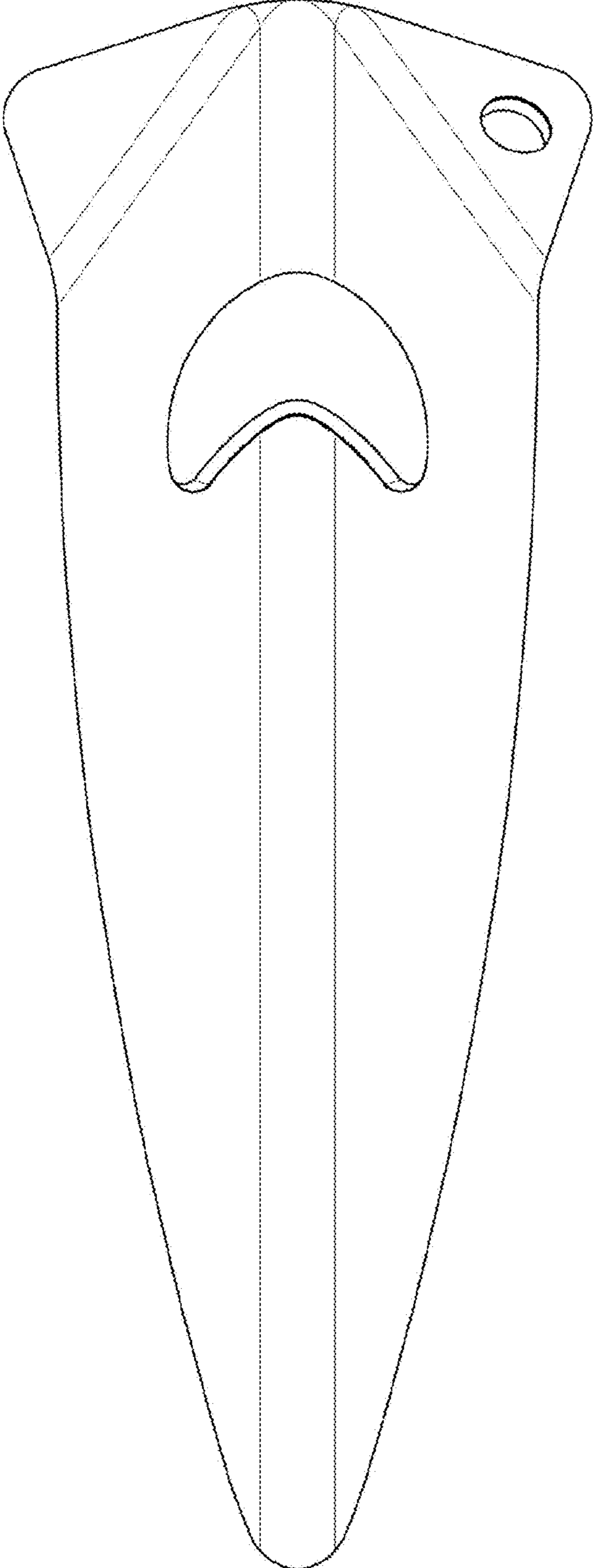

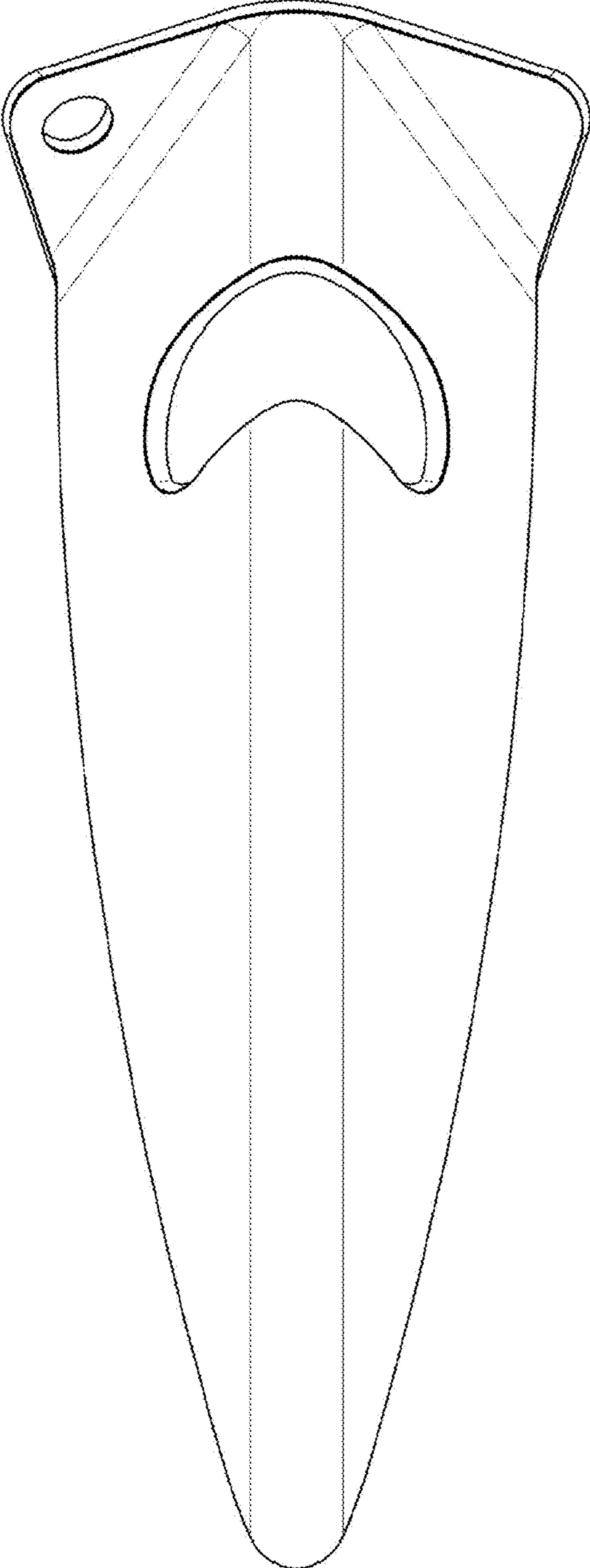

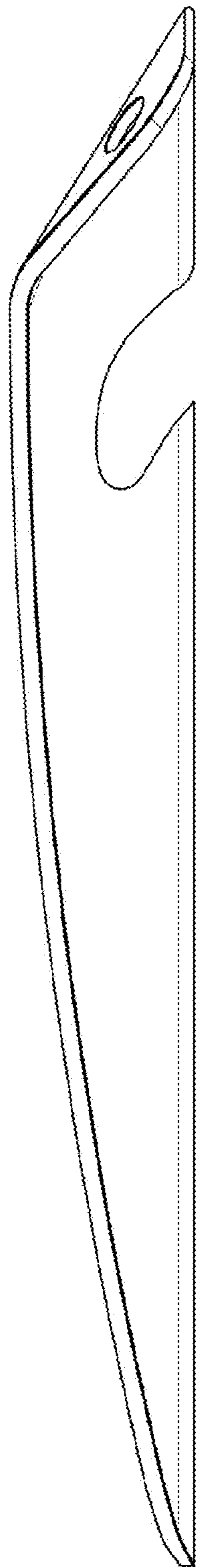

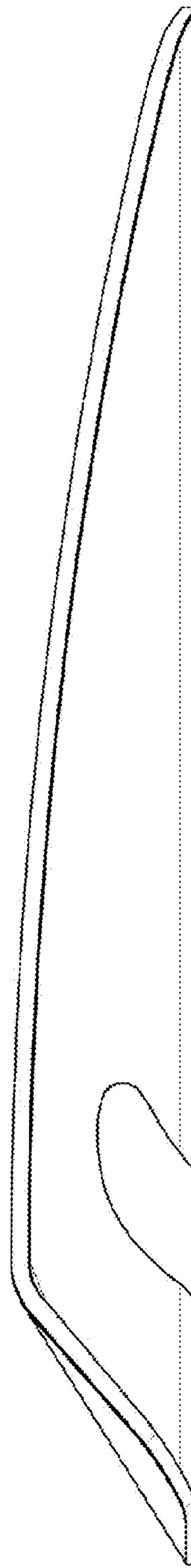

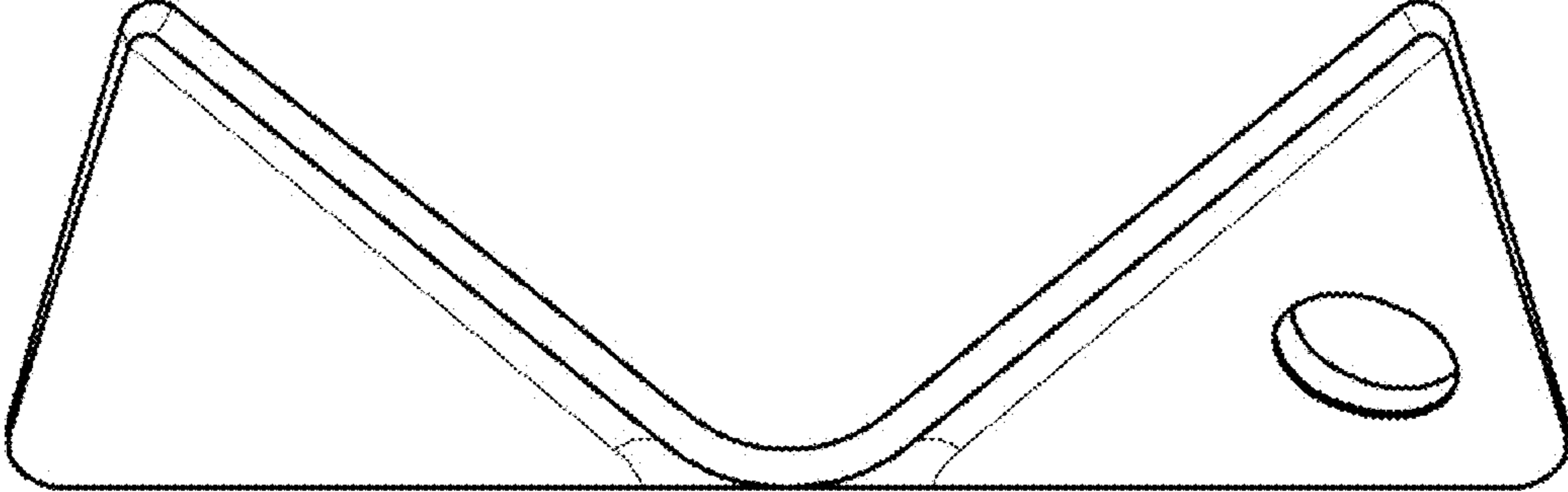

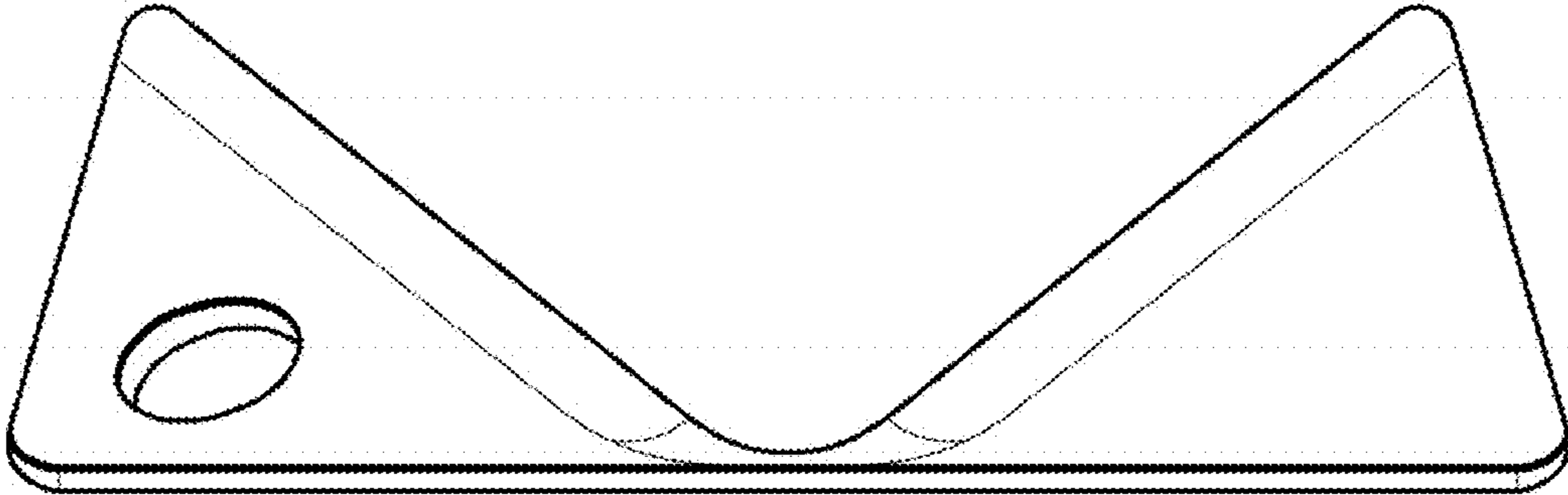
