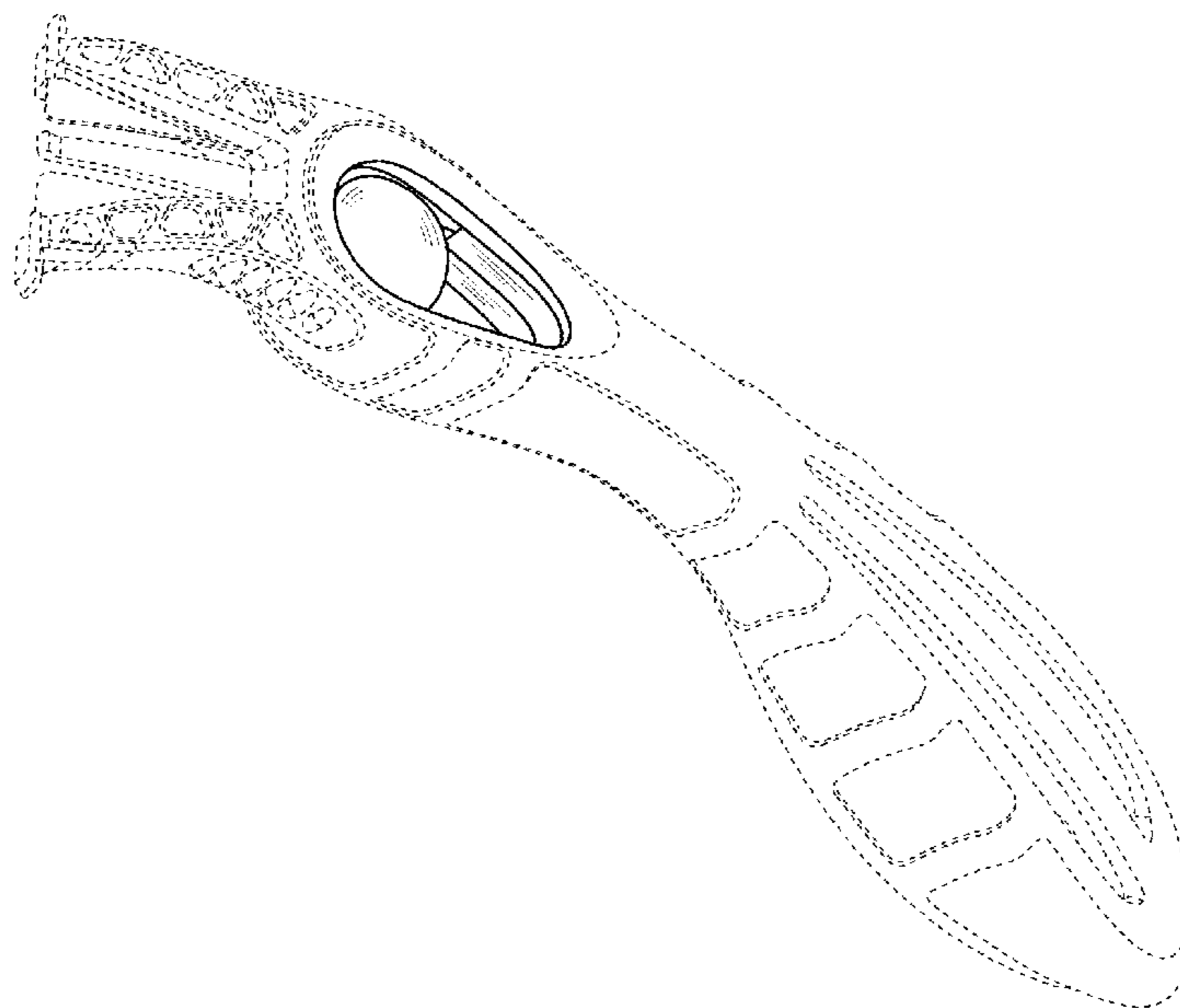

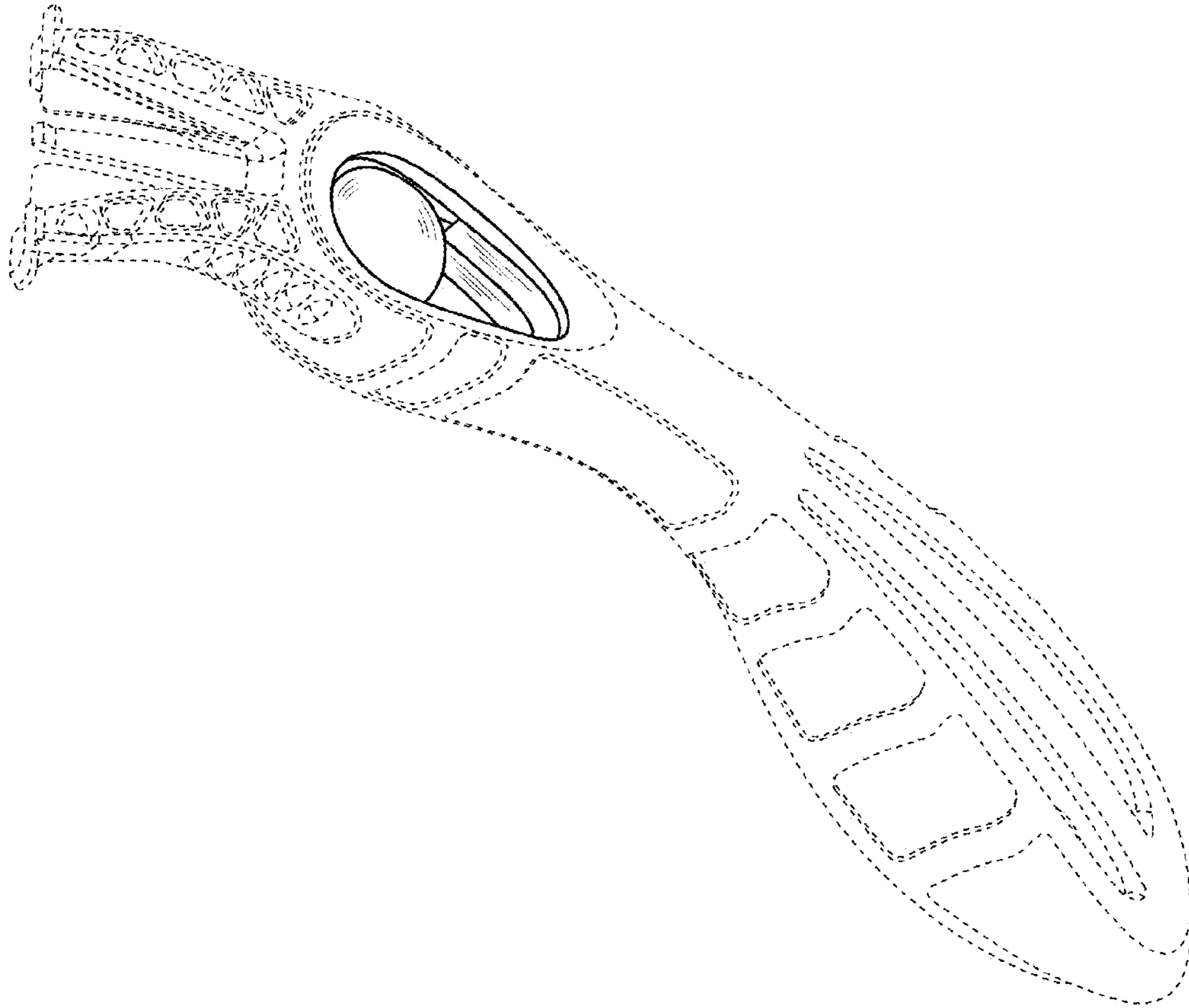
The ornamental design for a shaver handle, as shown and described.

**DESCRIPTION**

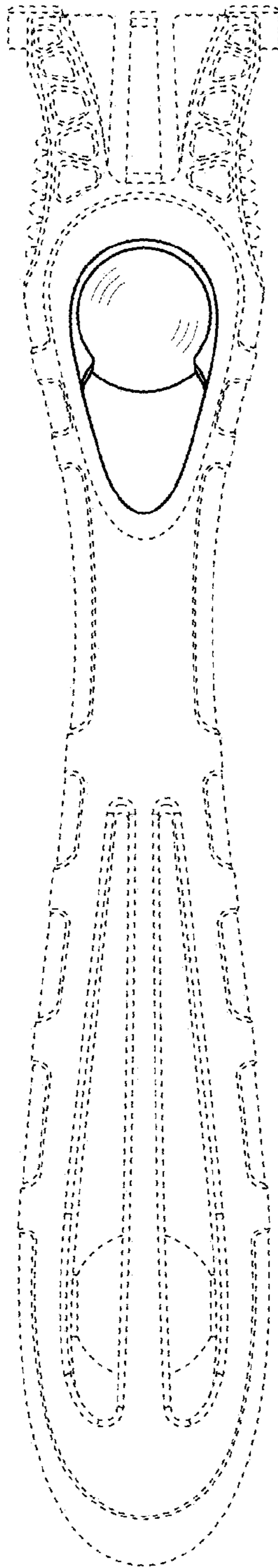

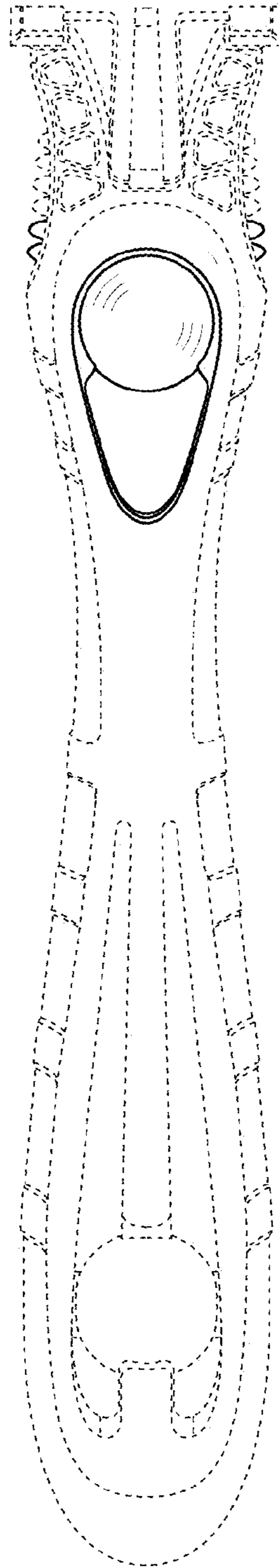




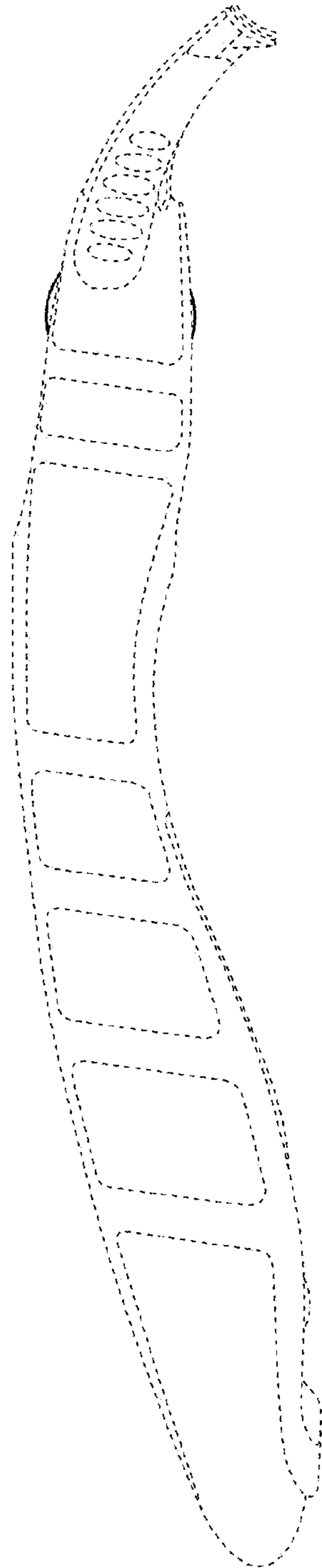

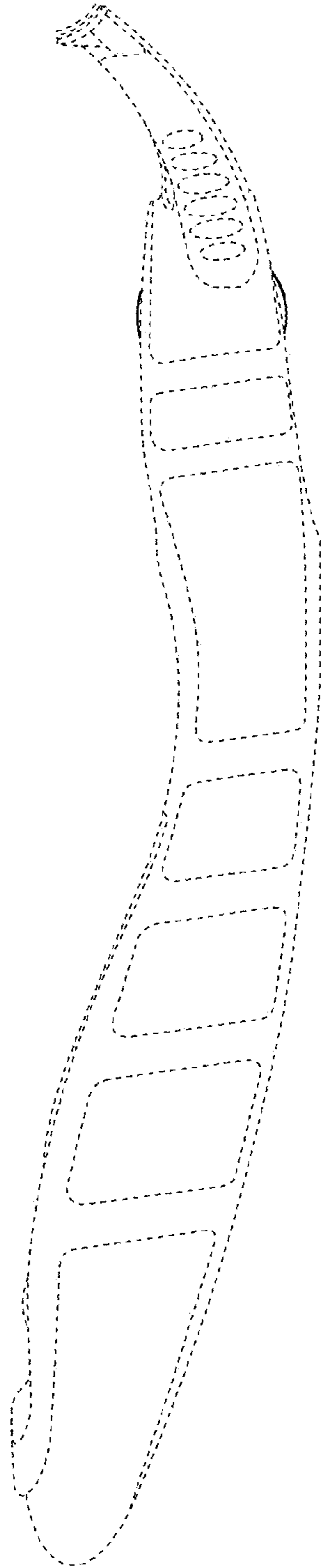

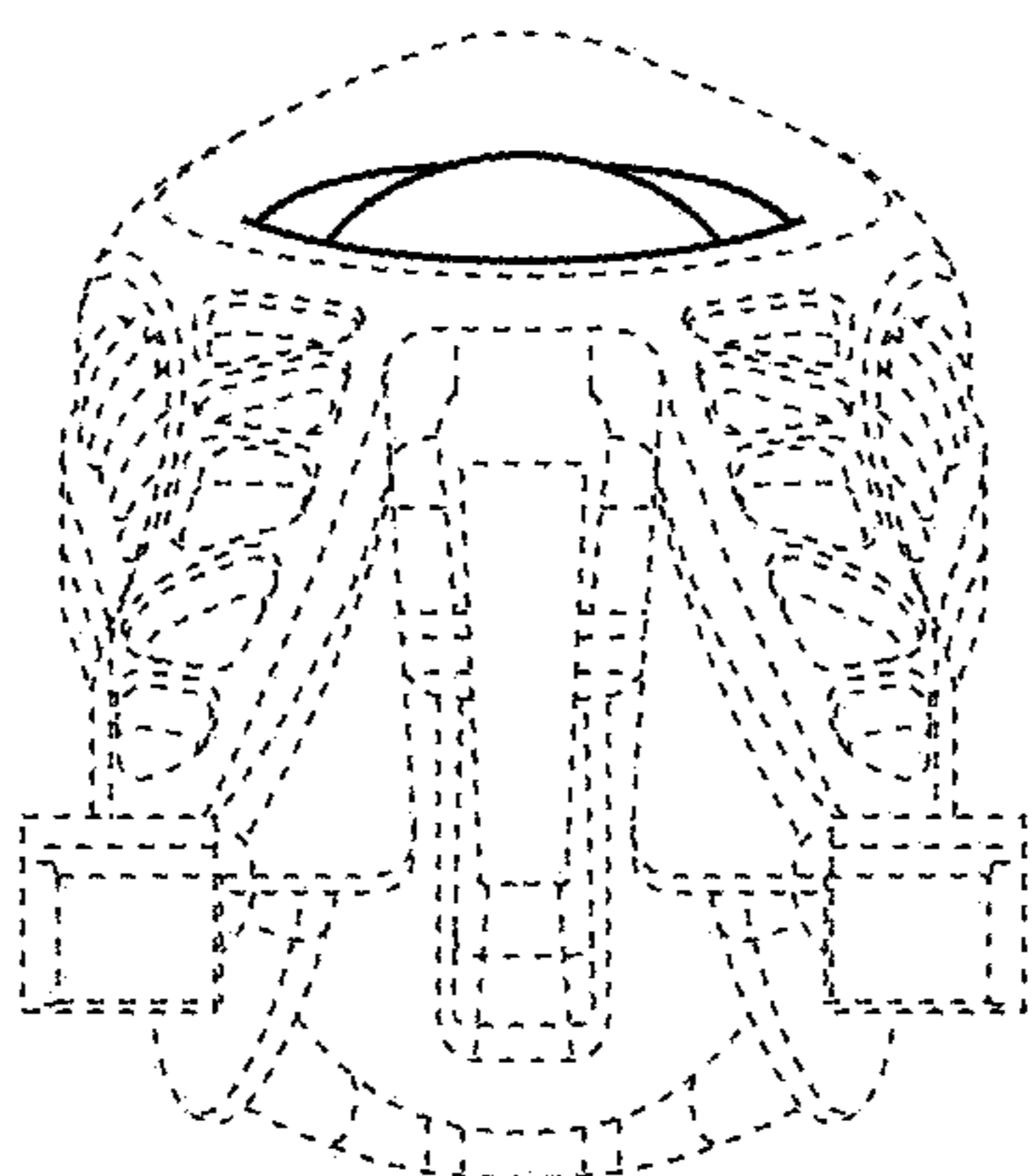

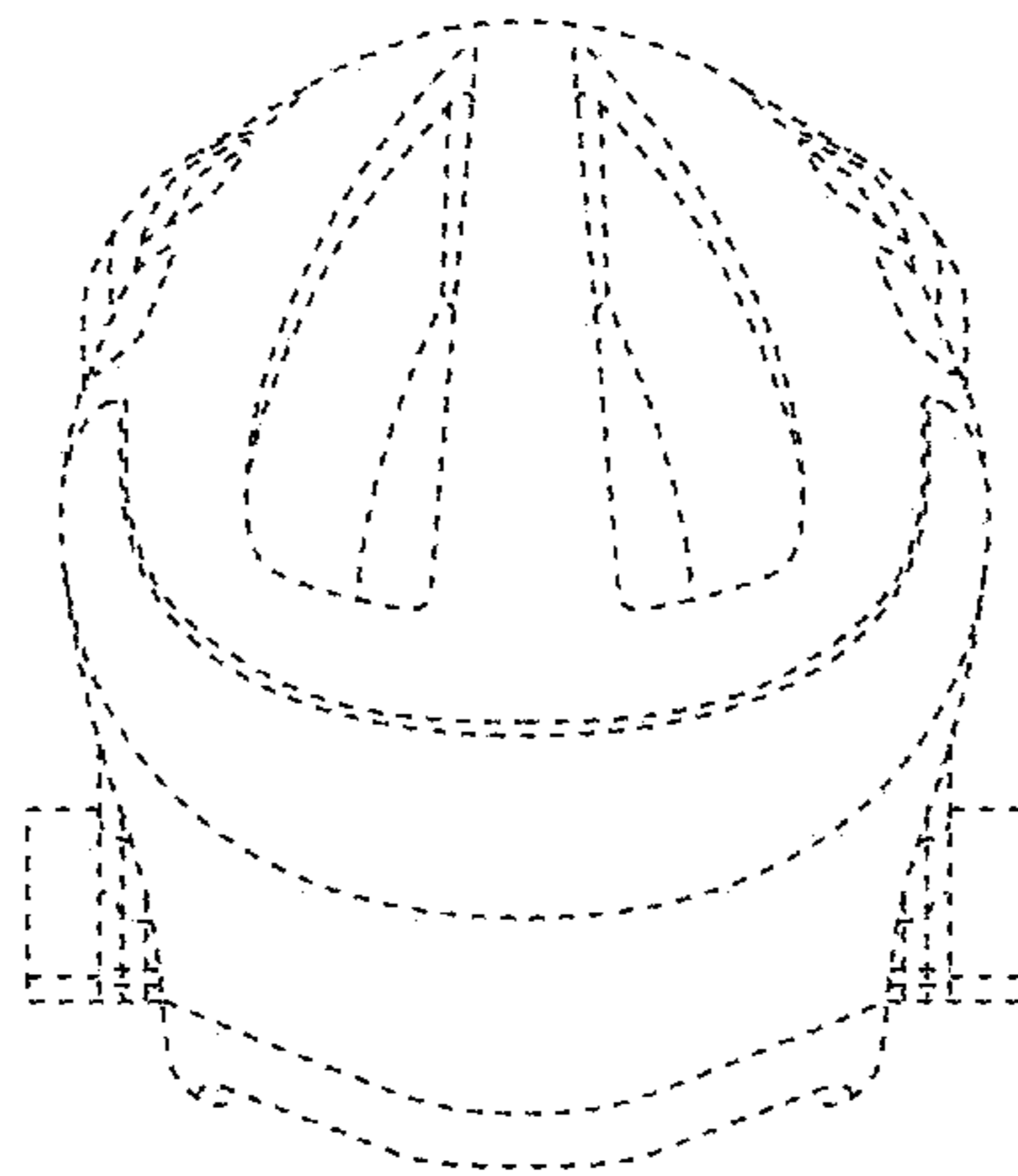
