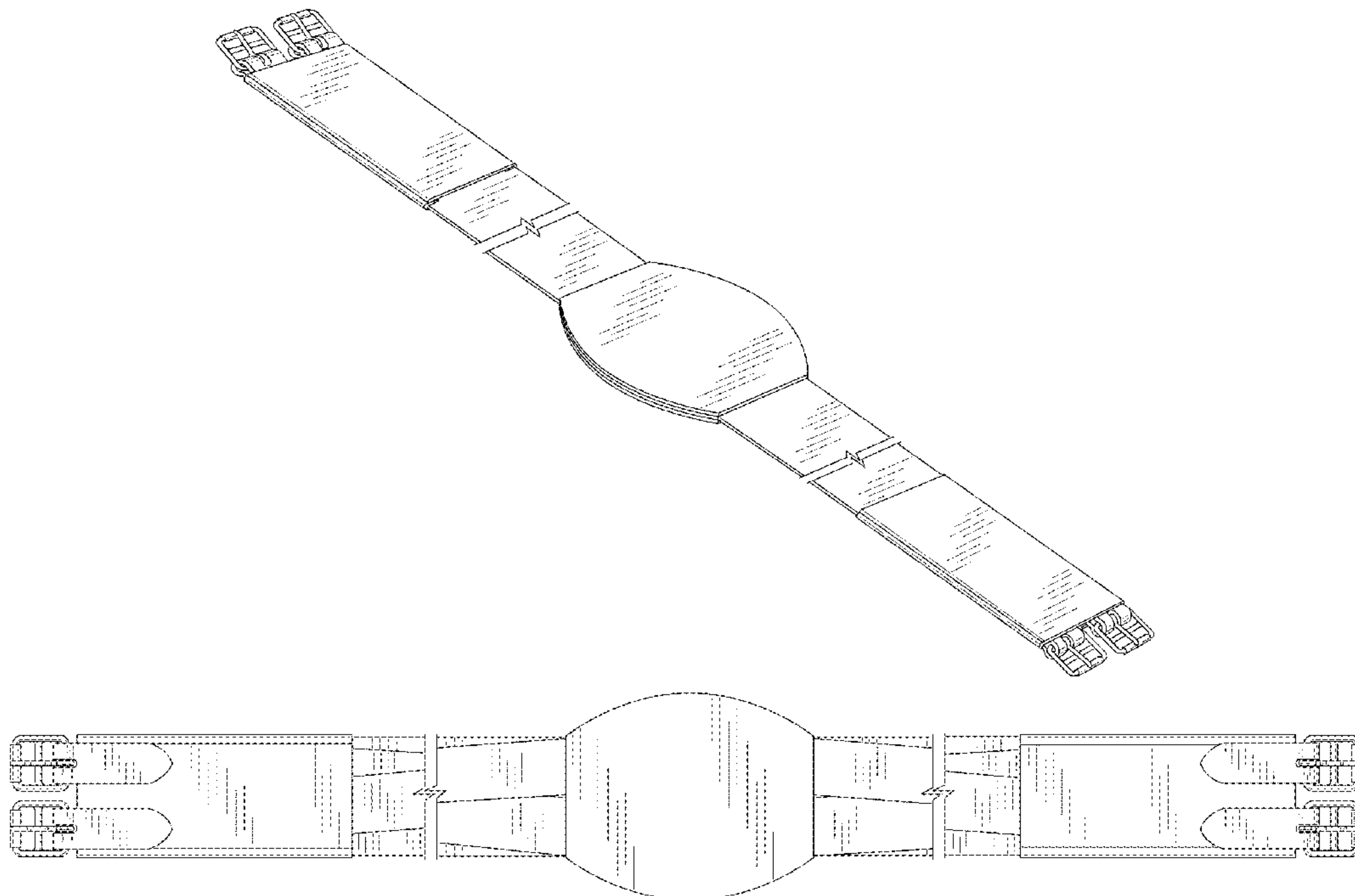
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is an isometric view of the girth of the invention;  
FIG. 2 is another isometric view thereof;  
FIG. 3 is a top view thereof;  
FIG. 4 is a bottom view thereof;  
FIG. 5 is a first side view thereof;  
FIG. 6 is a second side view thereof;

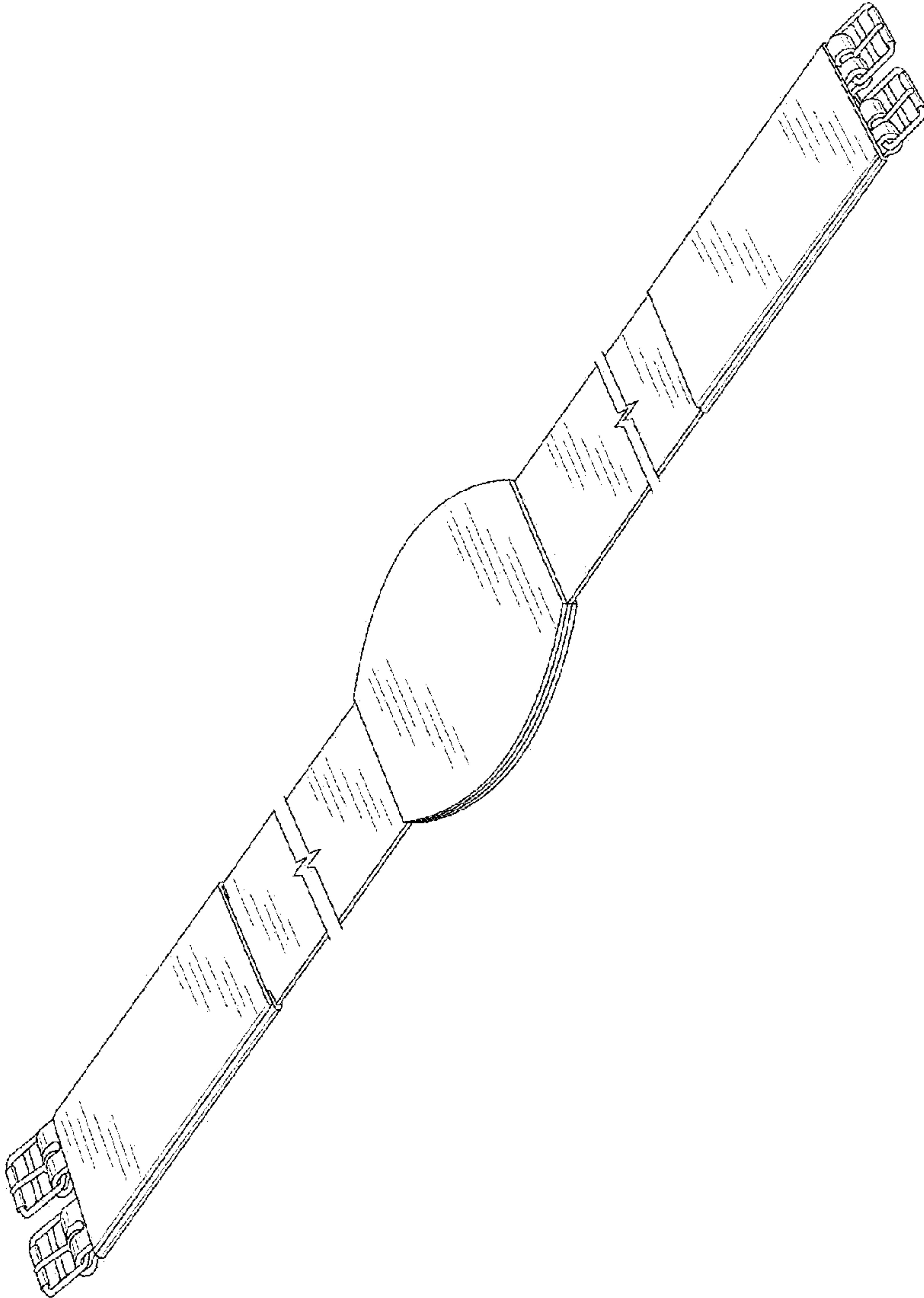

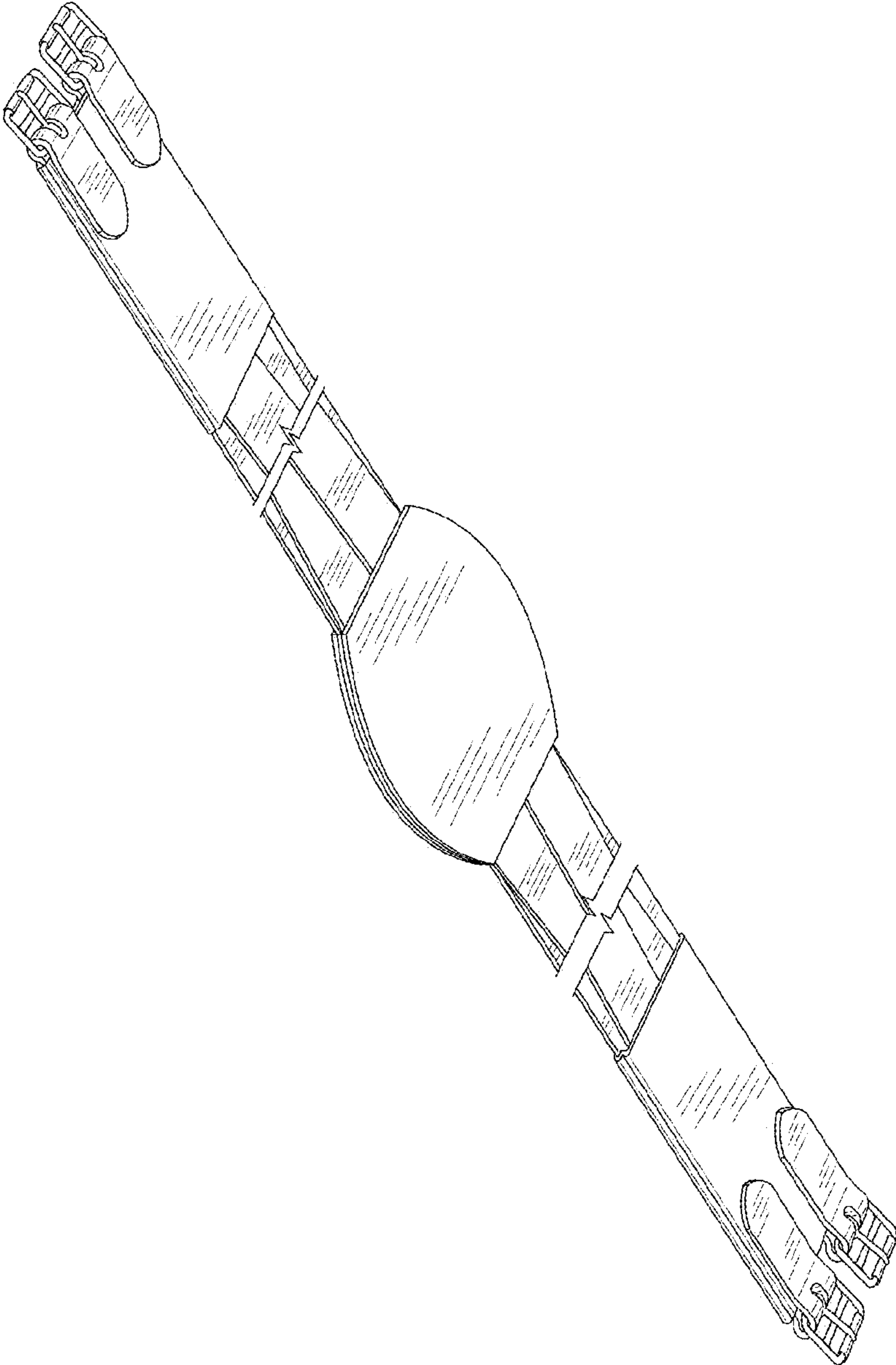

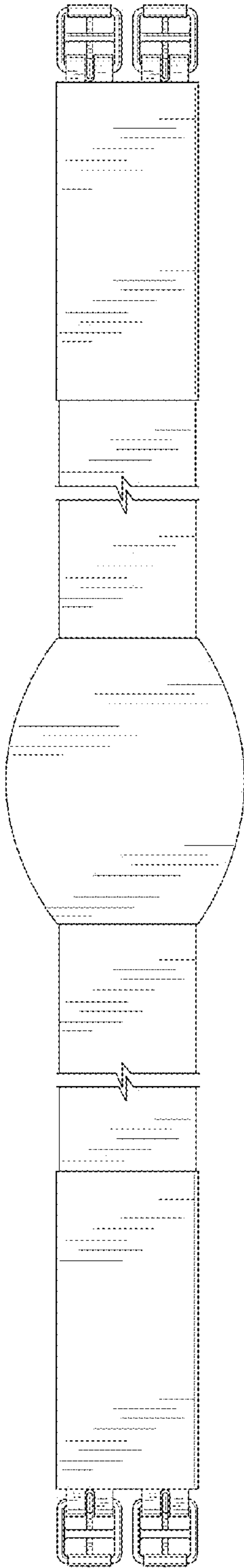

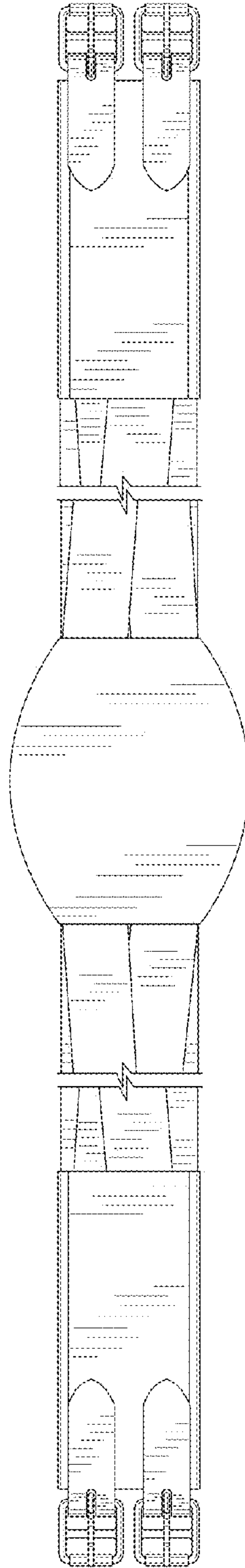

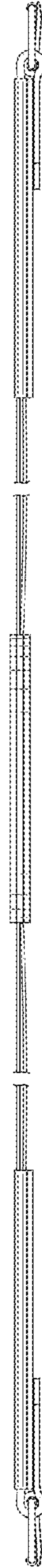

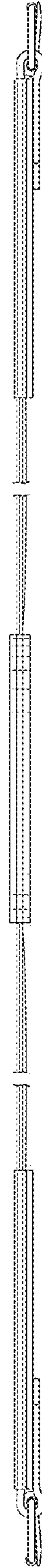

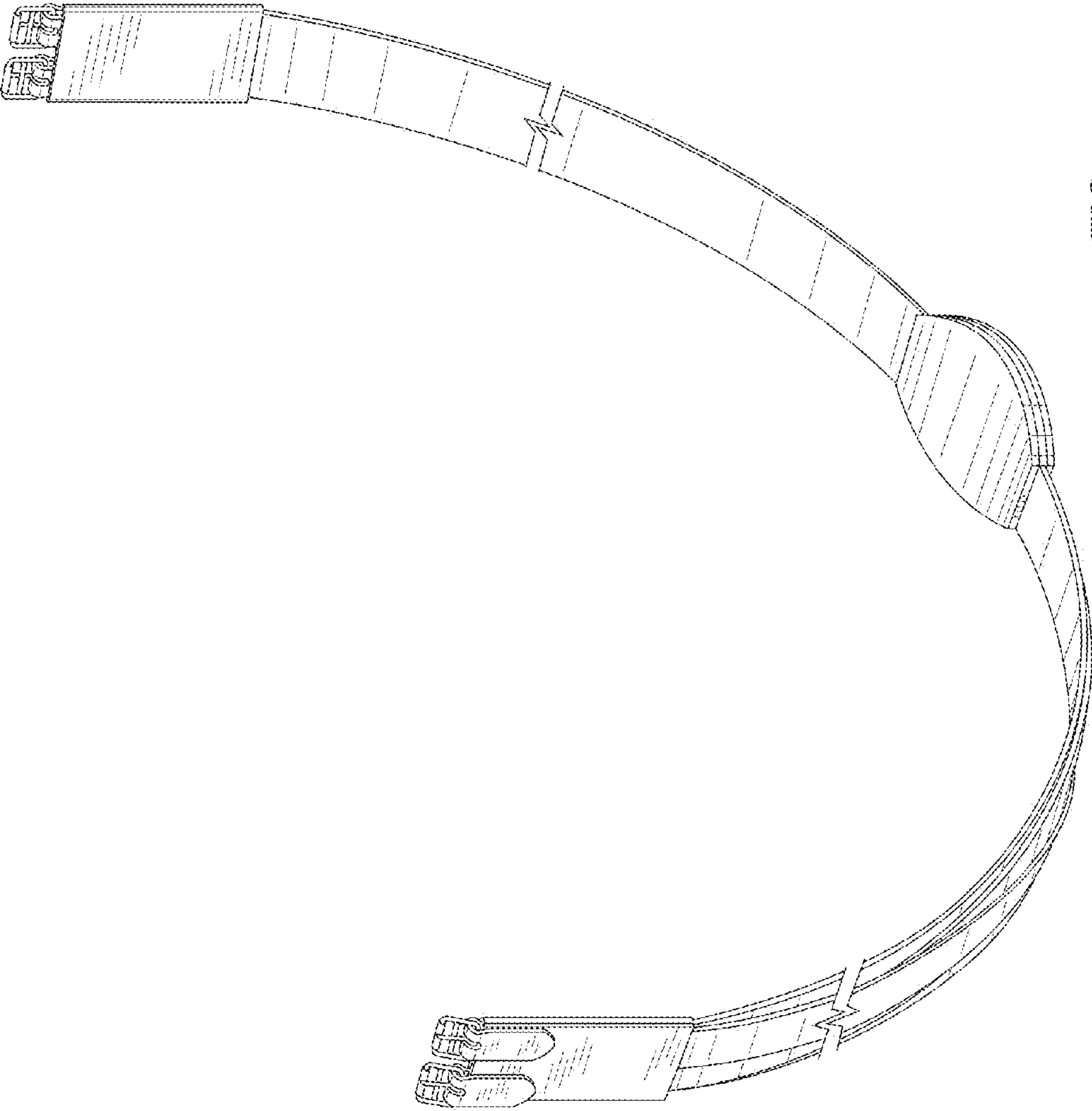

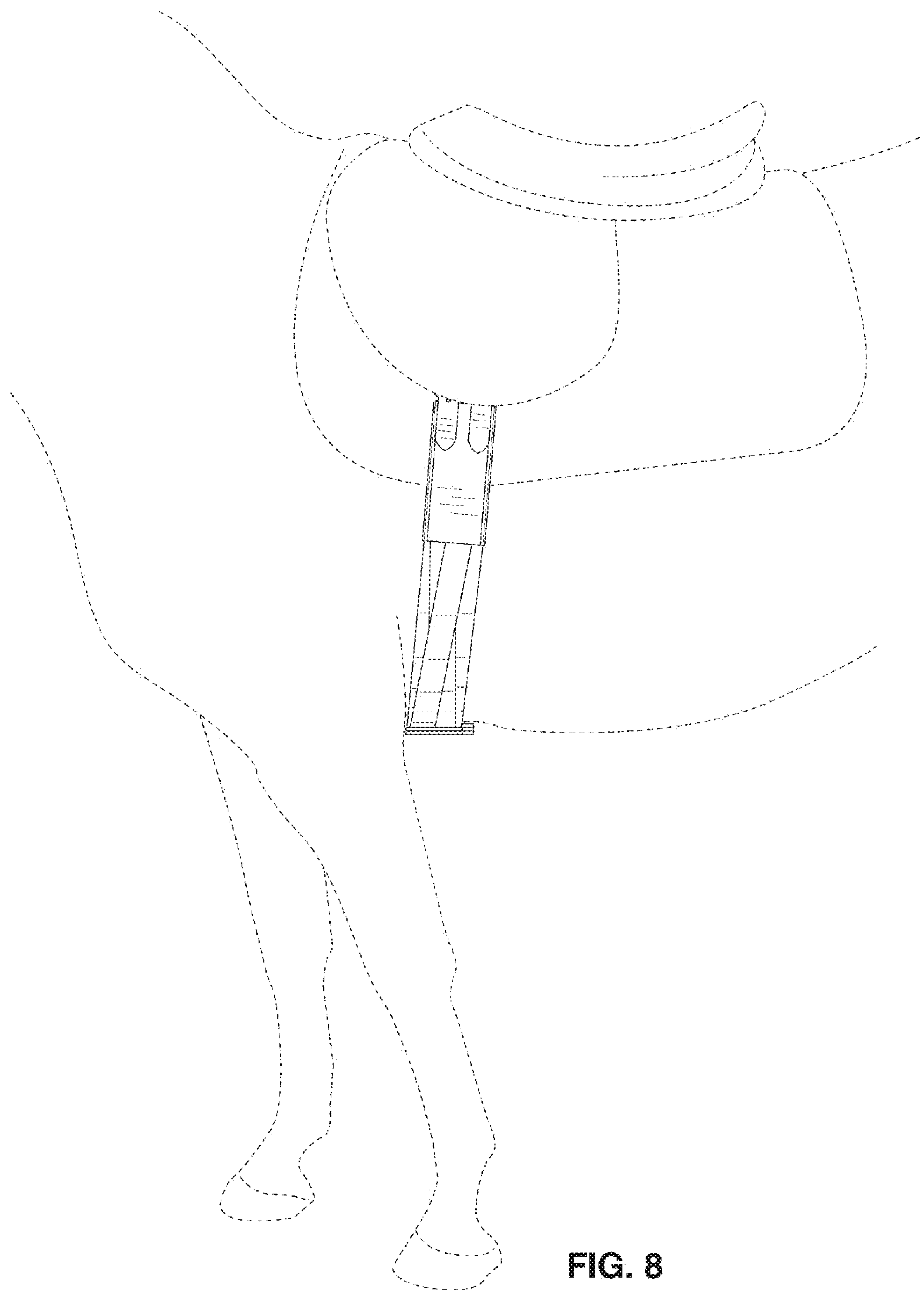

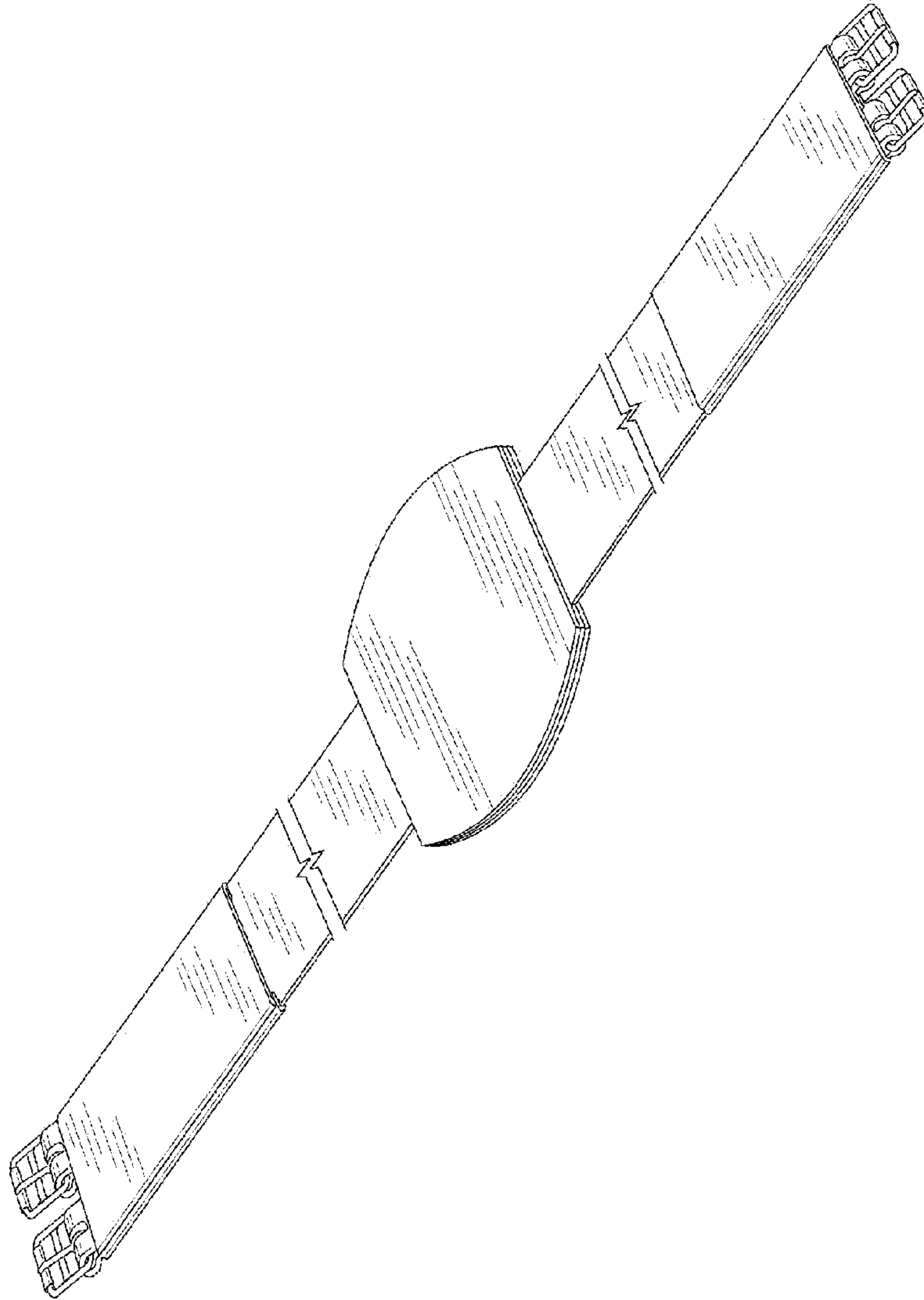

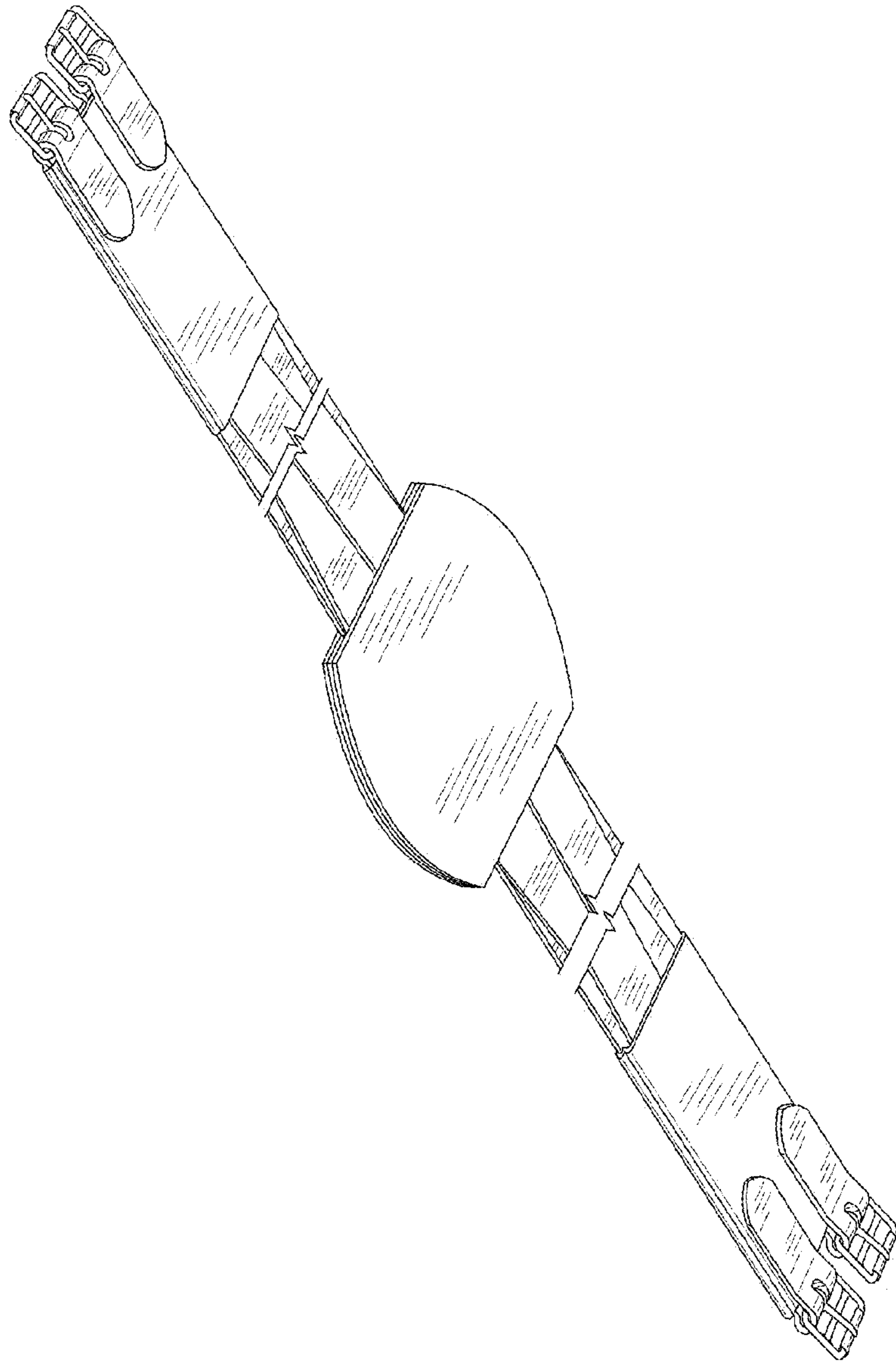

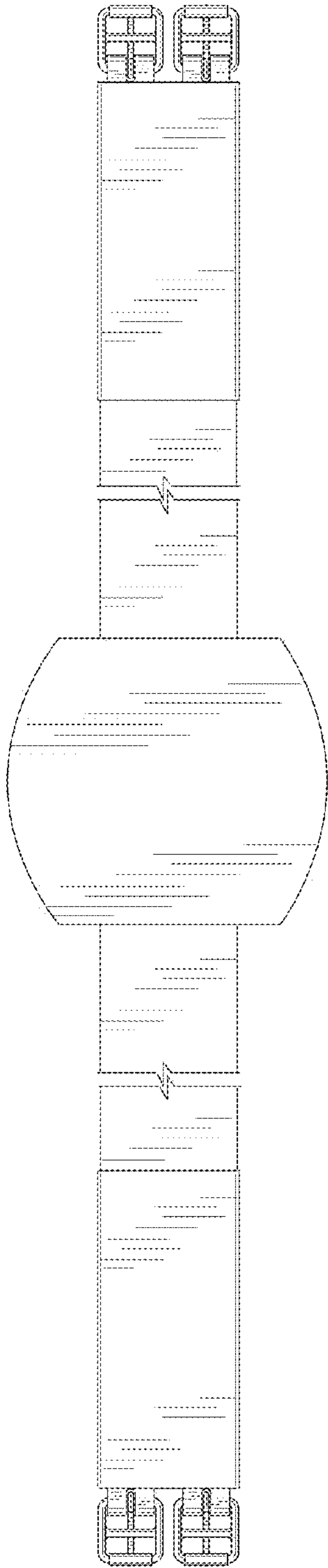

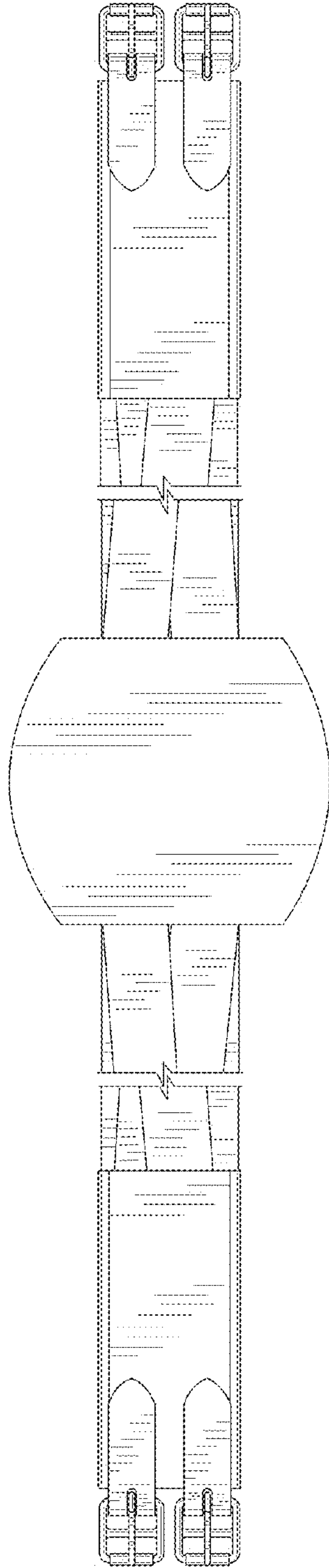

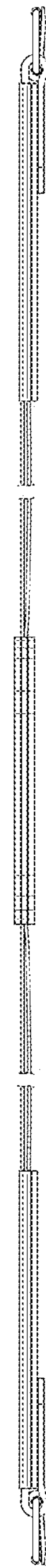

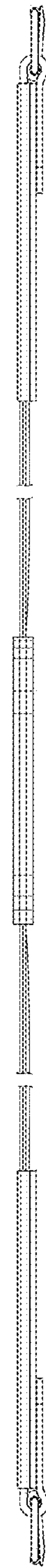

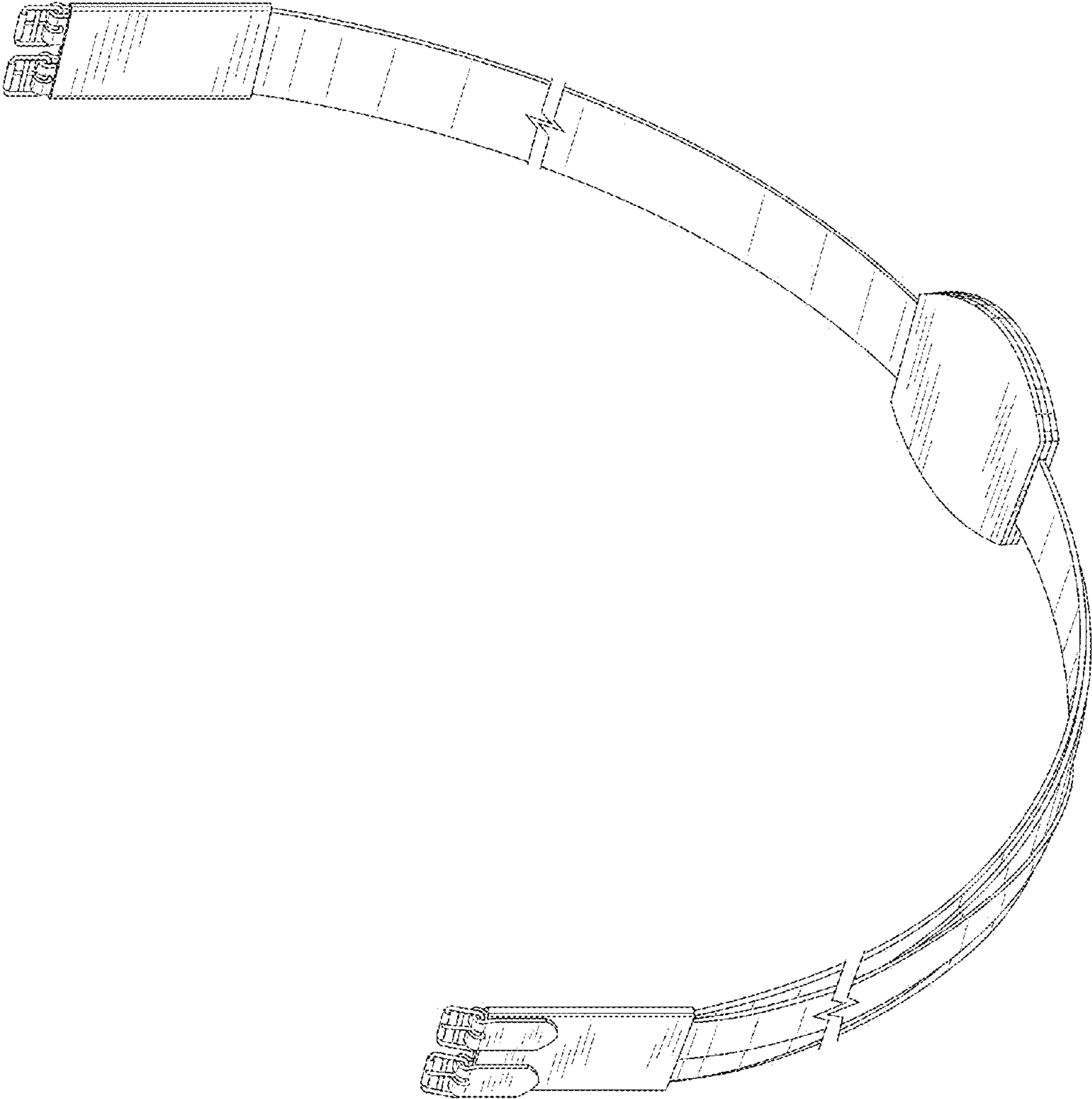
