DESCRIPTION

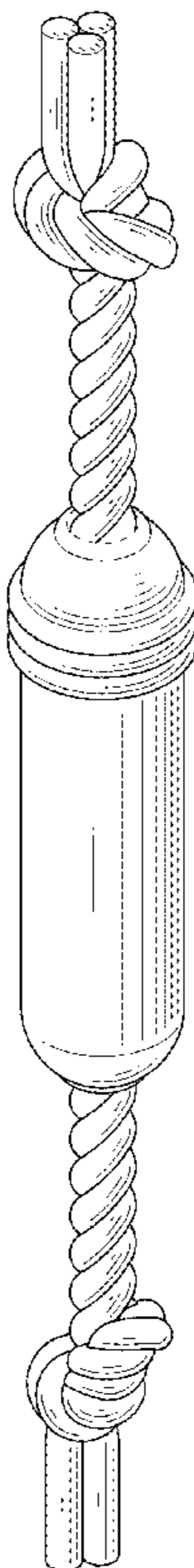
FIG. 1 is a perspective view of a pet toy showing my new design;

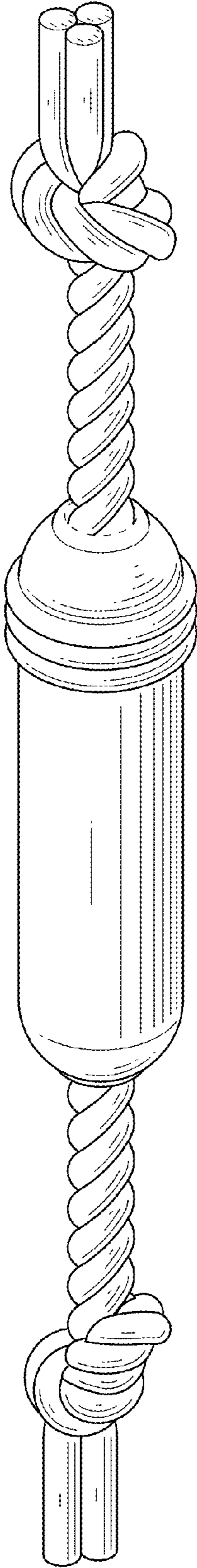

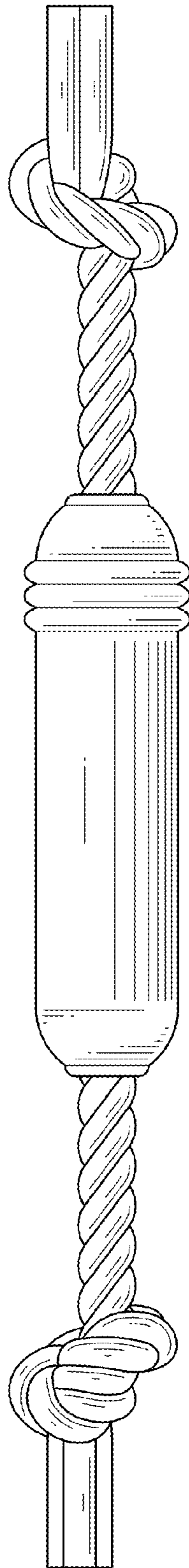

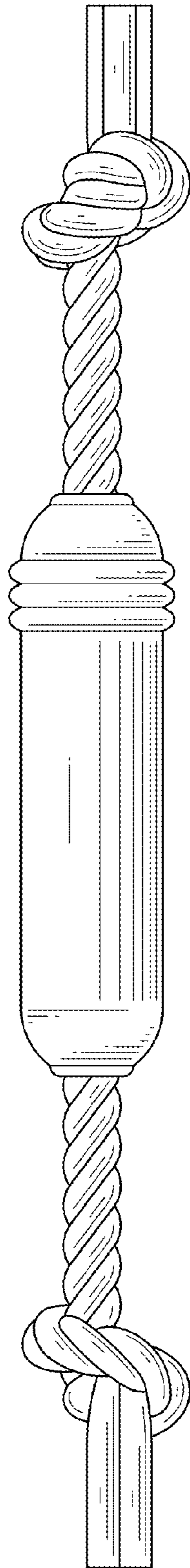

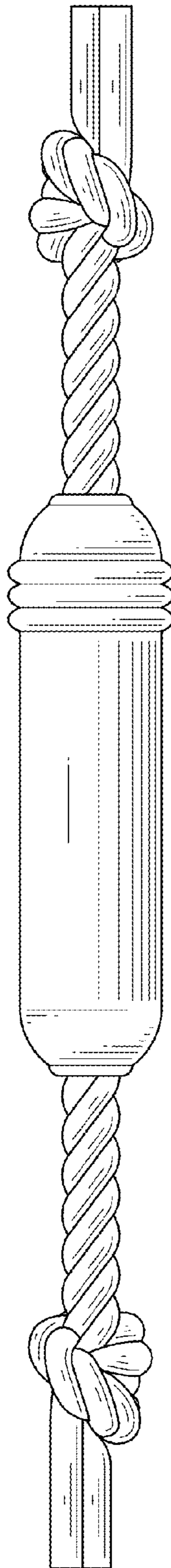

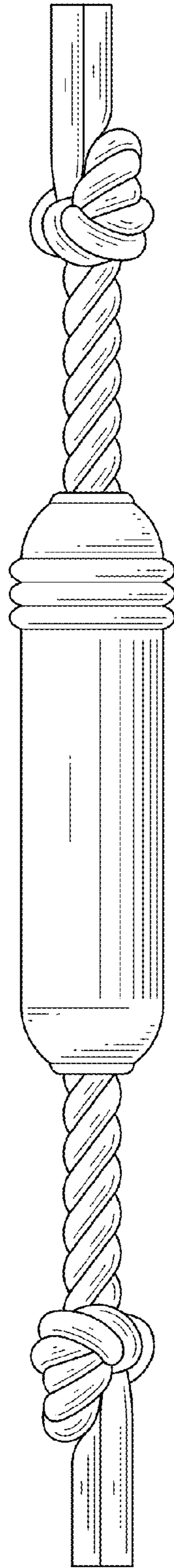

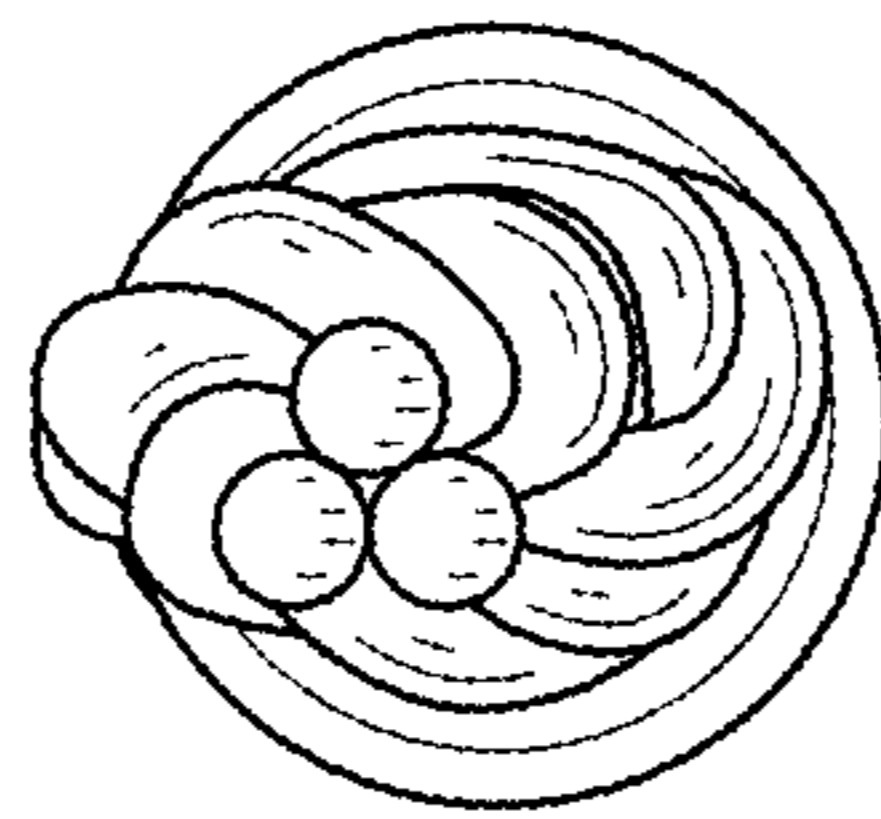

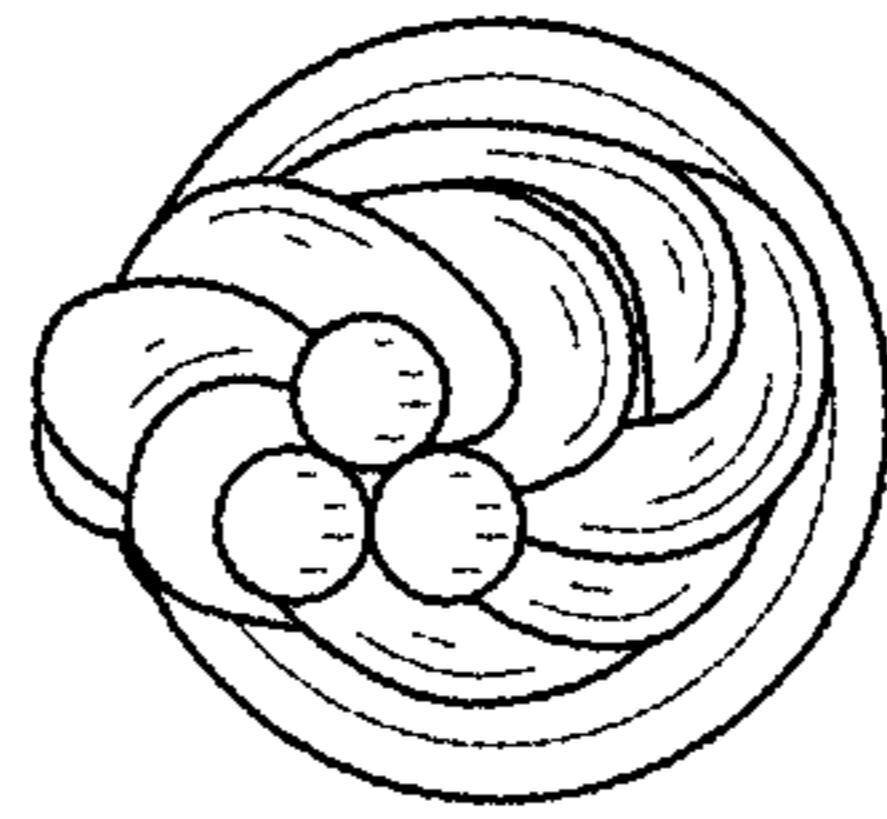
