(57) **CLAIM**

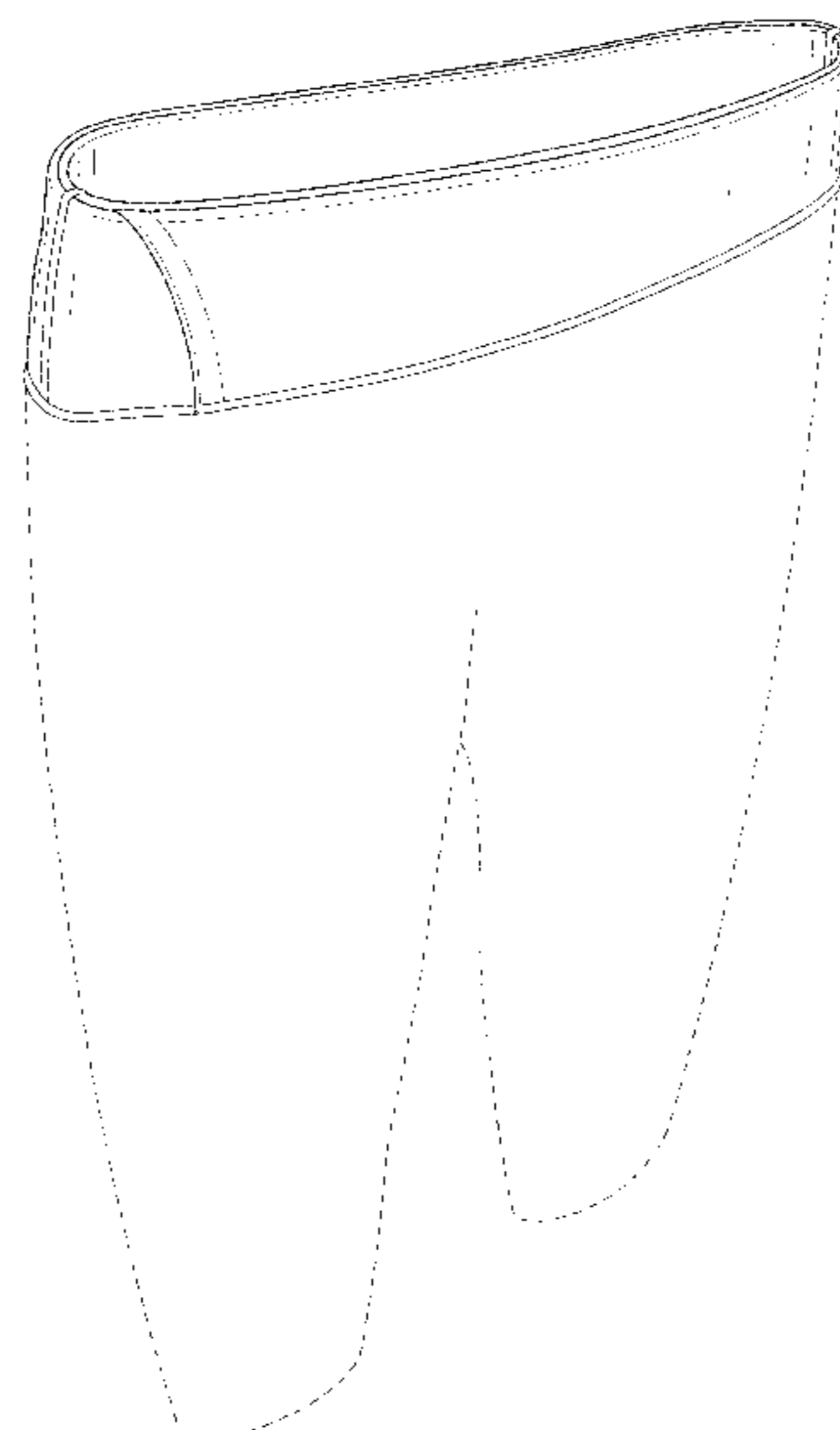
The ornamental design for a waistband, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a design for a waistband in accordance with the present invention; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is right side elevation view thereof; FIG. 6 is a left side elevation view thereof; and, FIG. 7 is a top plan view thereof.

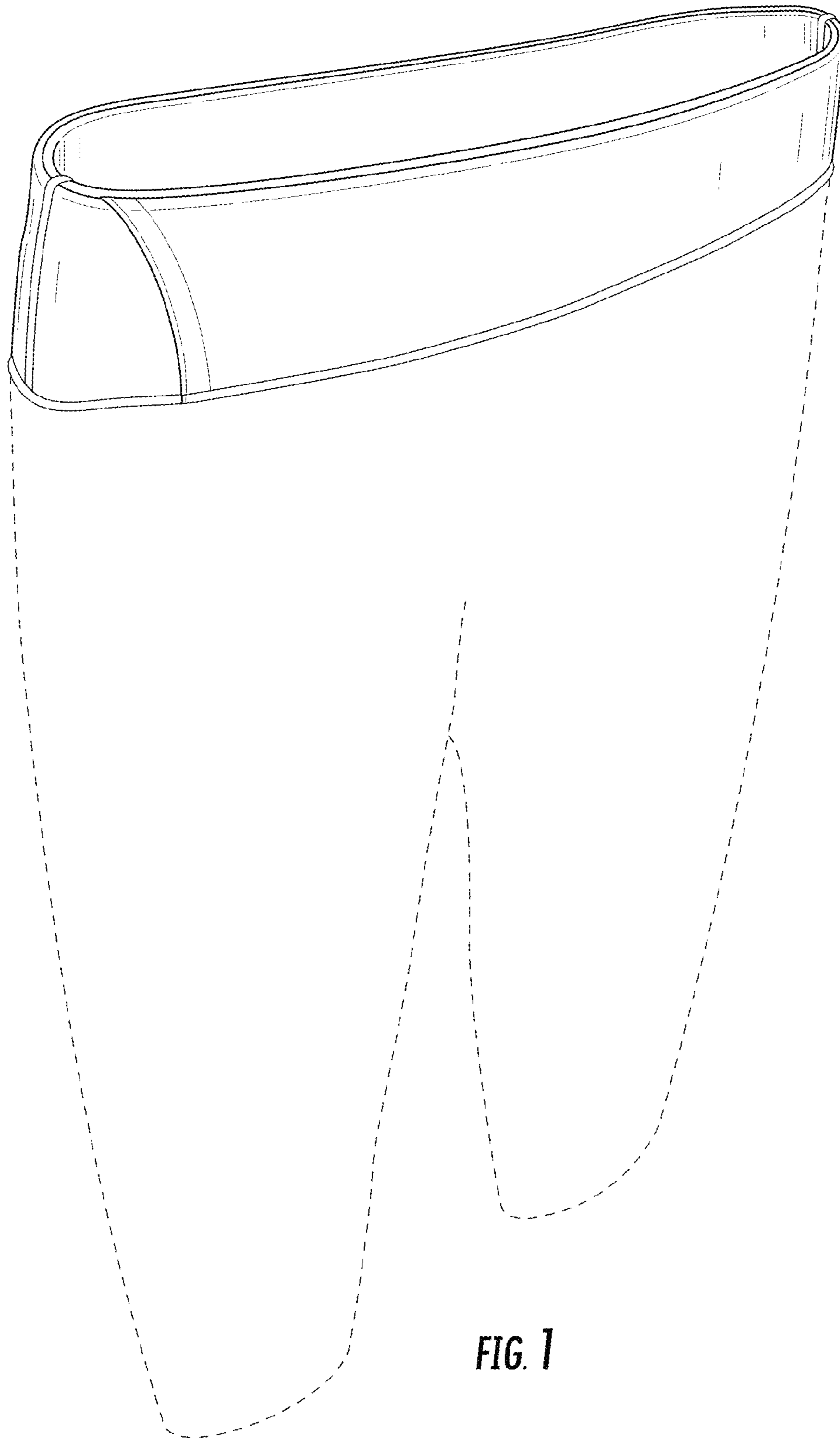

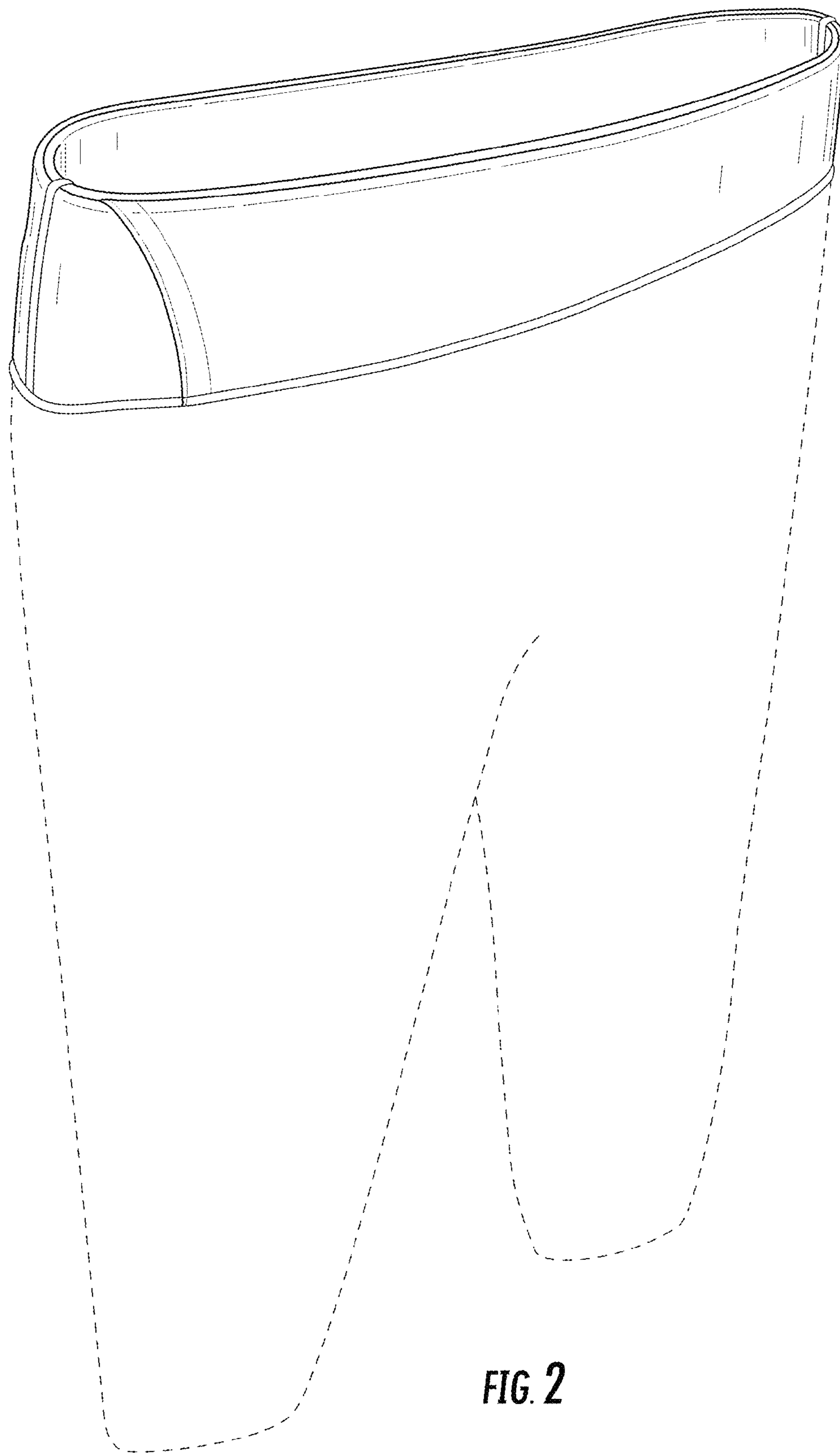

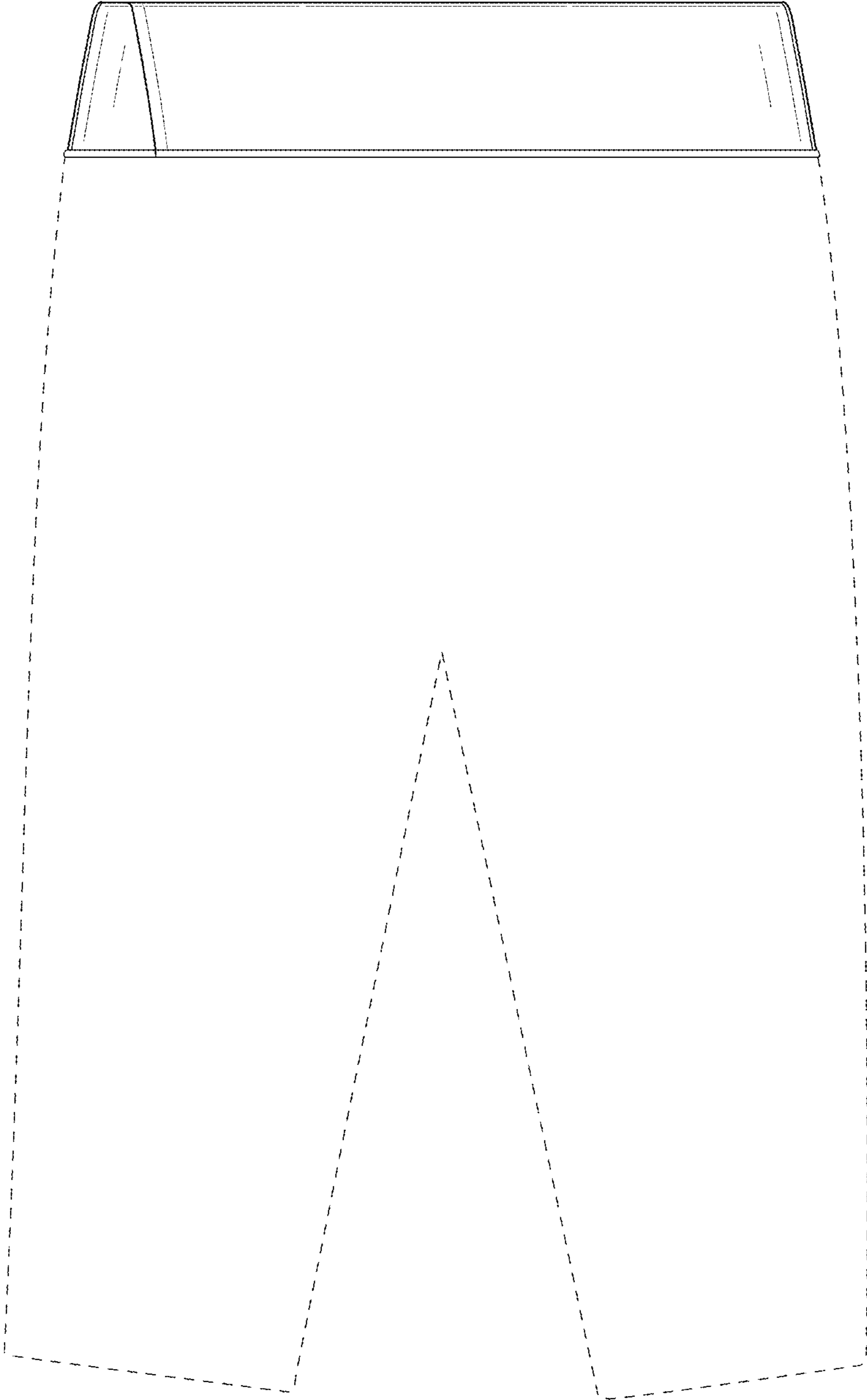

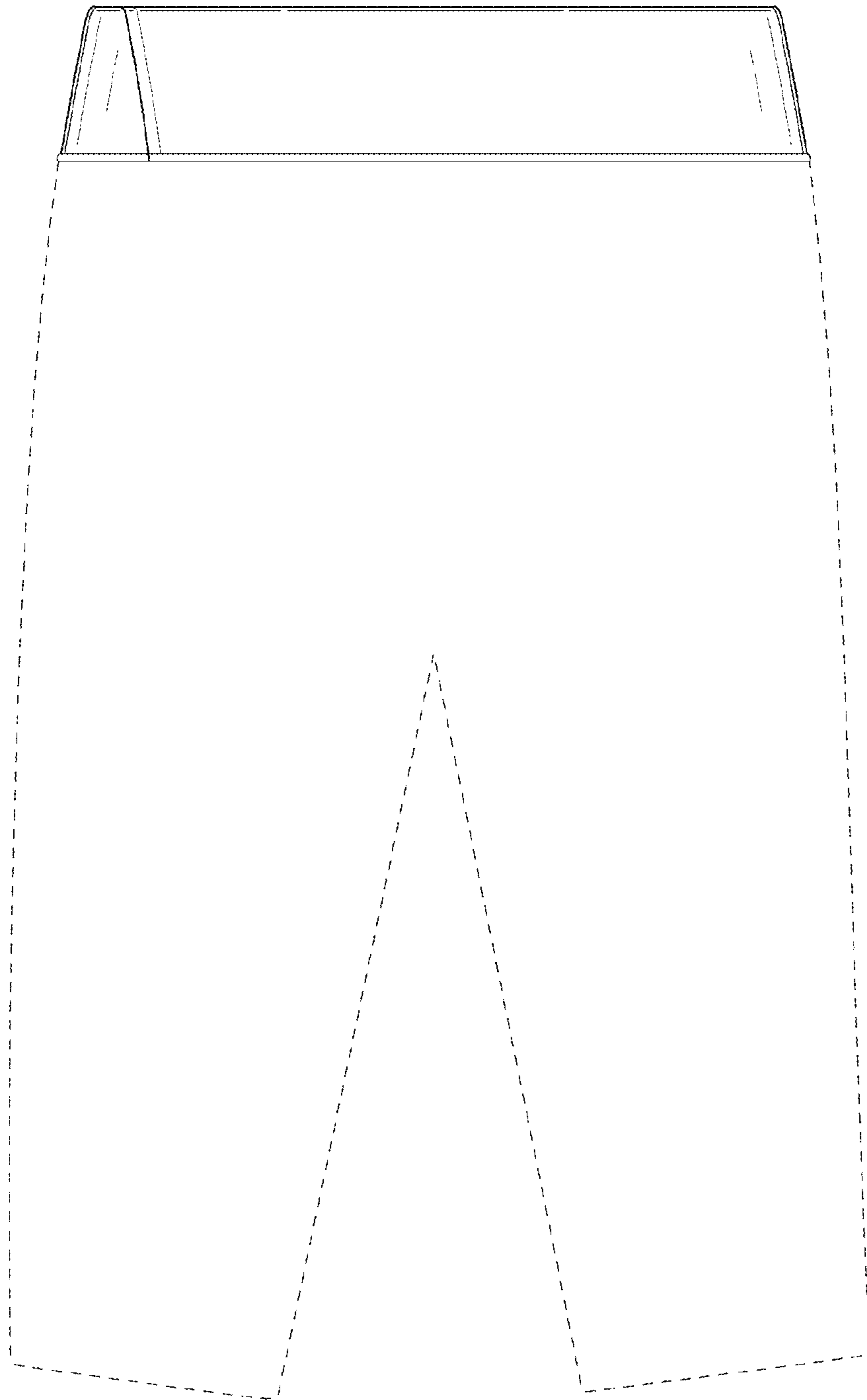
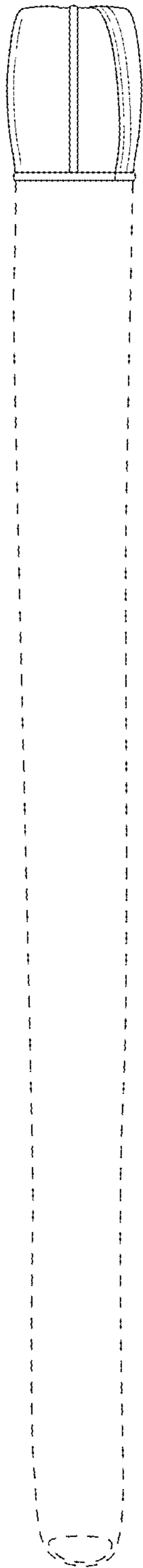
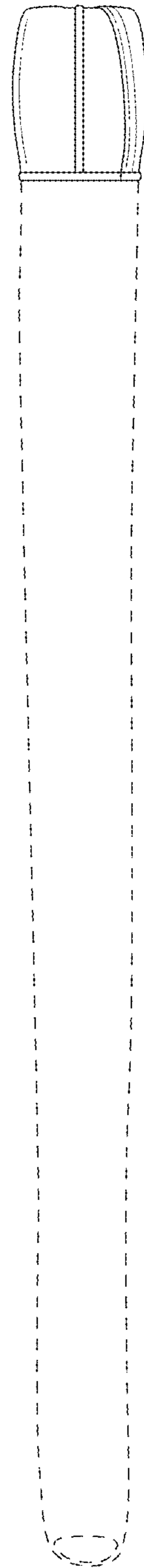


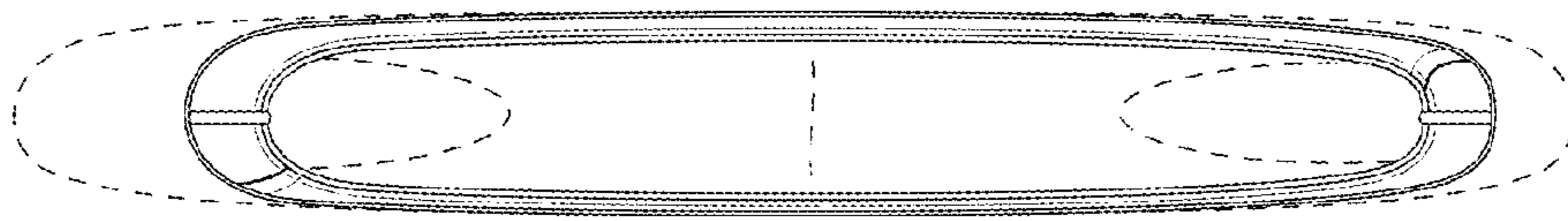
