**DESCRIPTION**

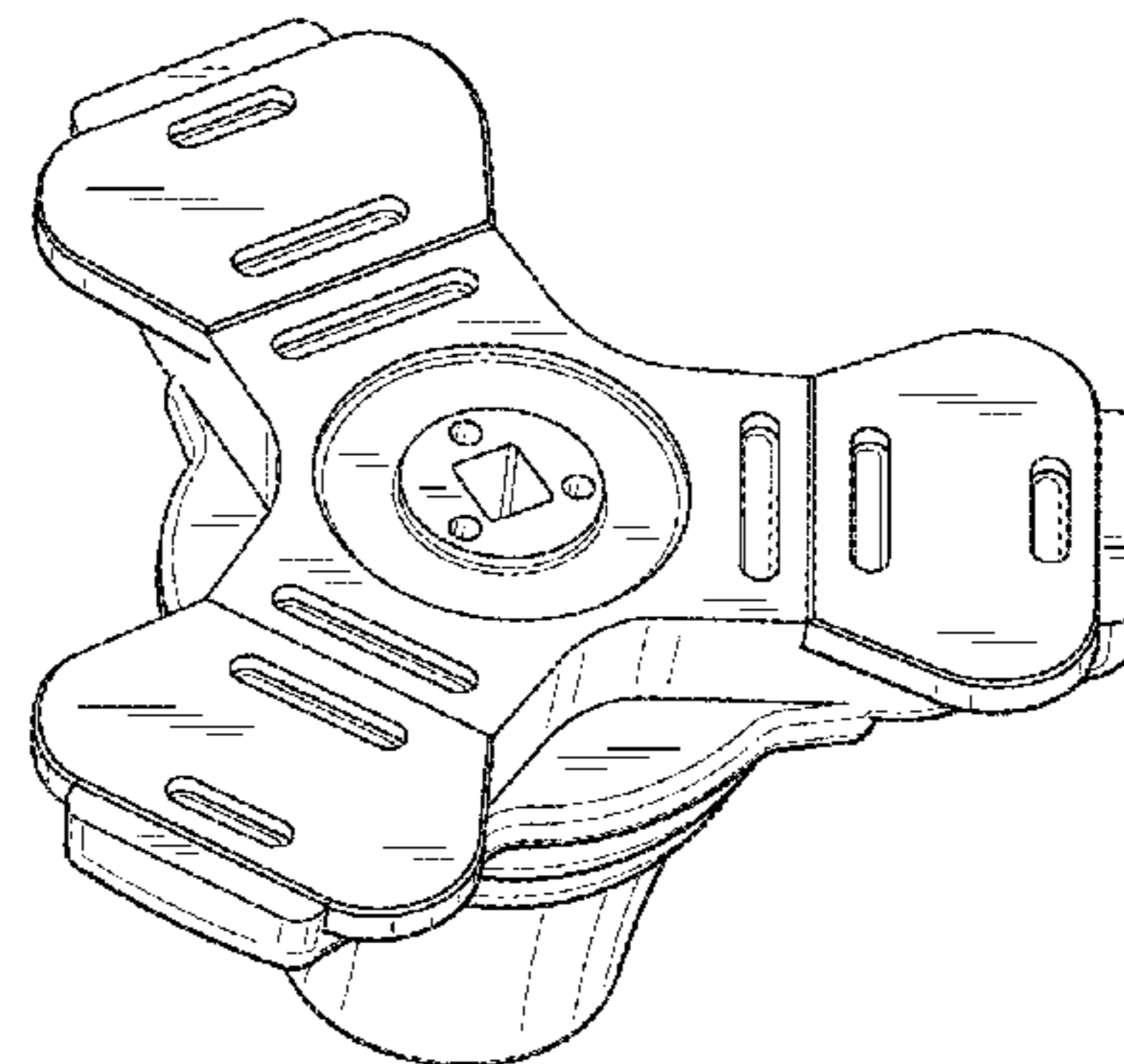
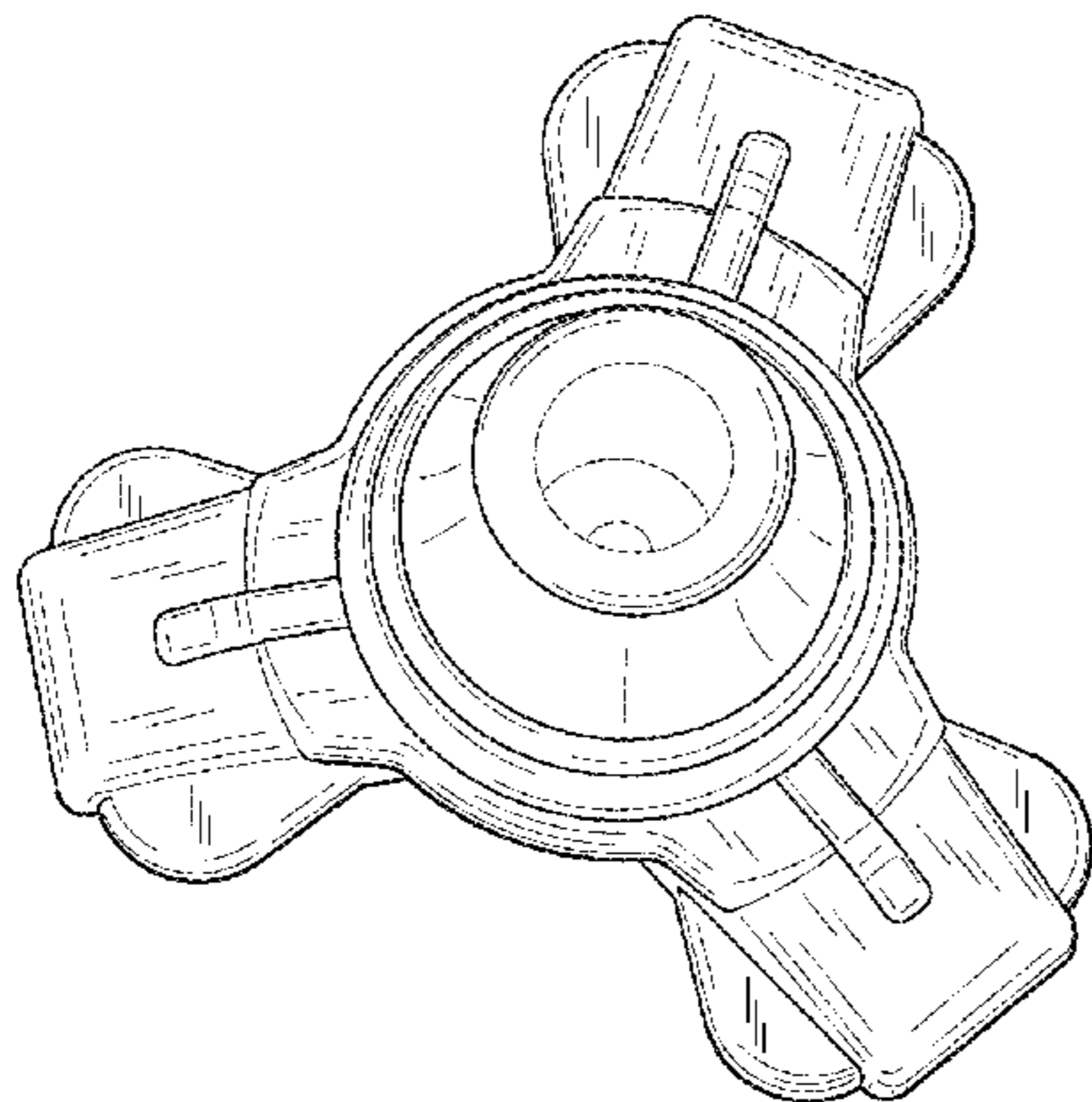
FIG. 1 is a first perspective view of my new design for a base for a cane showing it attached to a cane;

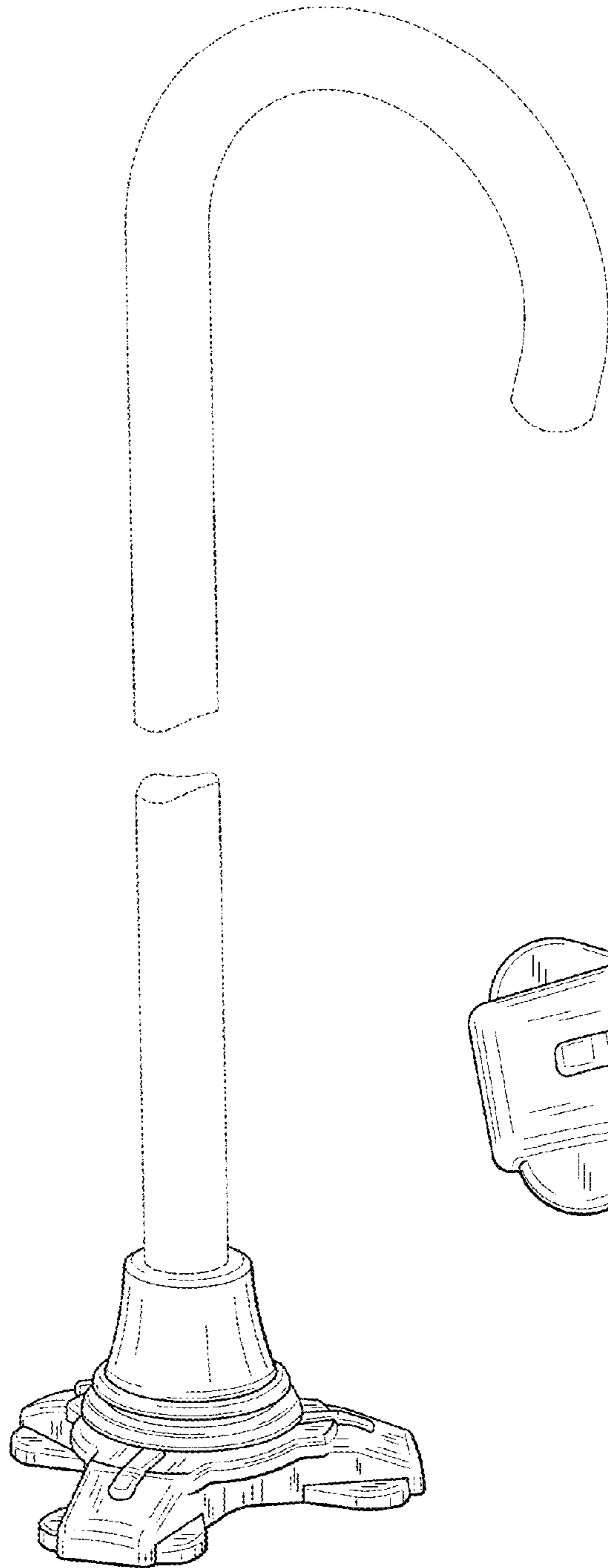

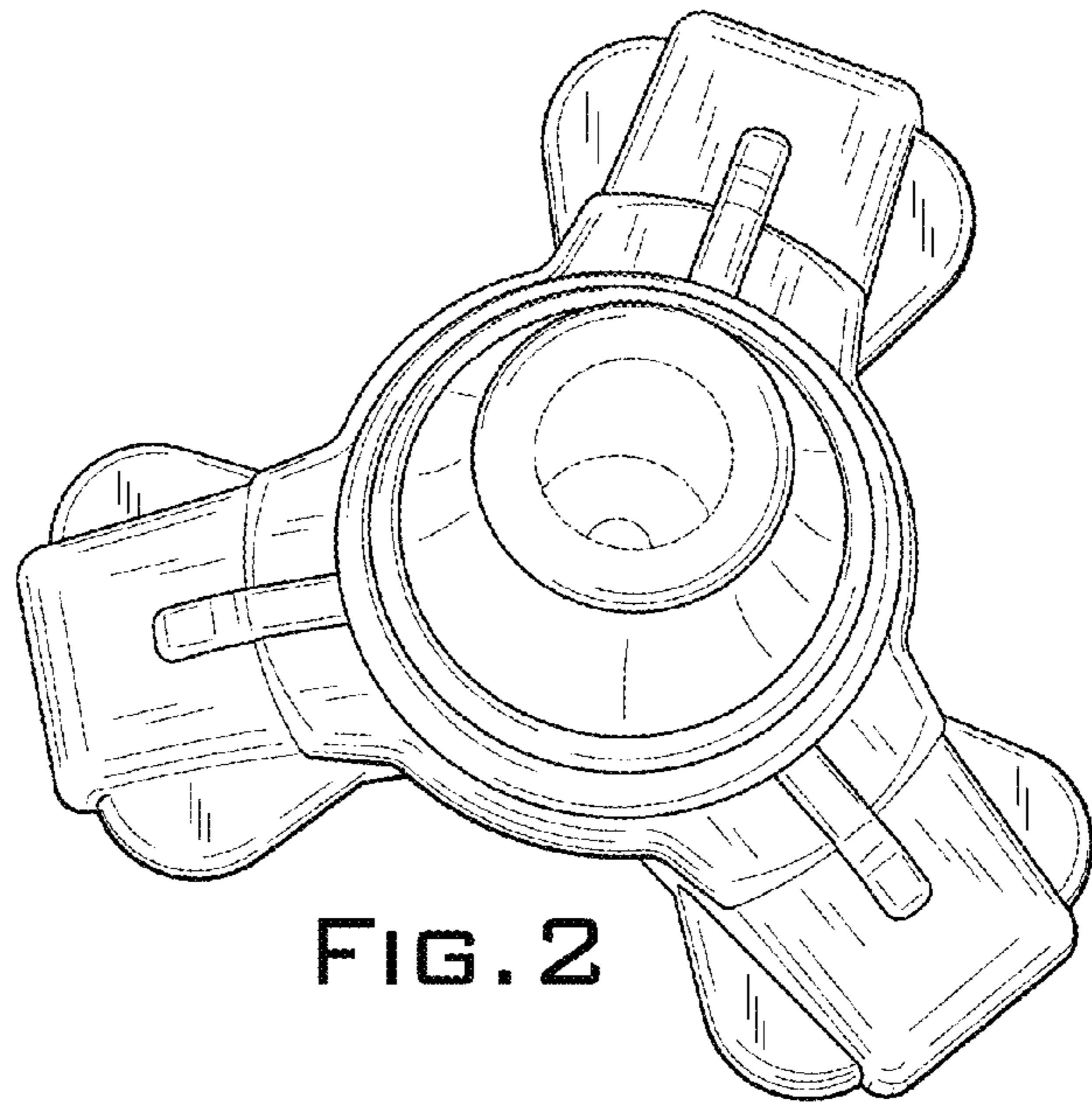

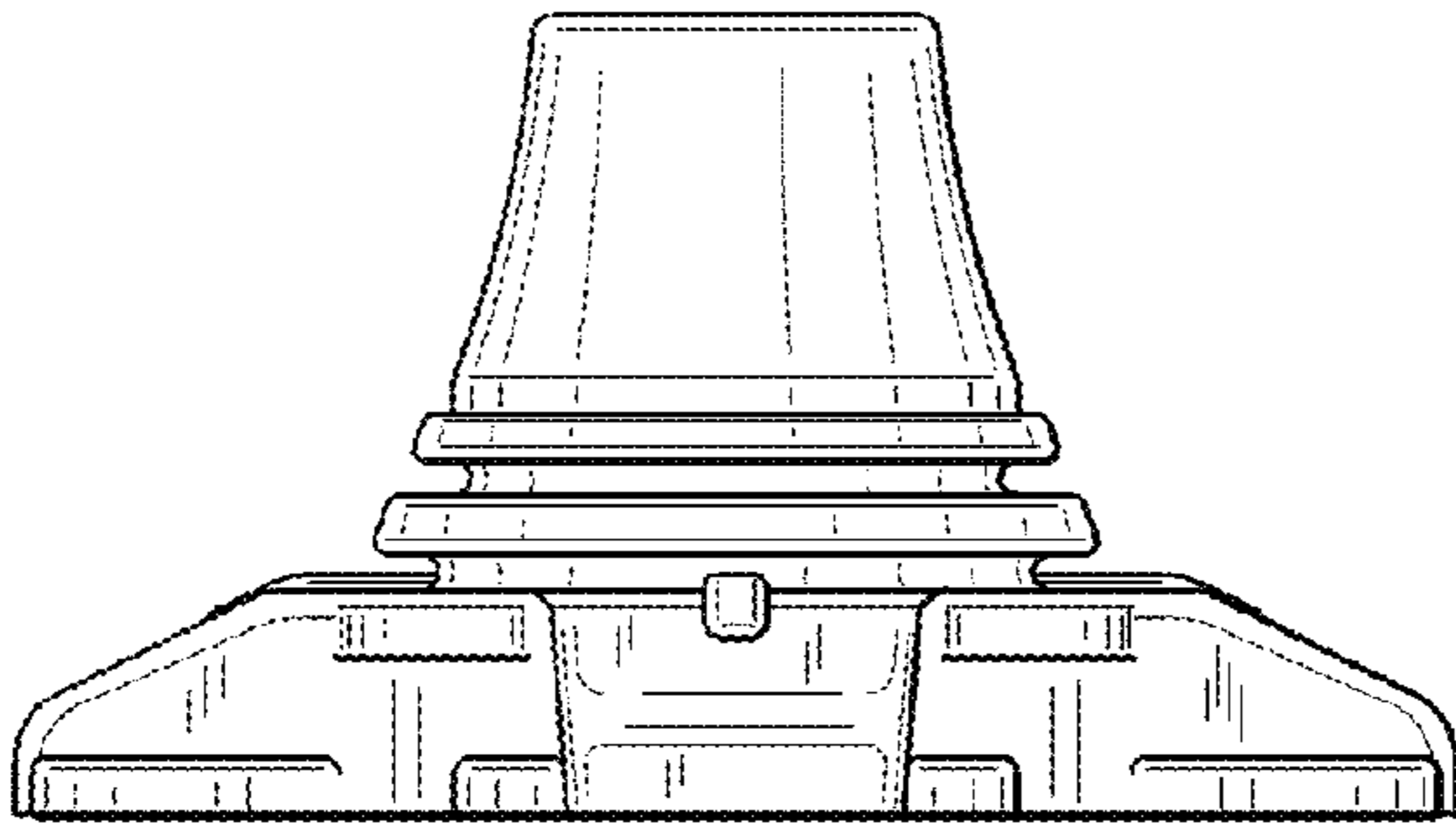

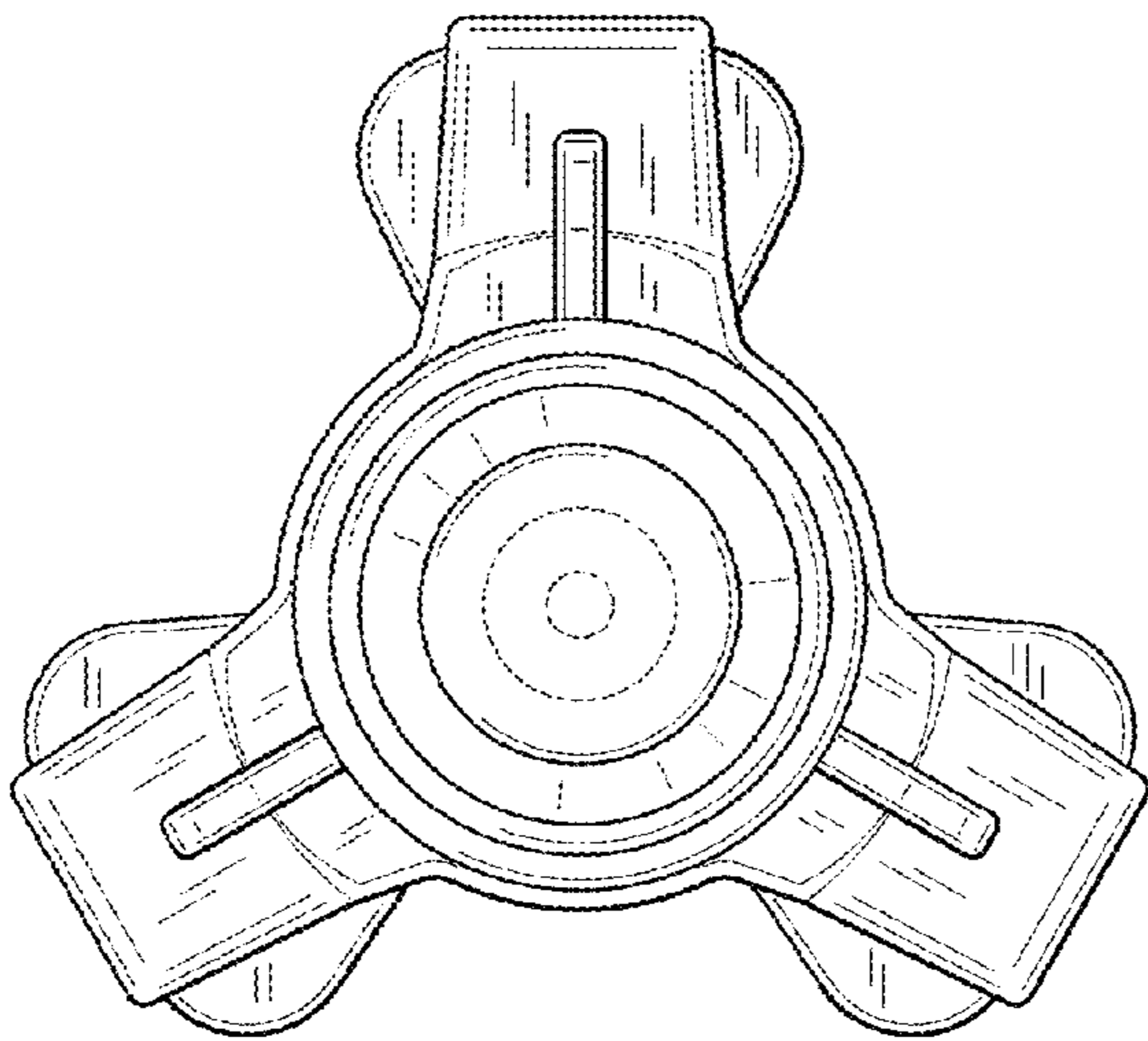

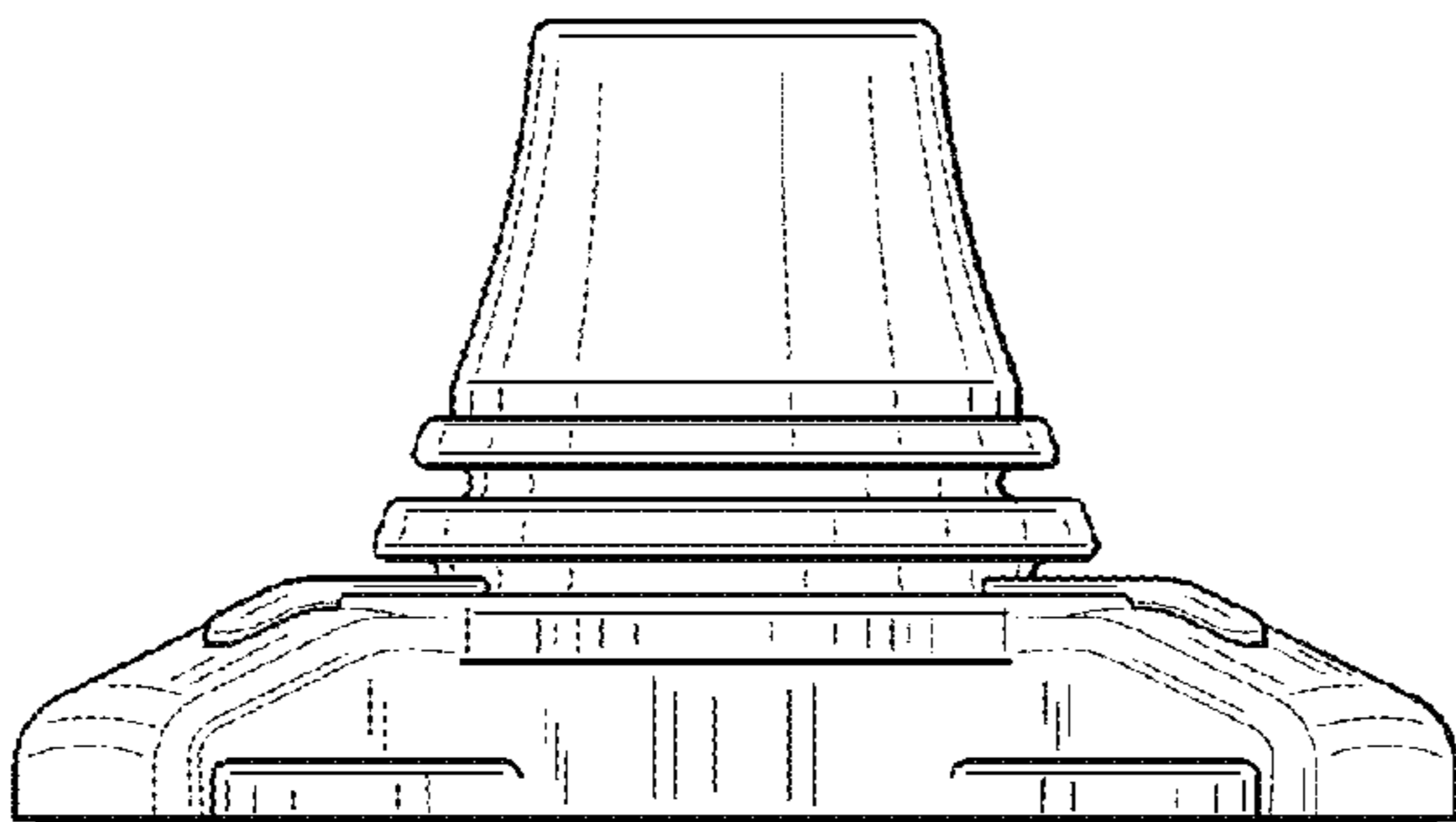

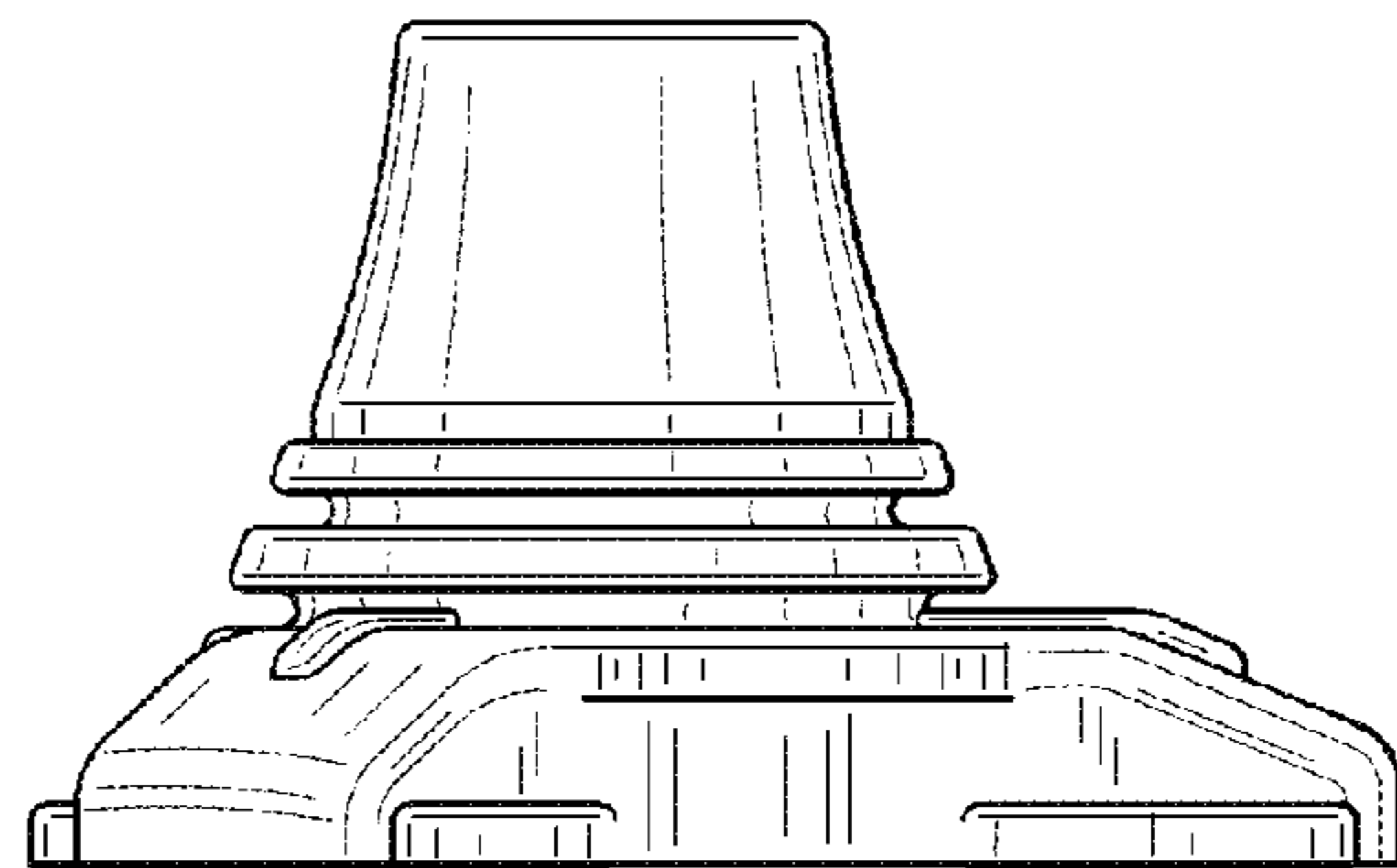

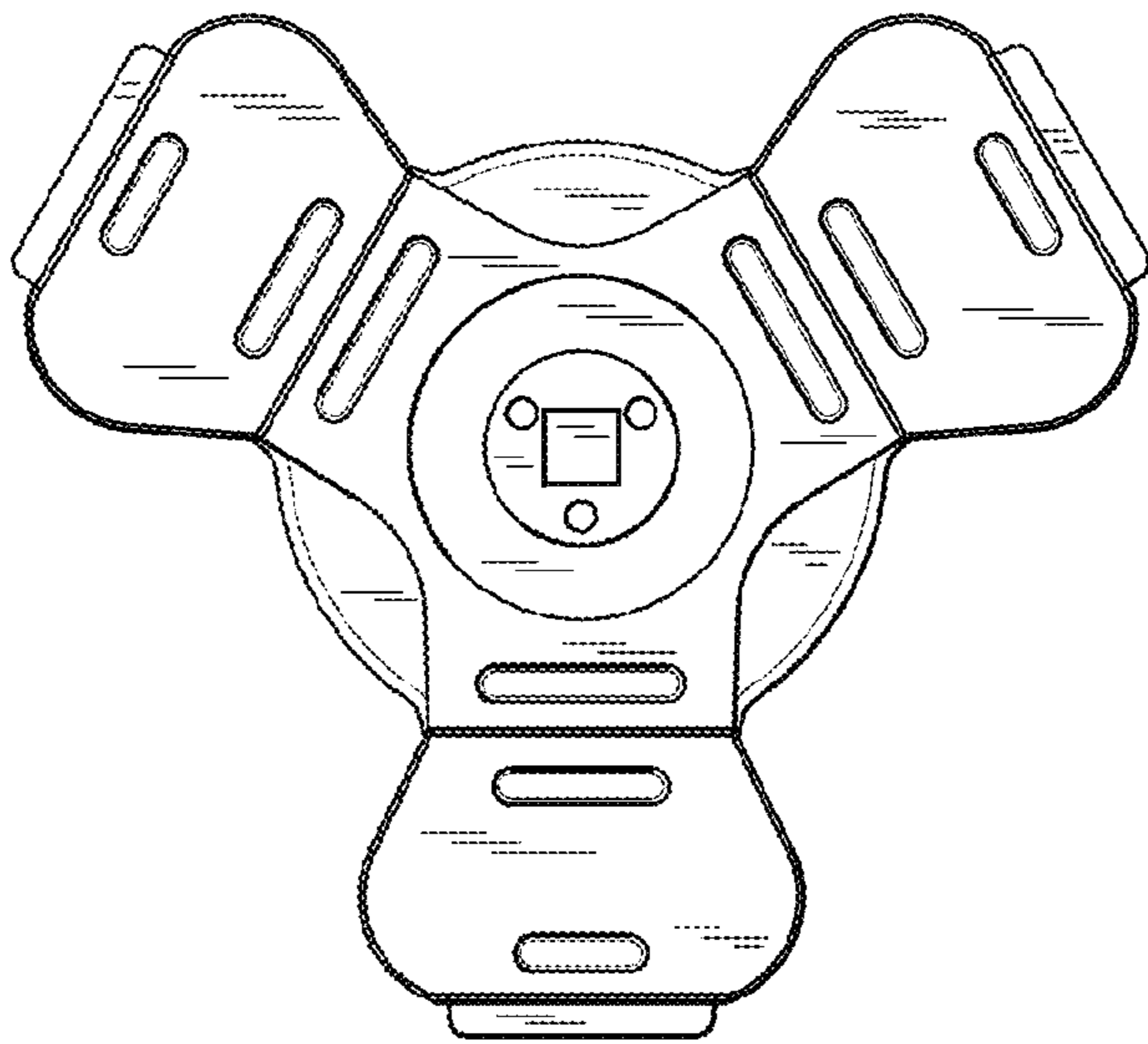

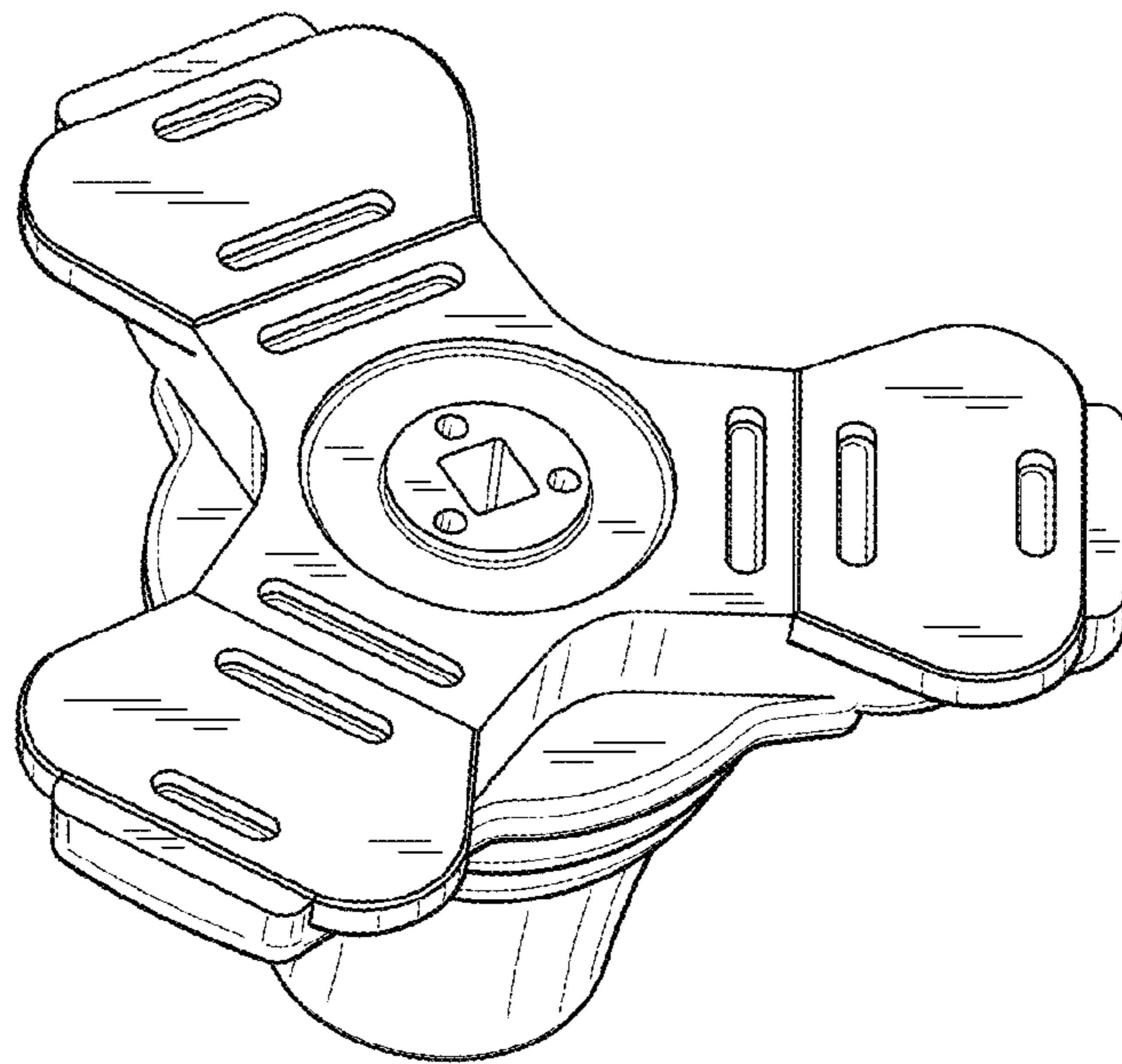
