FIG. 12 is a right side view of the embodiment of FIG. 8.

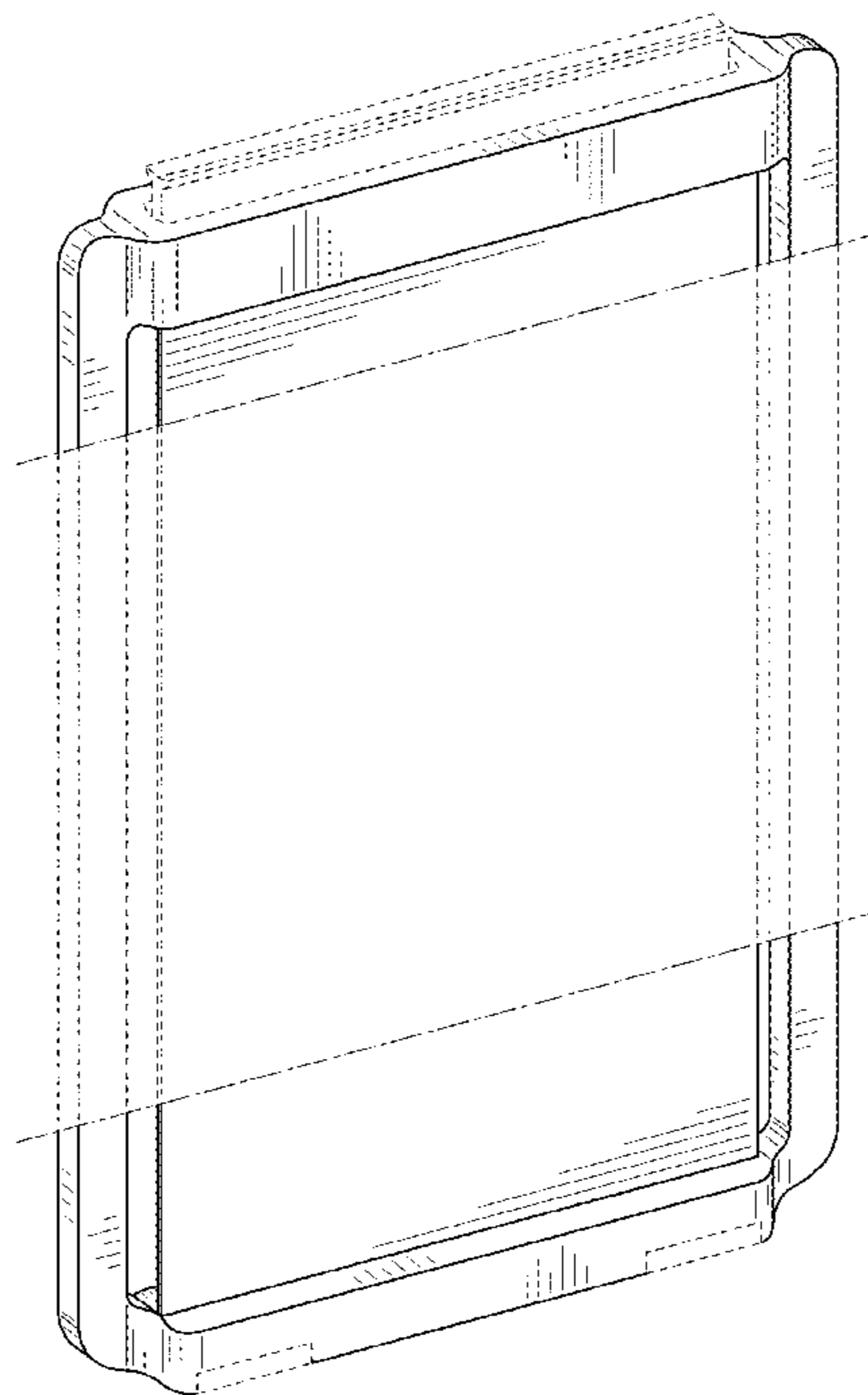
FIG. 13 is a top view of the embodiment of FIG. 8; and,

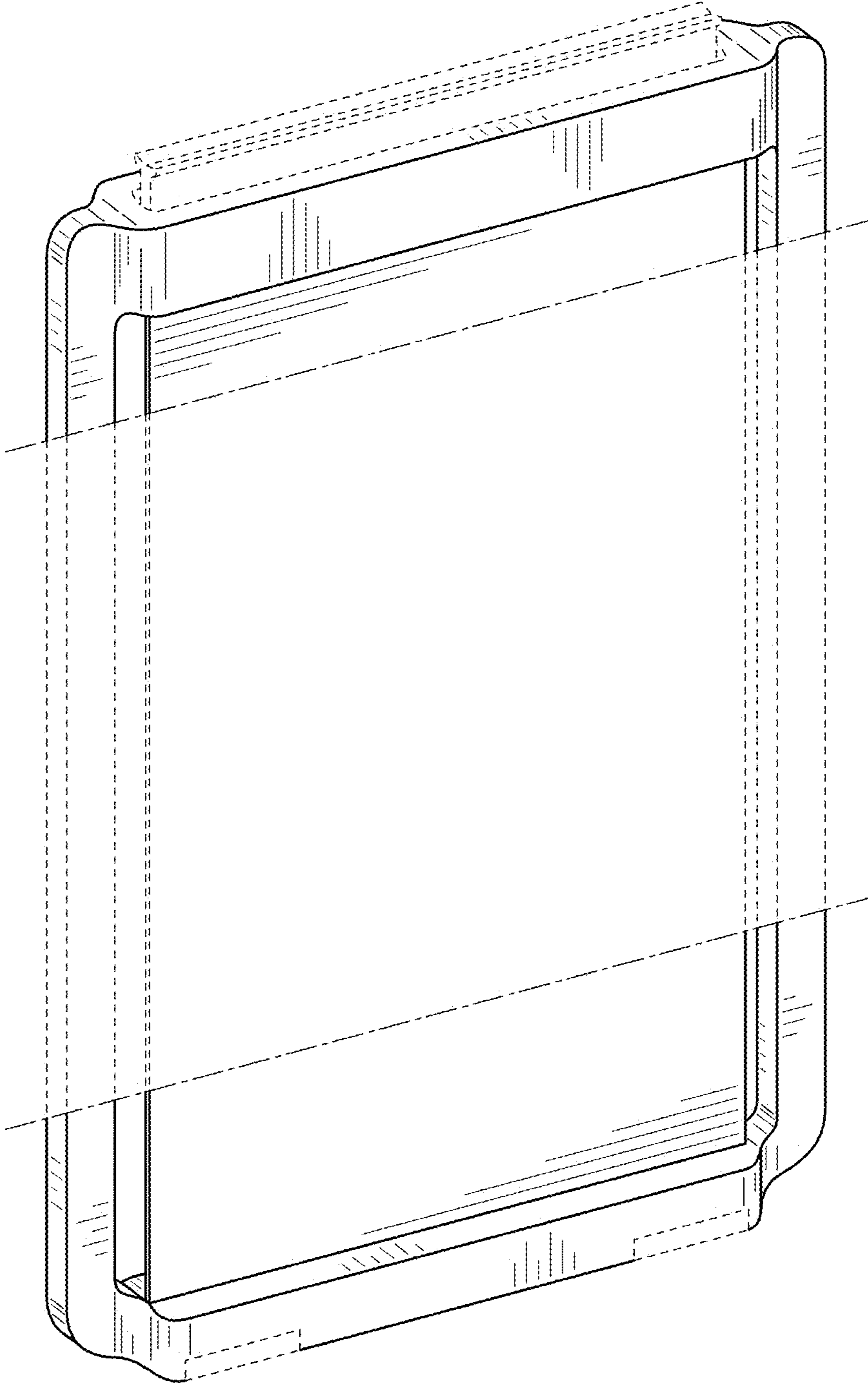

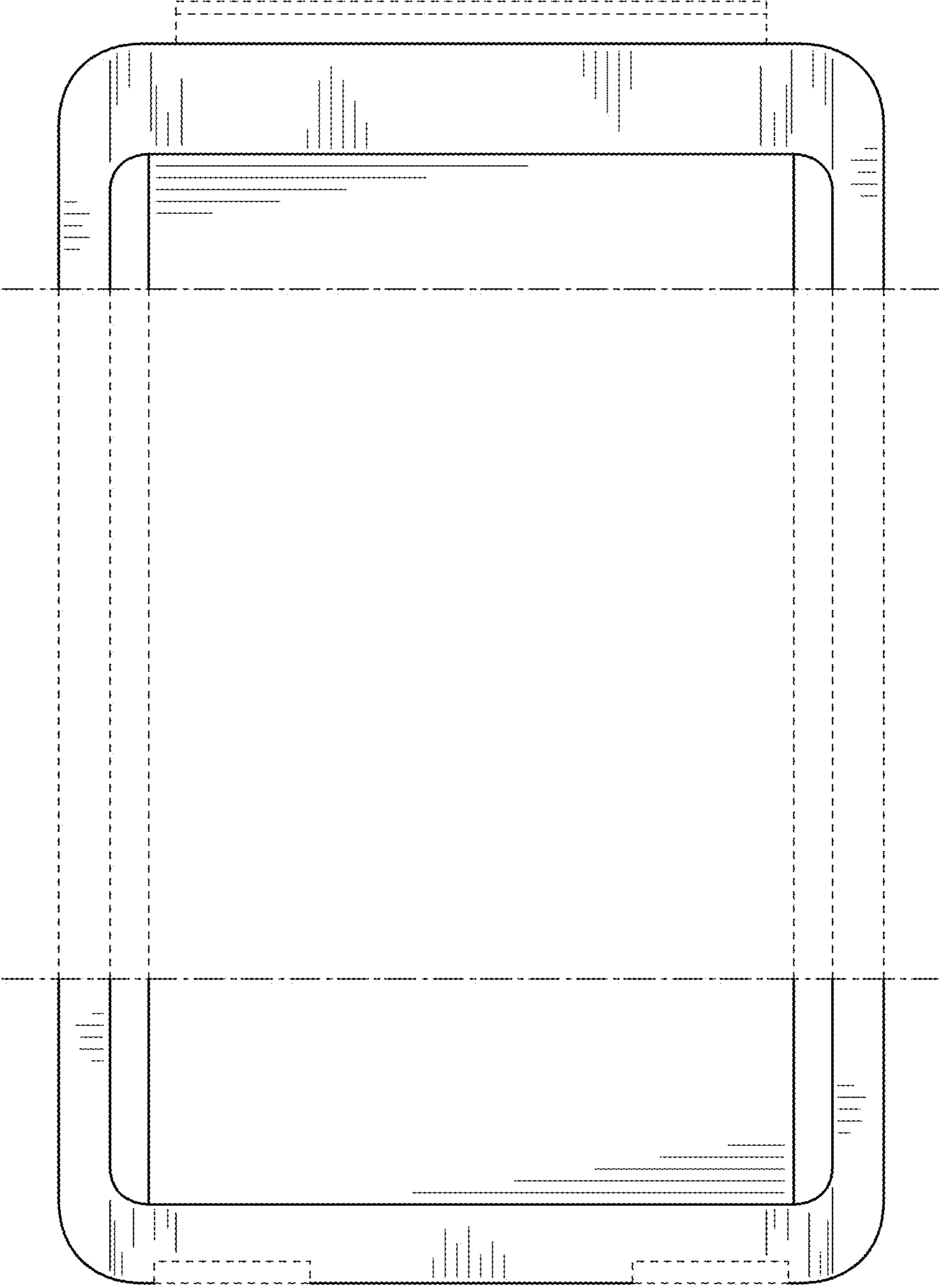

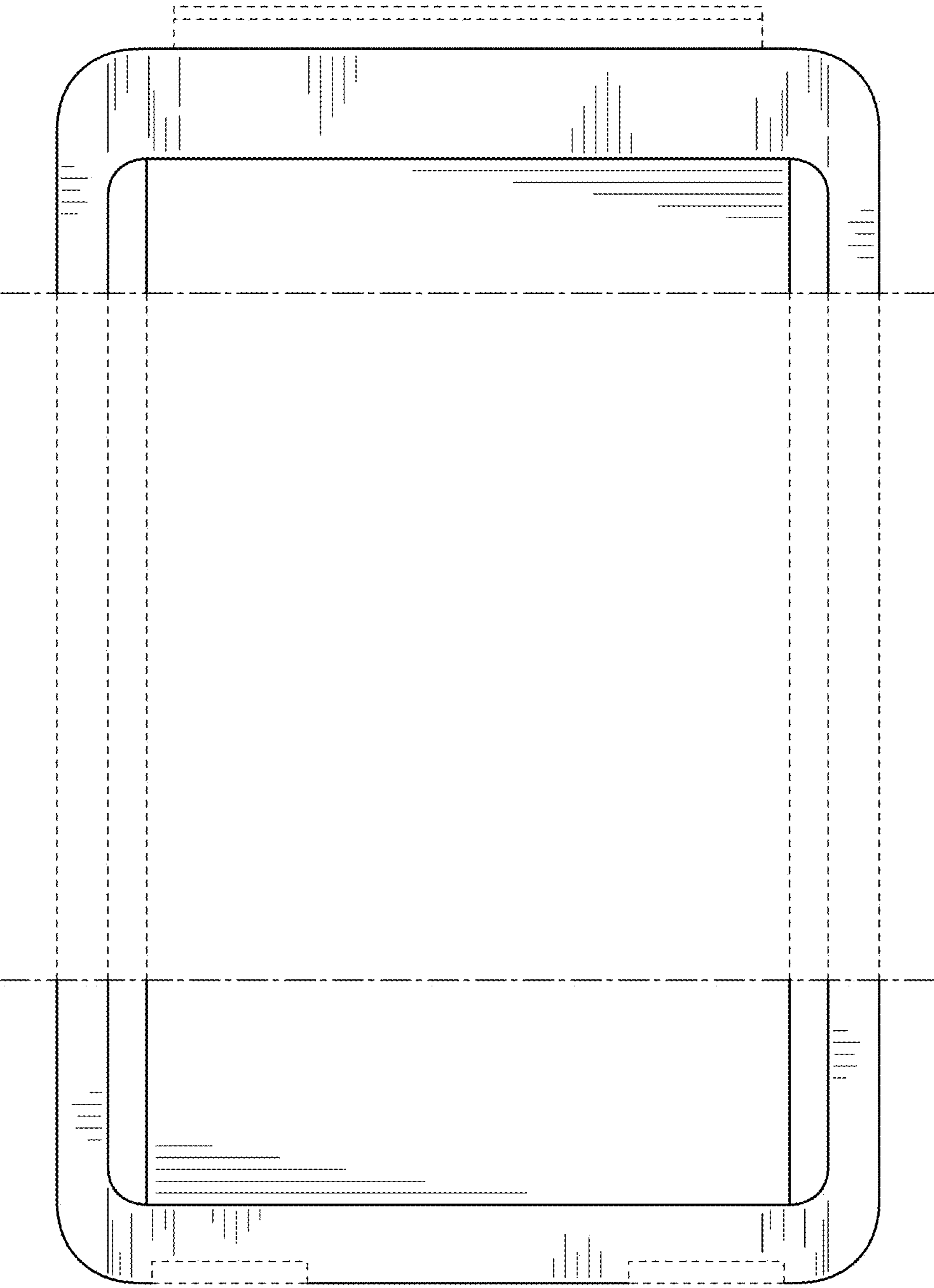

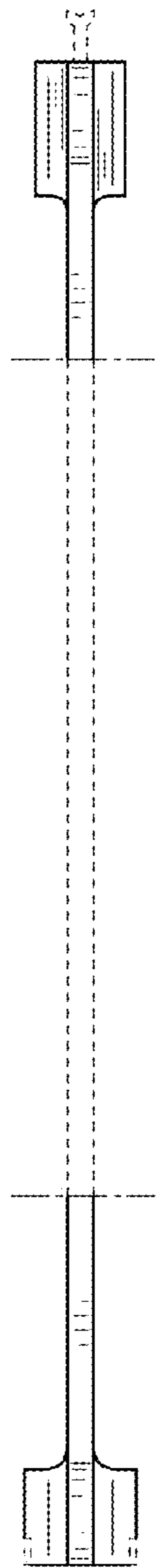

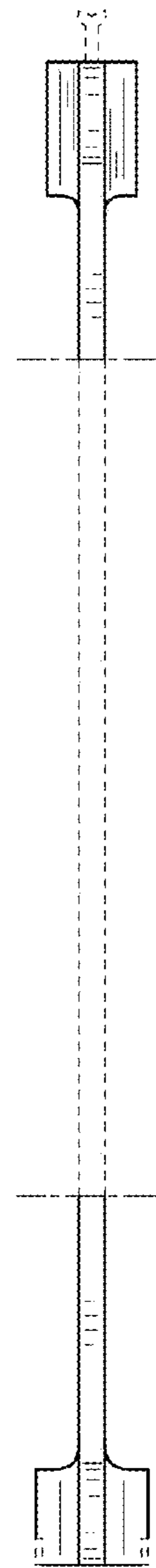

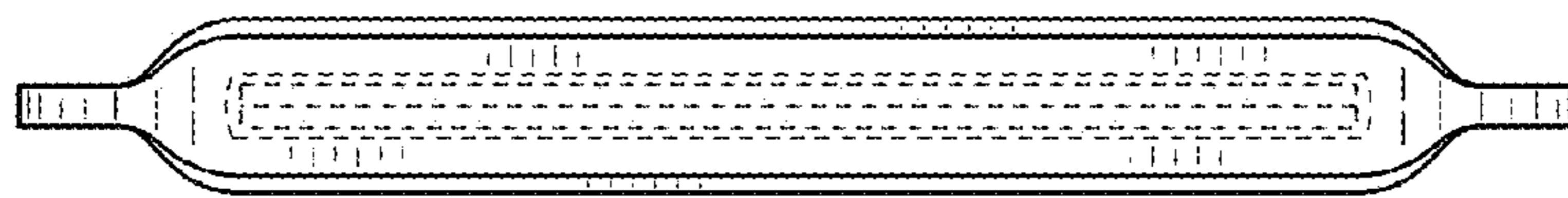

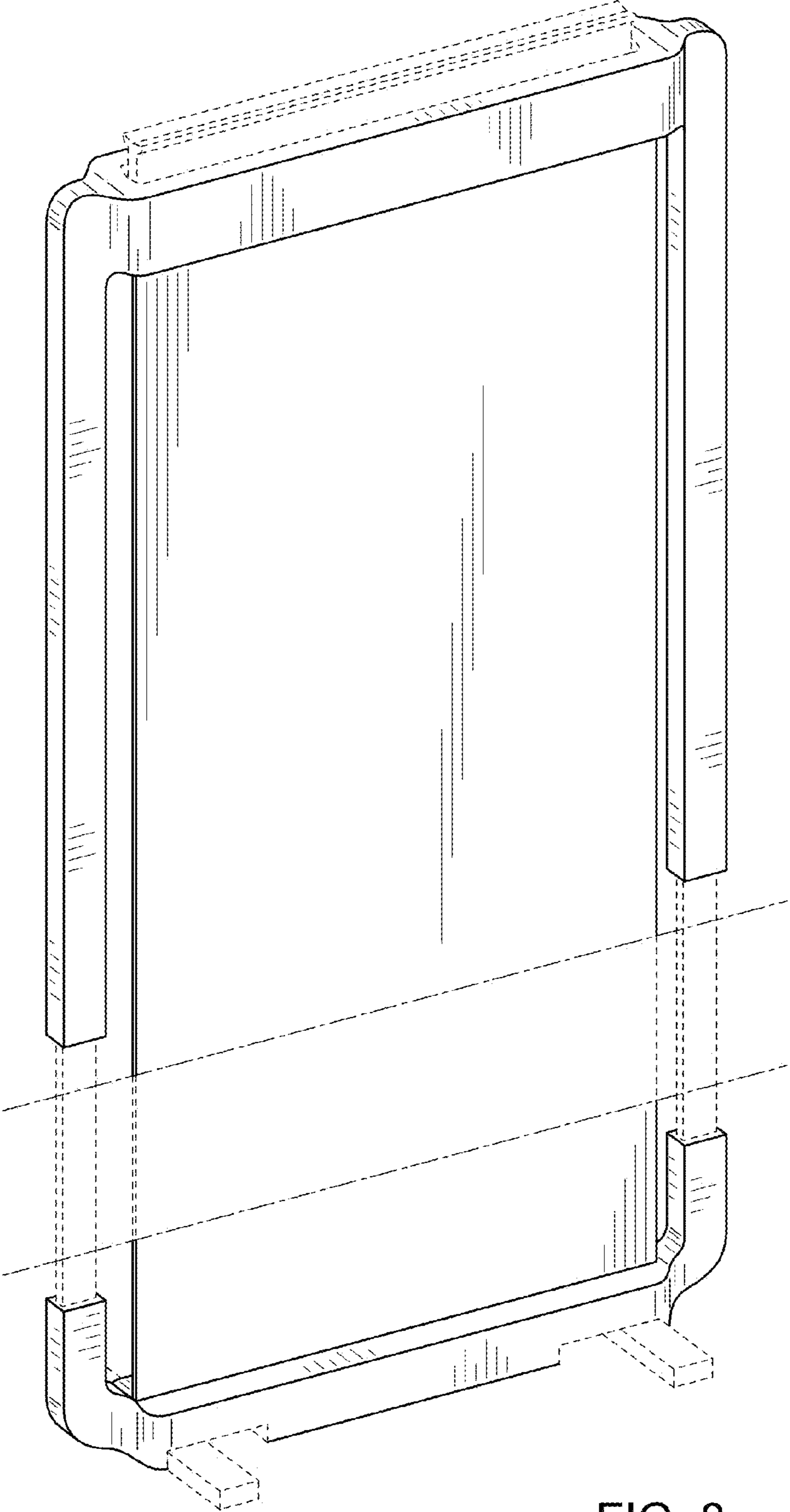

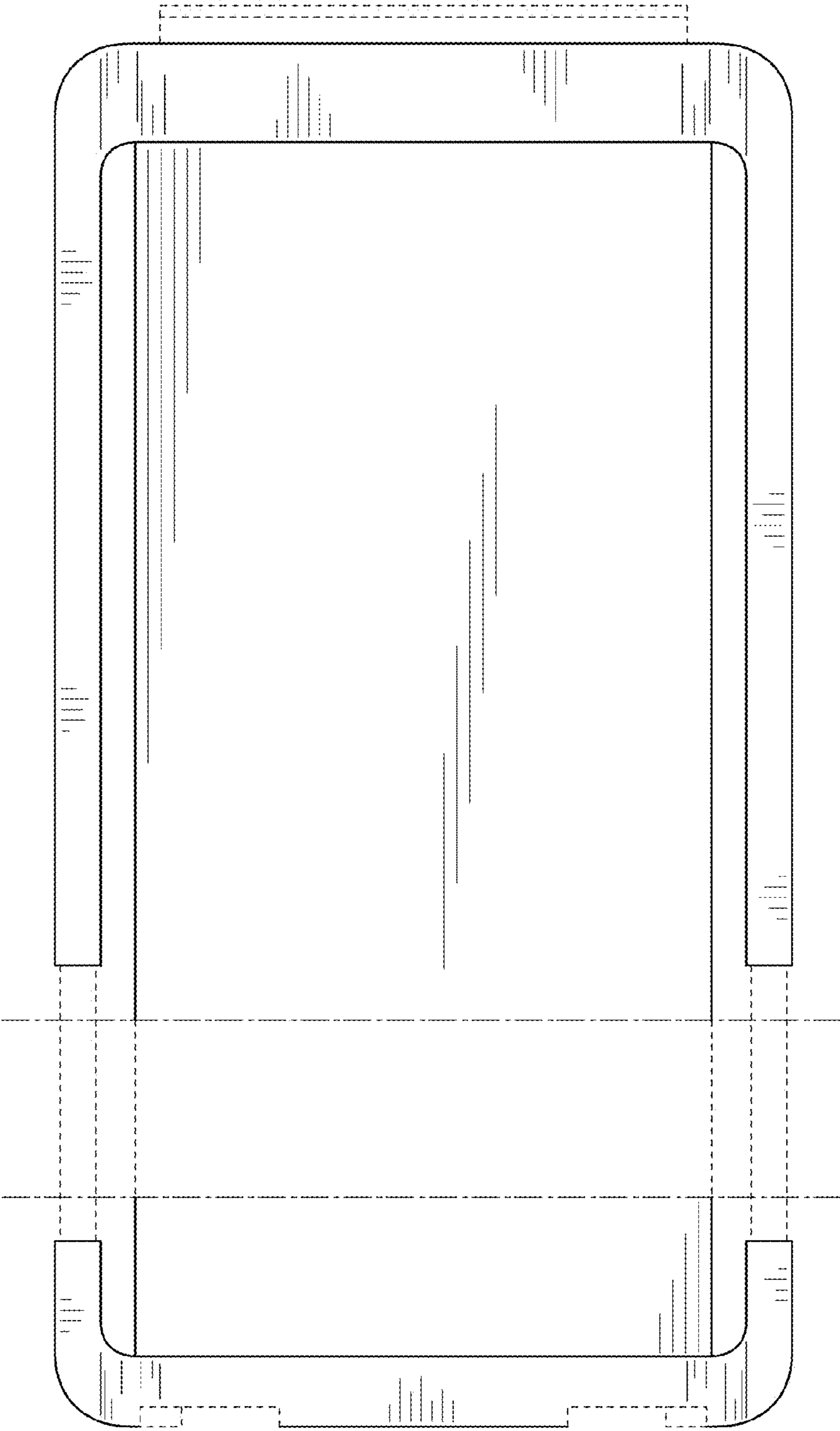

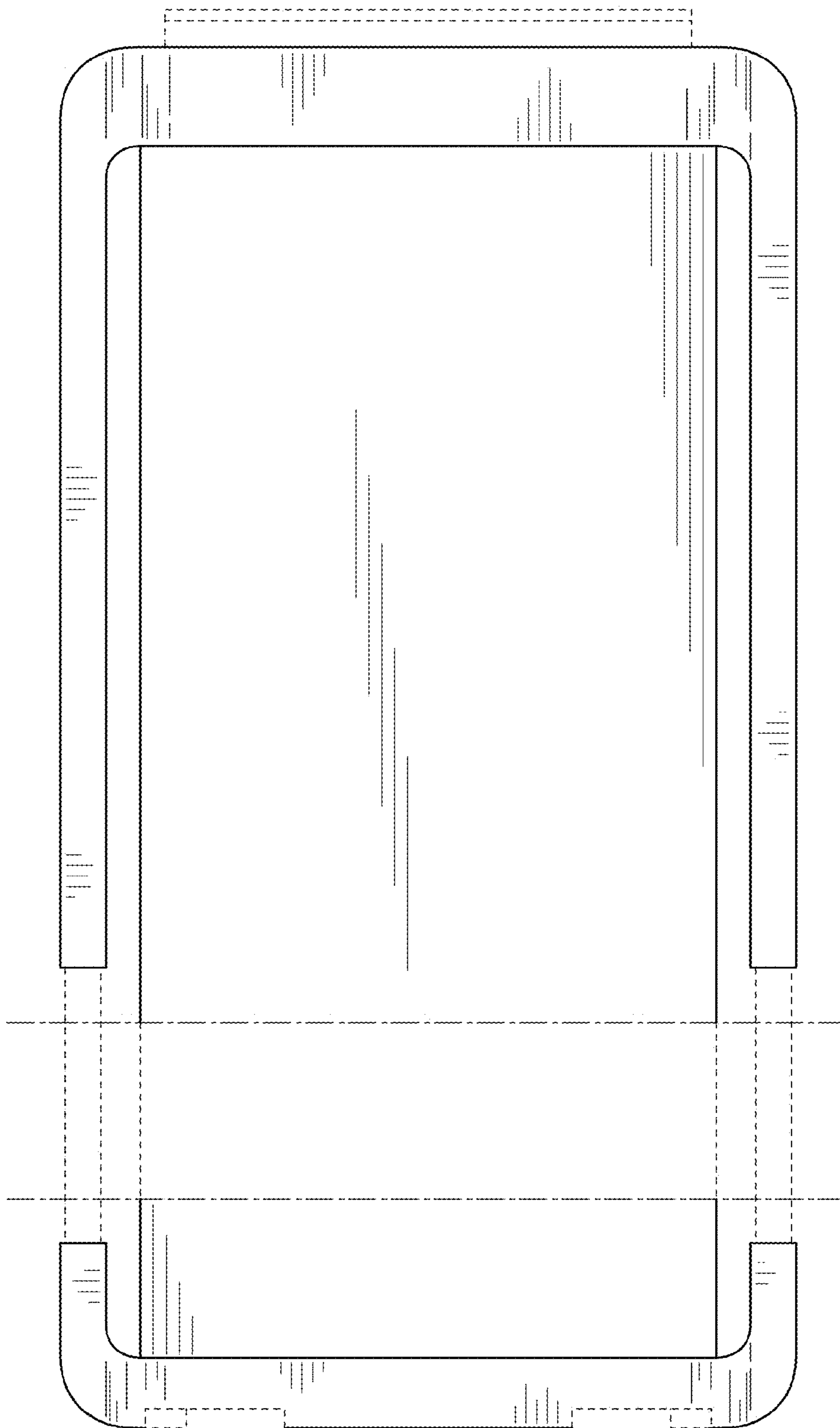

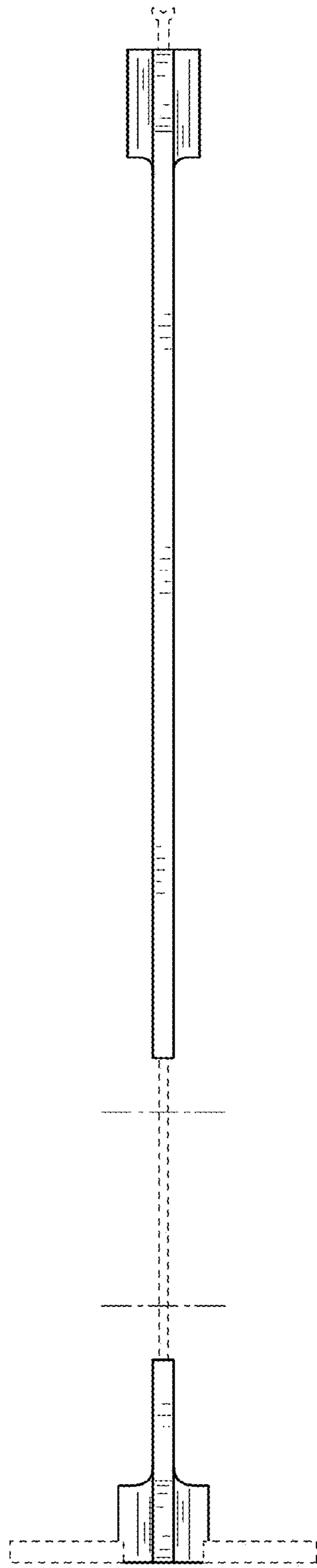

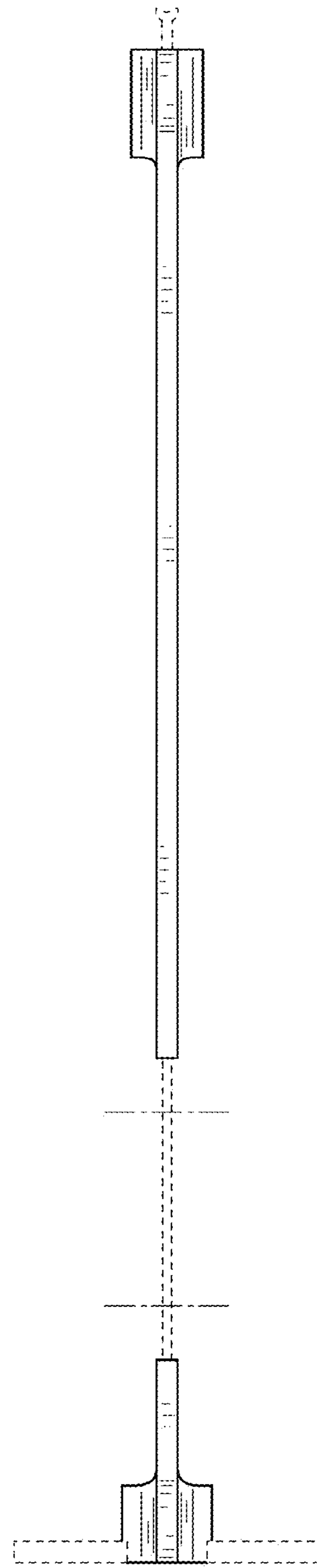

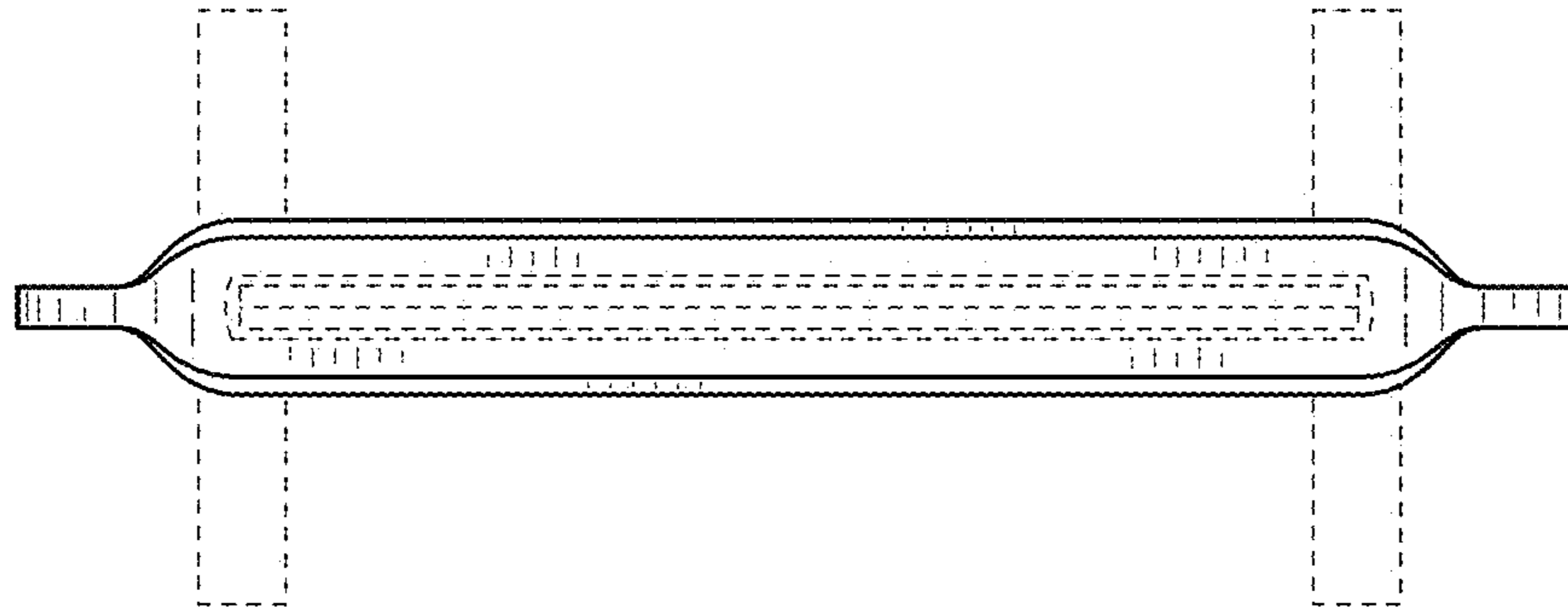

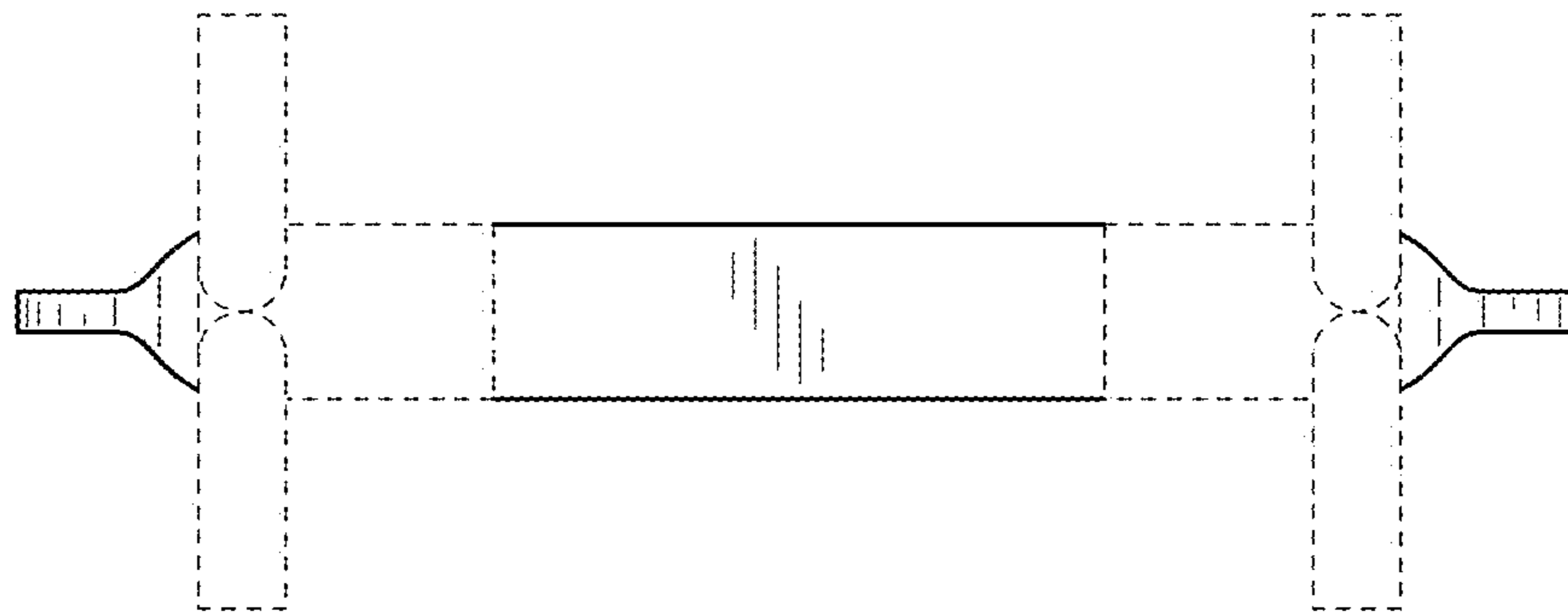
