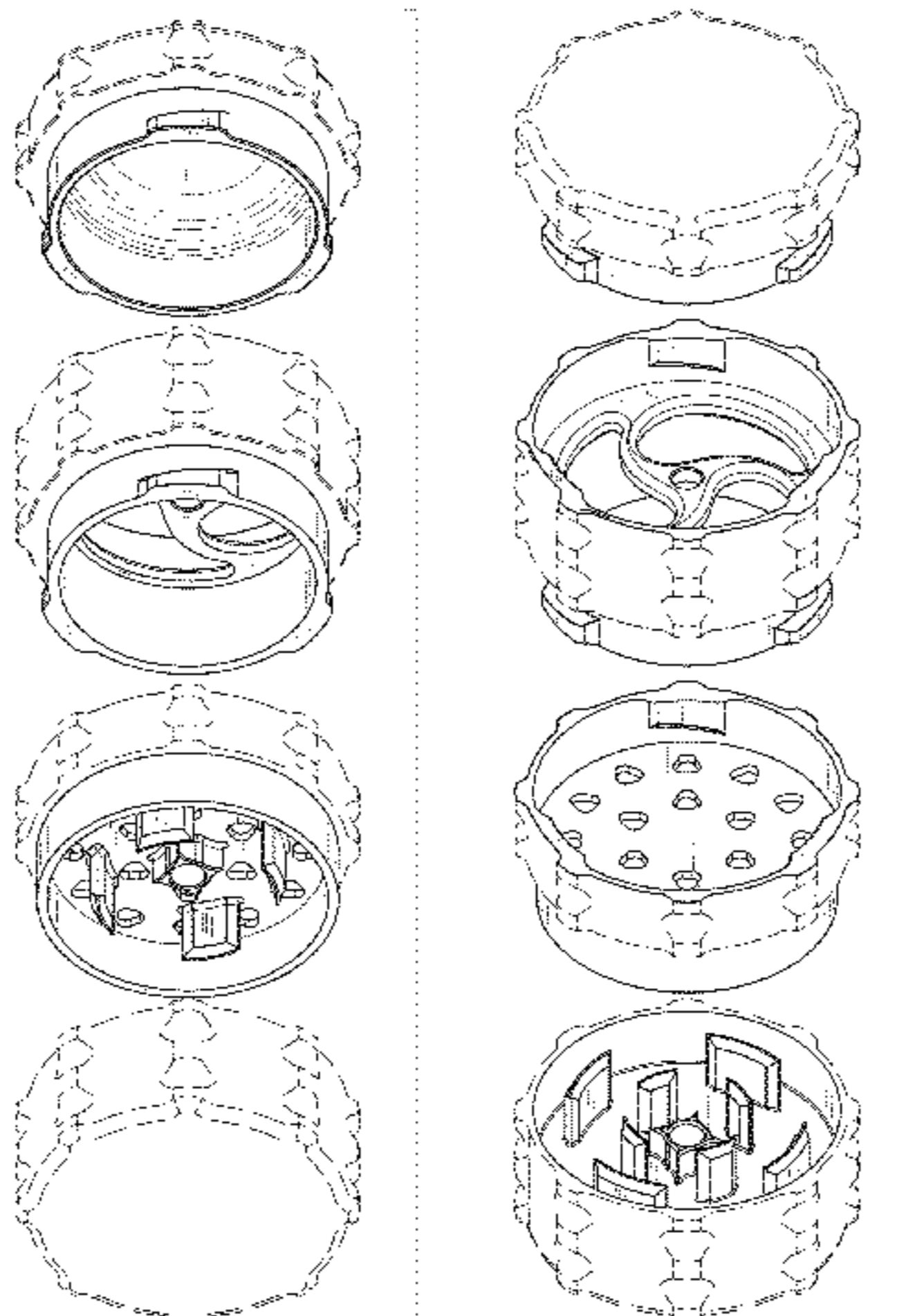
The ornamental design for the herb grinding device, as shown and described.

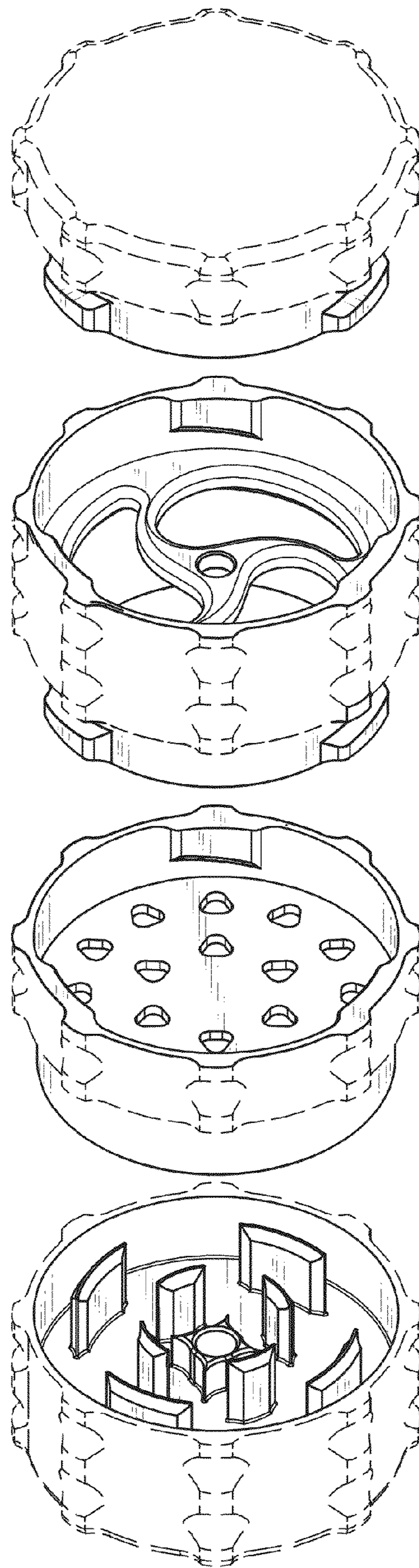
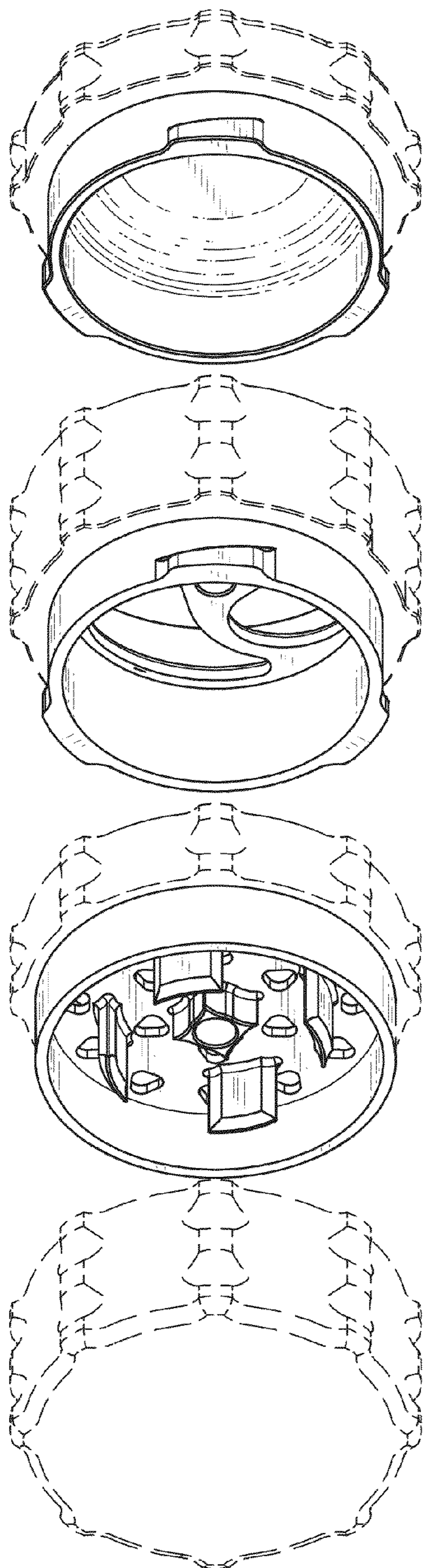

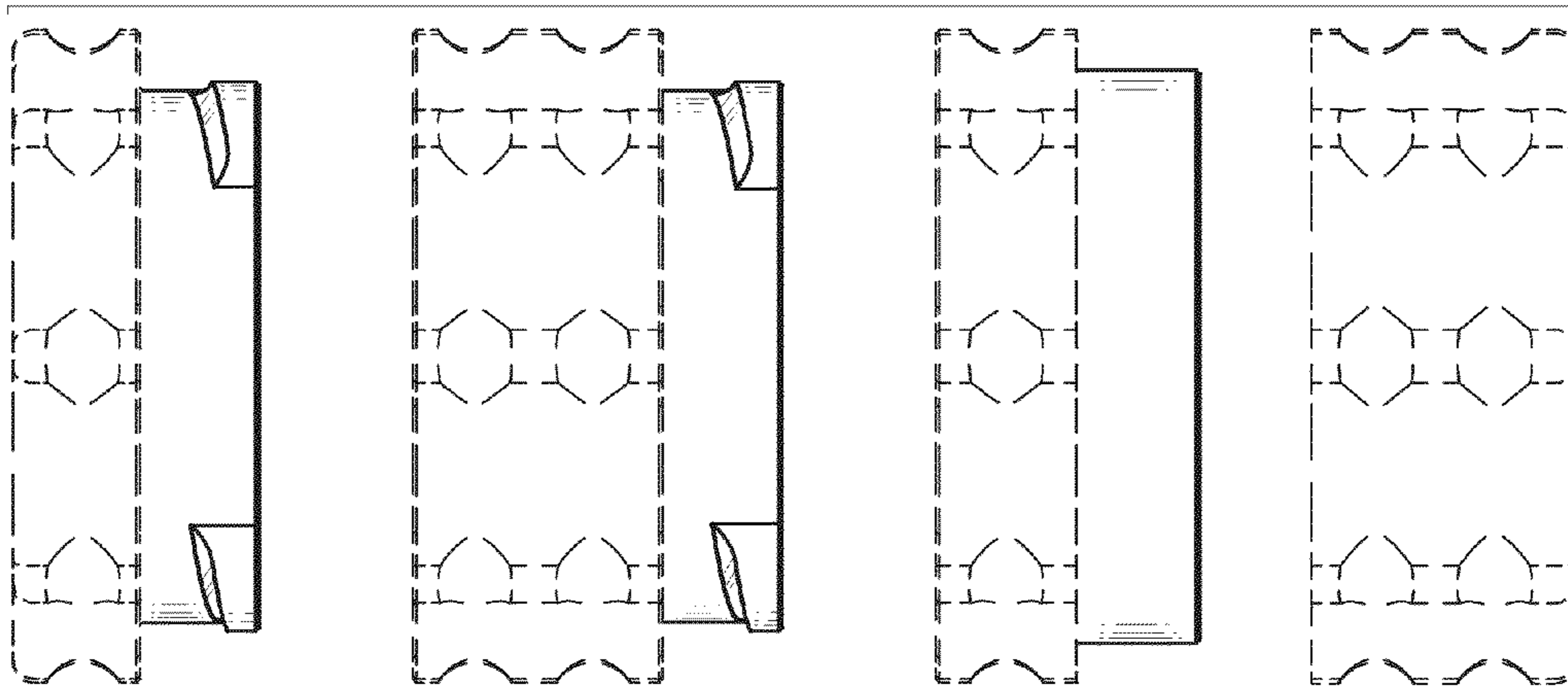

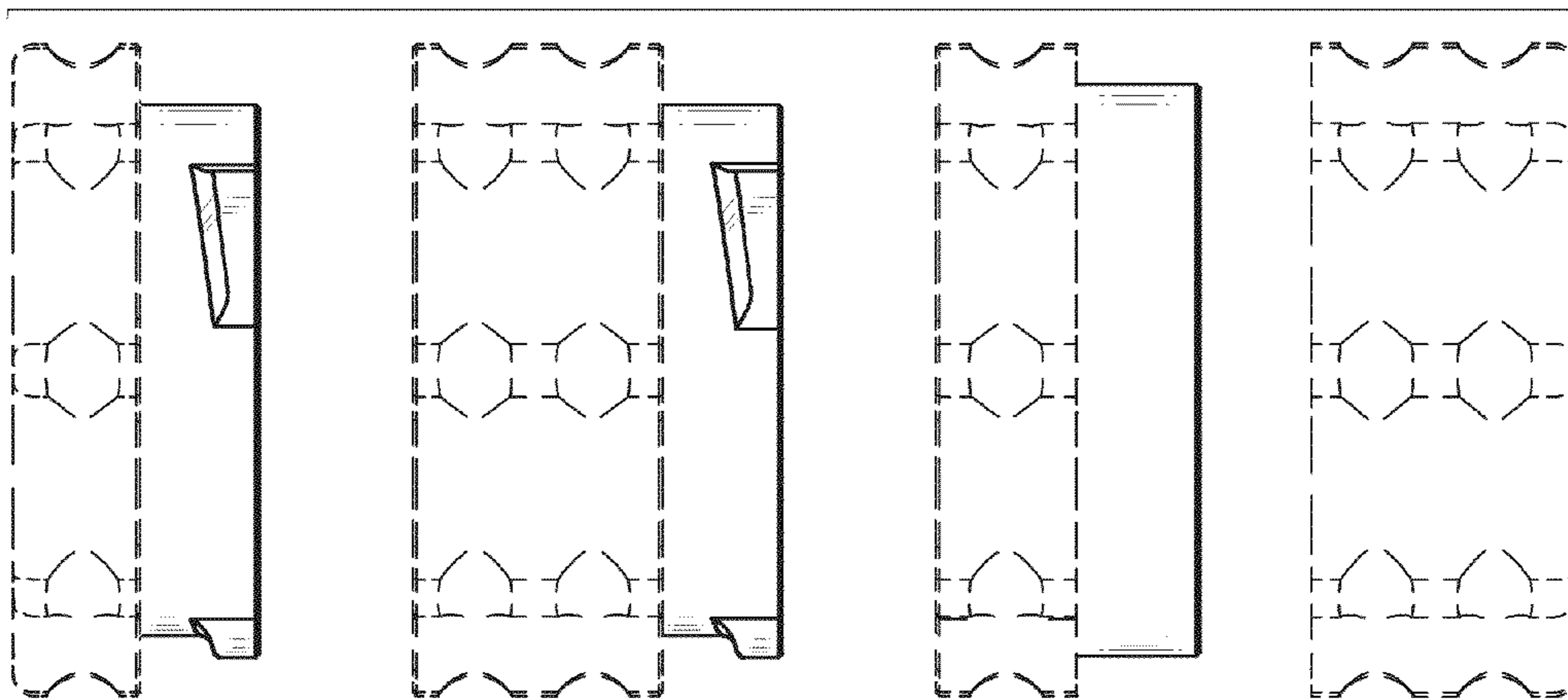

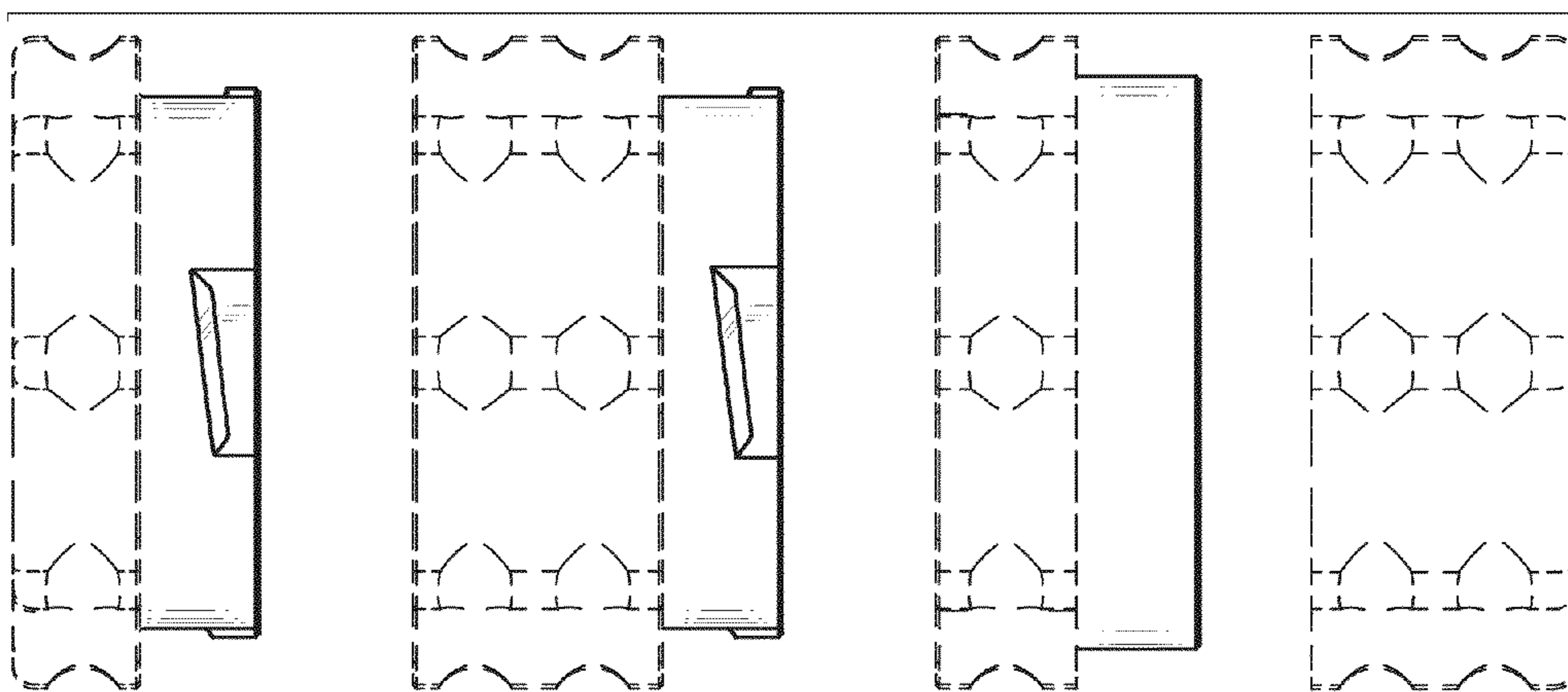

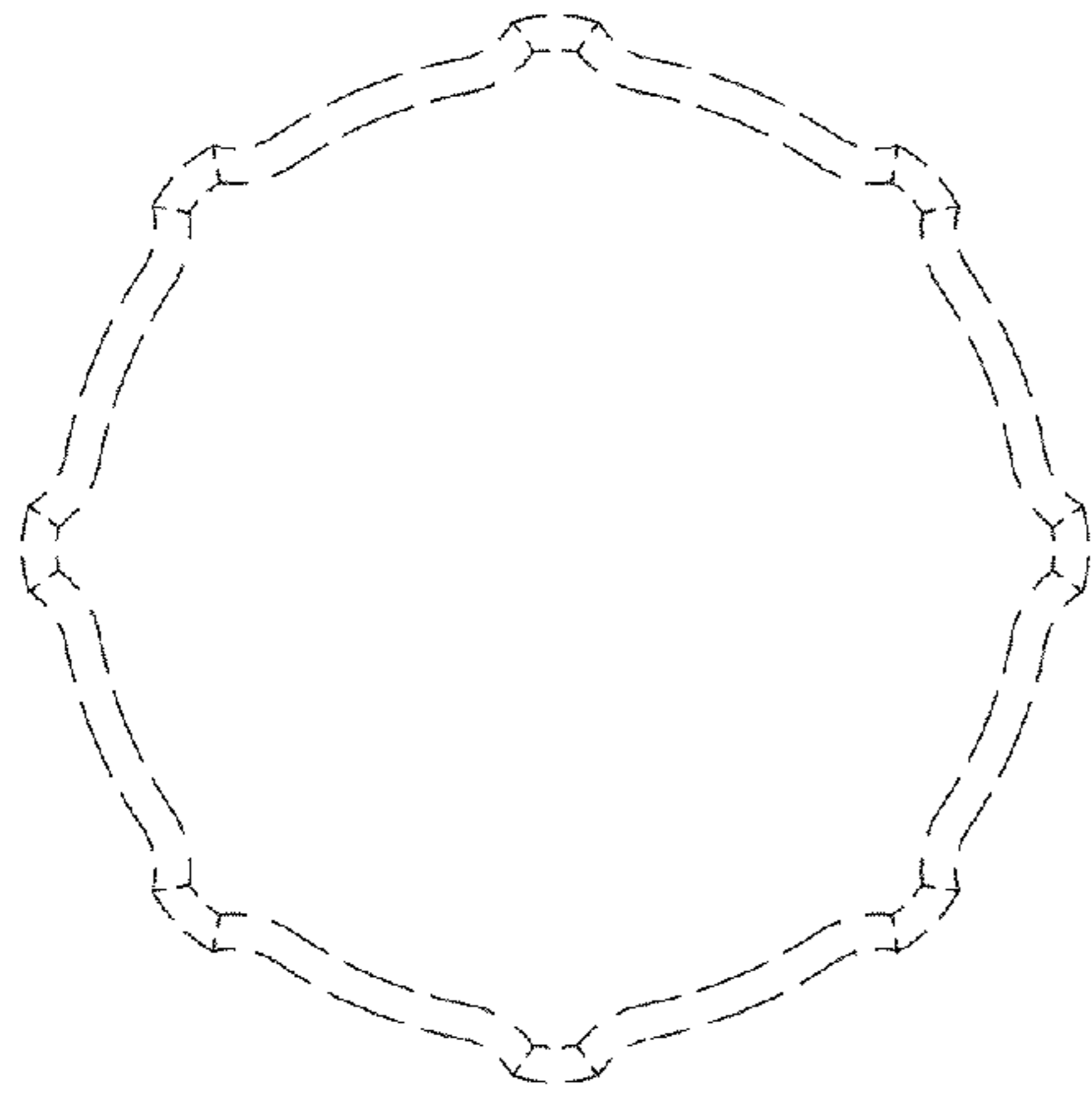

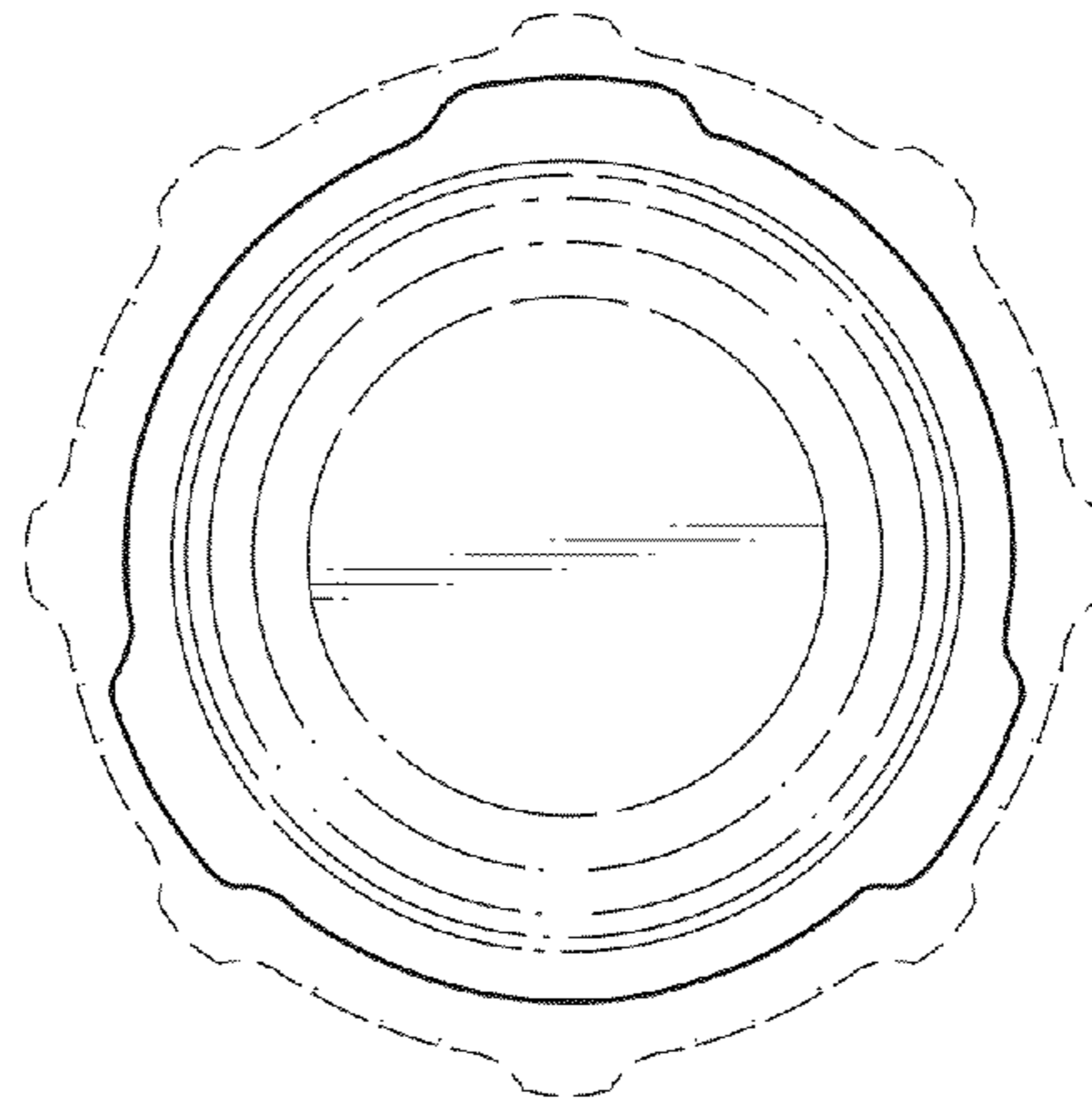

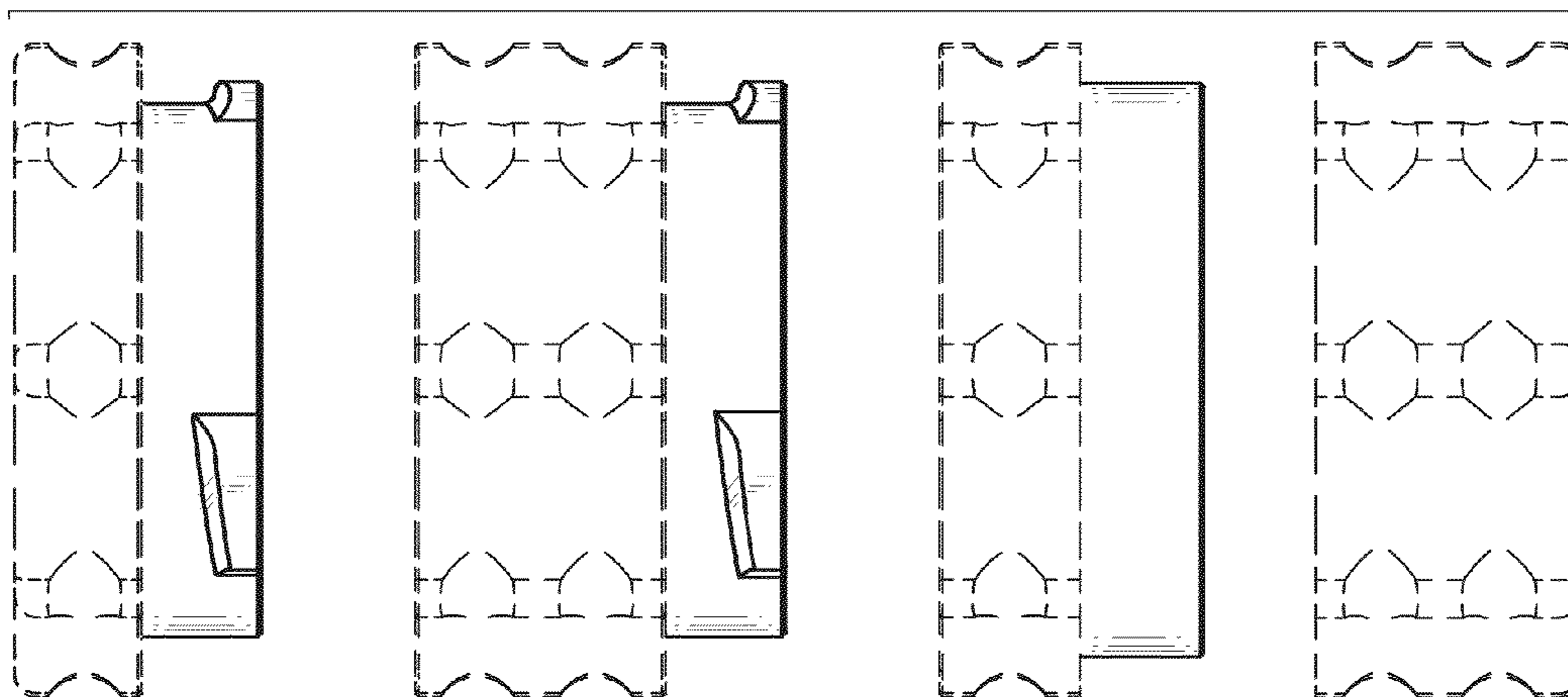

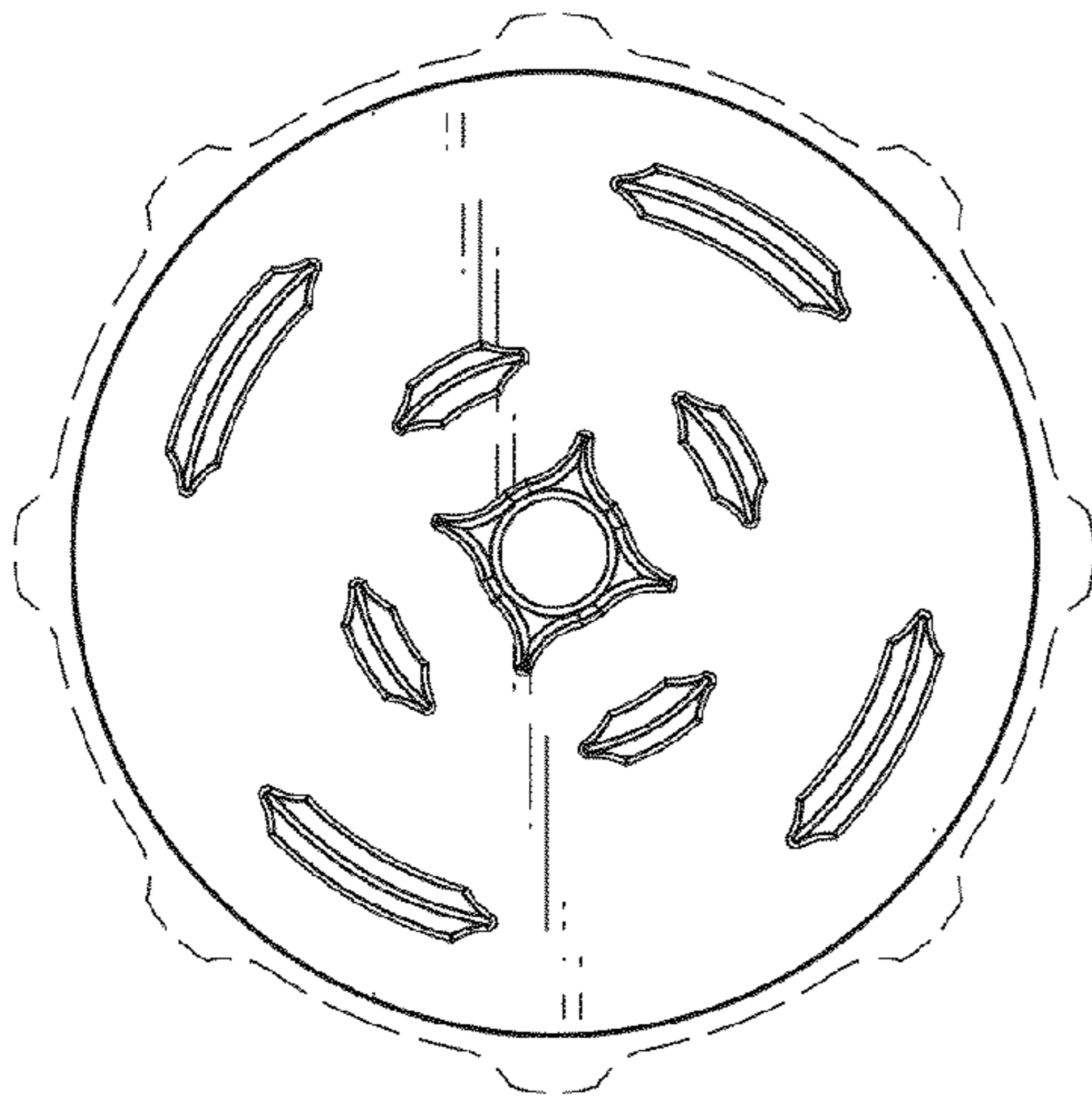

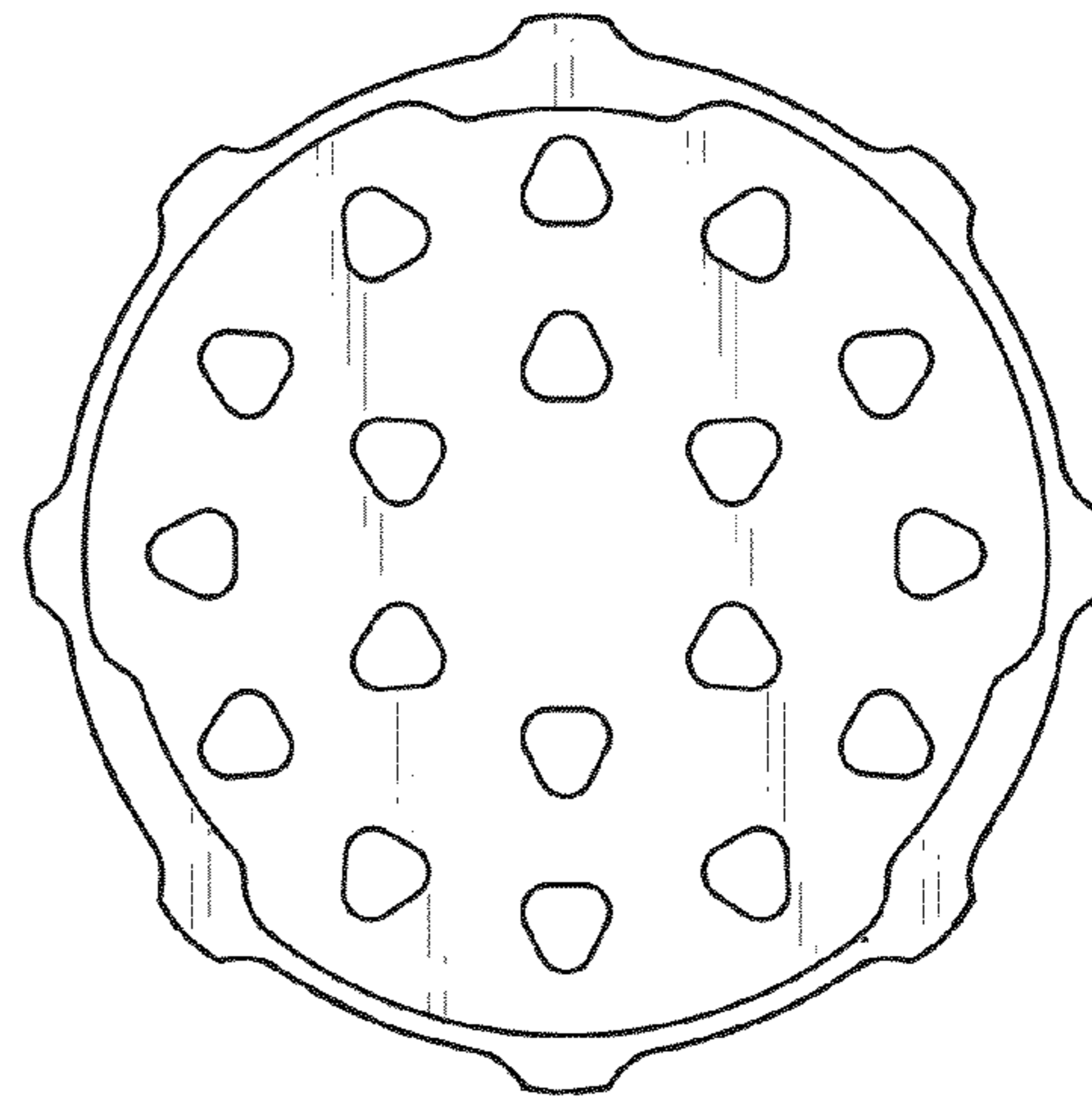

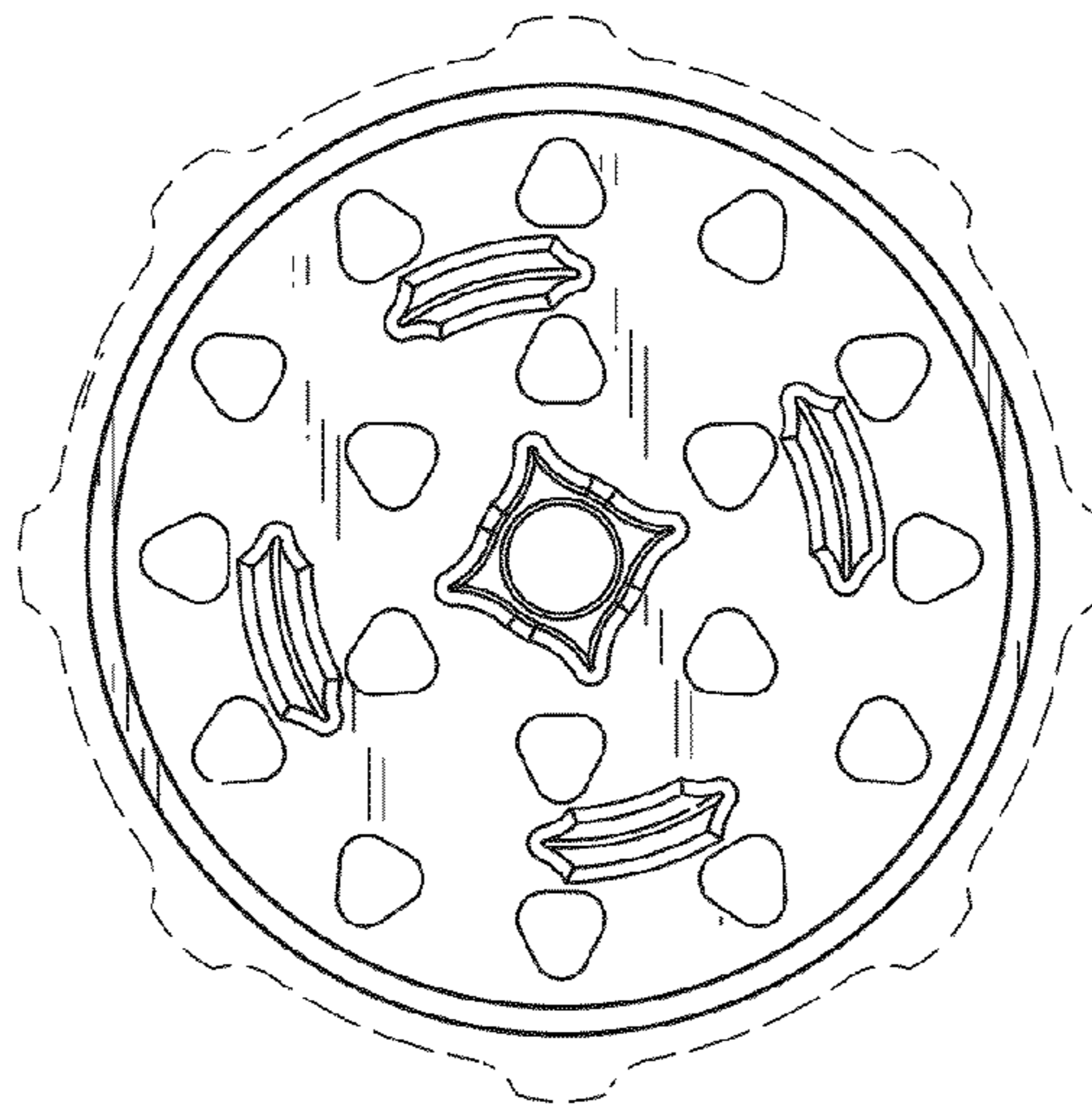

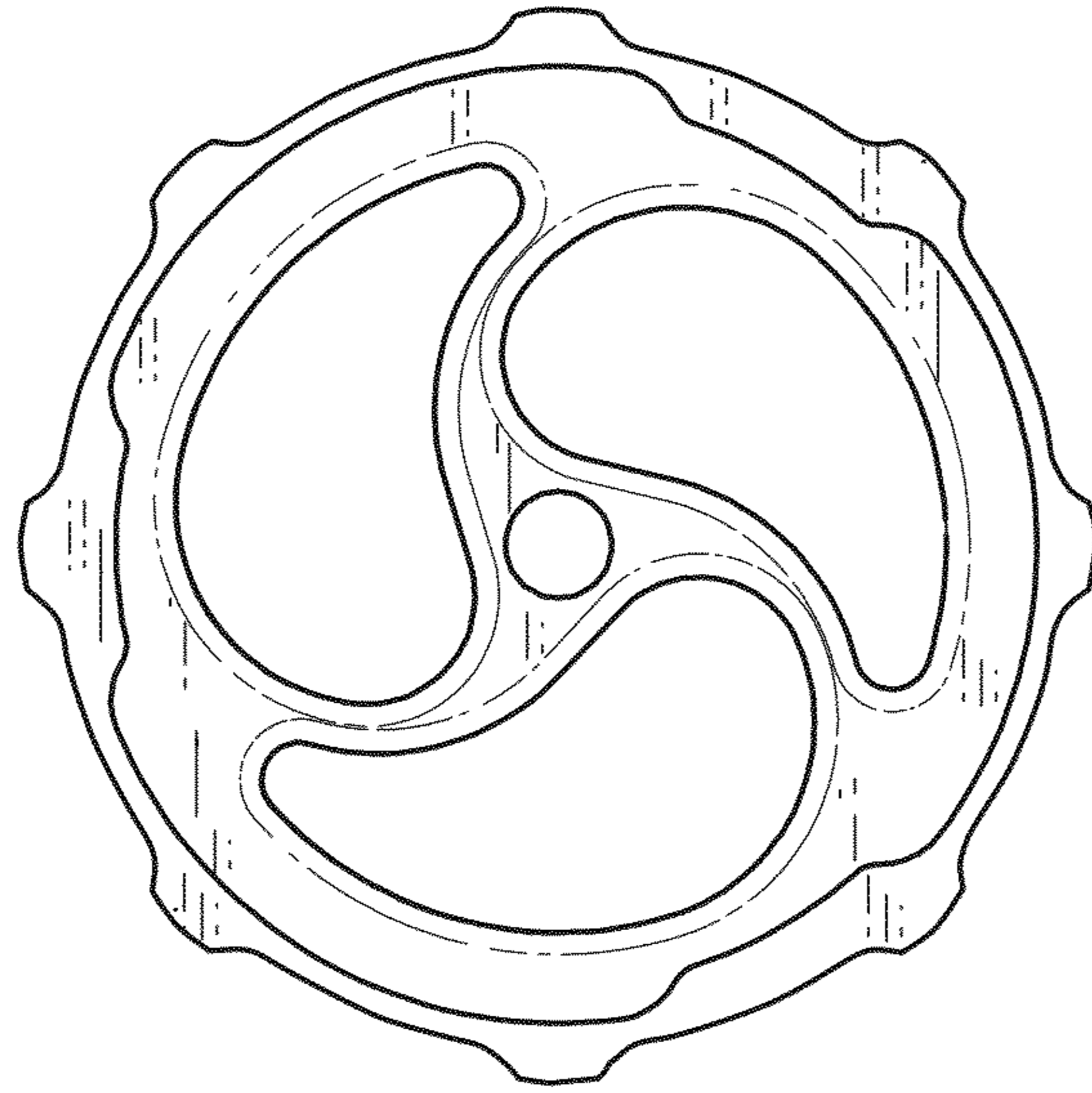

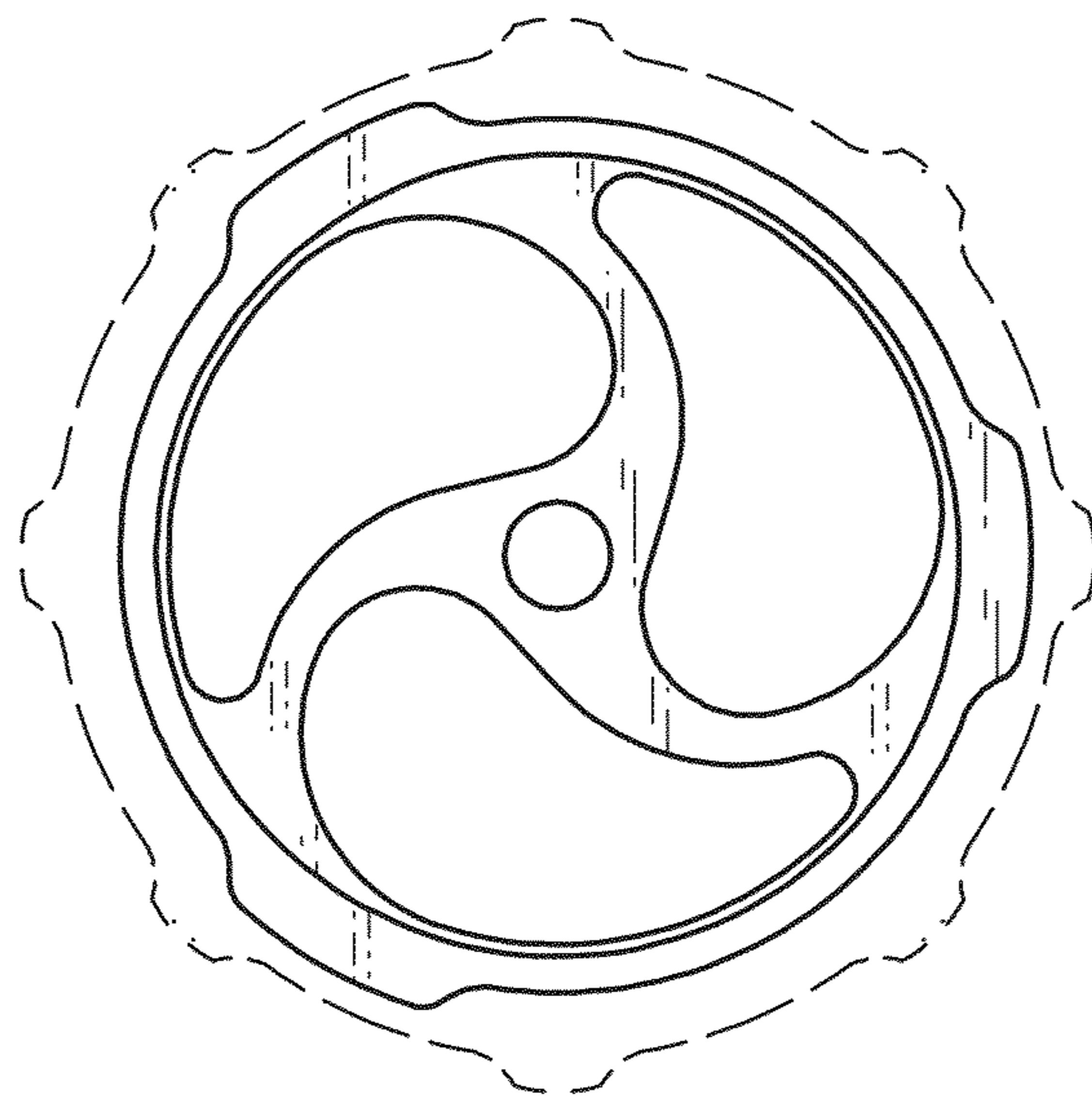

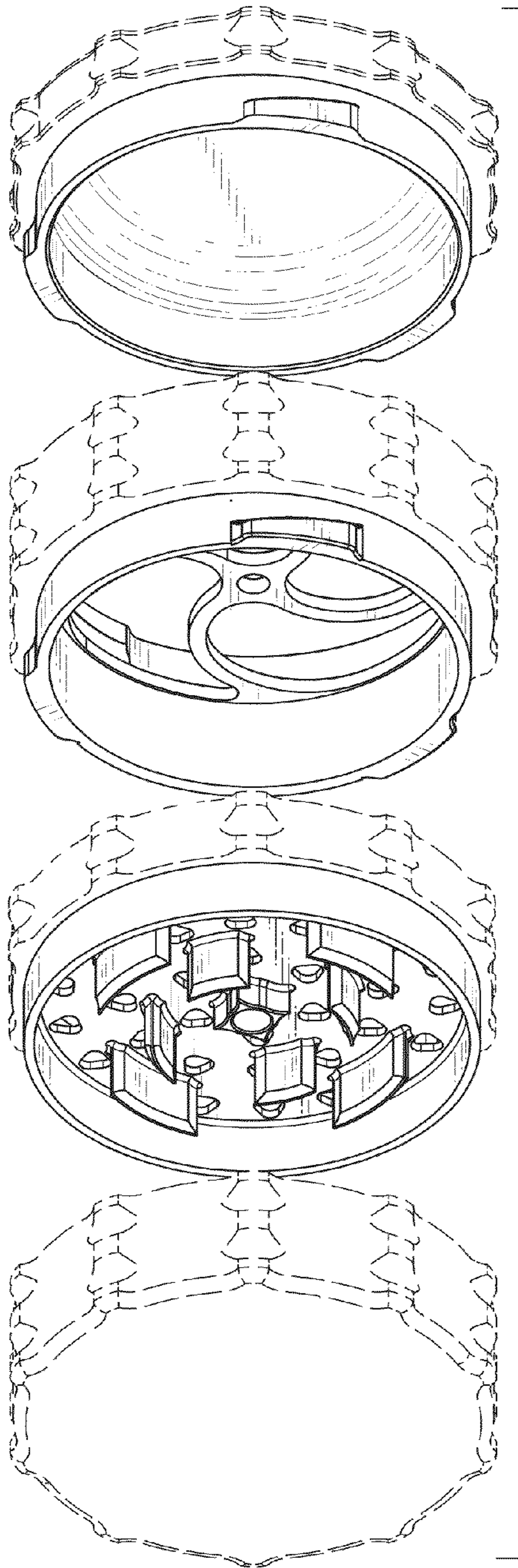

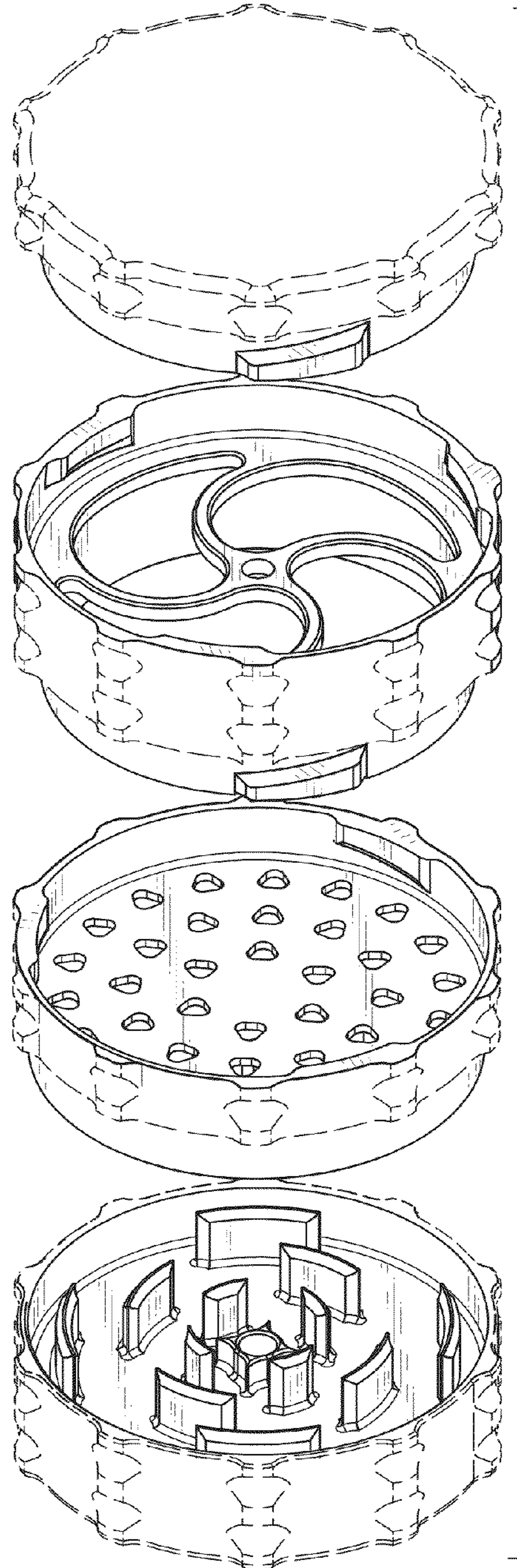

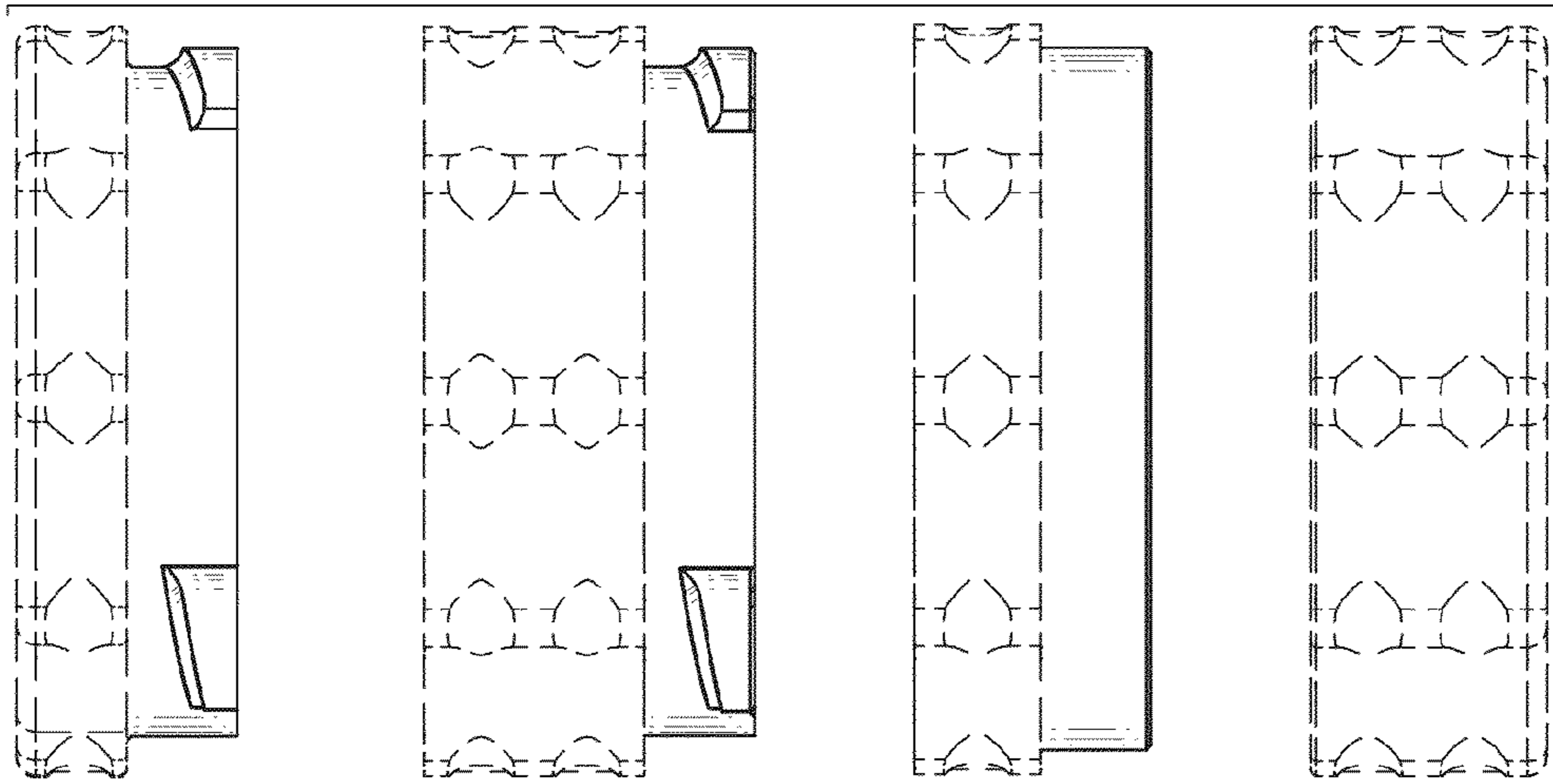

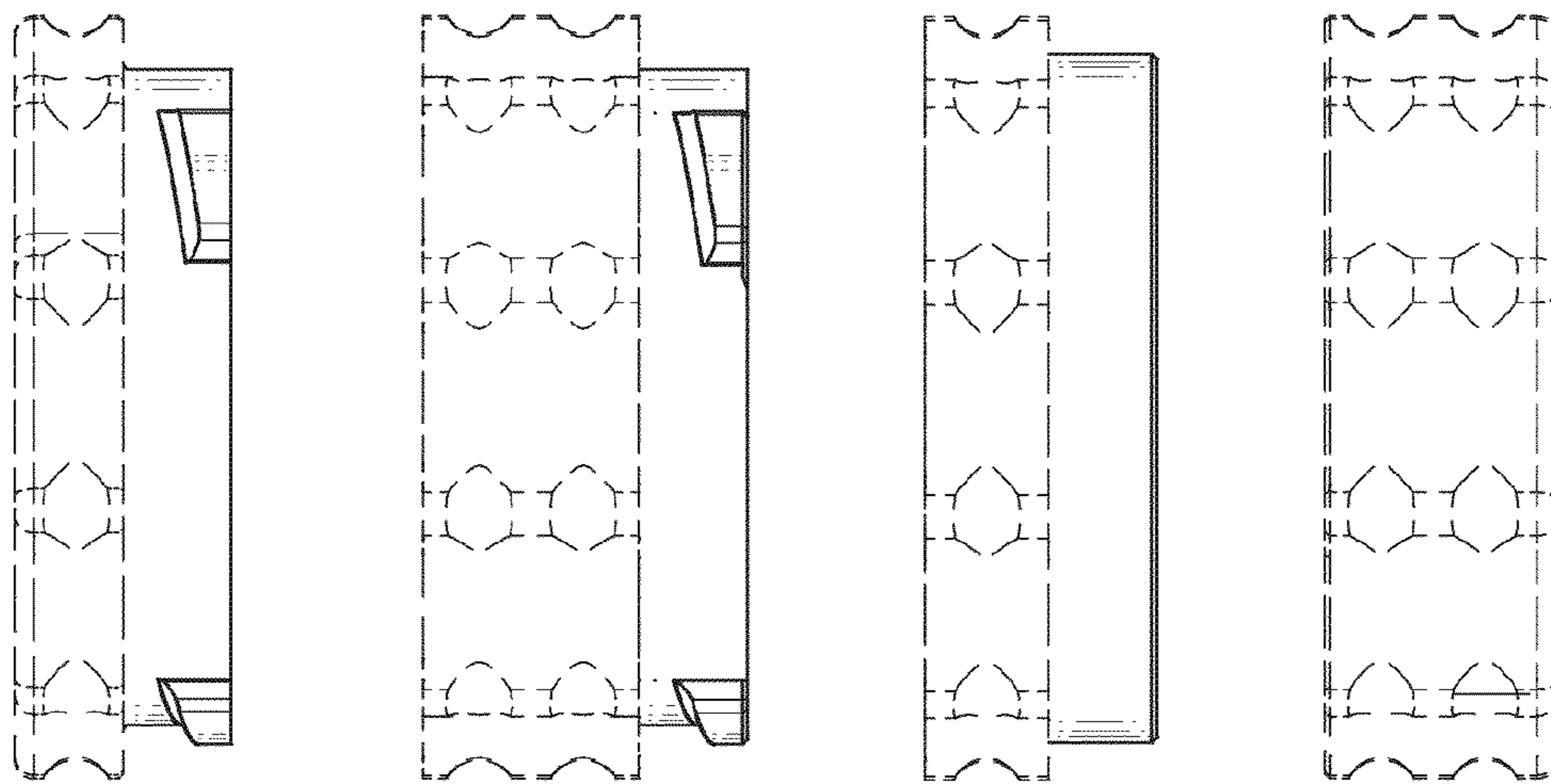

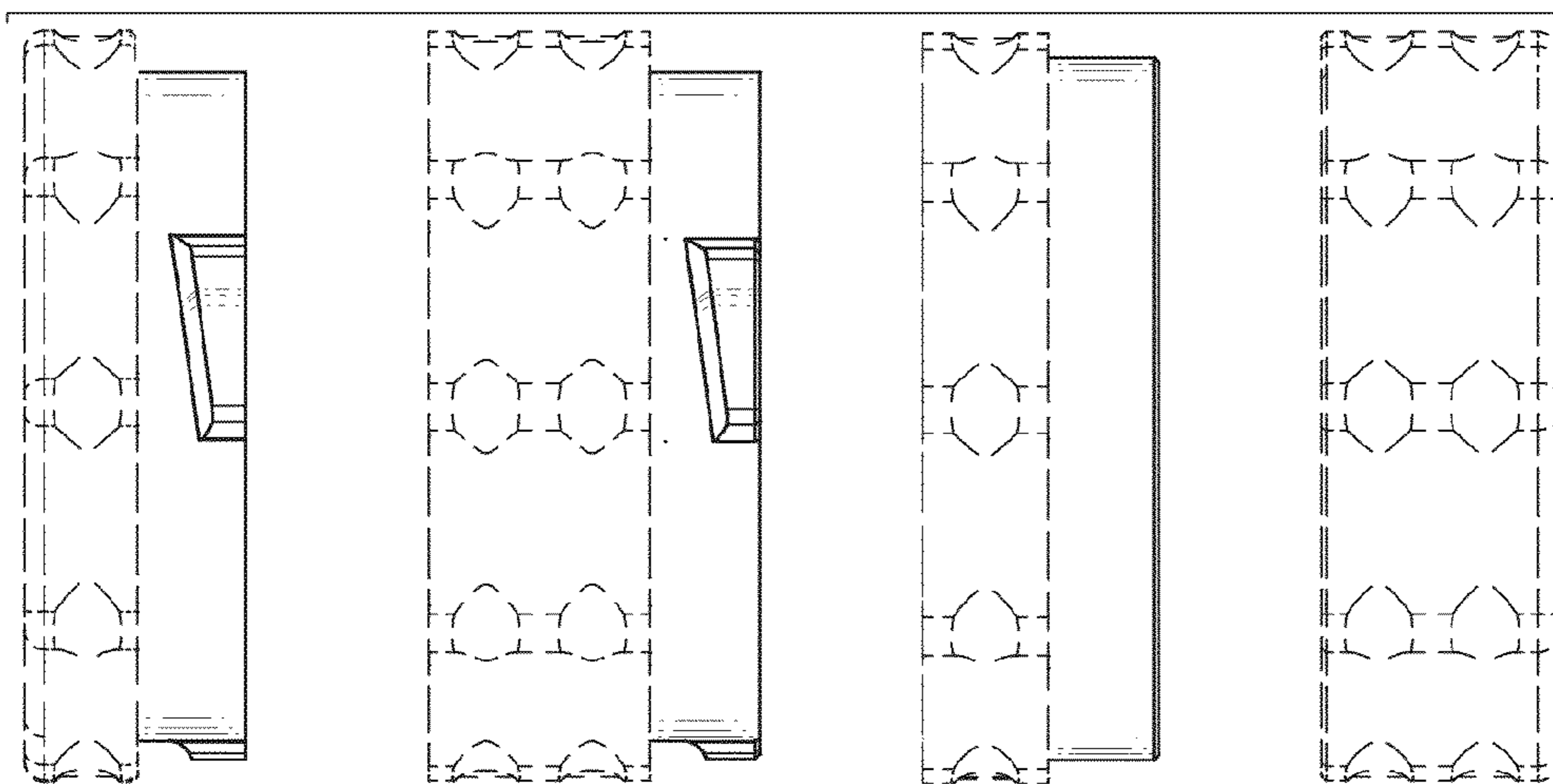

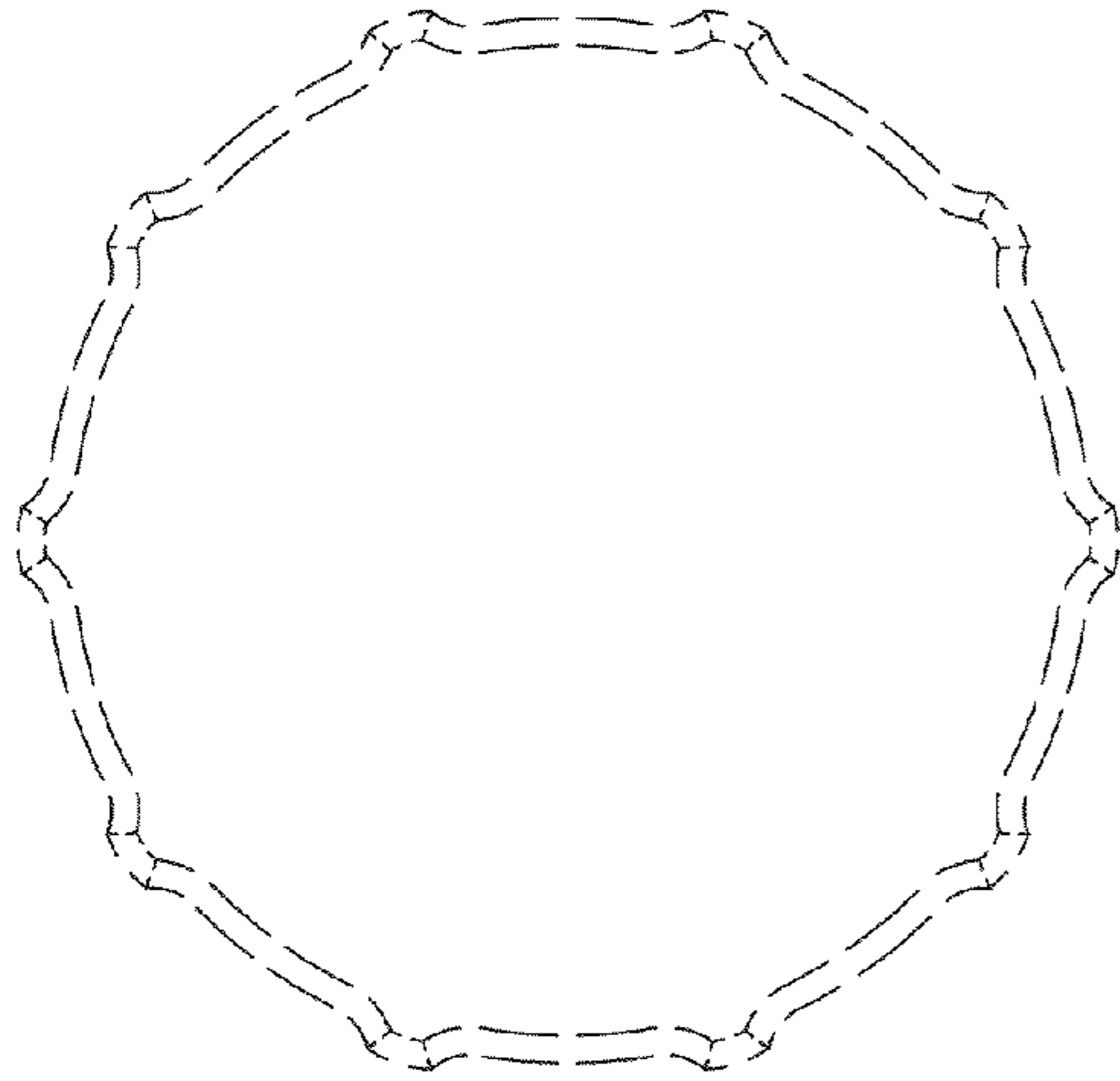

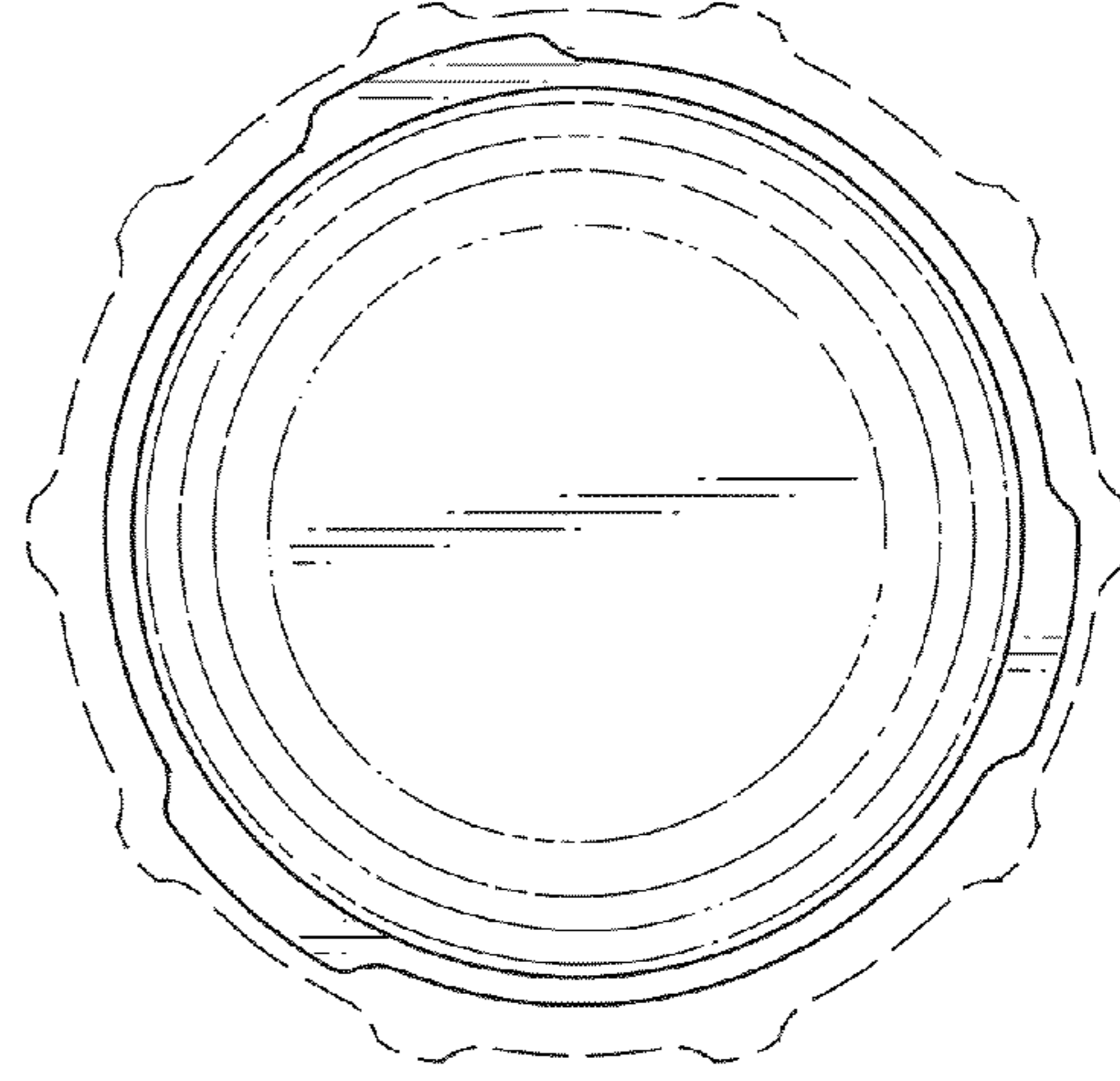

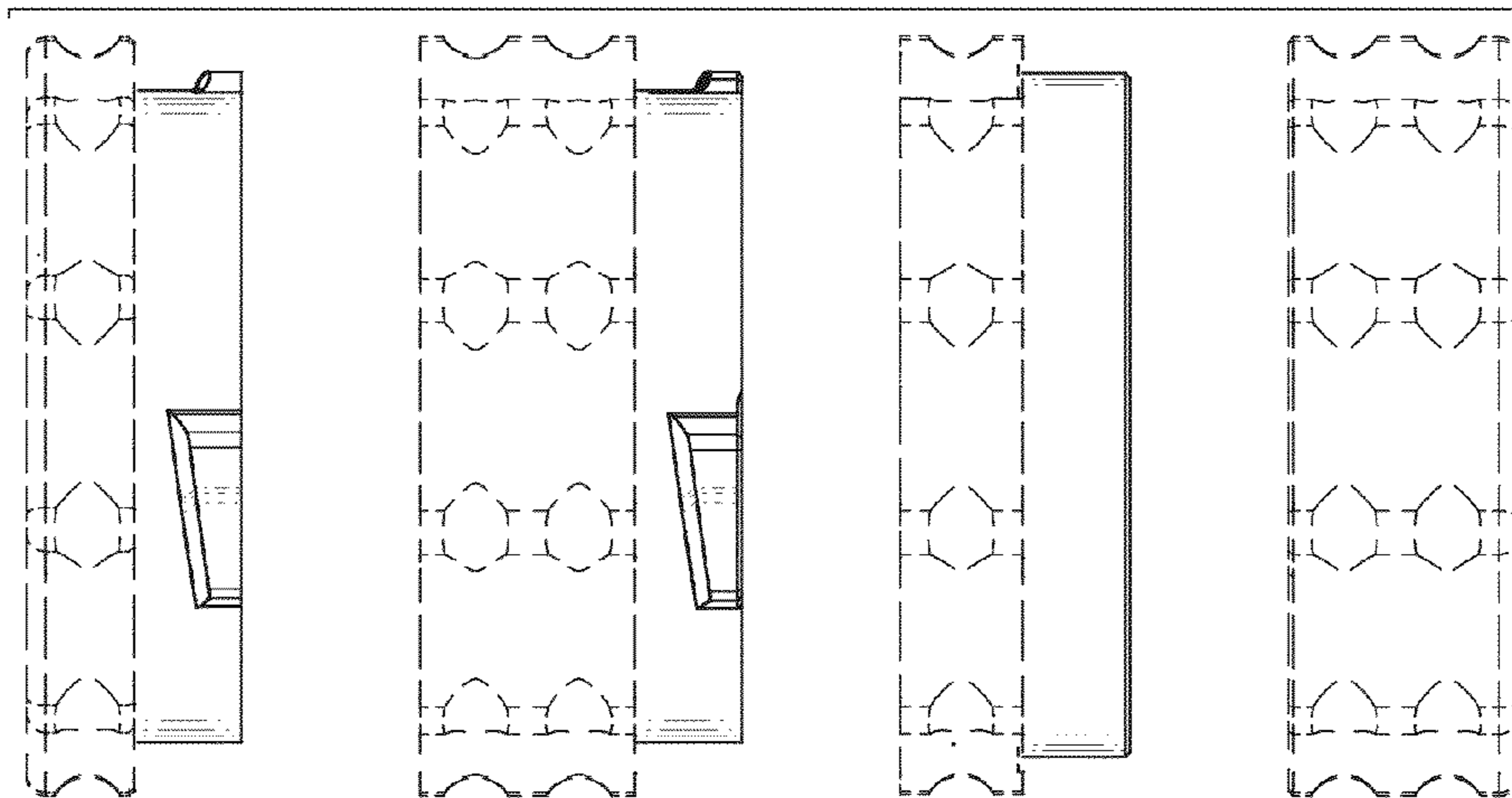

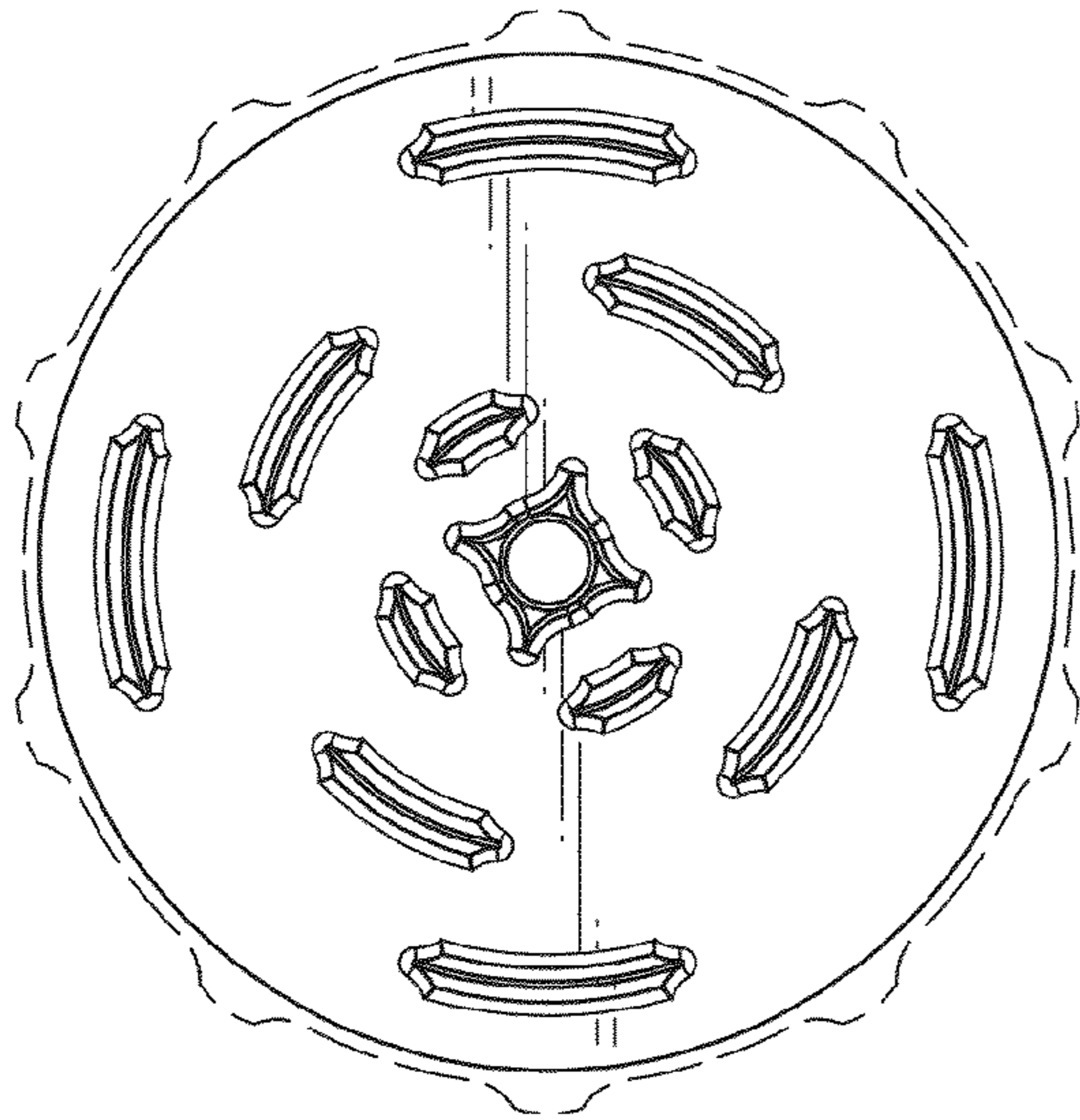

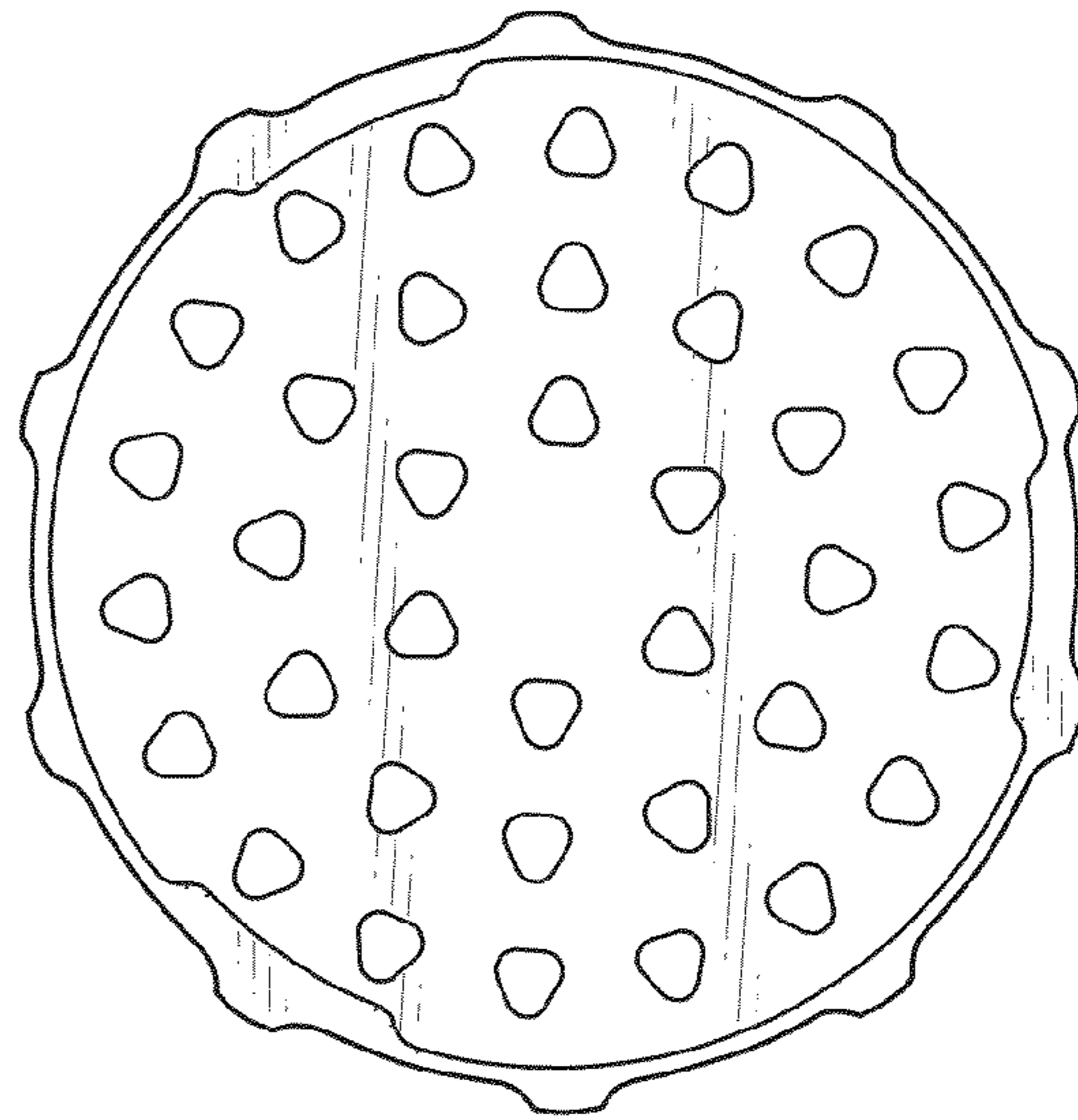

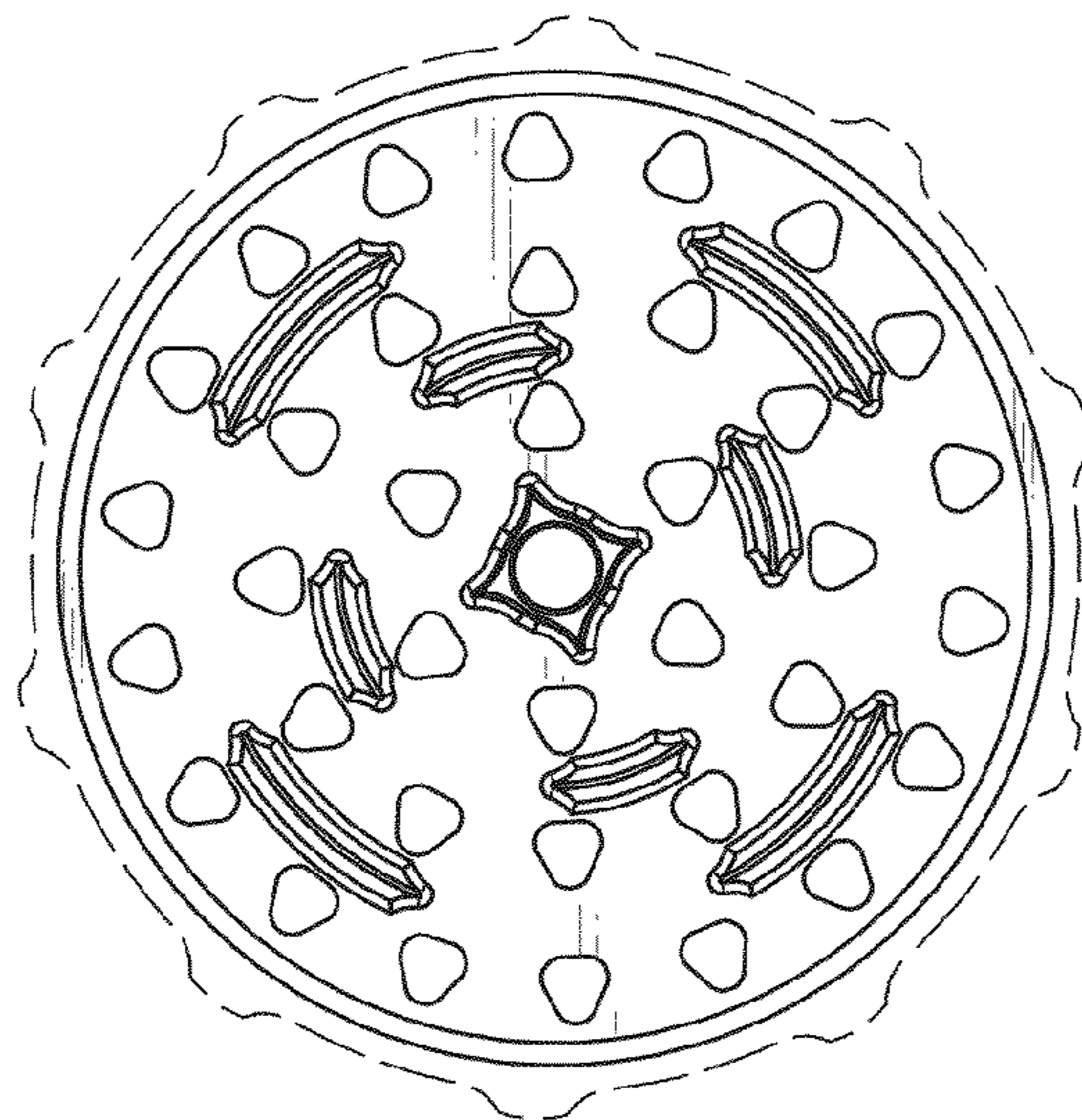

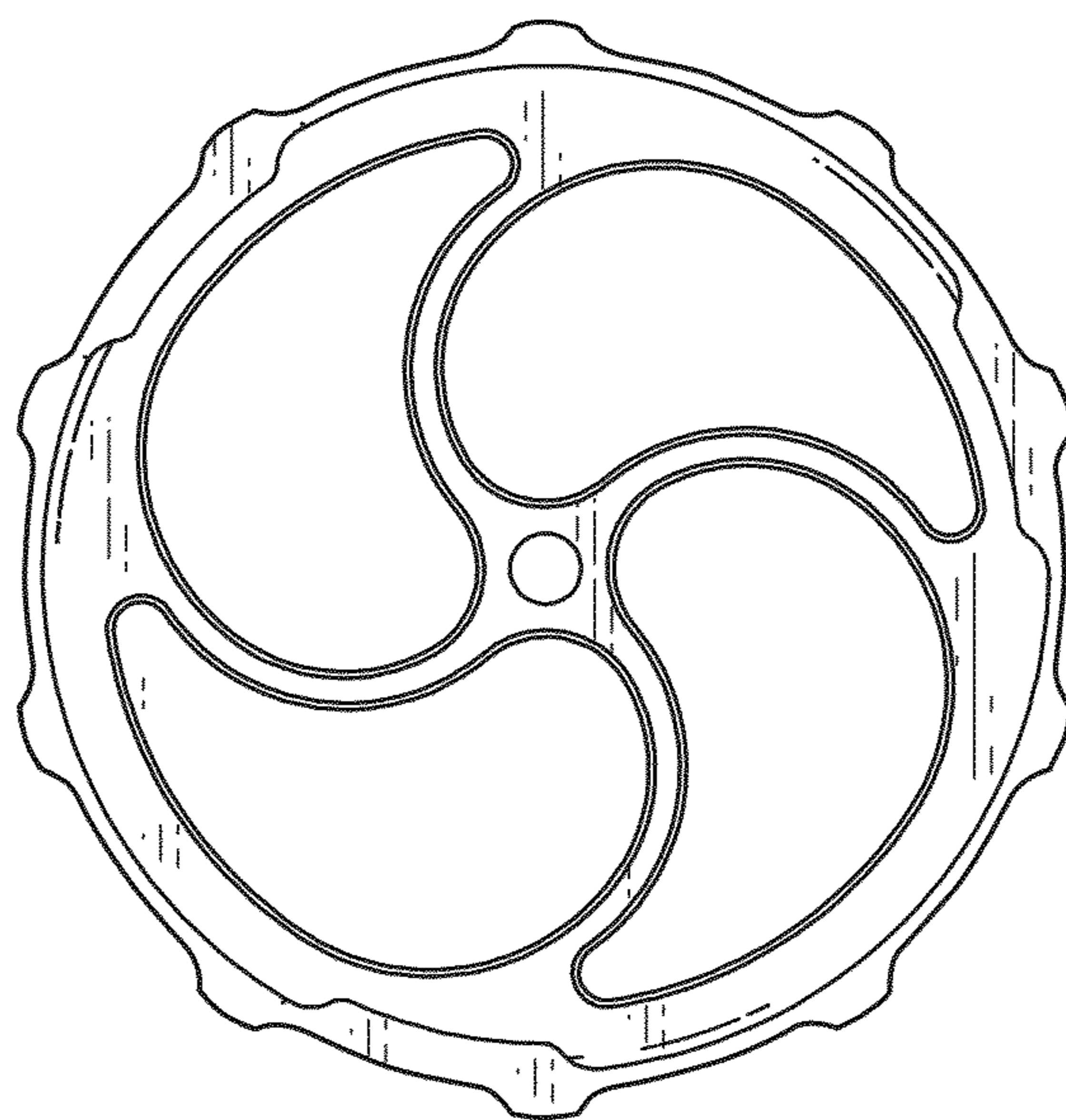

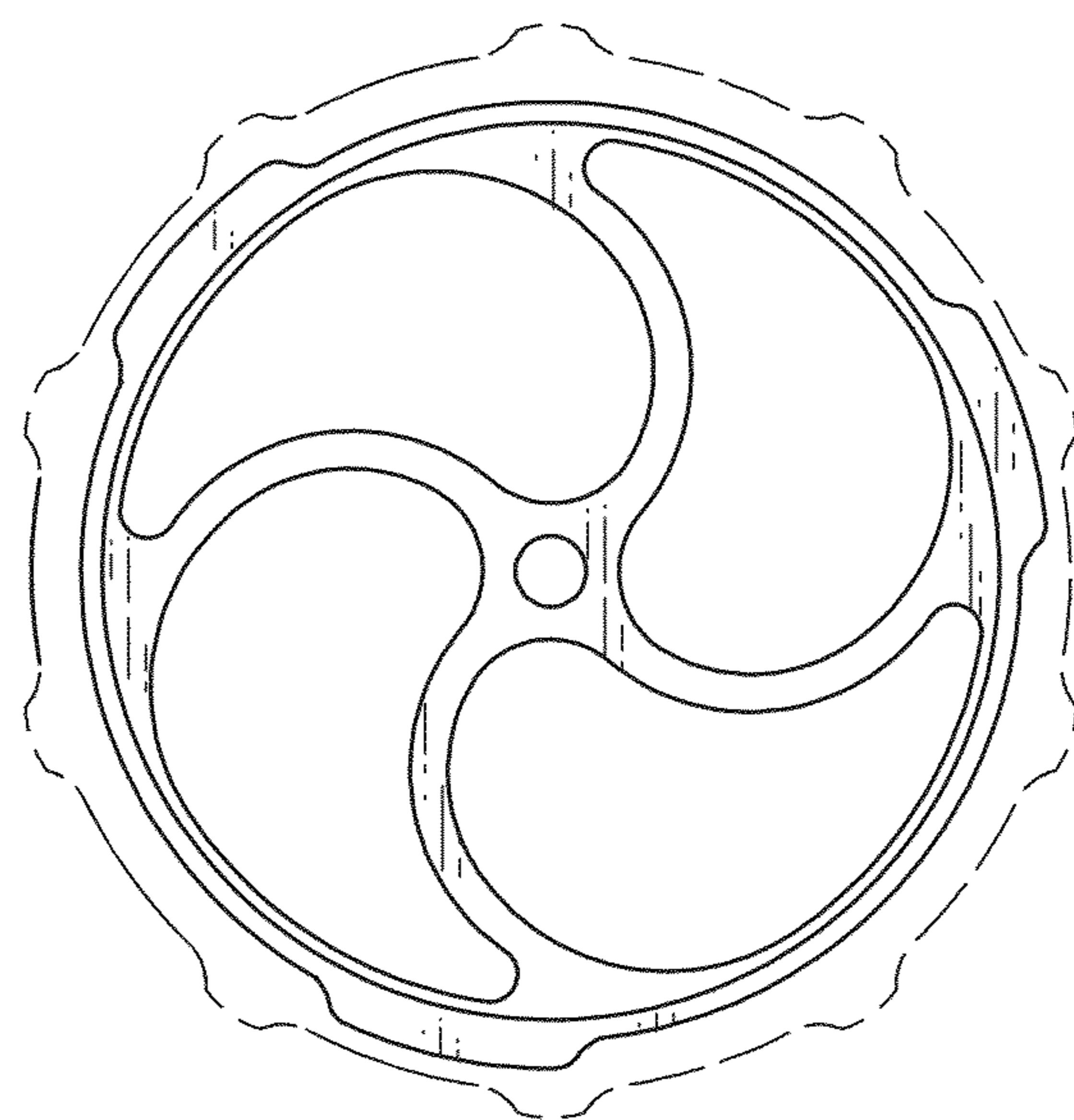

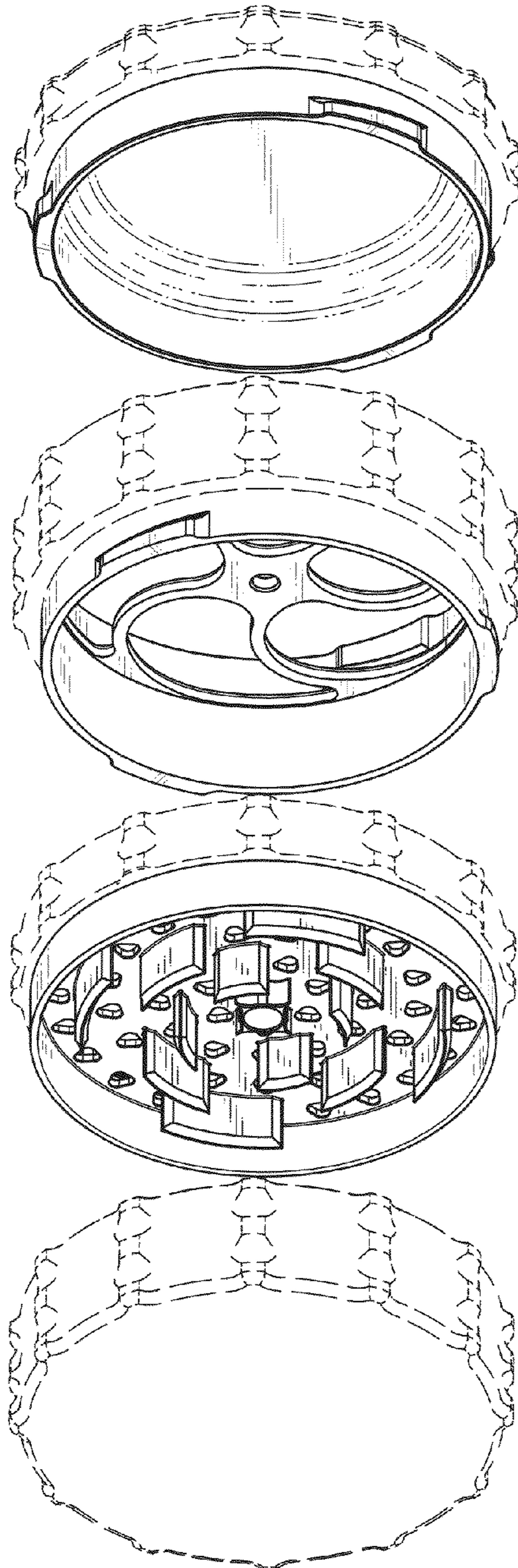

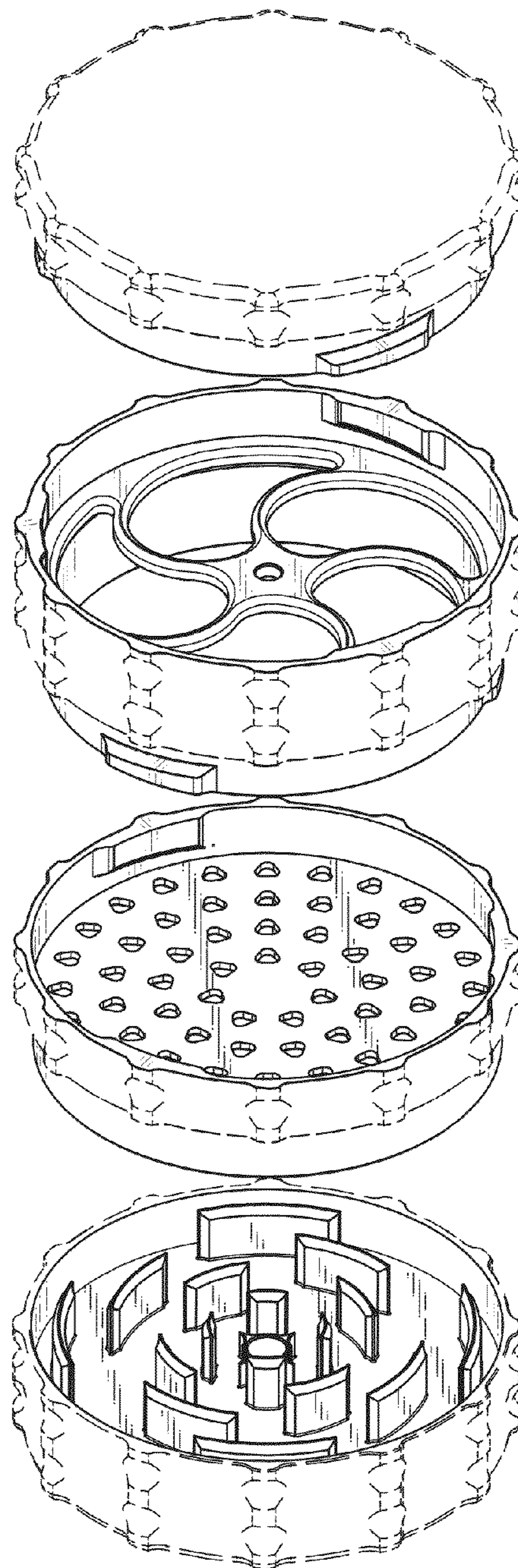

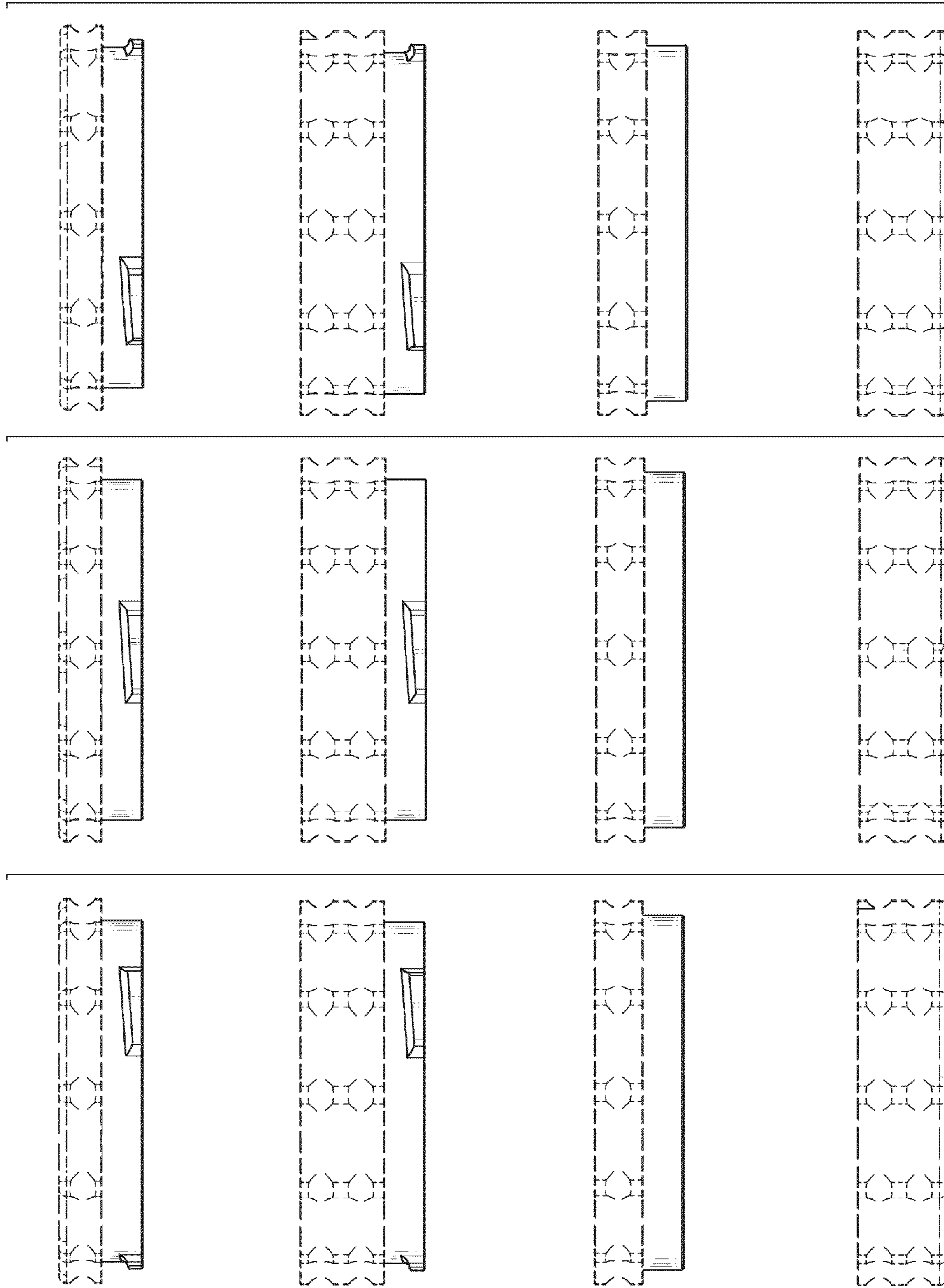

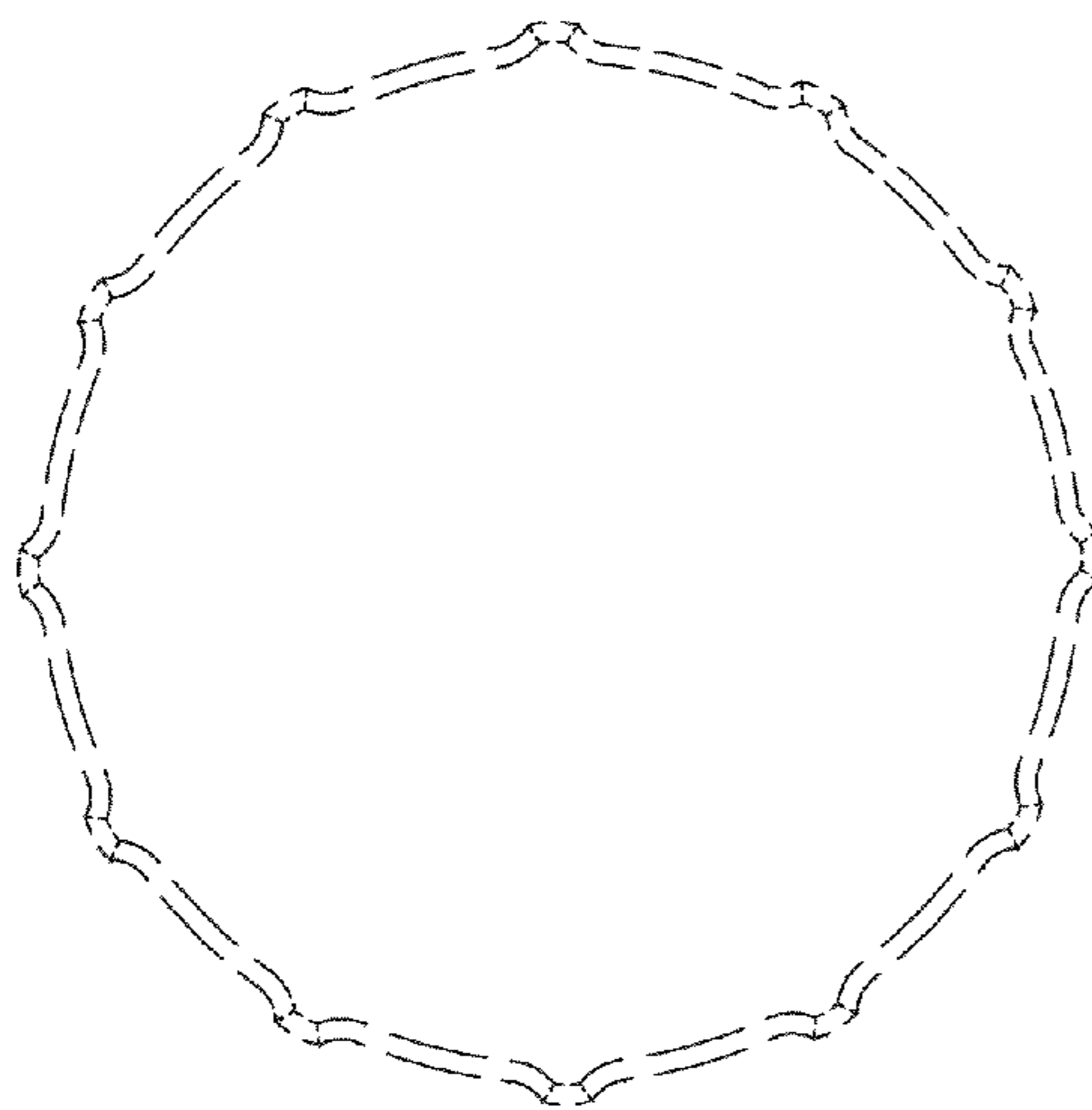

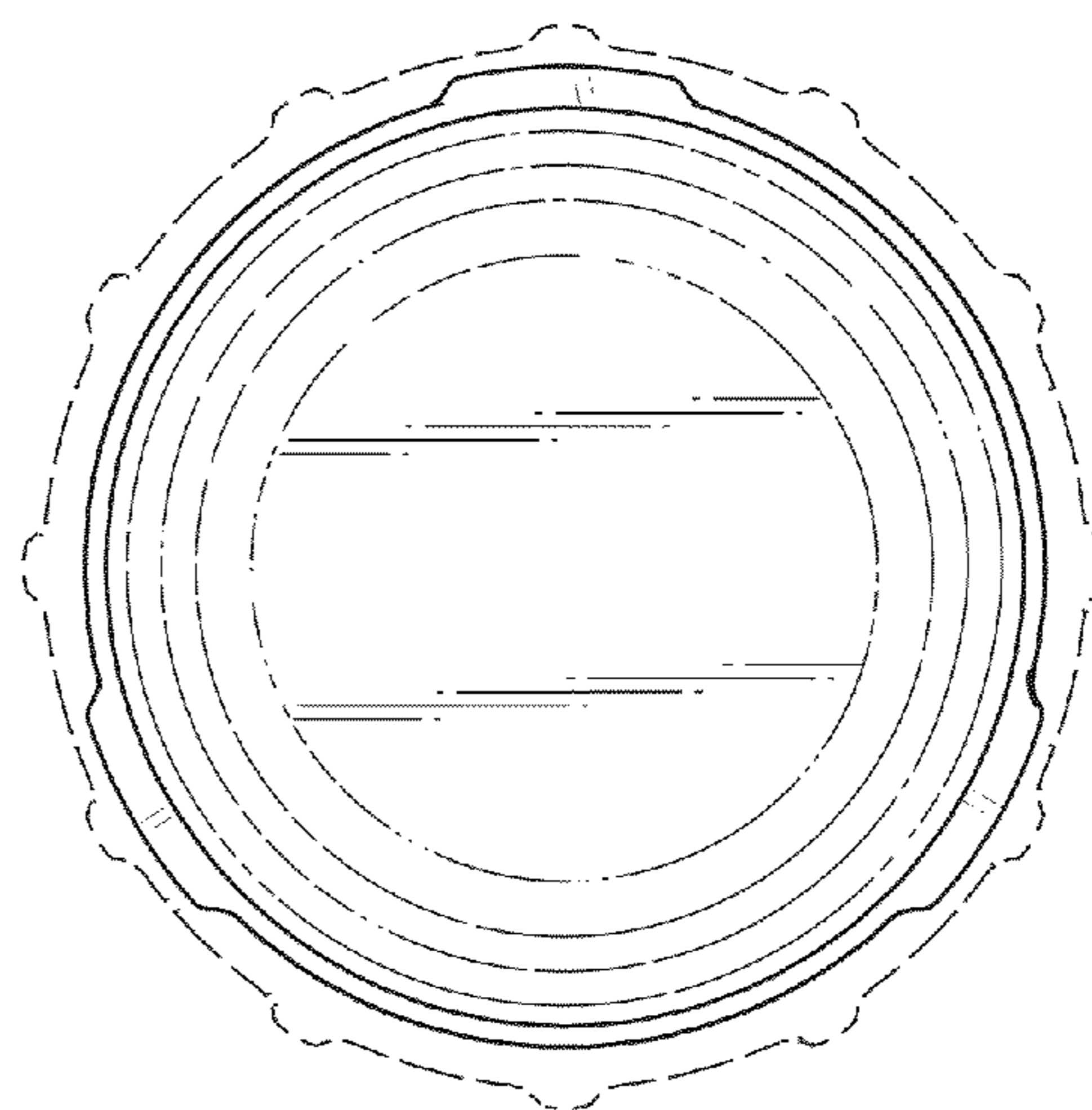

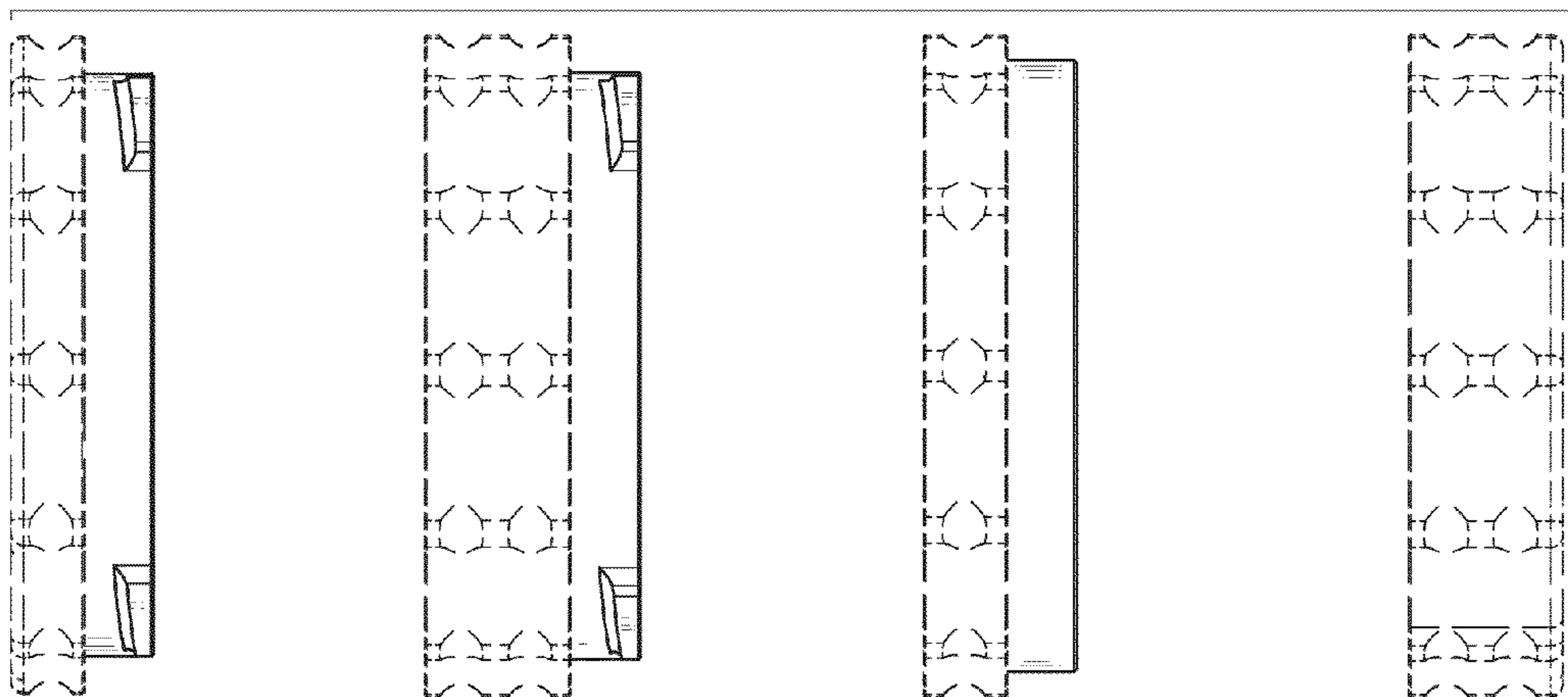

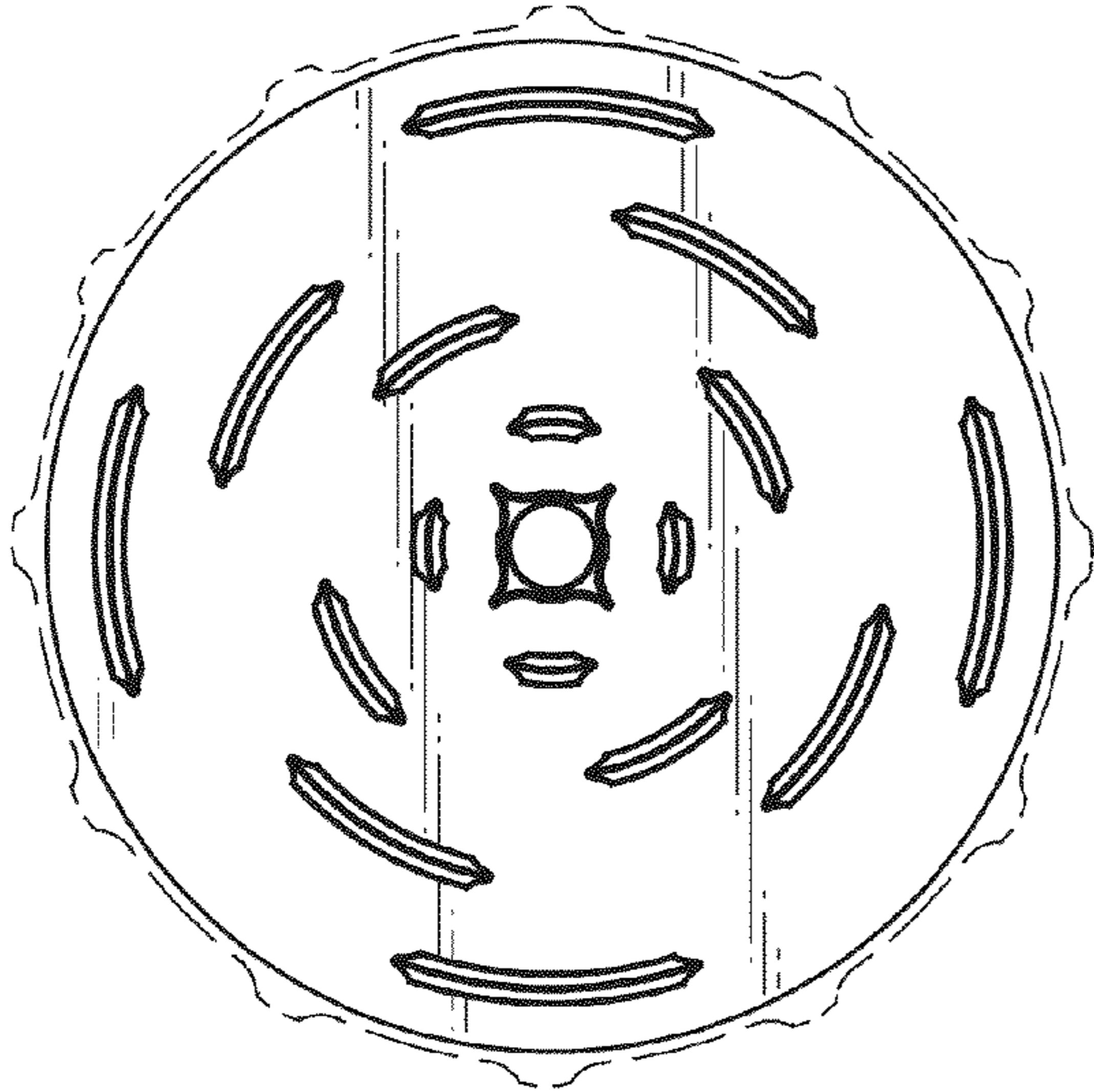

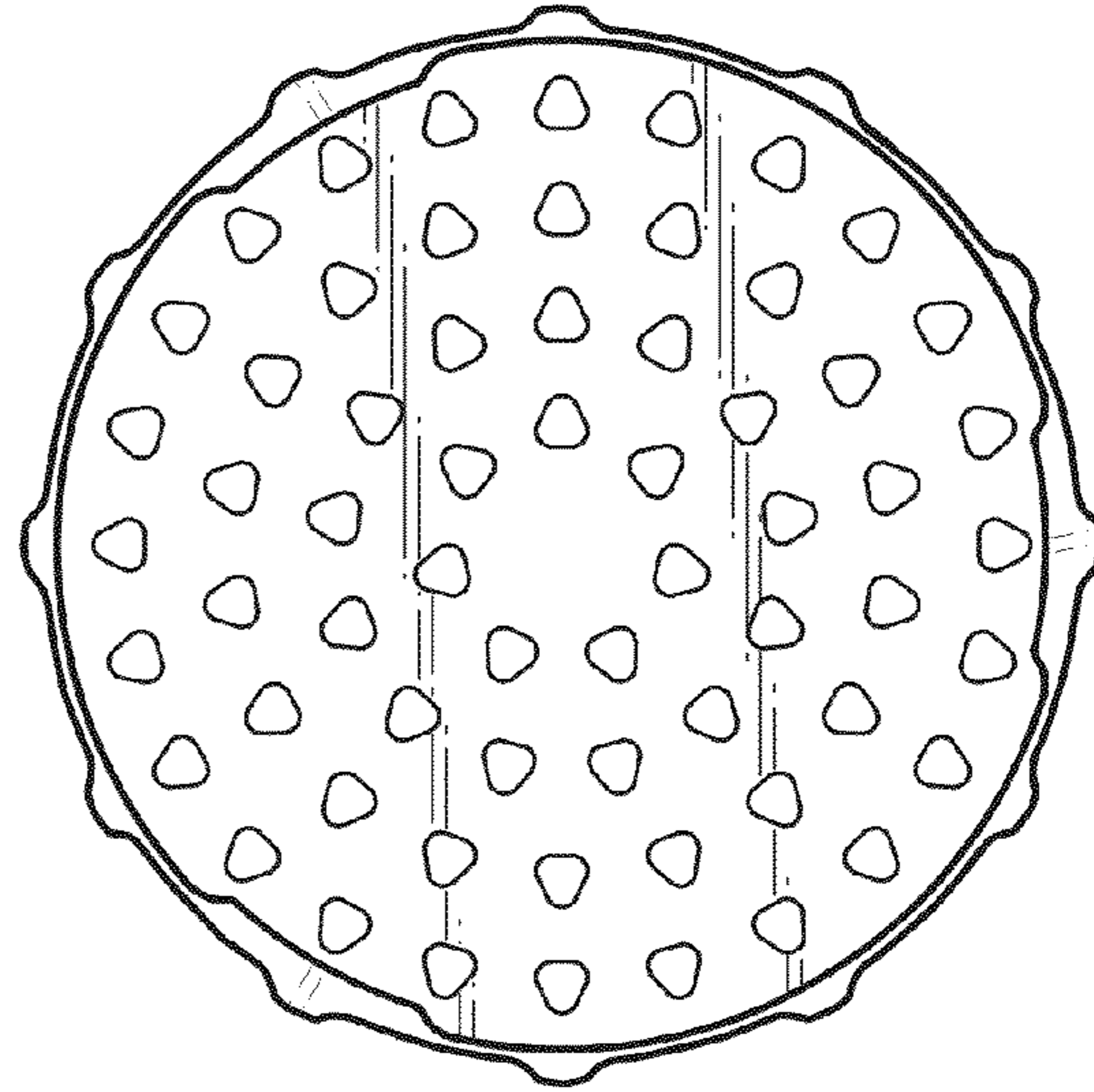

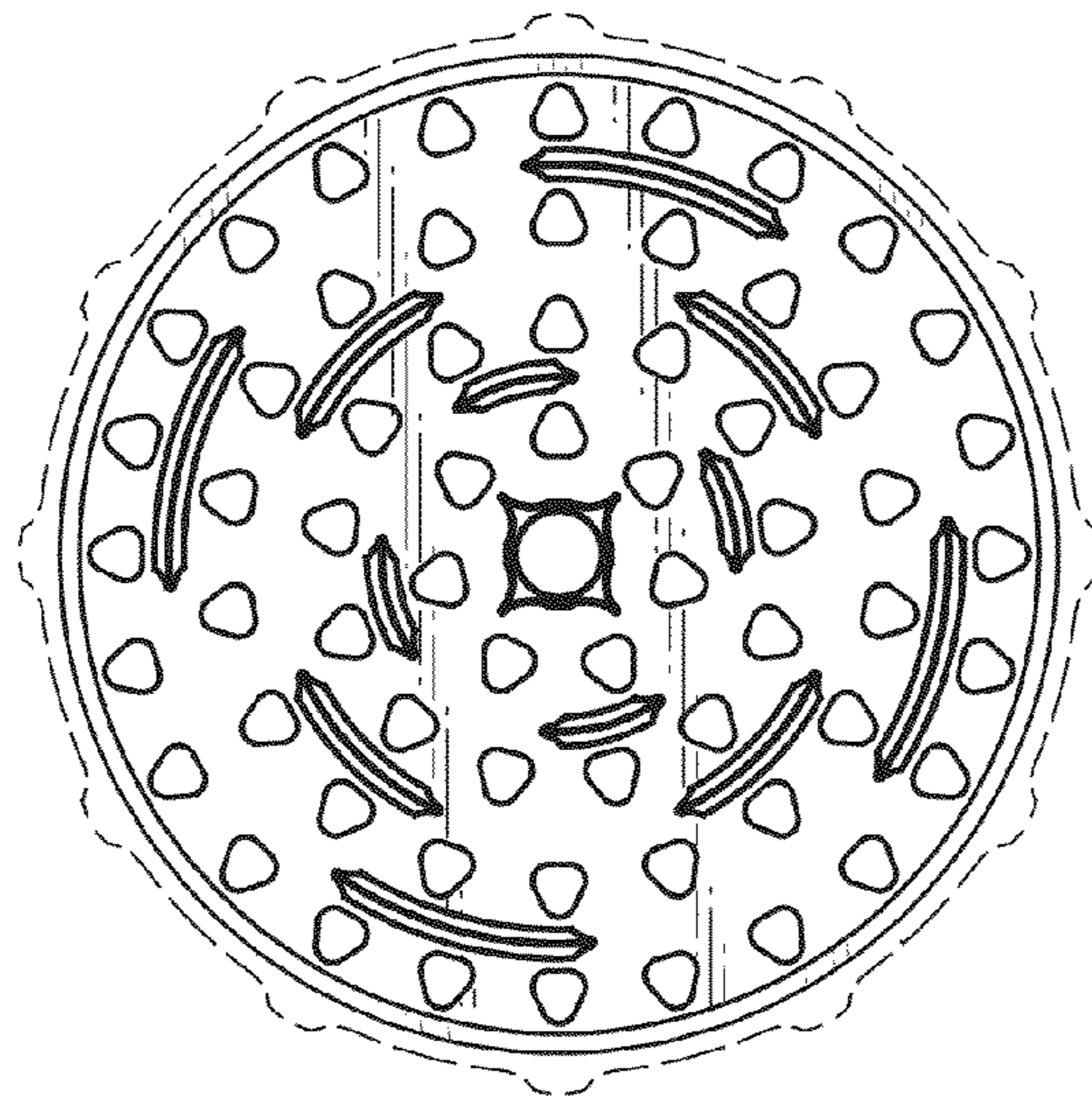

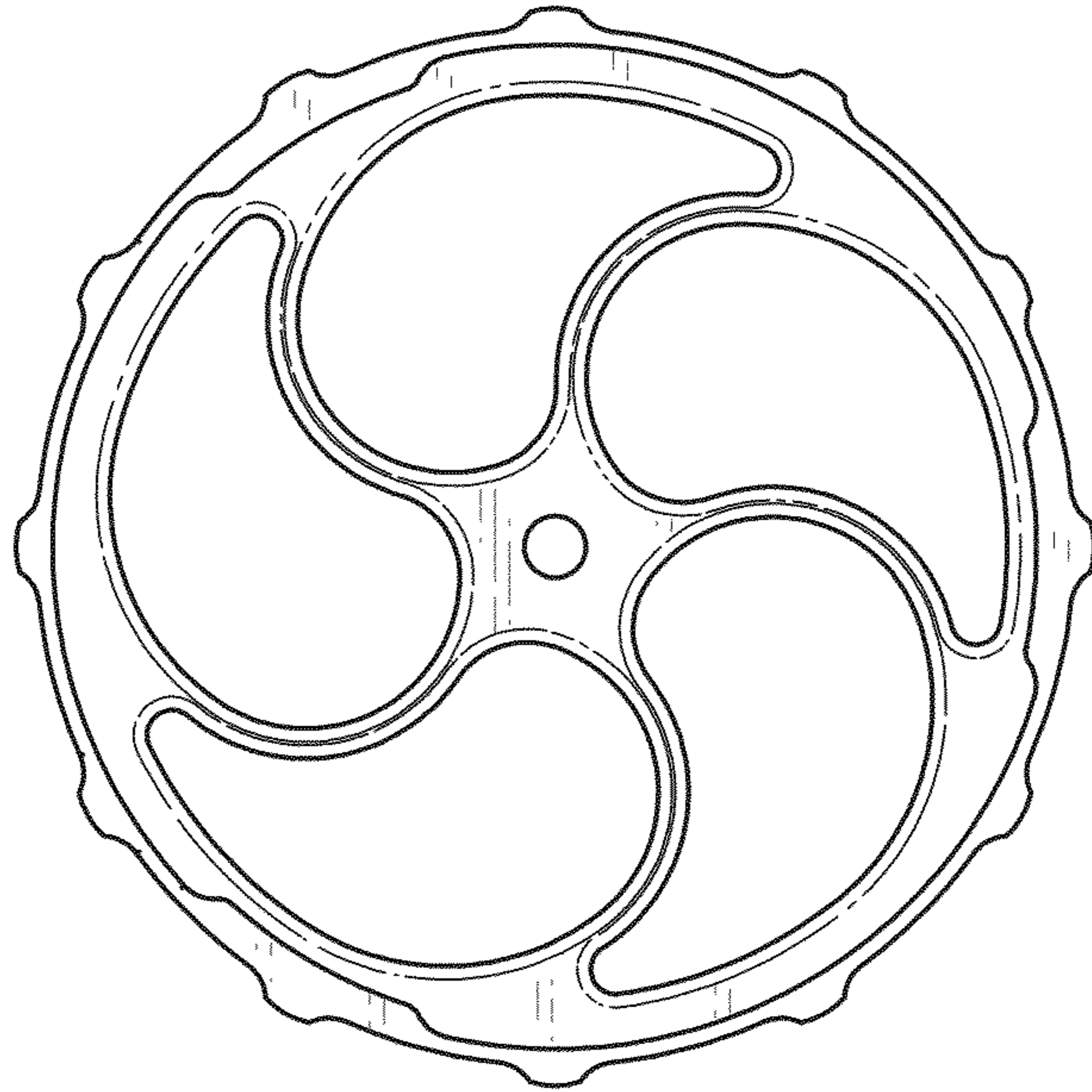

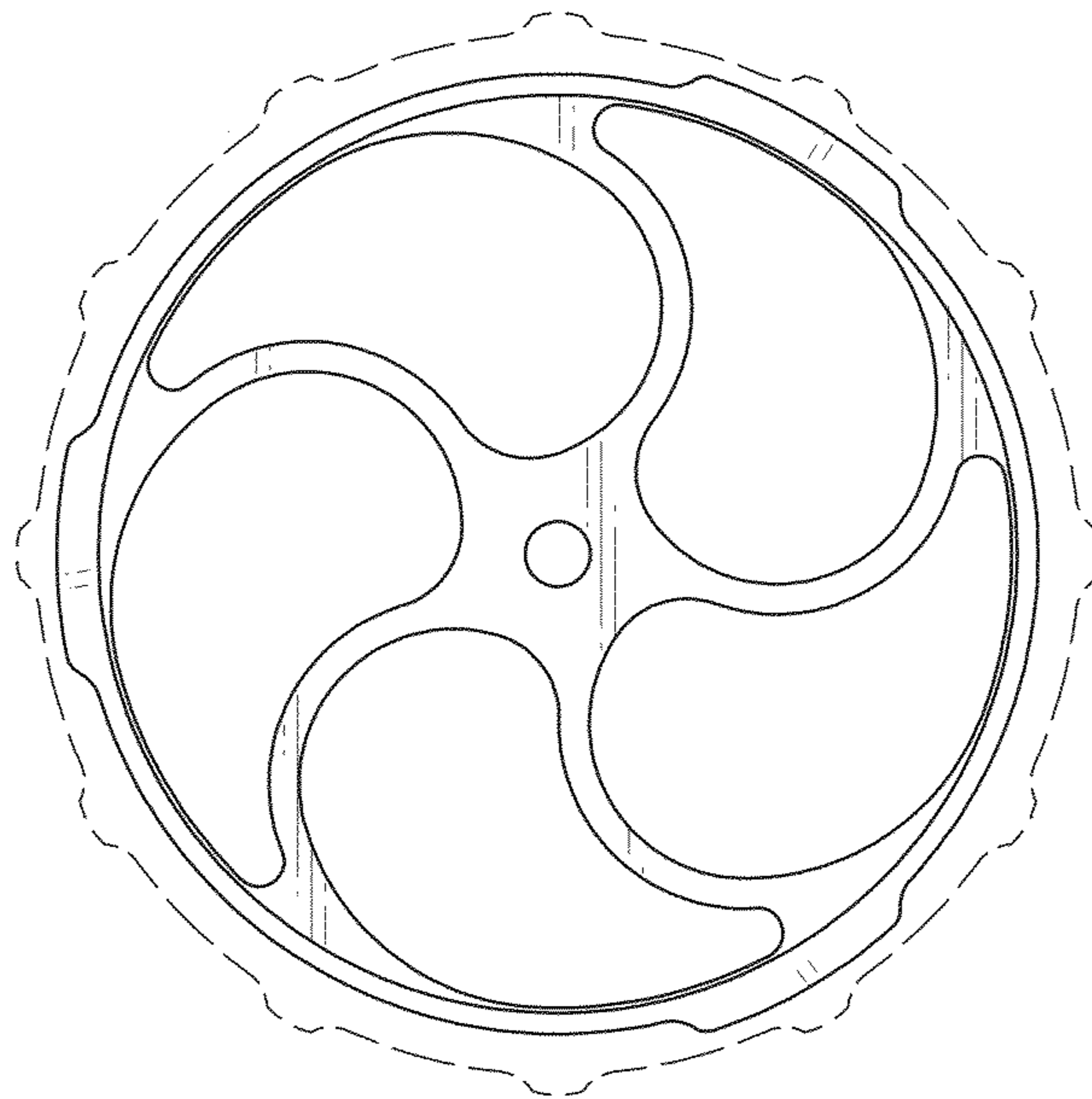
