The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bottle.

FIG. 2 is a front side elevational view of the bottle, the back side, right side, and left side elevational views being identical thereto.

FIG. 3 is a top plan view of the bottle; and,

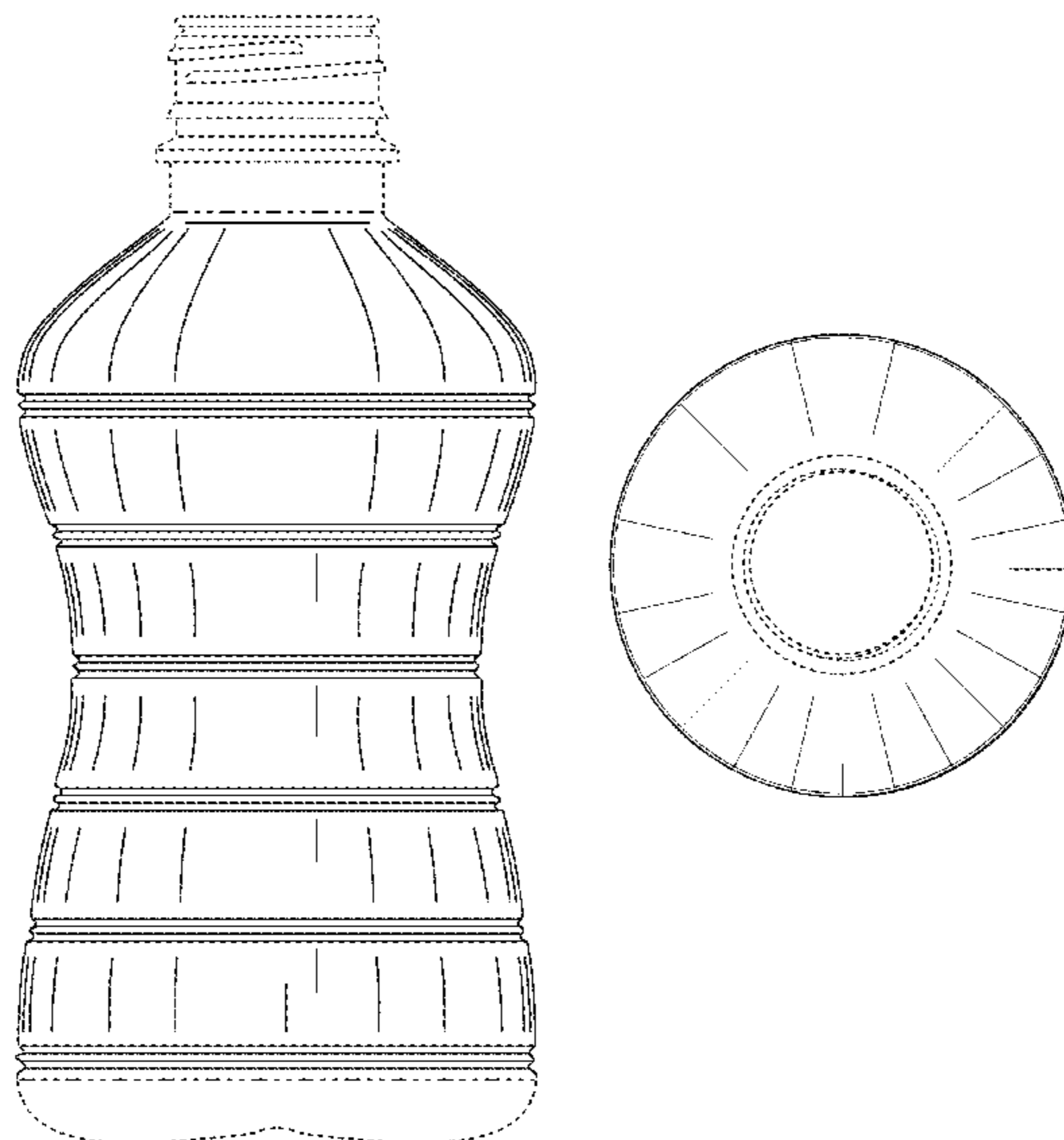
FIG. 4 is a bottom plan view of the bottle.

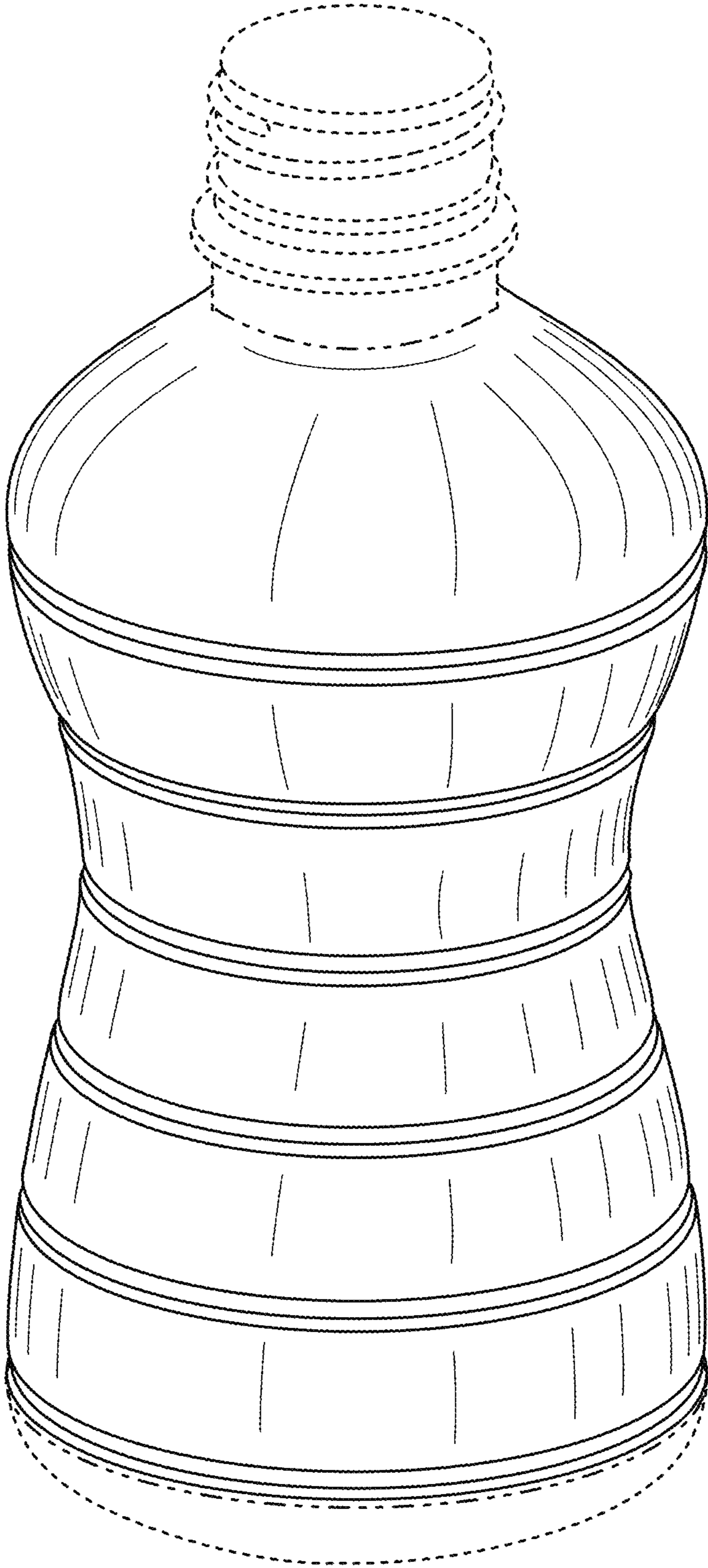

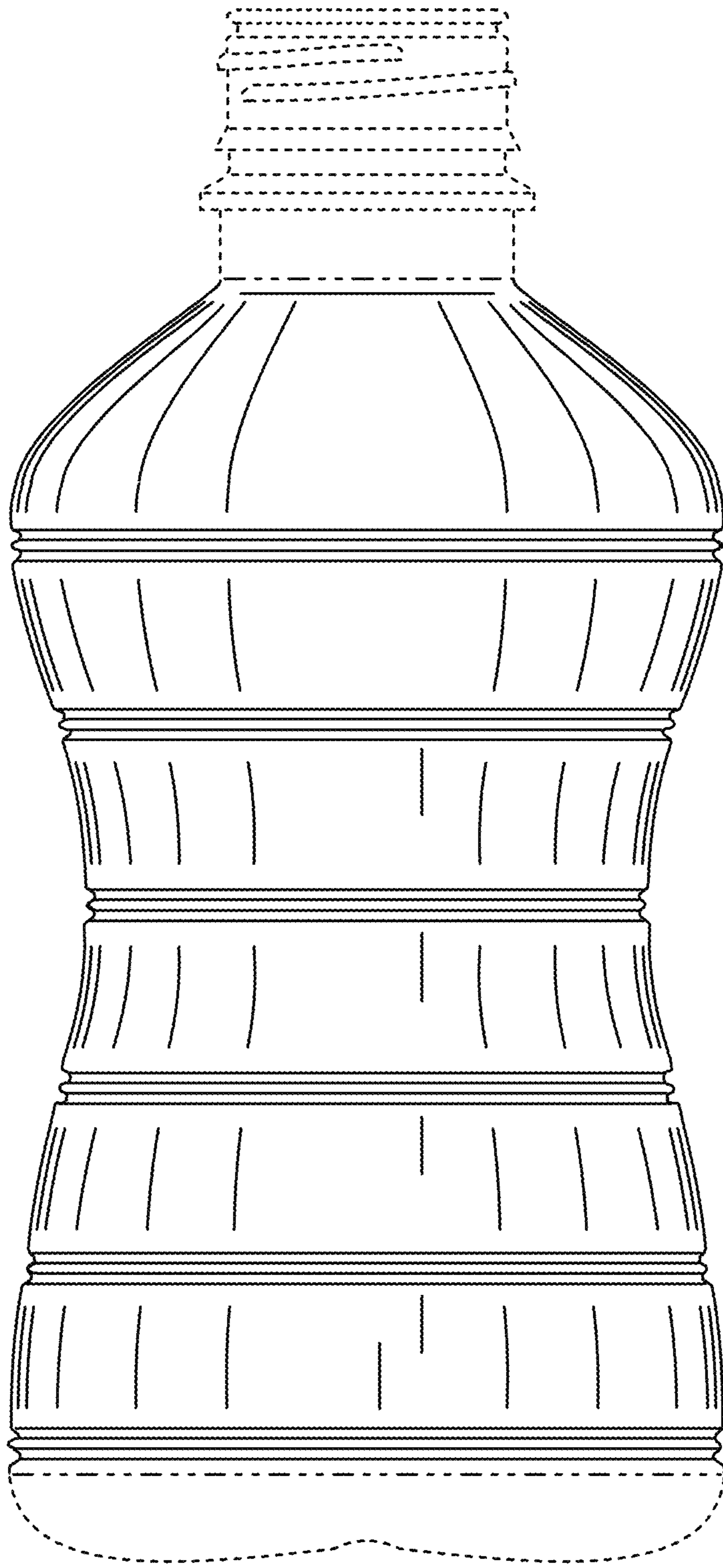

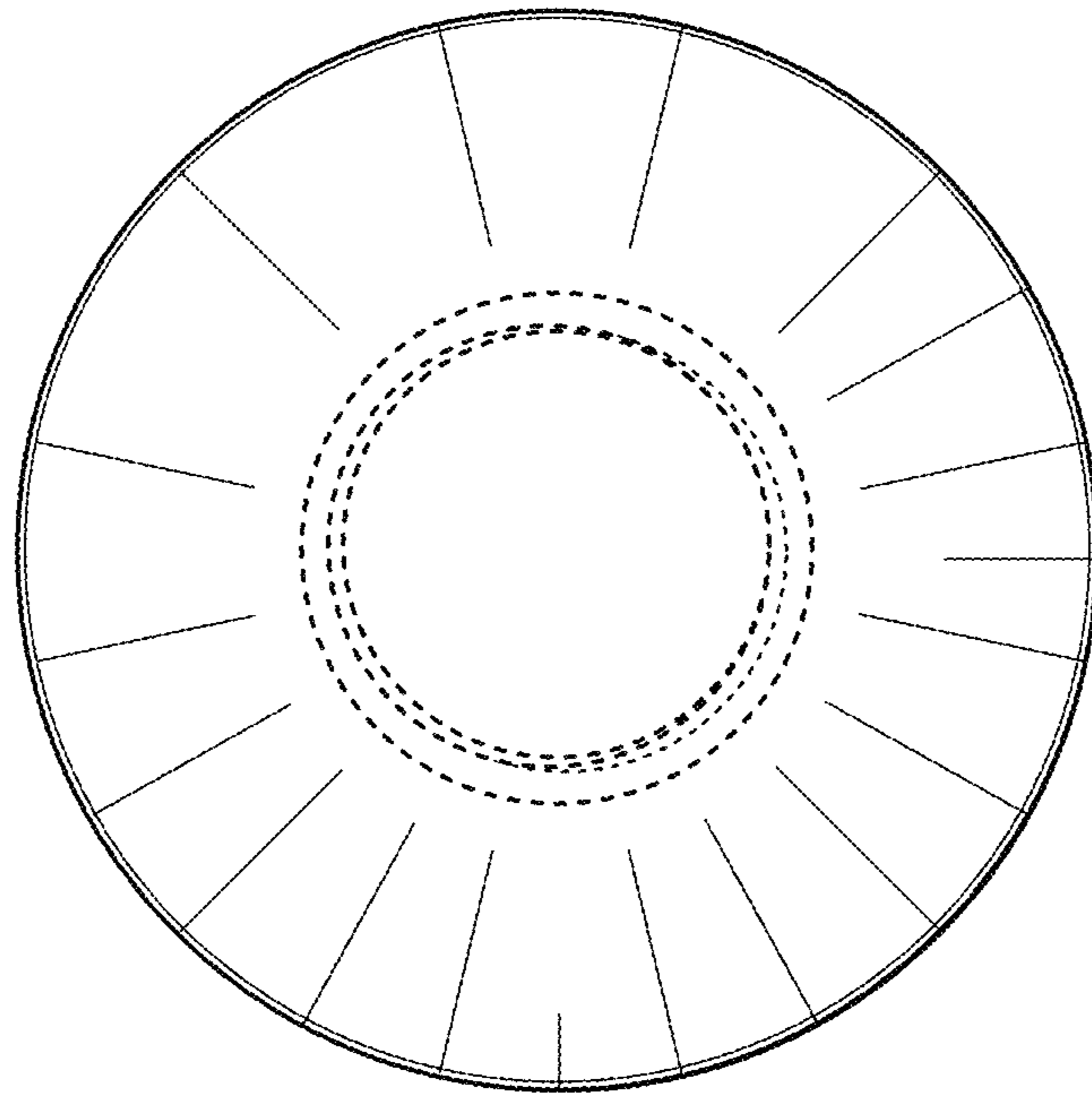

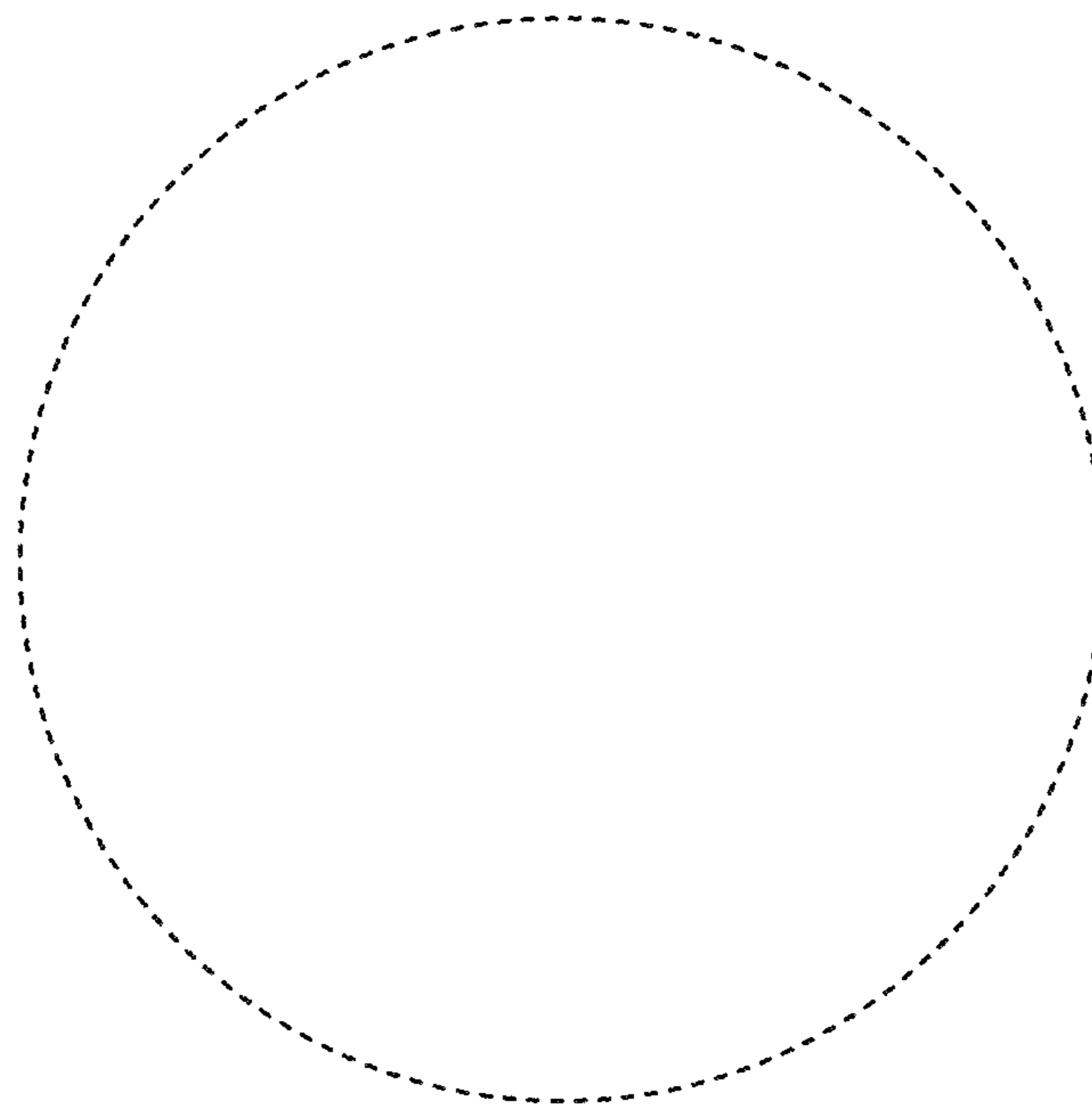
