(57) **CLAIM**

The ornamental design for a visual display device for a force and/or motion measurement system, as shown and described.

DESCRIPTION

FIG. 1 is a front-right perspective view of a first embodiment of a visual display device for a force and/or motion measurement system showing our new design;

FIG. 2 is a front elevational view of the embodiment shown in FIG. 1;

FIG. 3 is a top plan view of the embodiment shown in FIG. 1;

FIG. 4 is a bottom plan view of the embodiment shown in FIG. 1;

FIG. 5 is a right side elevational view of the embodiment shown in FIG. 1;

FIG. 6 is a left side elevational view of the embodiment shown in FIG. 1;

FIG. 7 is a rear elevational view of the embodiment shown in FIG. 1;

FIG. 8 is a rear-right perspective view of the embodiment shown in FIG. 1;

FIG. 9 is a rear-left perspective view of the embodiment shown in FIG. 1;

FIG. 10 is a front-right perspective view of a second embodiment of a visual display device for a force and/or motion measurement system showing our new design;

FIG. 11 is a front elevational view of the embodiment shown in FIG. 10;

FIG. 12 is a top plan view of the embodiment shown in FIG. 10;

FIG. 13 is a bottom plan view of the embodiment shown in FIG. 10;

FIG. 14 is a right side elevational view of the embodiment shown in FIG. 10;

FIG. 15 is a left side elevational view of the embodiment shown in FIG. 10;

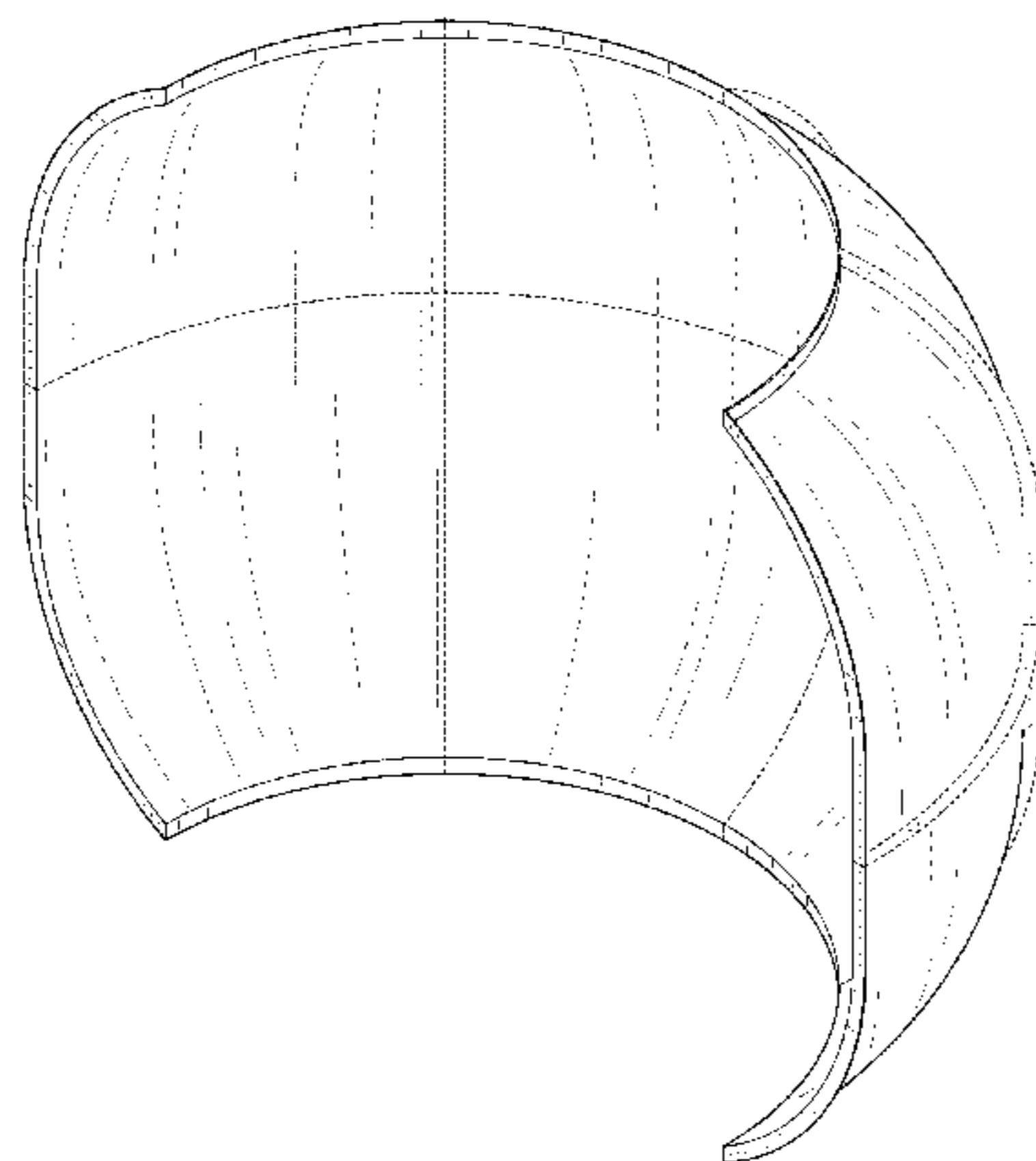
FIG. 16 is a rear elevational view of the embodiment shown in FIG. 10;

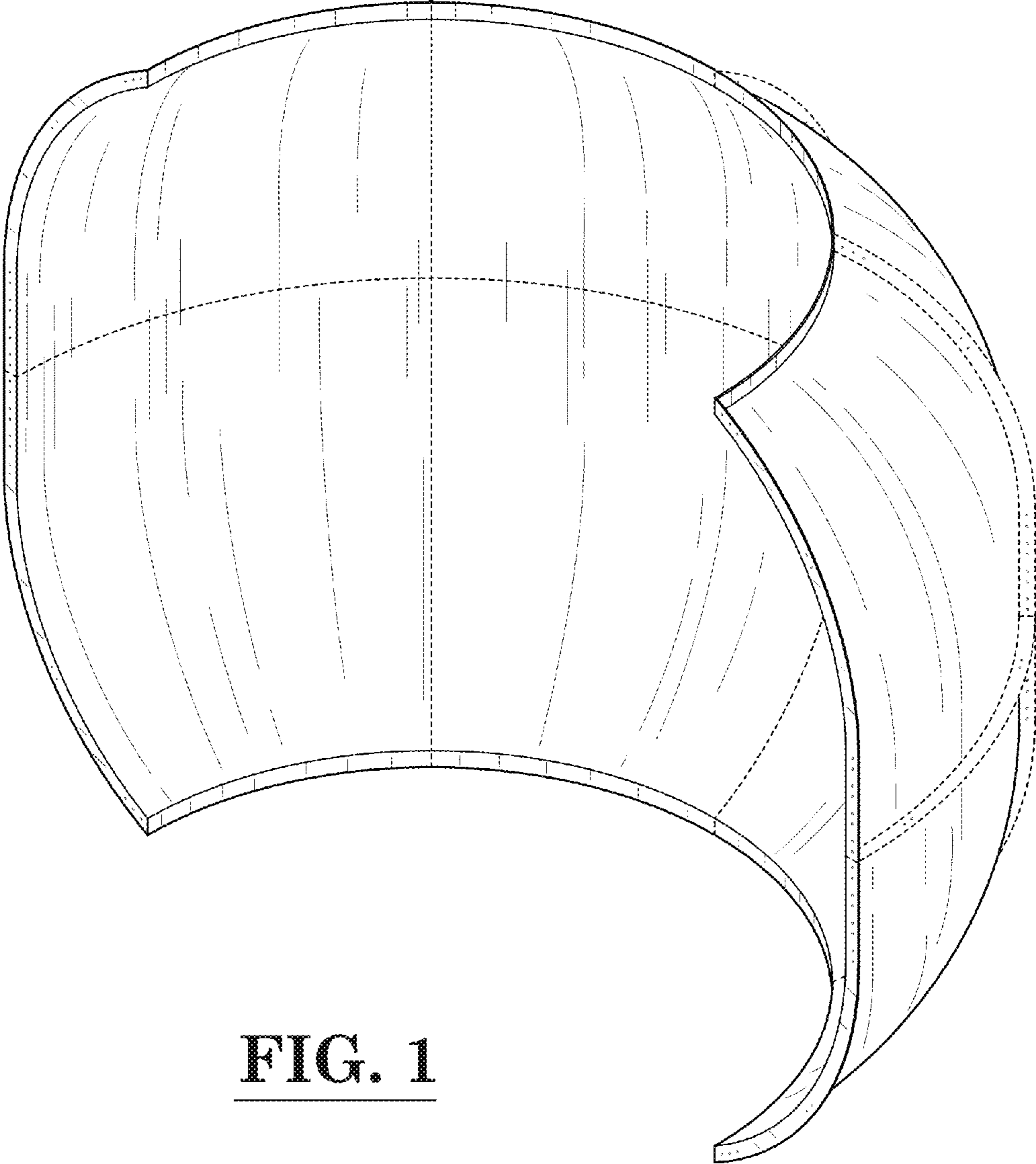

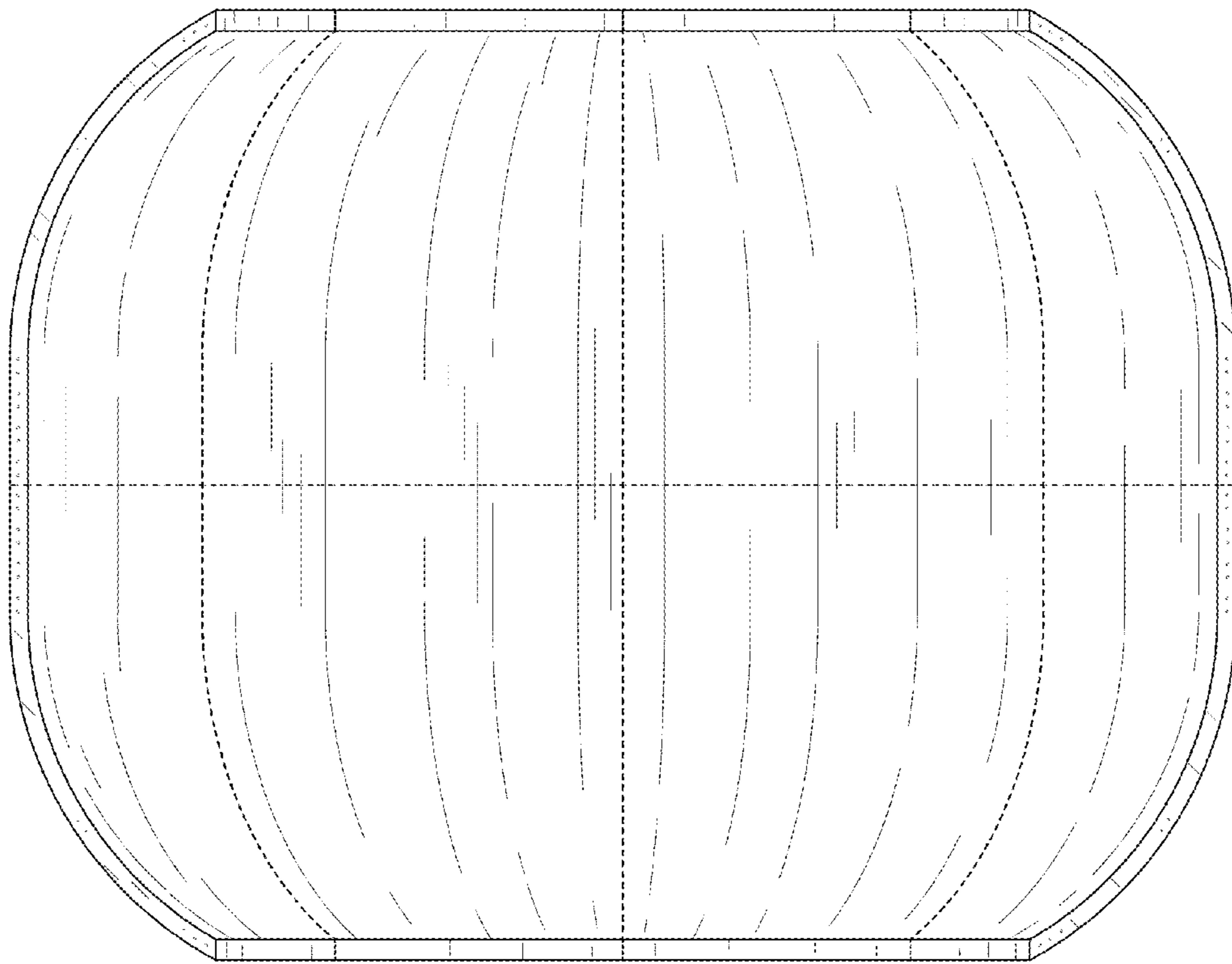

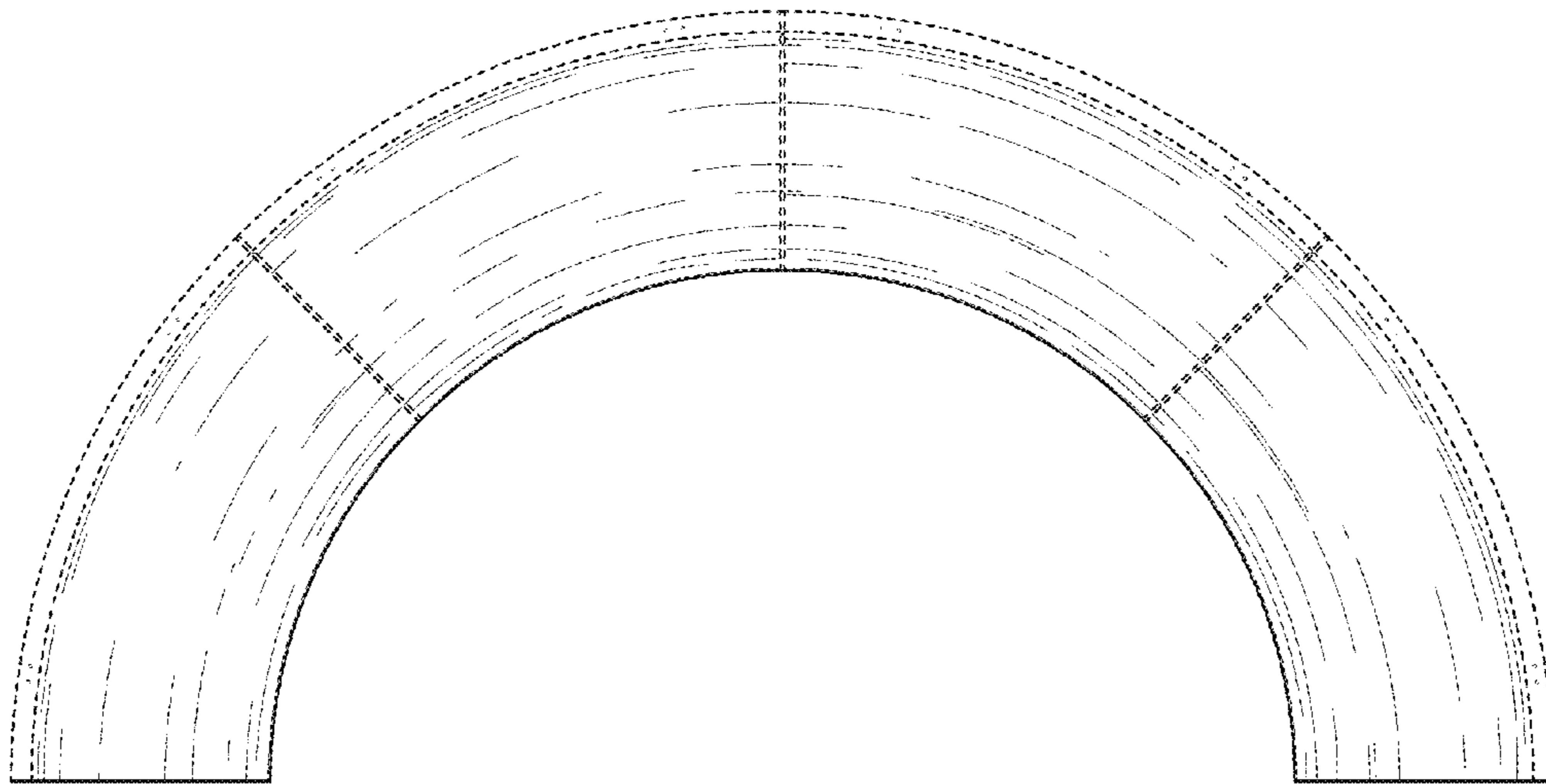

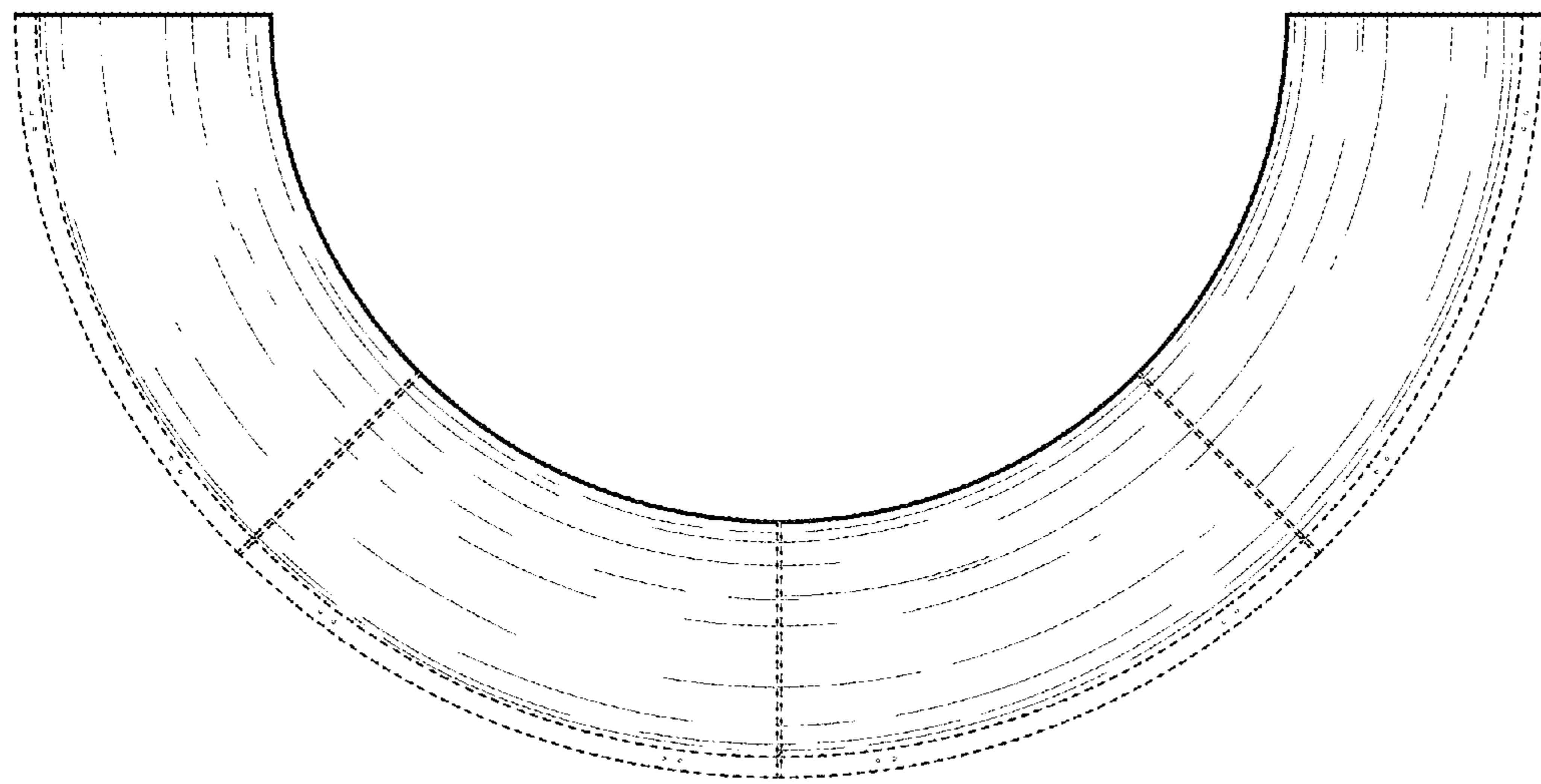

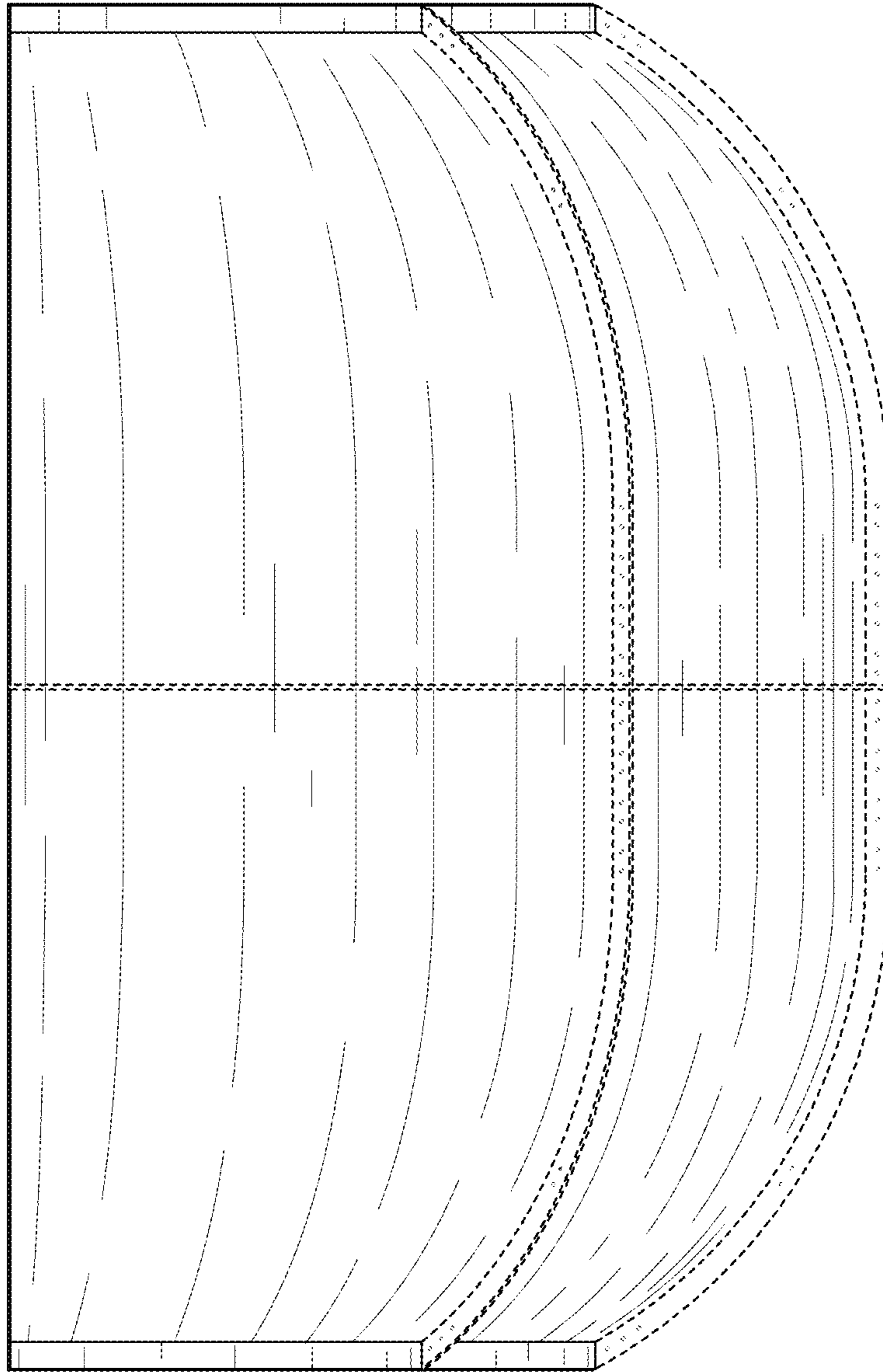

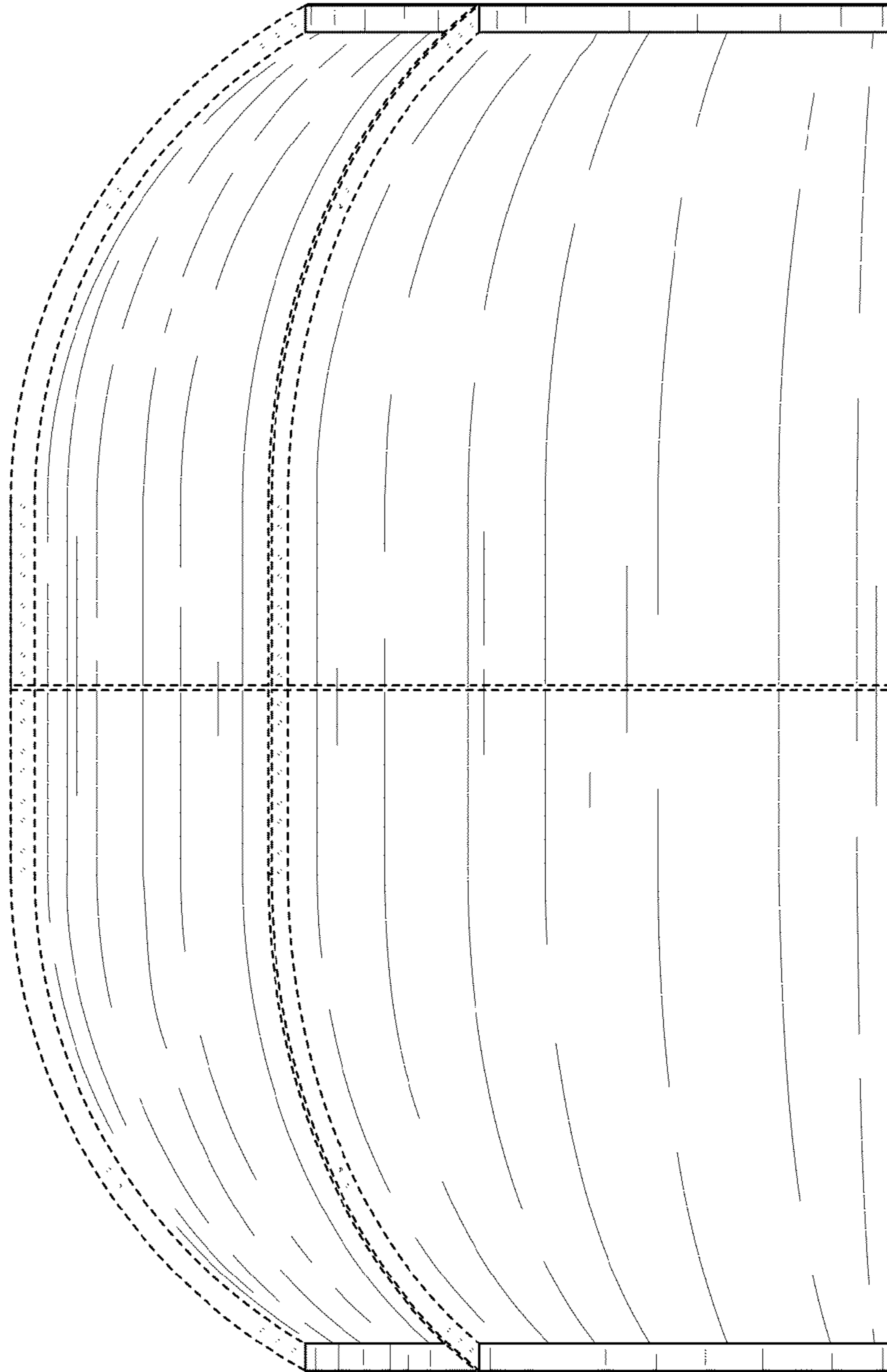

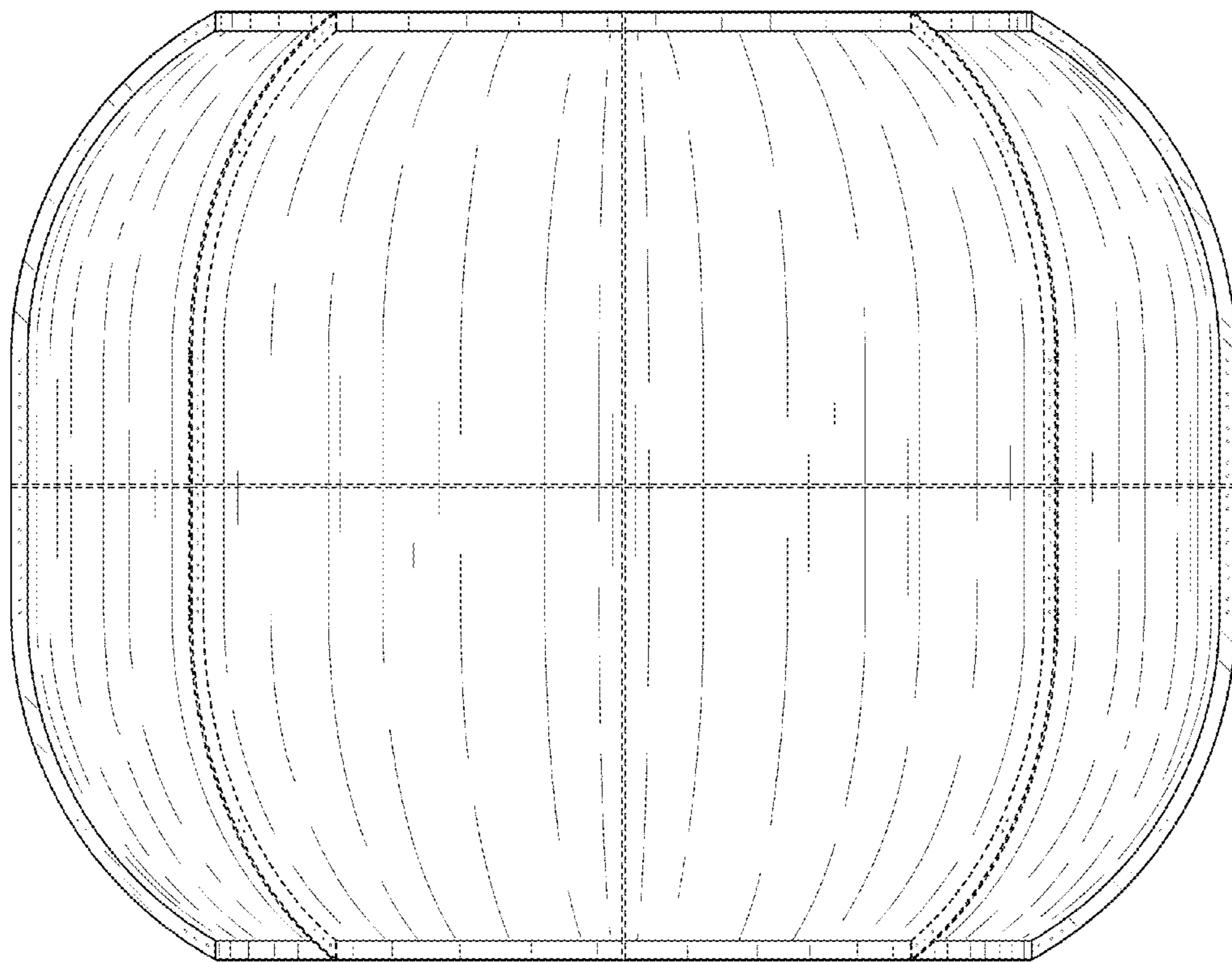

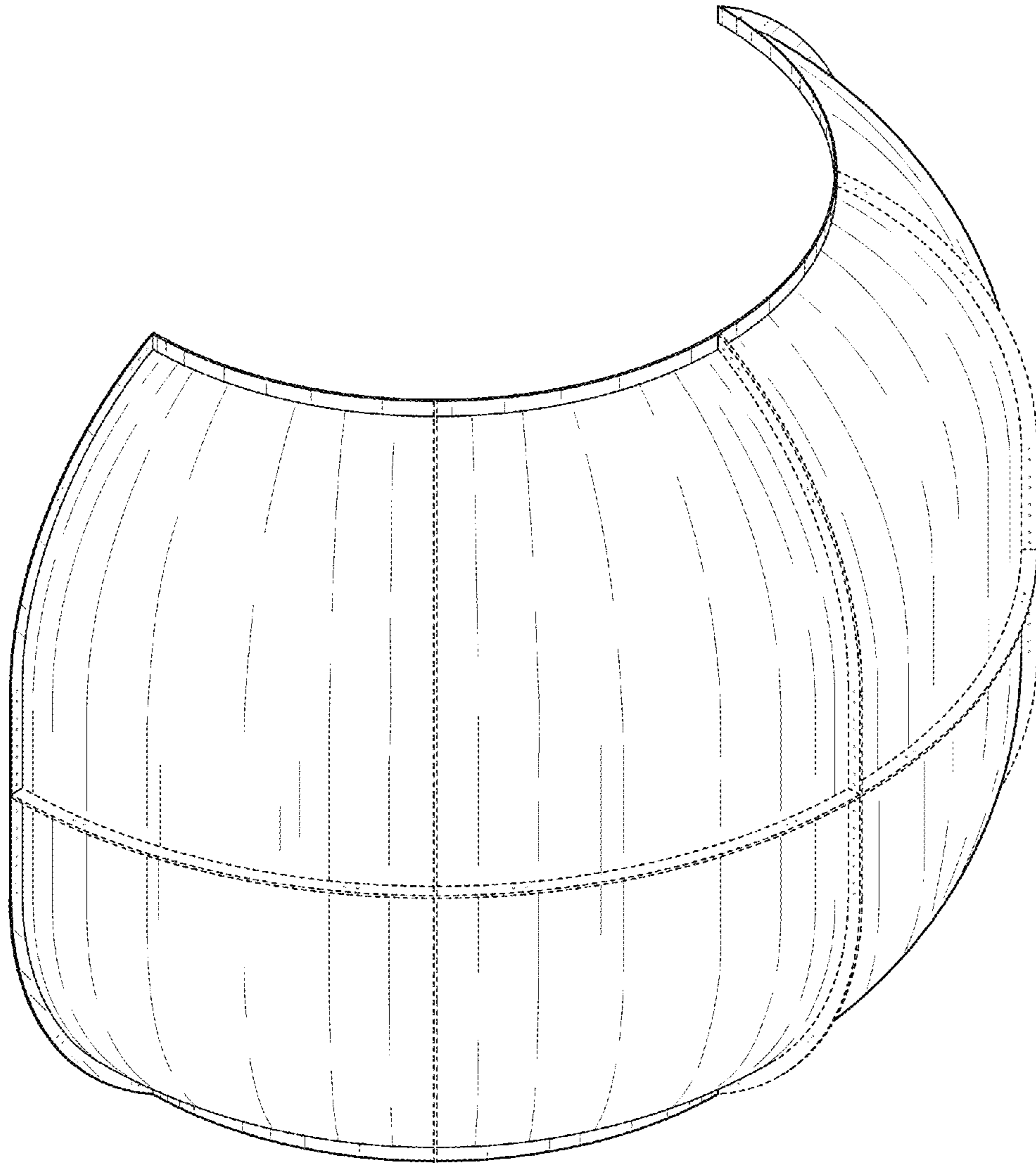

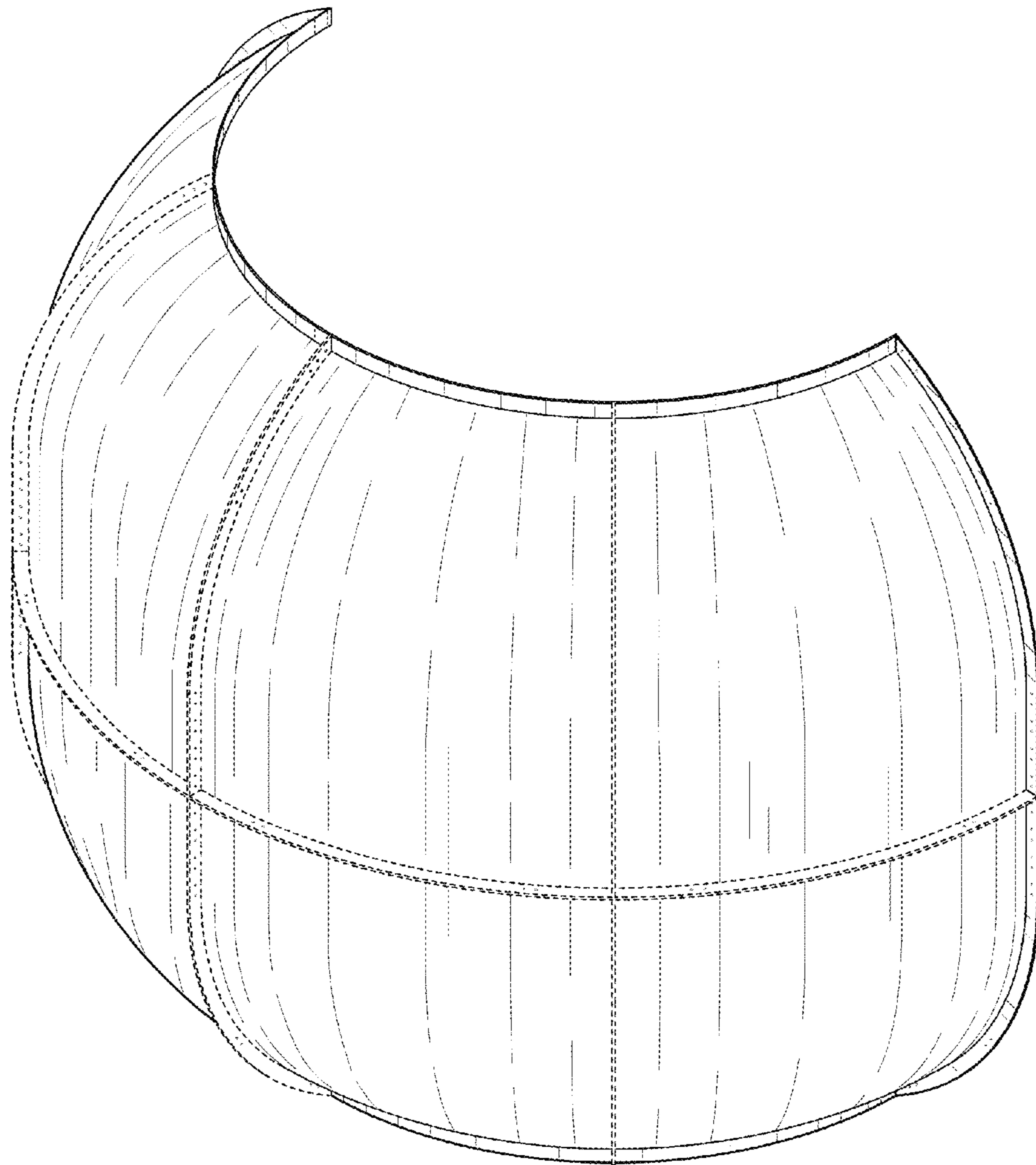

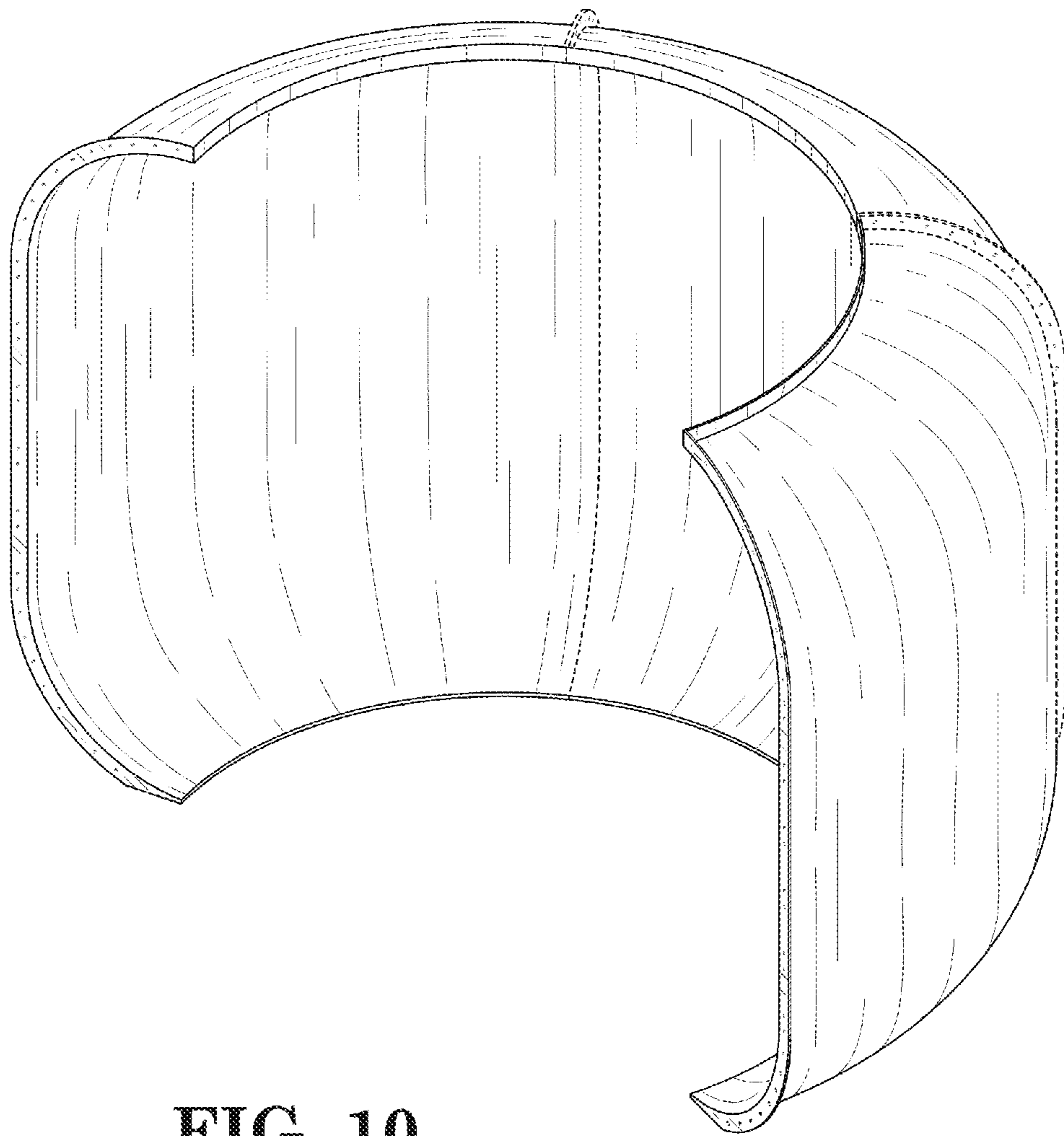

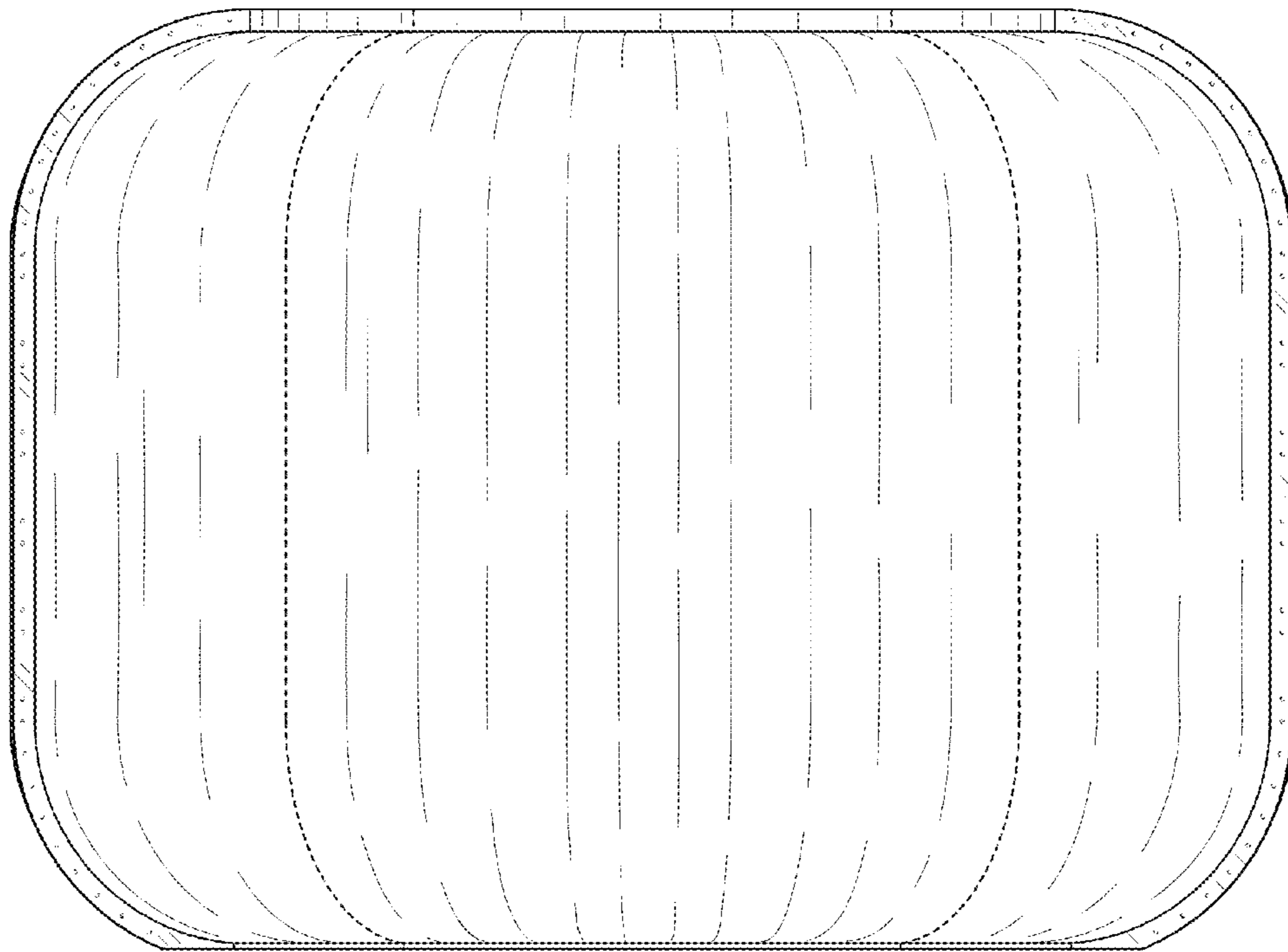

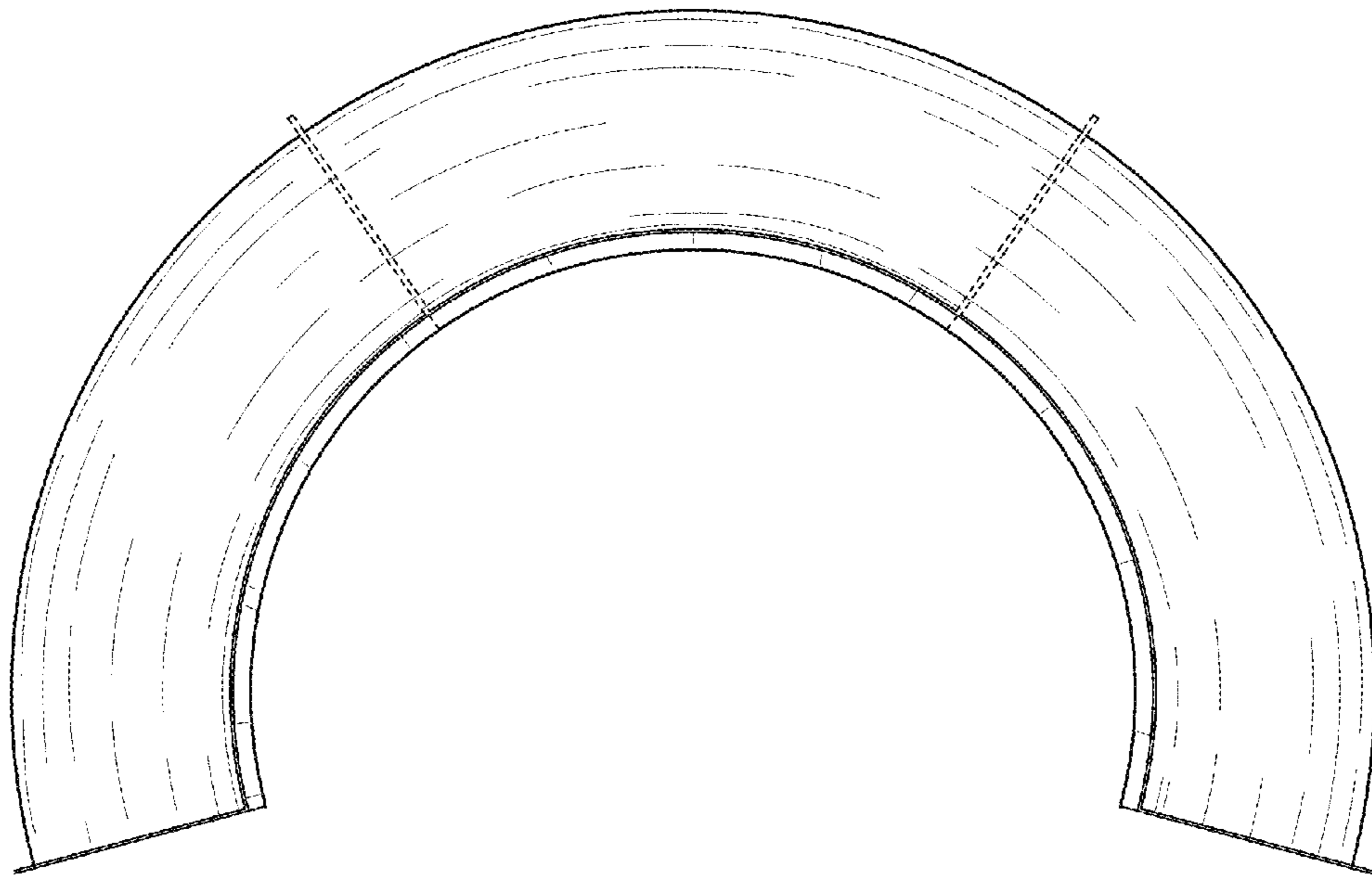

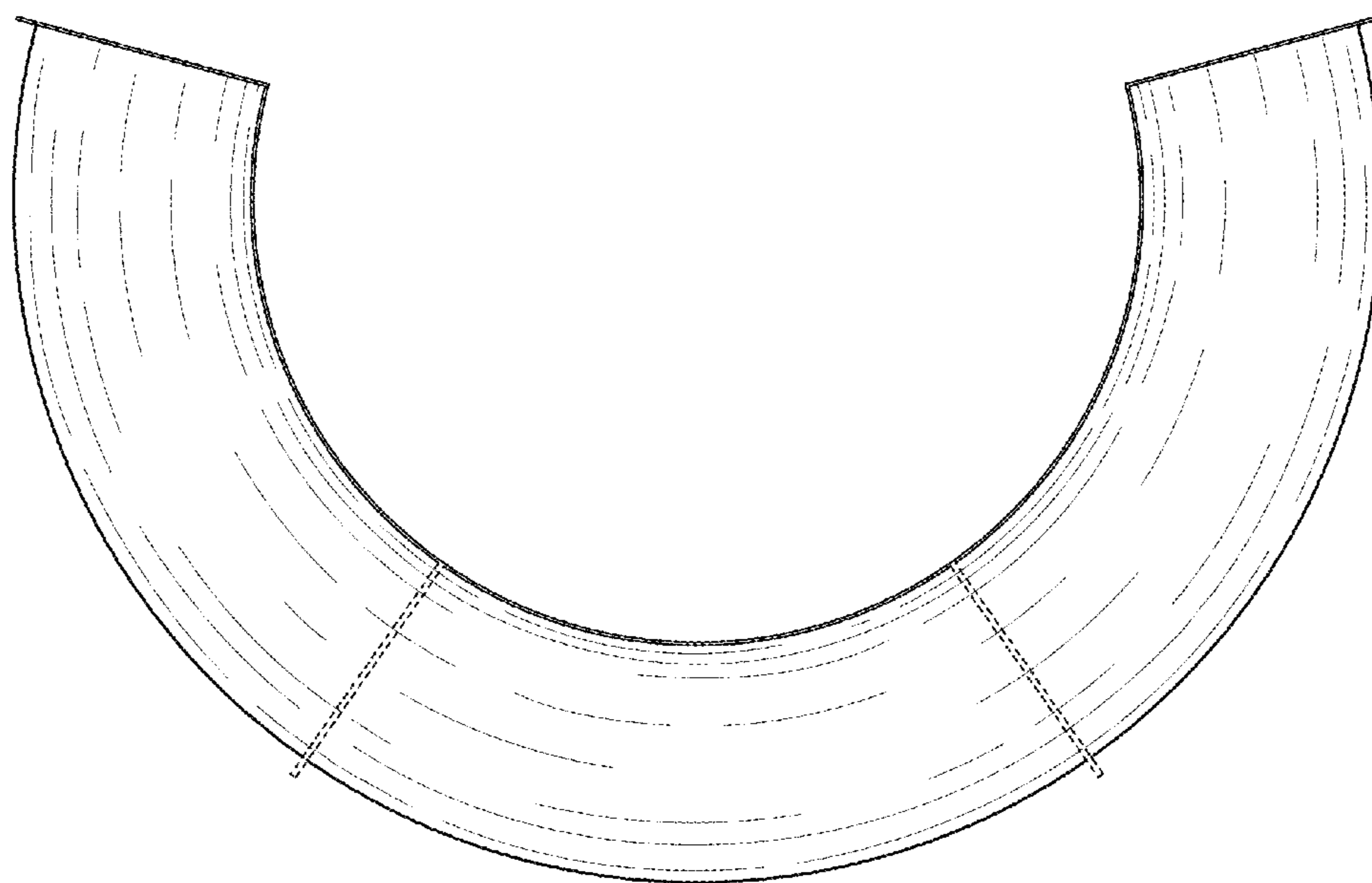

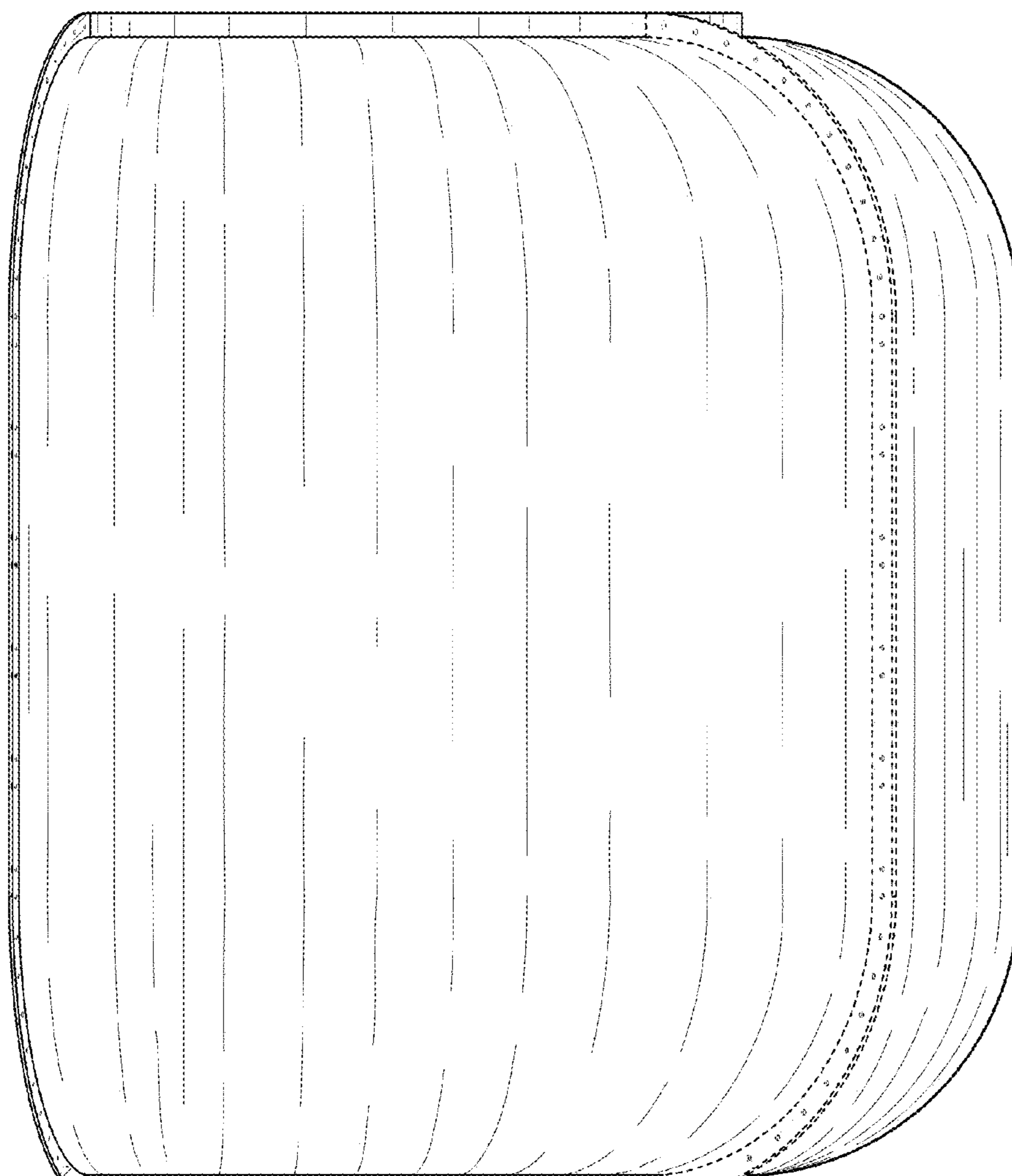

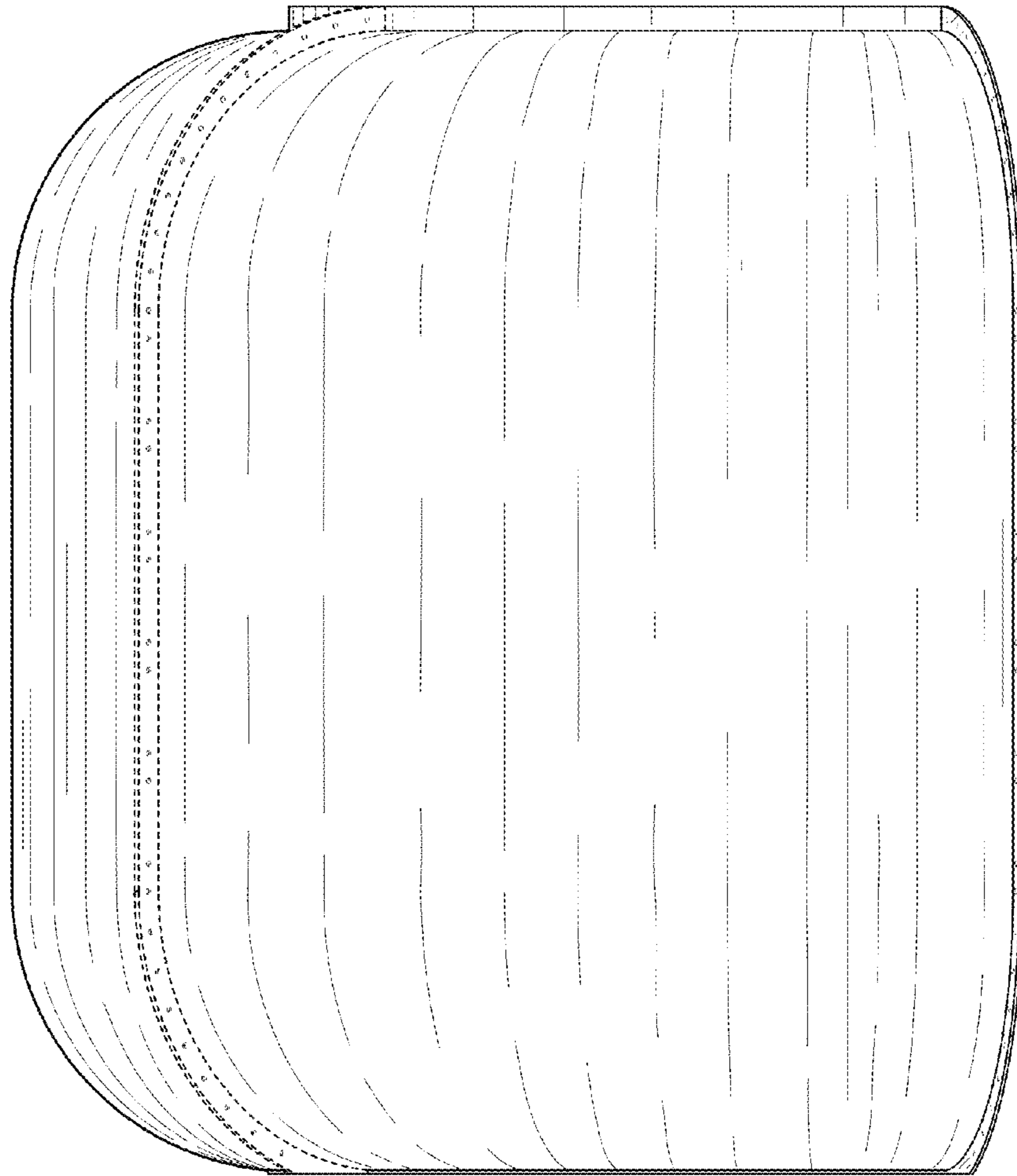

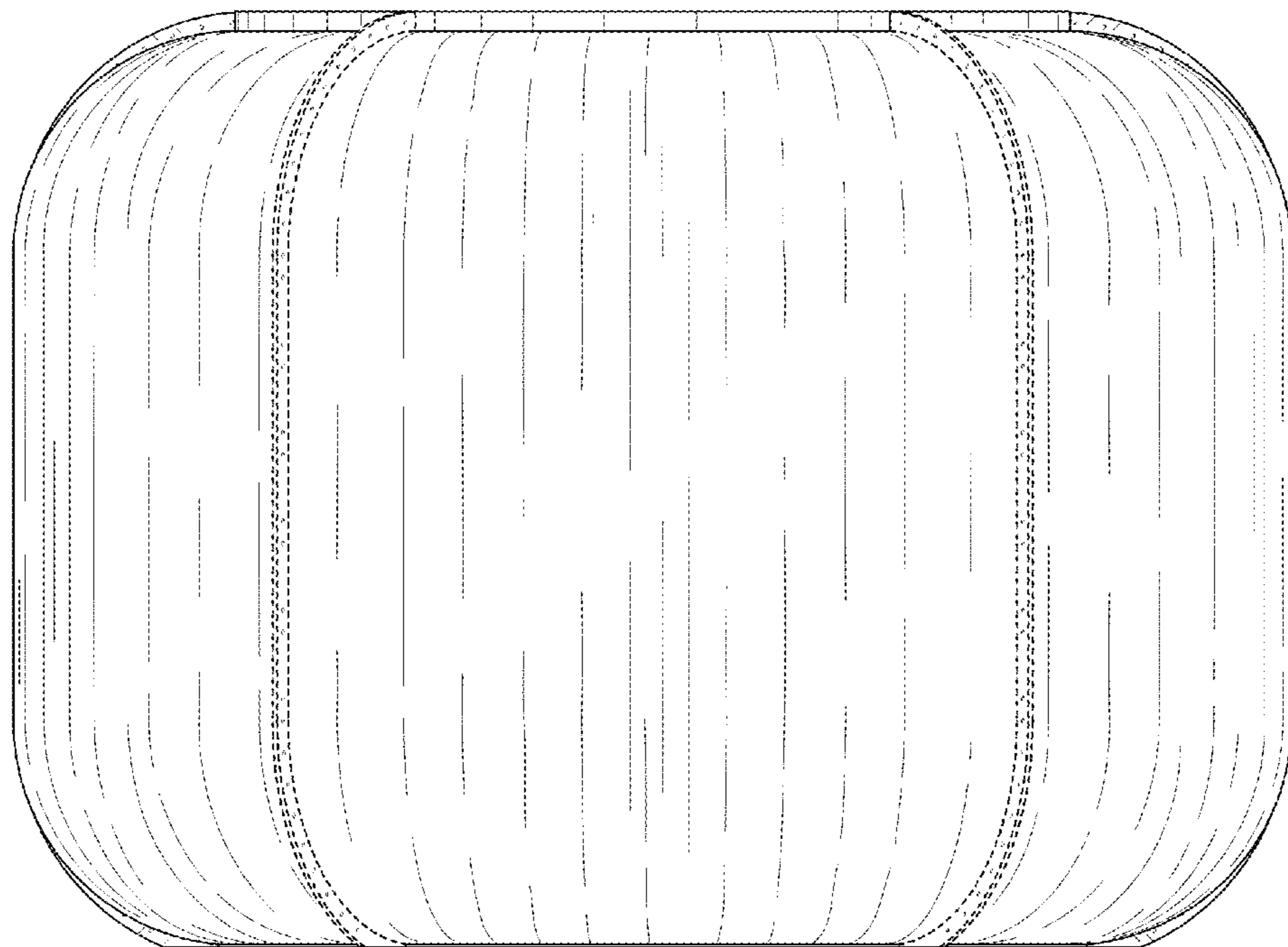

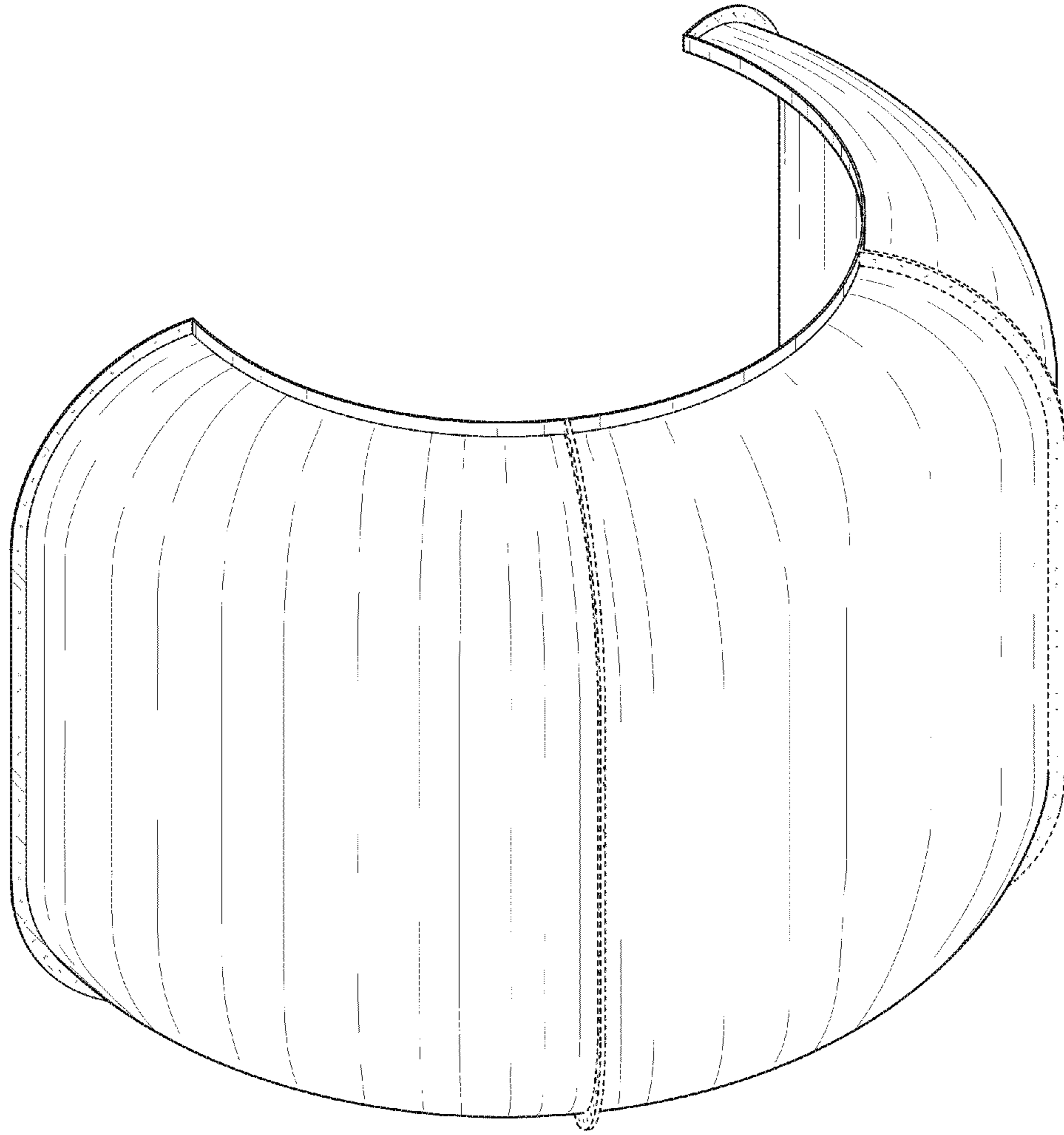

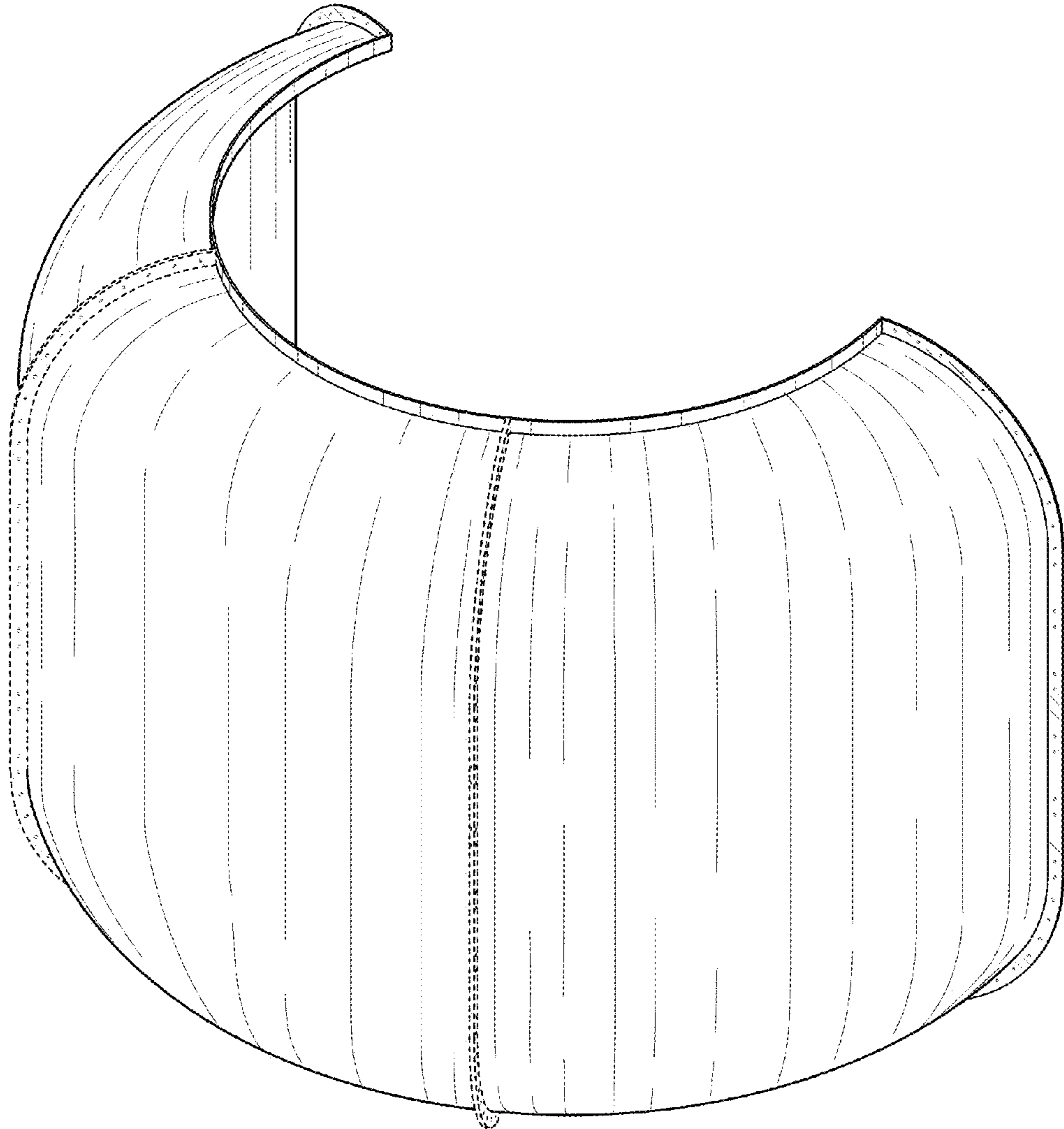
