(57) **CLAIM**

We claim the ornamental design for a motorcycle body panel, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side elevation view of a motorcycle body panel according to the invention.

FIG. 2 is a right side elevation view of the motorcycle body panel of FIG. 1.

FIG. 3 is a top plan view of the motorcycle body panel of FIG. 1.

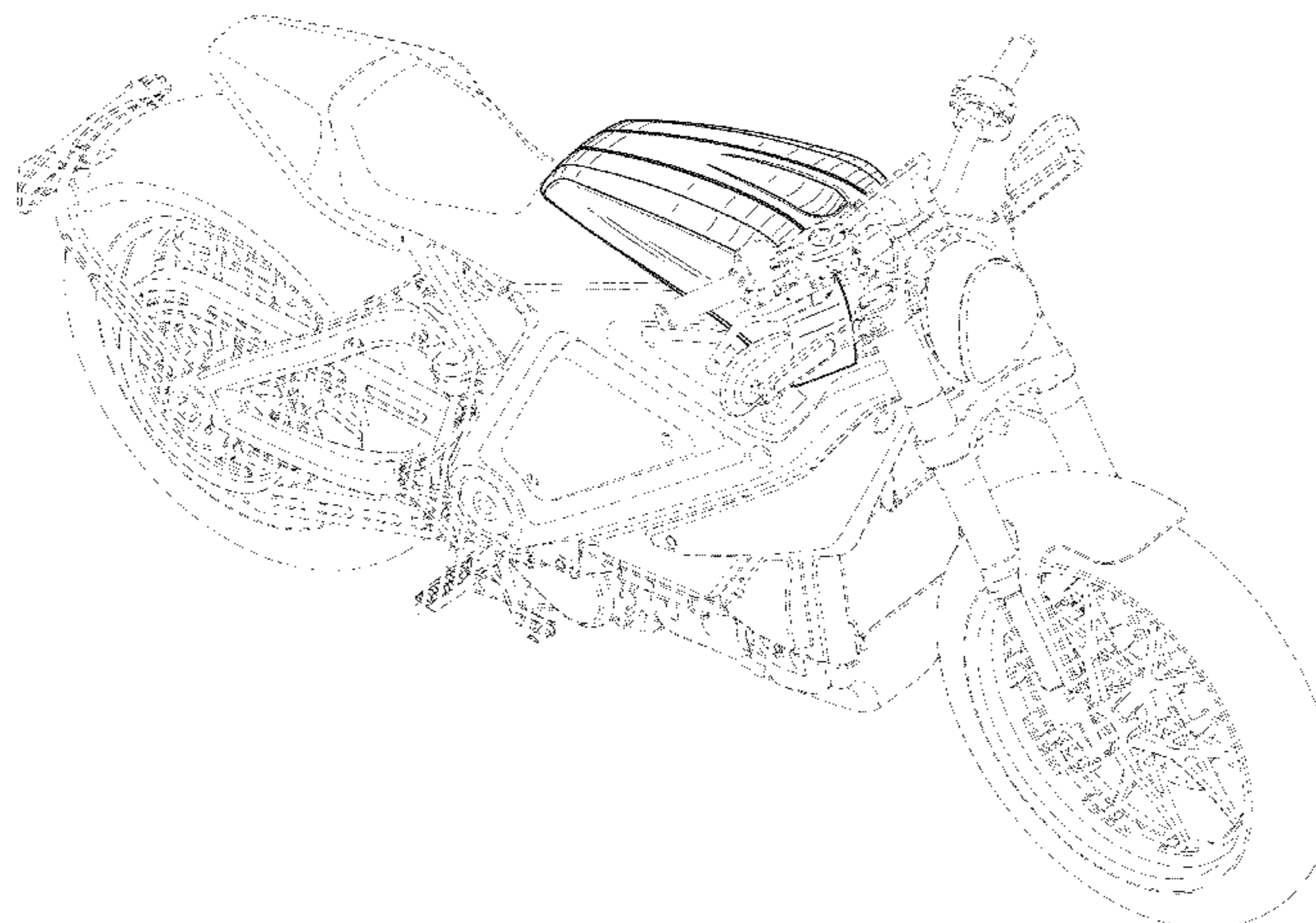
FIG. 4 is a front elevation view of the motorcycle body panel of FIG. 1.

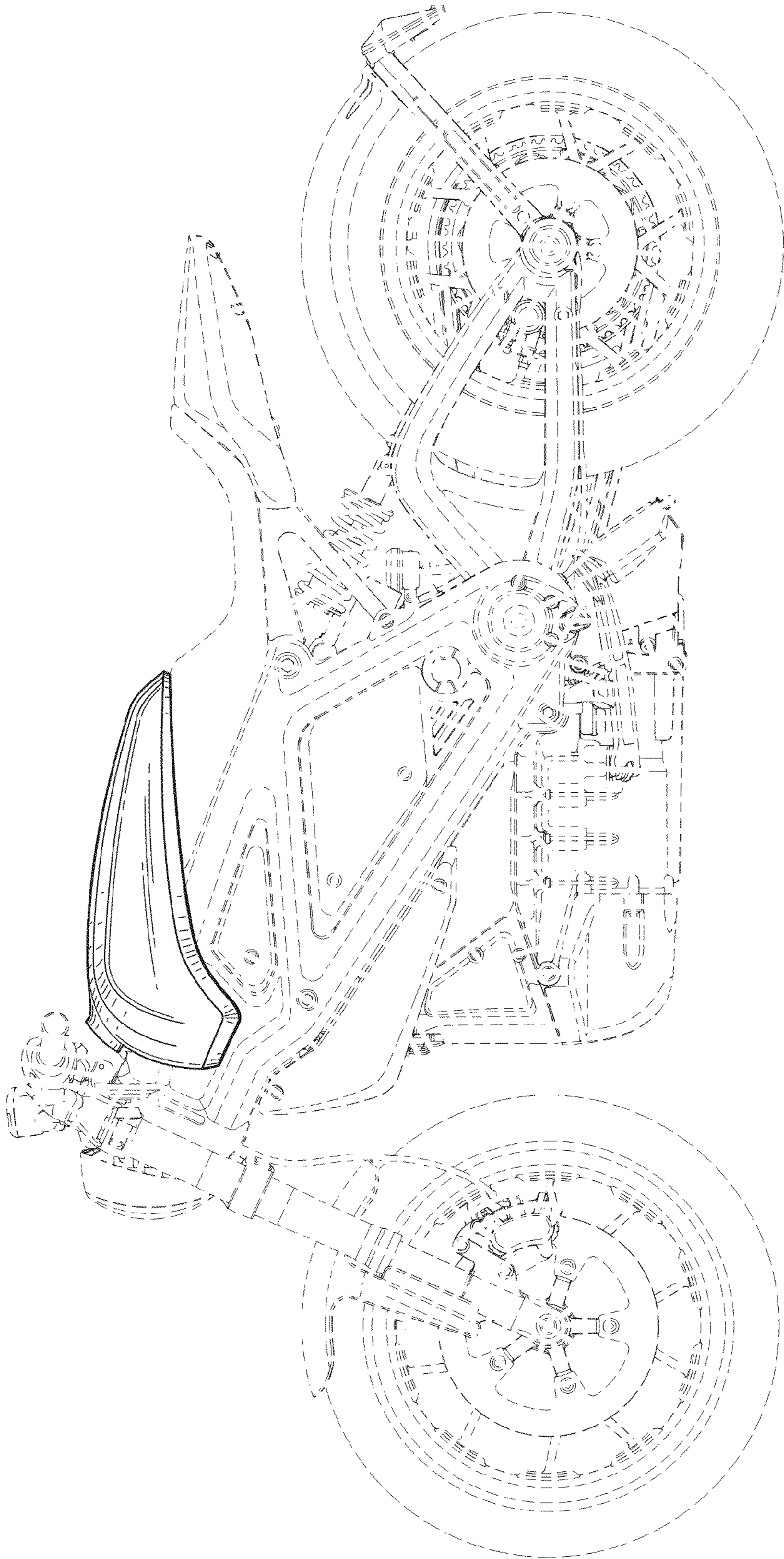

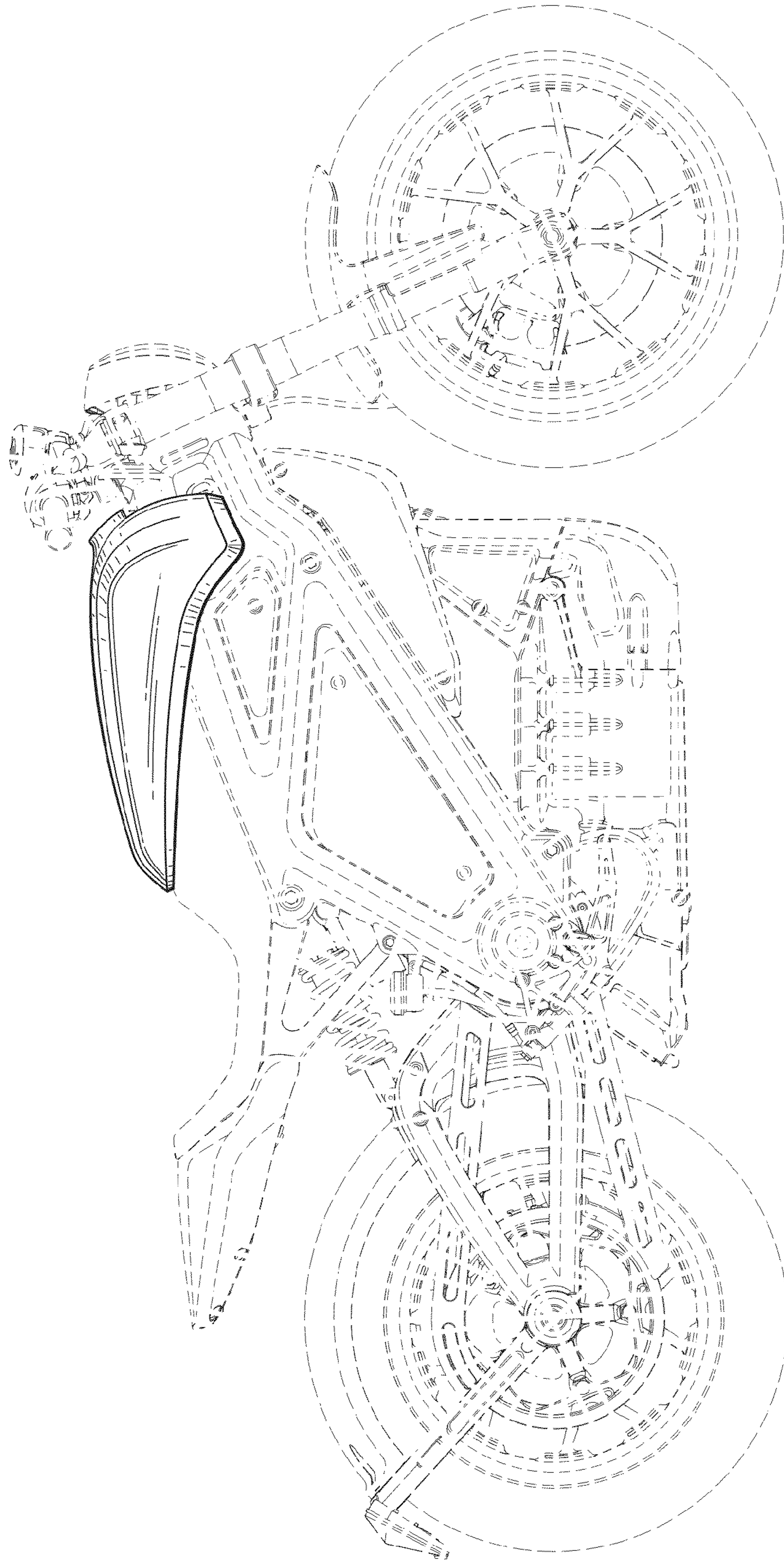

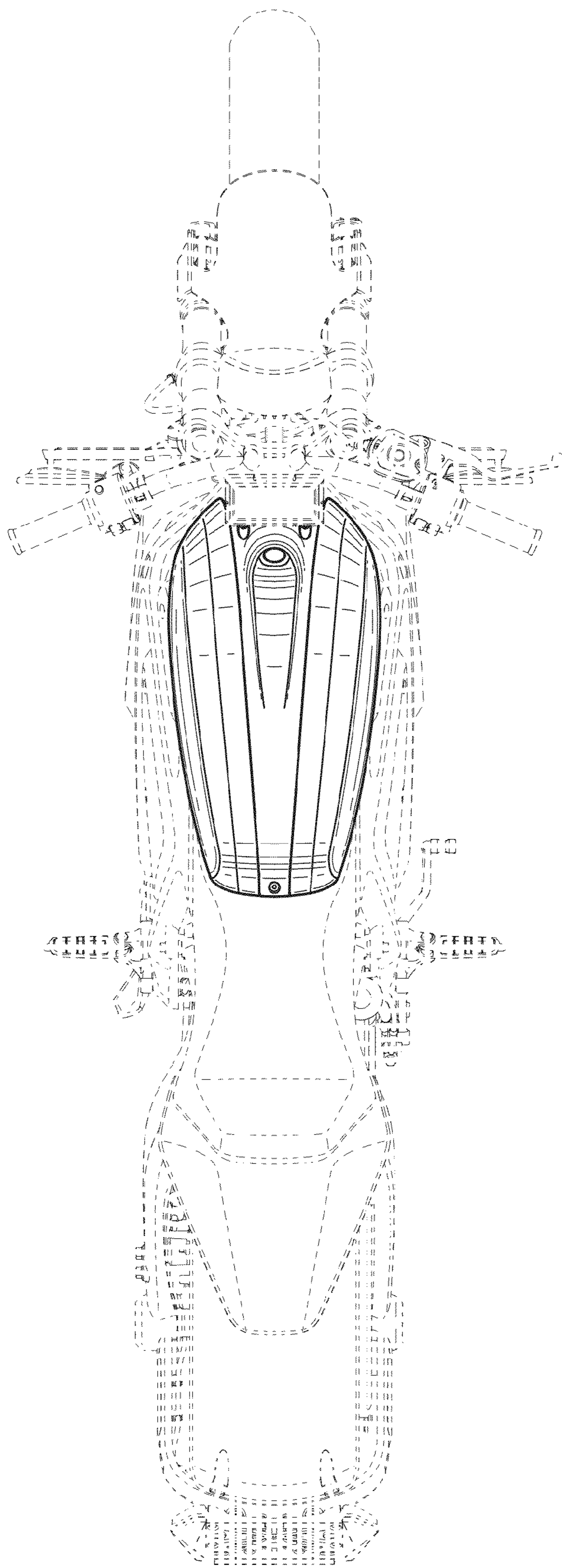
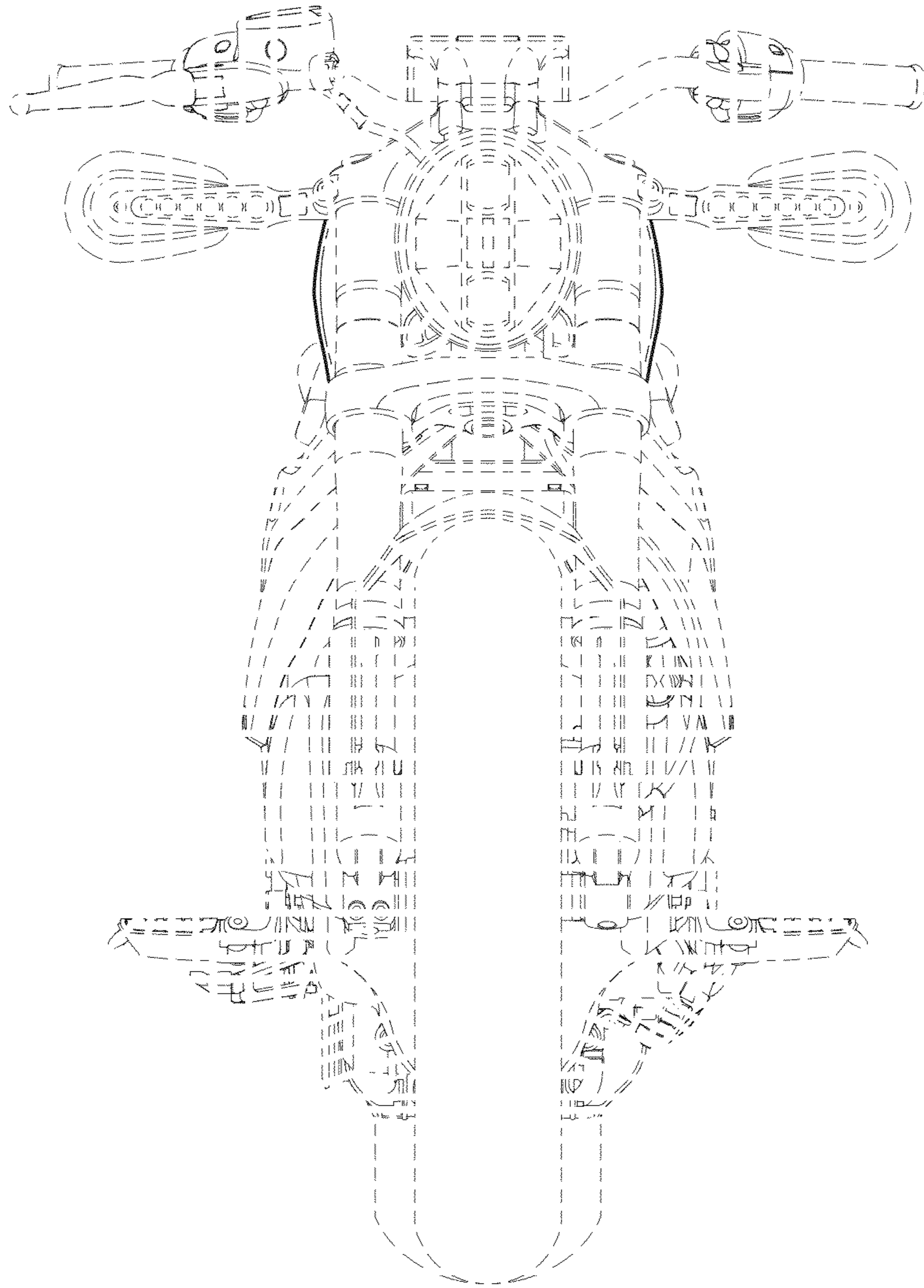
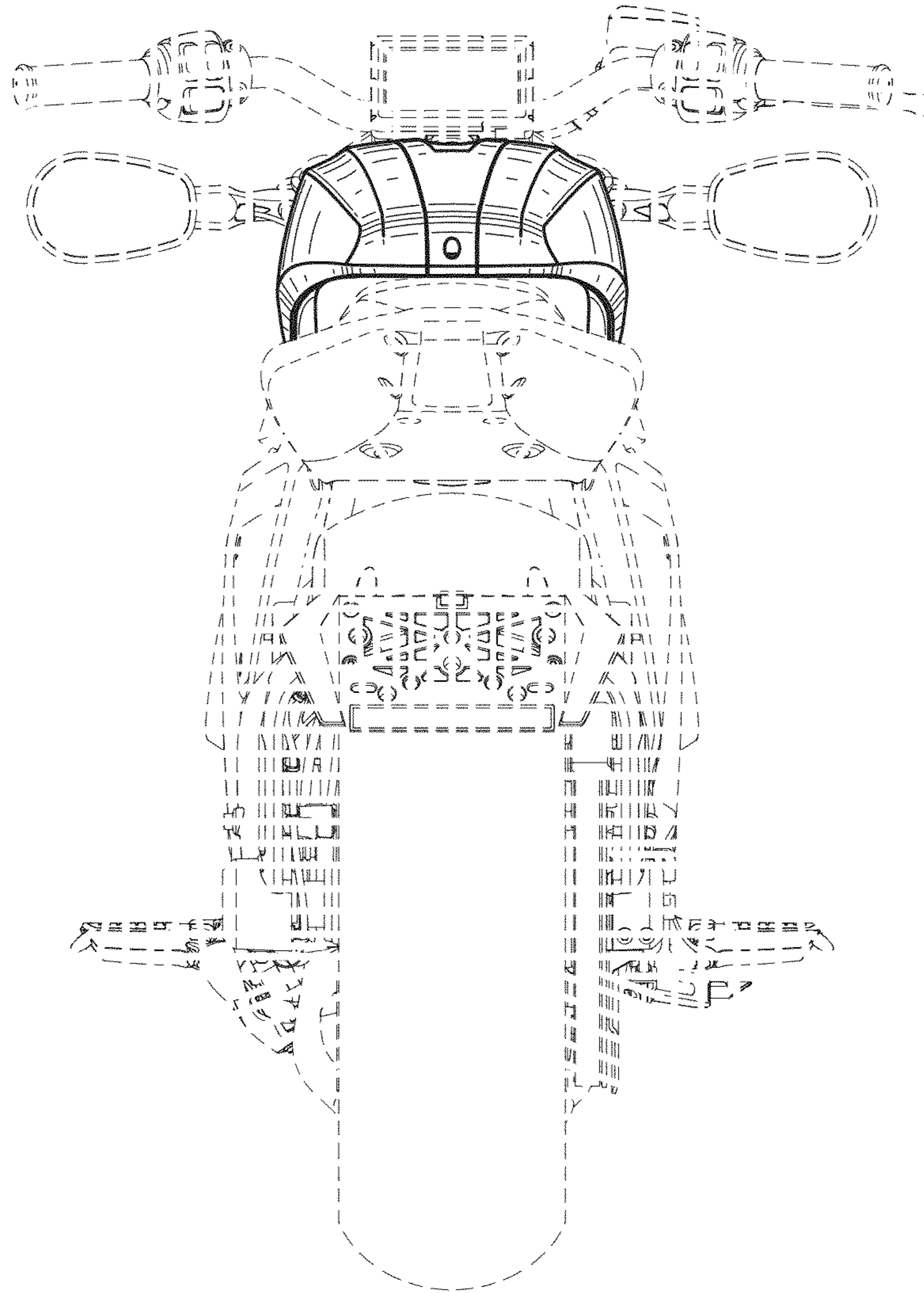

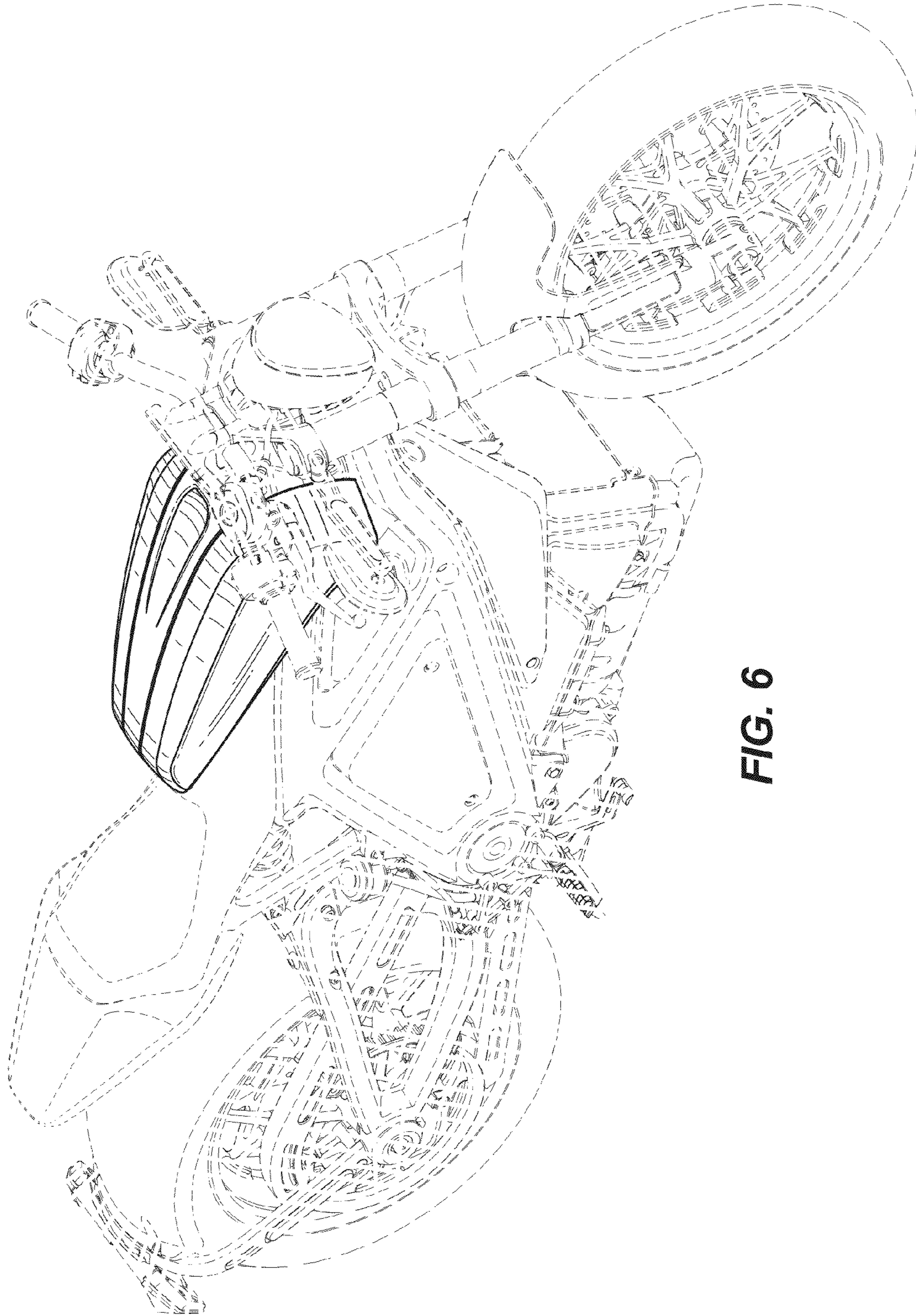
