(57) **CLAIM**

The ornamental design for a display screen with graphical user interface, as shown and described.

**DESCRIPTION**

The FIGURE is a front view of a display screen with graphical user interface showing my new design. The broken line showing of the text, the icons, the remainder of the graphical user interface, and the remainder of the display screen, illustrate portions of the display screen with graphical user interface, and form no part of the claimed design. The broken line showing of an electronic device is for the purpose of illustrating environmental structure, and forms no part of the claimed design.
