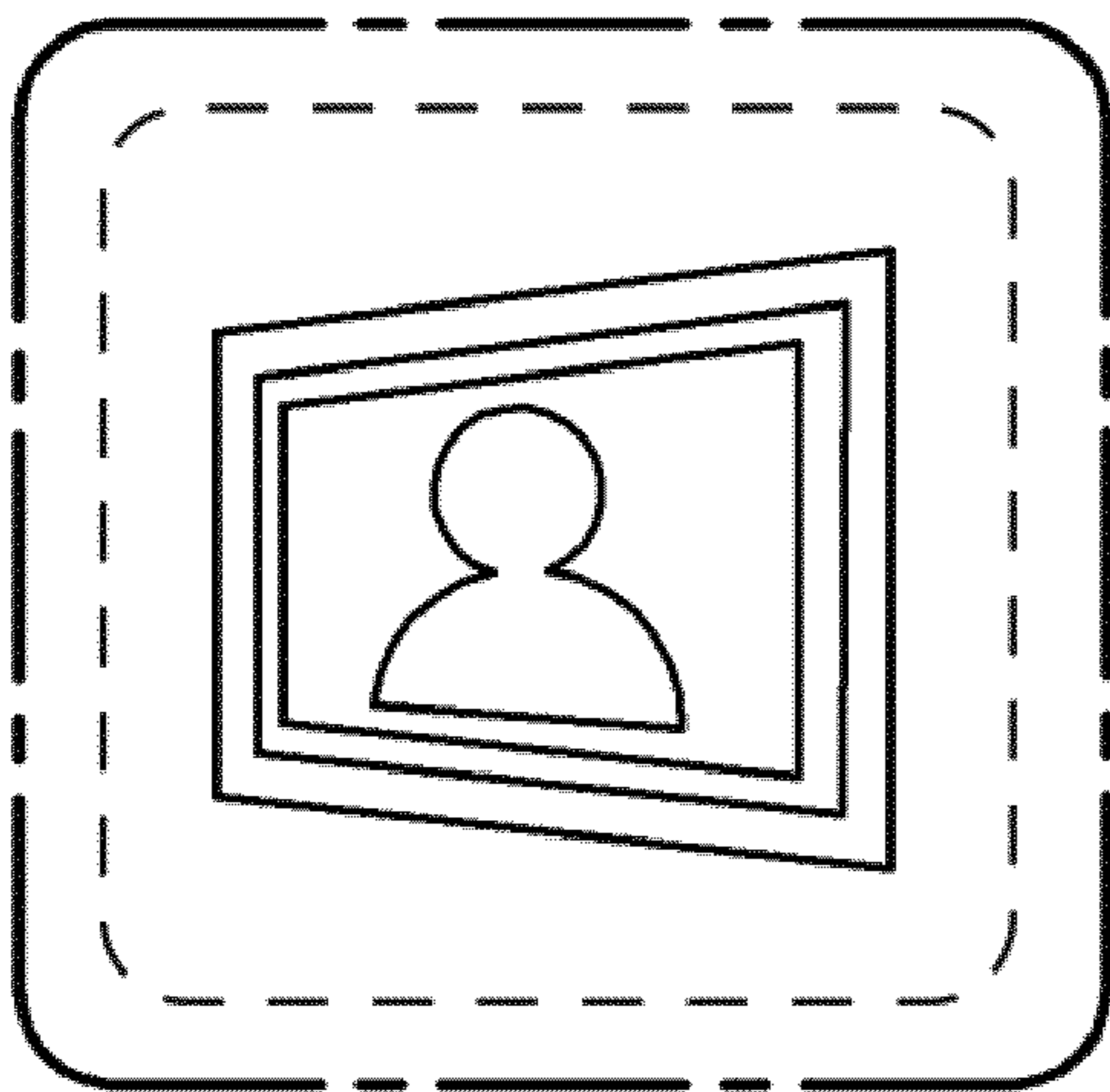
(57) **CLAIM**

The ornamental design for a display screen or portion thereof with icon, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with icon, showing my new design;
FIG. 2 is front view of a display screen or portion thereof with icon showing a second embodiment of the new design; and,
FIG. 3 is front view of a display screen or portion thereof with icon showing a third embodiment of the new design.
The dash-dot broken line around the figures represents a display screen or portion thereof and forms no part of the claimed design. The dash-dash broken lines within the dash-dot broken line in FIGS. 1 and 2 show portions of the display screen or portion thereof with icon that form no part of the claimed design.

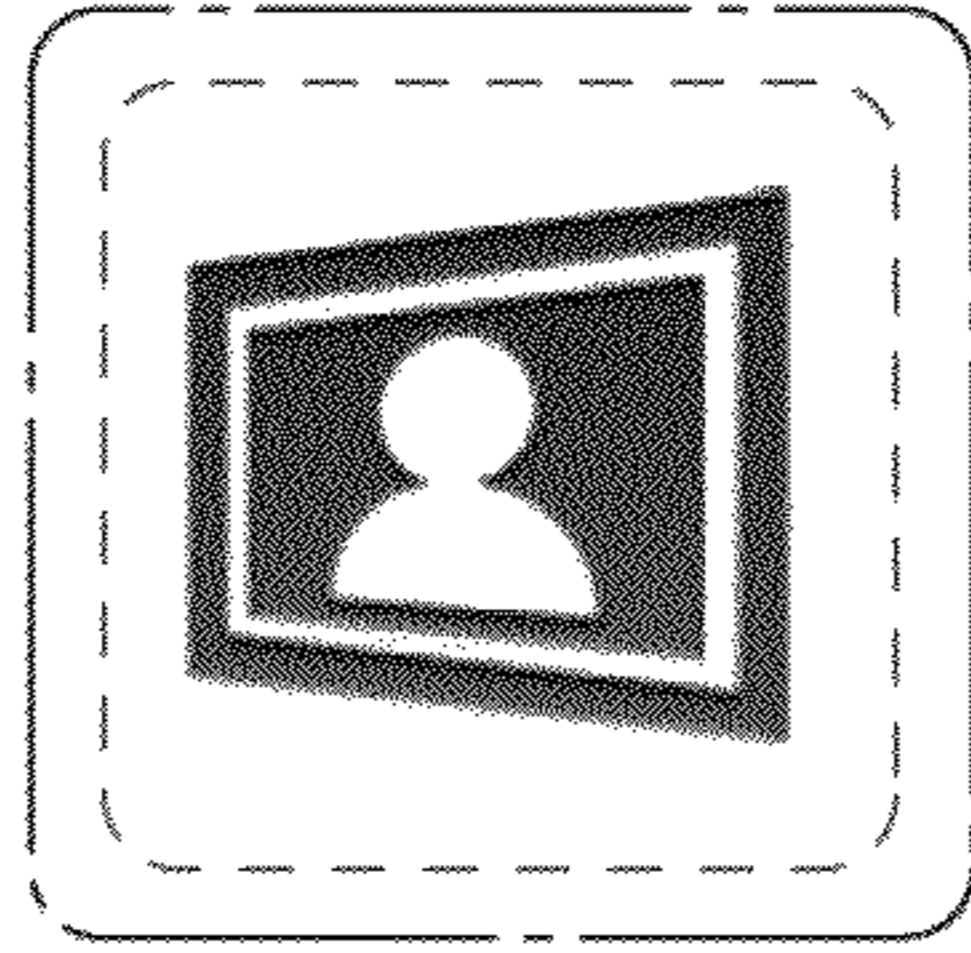

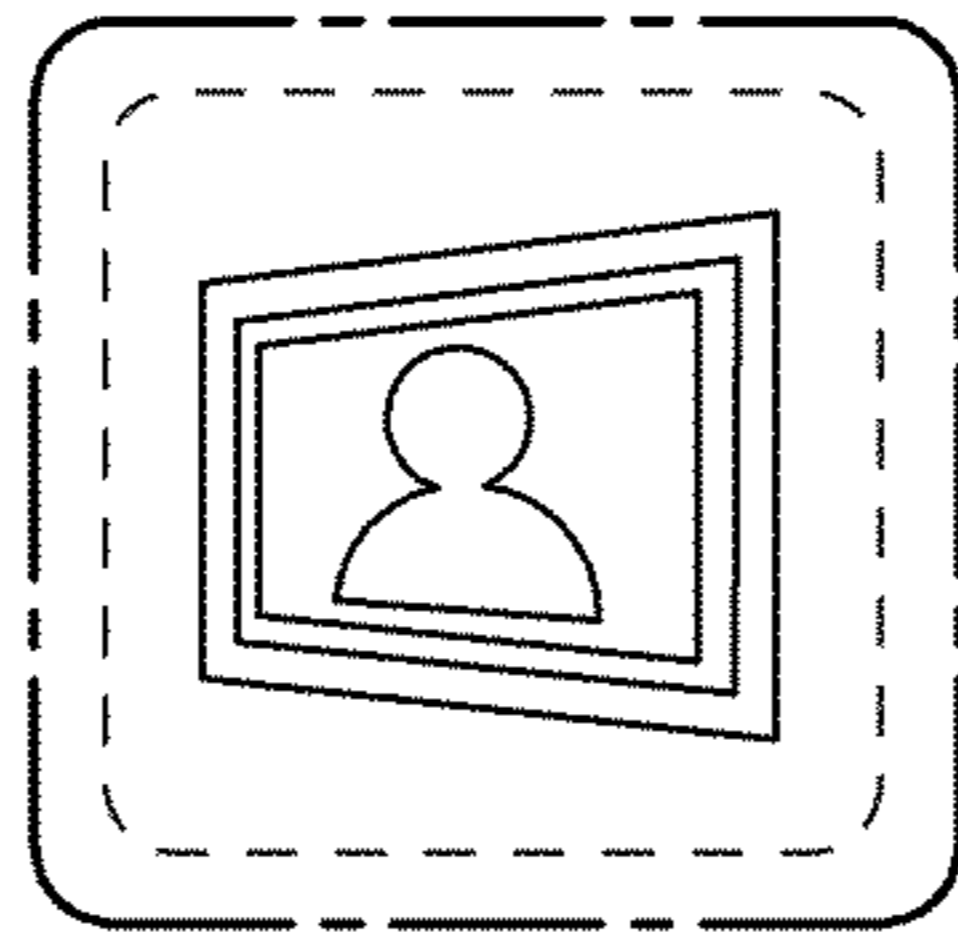

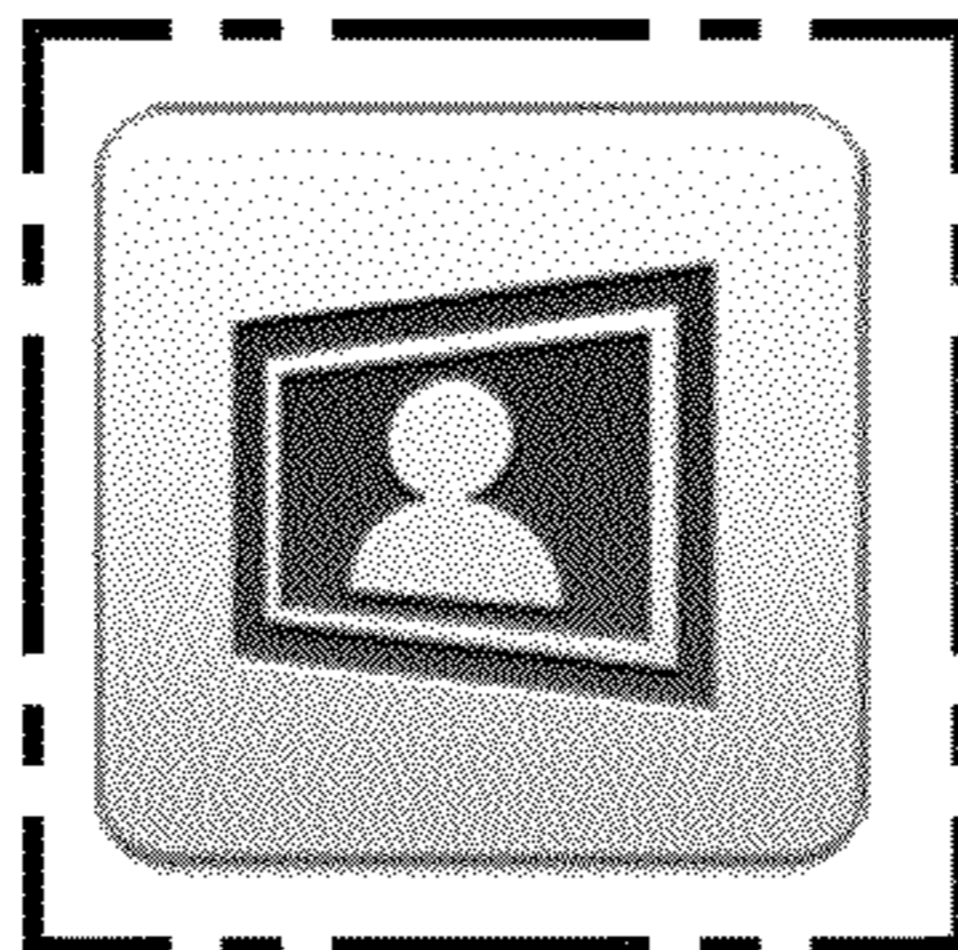
