**DESCRIPTION**

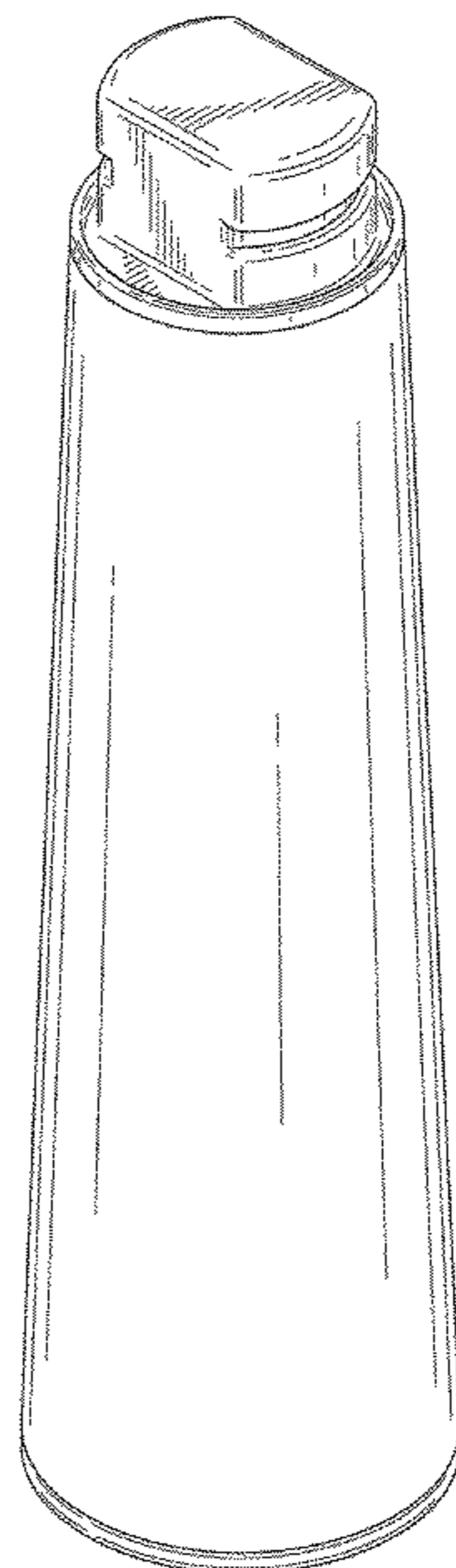
FIG. 1 is a top, front, and right side perspective view of a first

FIG. 14 is a bottom plan thereof.

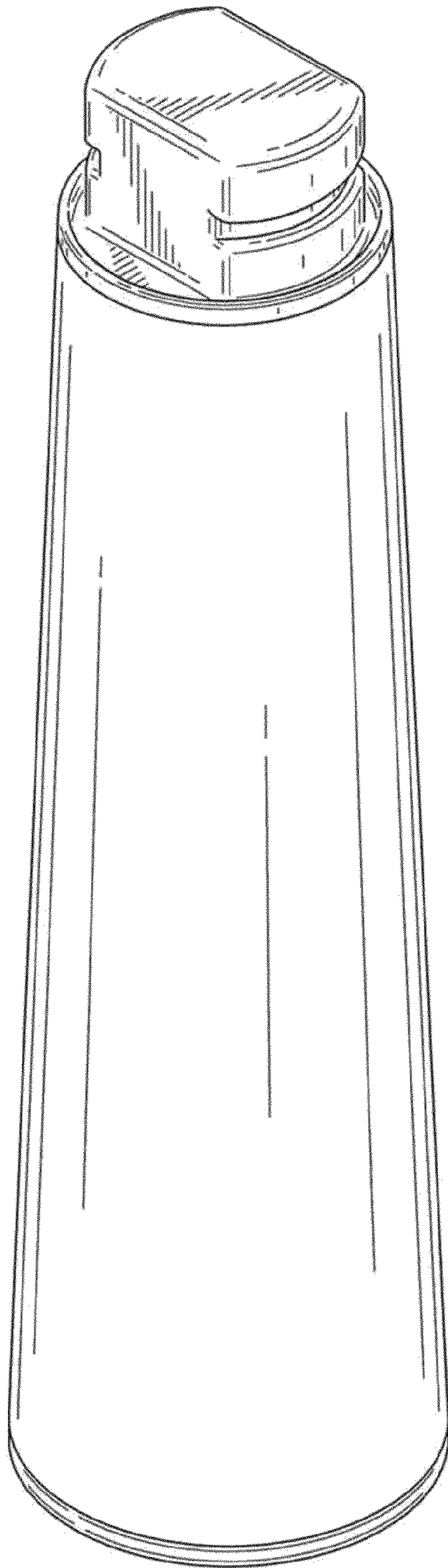

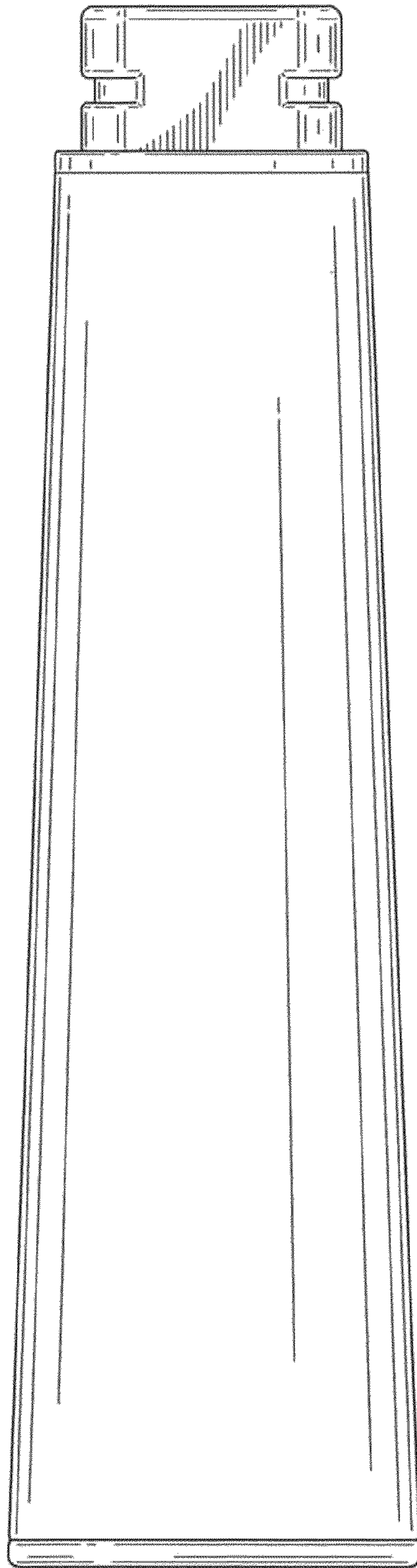

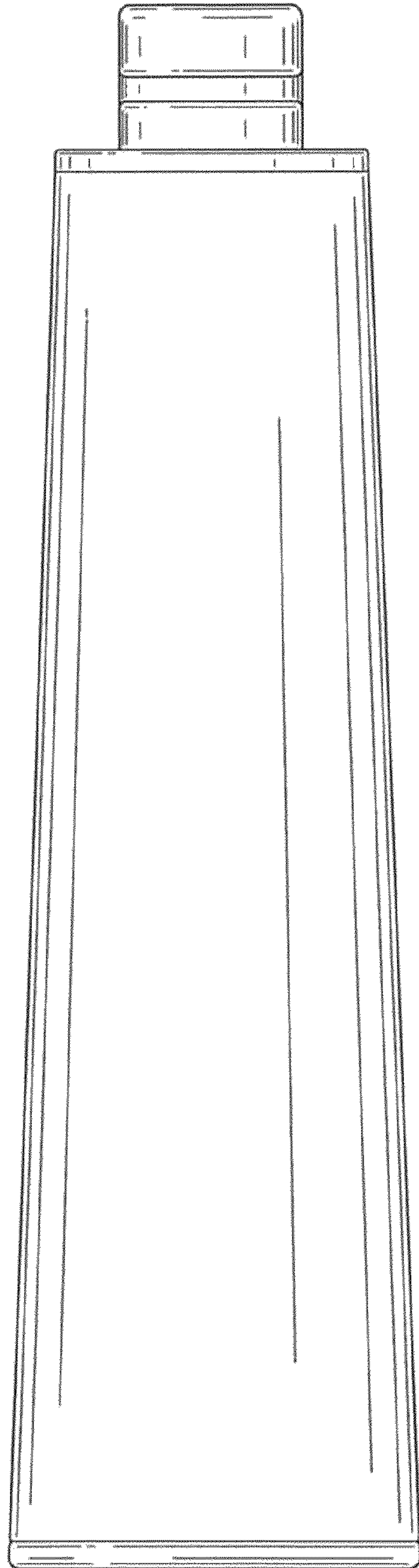

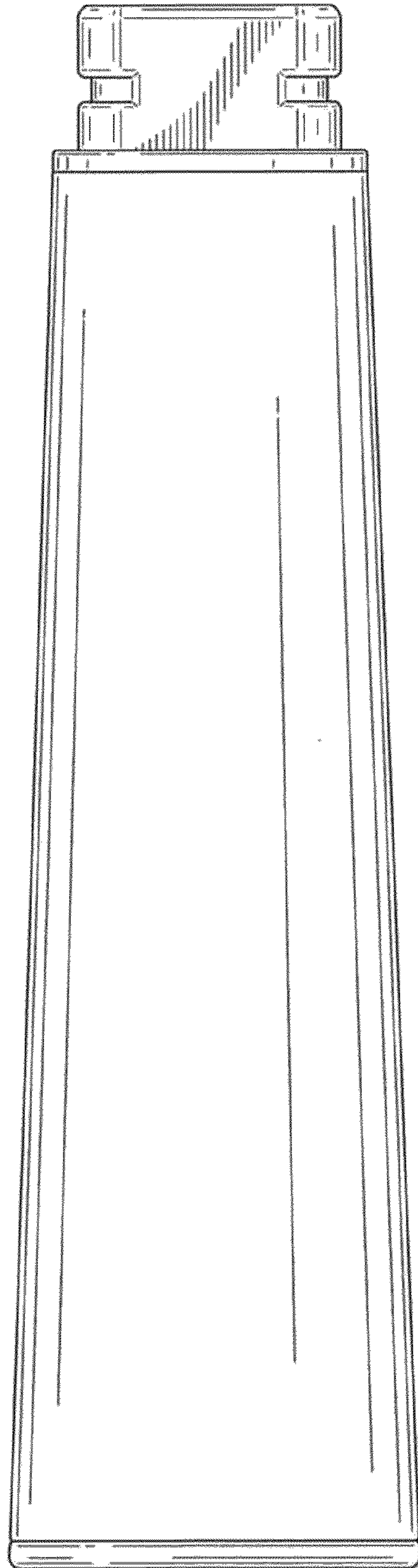

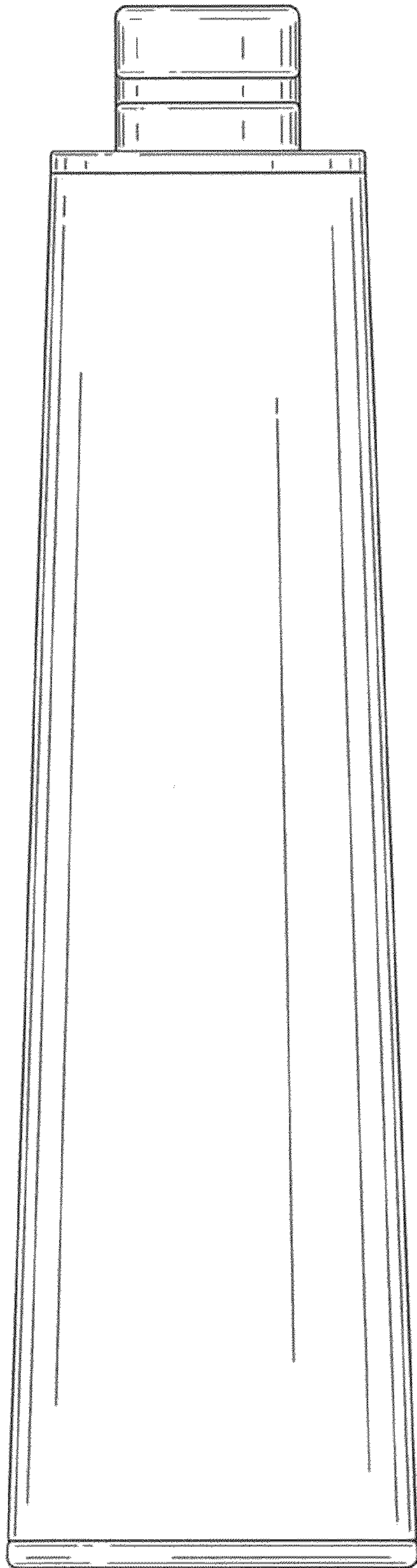

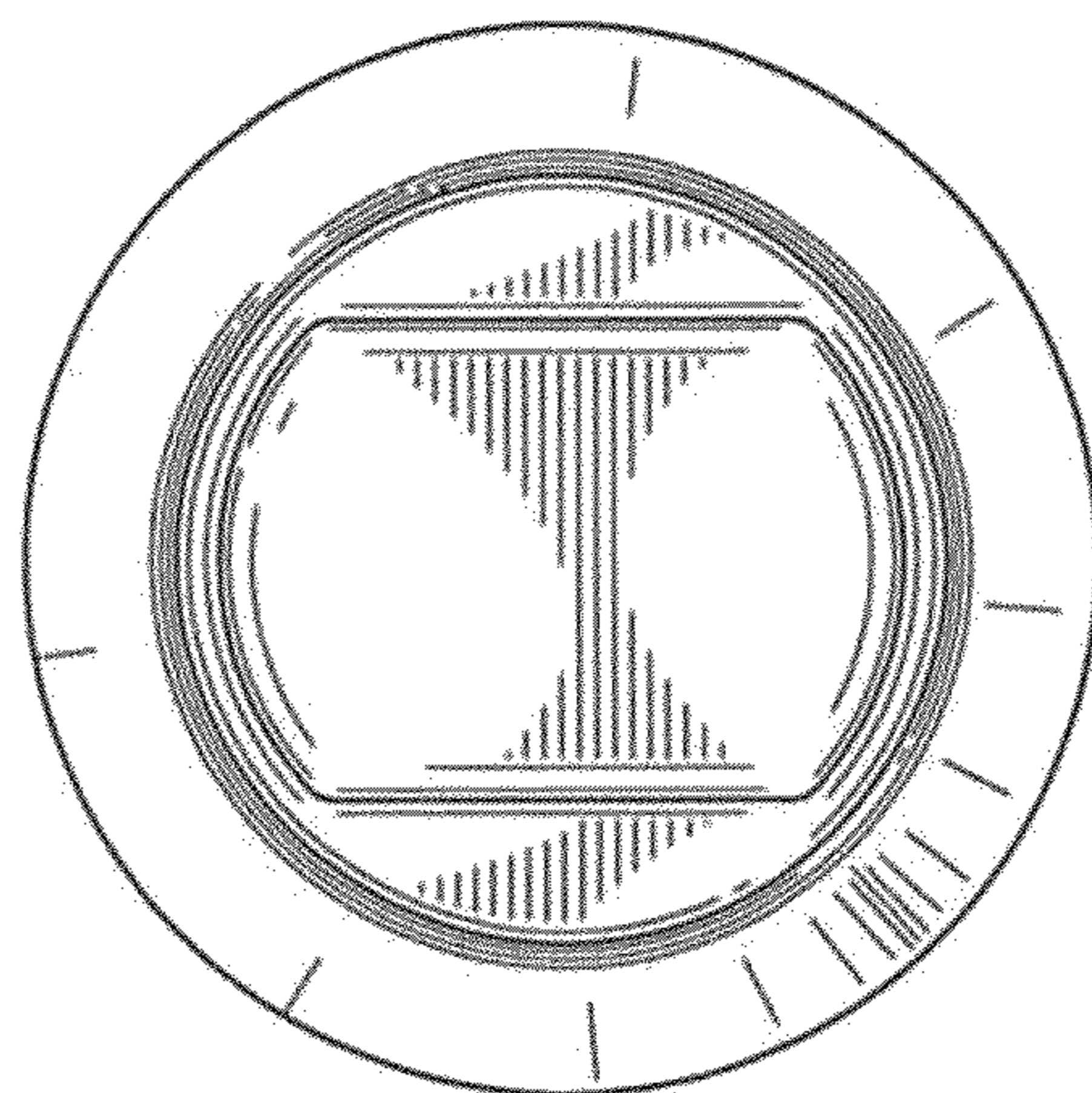

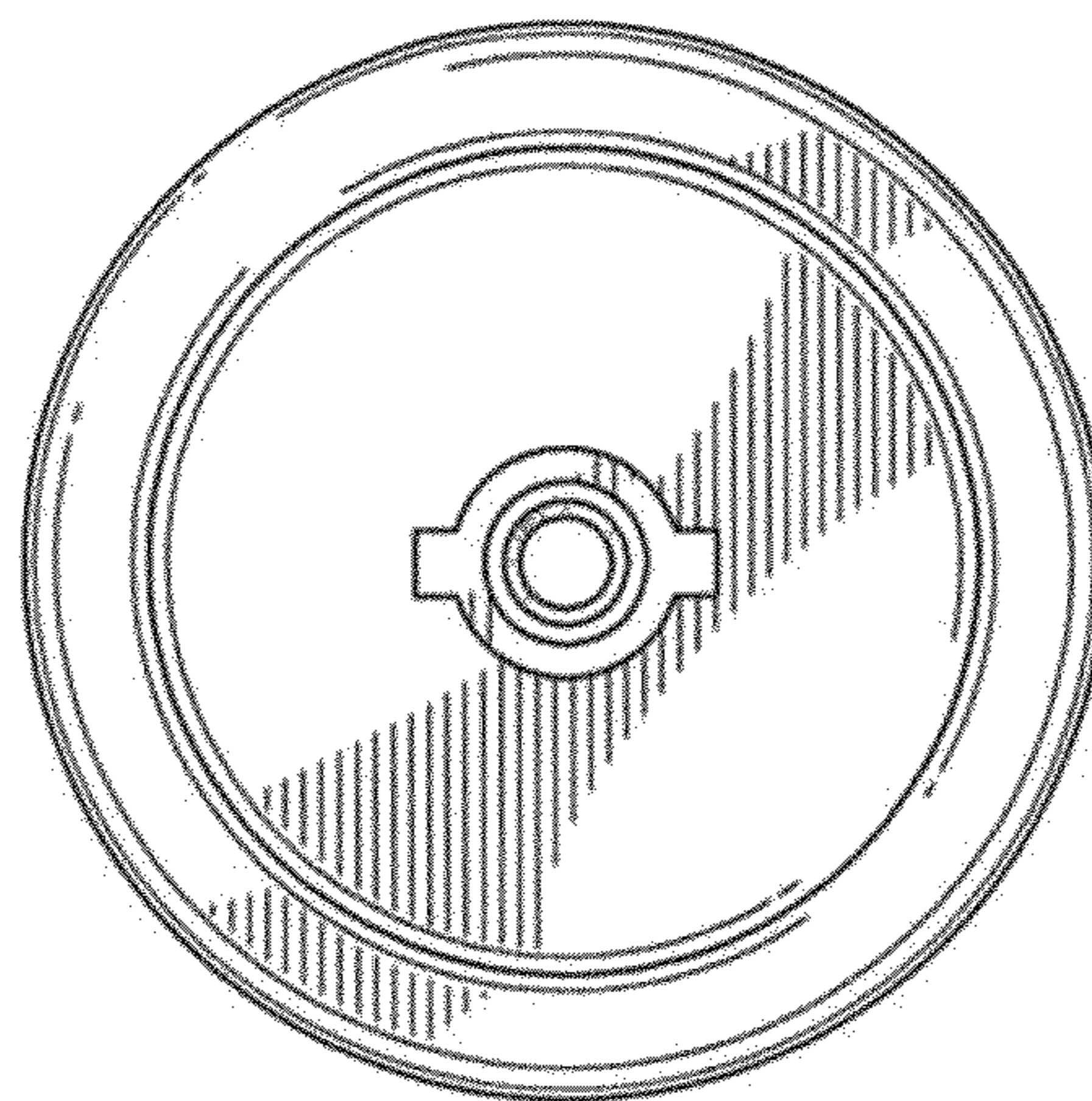

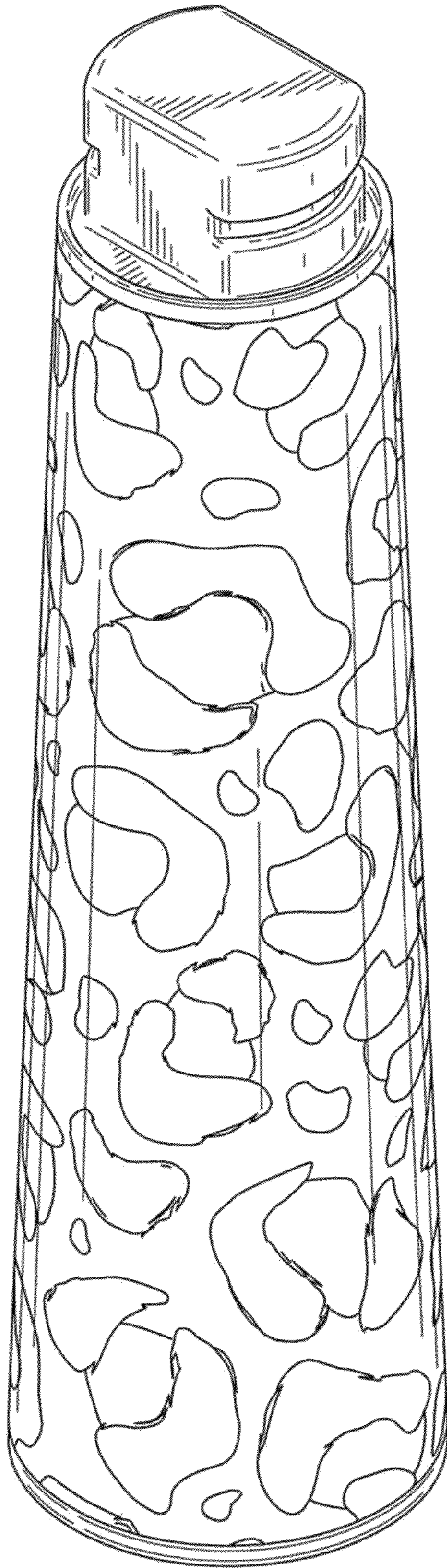

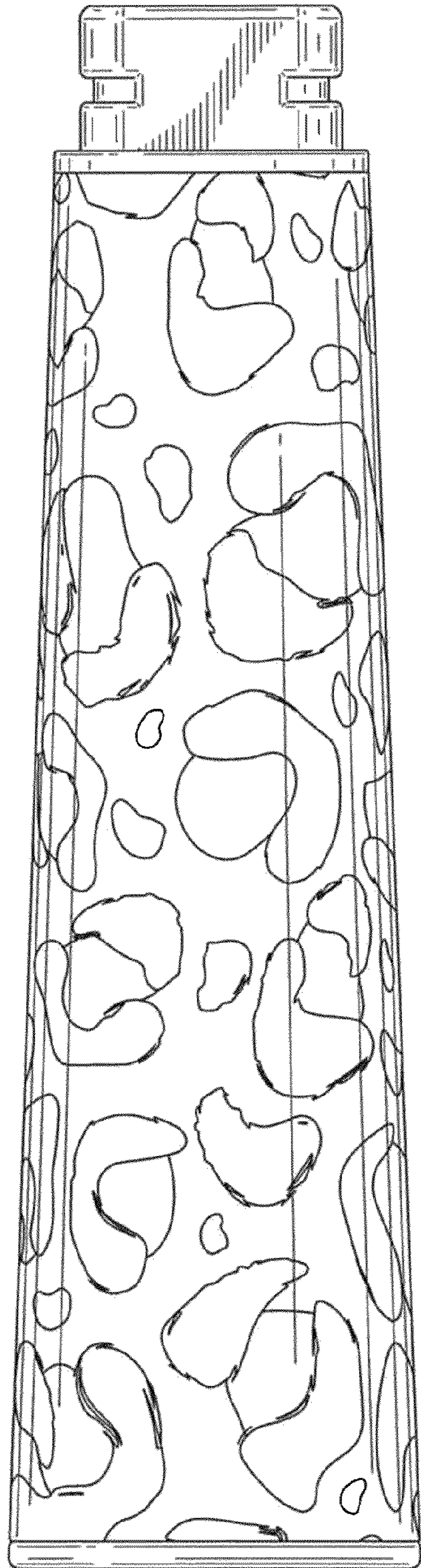

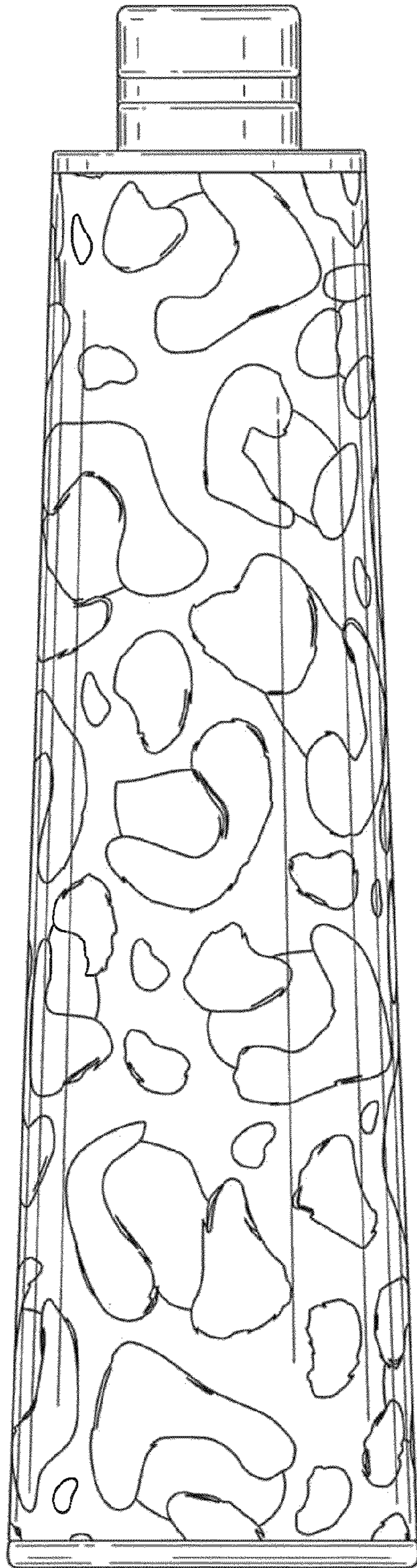

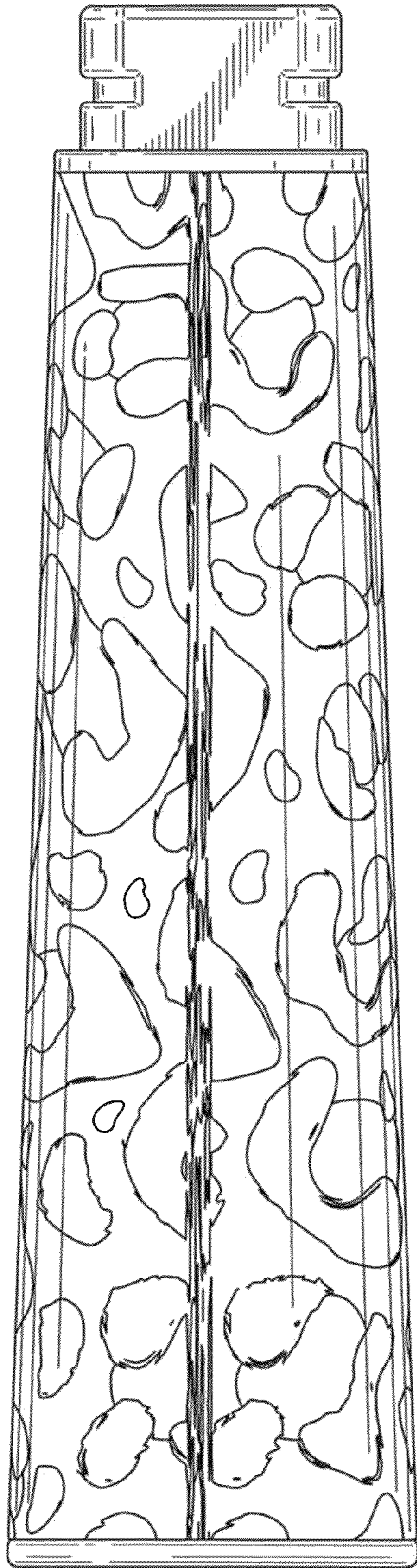

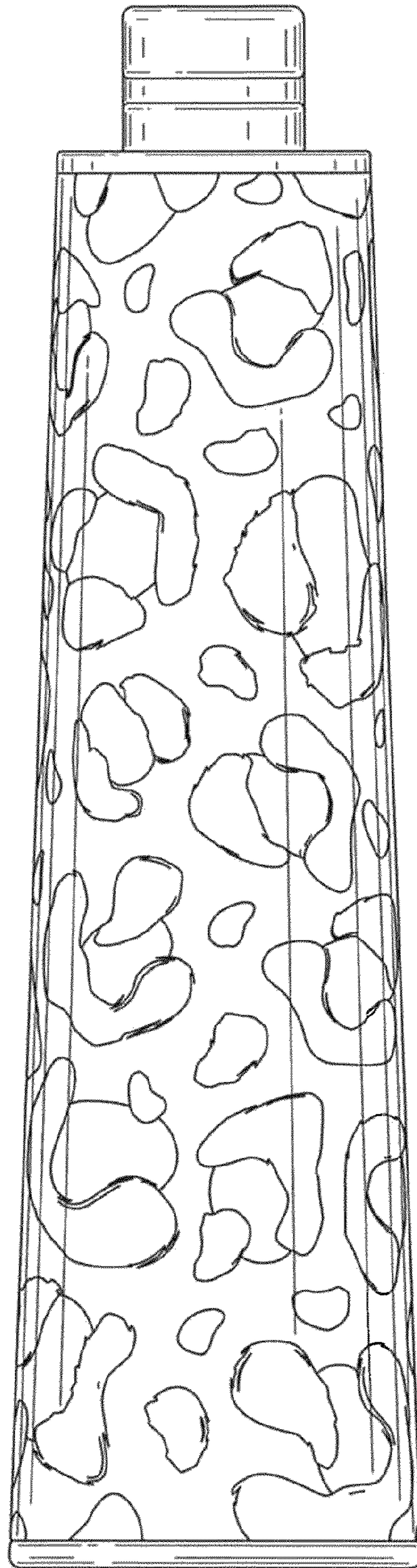

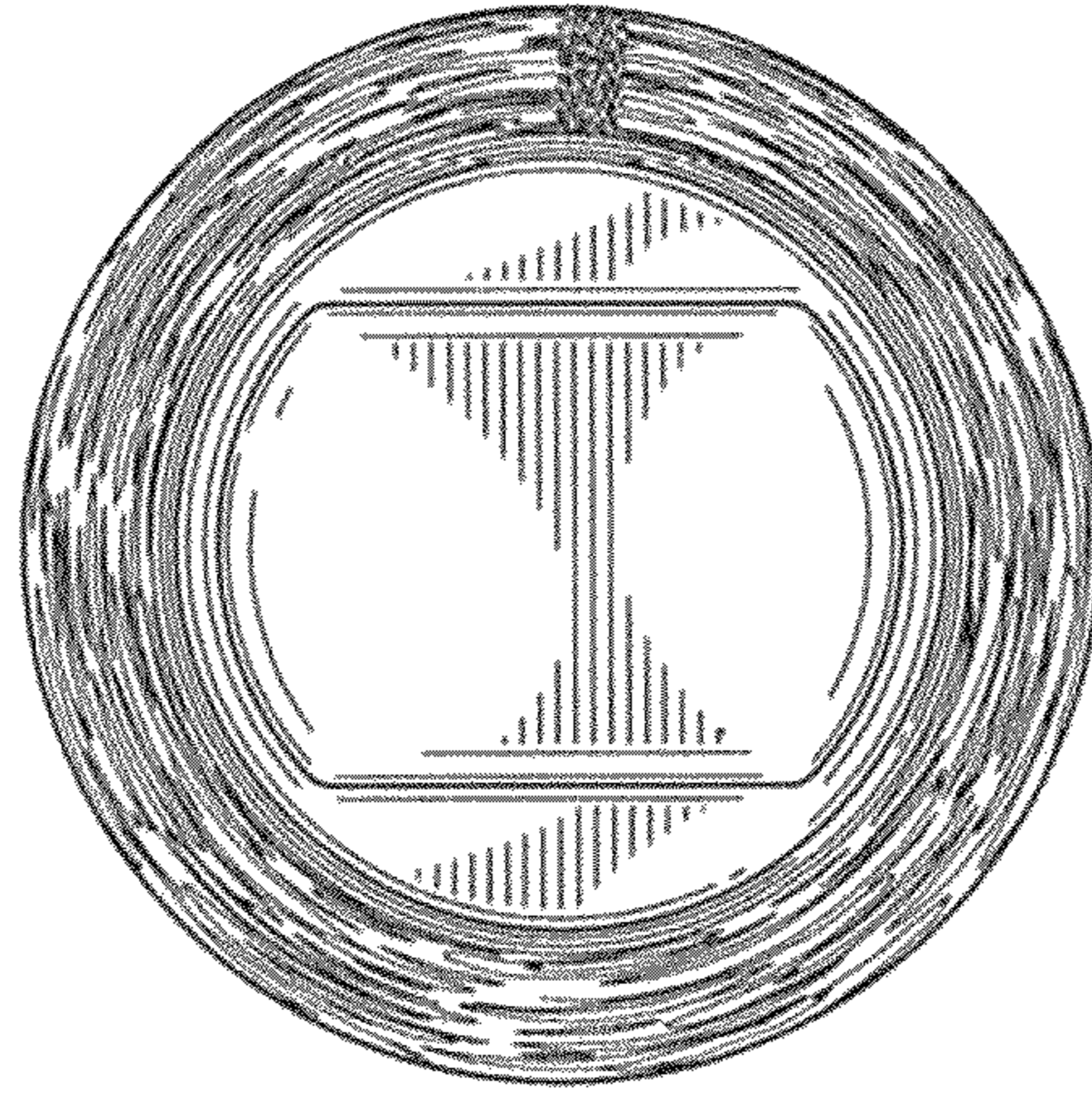

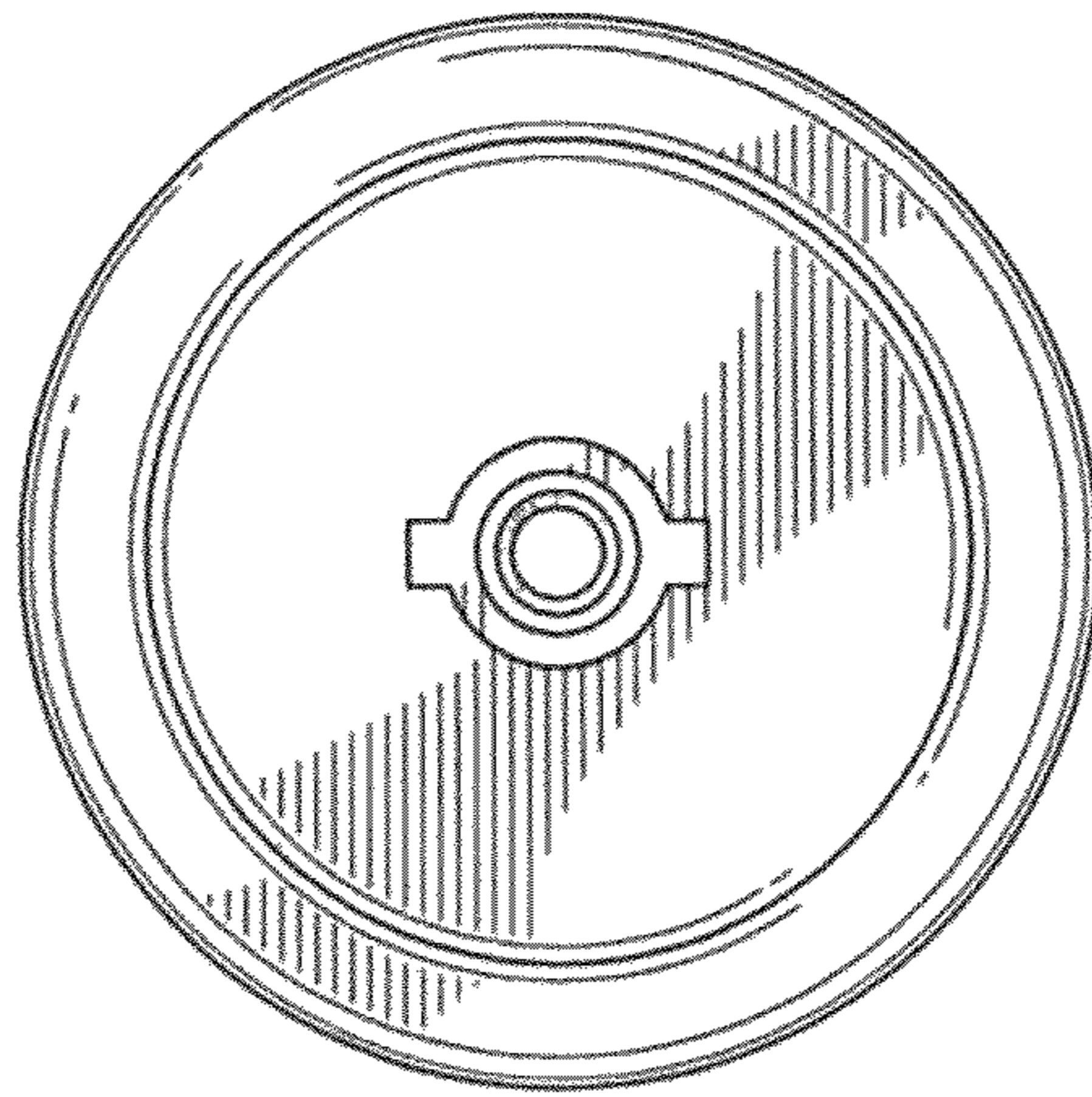
