The ornamental design for a toy car, as shown and described.

DESCRIPTION

FIG. 1 is a front, perspective view of a toy car unit showing my new design;
FIG. 2 is a rear perspective view thereof;

FIG. 4 is a right side elevational view thereof;
FIG. 5 is a front elevational view thereof;
FIG. 6 is a rear elevational view thereof;

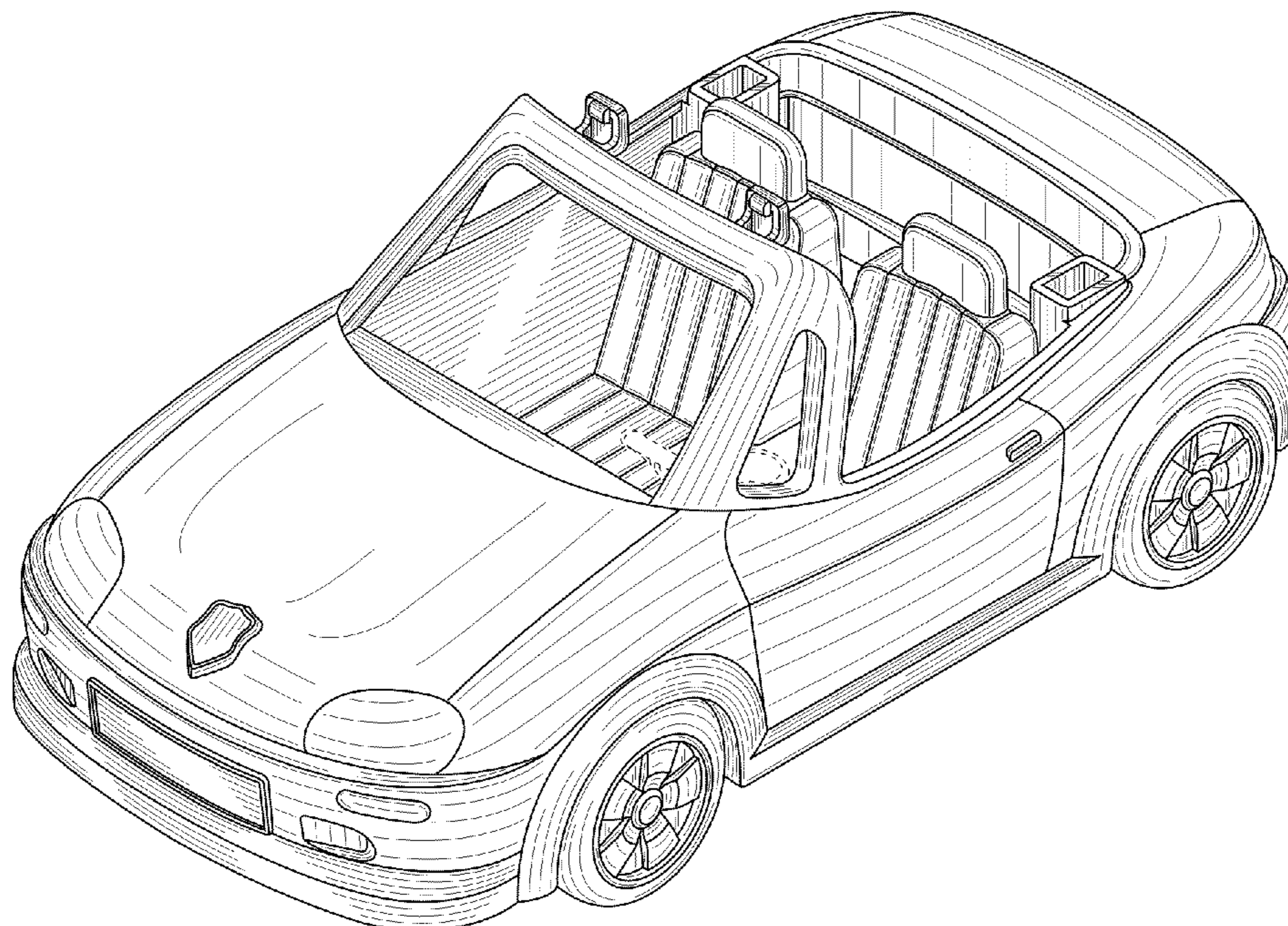

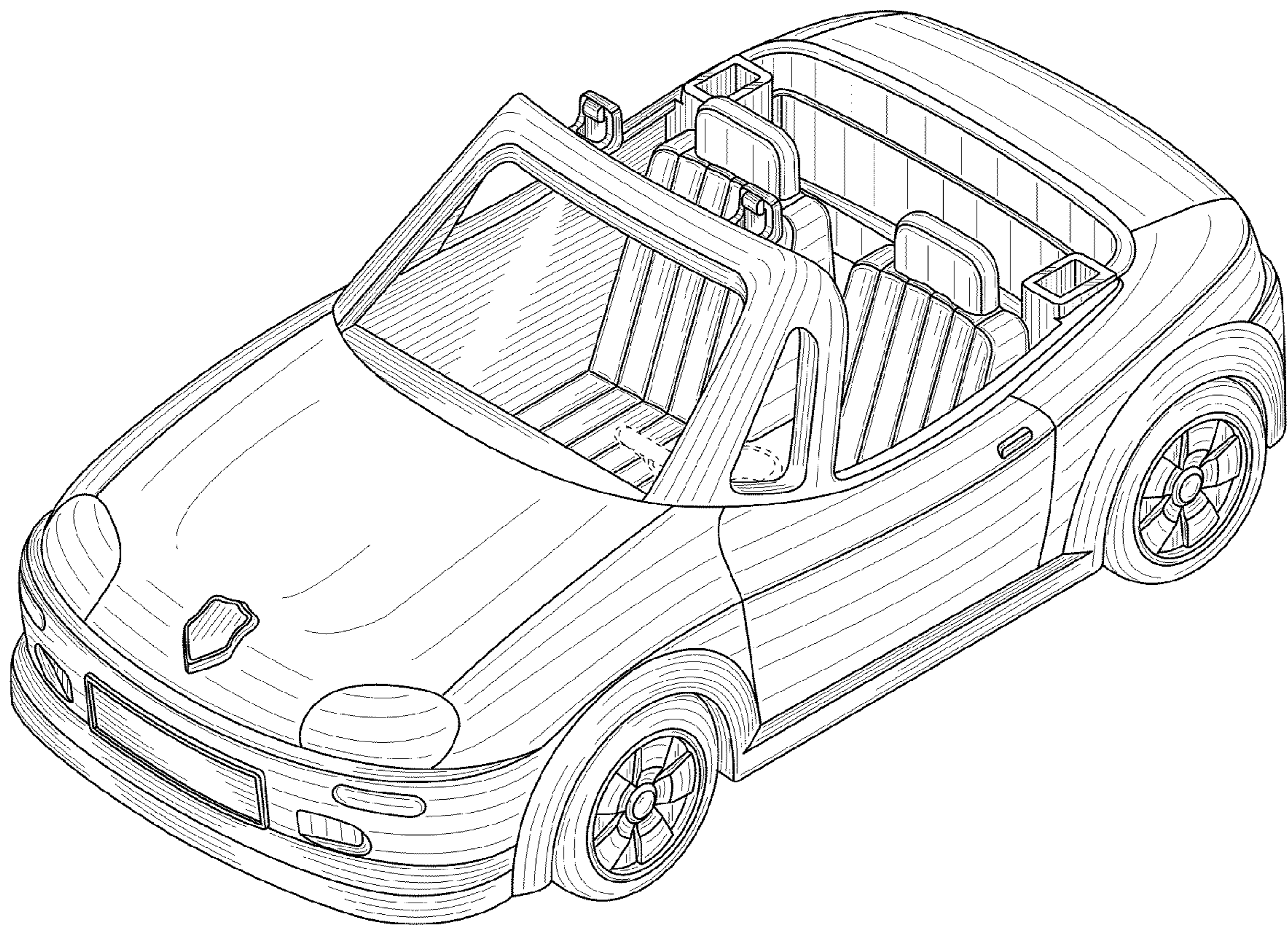

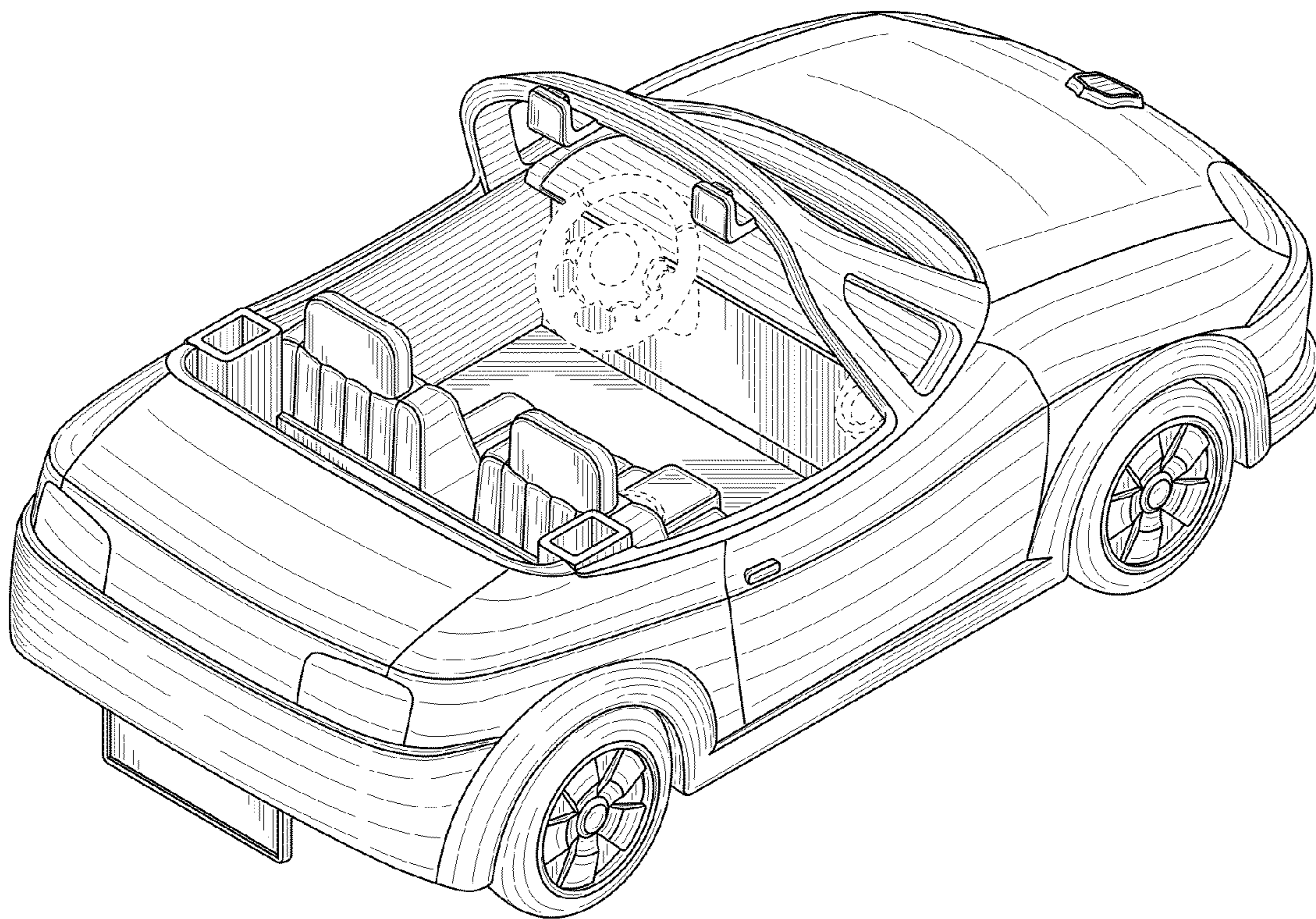

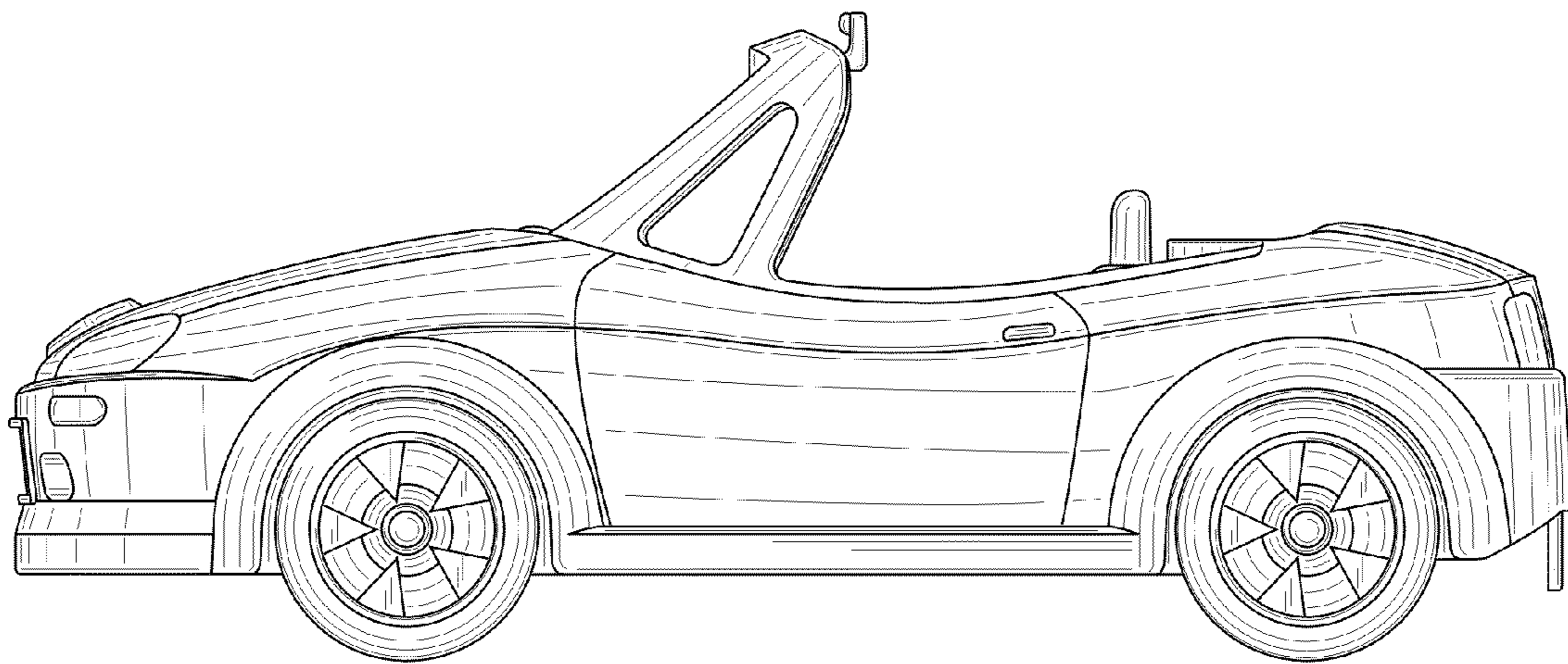

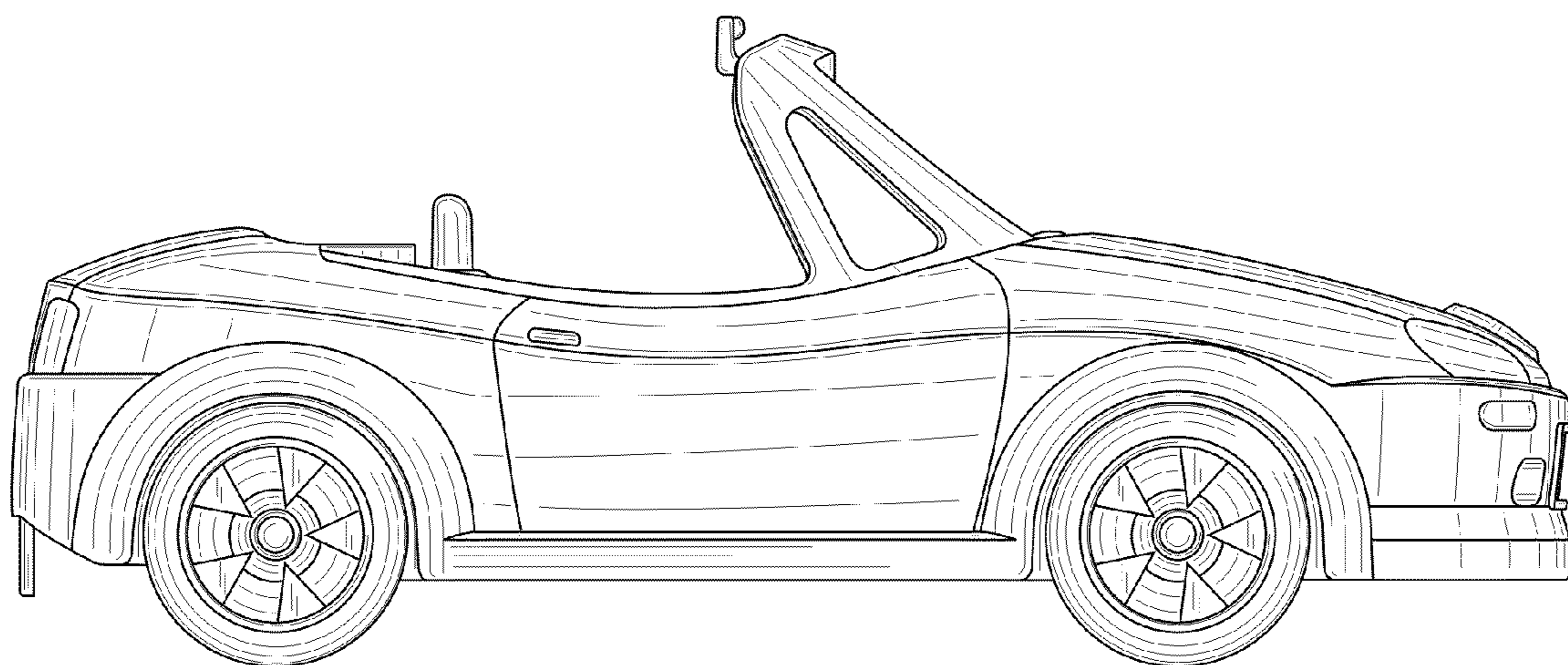

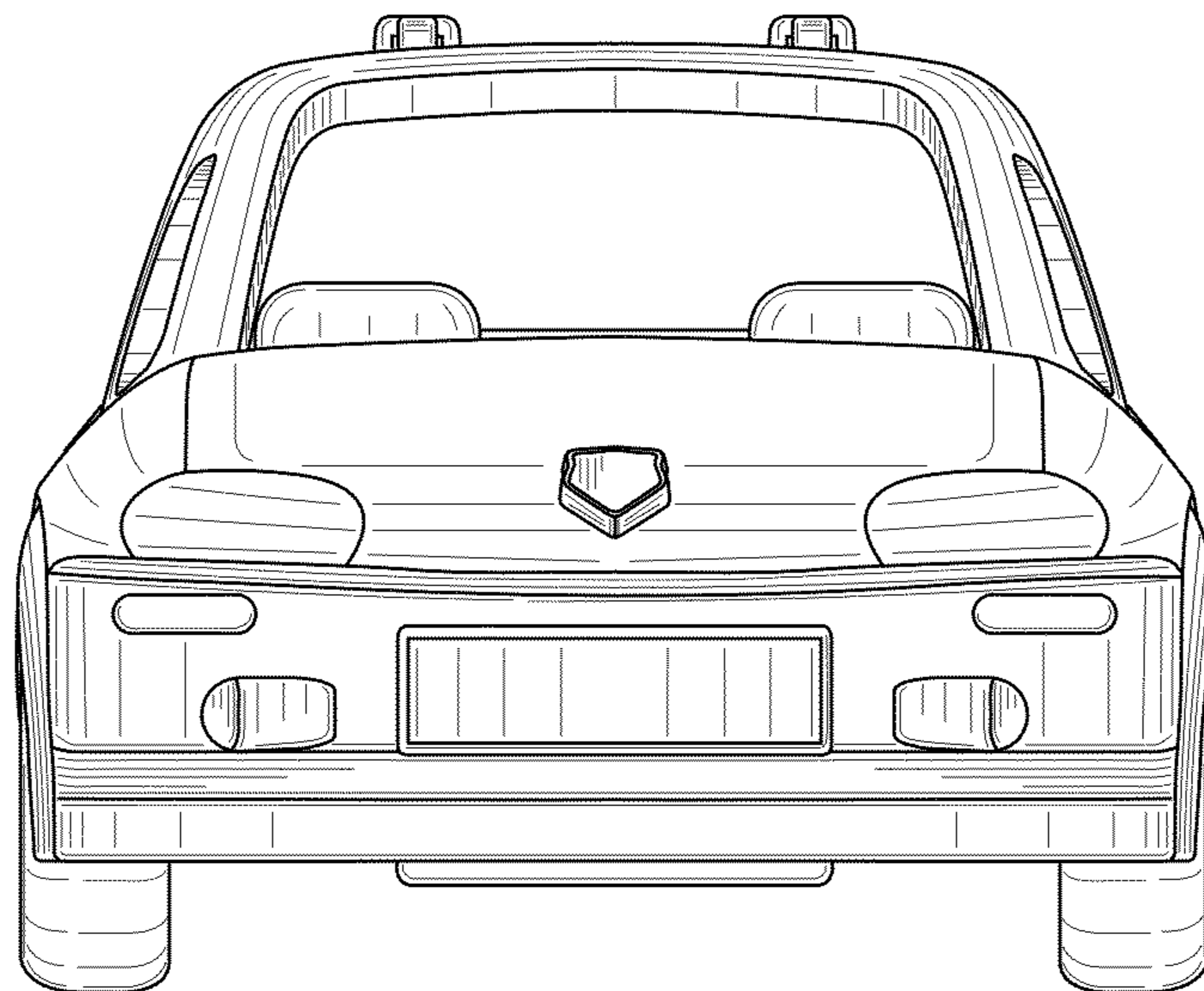

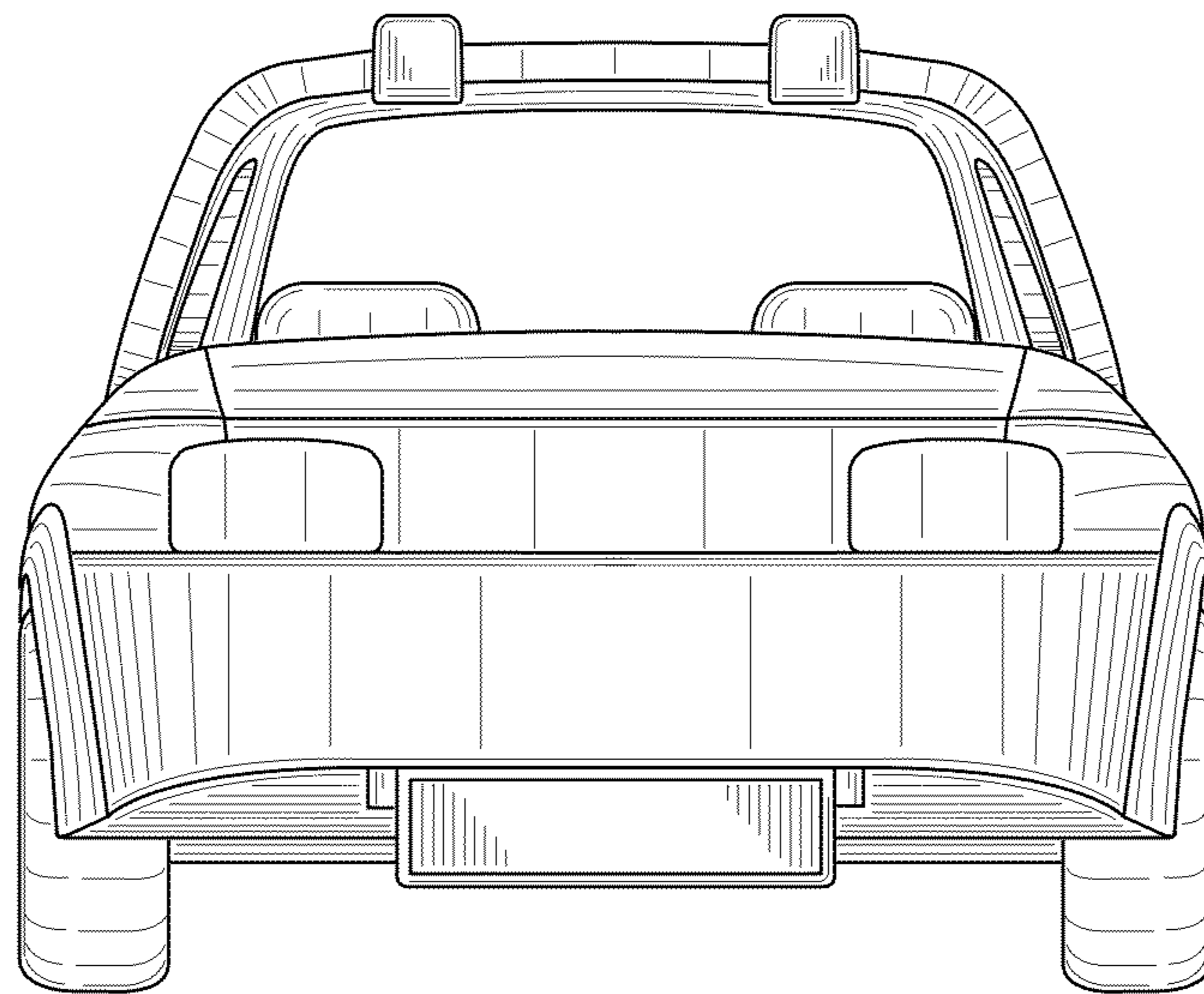

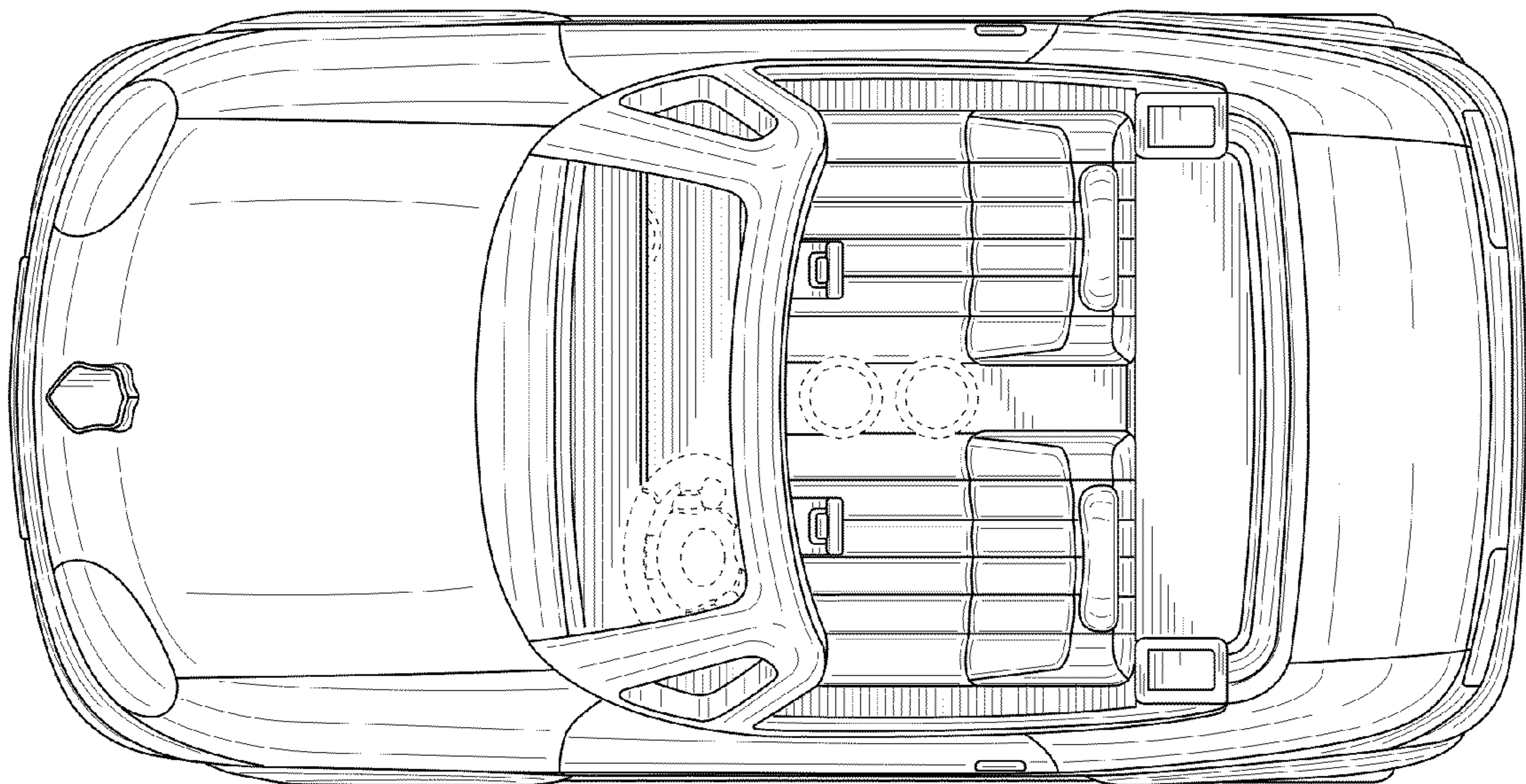

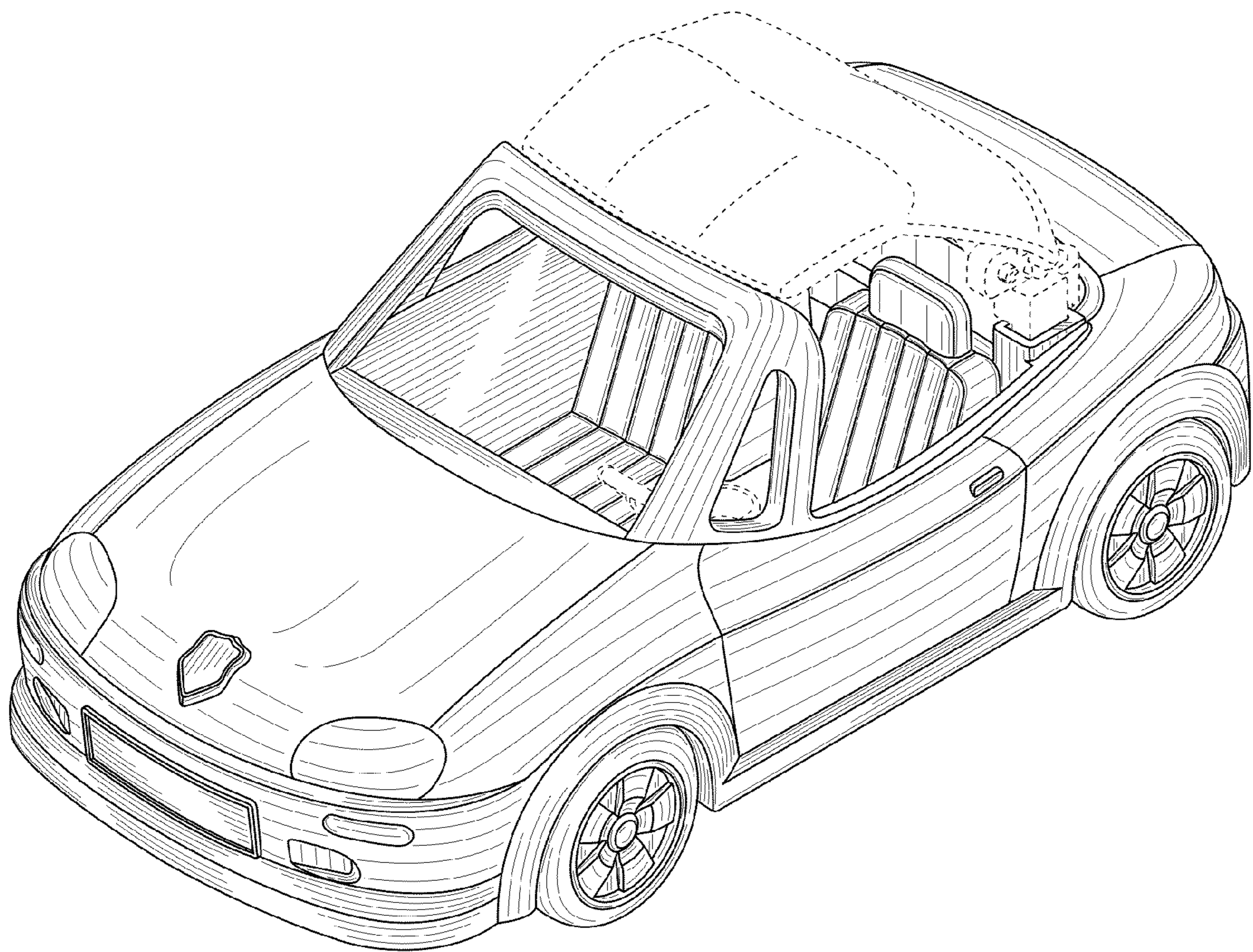
