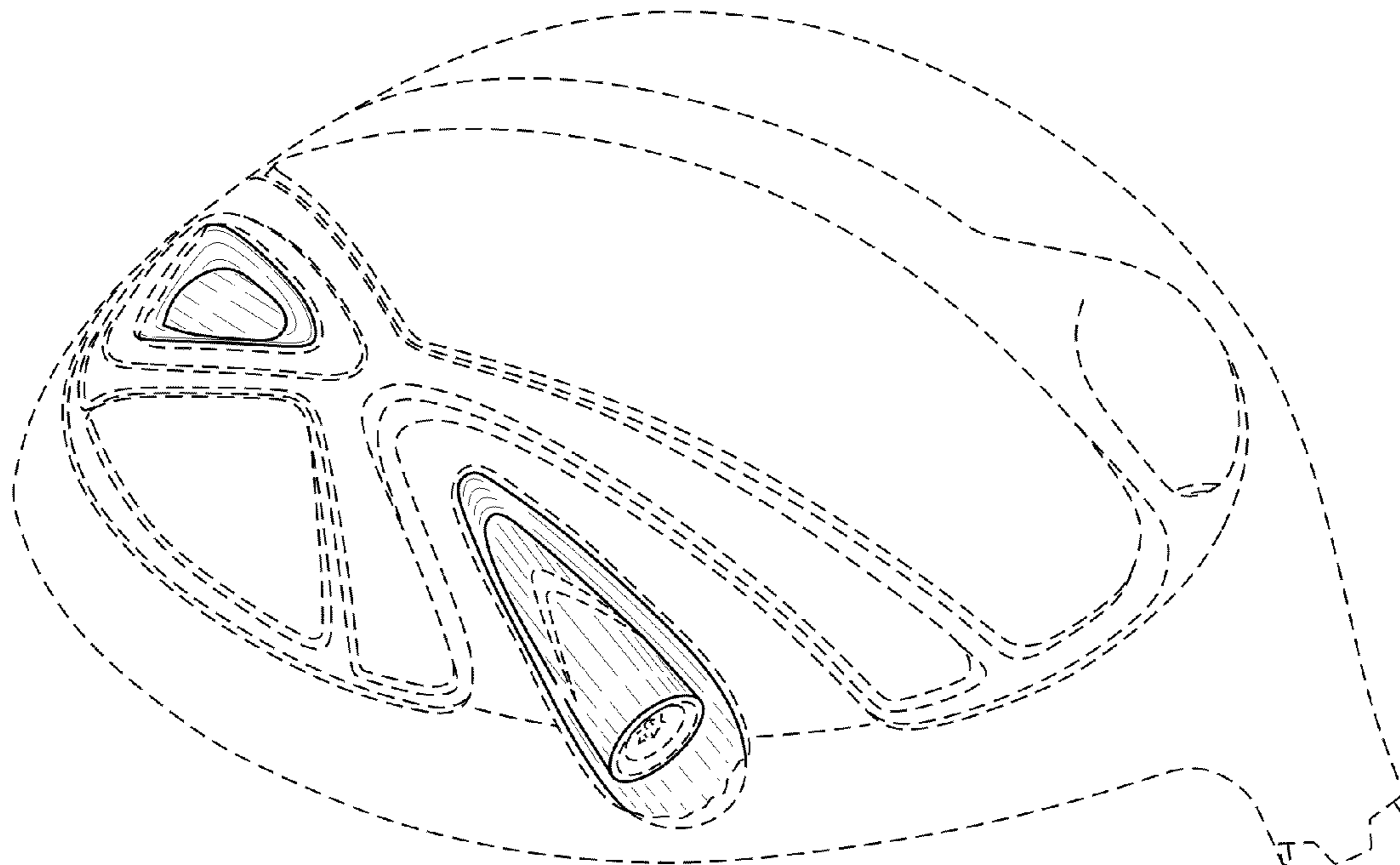
(57) **CLAIM**
The ornamental design for a sole of a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a sole, heel side perspective view of a new design for a sole of a golf club head;
FIG. 2 is a front view thereof;

FIG. 4 is a back view thereof;

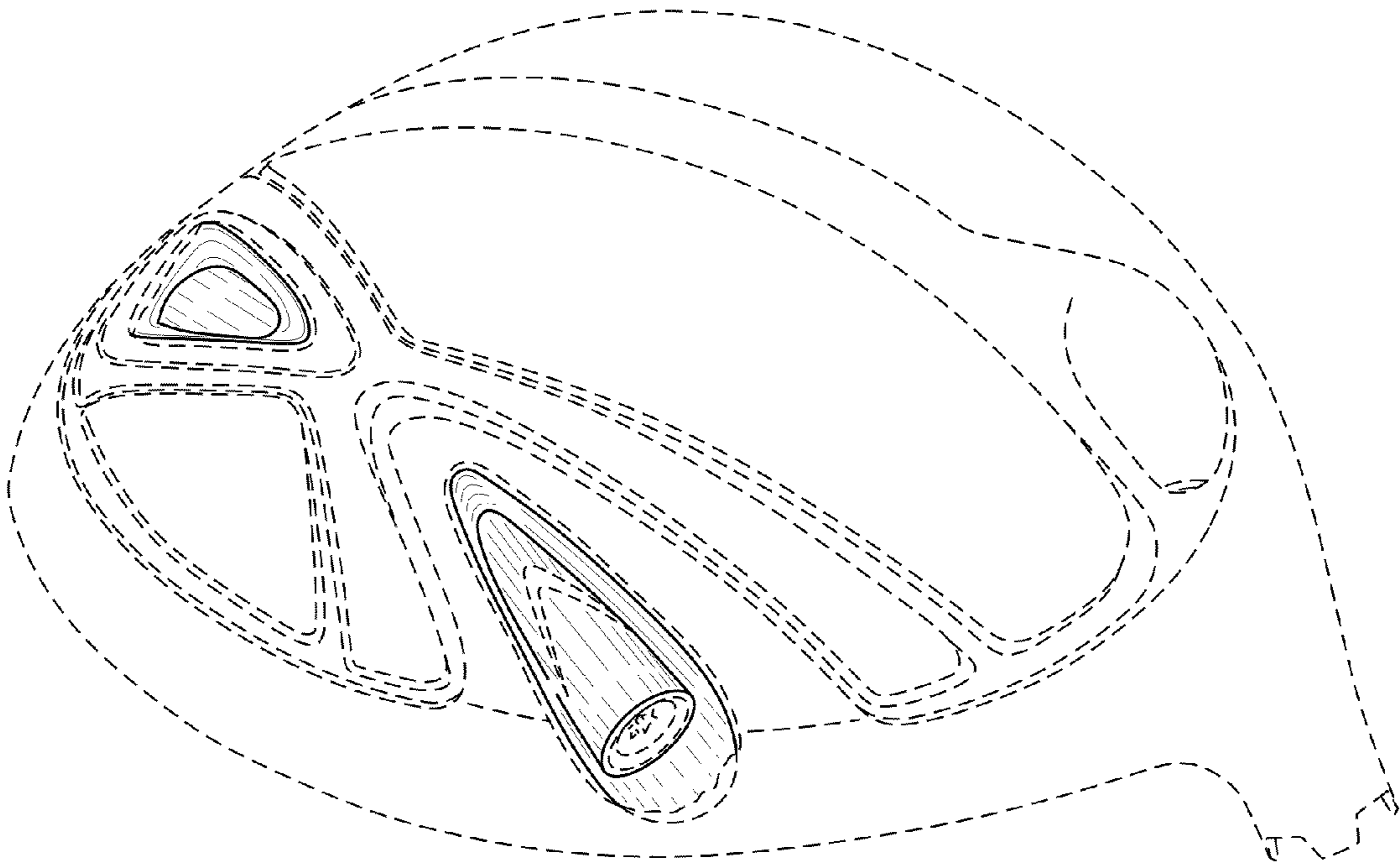

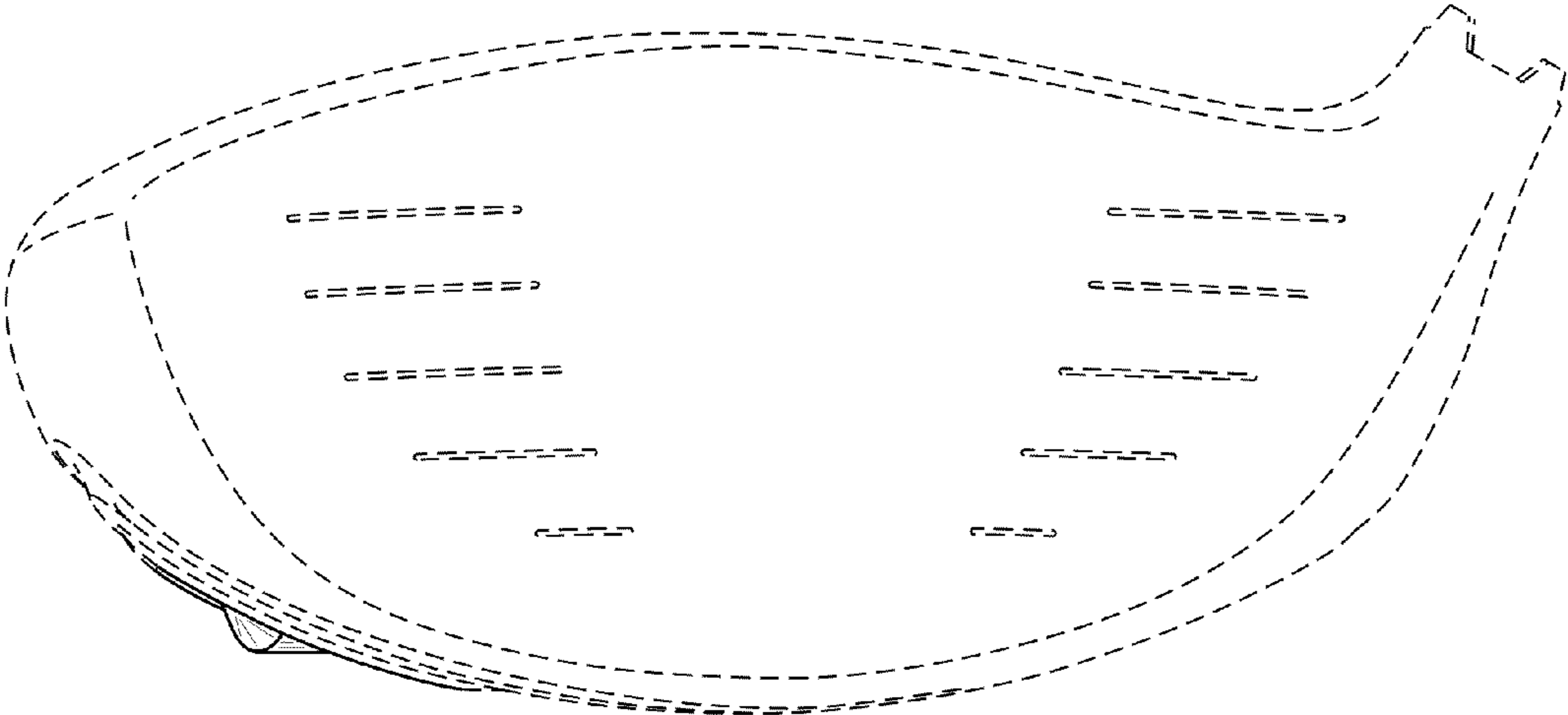

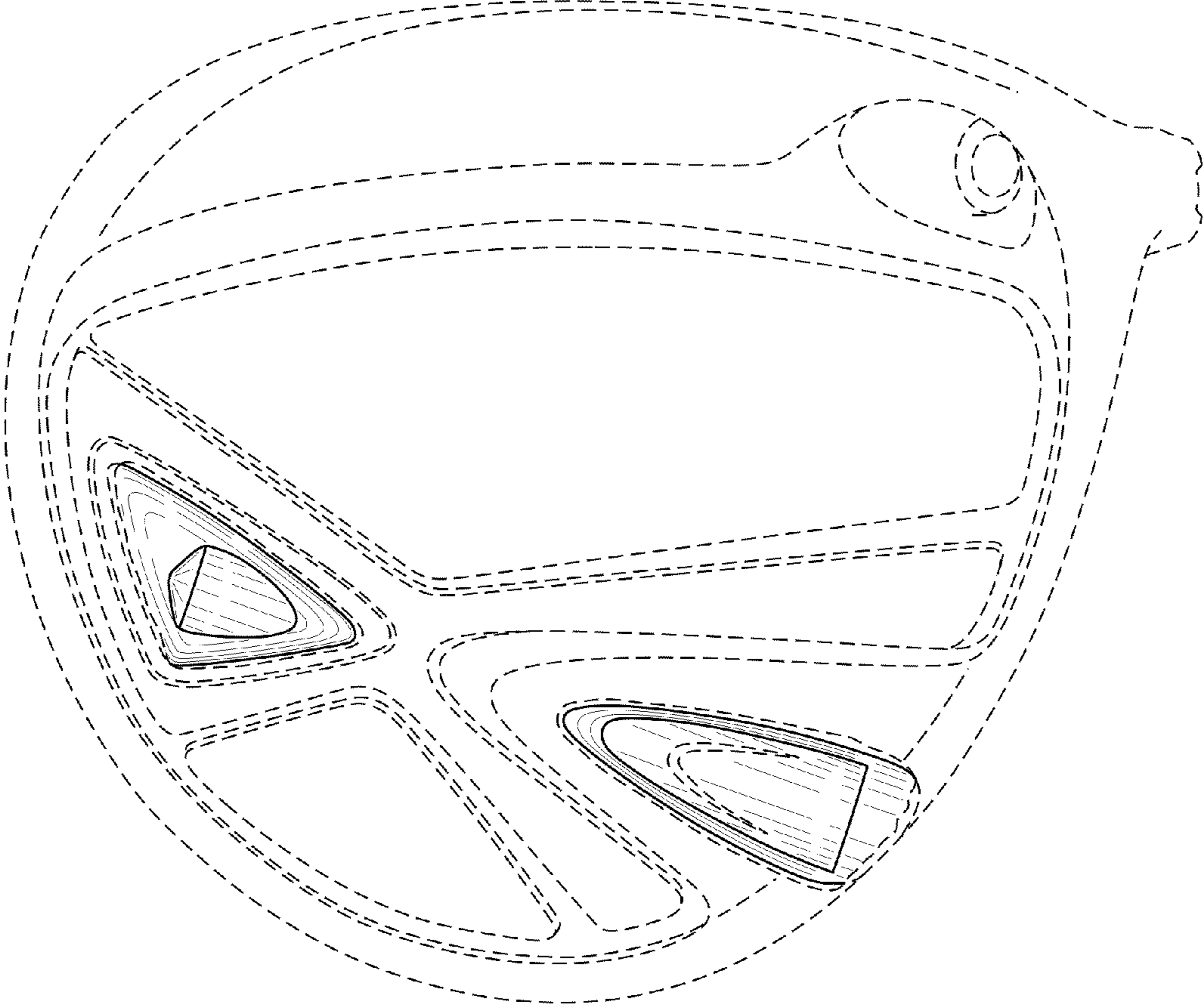

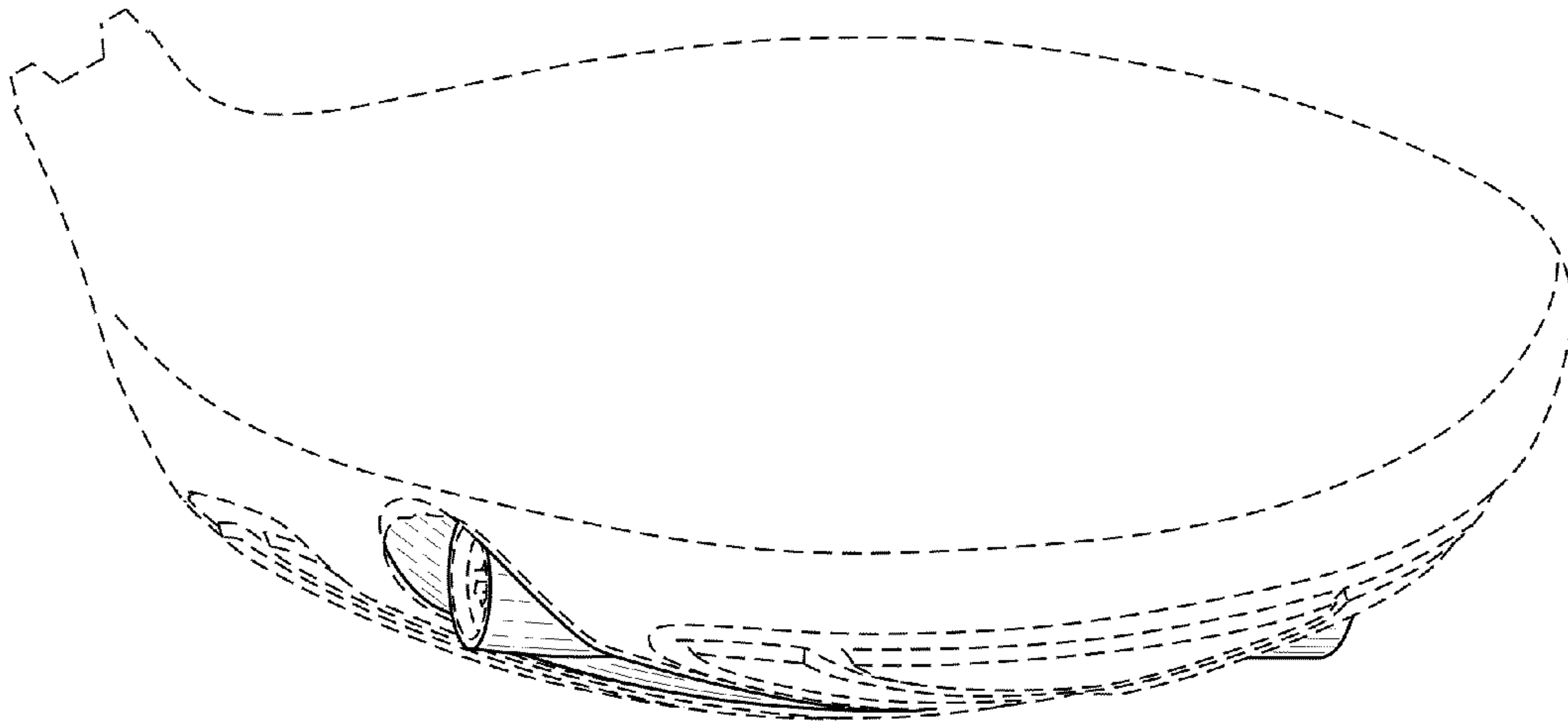

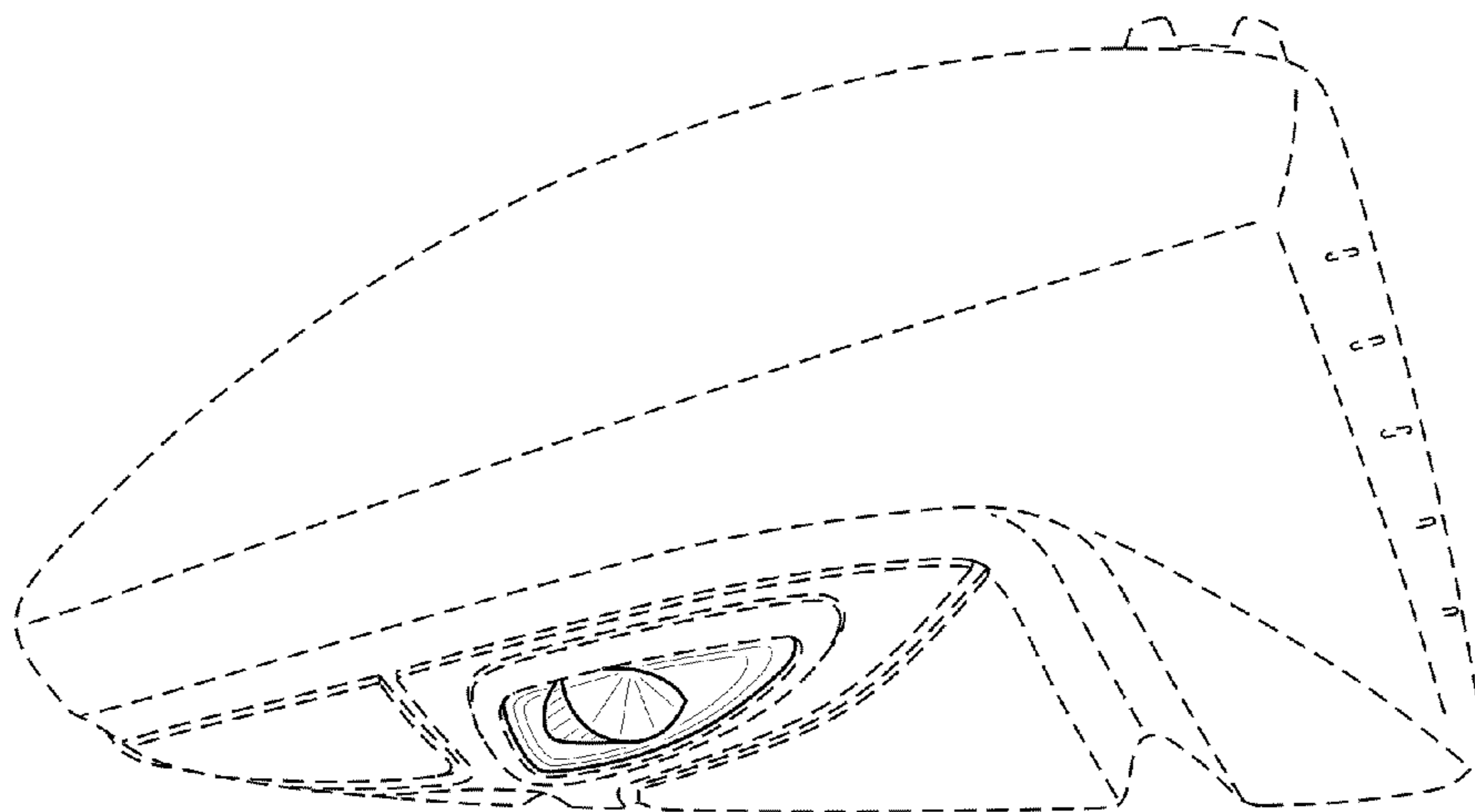

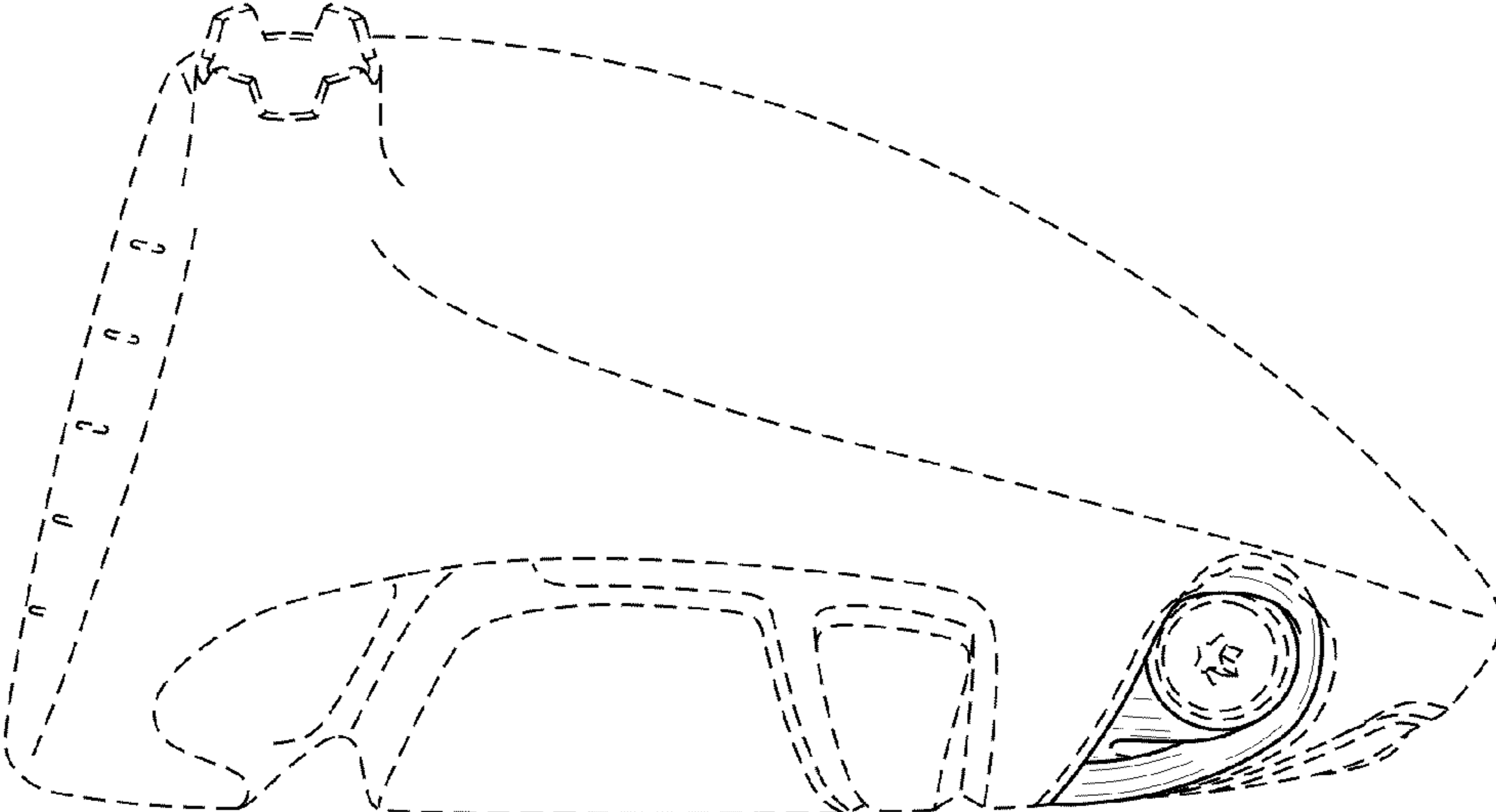
