(57) **CLAIM**

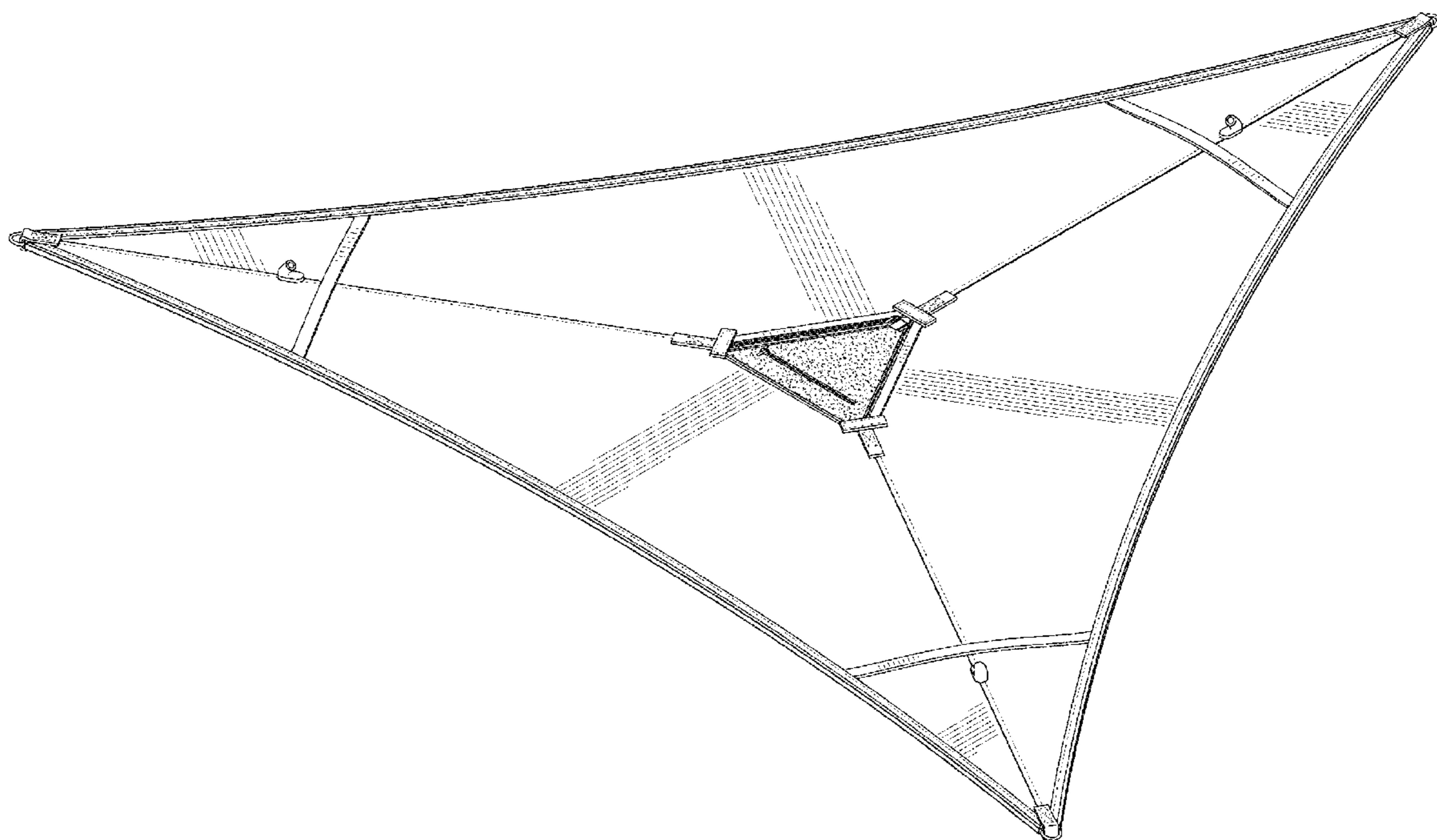
The ornamental design for a triangle tent mat, as shown and described.

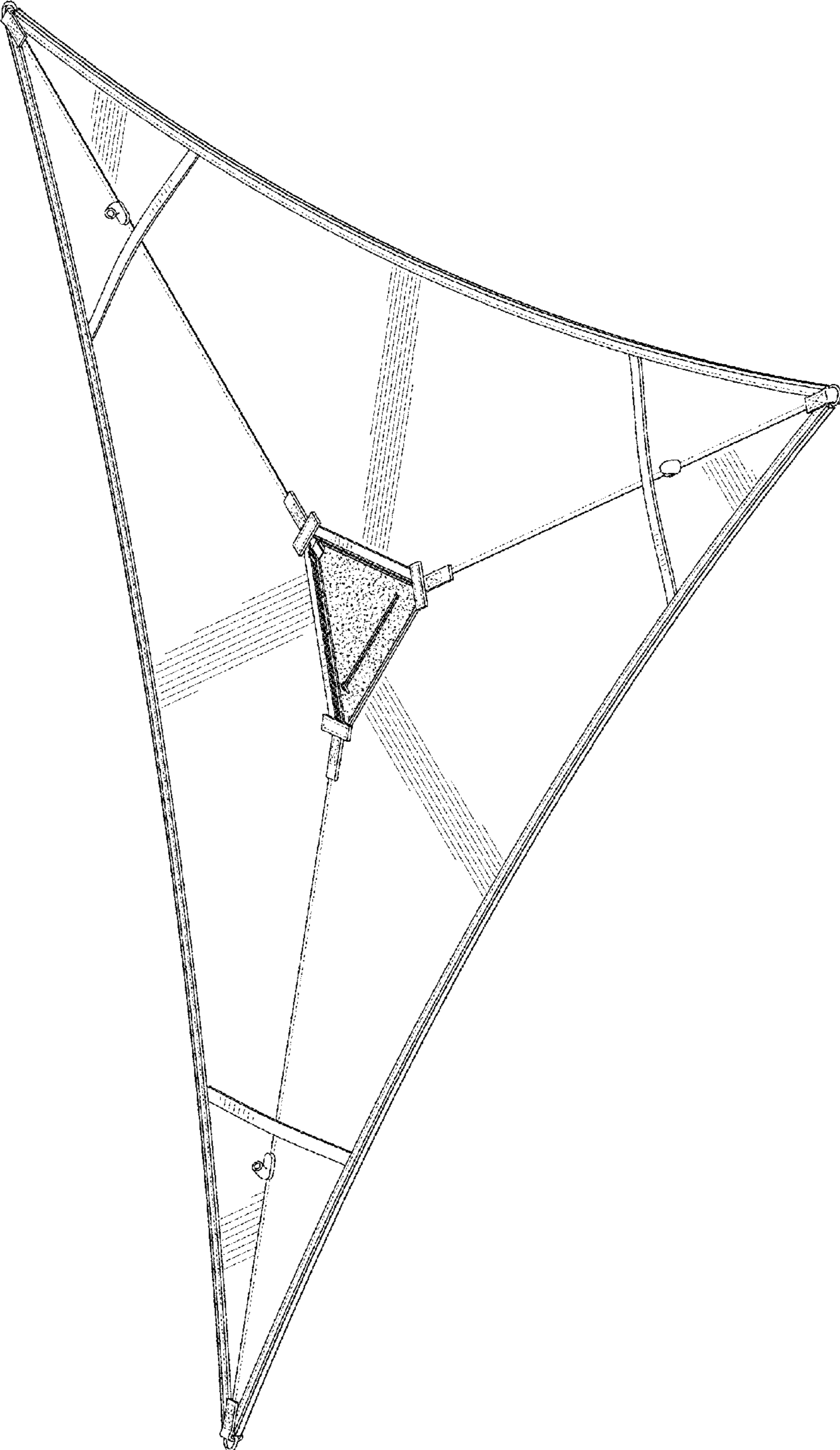

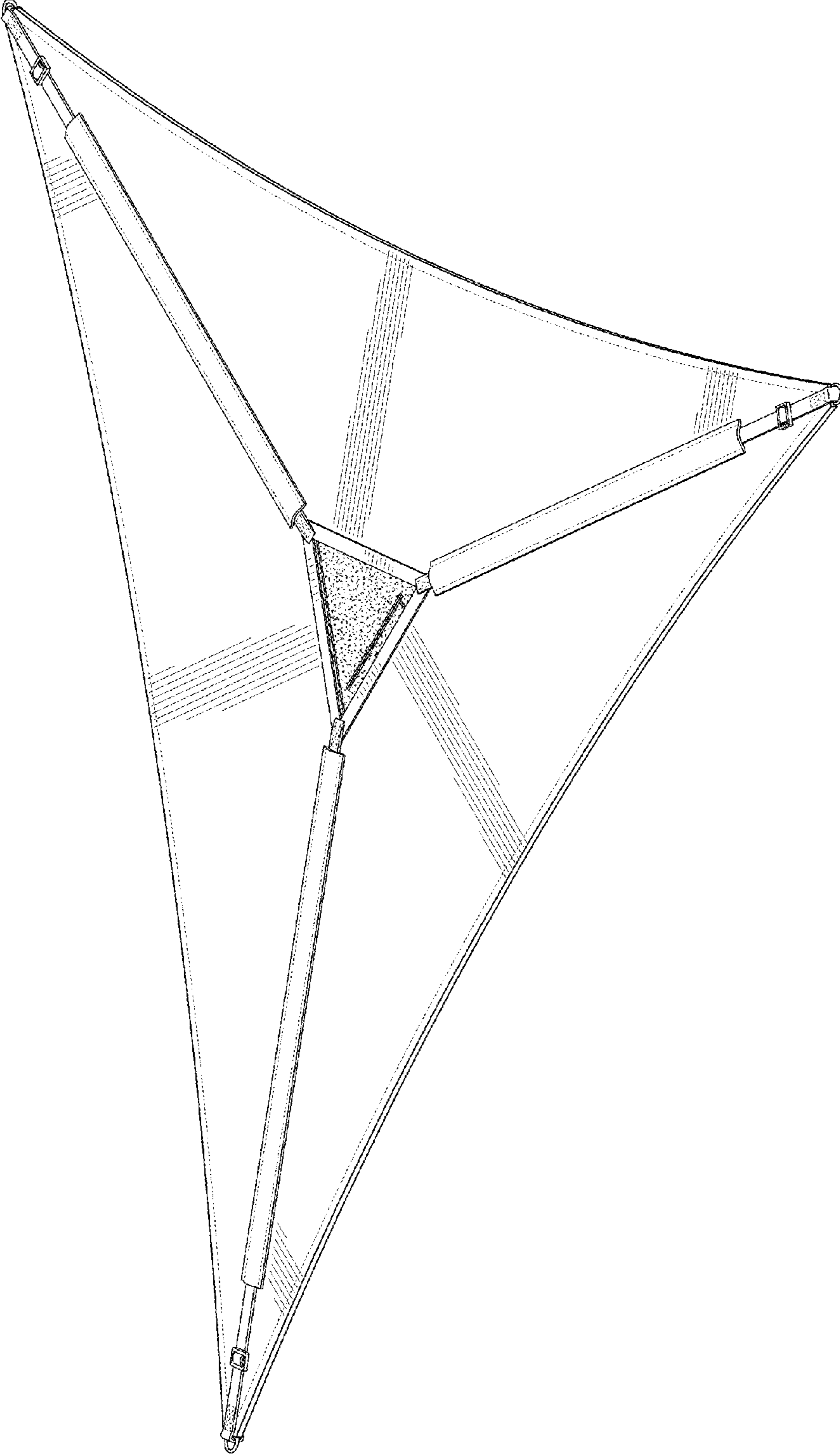

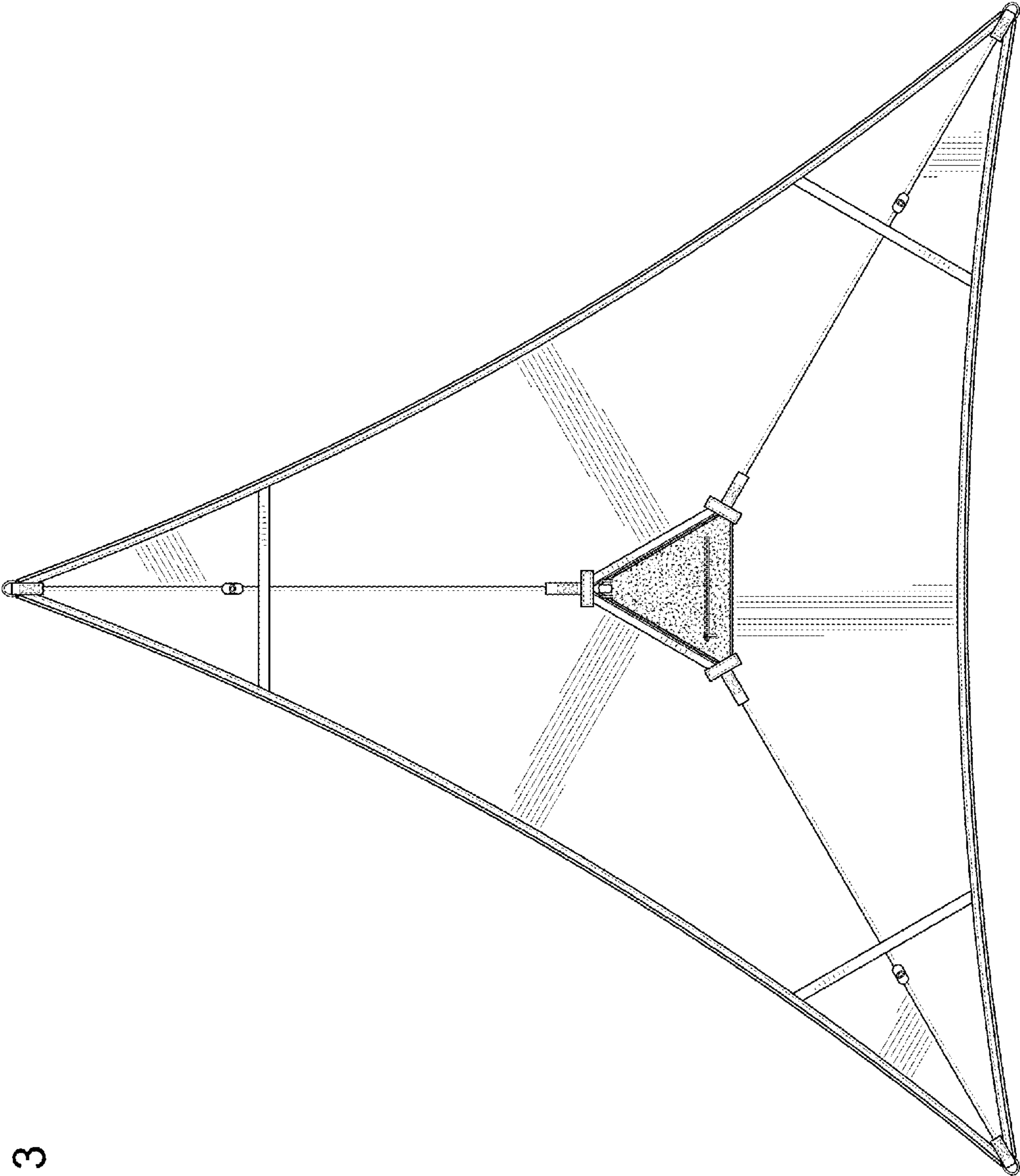

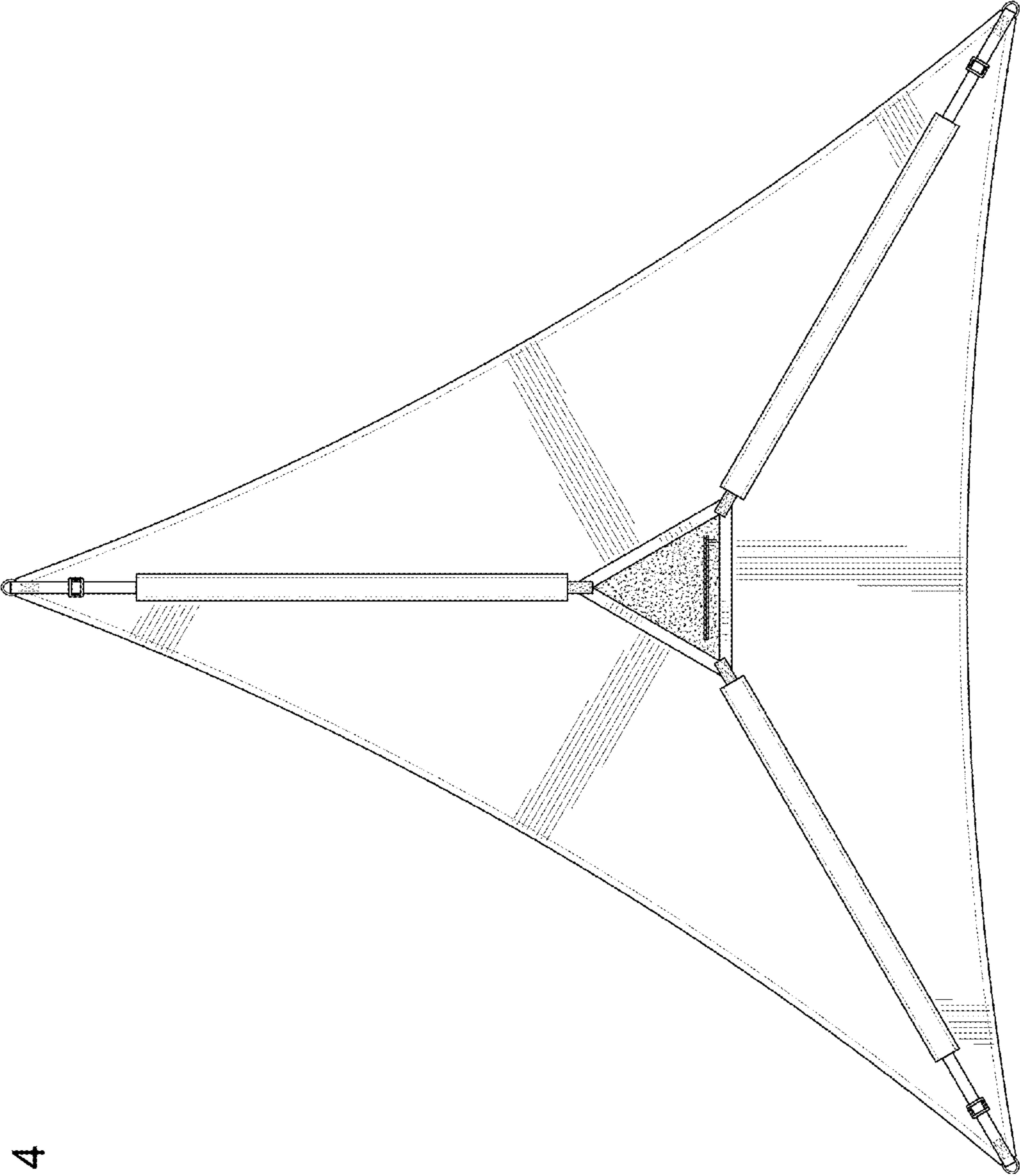

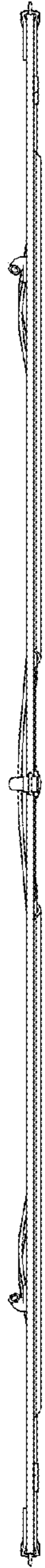

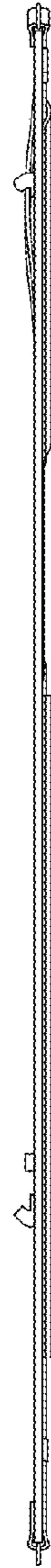
