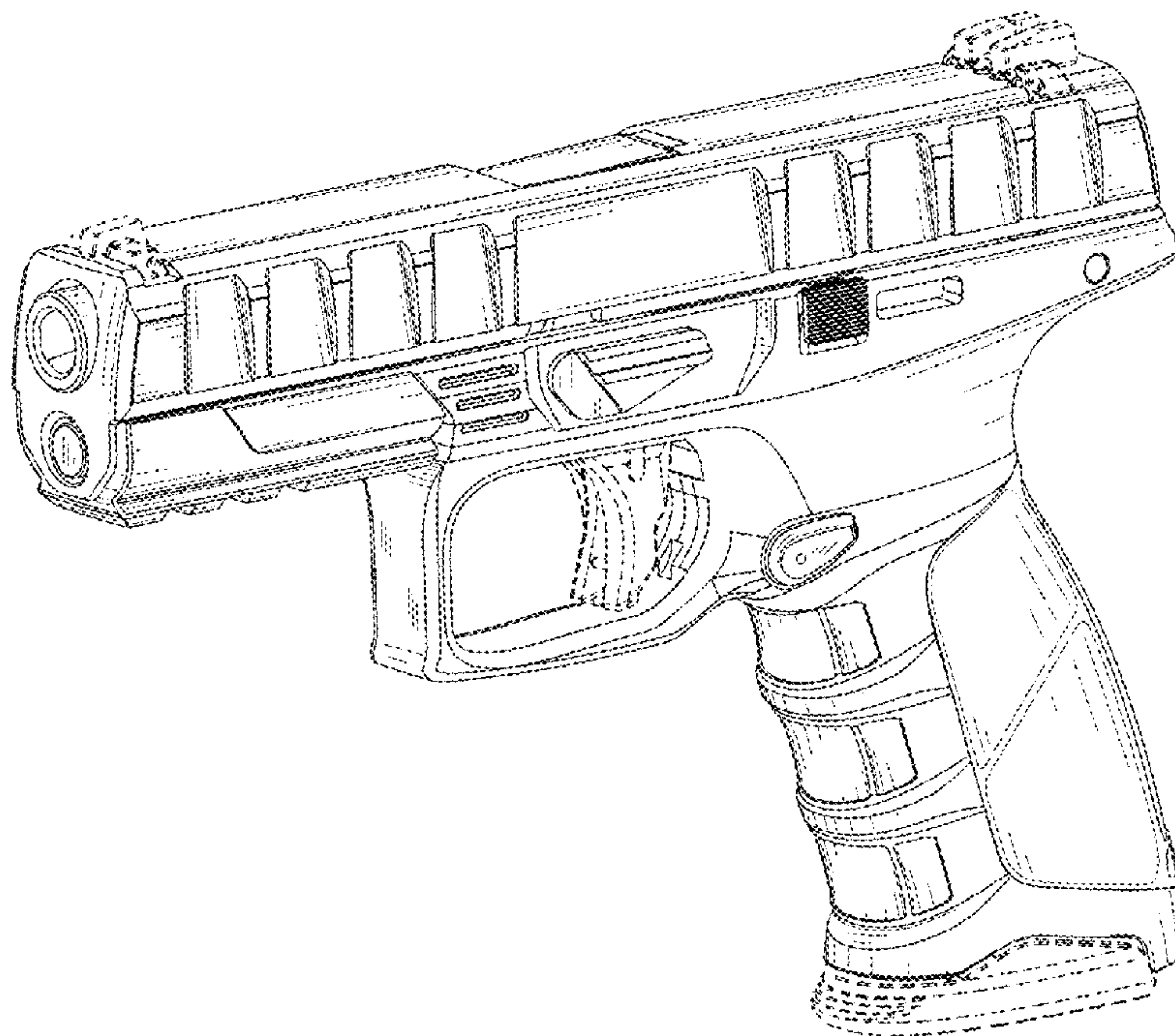
(57) **CLAIM**  
An ornamental design for gun, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of one embodiment of the gun. FIG. 2 is a left side view of the embodiment depicted in FIG. 1. FIG. 3 is a right side view of the embodiment depicted in FIG. 1. FIG. 4 is a front view of the embodiment depicted in FIG. 1. FIG. 5 is a rear view of the embodiment depicted in FIG. 1. FIG. 6 is a top view of the embodiment depicted in FIG. 1; and, FIG. 7 is a bottom view of the embodiment depicted in FIG. 1. The broken line showing in the drawing views is included for the purpose of illustrating portions of the gun that forms no part of the claimed design.

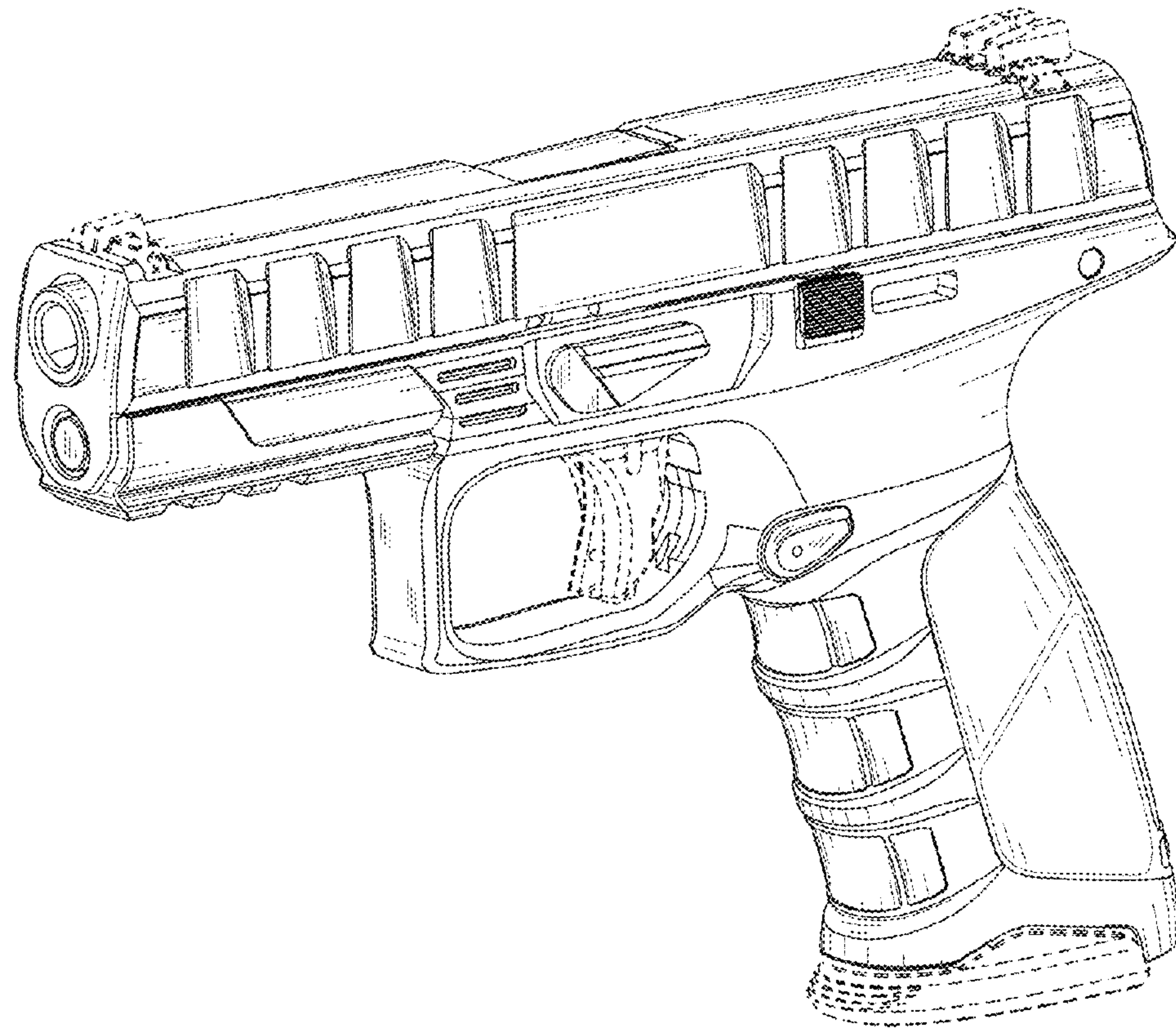

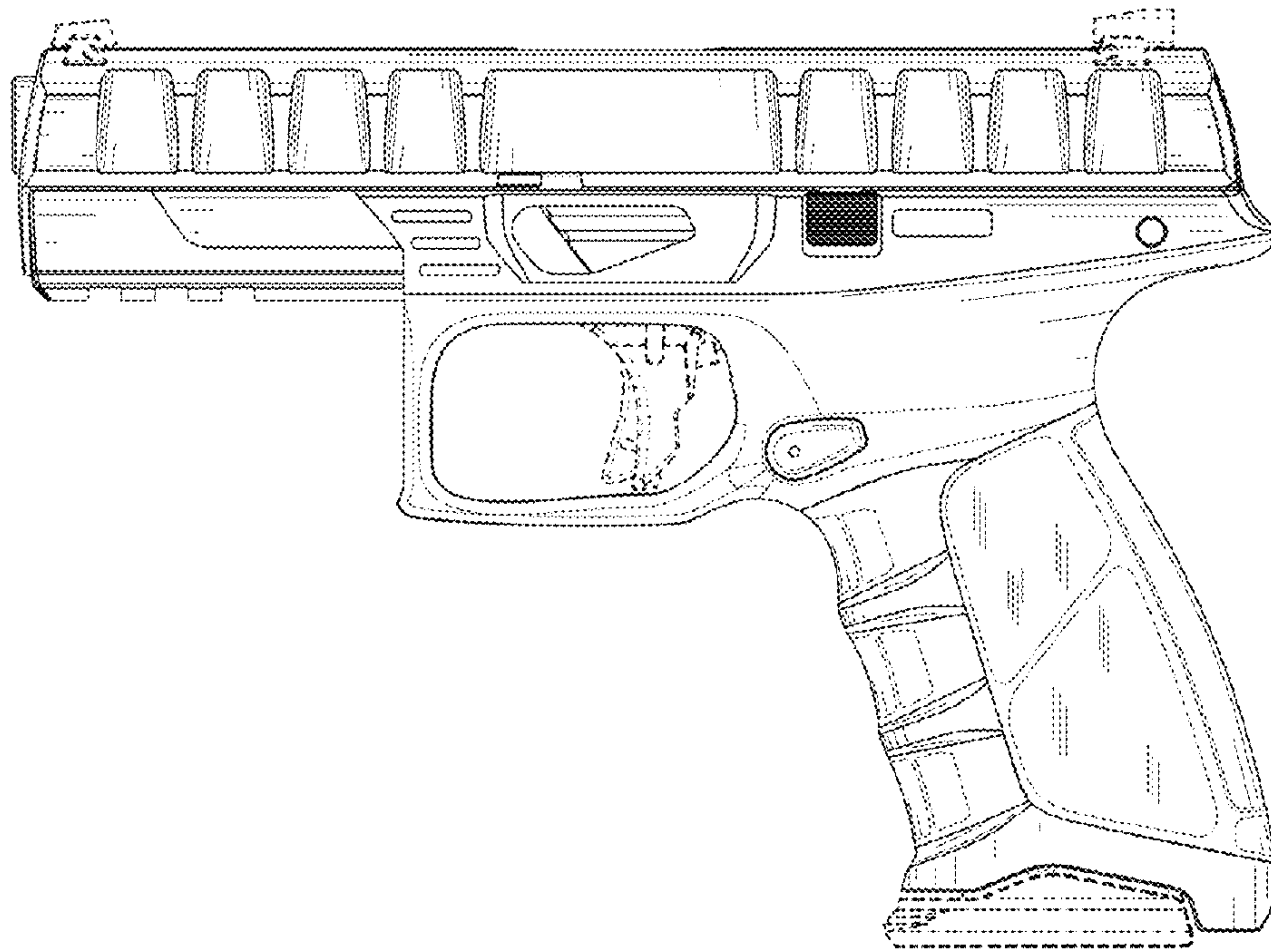

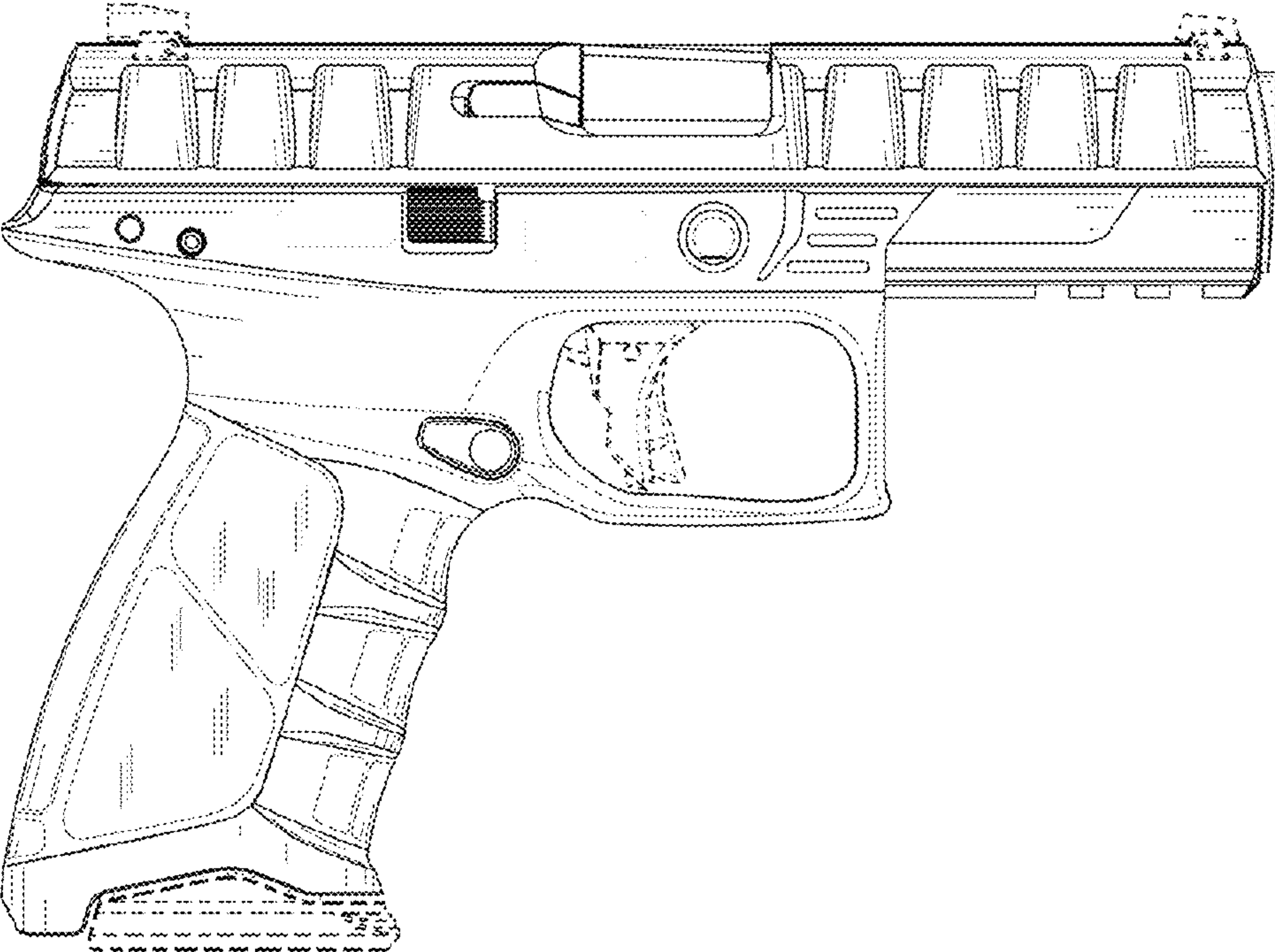

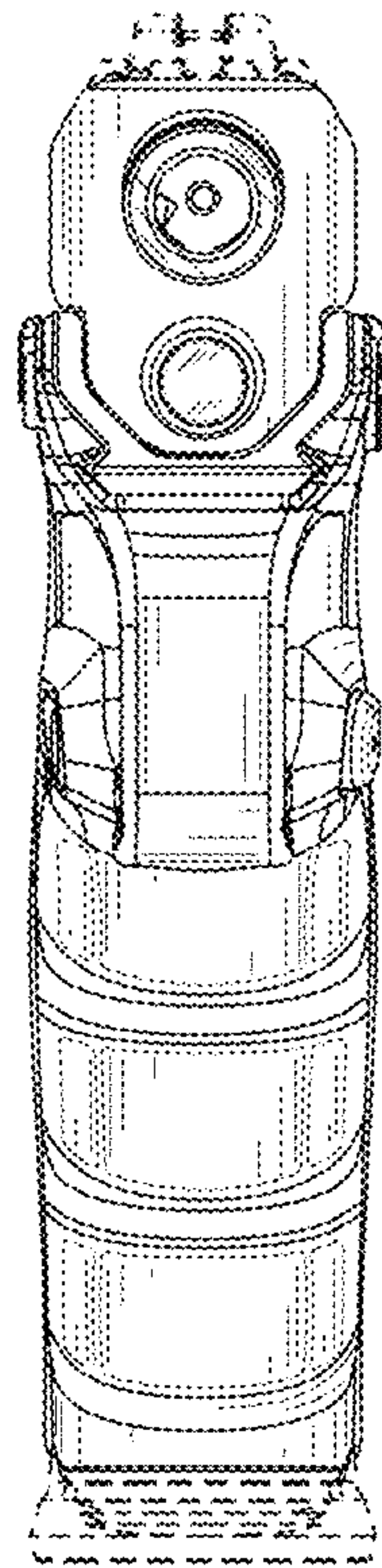

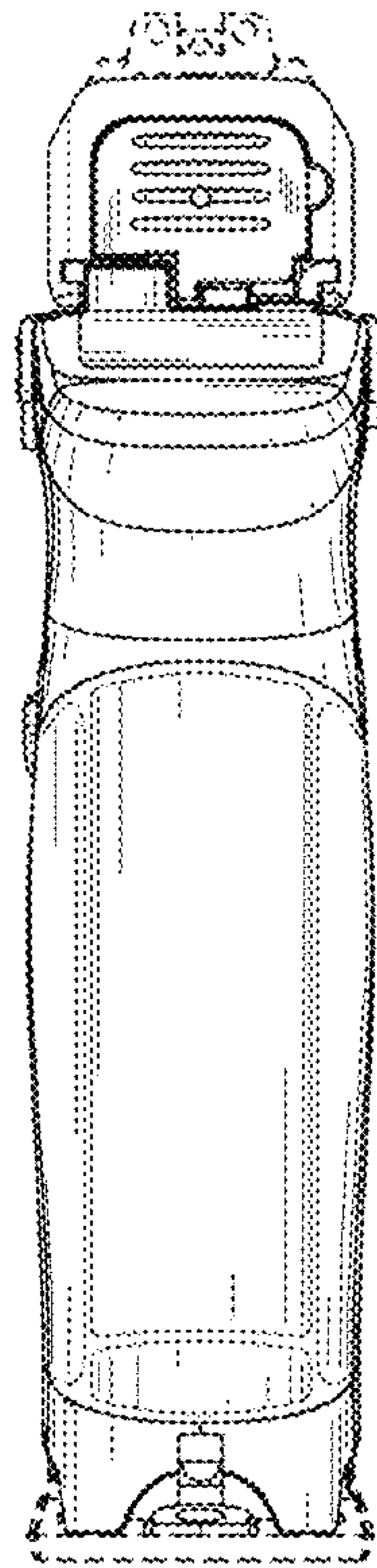

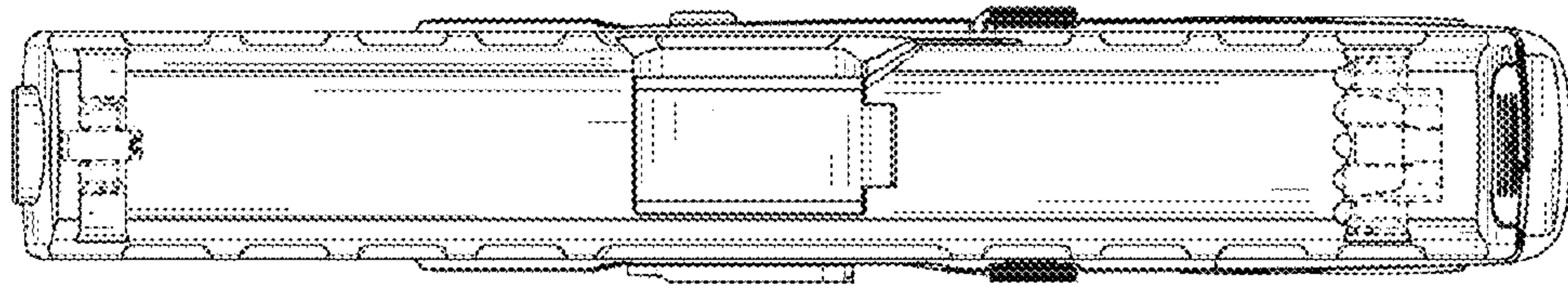

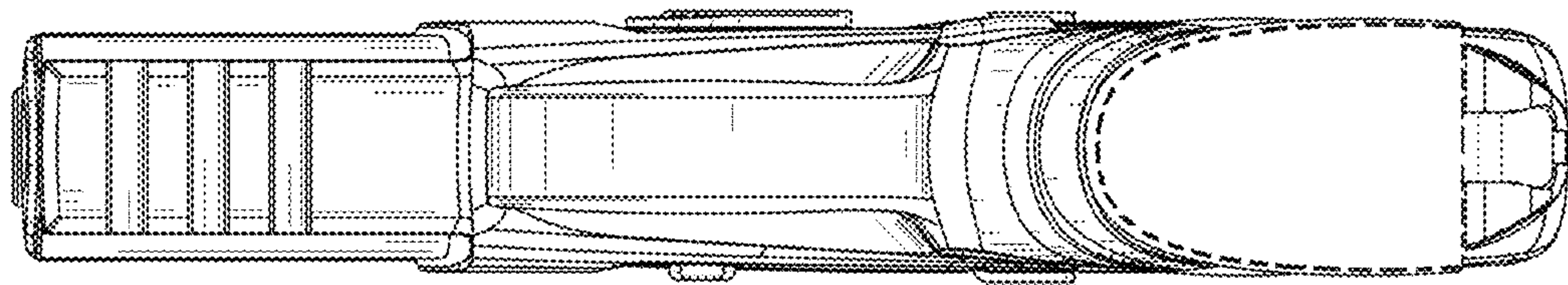
