The ornamental design for a gun rail mounting device, as shown and described.

DESCRIPTION

FIG. 1 is a right/front isometric view of the gun rail mounting device;
FIG. 2 is a left/rear isometric view of the device of FIG. 1;
FIG. 3 is a front elevational view of the device of FIG. 1;
FIG. 4 is a rear elevation view of the device of FIG. 1;
FIG. 5 is a right elevational view of the device of FIG. 1;

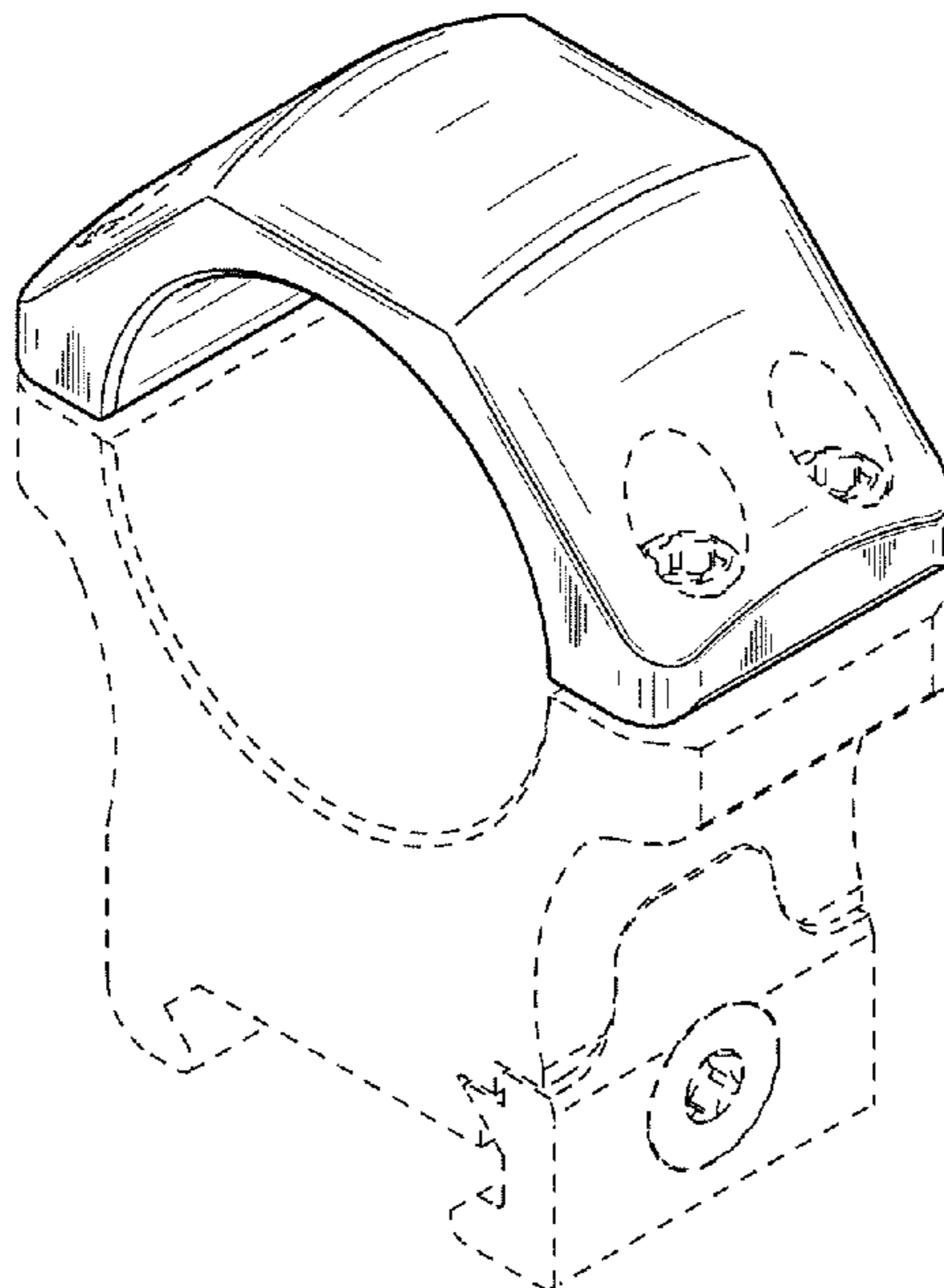

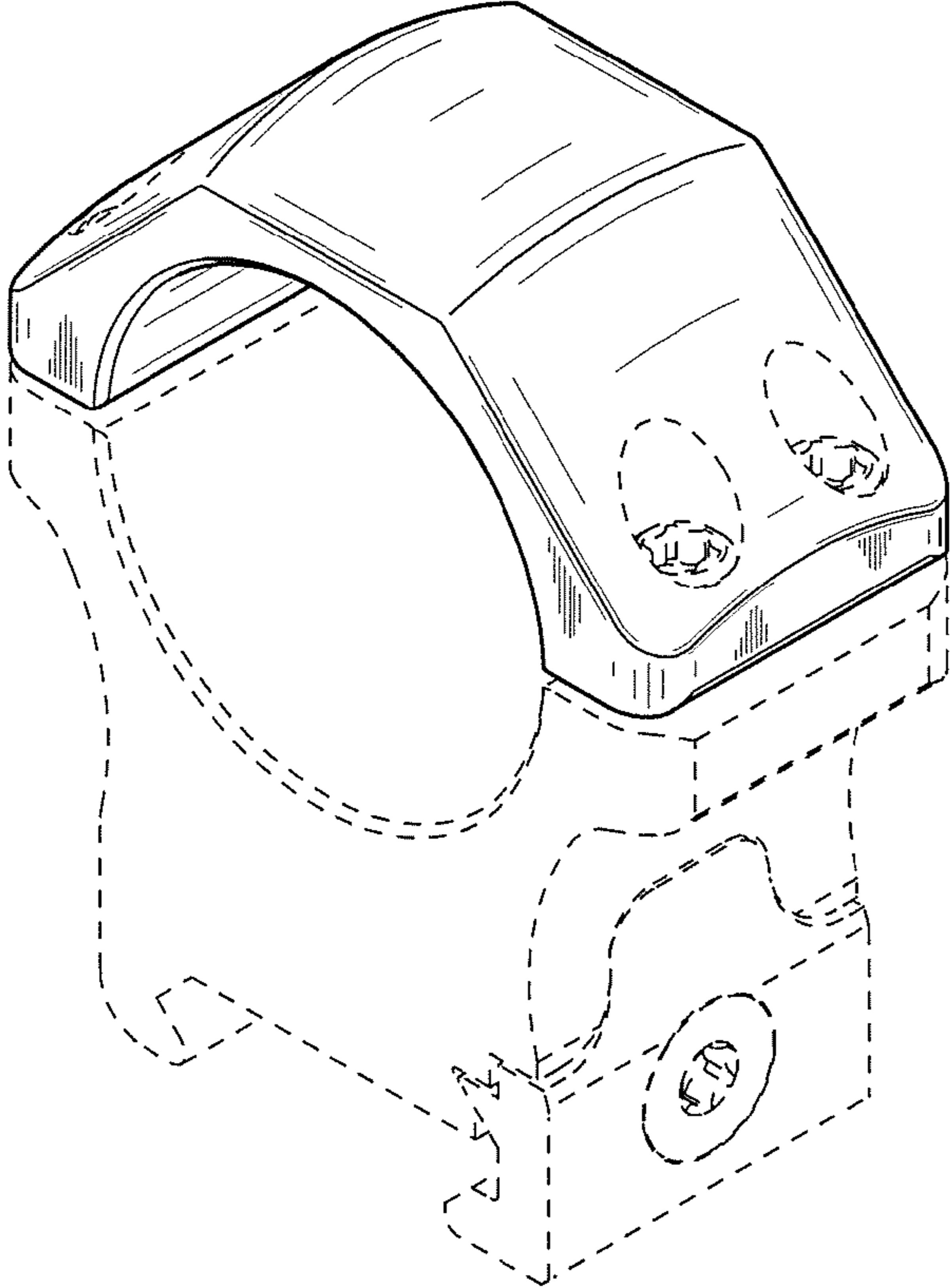
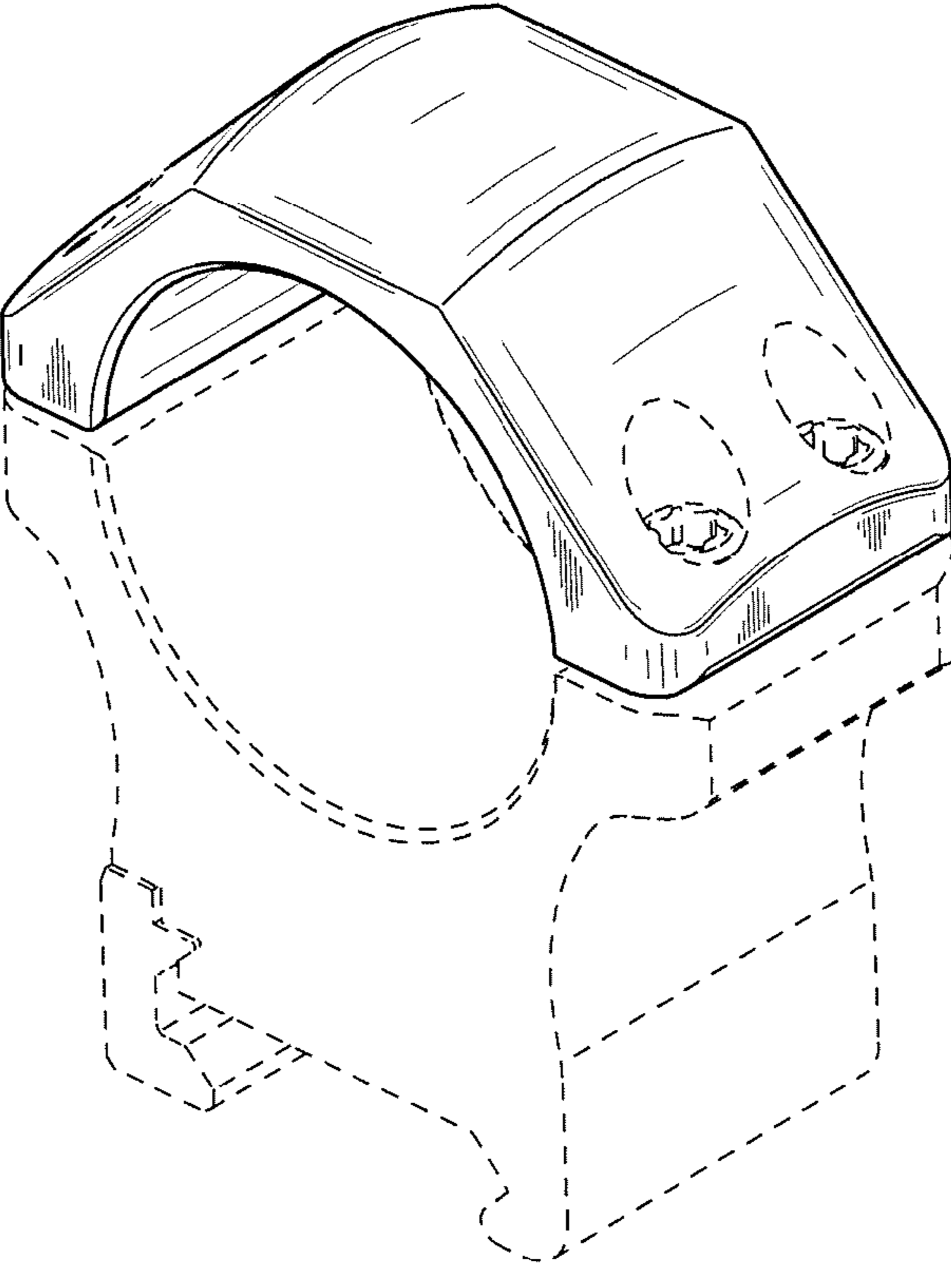

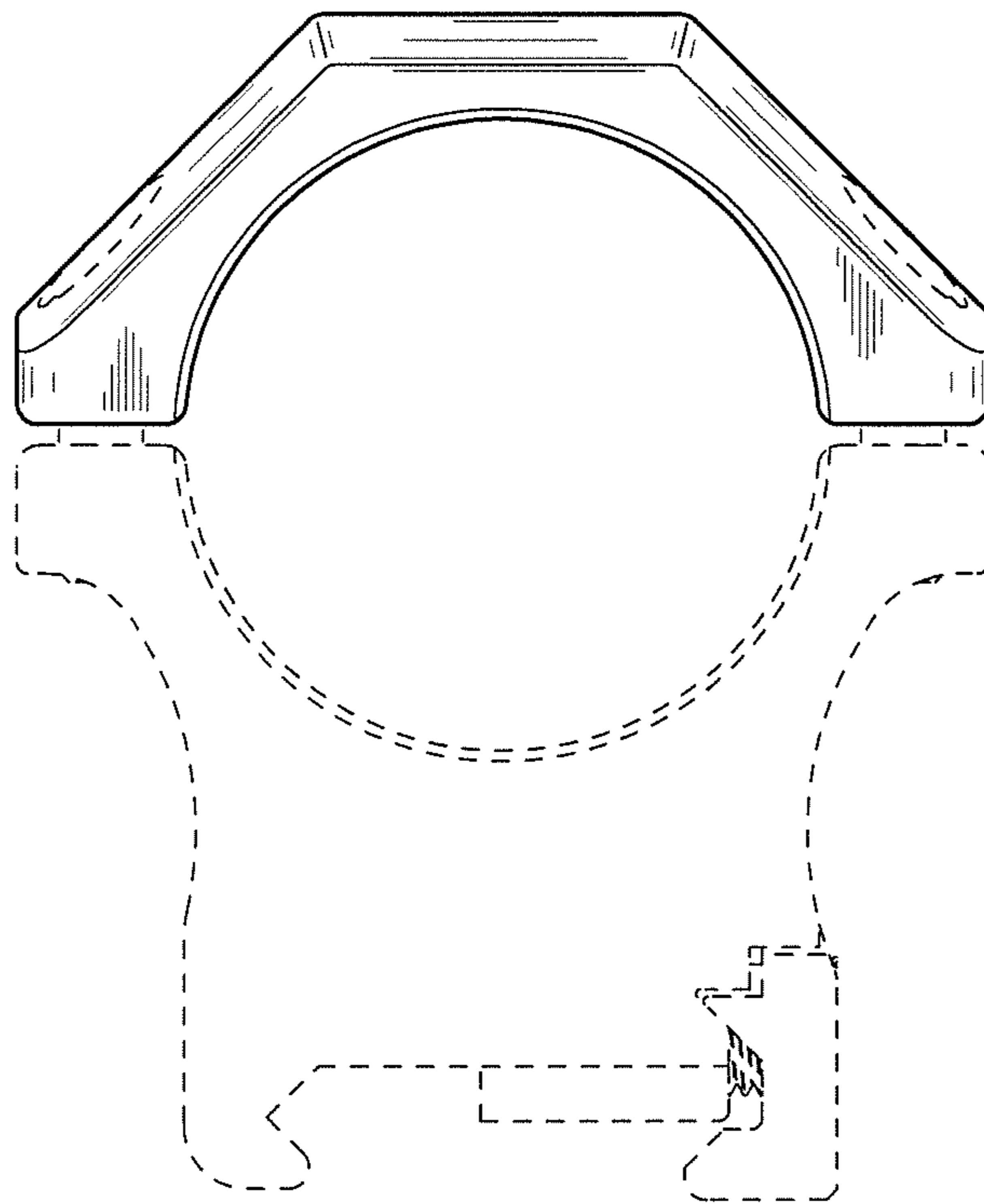

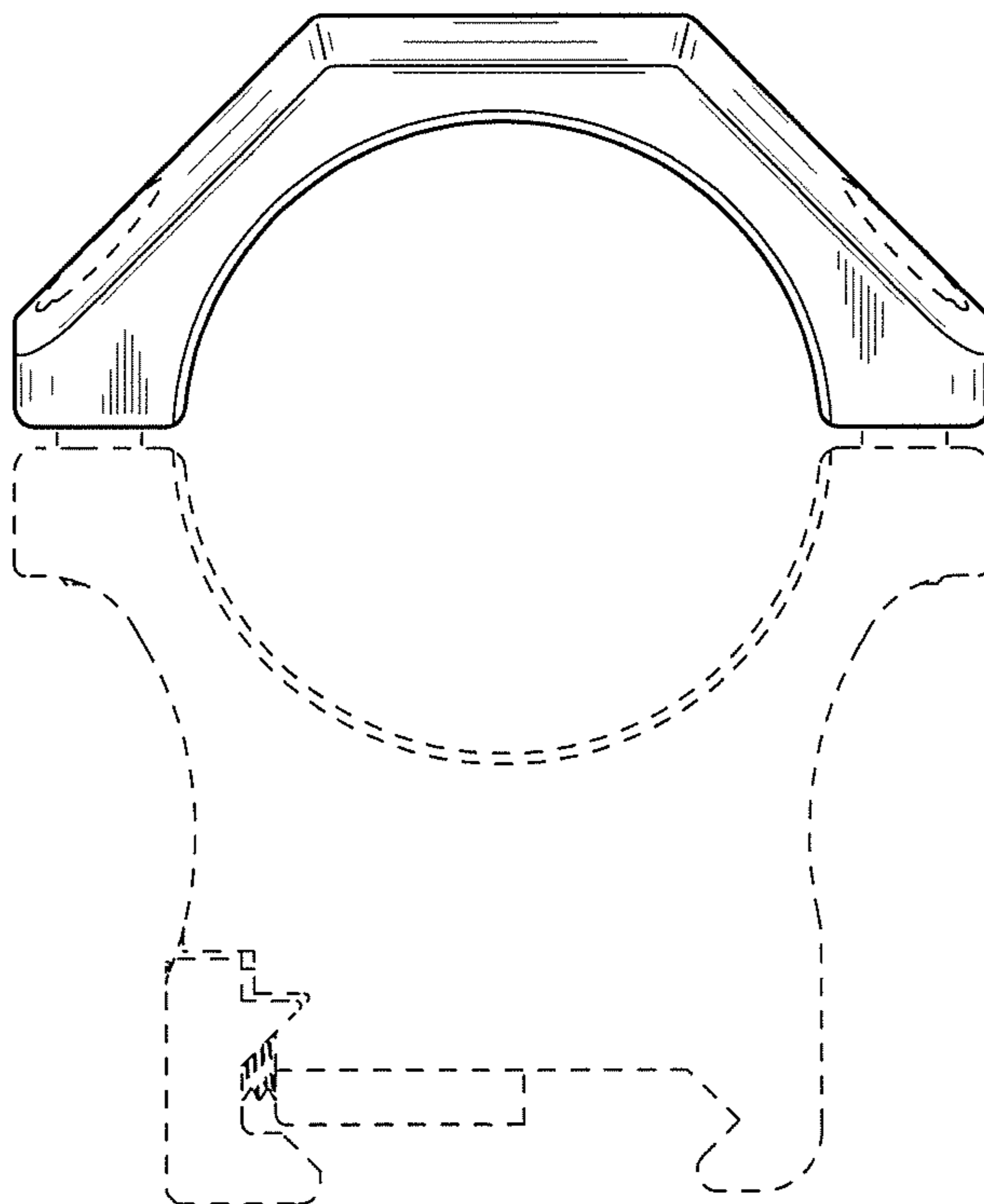

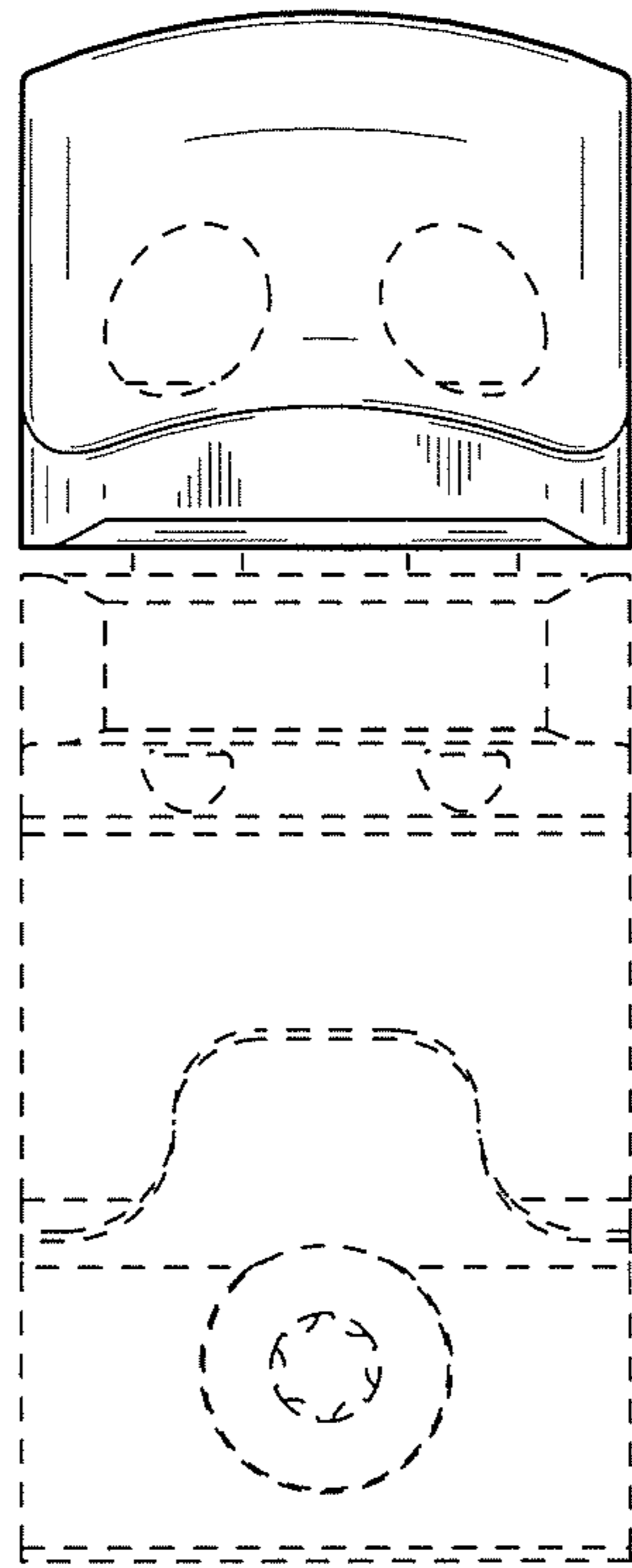

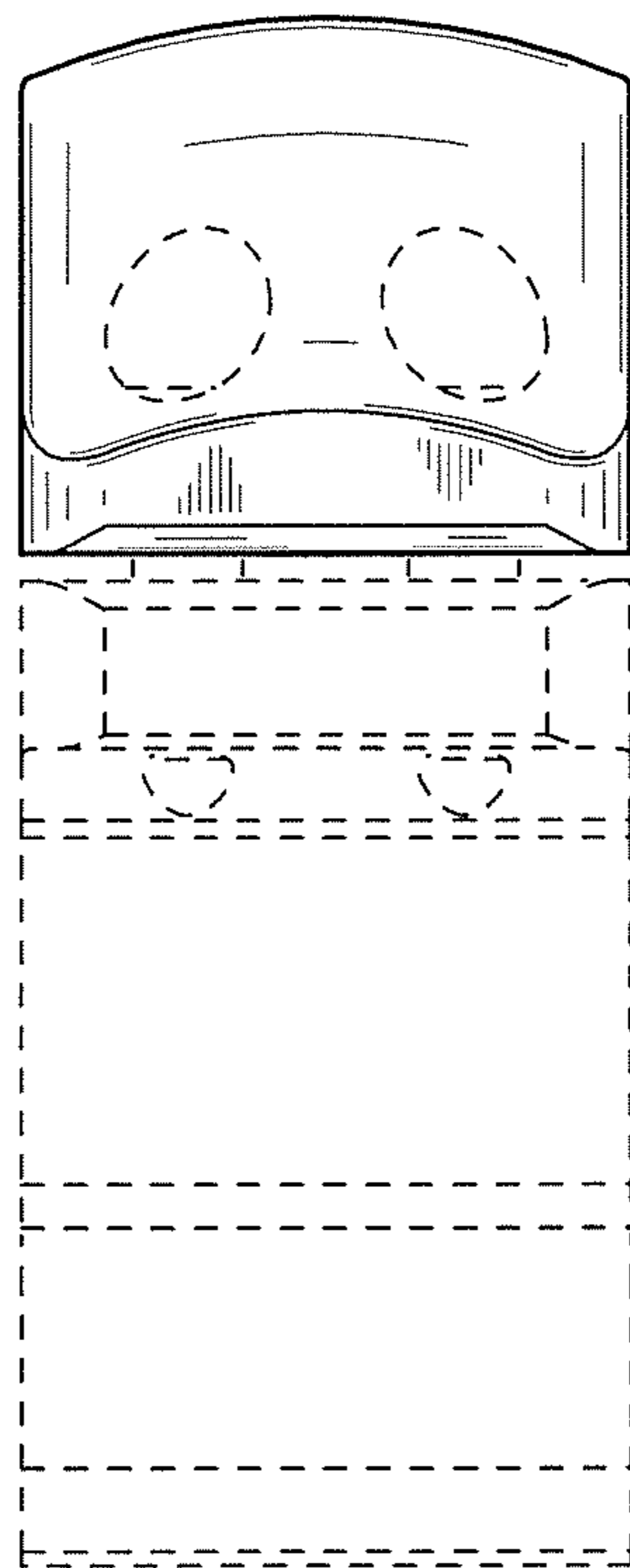

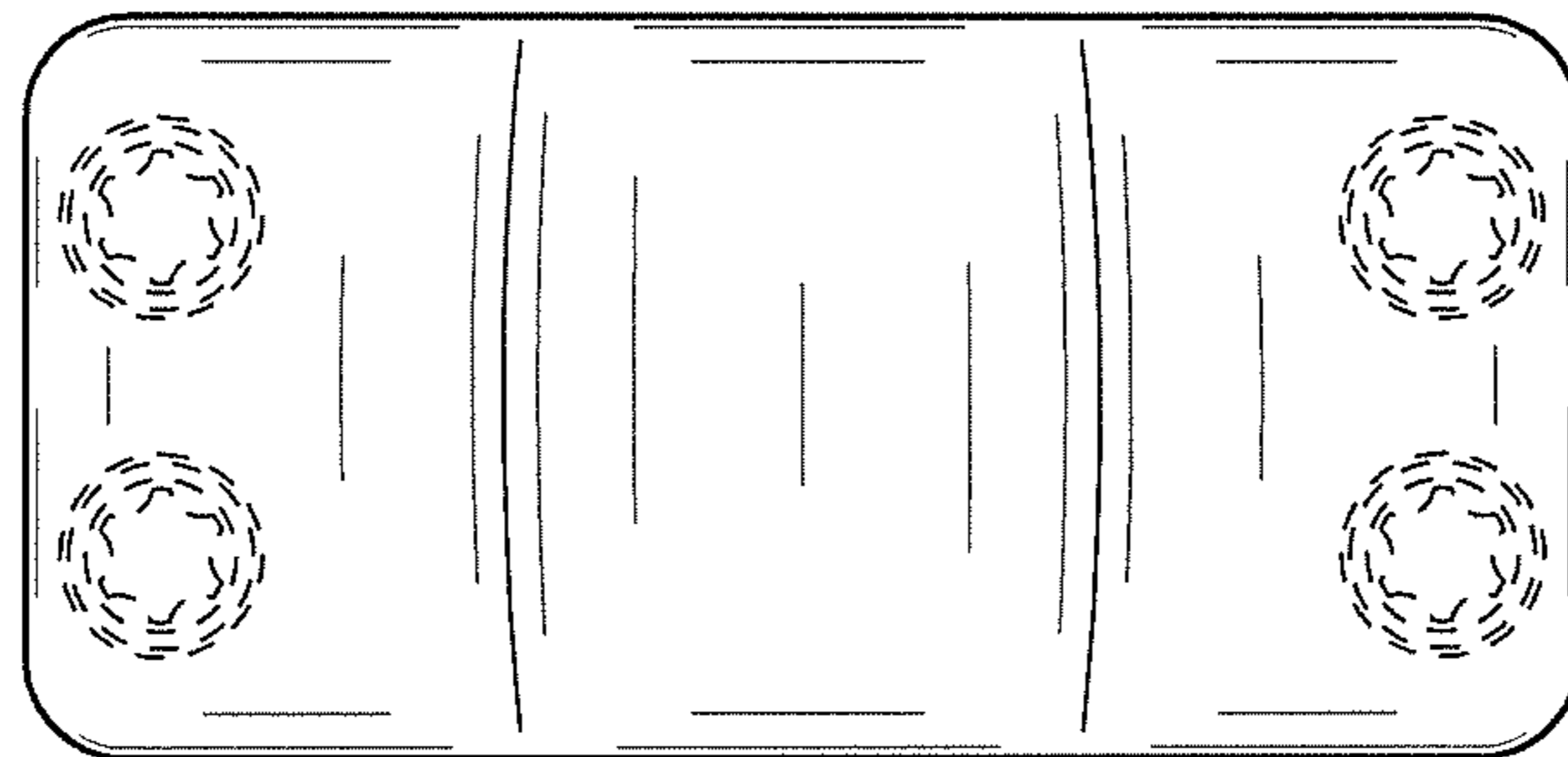

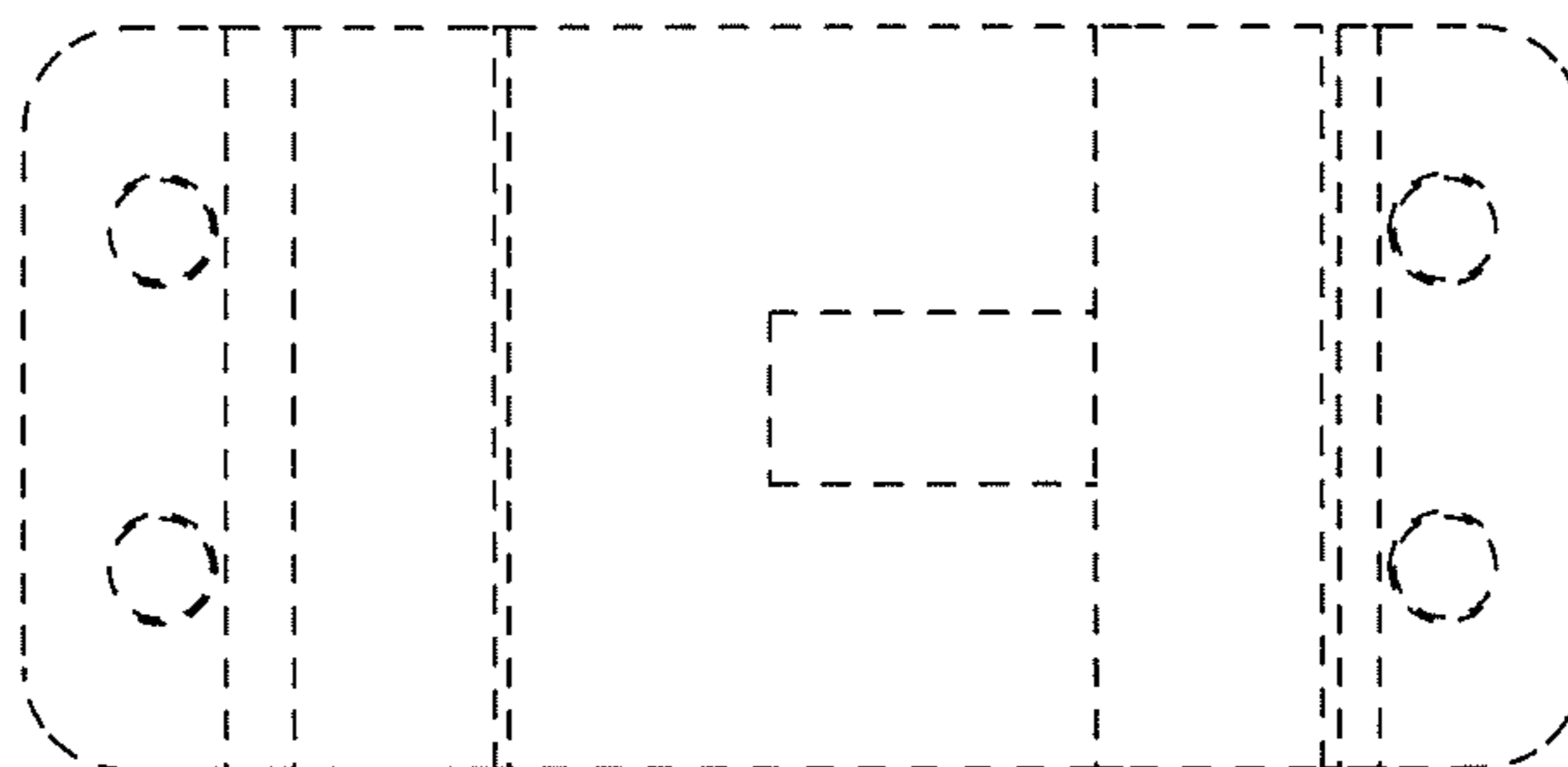
