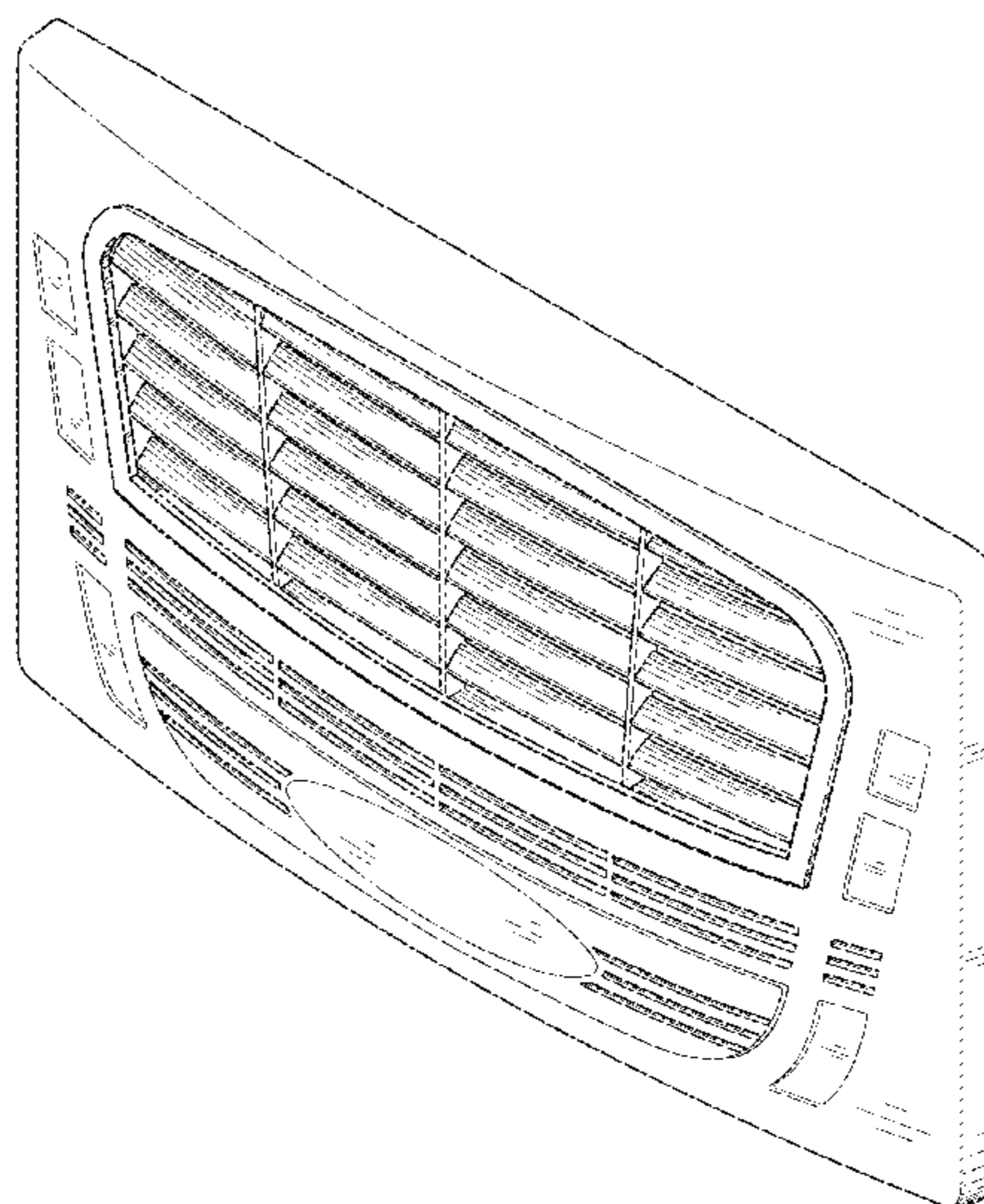
(57) **CLAIM**

The ornamental design for a weir door, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the weir door of the present design.  
FIG. 2 is a front elevation view thereof.  
FIG. 3 is a rear elevation view thereof.  
FIG. 4 is a left side elevation view thereof, with a right side elevation view being a mirror image thereof.  
FIG. 5 is a top plan view thereof; and,  
FIG. 6 is a bottom plan view thereof.

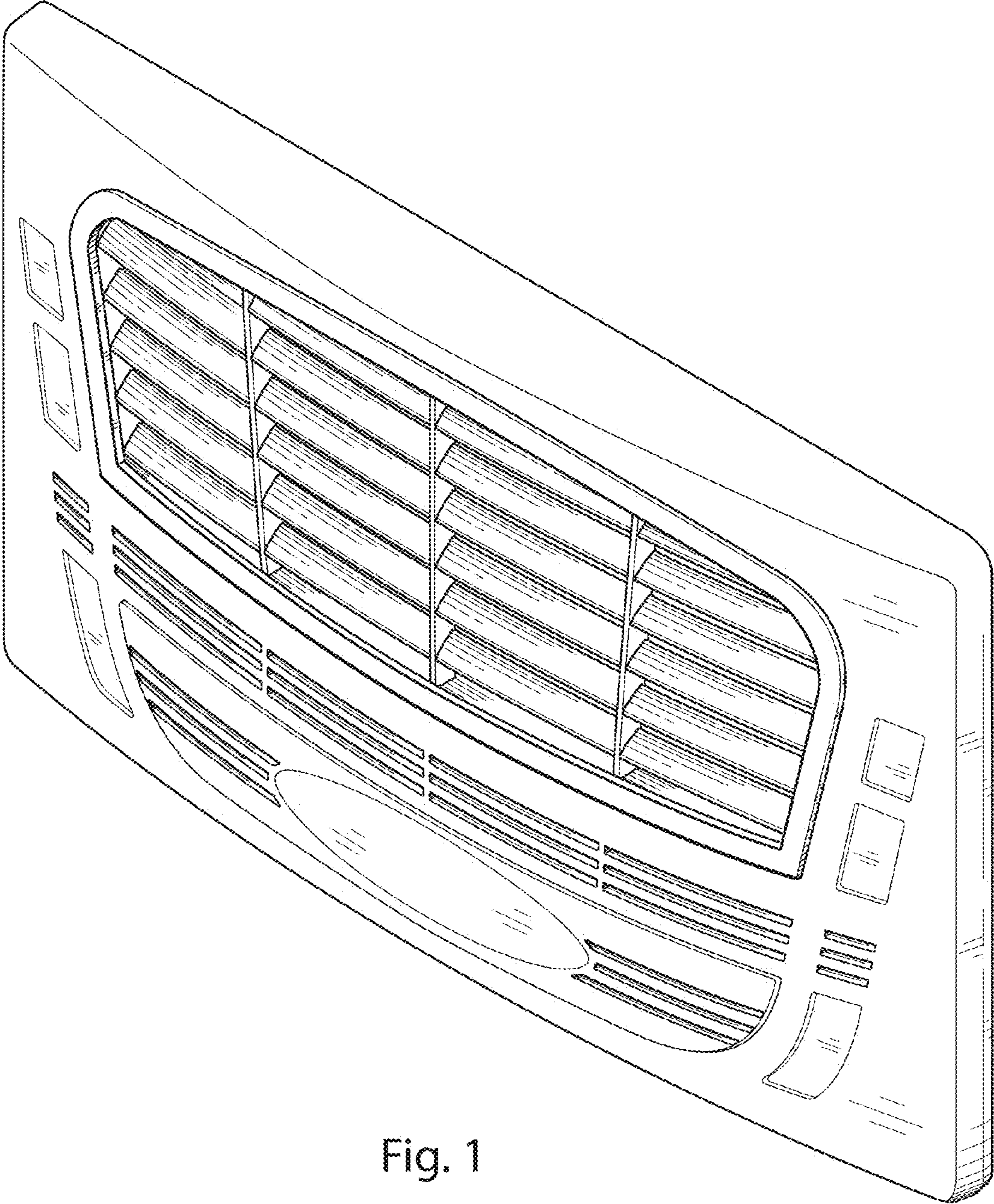

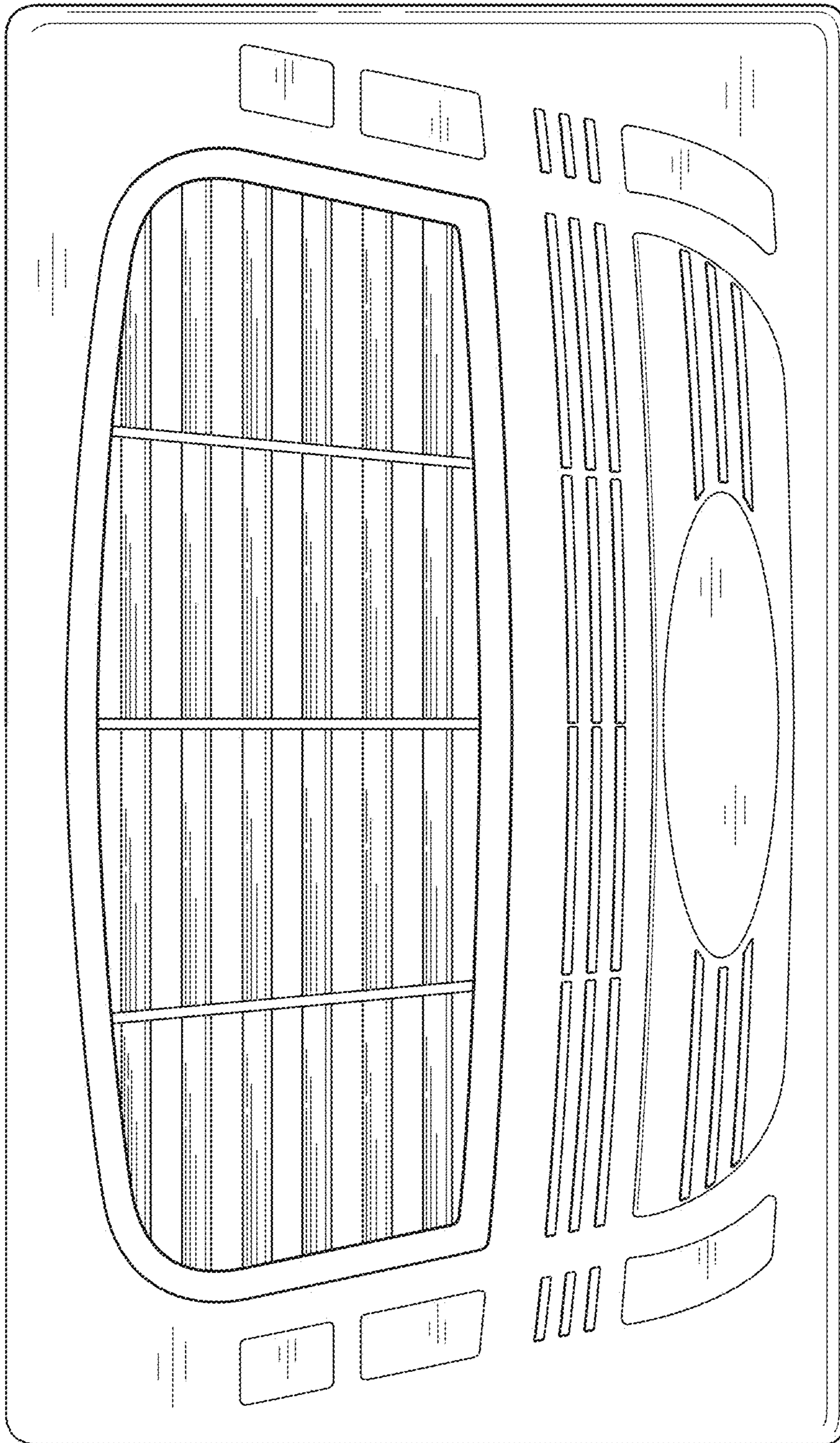

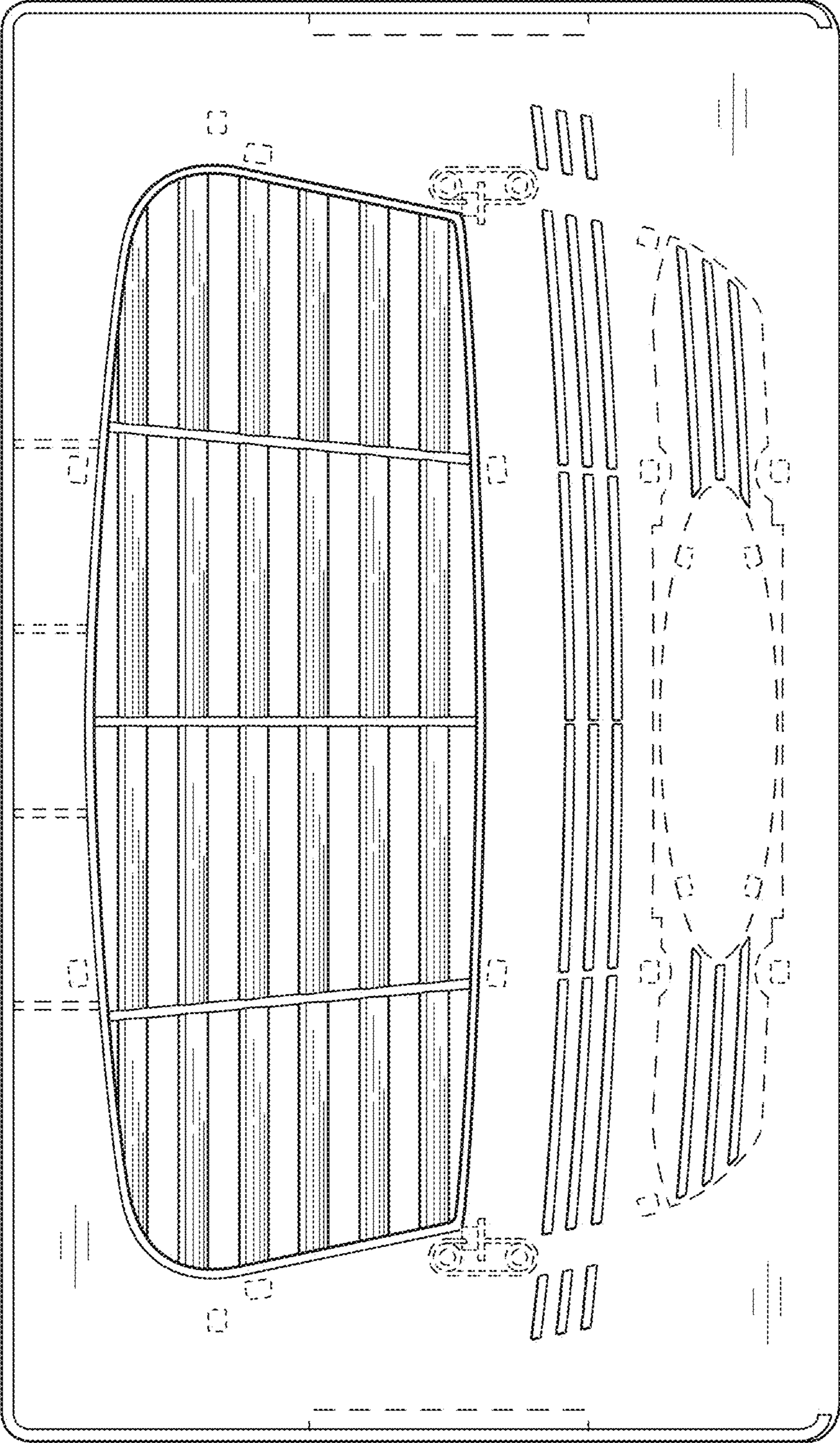

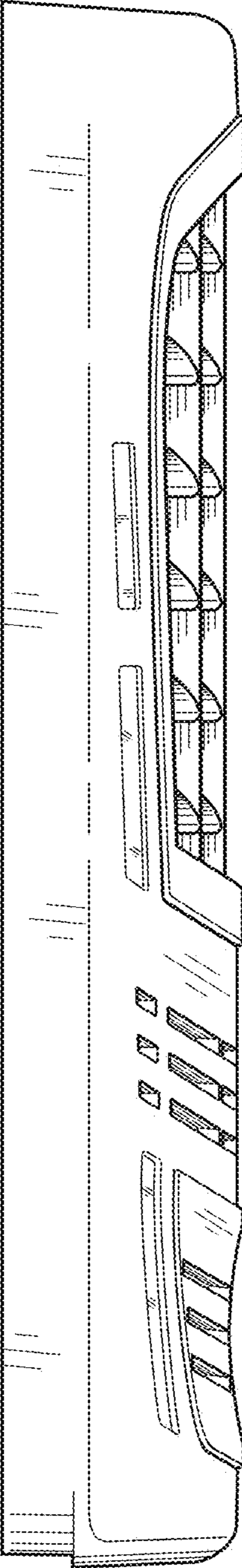

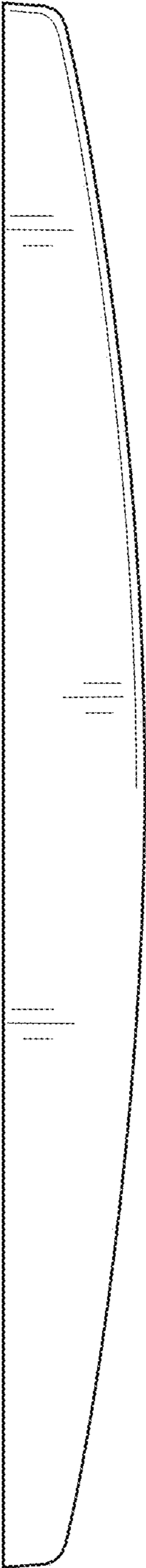

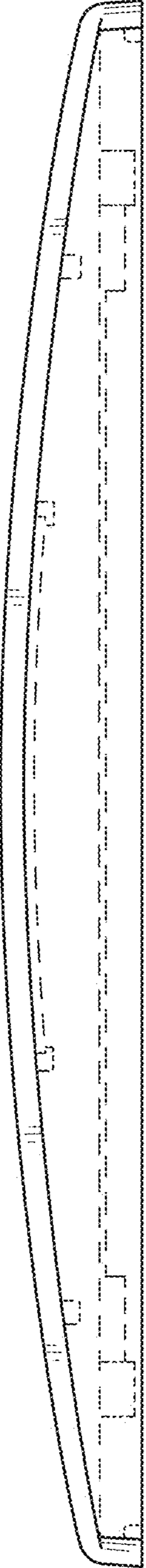
