FIG. 3 depicts a side elevation view thereof.

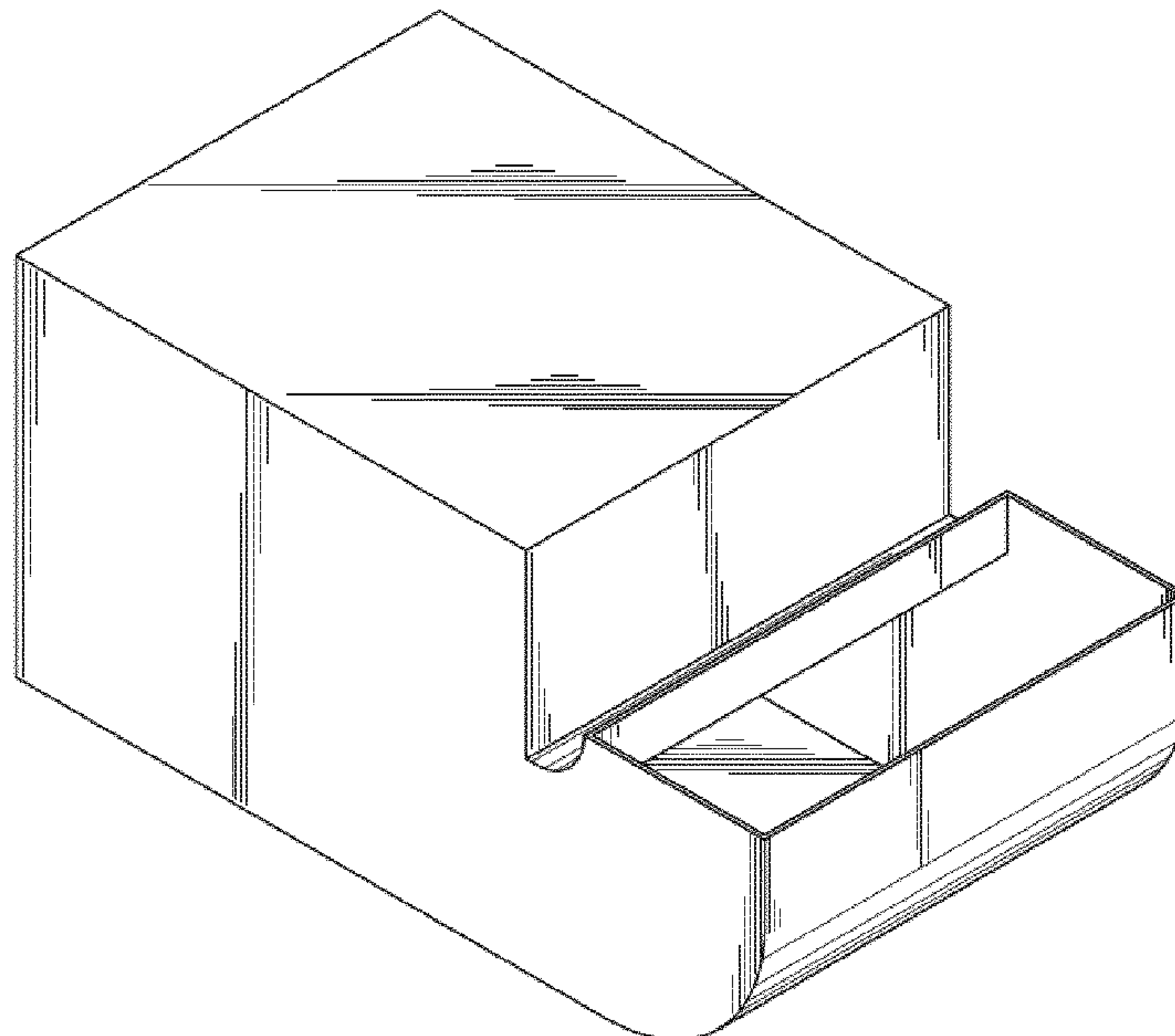
FIG. 4 depicts a side elevation view thereof.

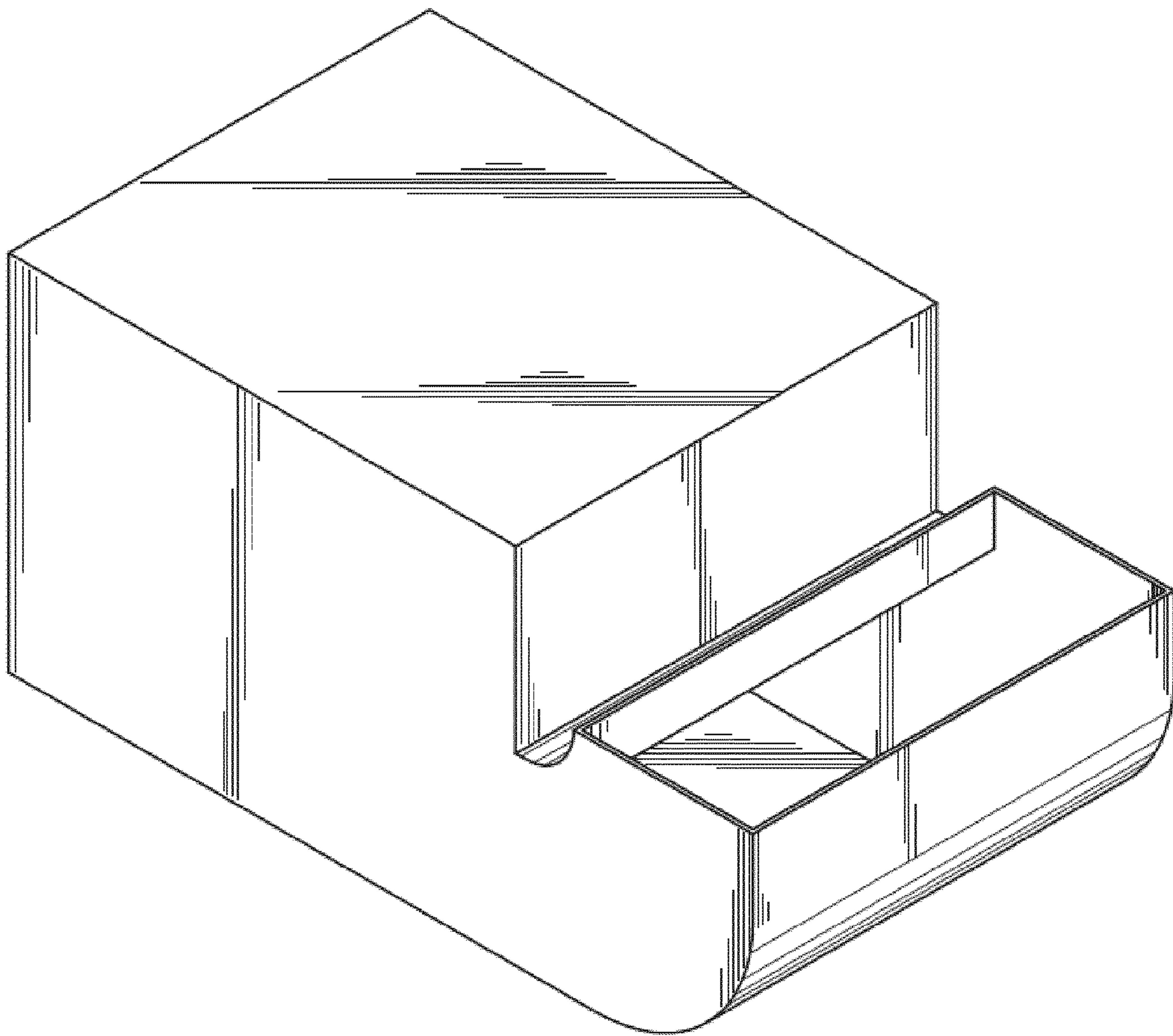

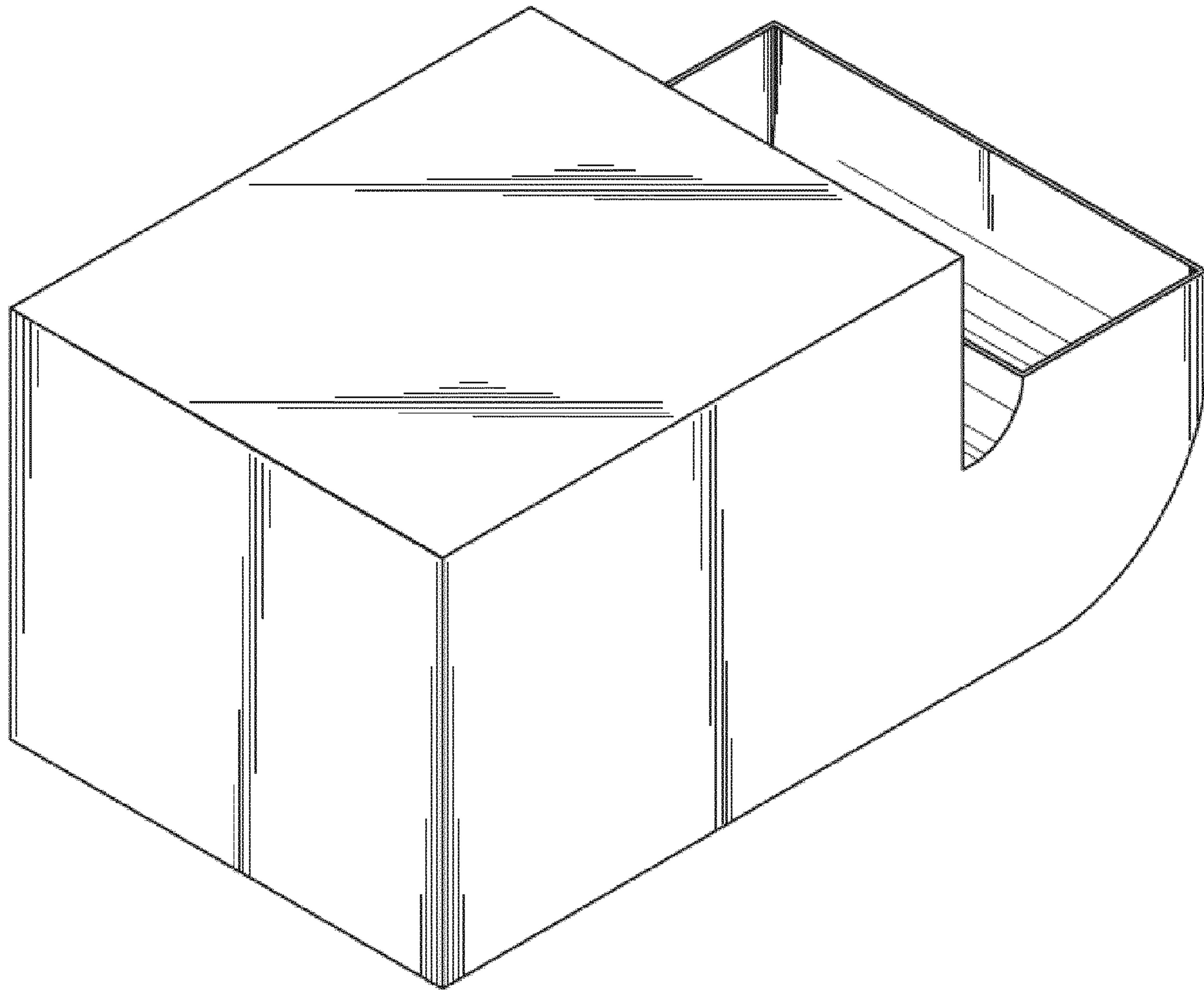

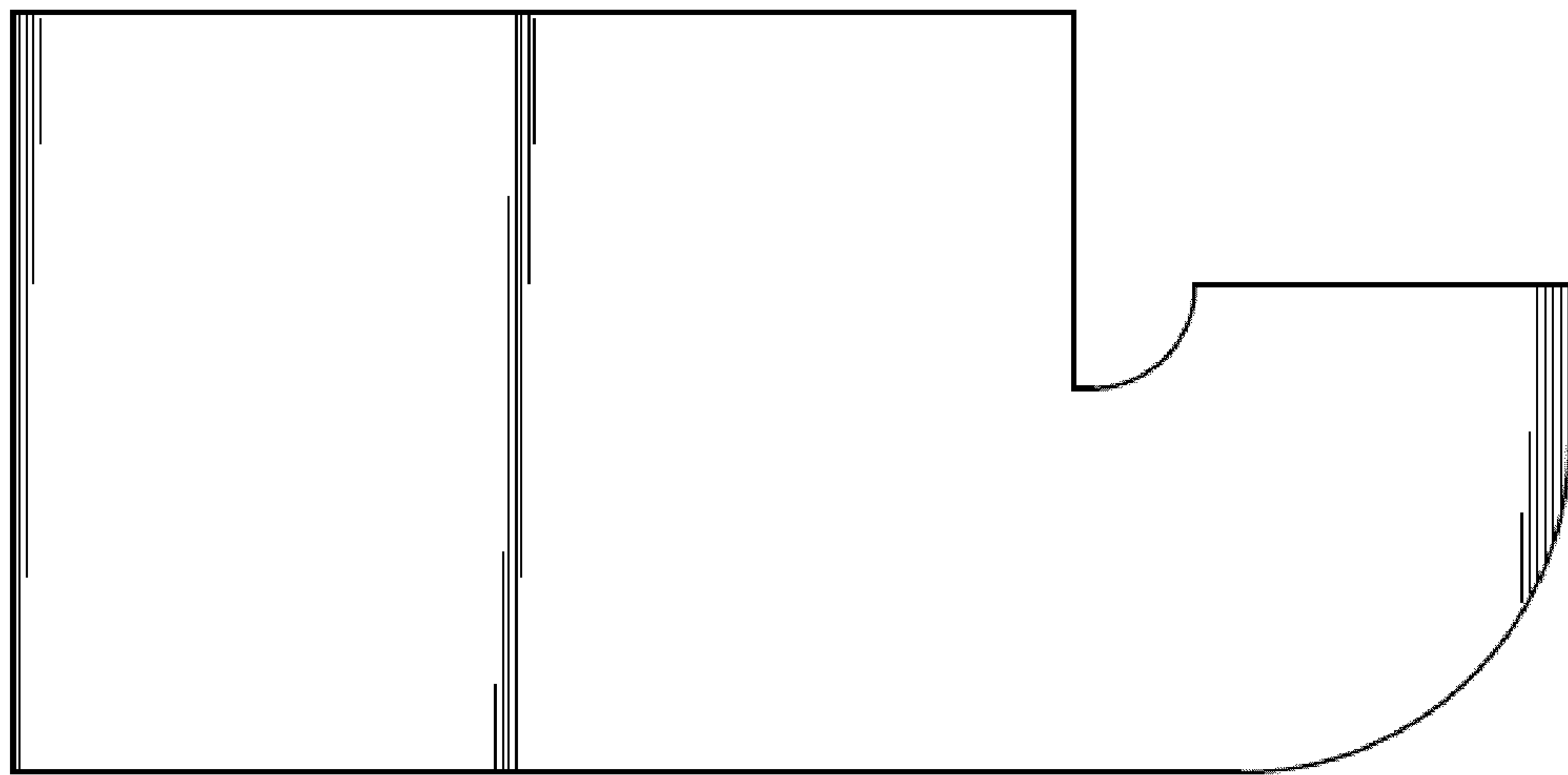

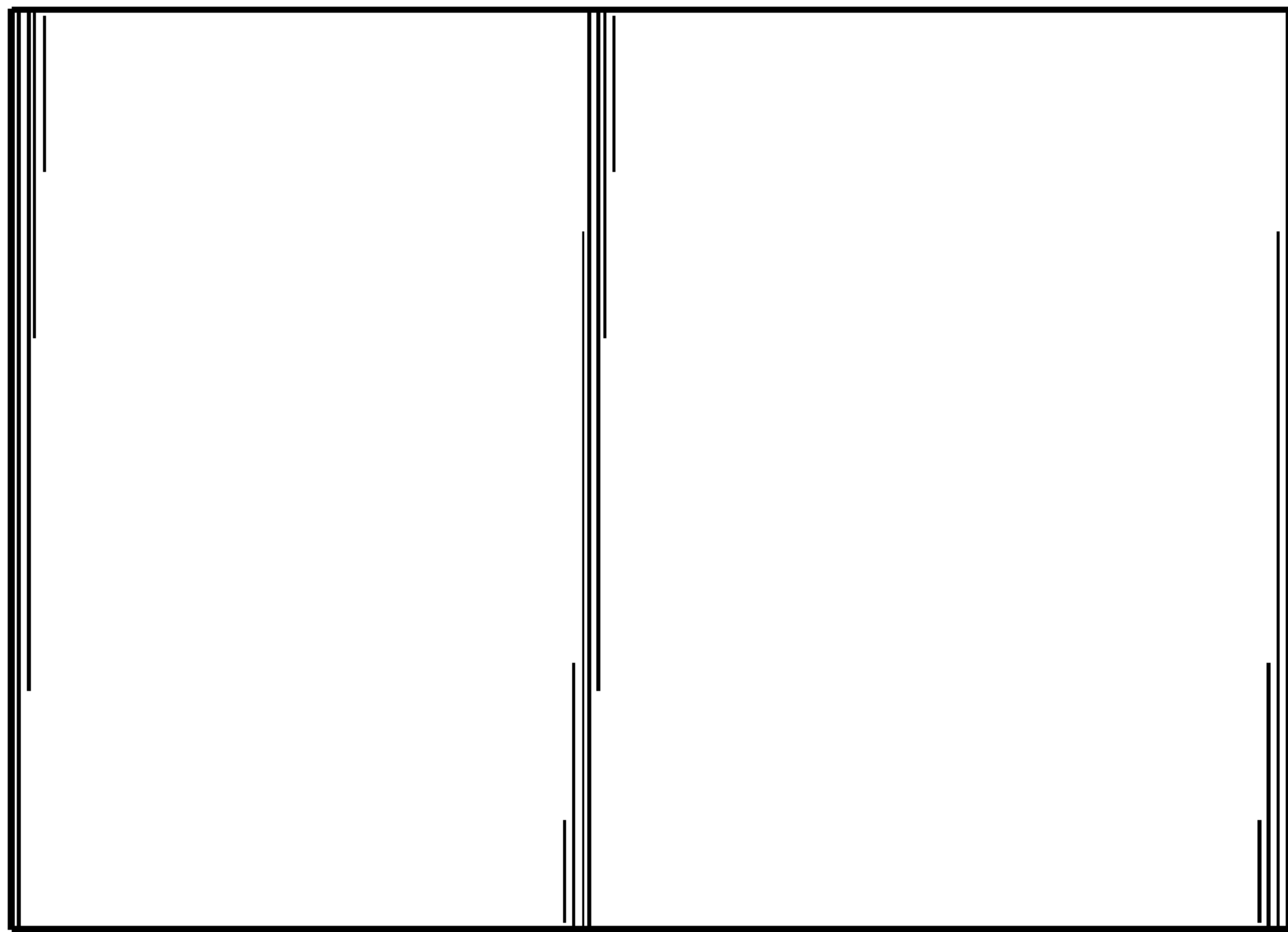

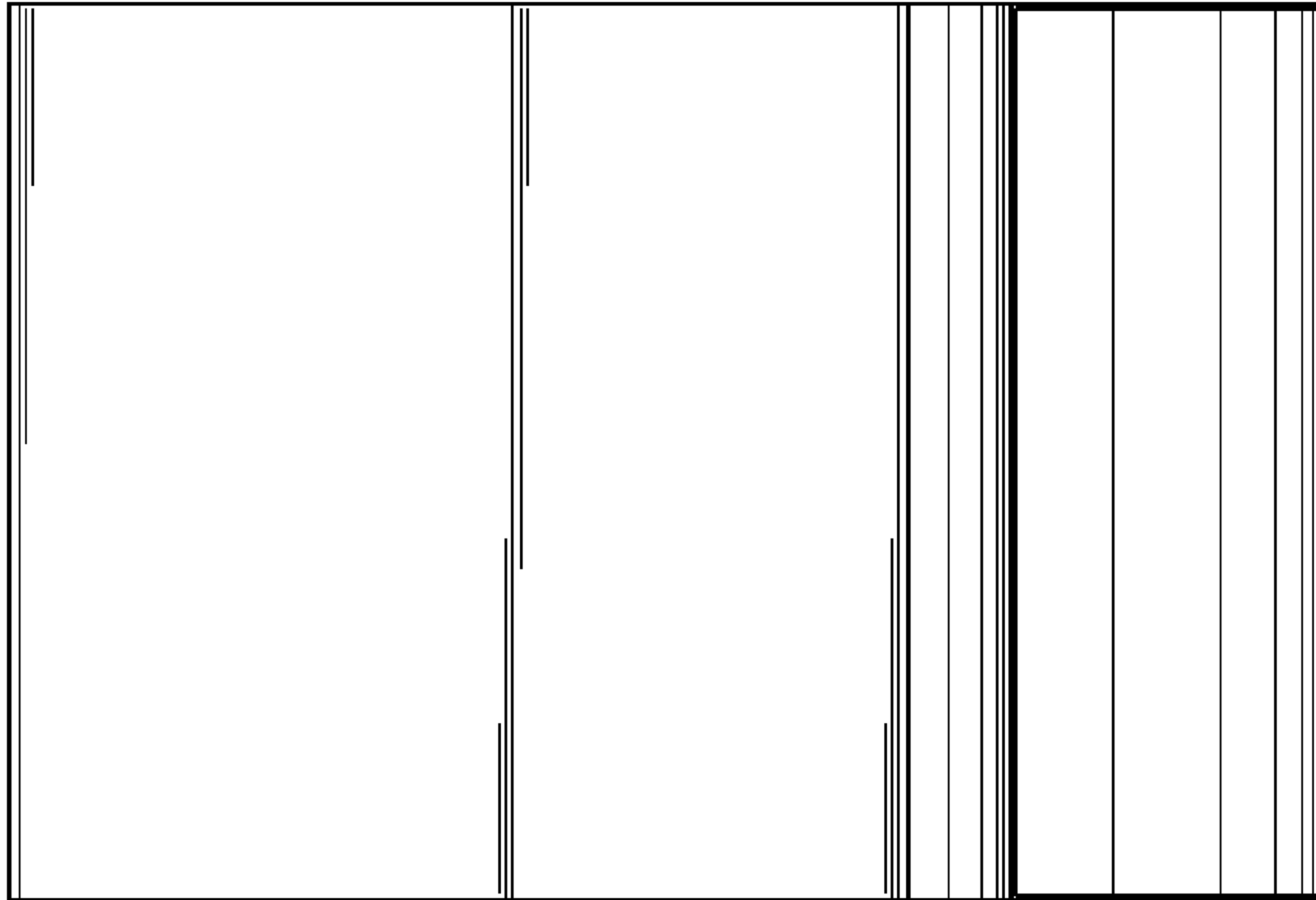

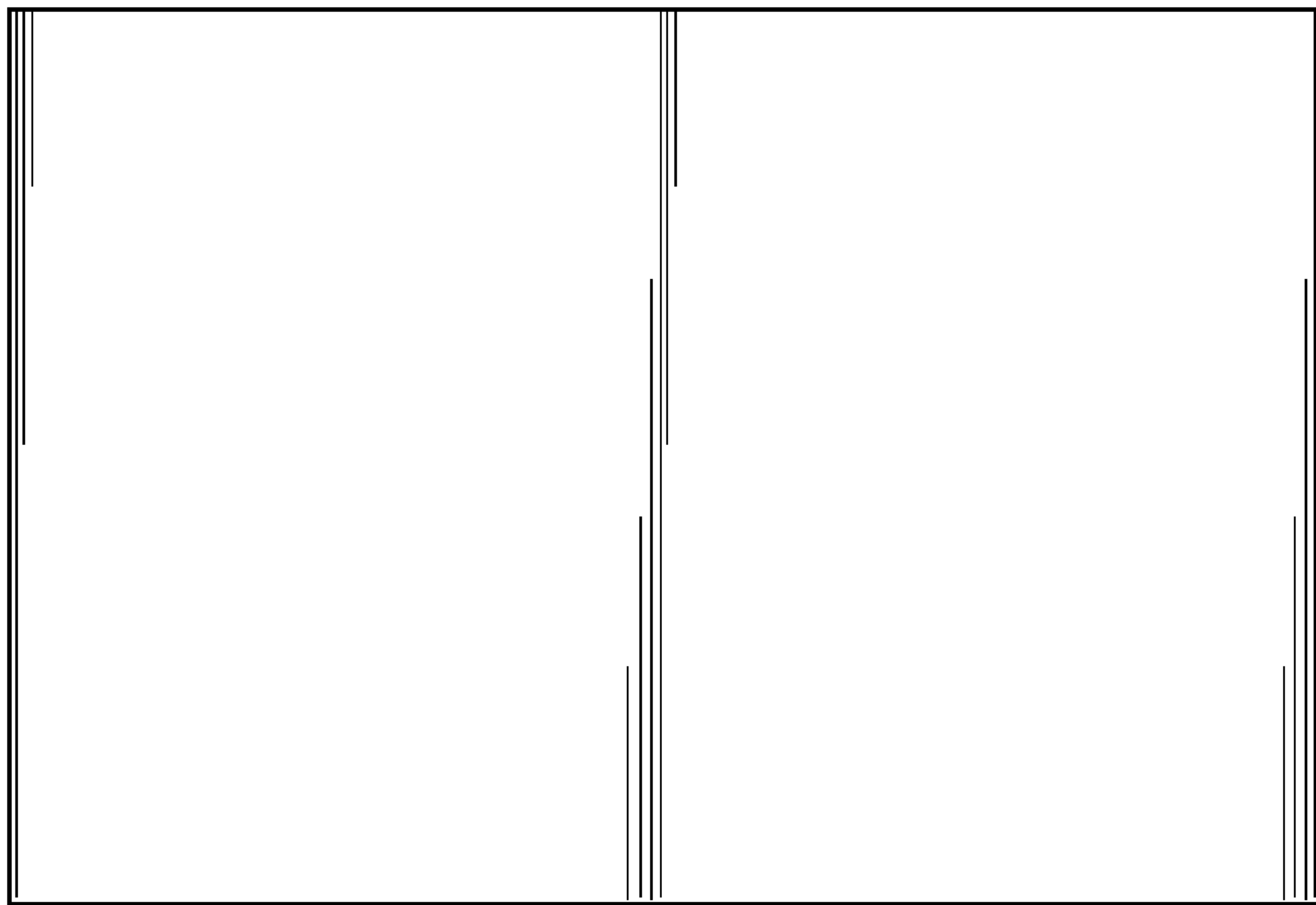
