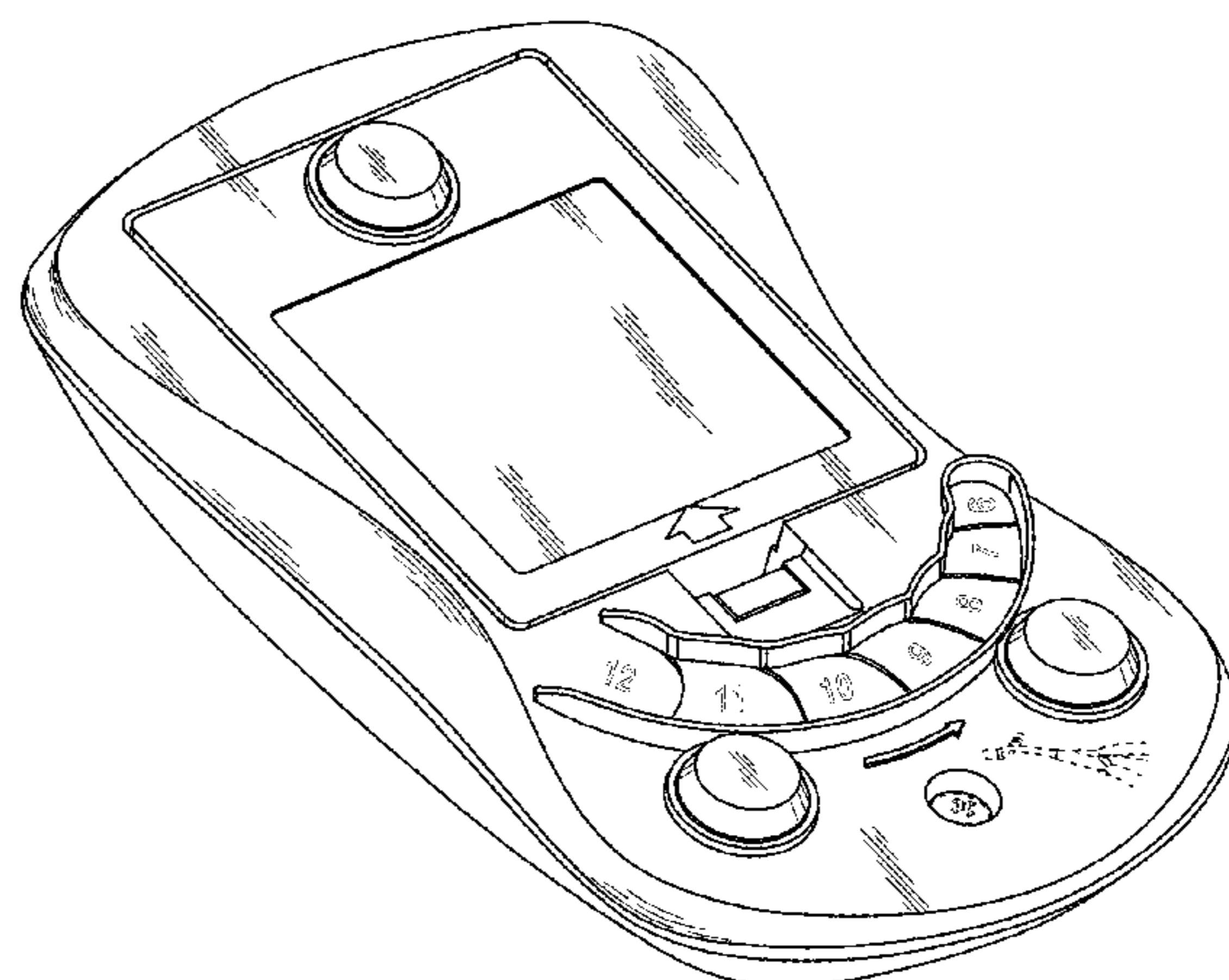
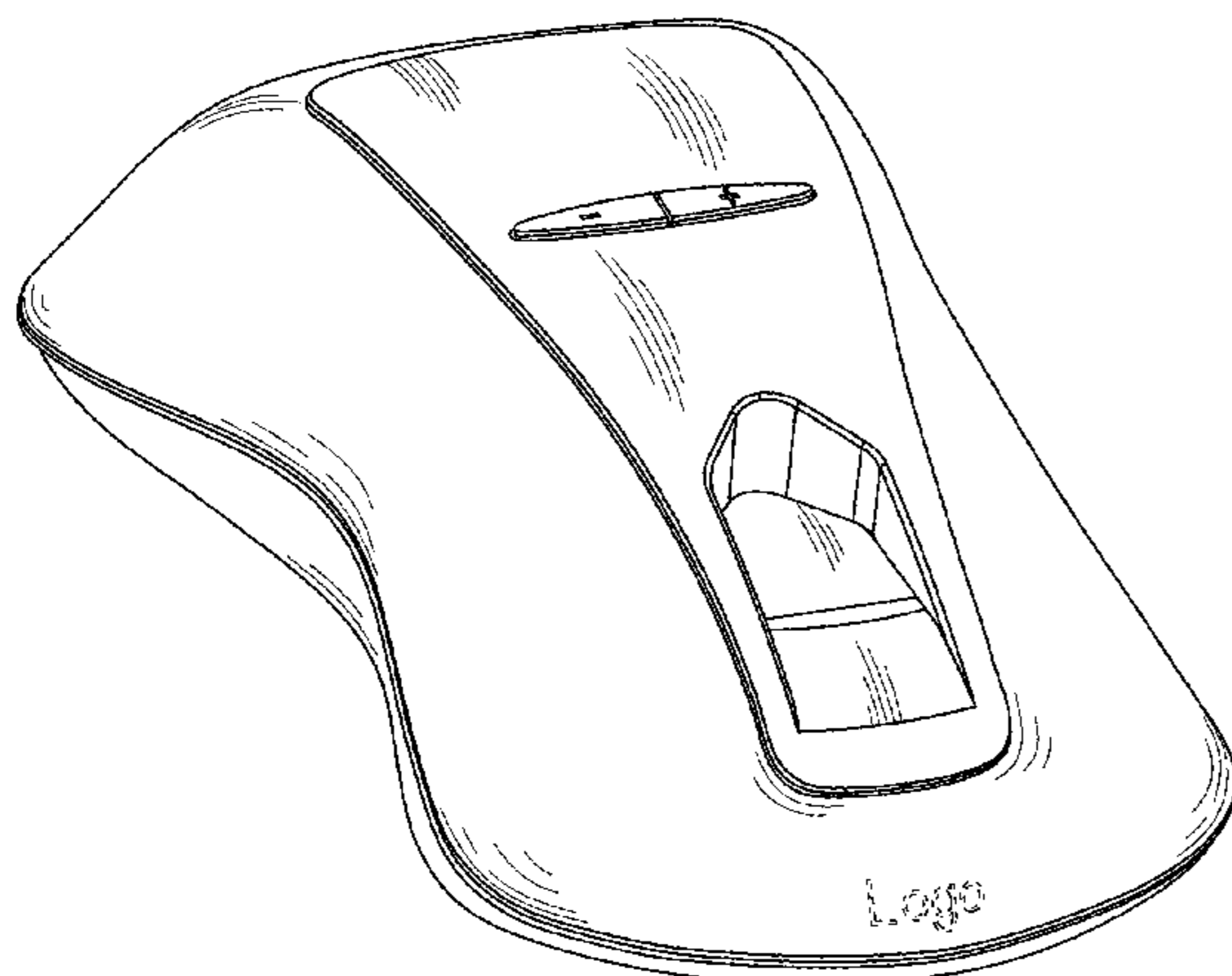
(57) **CLAIM**

The ornamental design for a light meter for dental light curing devices, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a light metering device for dental curing devices showing my new design.

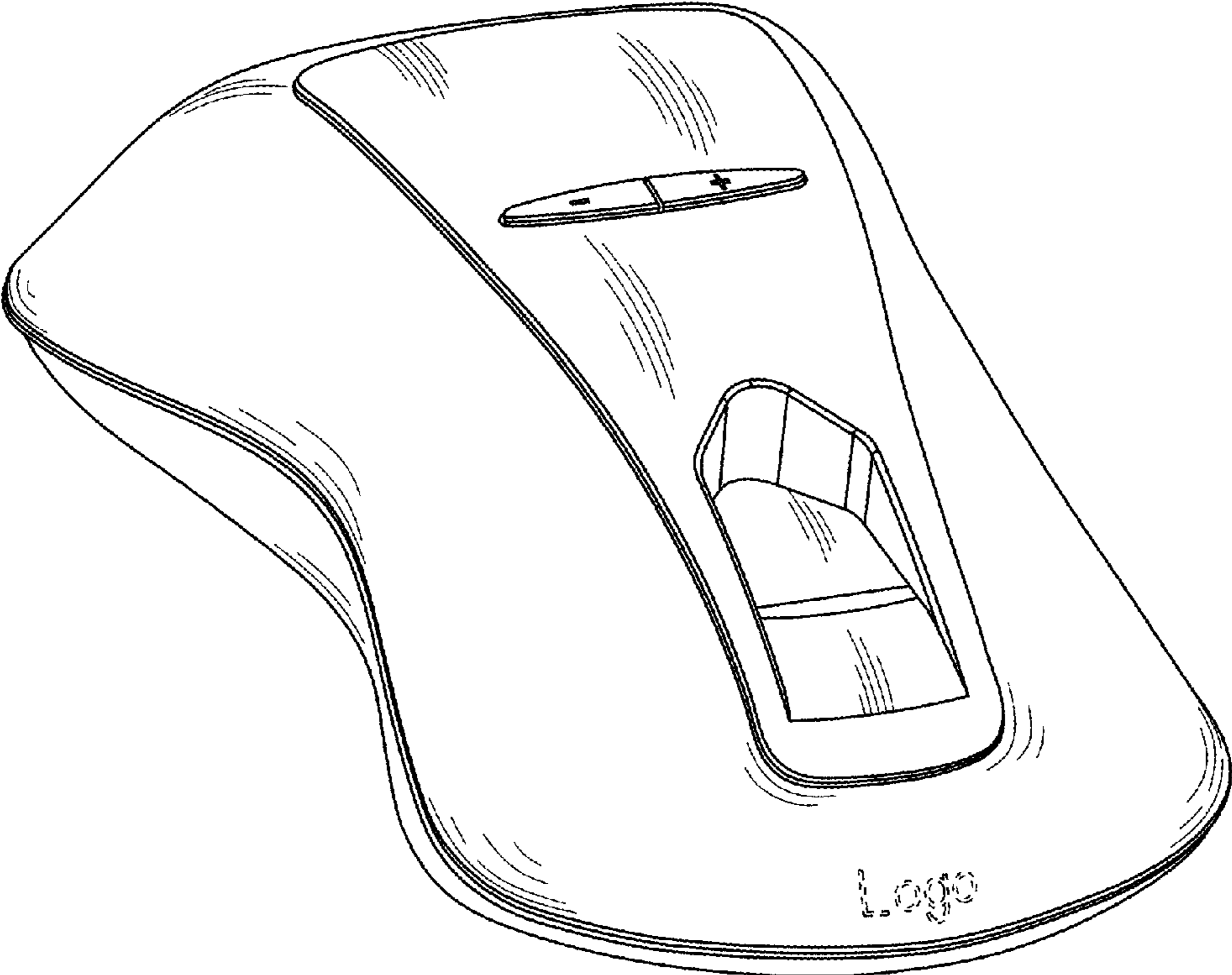

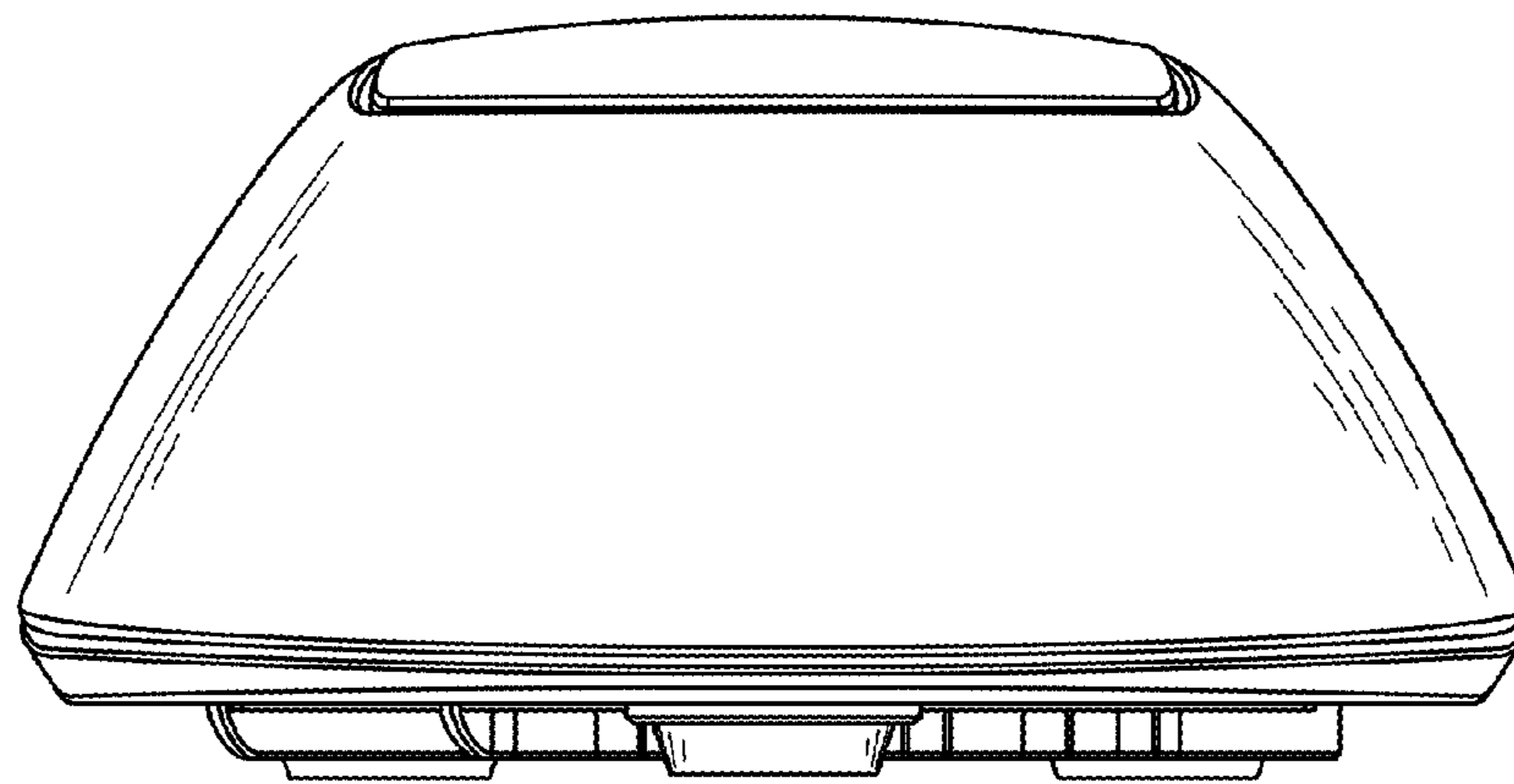

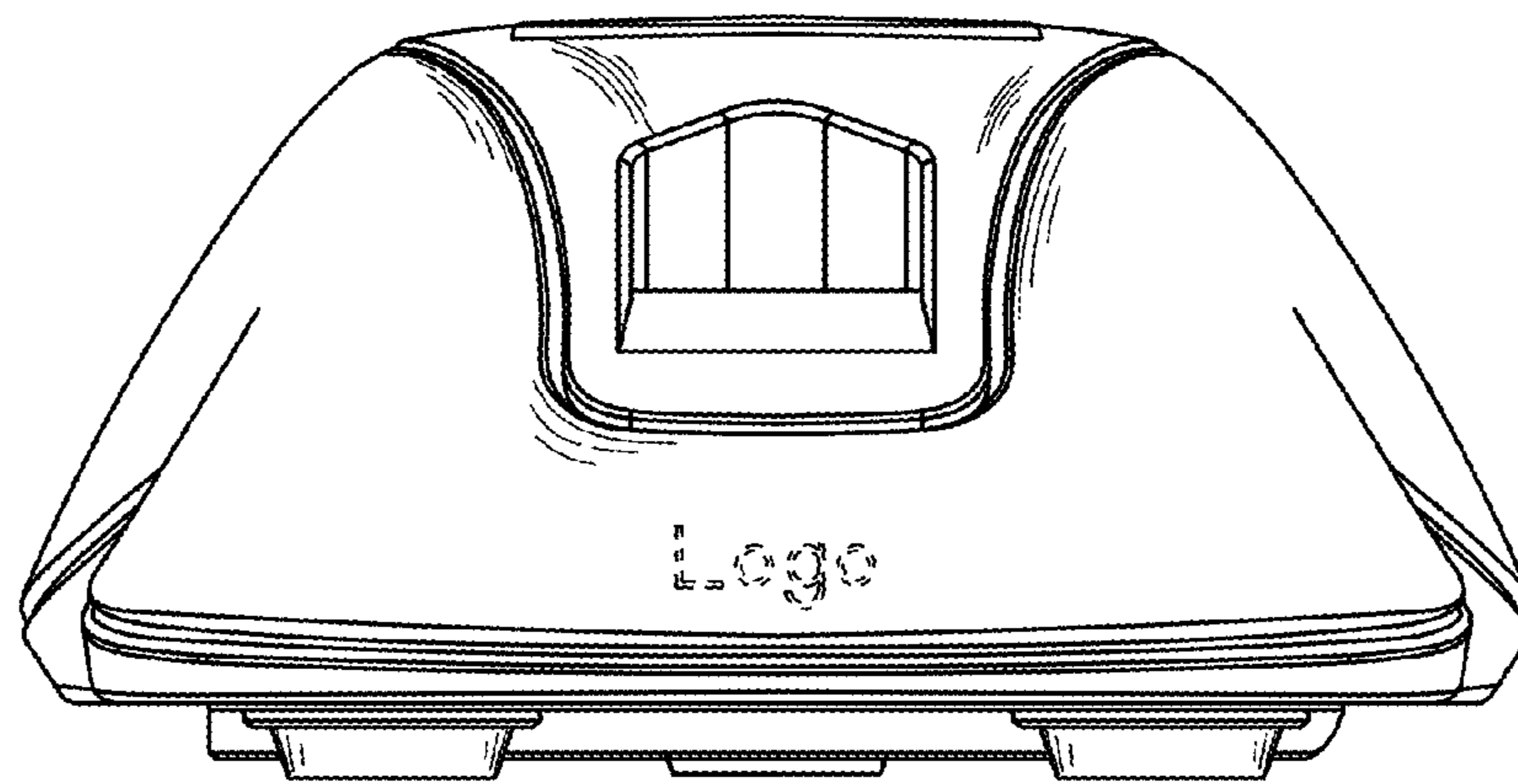

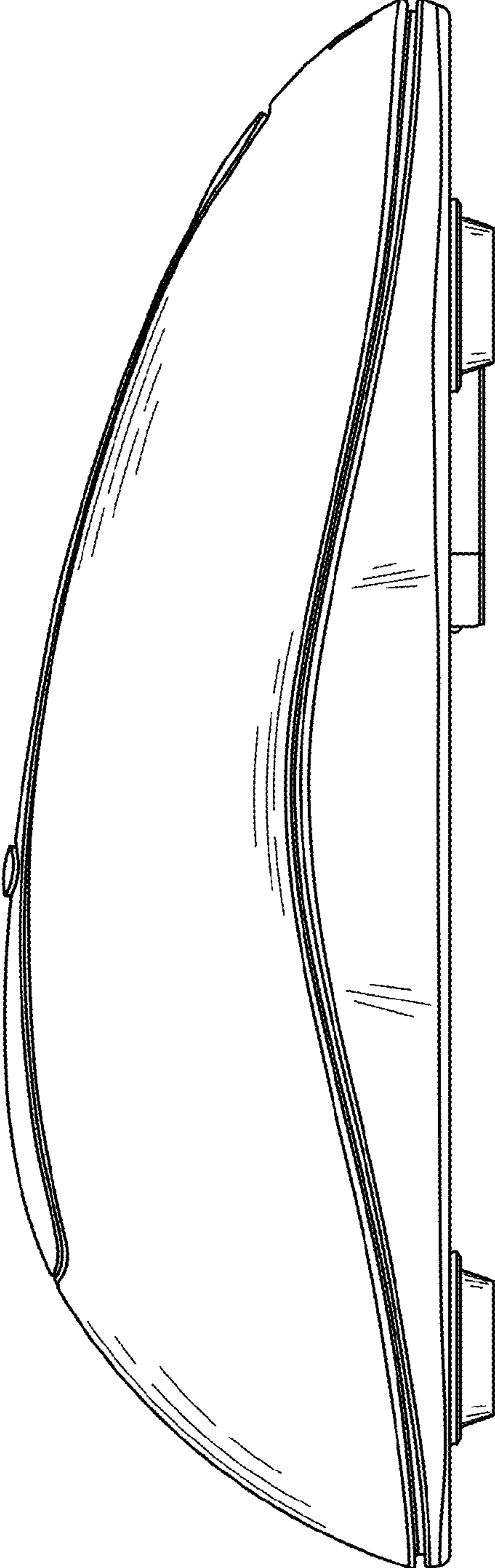

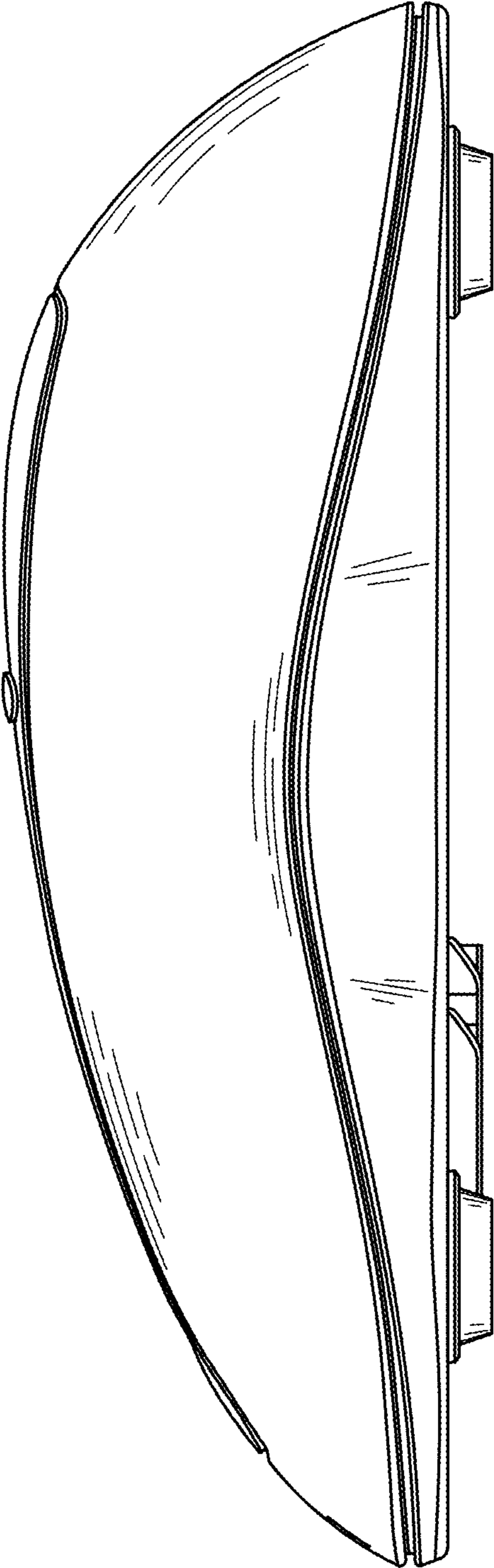

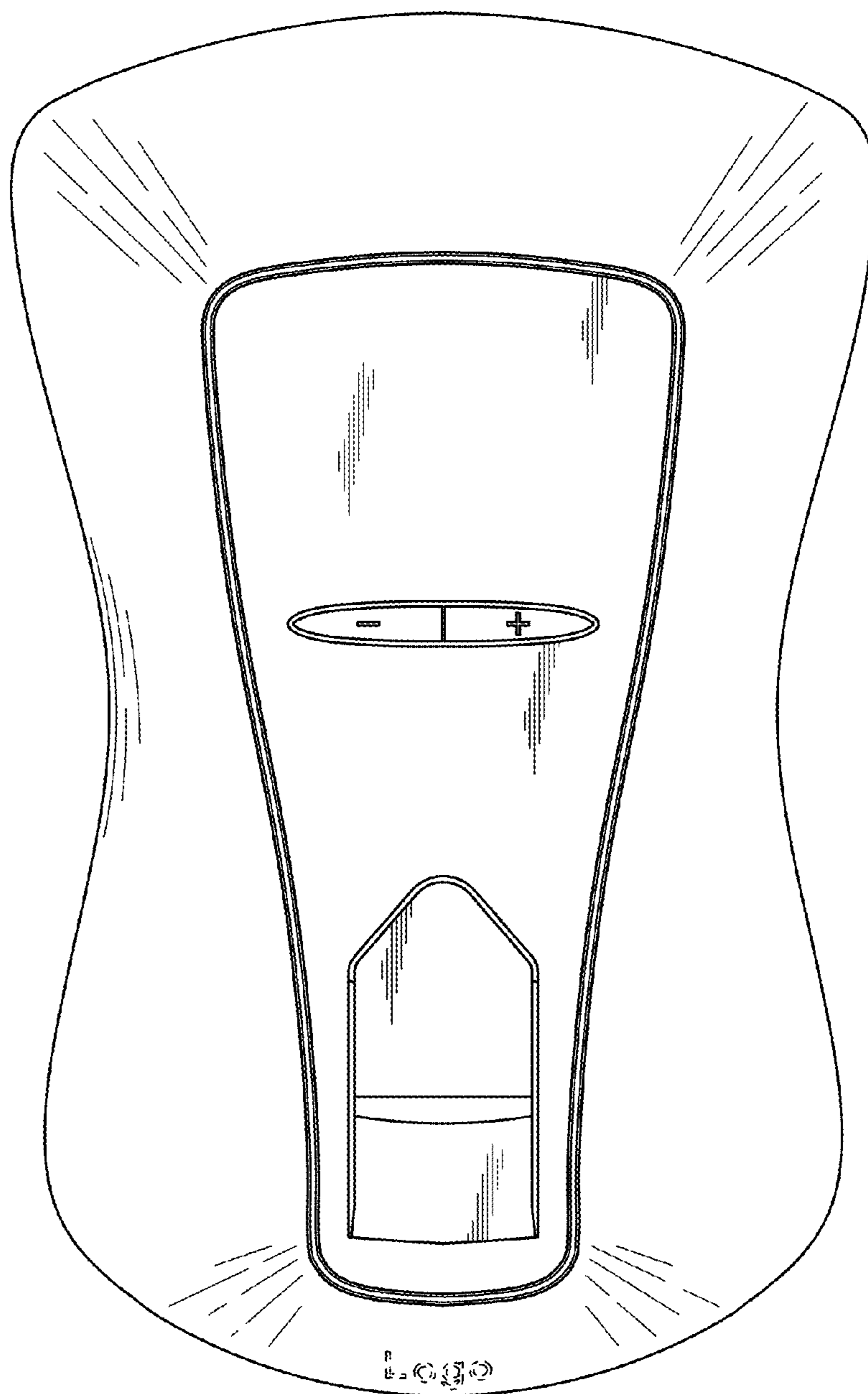

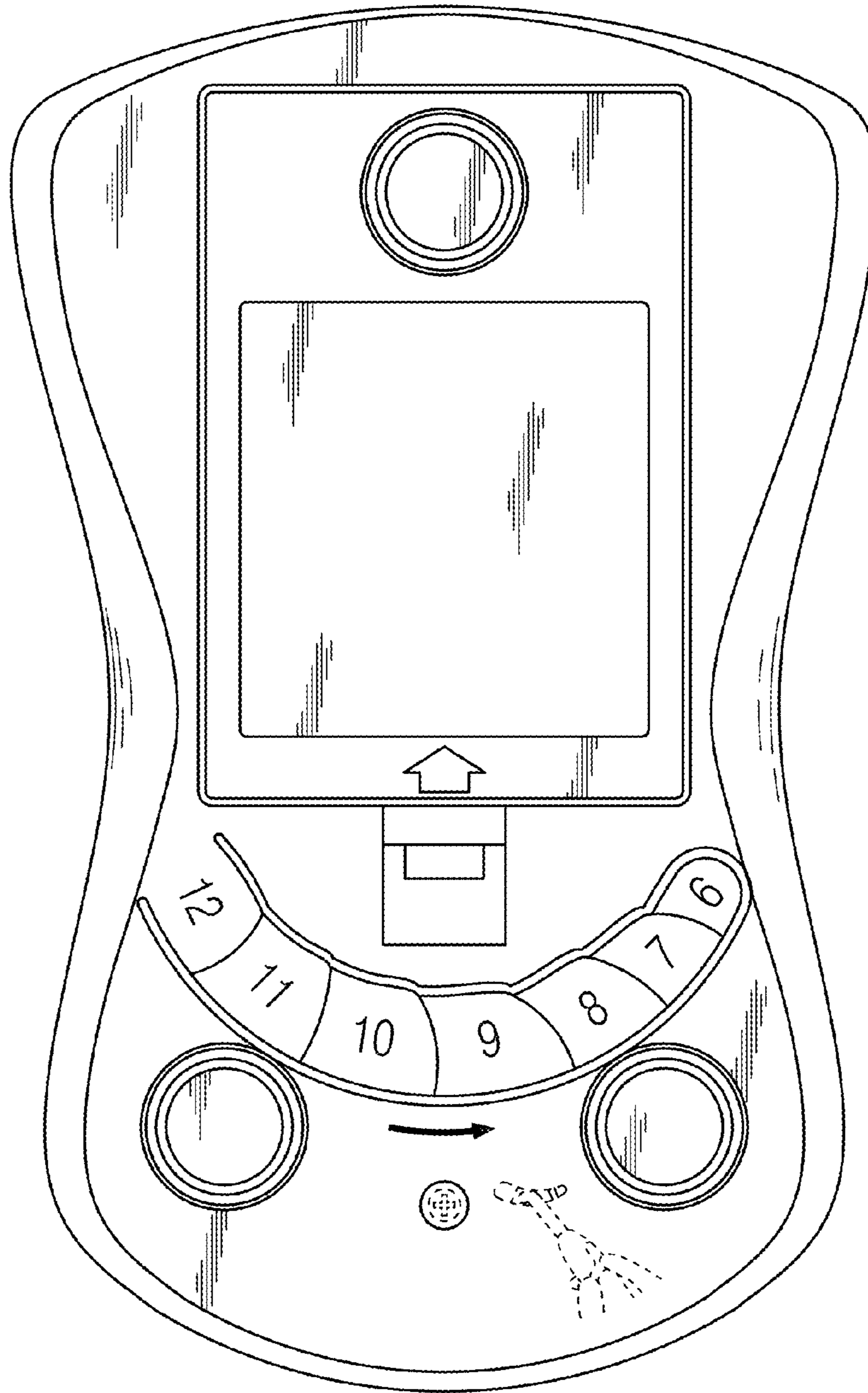

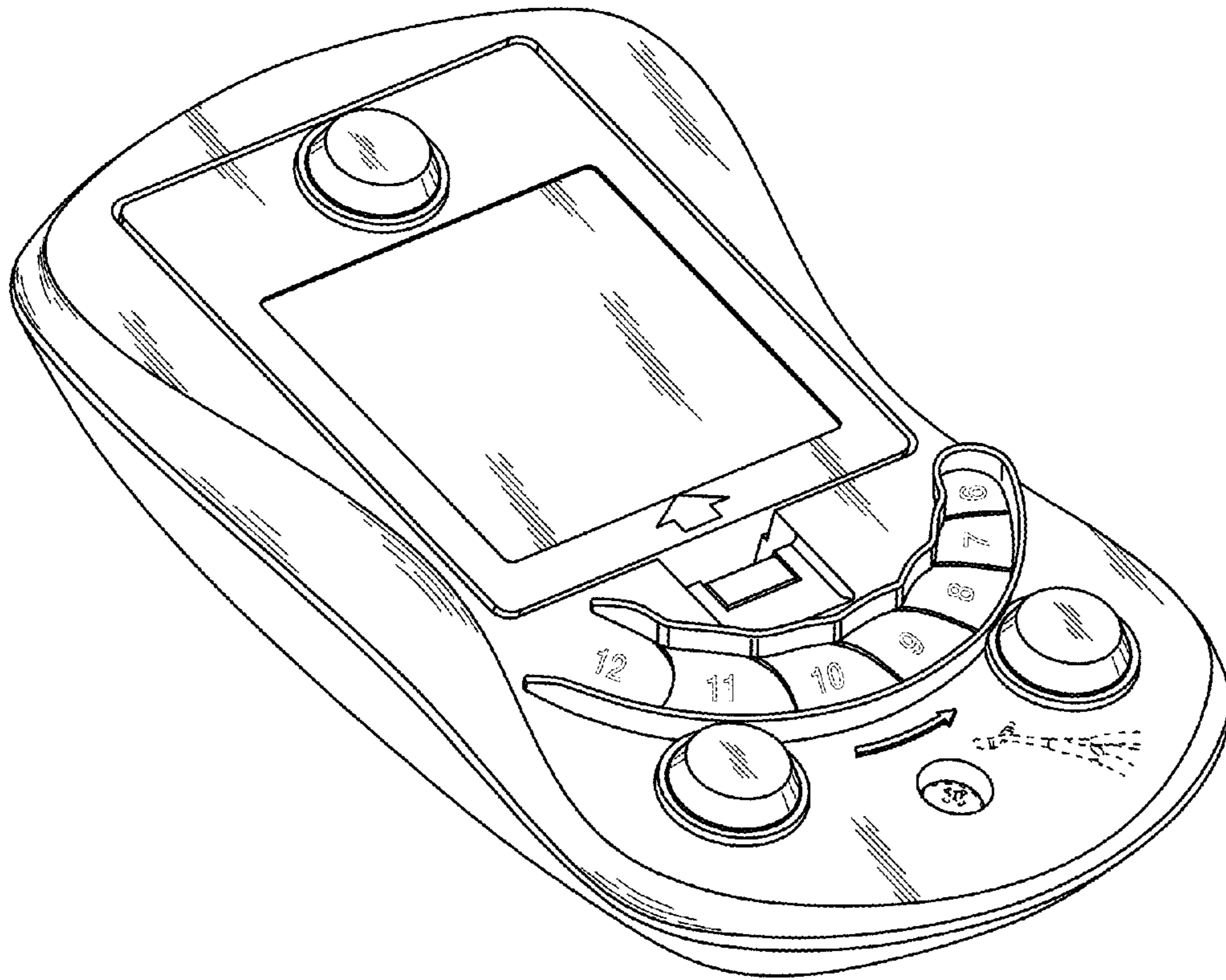
