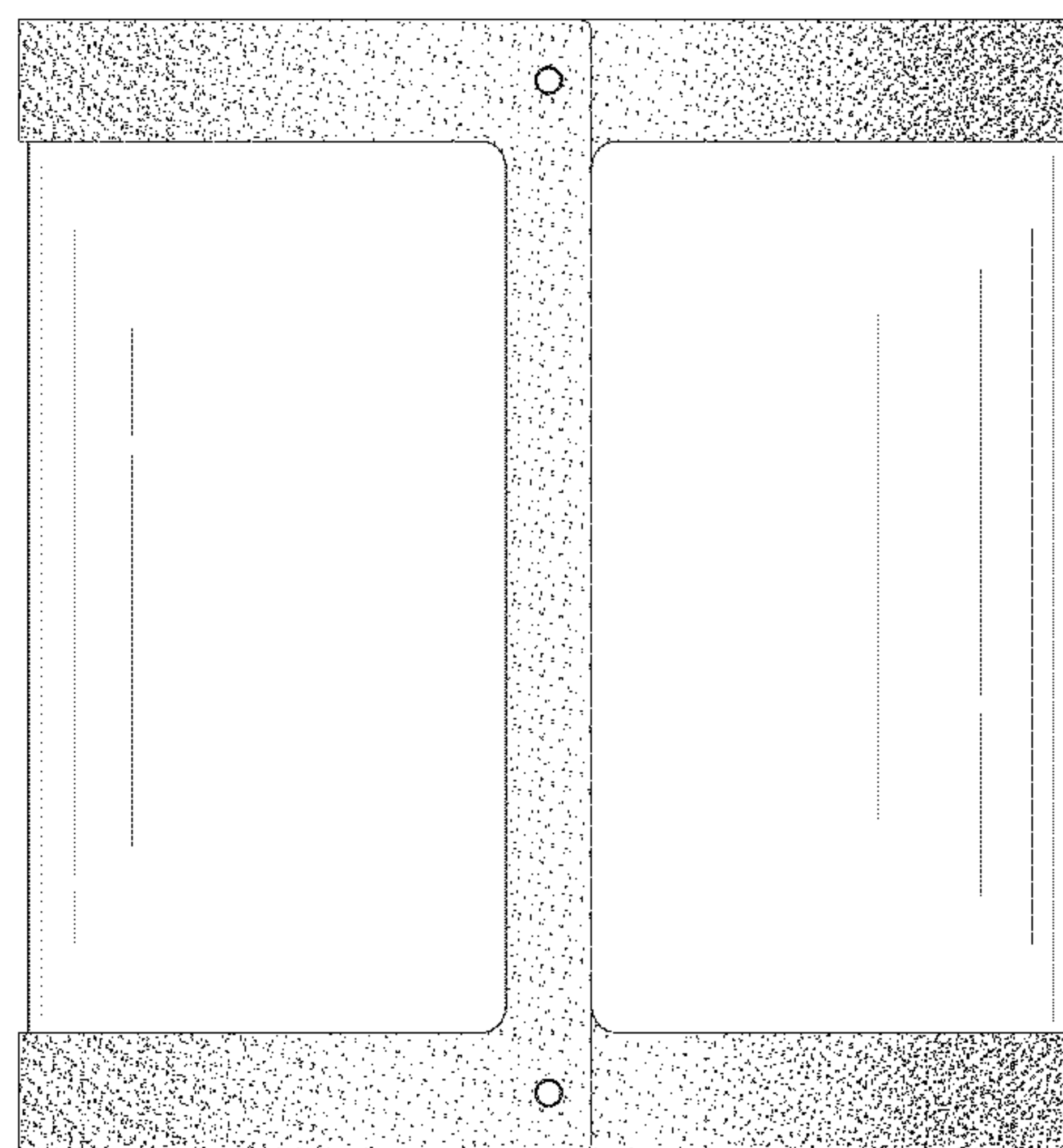
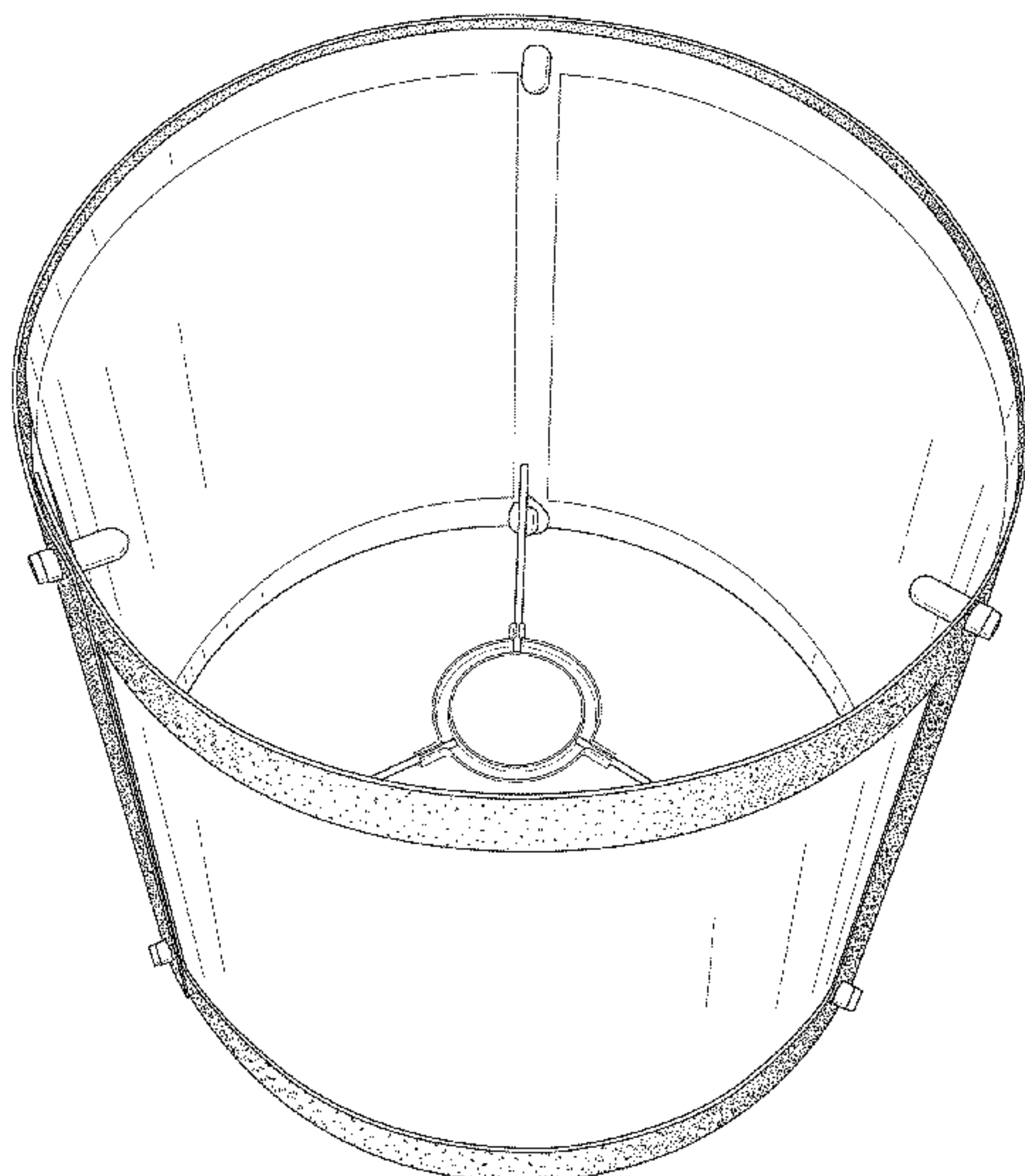
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a frontal perspective view of the lamp shade; FIG. 2 is a front view of the lamp shade; FIG. 3 is a back view of the lamp shade; FIG. 4 is a right view of the lamp shade; FIG. 5 is a top view of the lamp shade; and, FIG. 6 is a bottom view of the lamp shade.

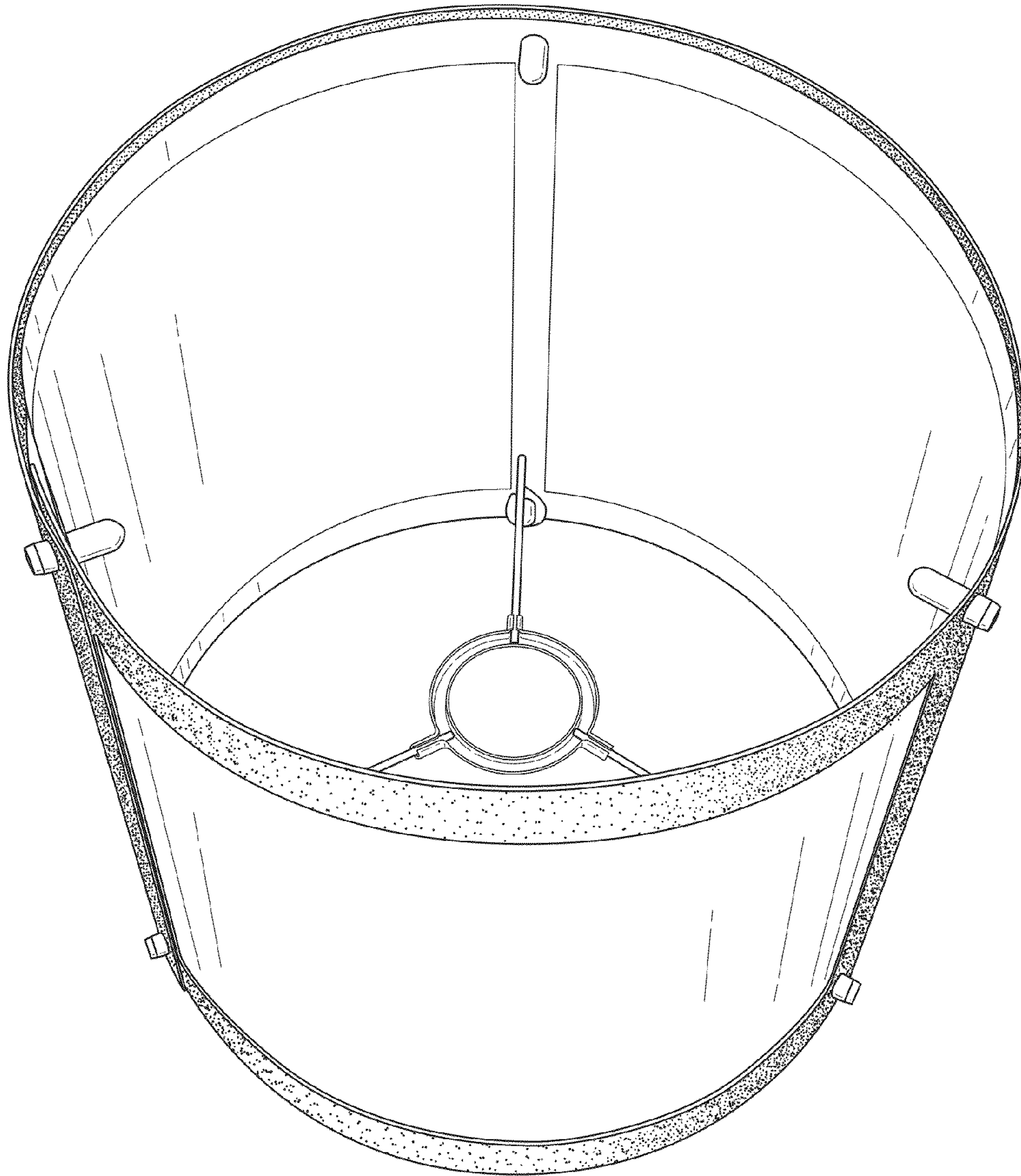

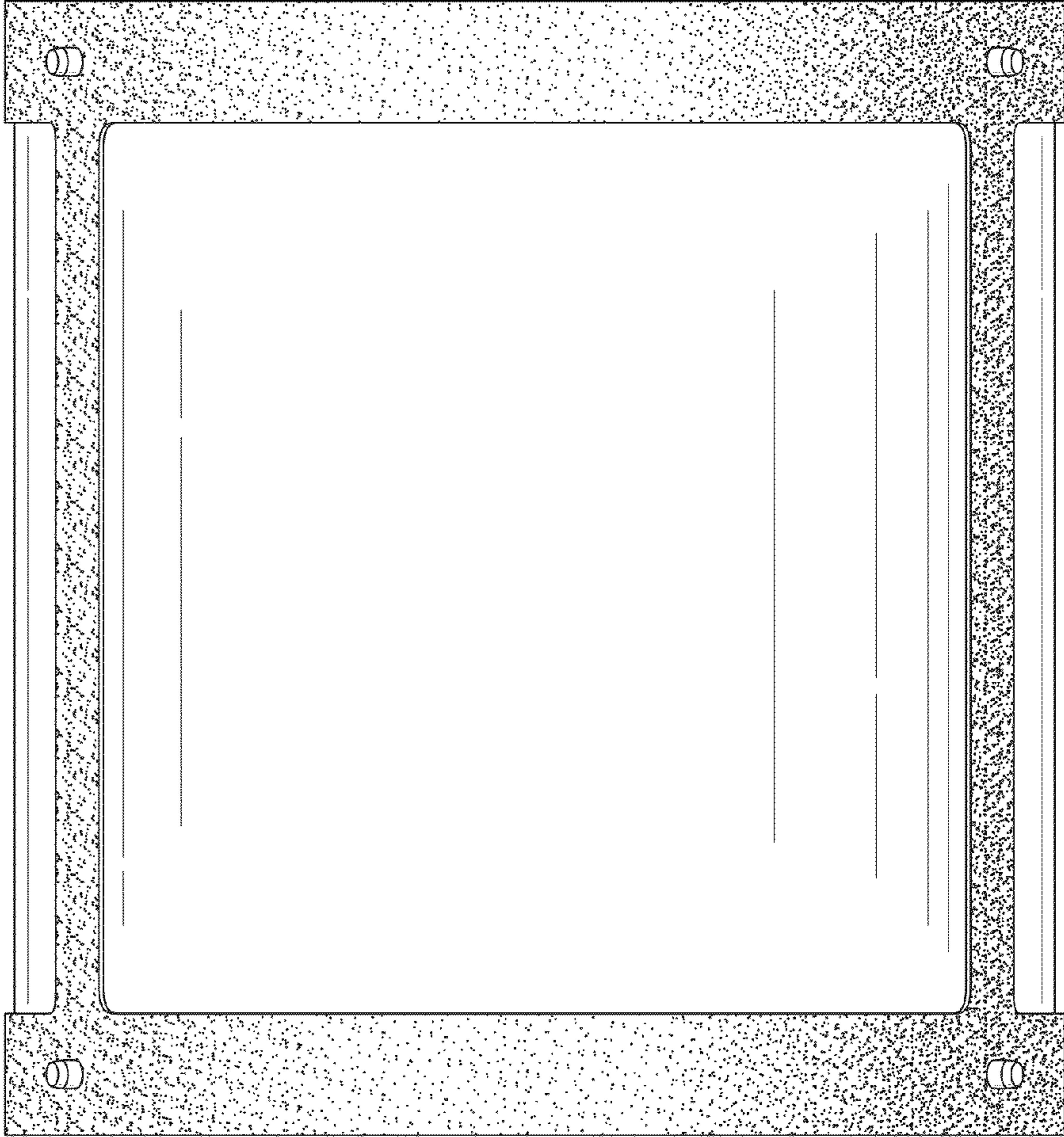

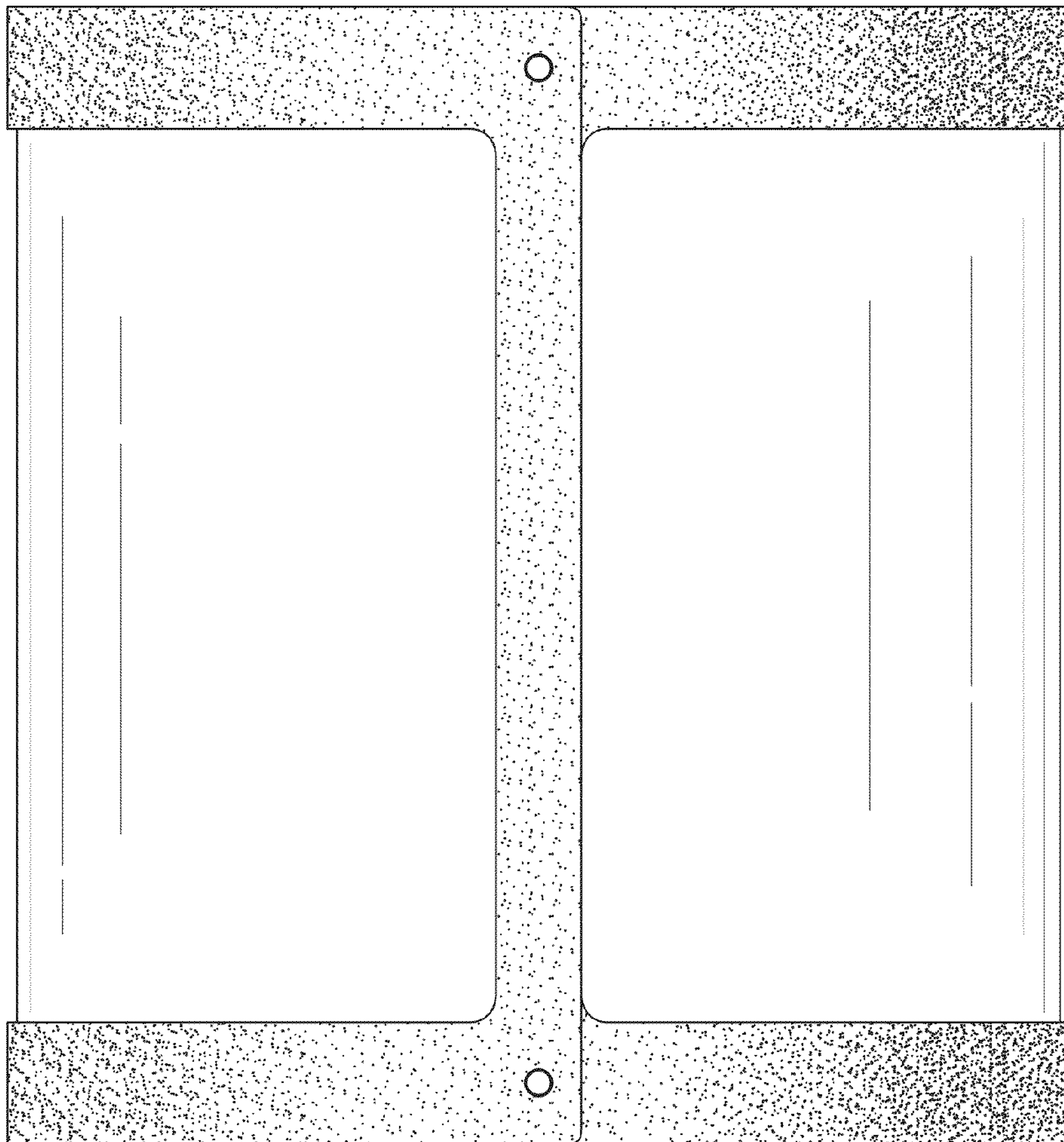

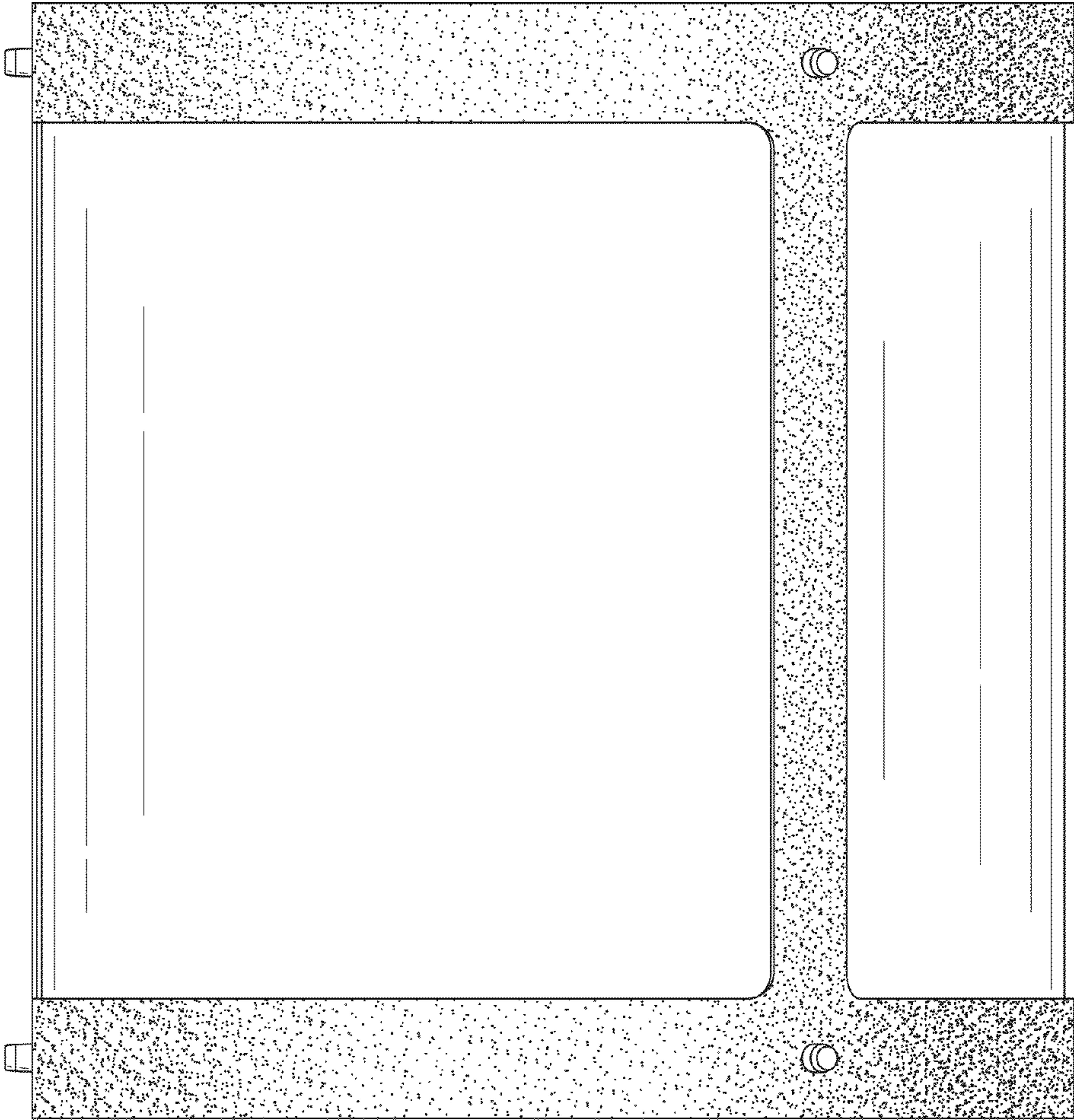

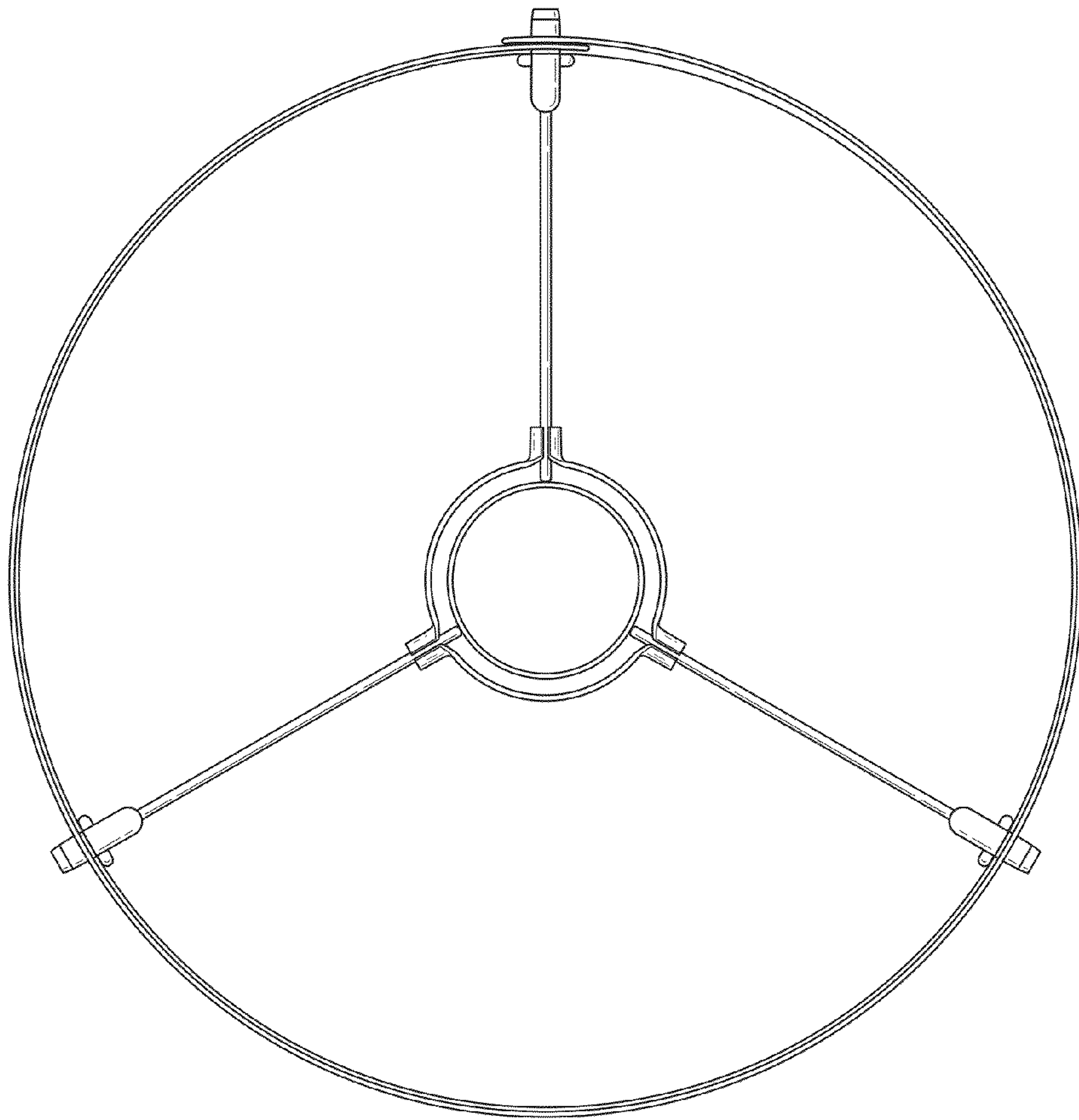

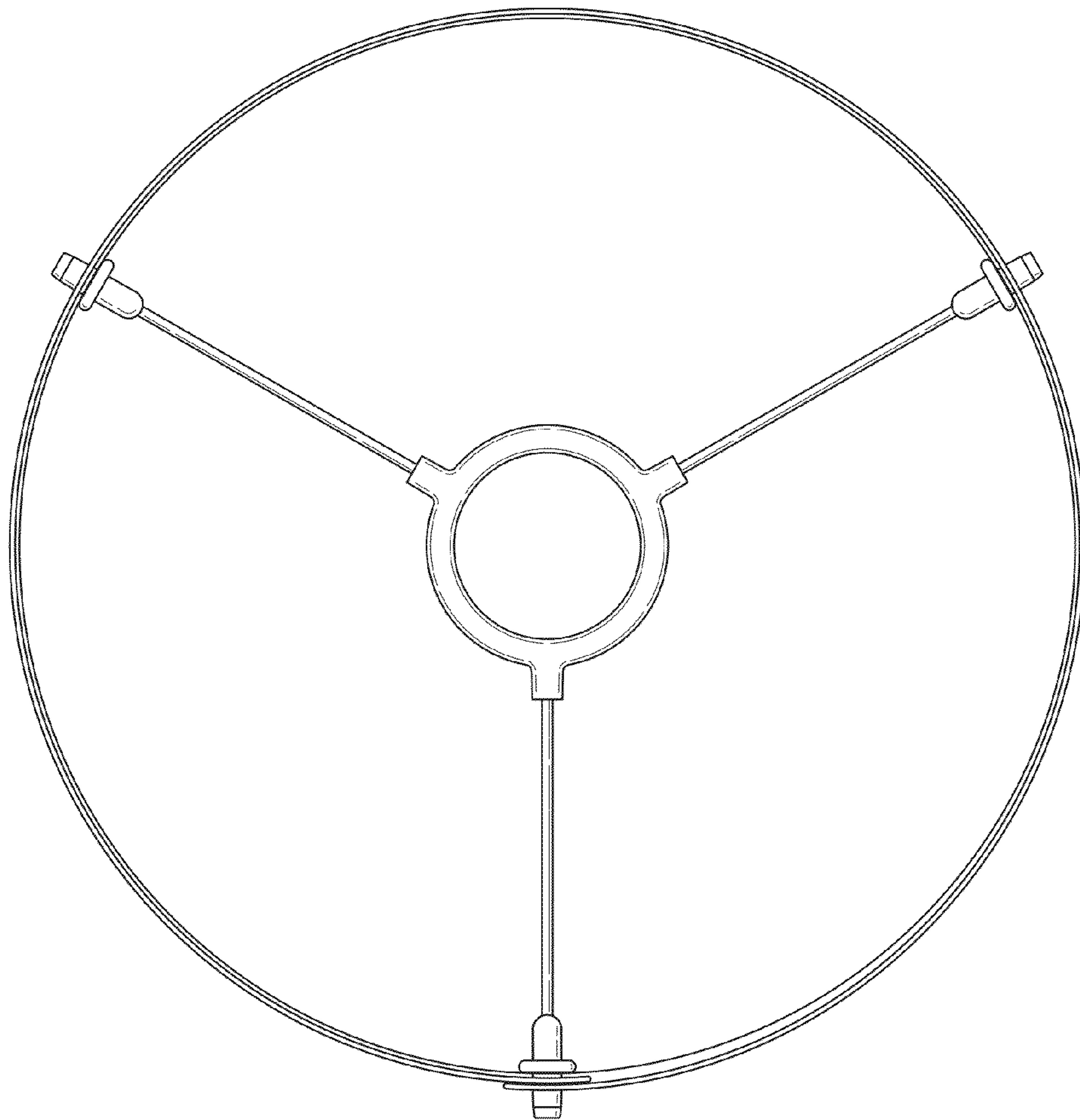
