(57) **CLAIM**

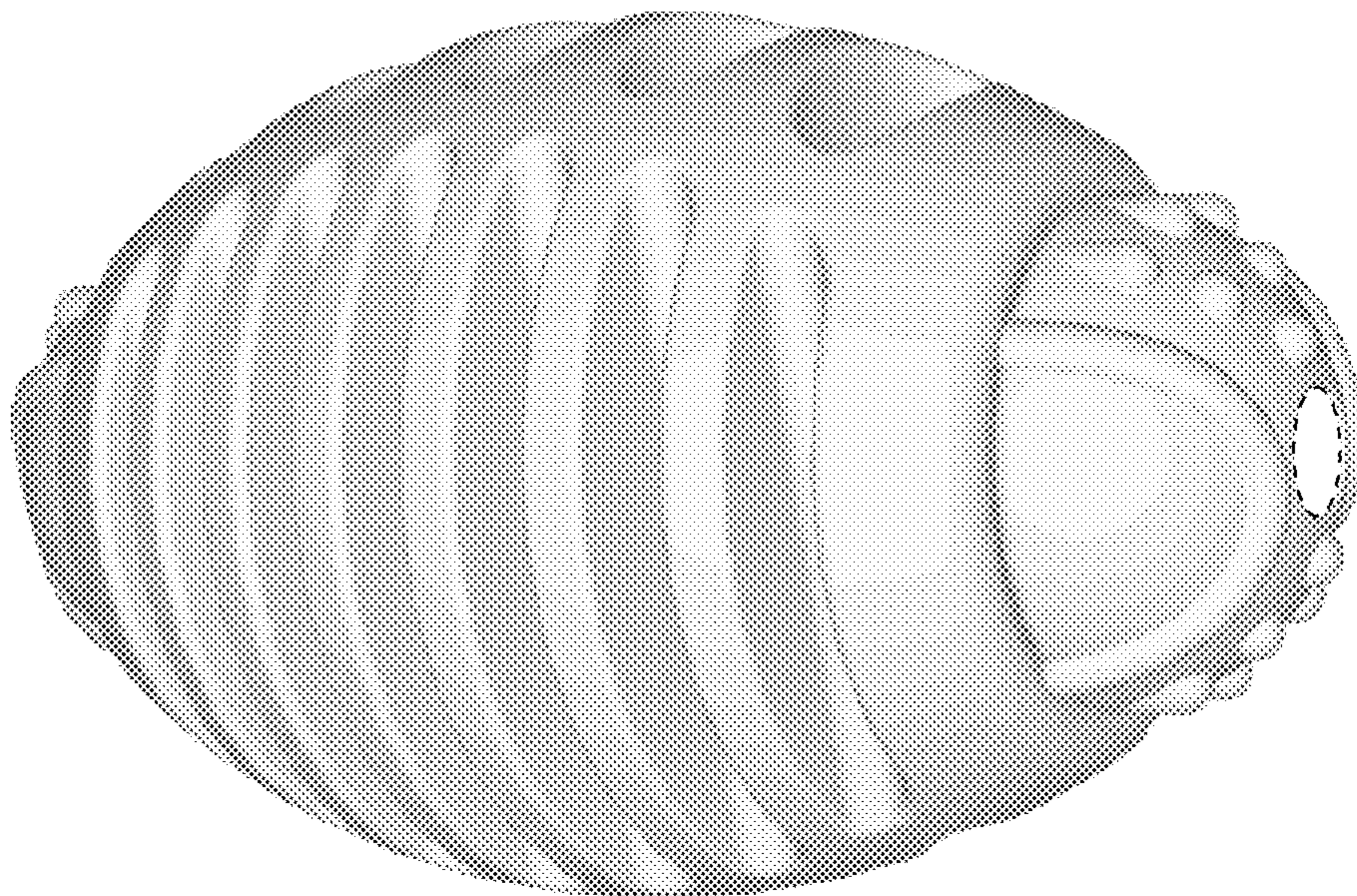
The ornamental design for a football-shaped chew toy, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a bone-shaped chew toy, from the right, front and top, showing my new design;  
 FIG. 2 is a perspective view thereof, from the left, rear and bottom;  
 FIG. 3 is a front elevational view thereof, the rear elevational view being a mirror image; and,  
 FIG. 4 is a top plan view thereof, the bottom plan view being a mirror image.  
 Broken lines depict environmental subject matter and form no part of the claimed design.

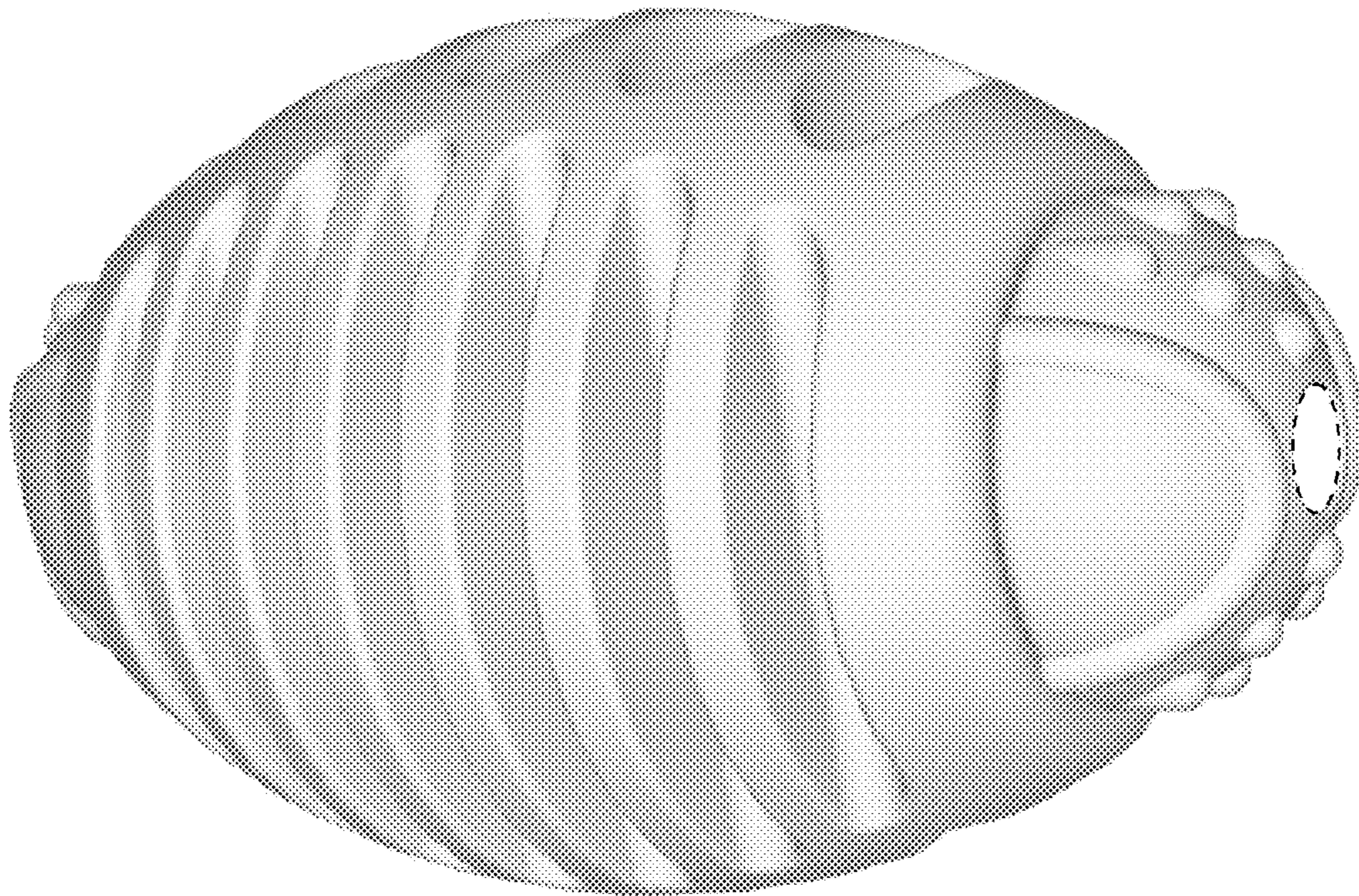

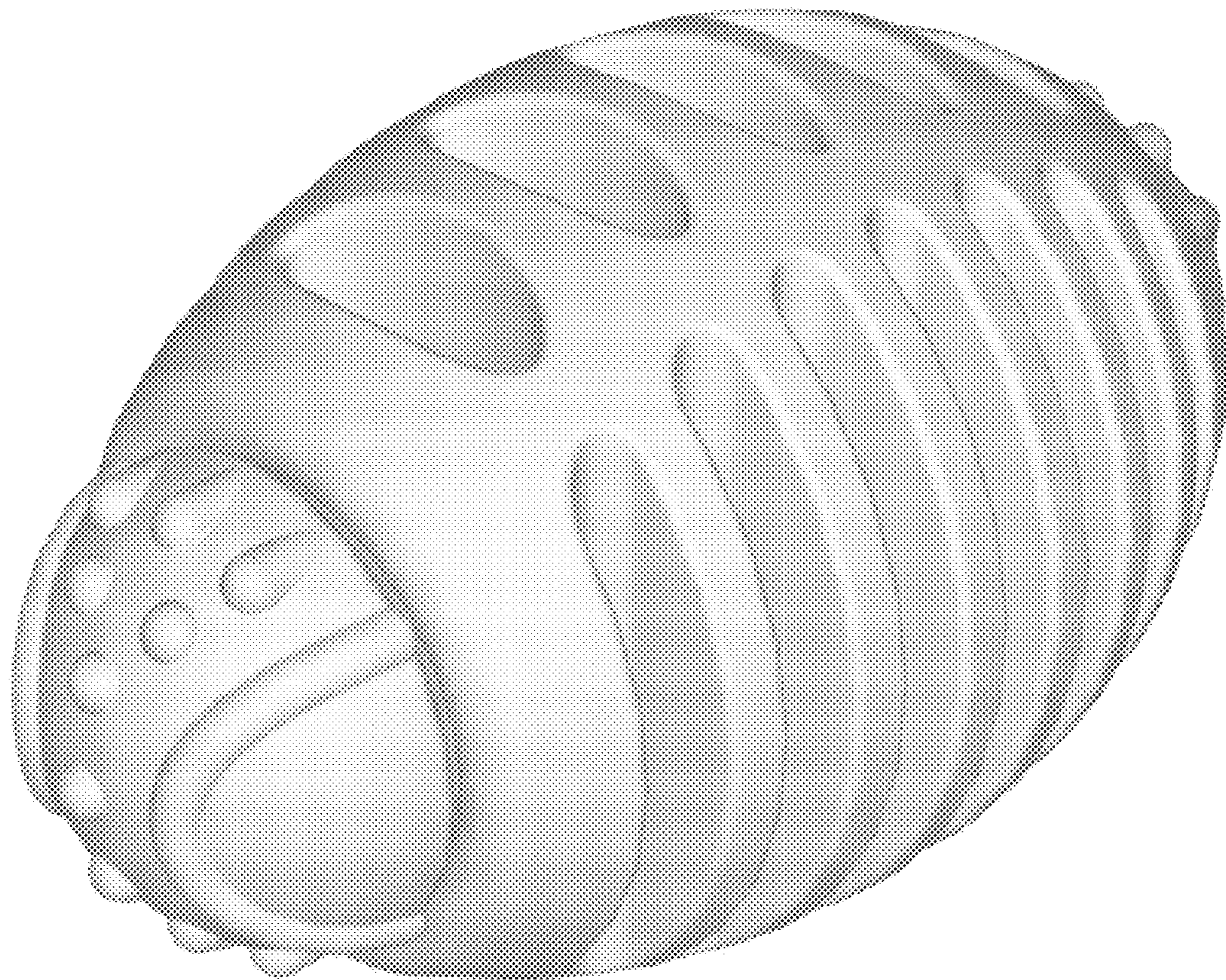

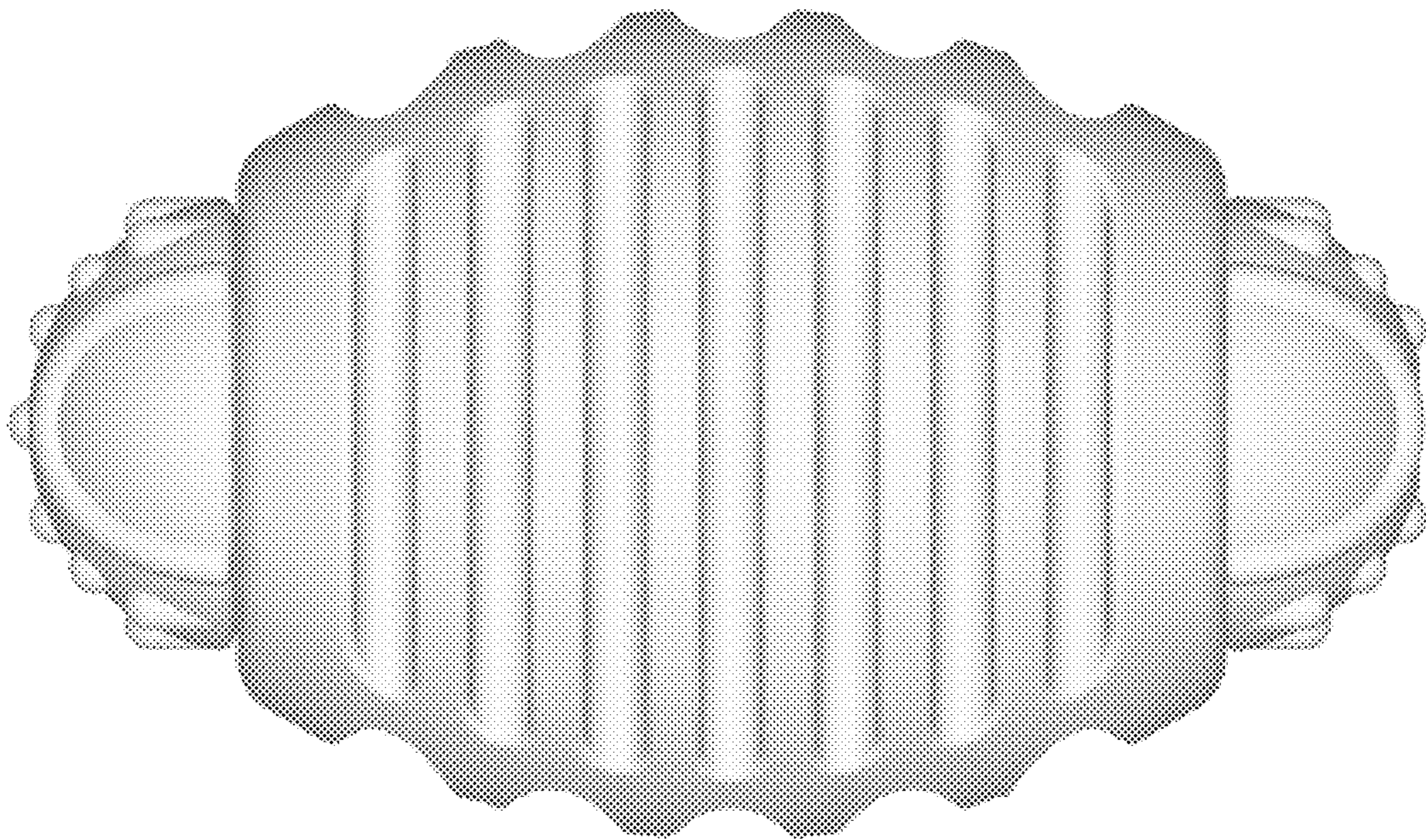

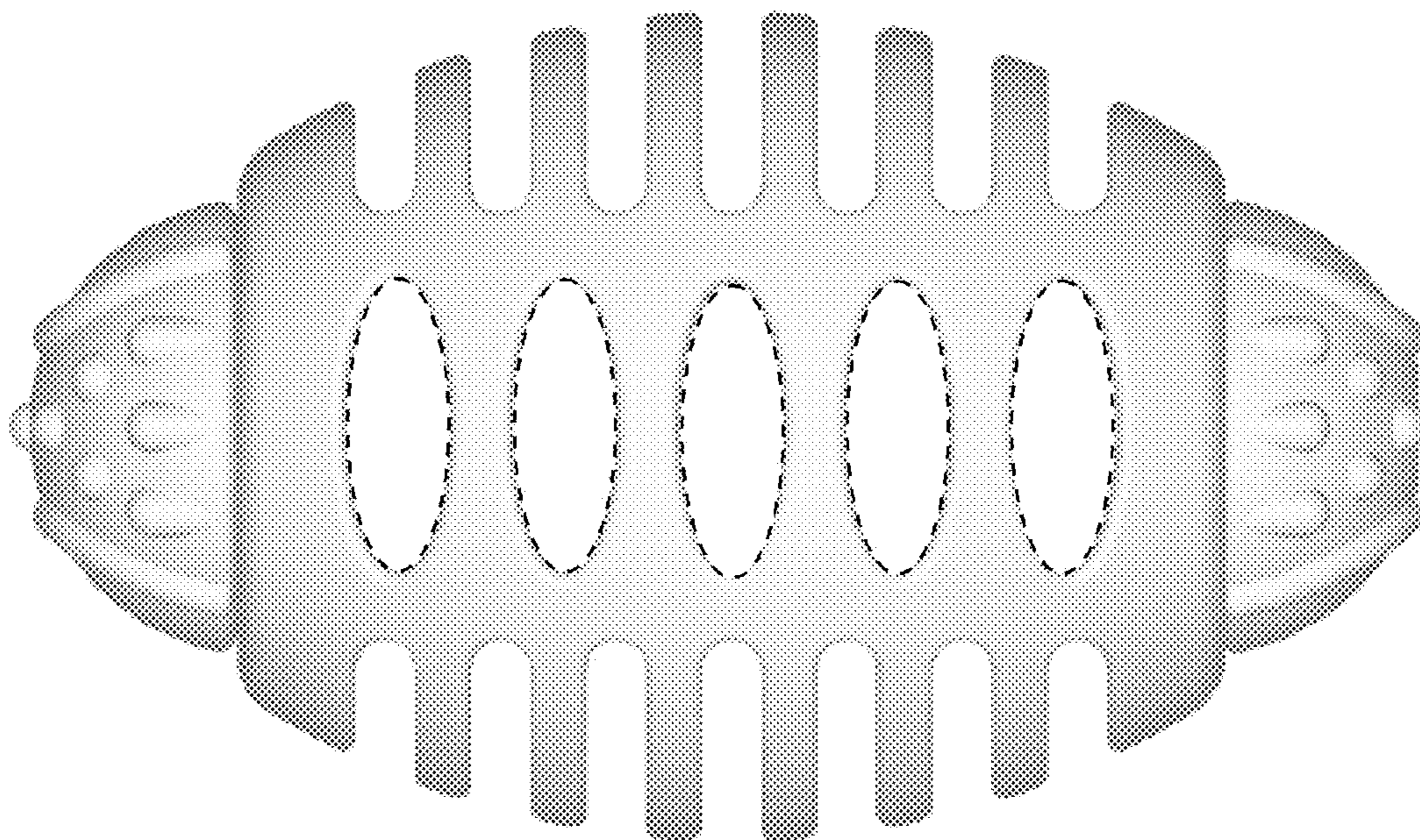
