FIG. 2 is a front elevation view thereof;

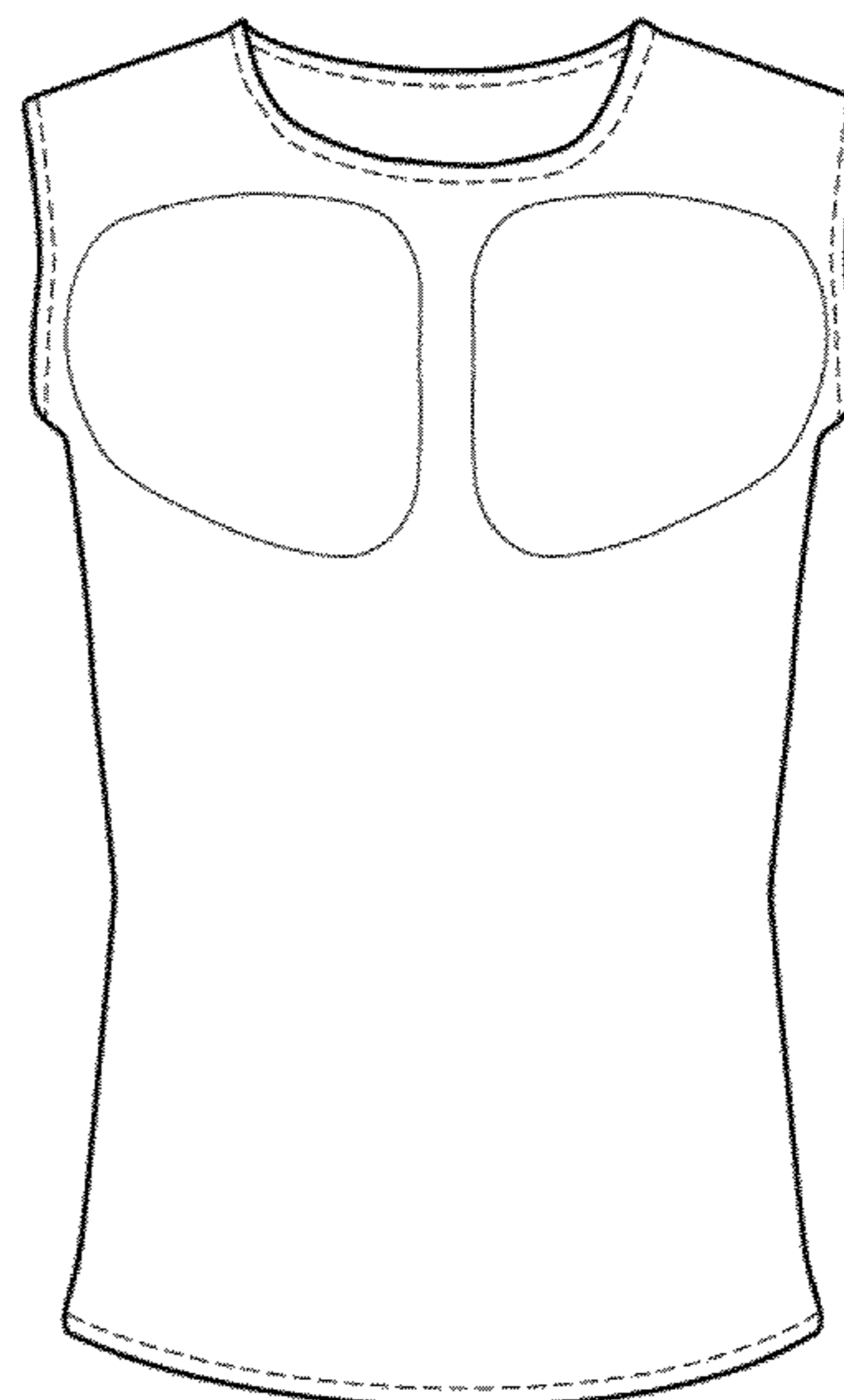
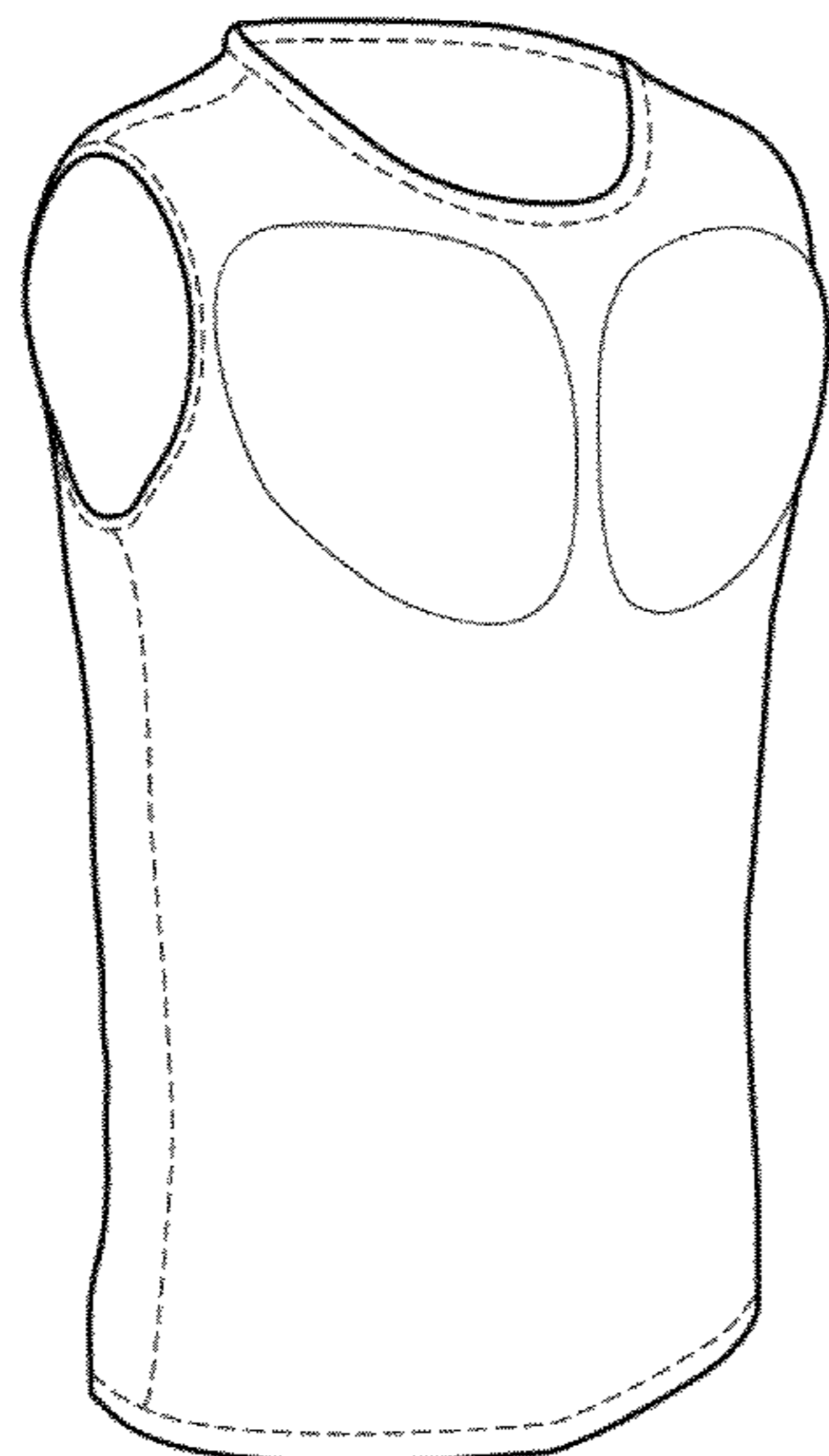
FIG. 3 is a back elevation view thereof;

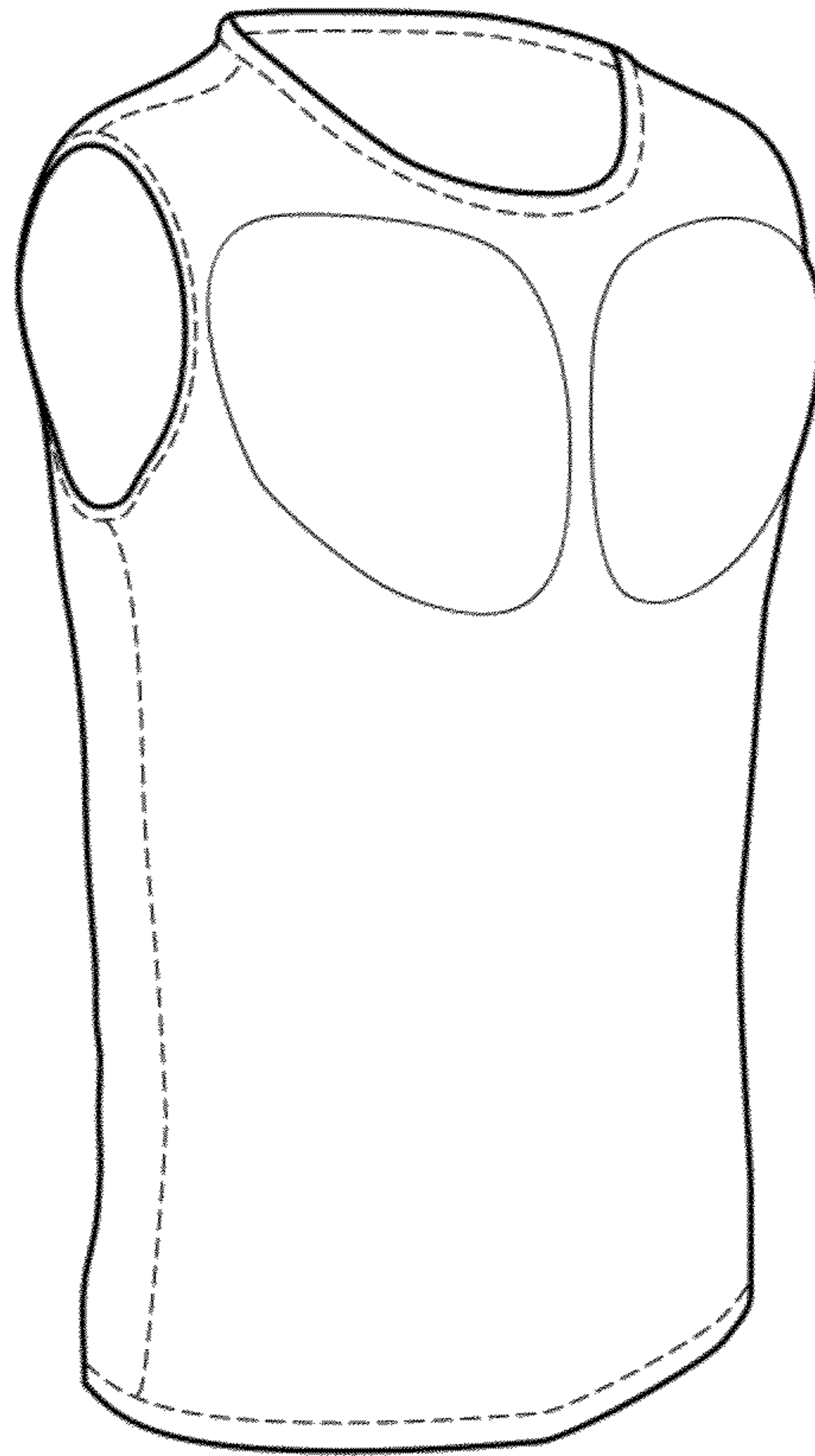
FIG. 4 is a side elevation view thereof; and,

FIG. 5 is a top plan view thereof.

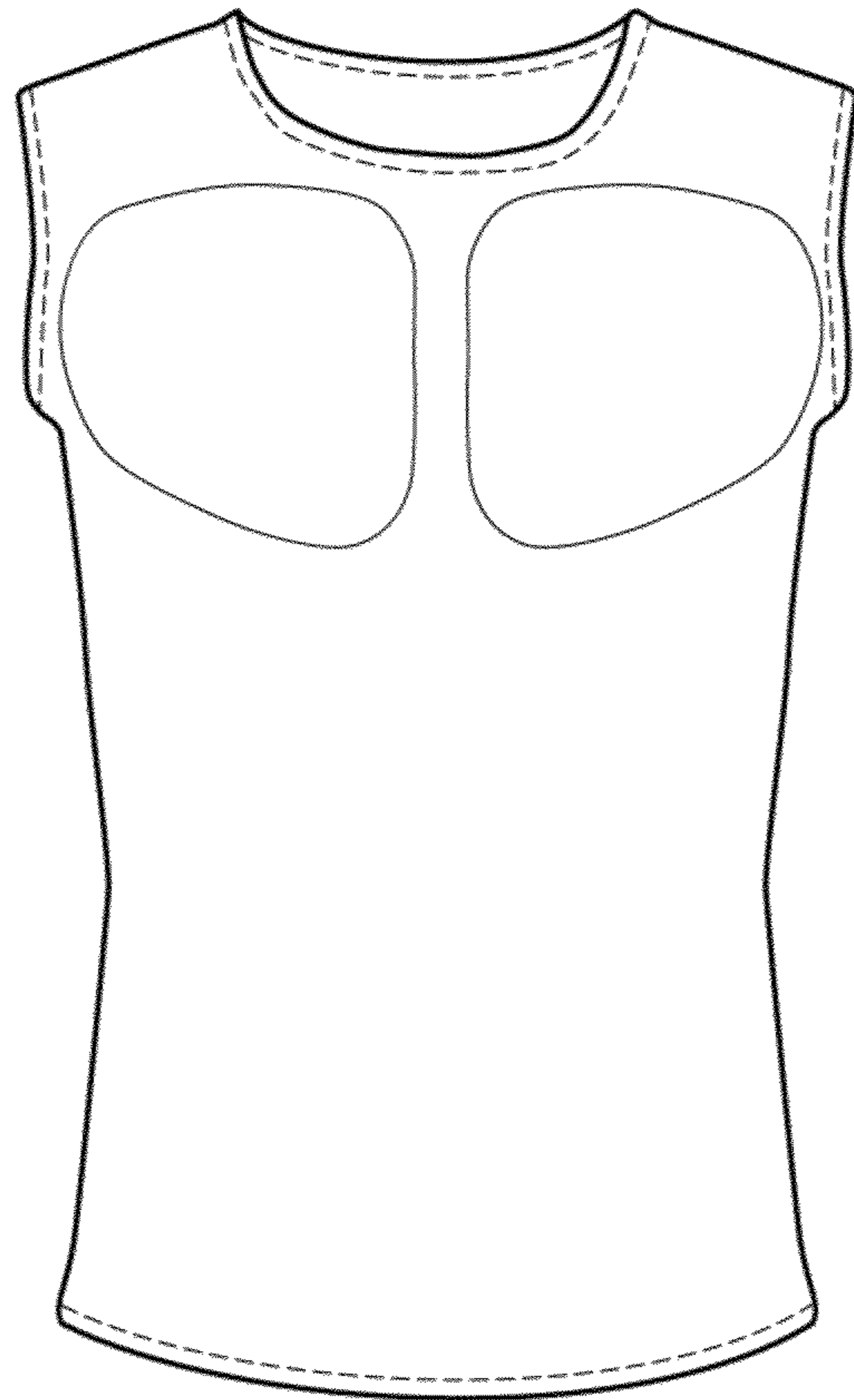
The broken lines in FIGS. 1-5 represent stitching and seams that form no part of the claimed design.

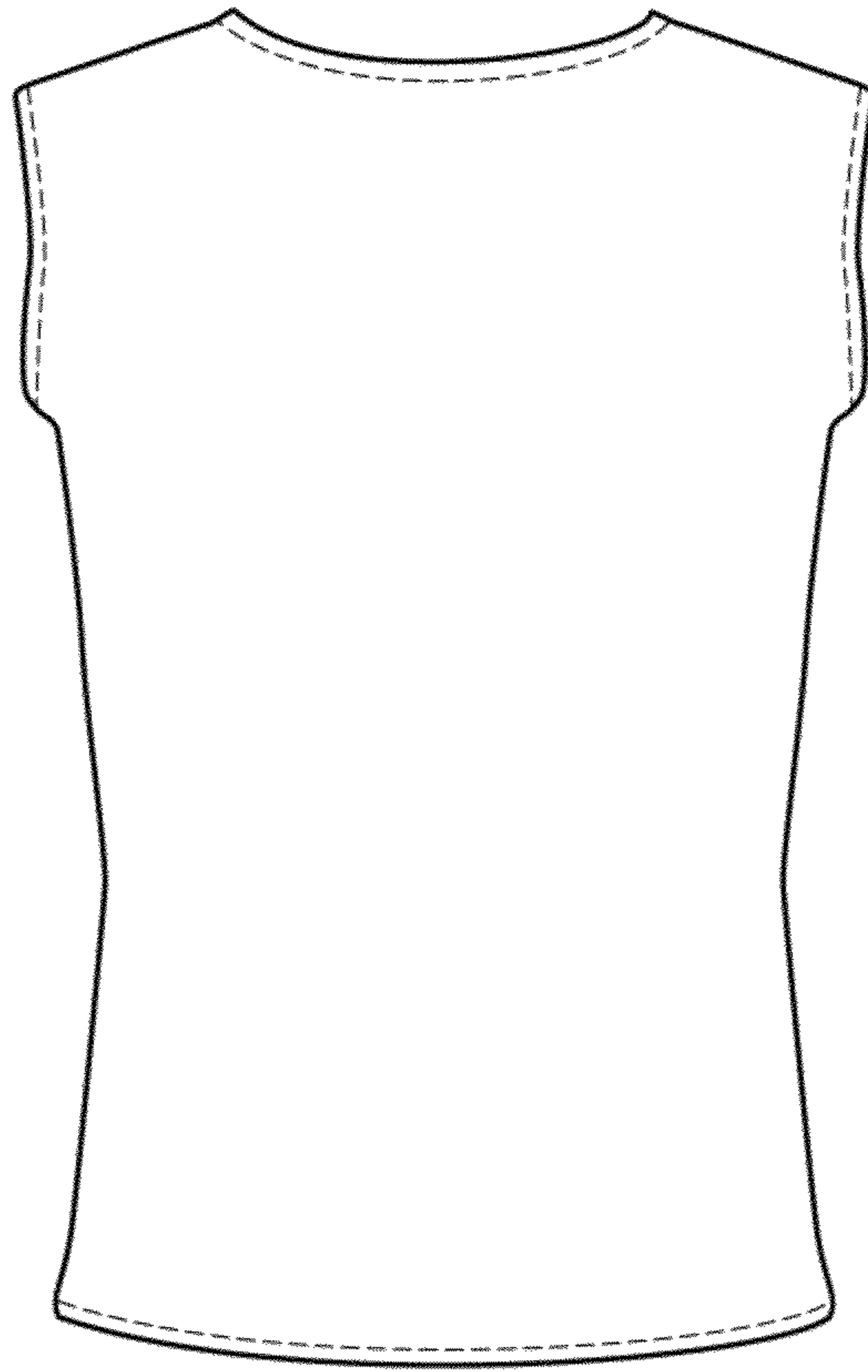




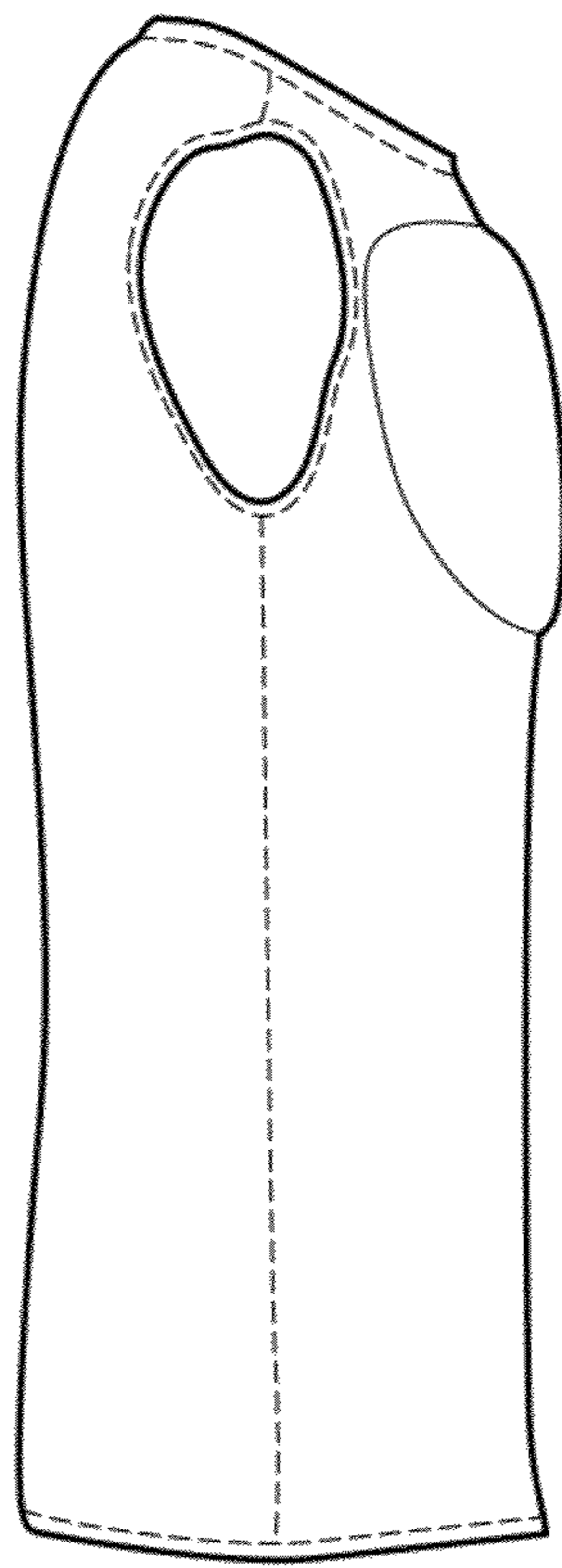

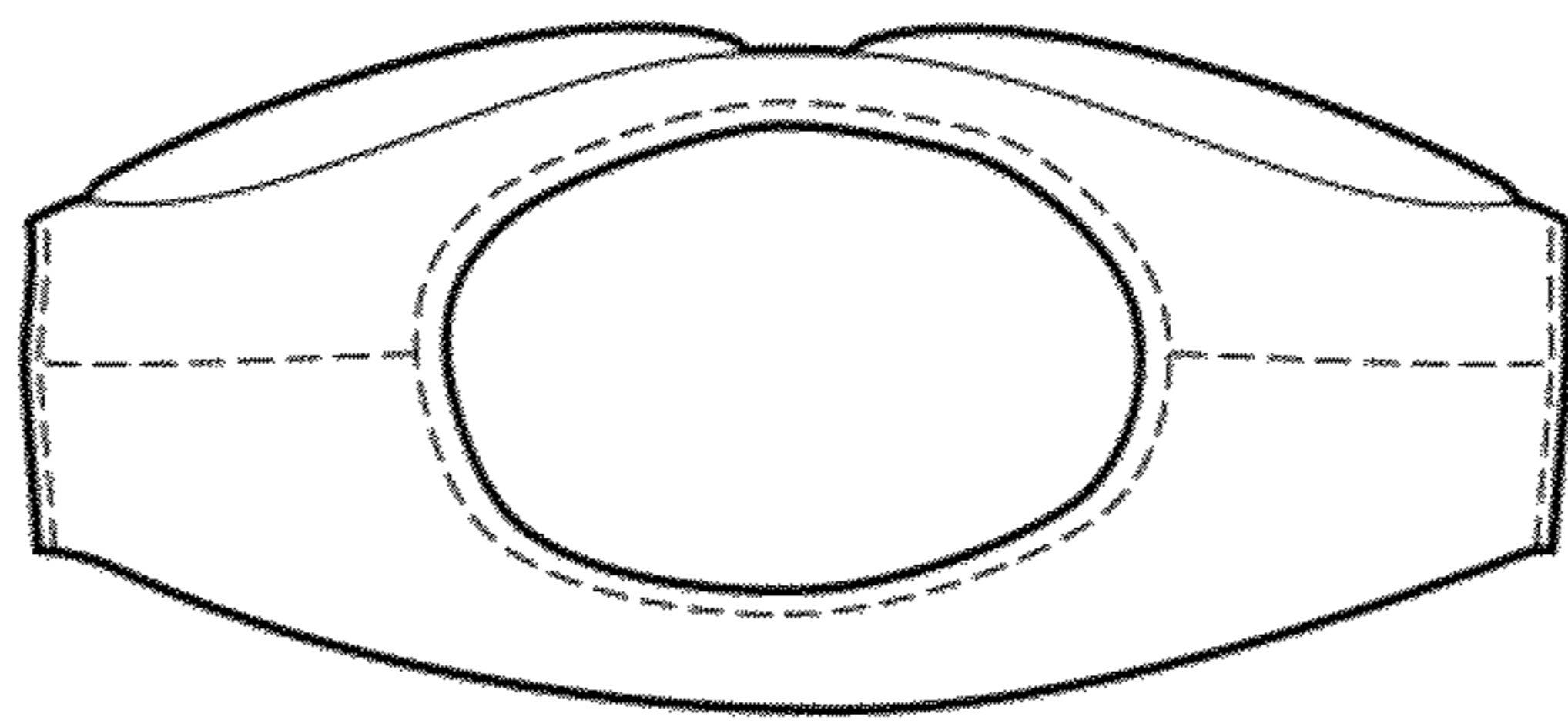
