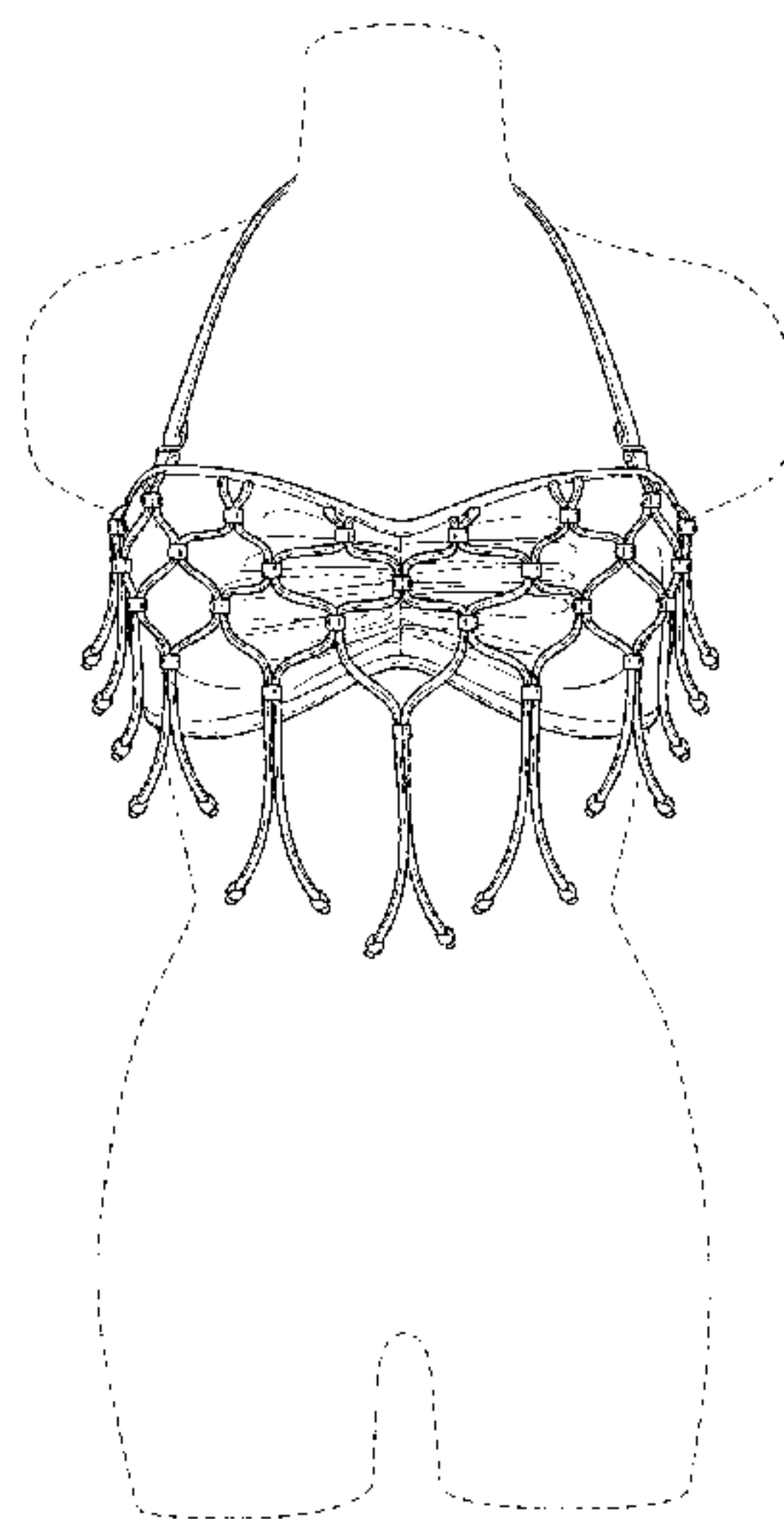

(57) **CLAIM**
I claim the ornamental design for a swimsuit top, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a swimsuit top on a model showing my new design.
FIG. 2 is a rear view of the swimsuit top of FIG. 1.
FIG. 3 is a right-side view of the swimsuit top of FIG. 1; and, FIG. 4 is a left-side view of the swimsuit top of FIG. 1.
The broken lines formed by linear segments of equal length in FIGS. 1-4 are provided for environment only and form no part of the claimed design.

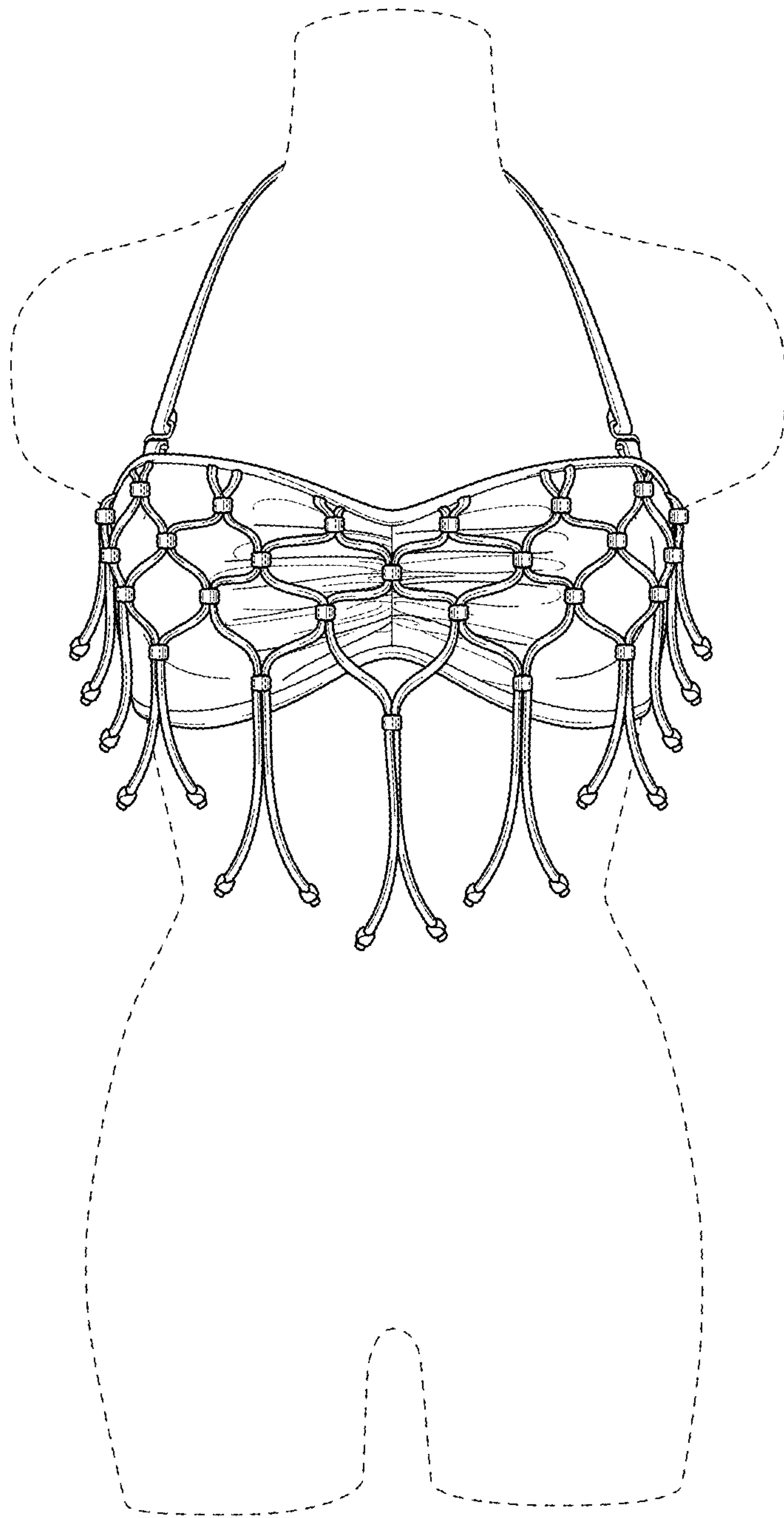

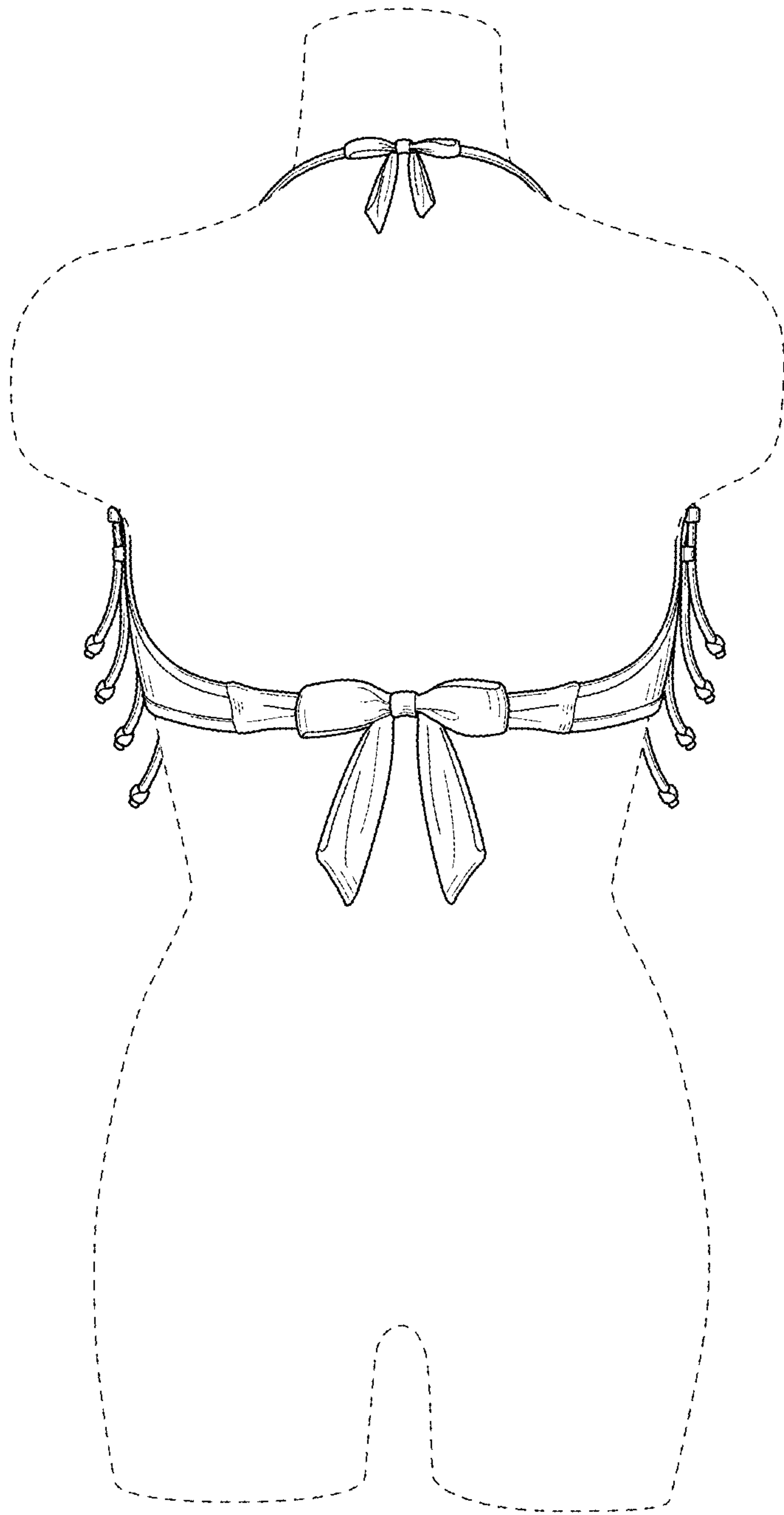

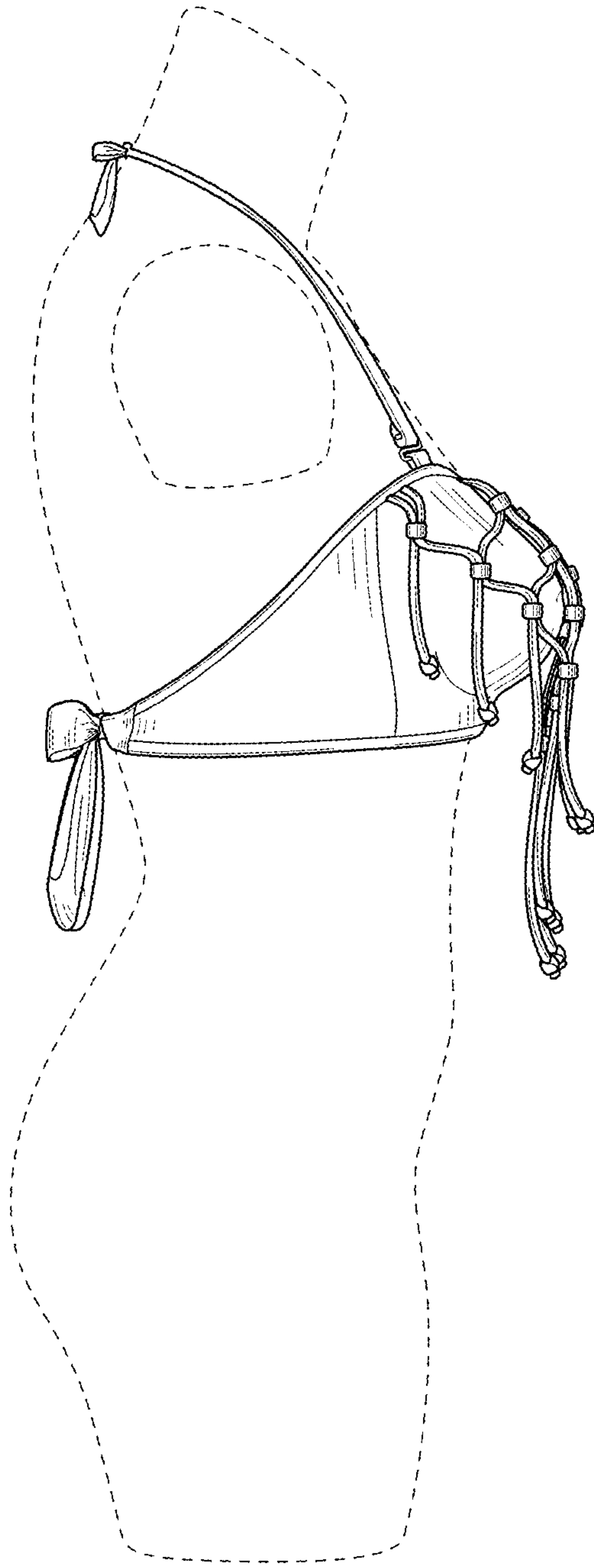

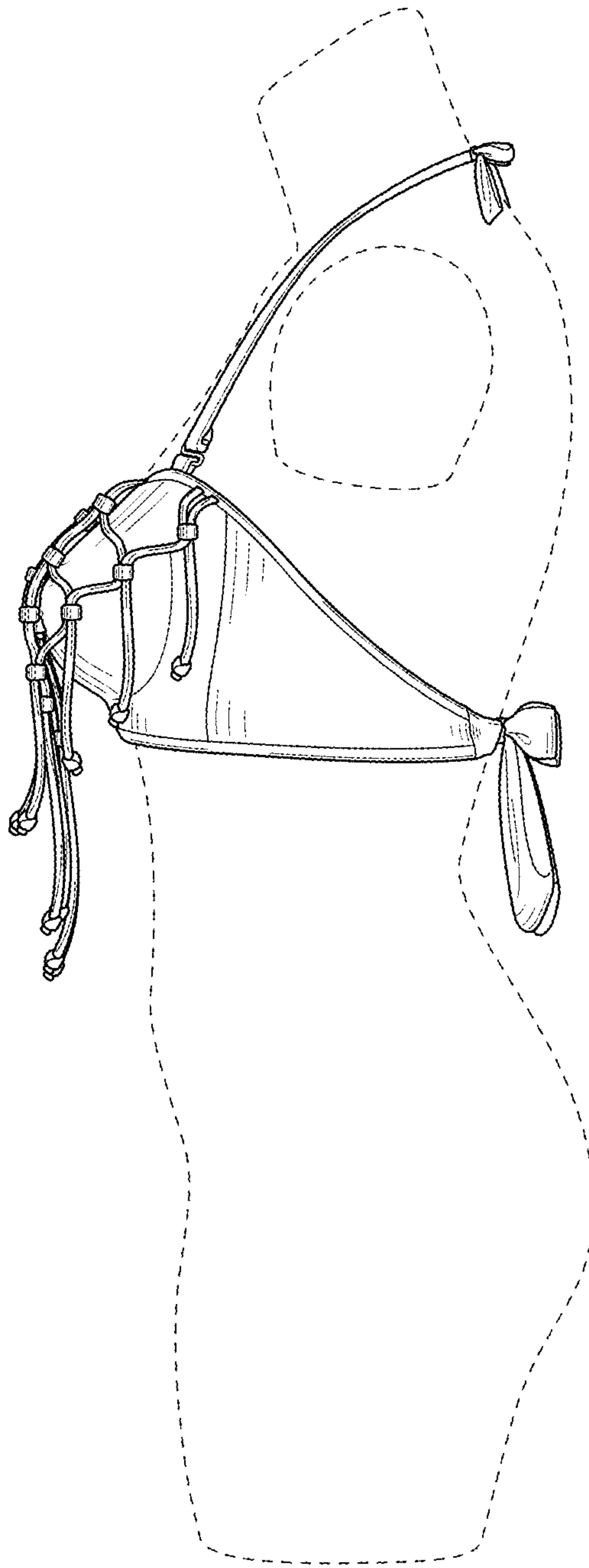
