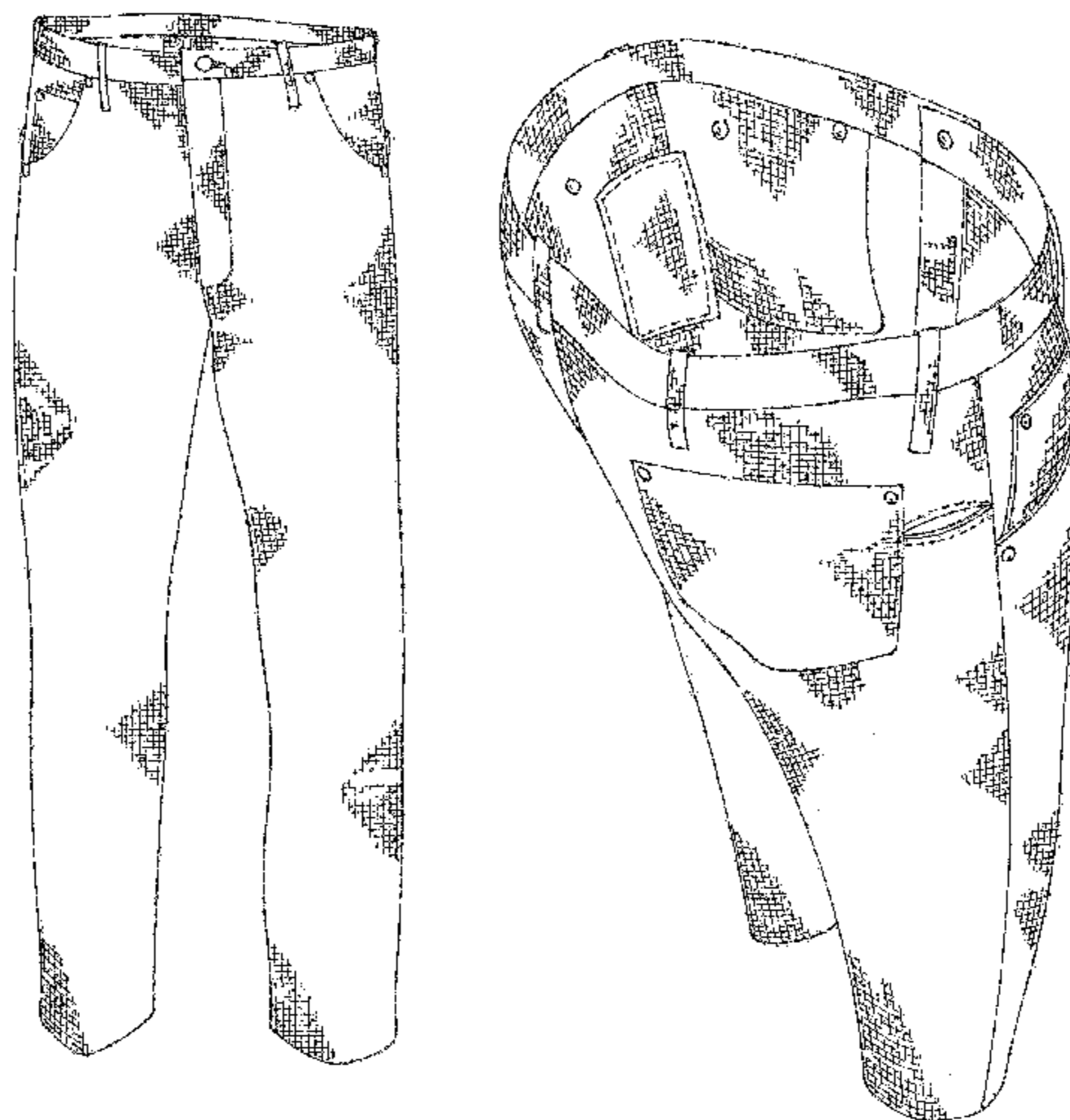
(57) **CLAIM**

I claim the ornamental design for pants with utility pocket, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a two-pocket embodiment of pants with utility pocket showing my new design; FIG. 2 is a left side view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a top left perspective view thereof; and FIG. 6 is a top right perspective view thereof. FIG. 7 is a front perspective view of a one-pocket embodiment of pants with utility pocket showing my new design; FIG. 8 is a left side view thereof; FIG. 9 is a right side view thereof; FIG. 10 is a rear view thereof; FIG. 11 is a top left perspective view thereof; and, FIG. 12 is a top right perspective view thereof. The broken lines on the interior and exterior indicate stitching.

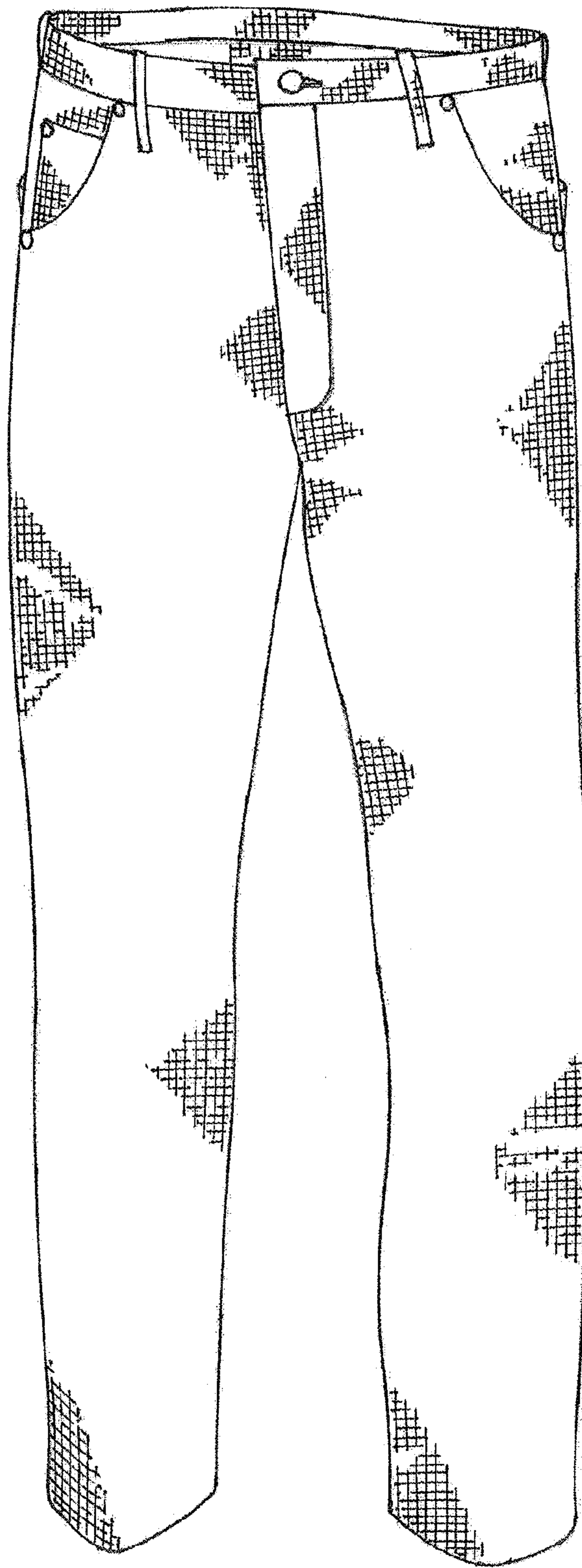

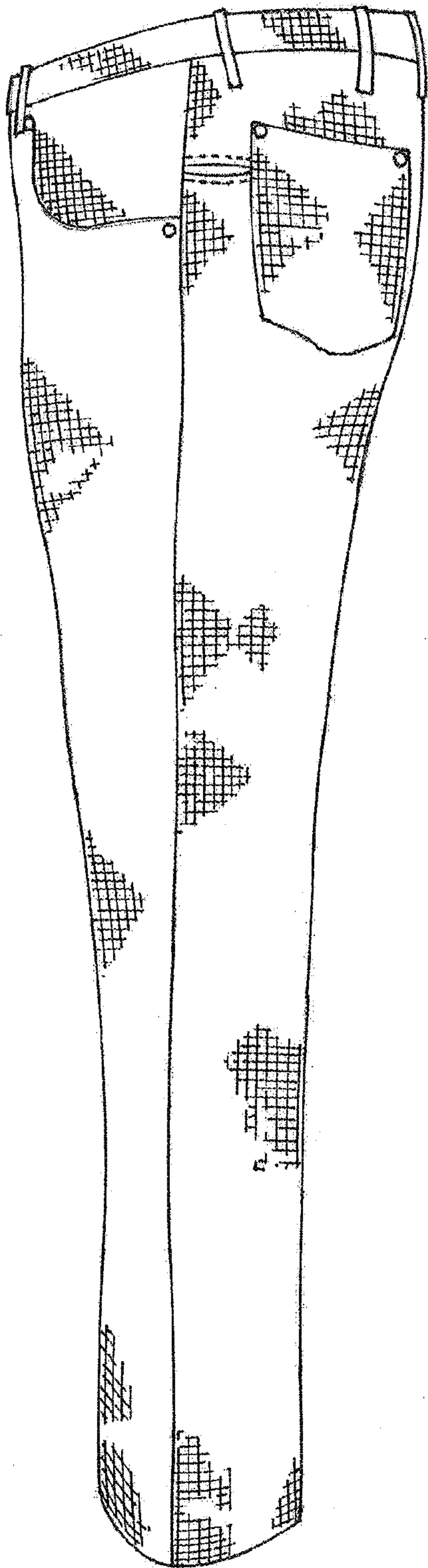

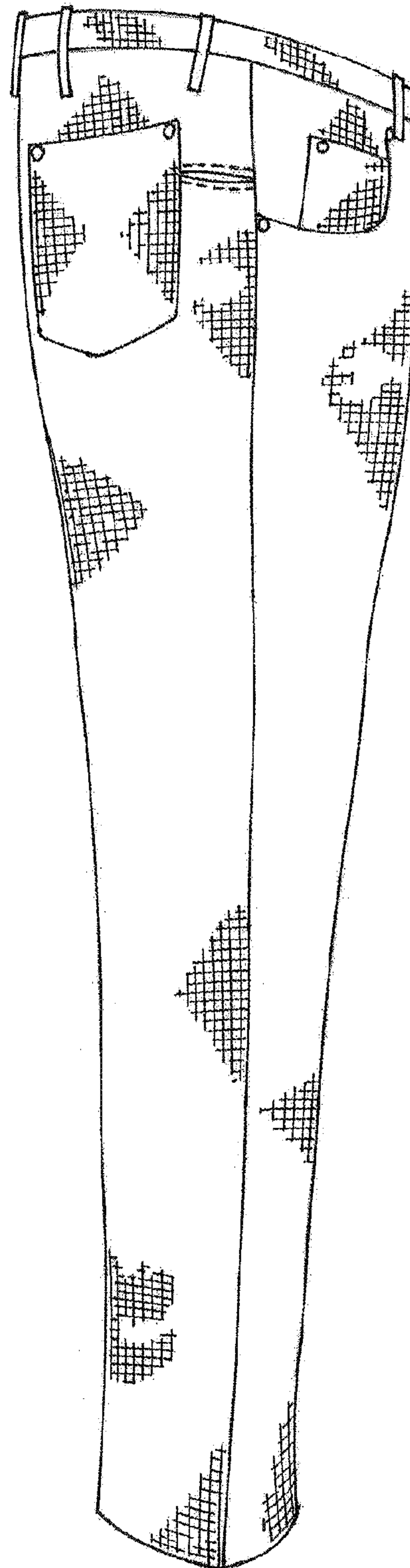

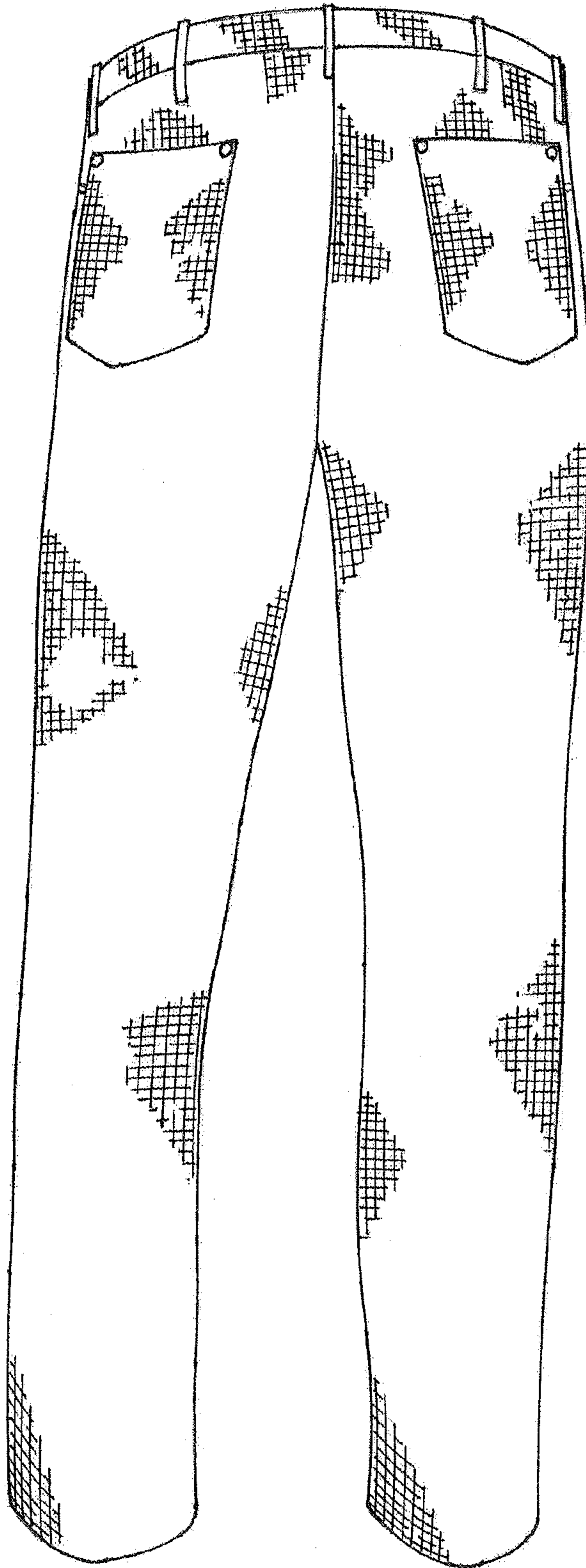

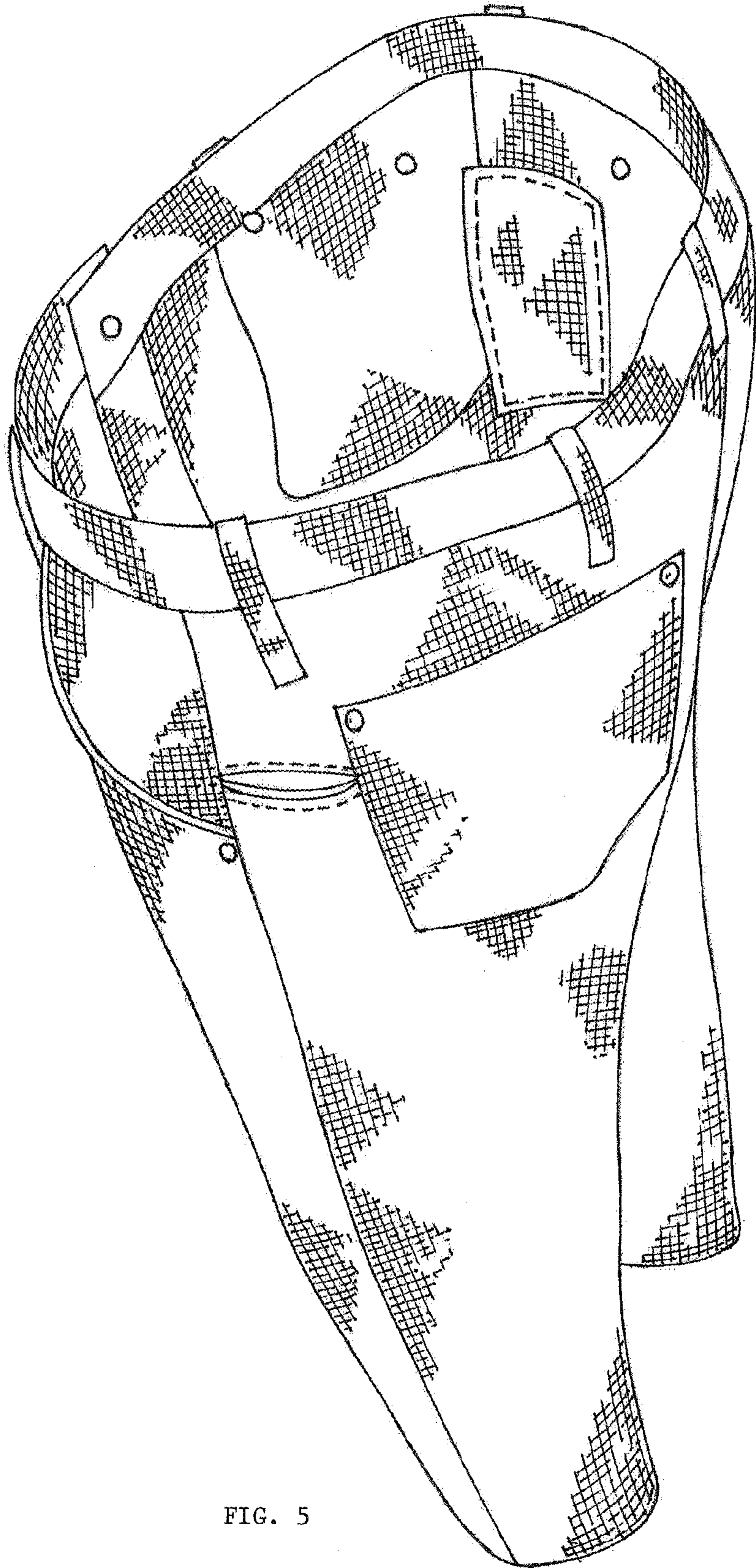

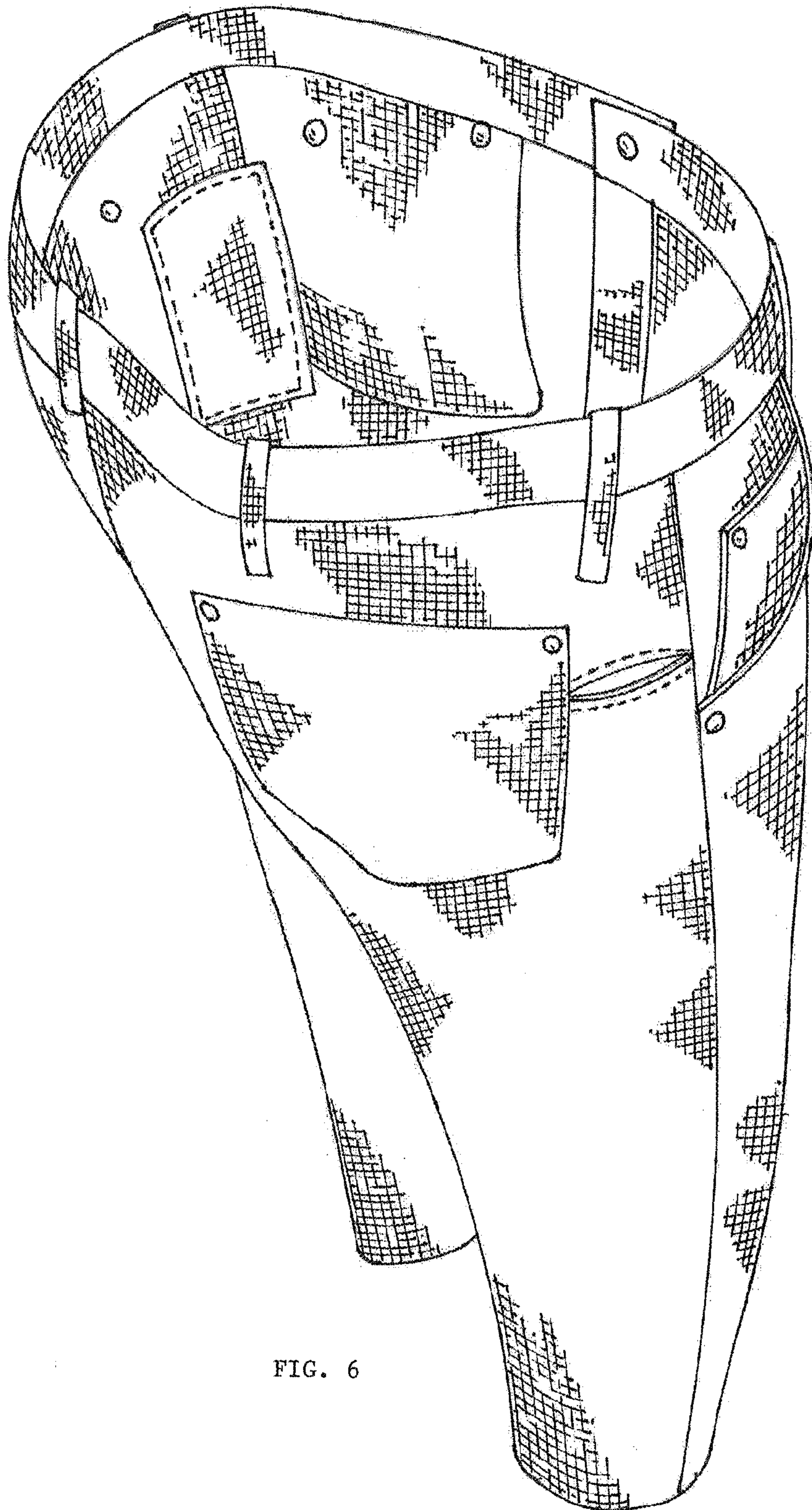

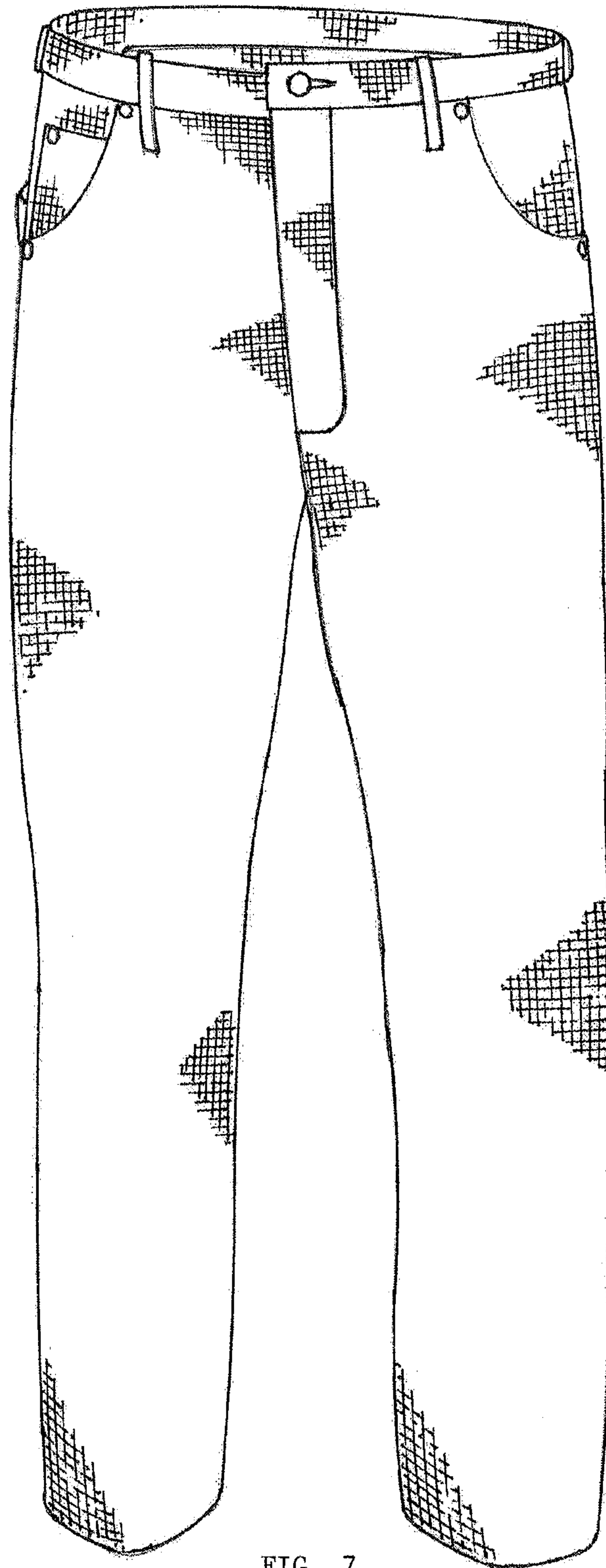

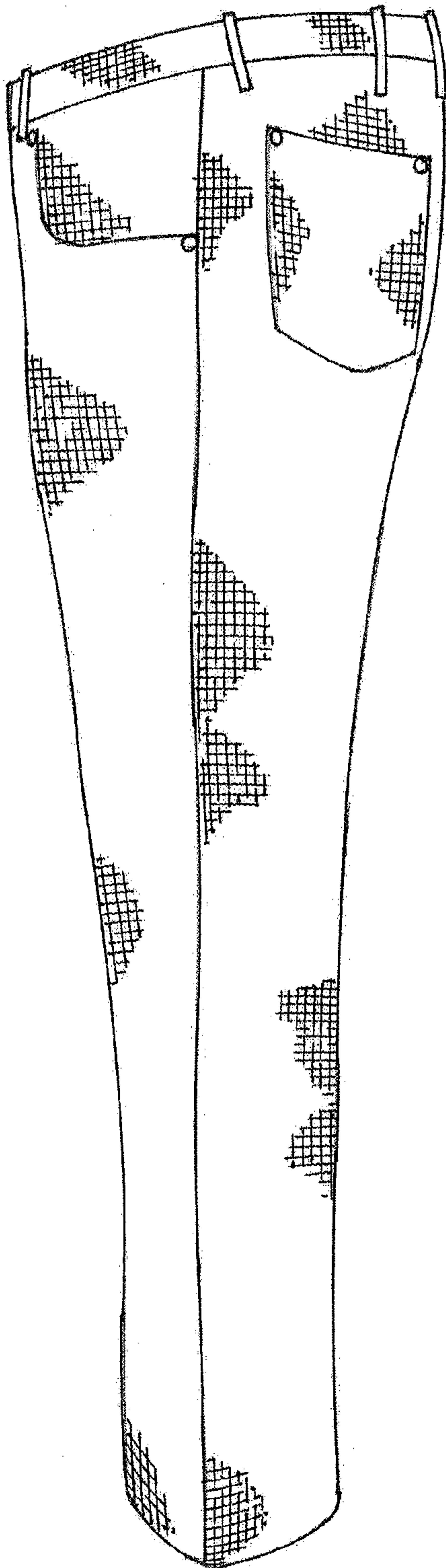

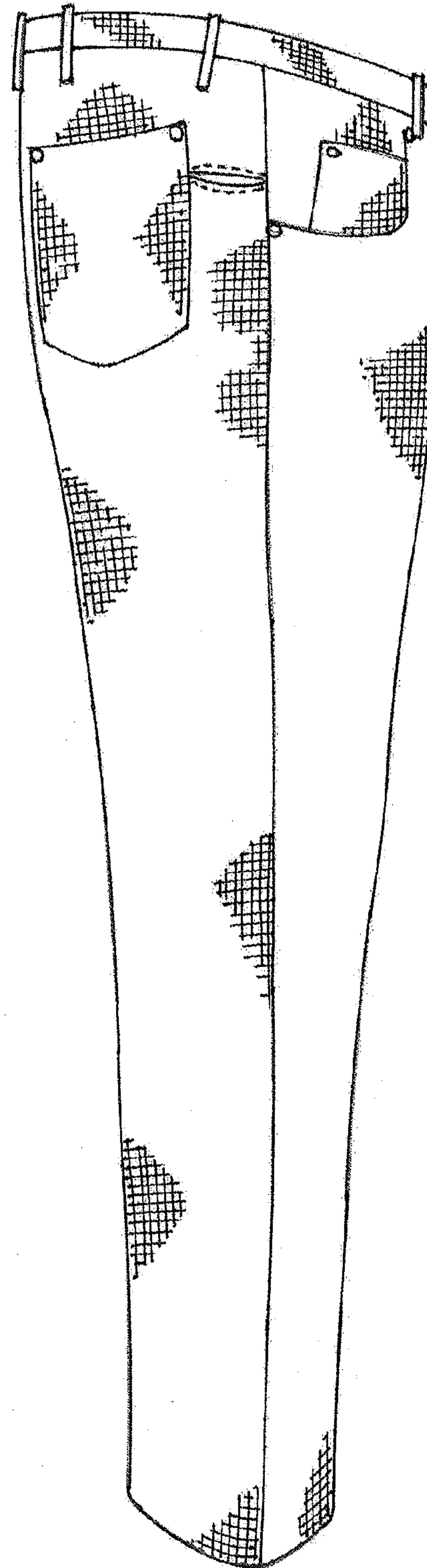

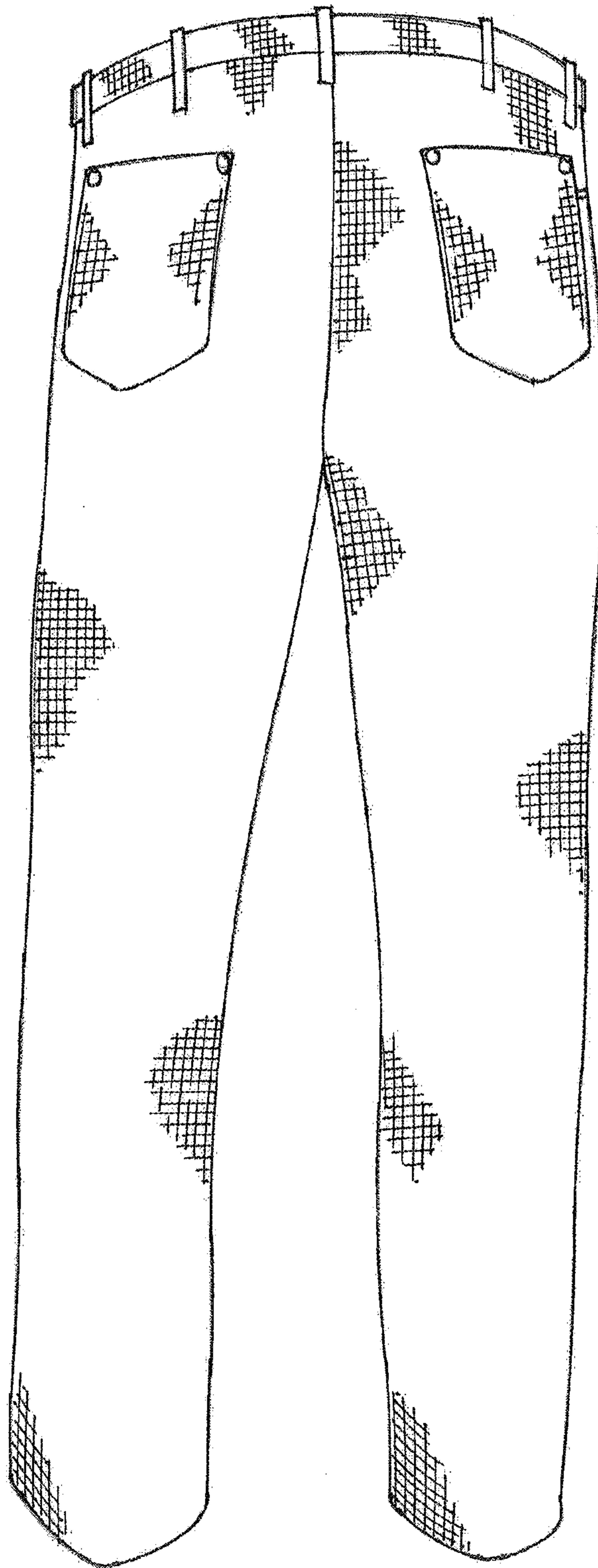

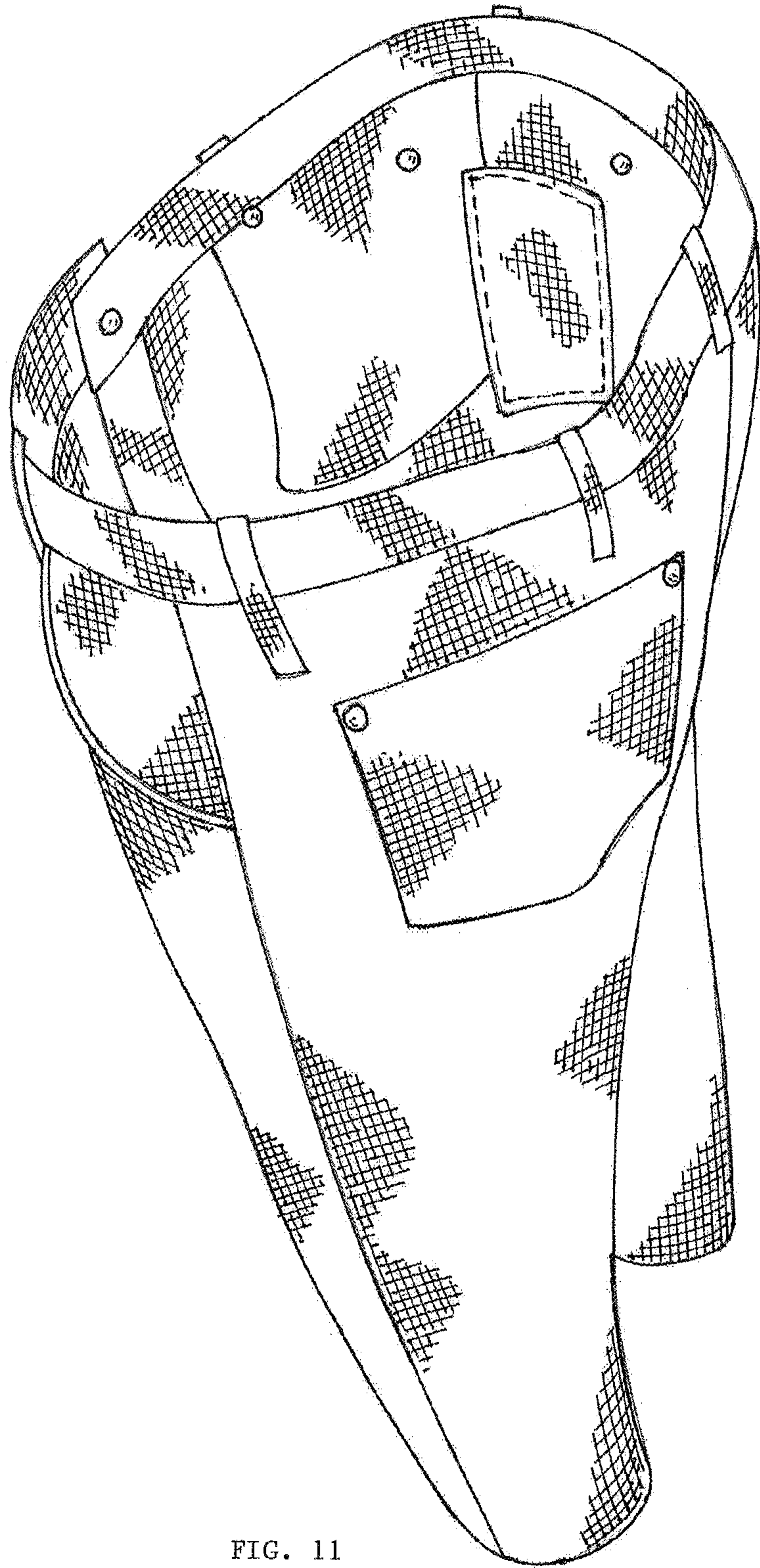

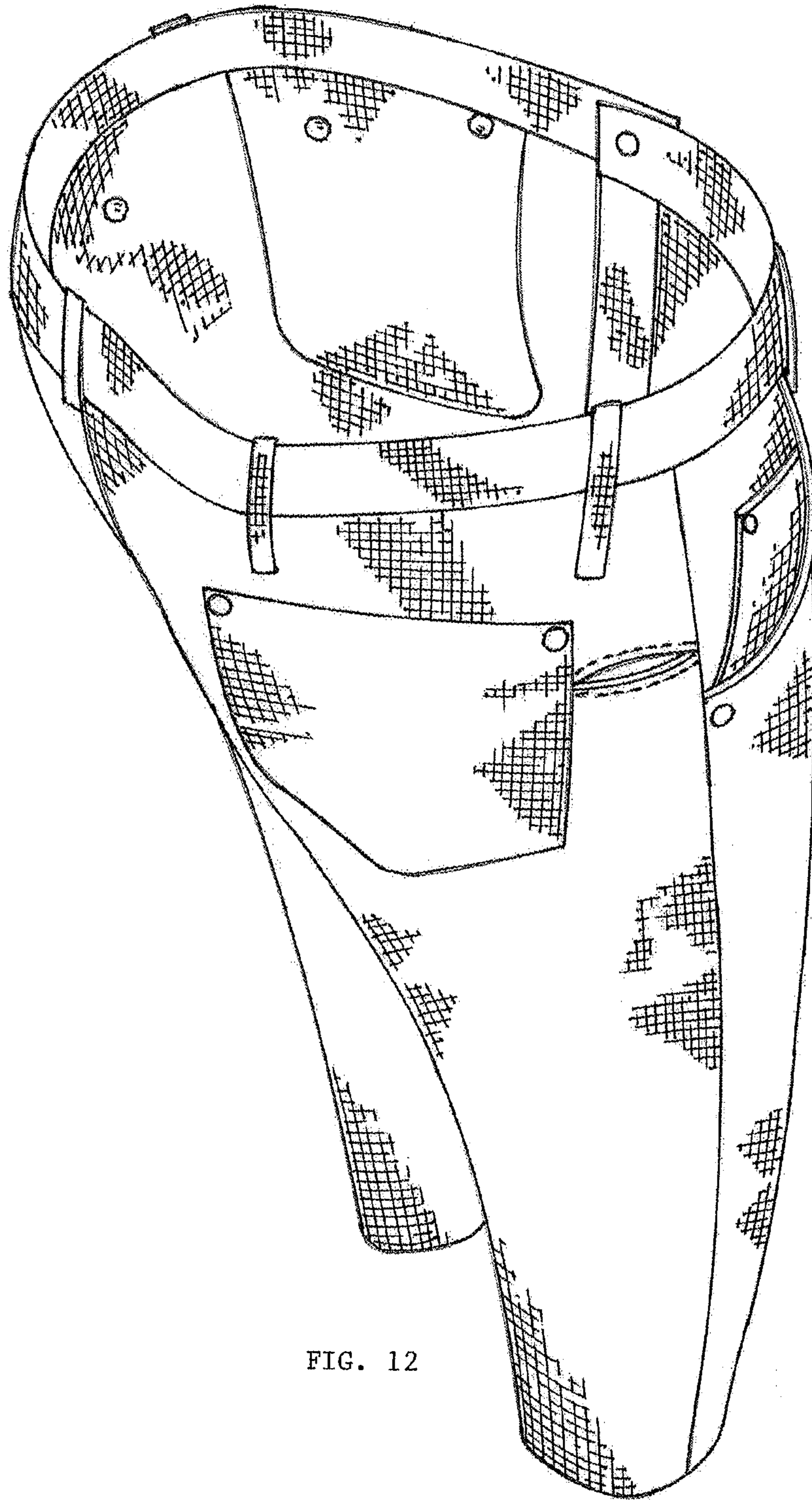
