(57) **CLAIM**

We claim the ornamental design for a golf shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a golf shoe as viewed from the front and one side thereof, according to an embodiment of the design.

FIG. 2 is a front elevation view of the golf shoe of FIG. 1.

FIG. 3 is a rear elevation view of the golf shoe of FIG. 1.

FIG. 4 is a side elevation view of the golf shoe of FIG. 1.

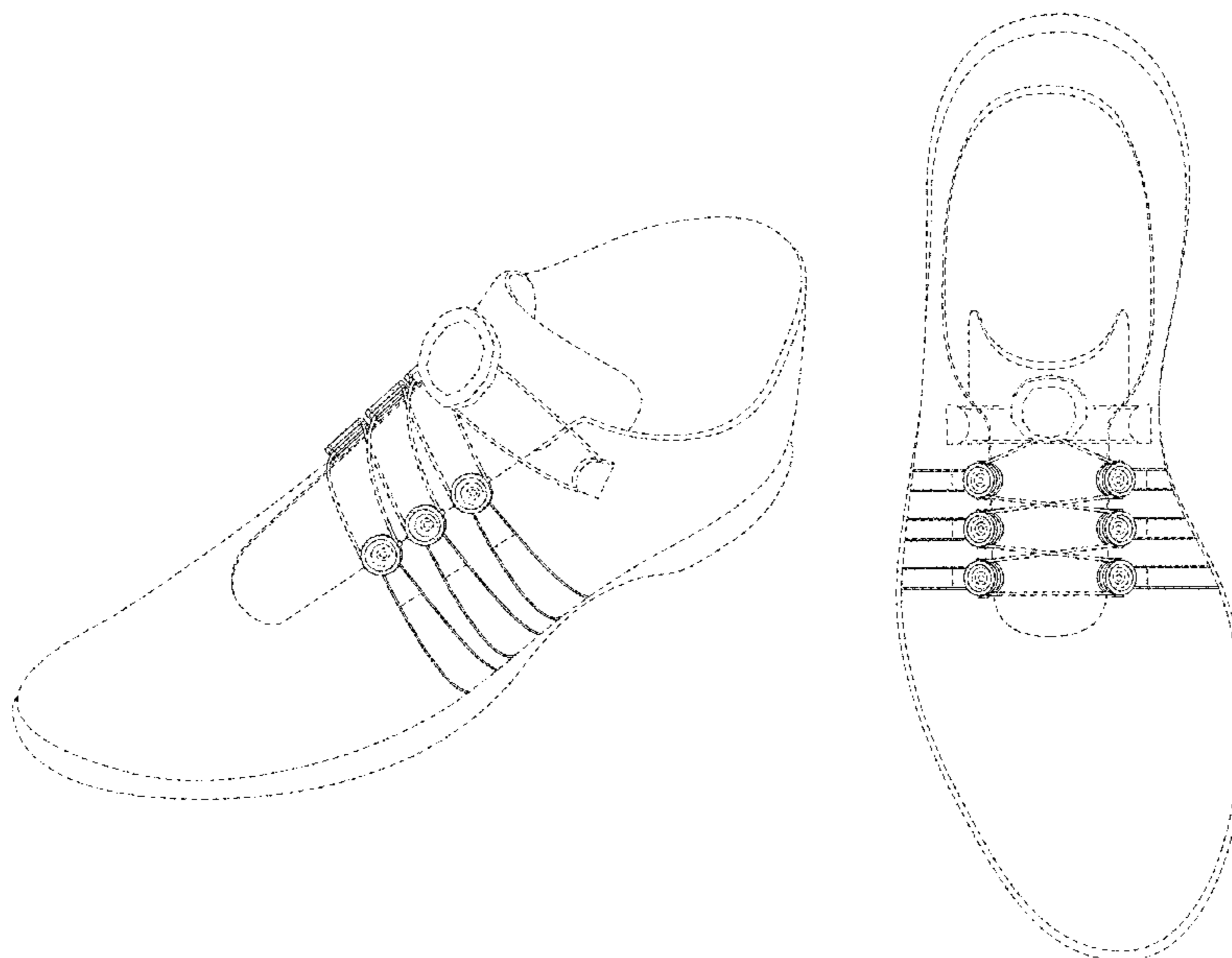
FIG. 5 is a side elevation view of the golf shoe of FIG. 1, from the side opposite FIG. 4.

FIG. 6 is a top plan view of the golf shoe of FIG. 1; and,

FIG. 7 is a bottom plan view of the golf shoe of FIG. 1.

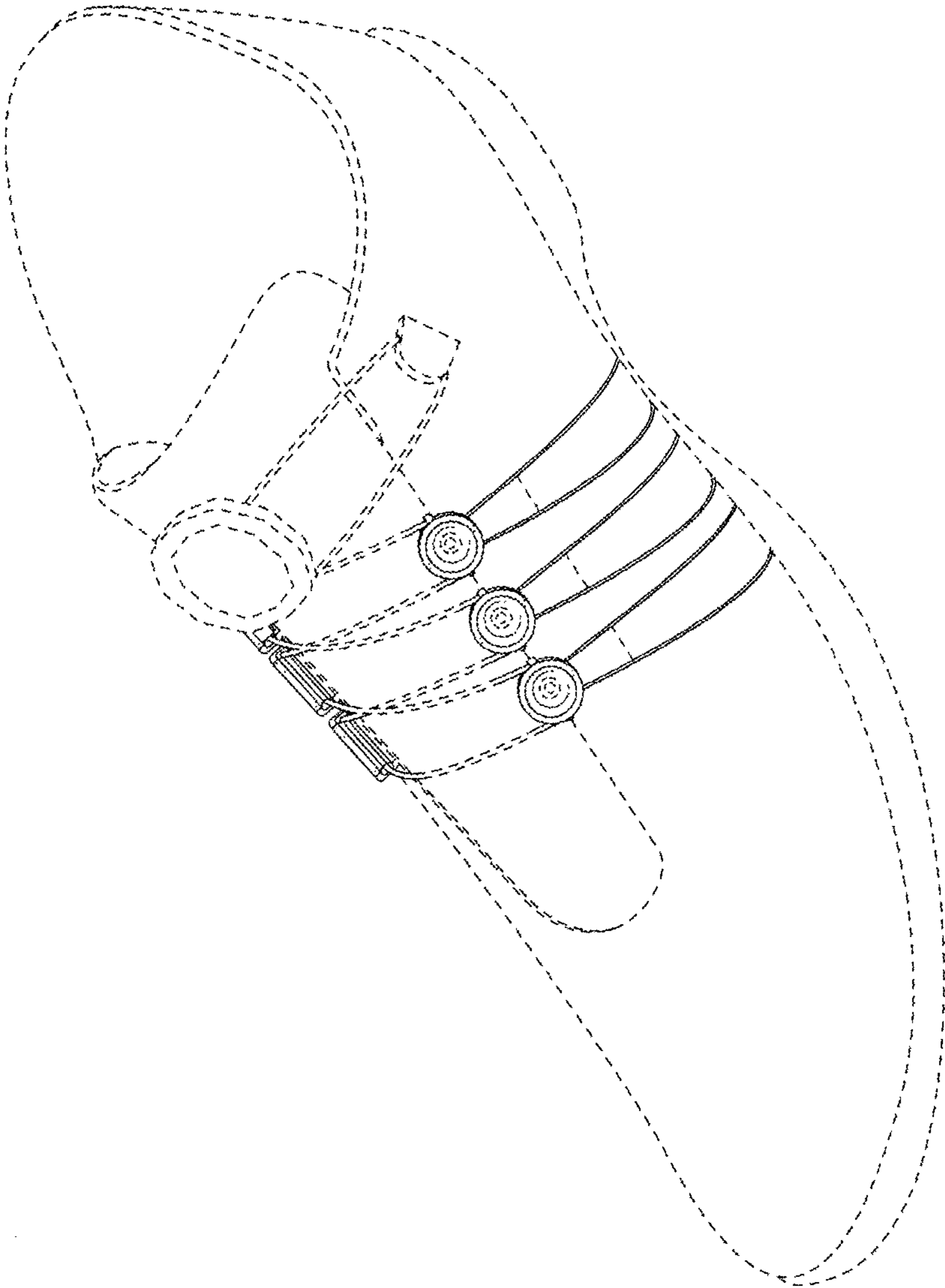

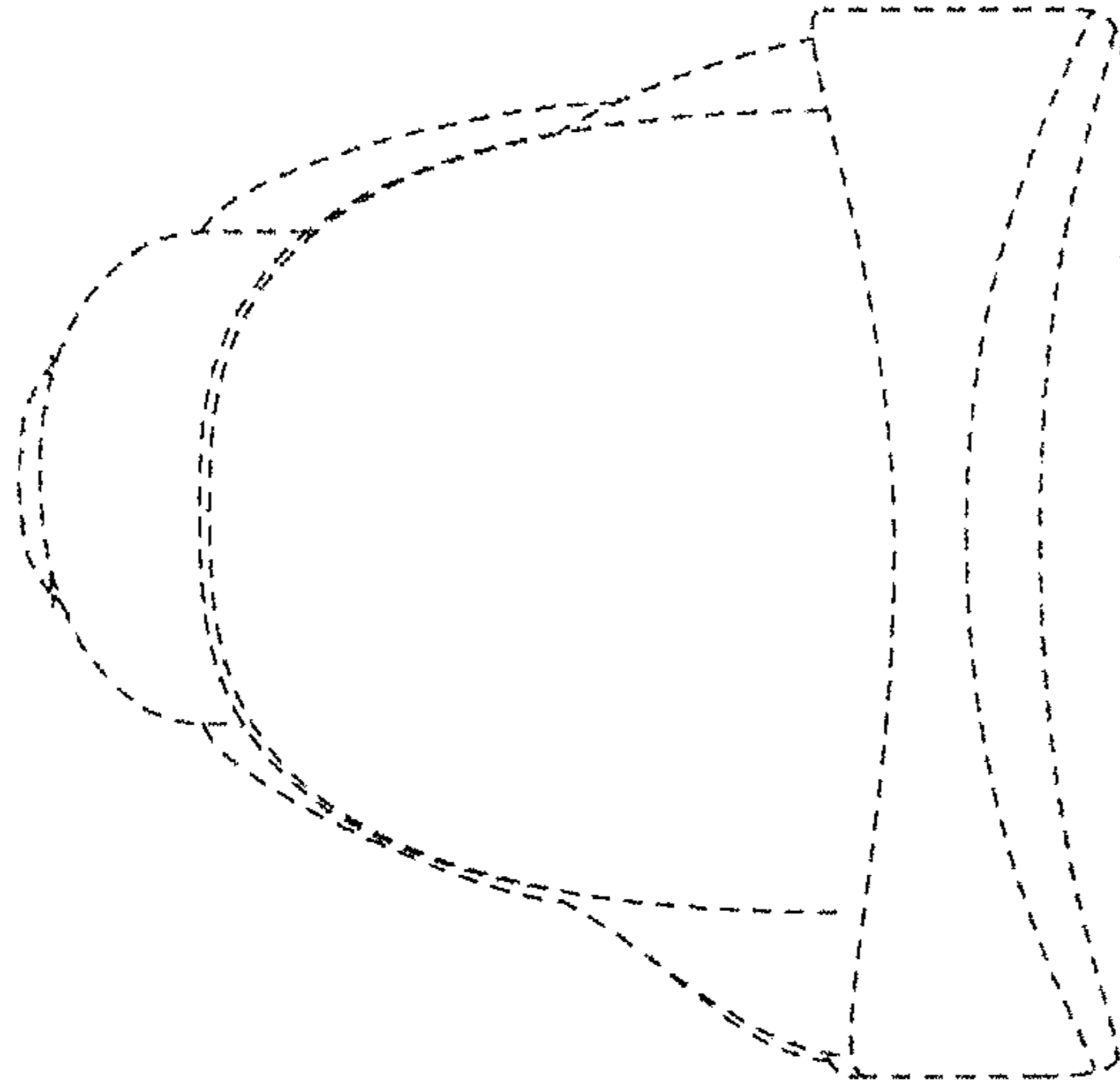

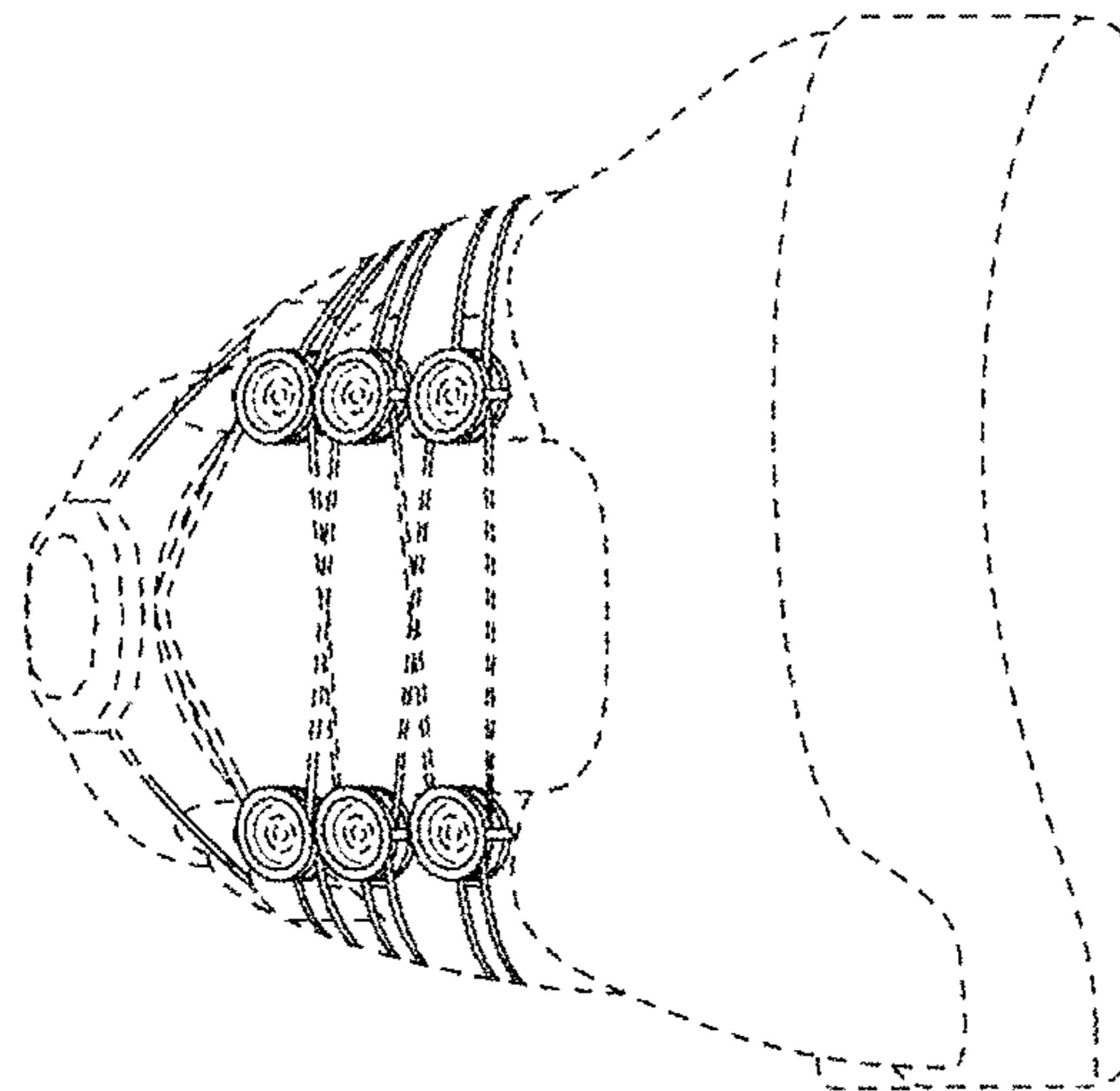

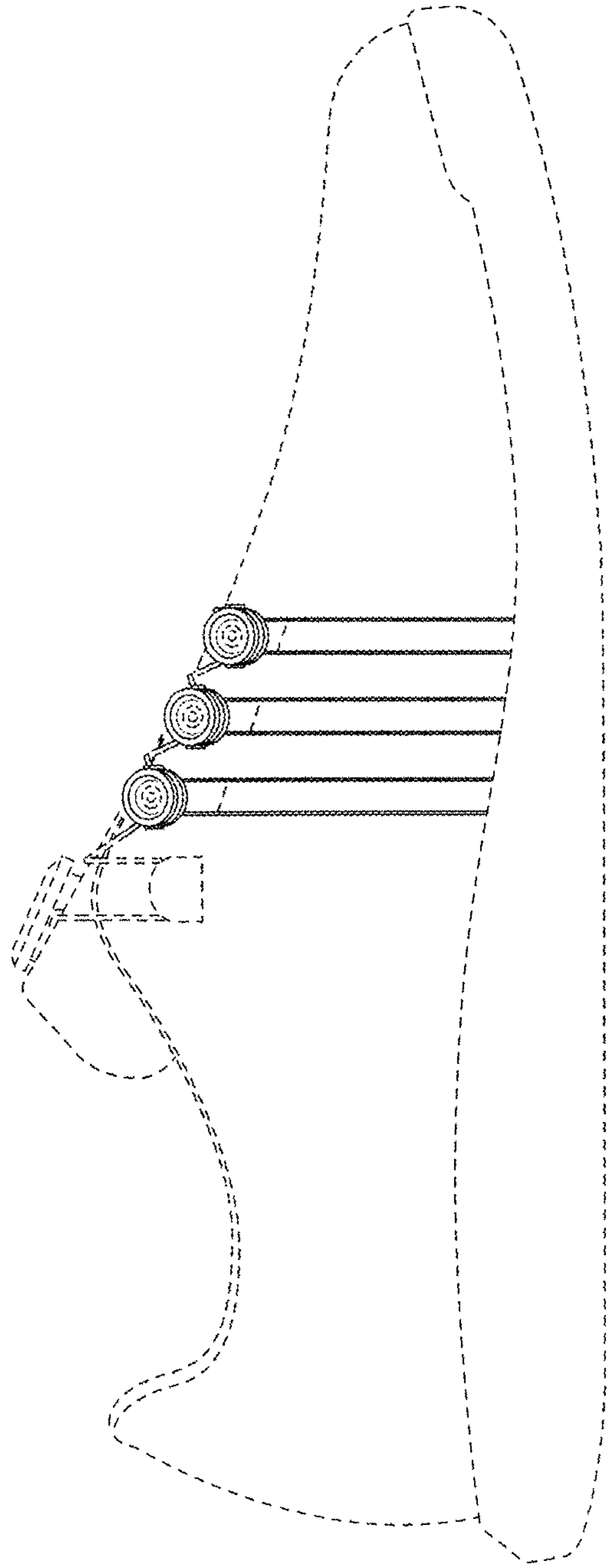

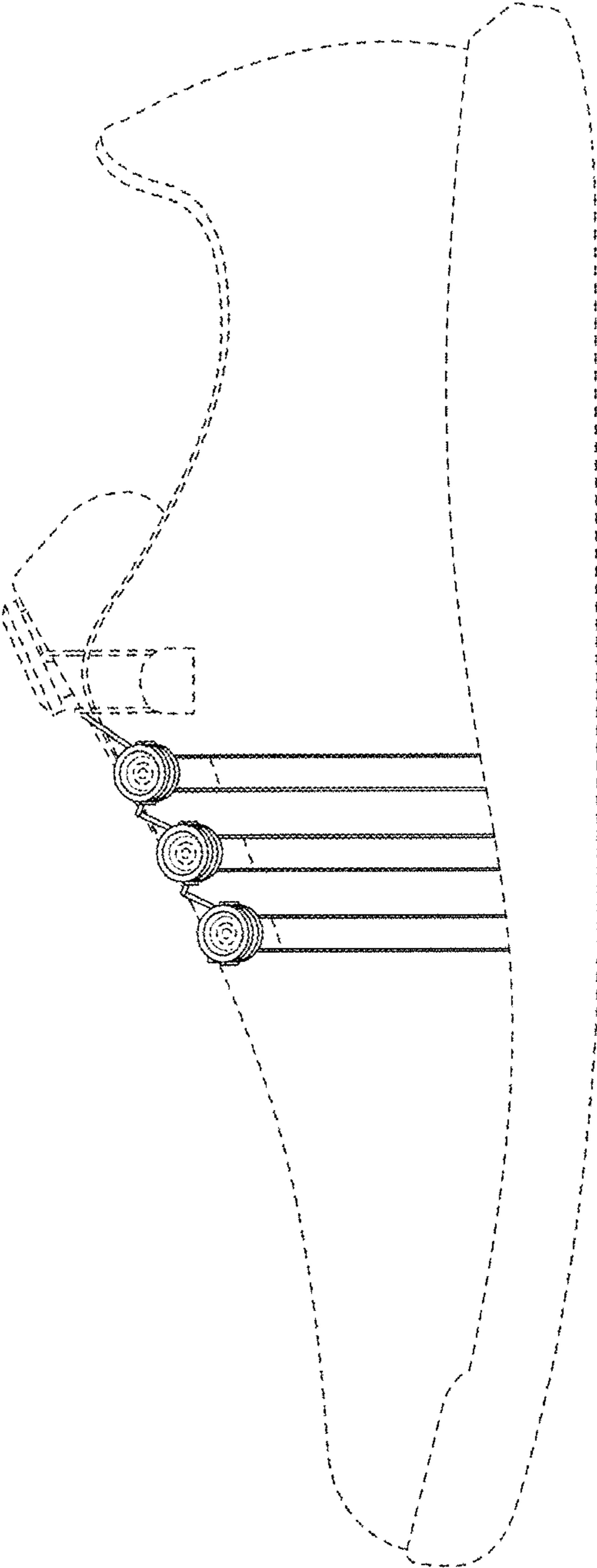

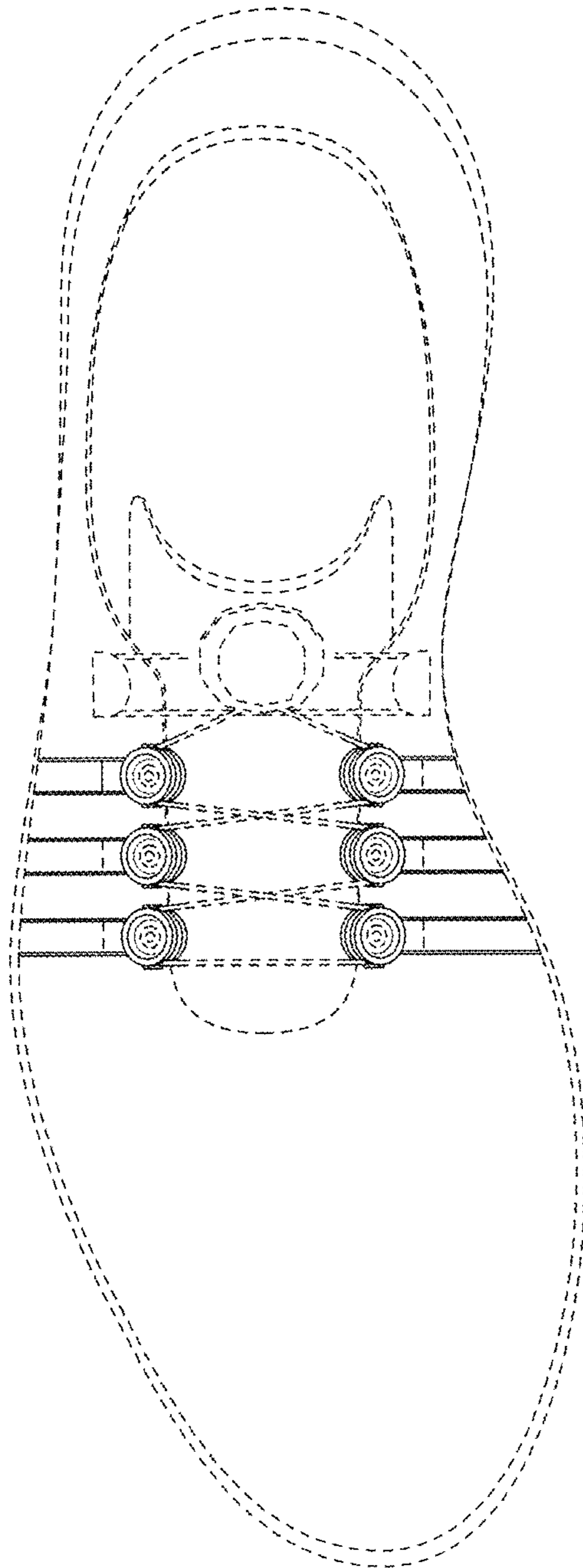

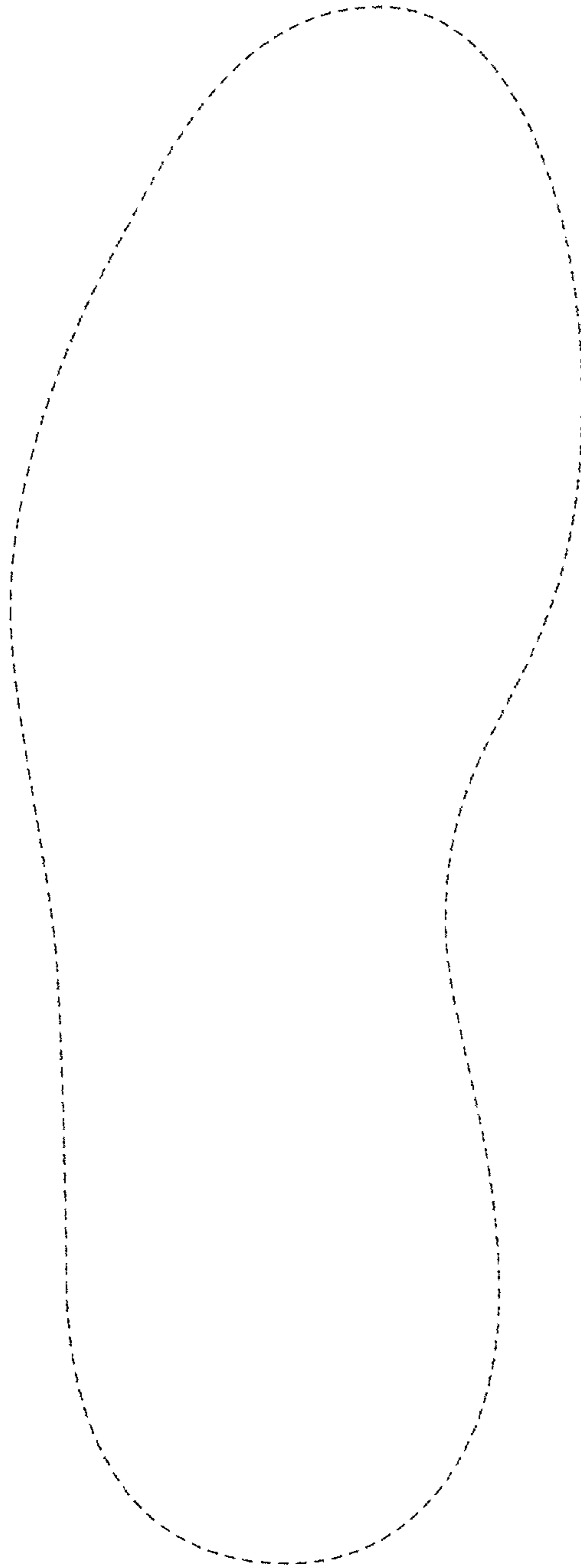
