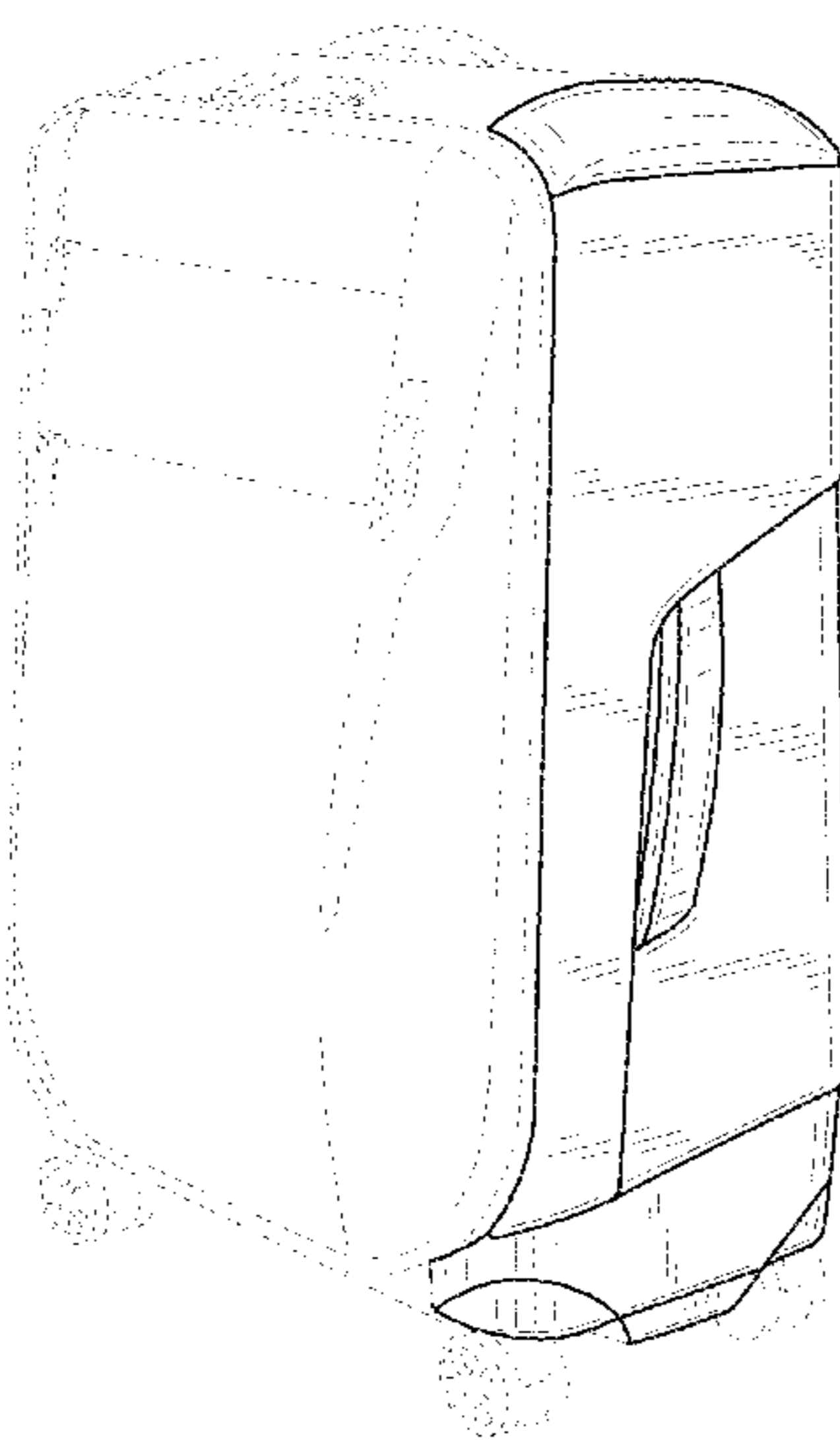
FIG. 5 shows a rear elevation view of a luggage side panel with handle of FIG. 1;

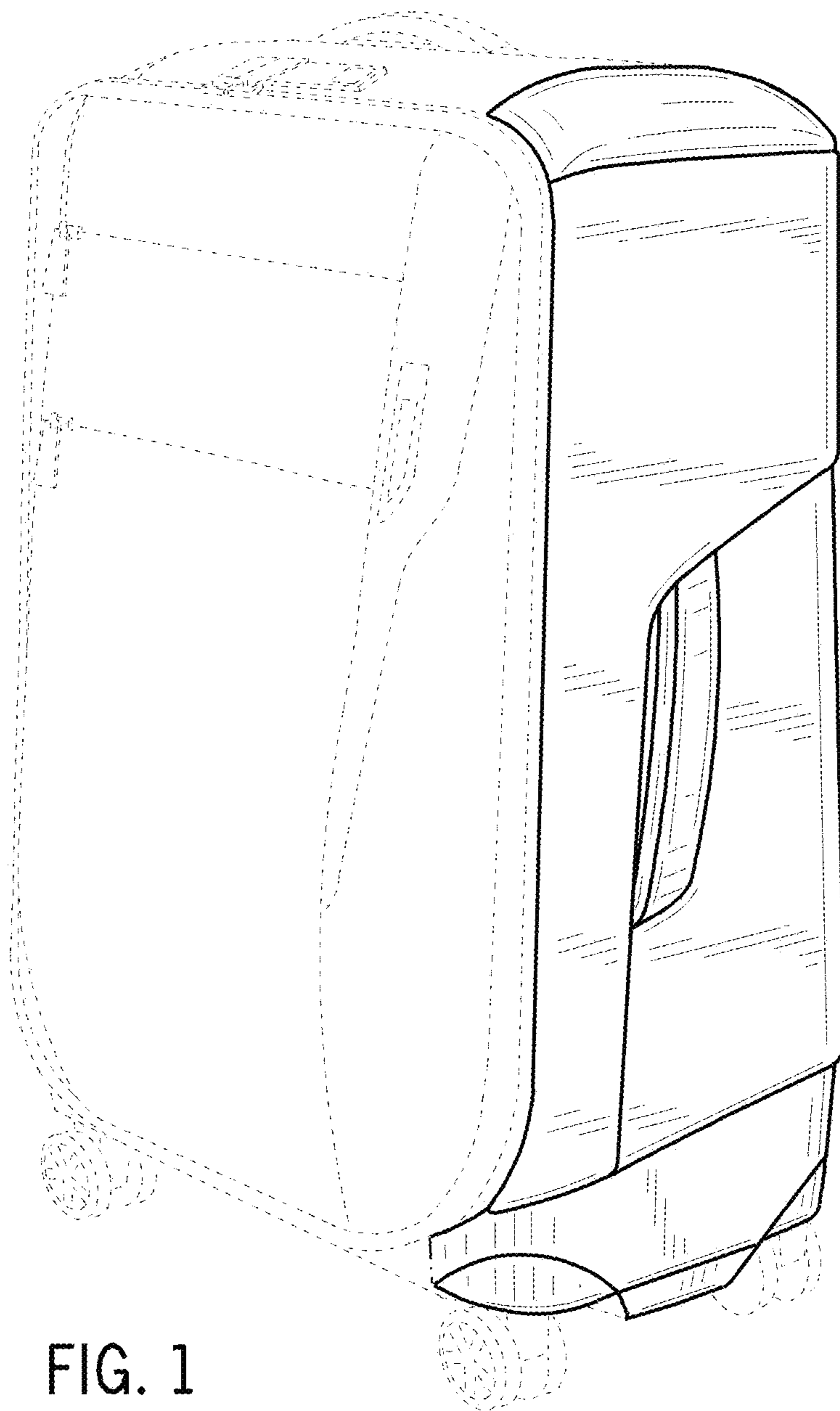

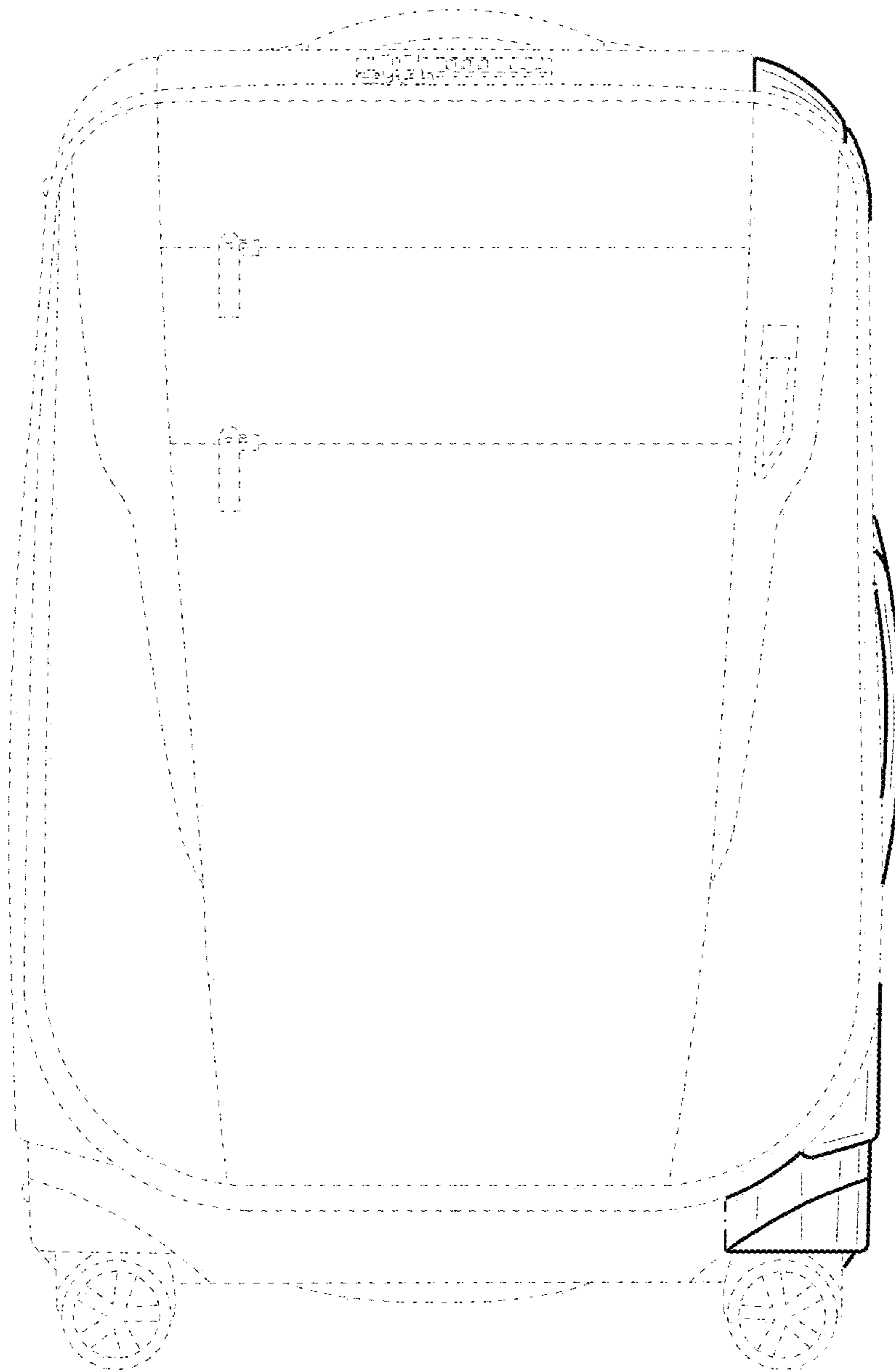

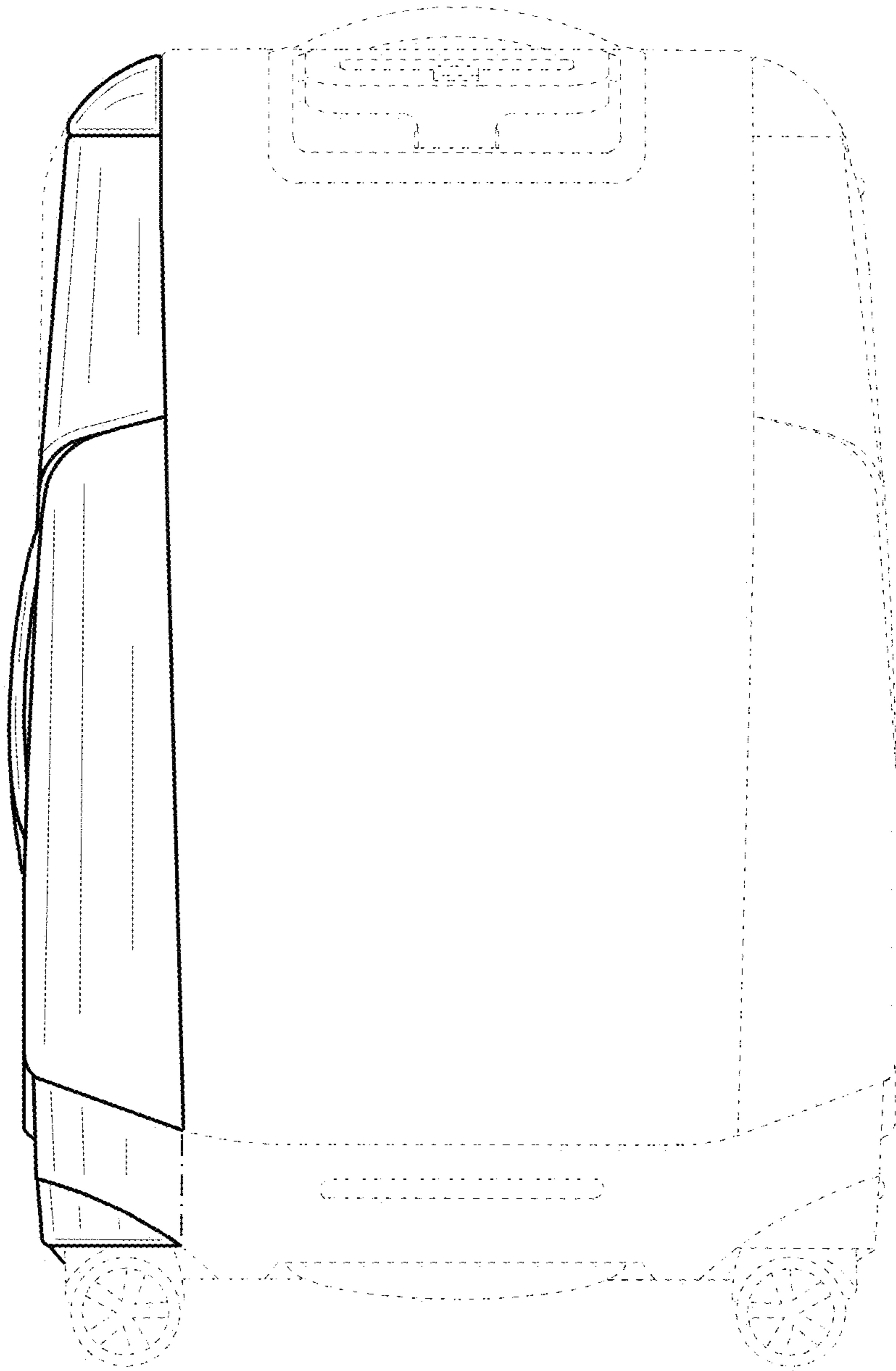

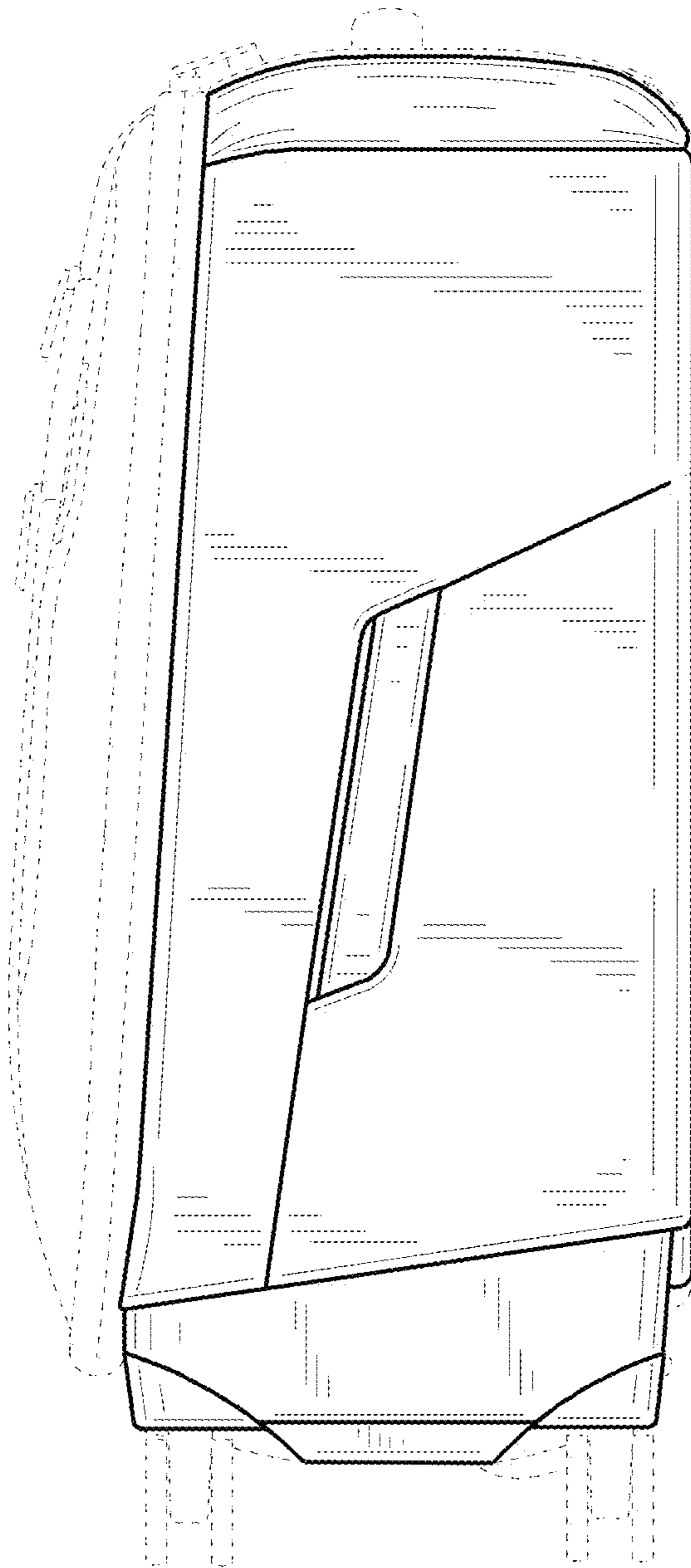

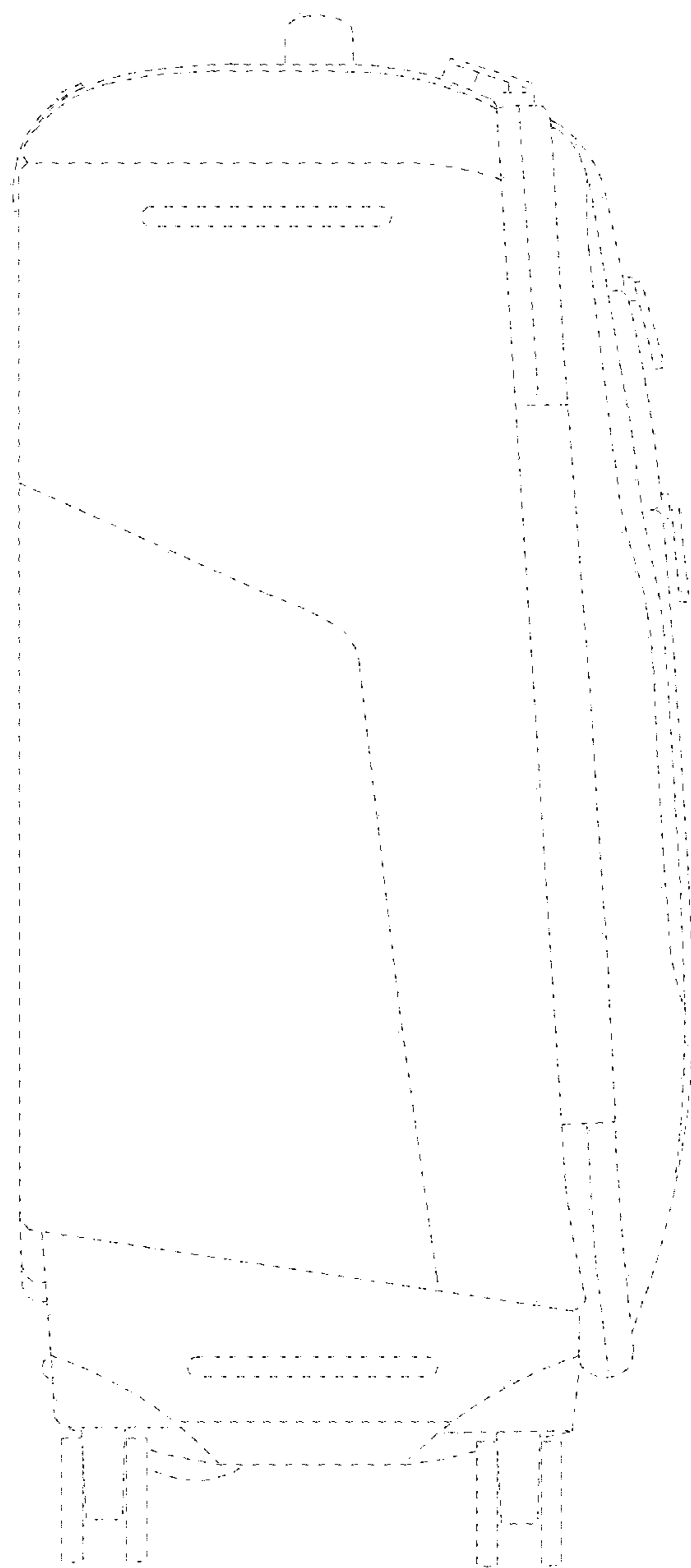

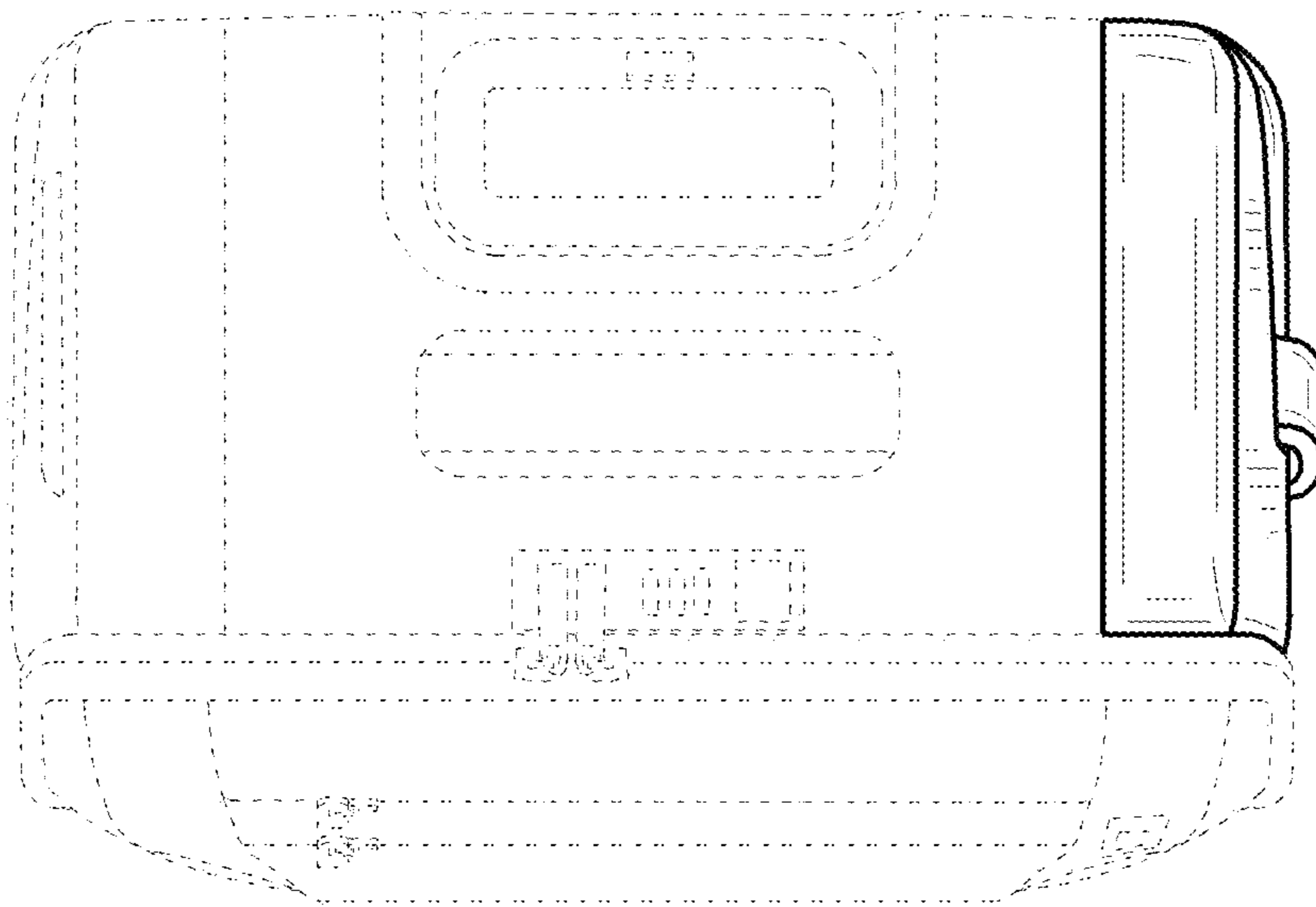

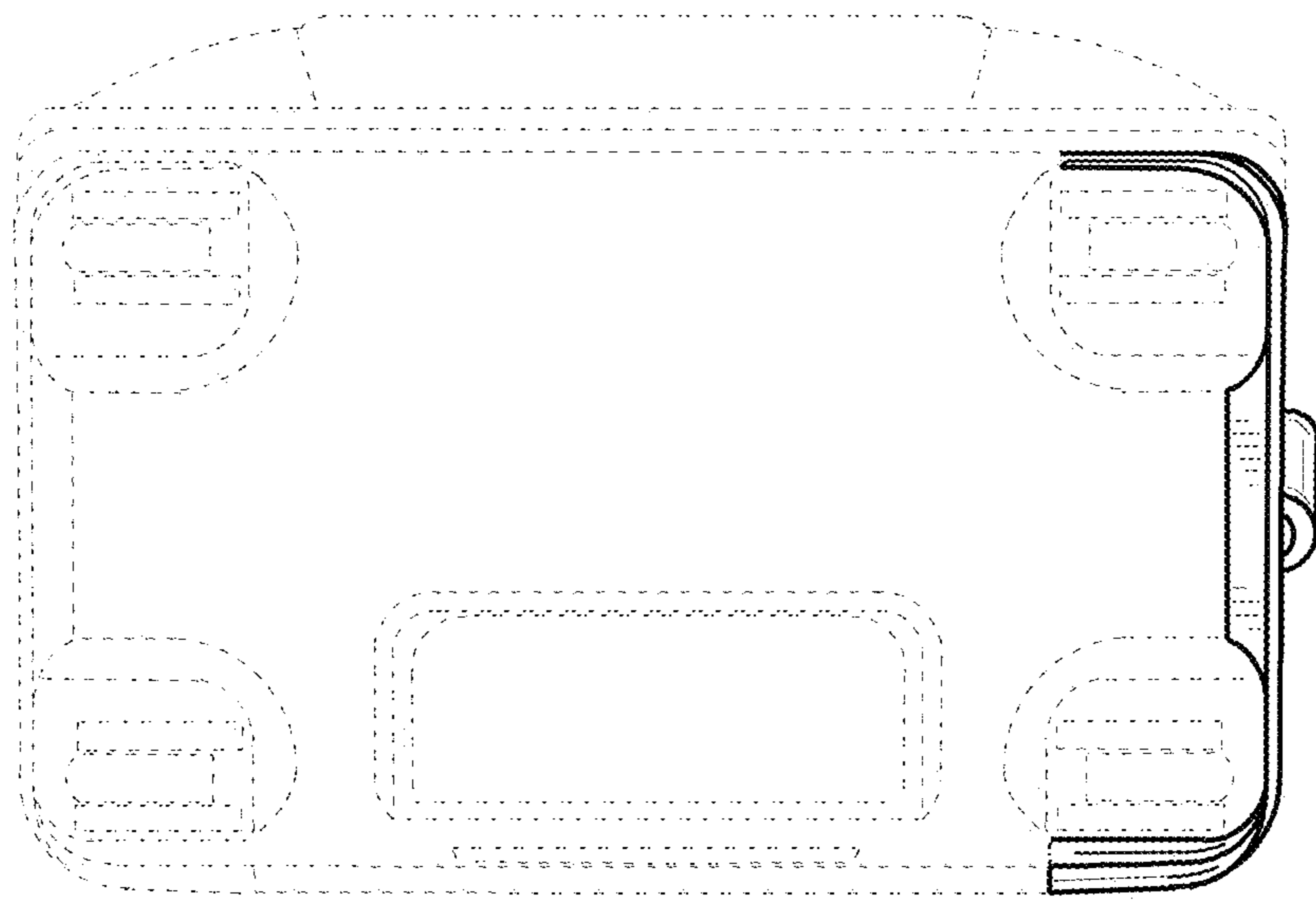
