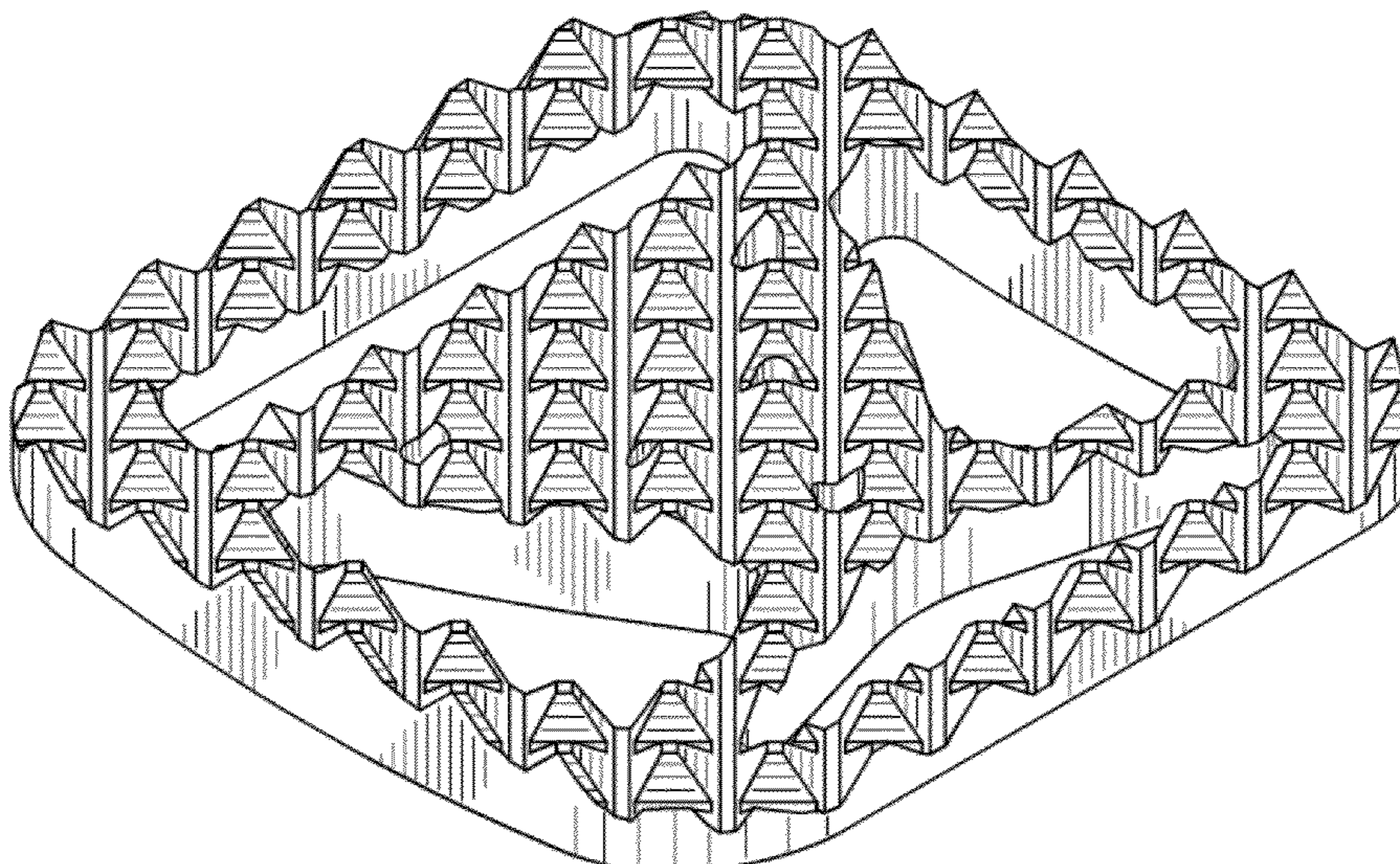
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top plan view of a bicycle clipless pedal platform adapter embodying our design;

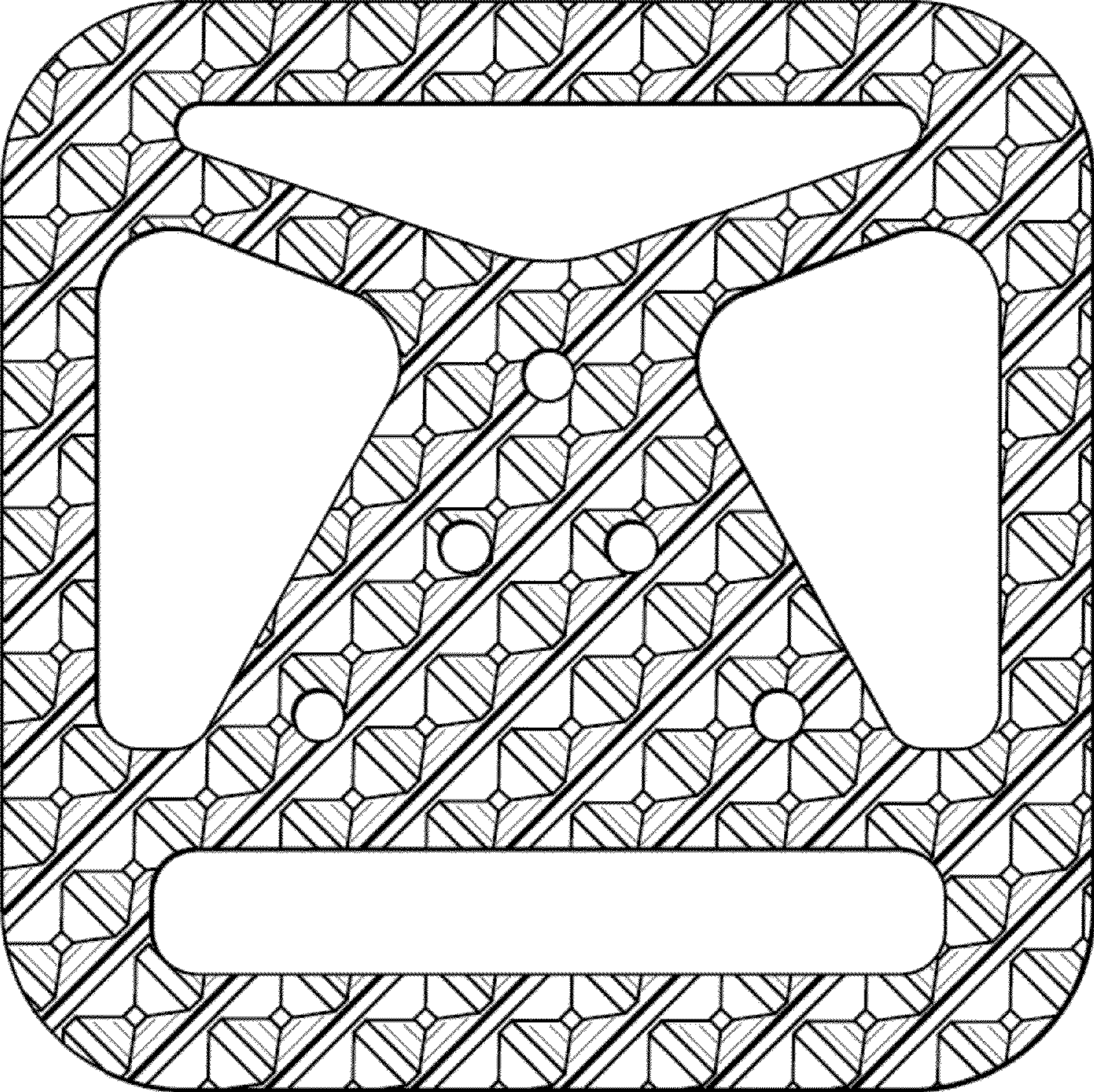

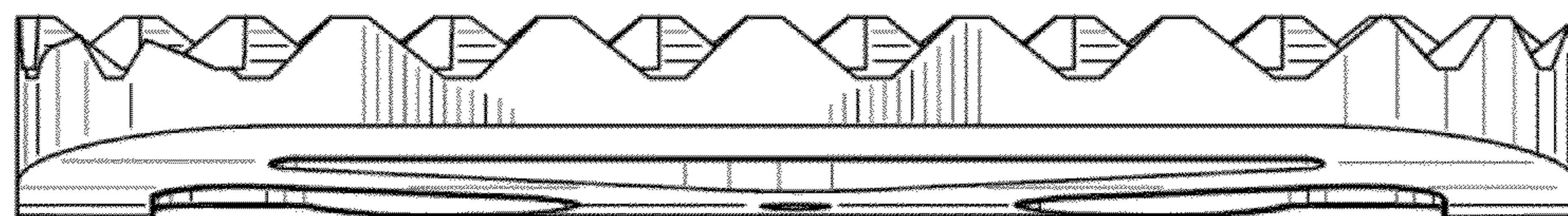

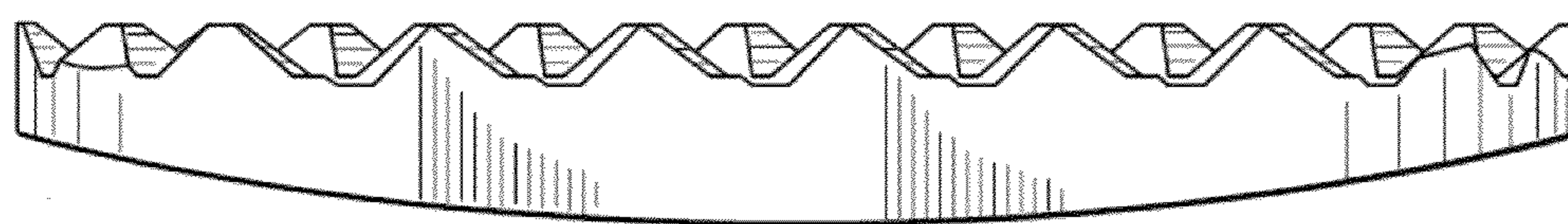

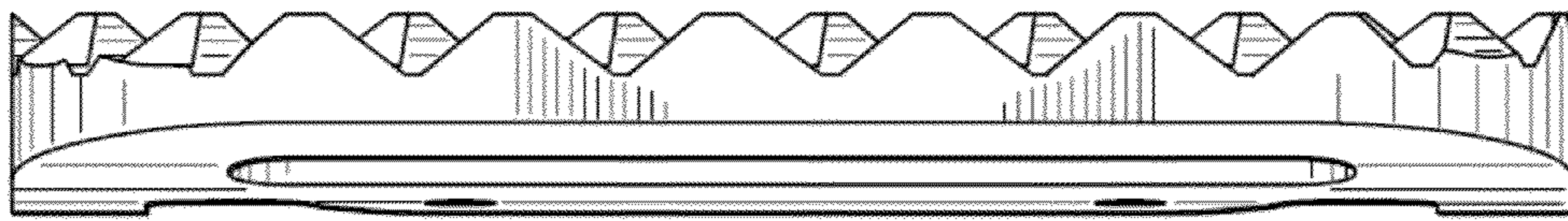

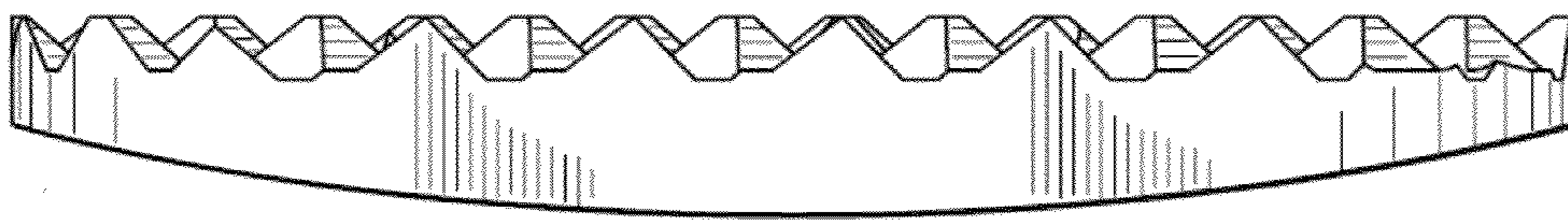

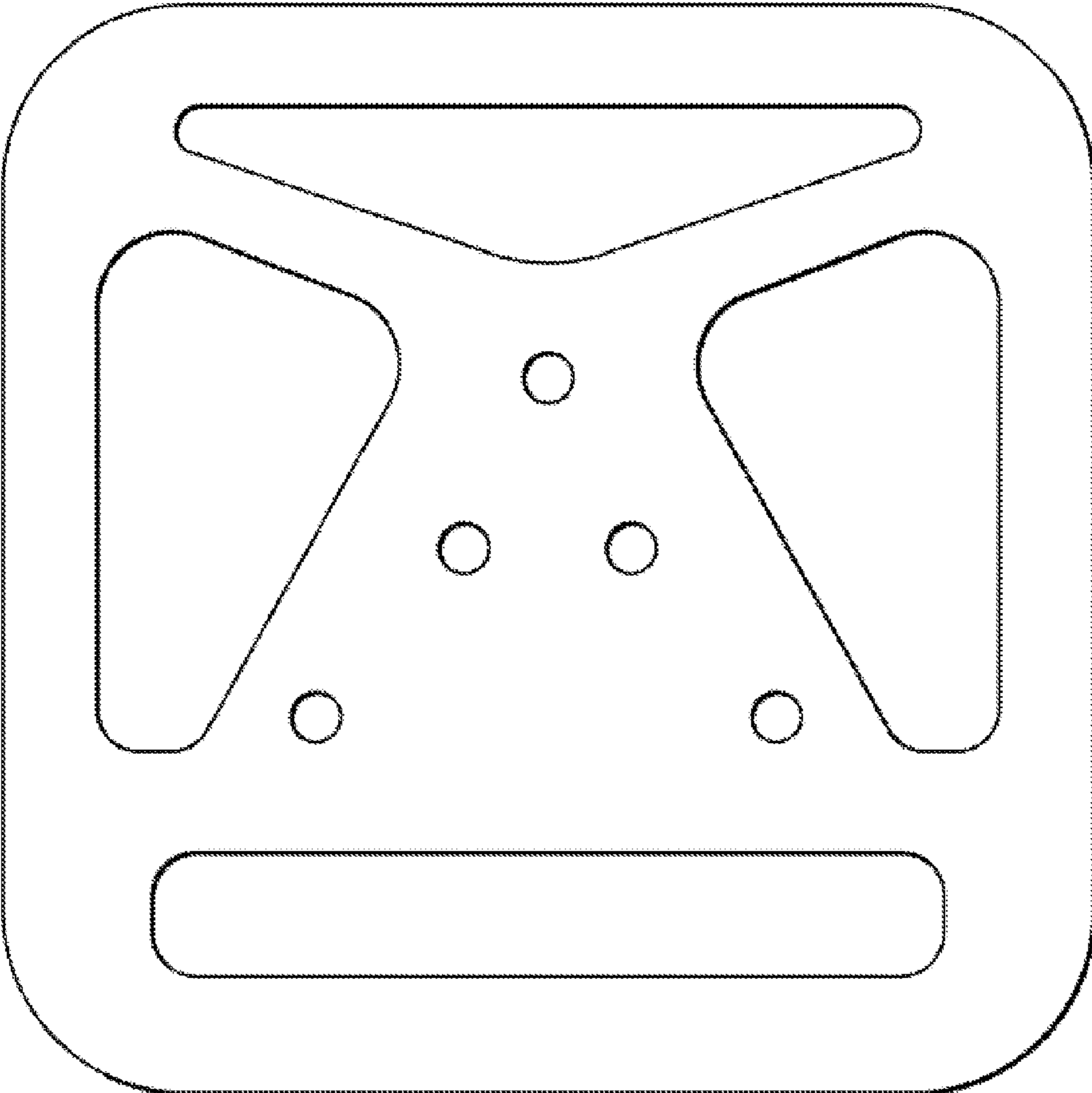

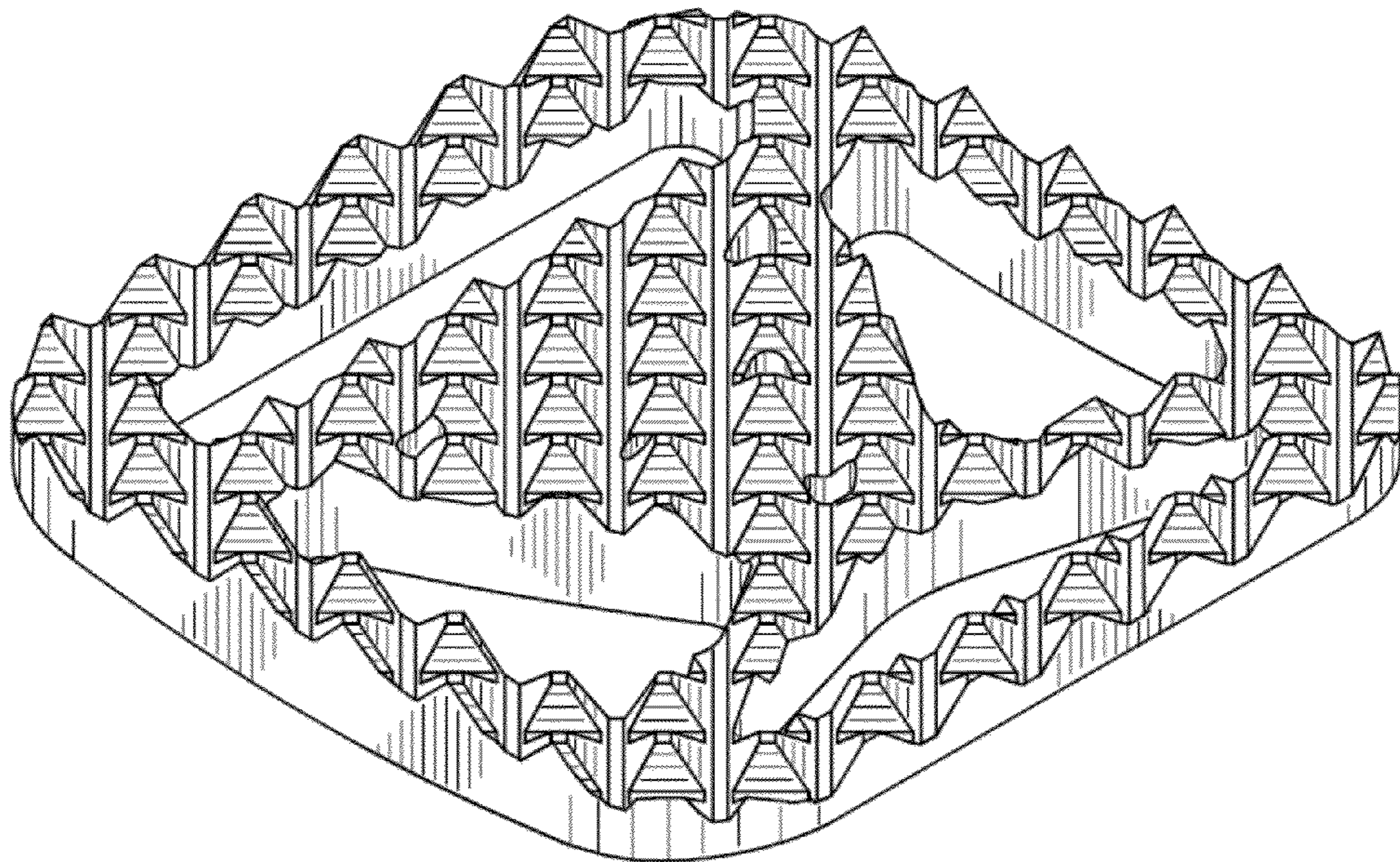
