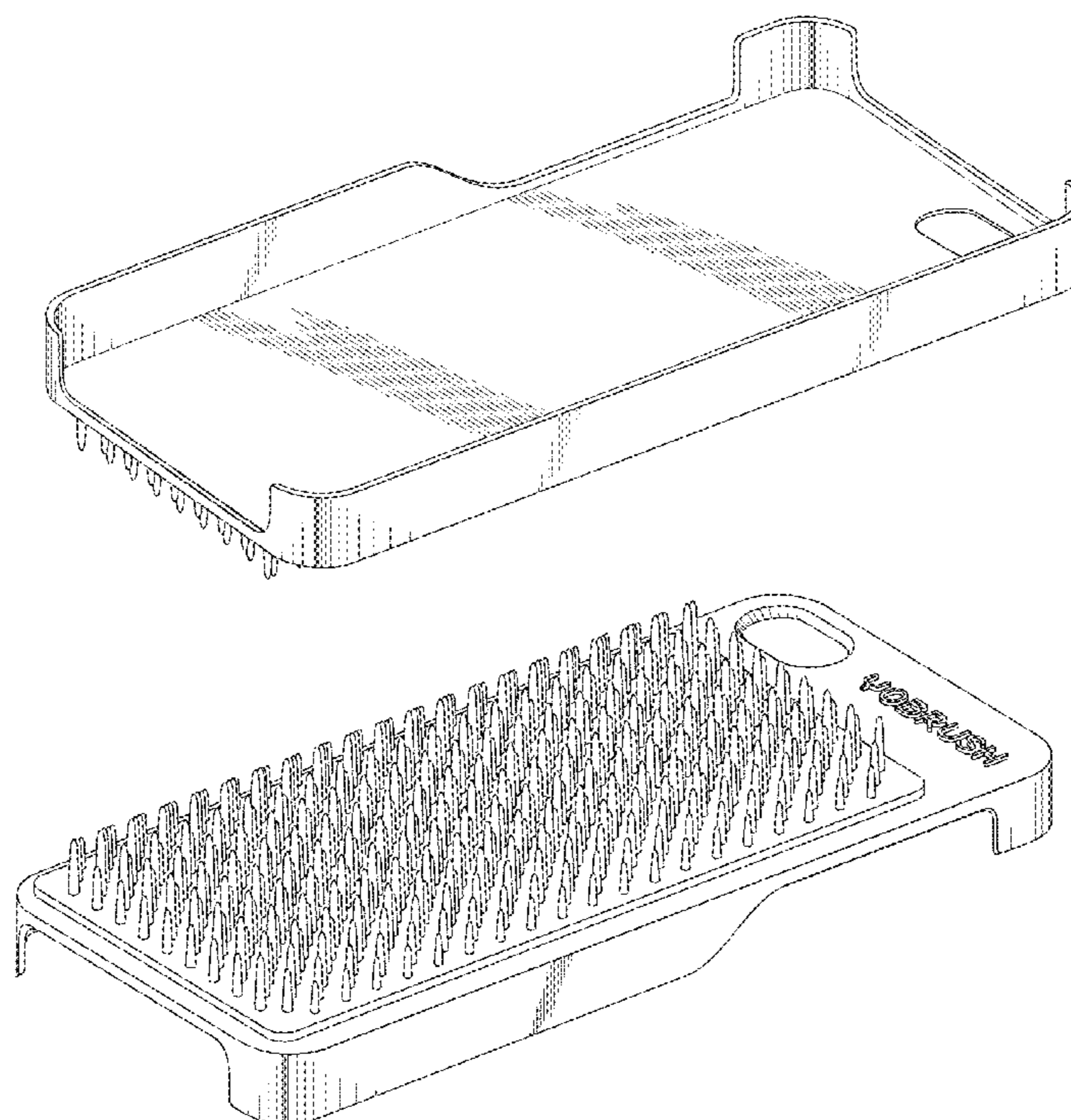
(57) **CLAIM**  
The ornamental design for a cellular accessory, as shown and described in the Figures.

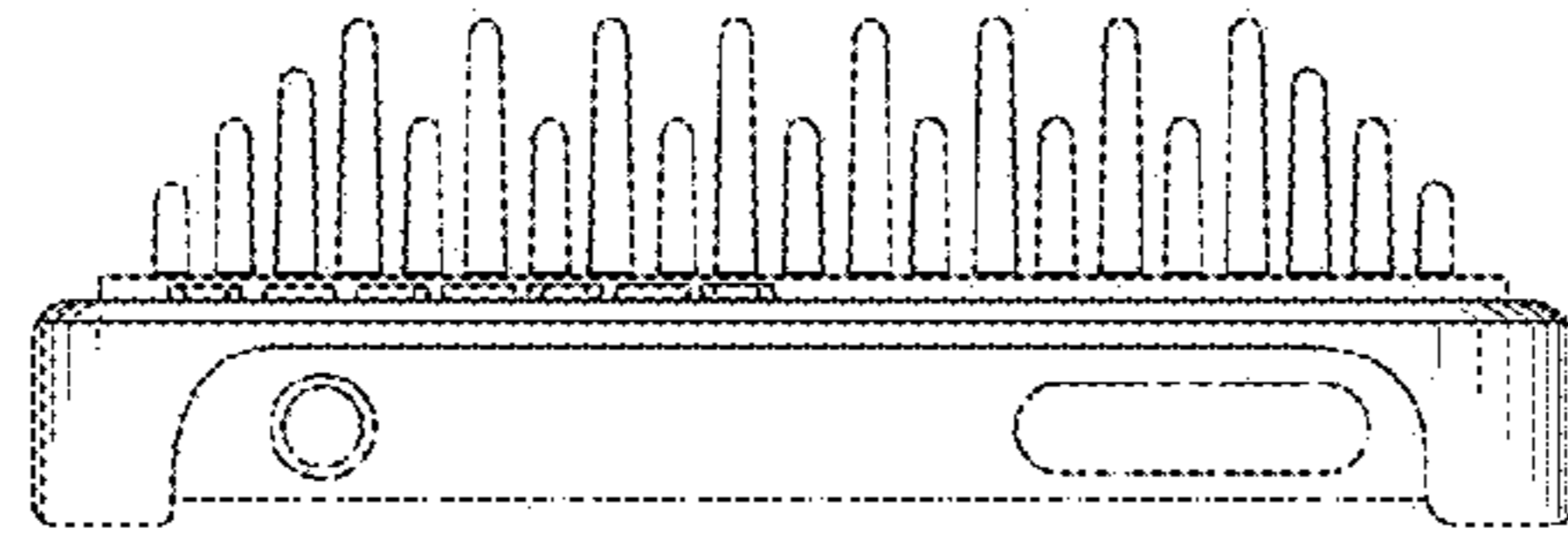
**DESCRIPTION**

The broken line showing of structure is for illustrative purposes only, and forms no part of the claimed design.

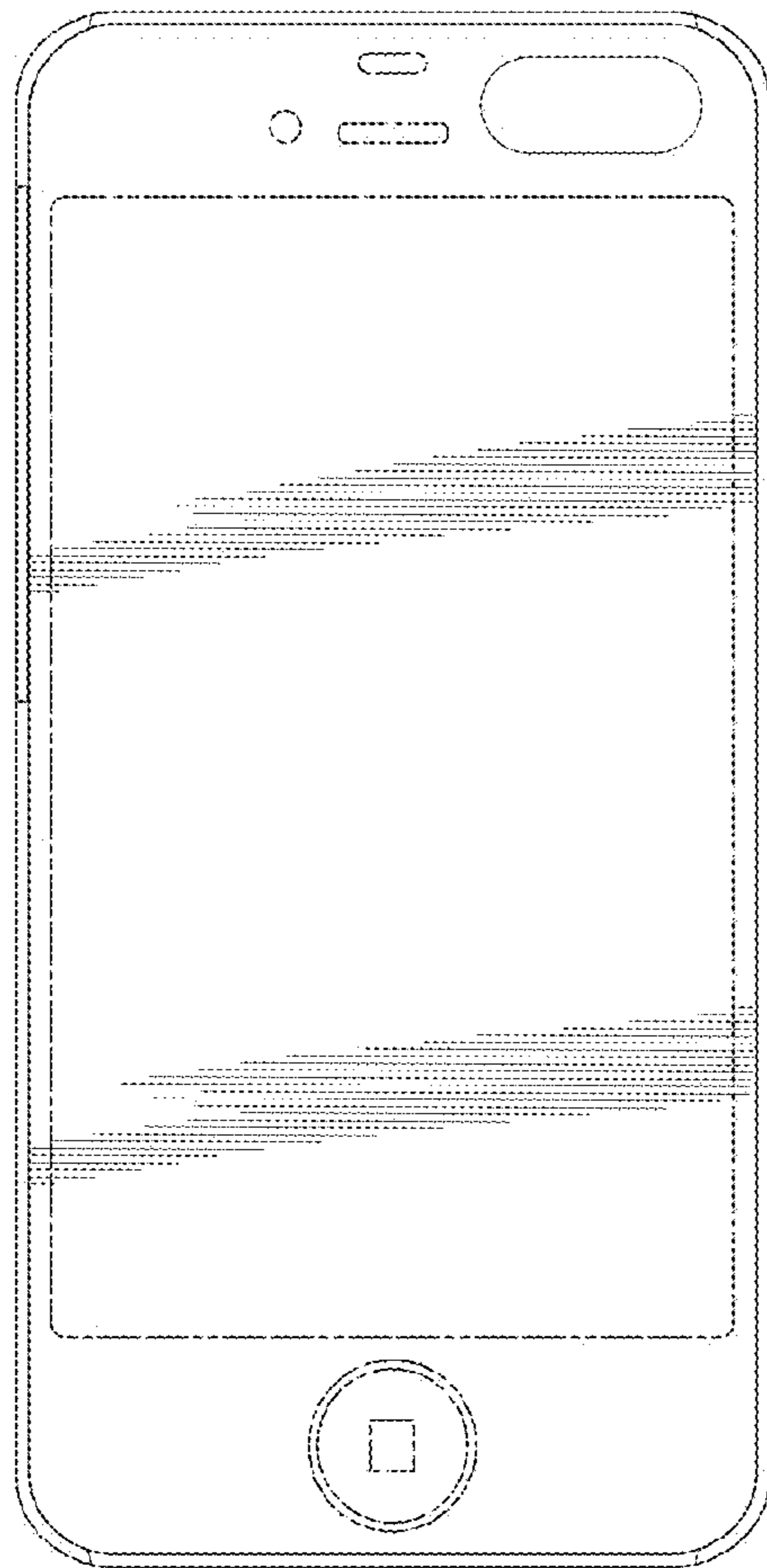

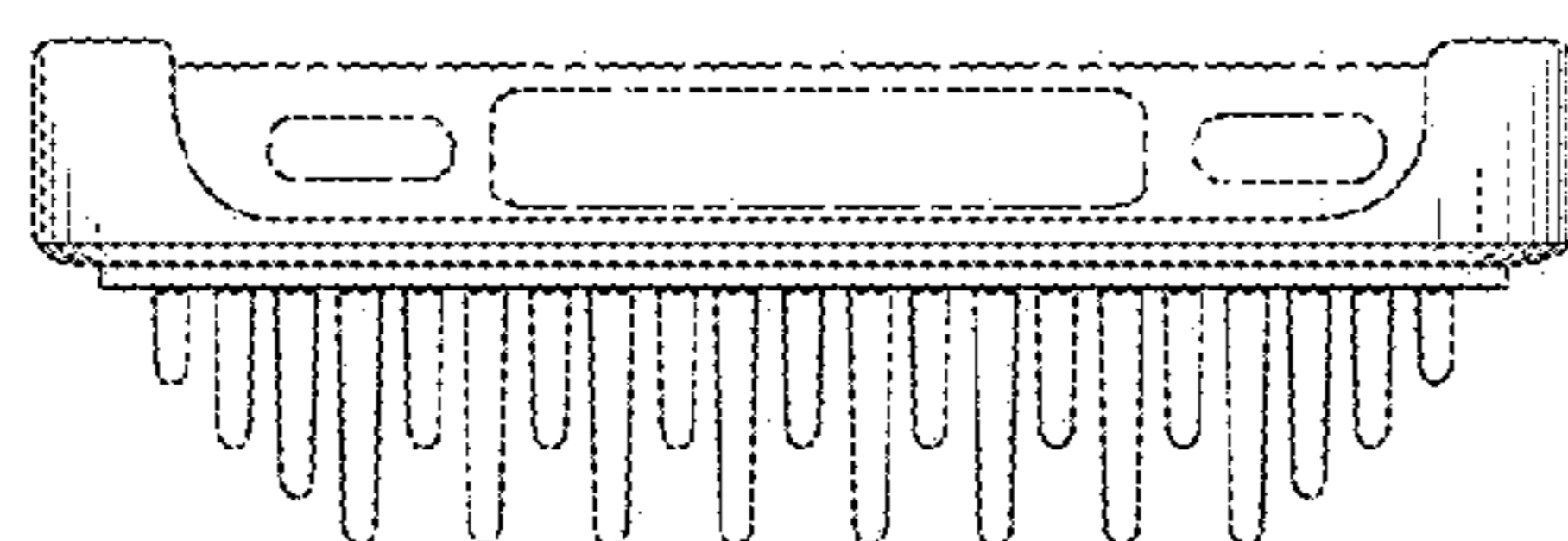

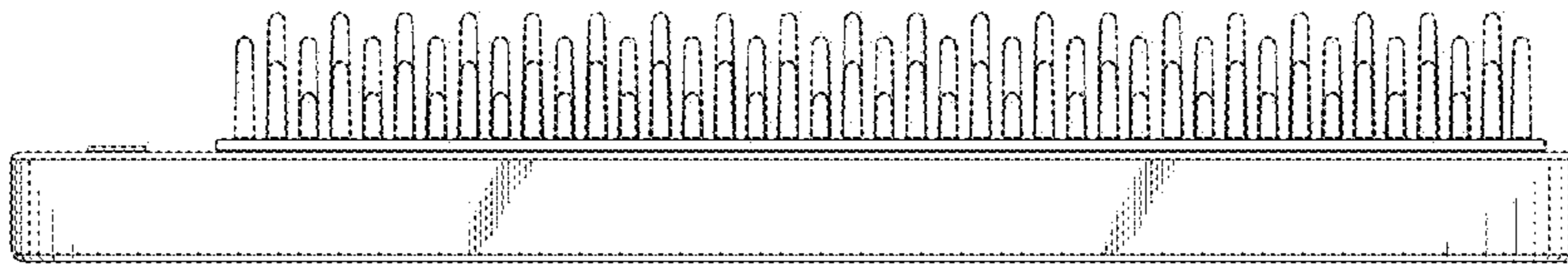

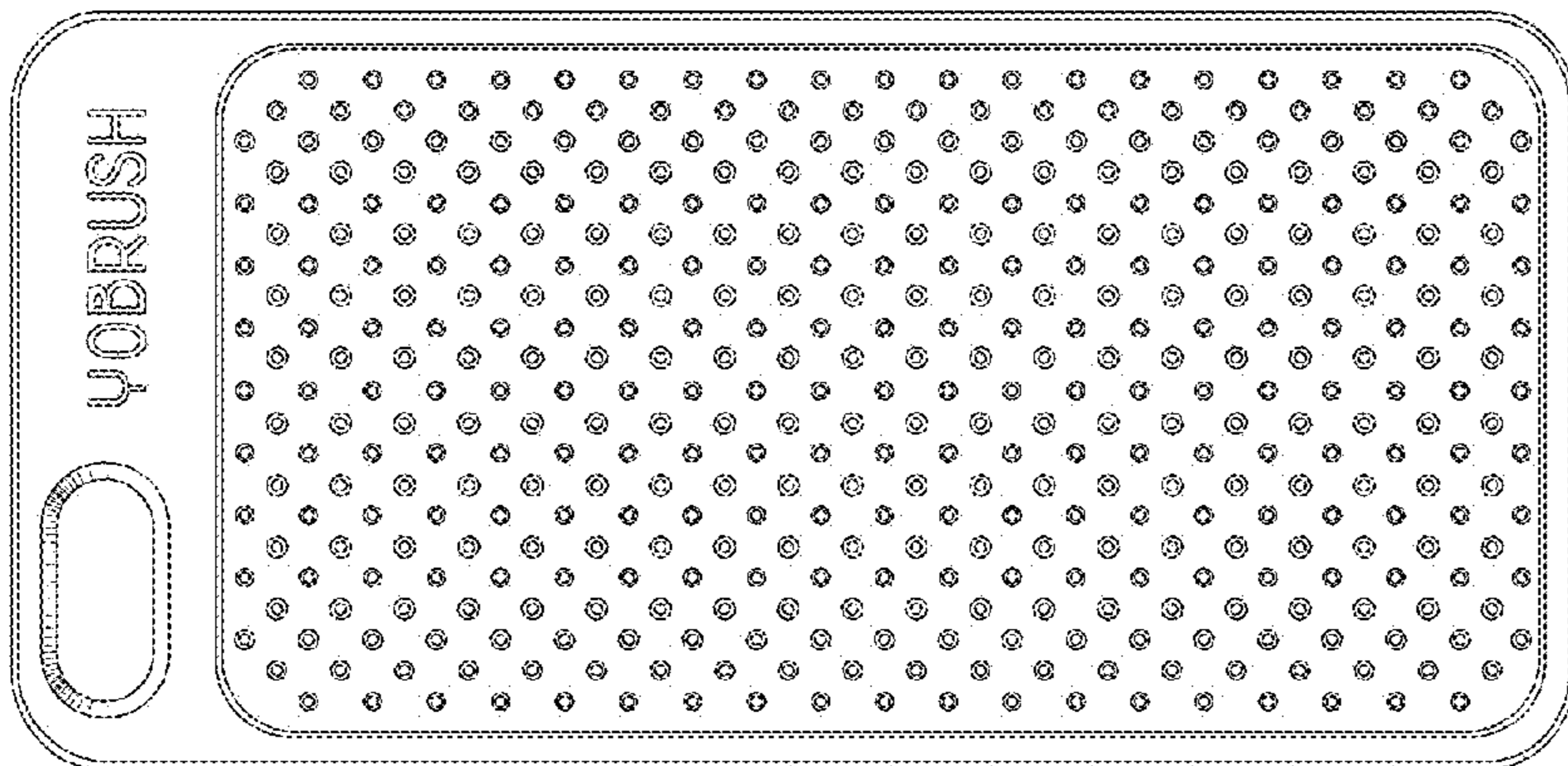

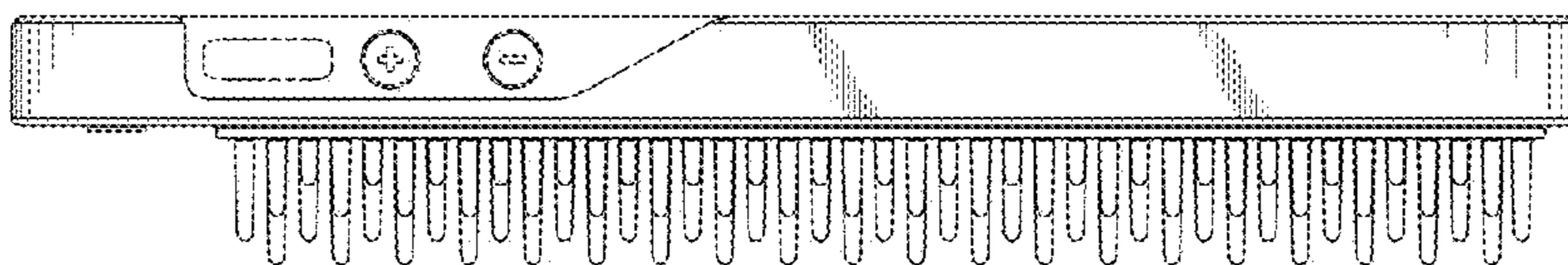
