(57) **CLAIM**

The ornamental design for a data receiver and transmitter, as shown and described.

**DESCRIPTION**

FIG. 1 is a back side view of a data receiver and transmitter of the present invention.

FIG. 2 is a front side view of the data receiver and transmitter of FIG. 1.

FIG. 3 is a left side view of the data receiver and transmitter of FIG. 1.

FIG. 4 is a right side view of the data receiver and transmitter of FIG. 1.

FIG. 5 is a top side view of the data receiver and transmitter of FIG. 1.

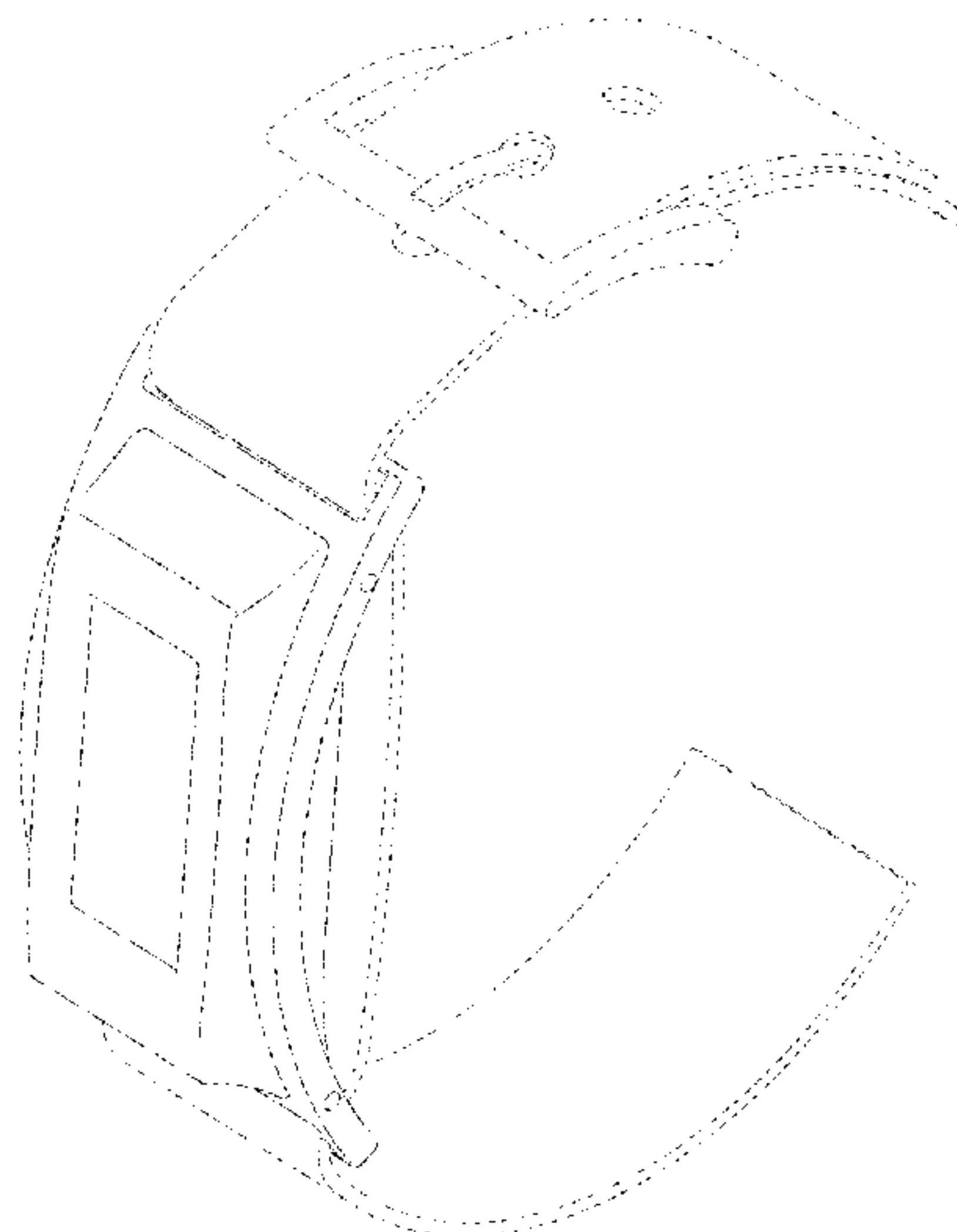
FIG. 6 is a bottom side view of the data receiver and transmitter of FIG. 1.

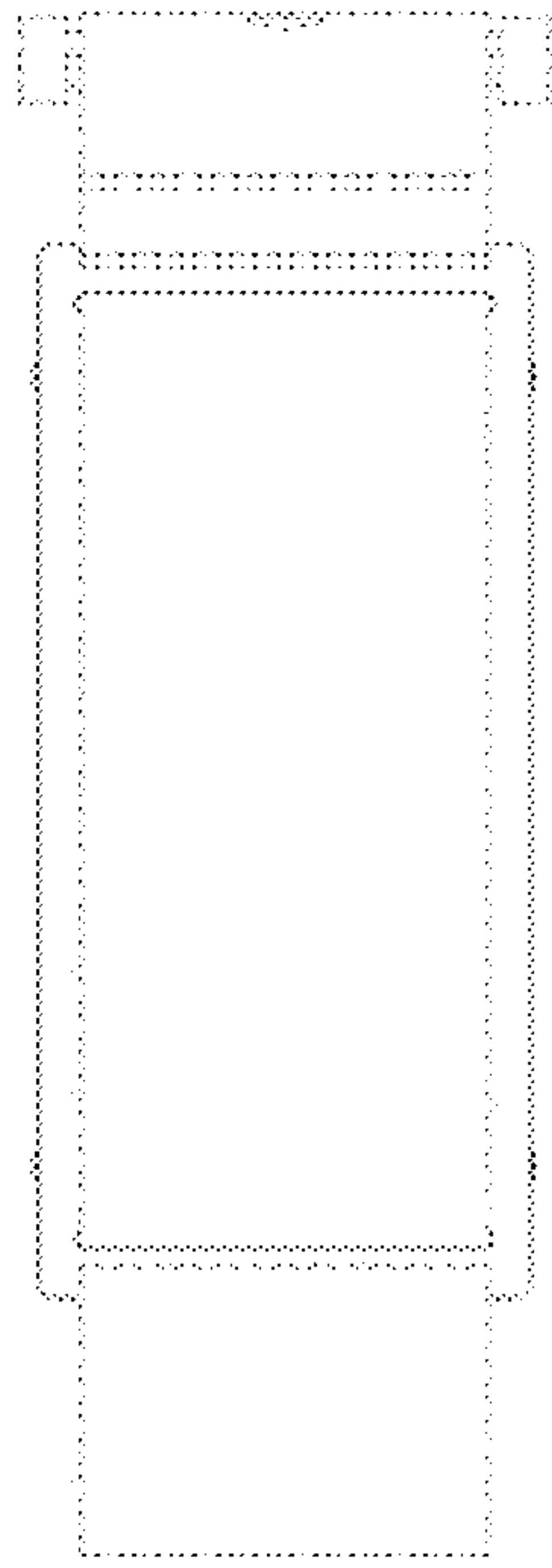

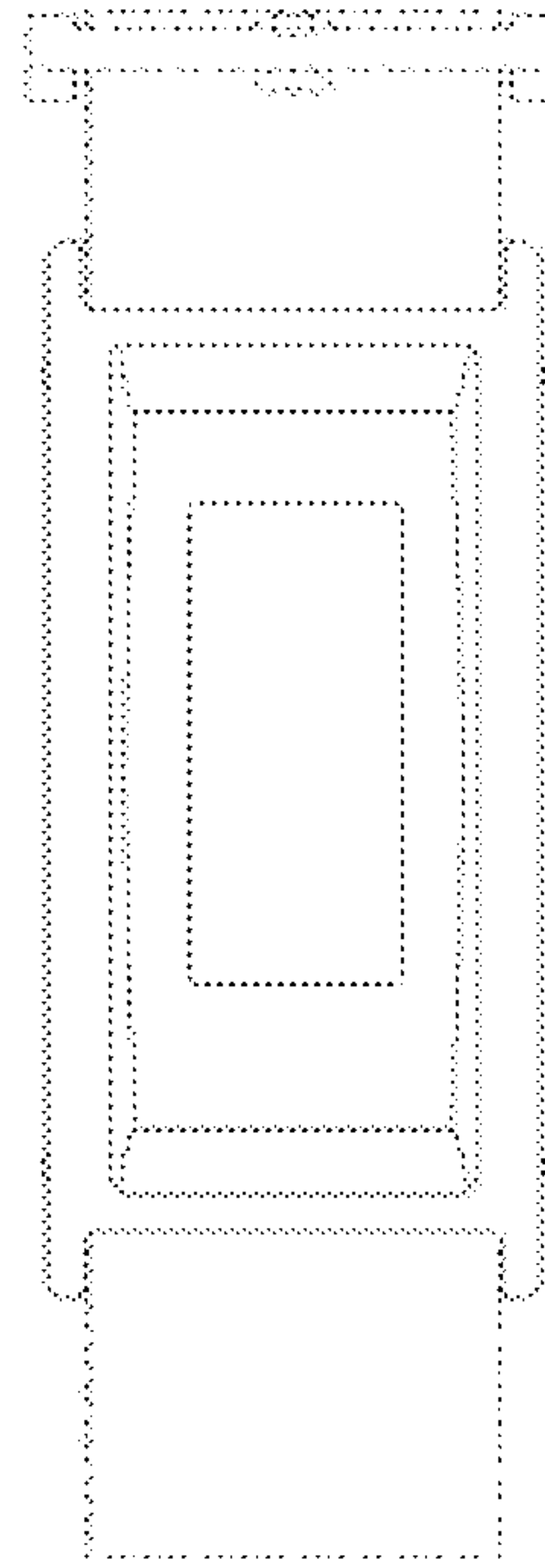

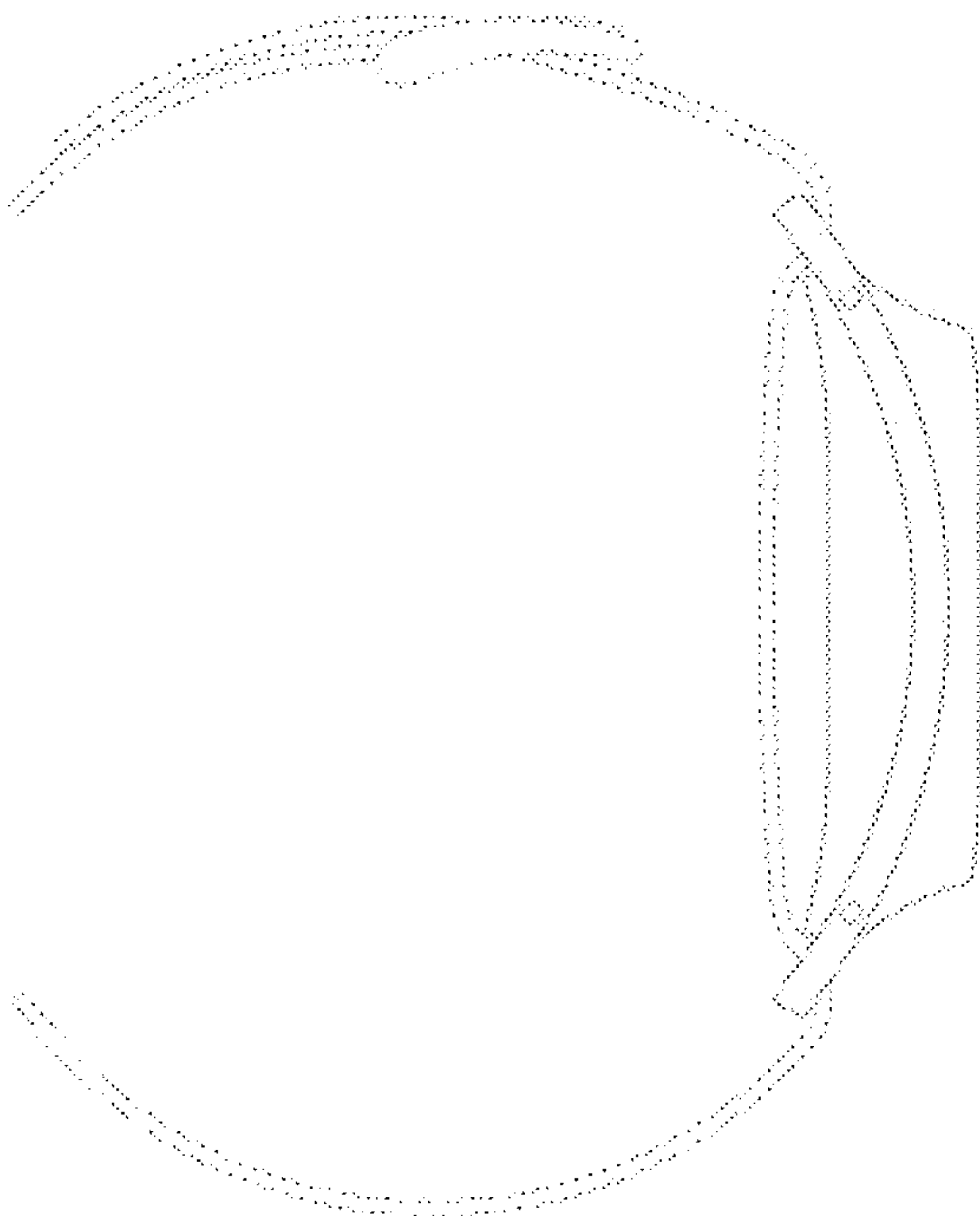

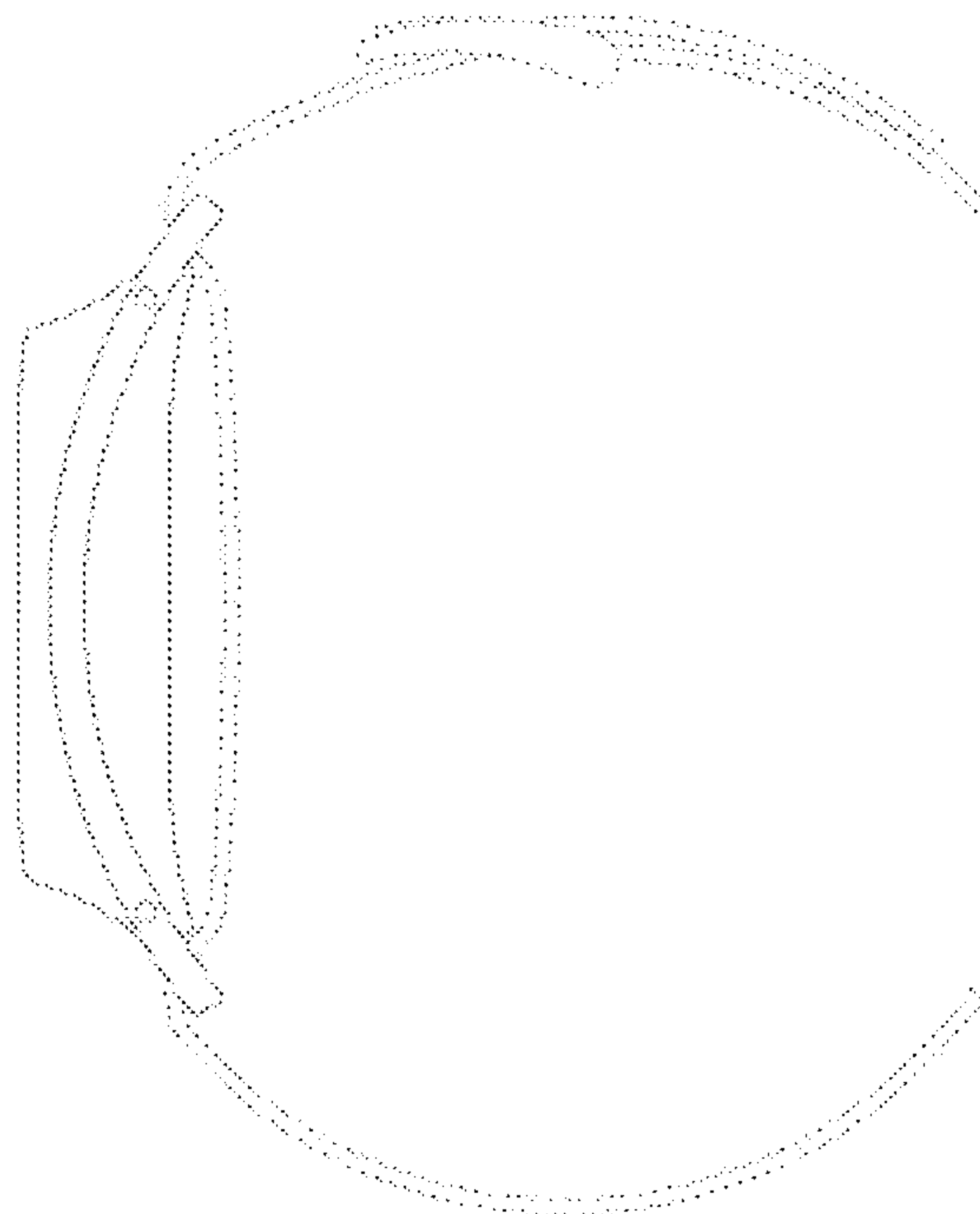

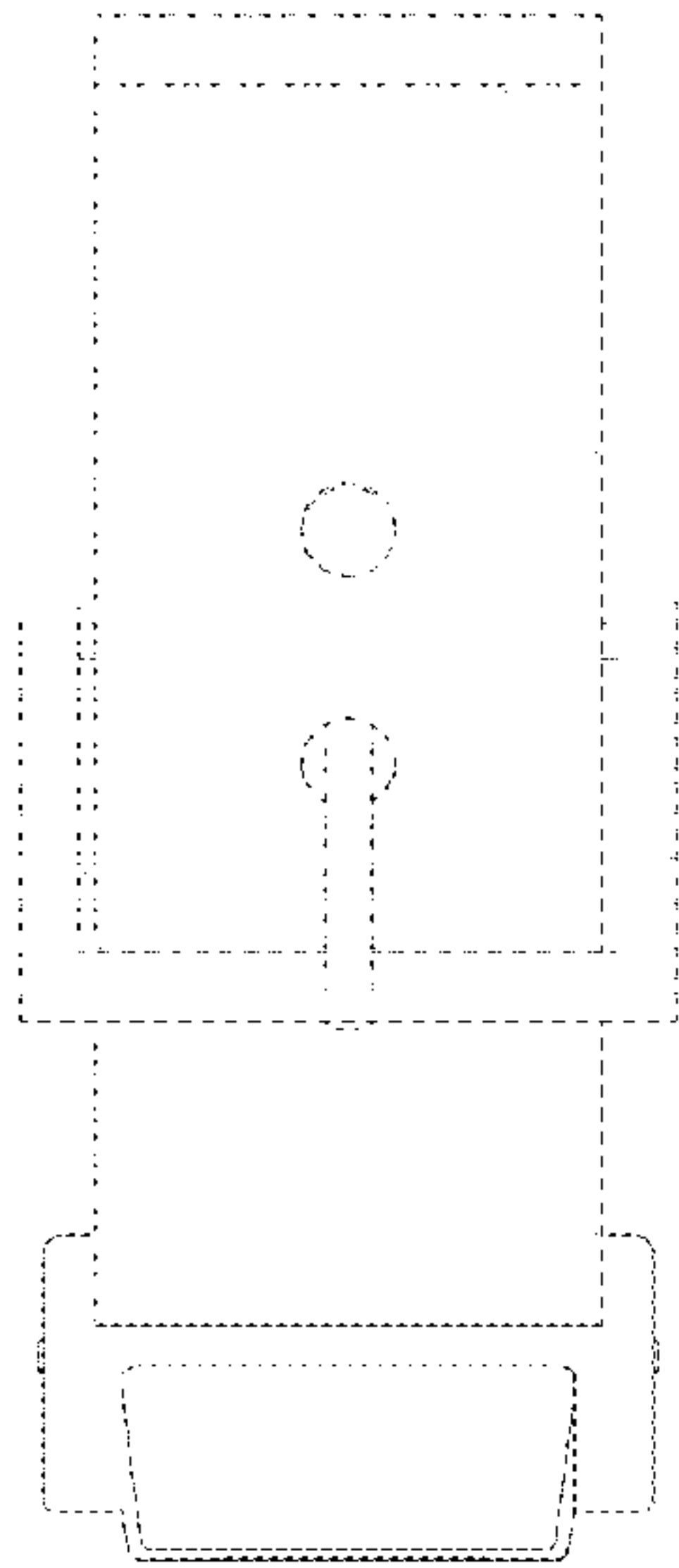

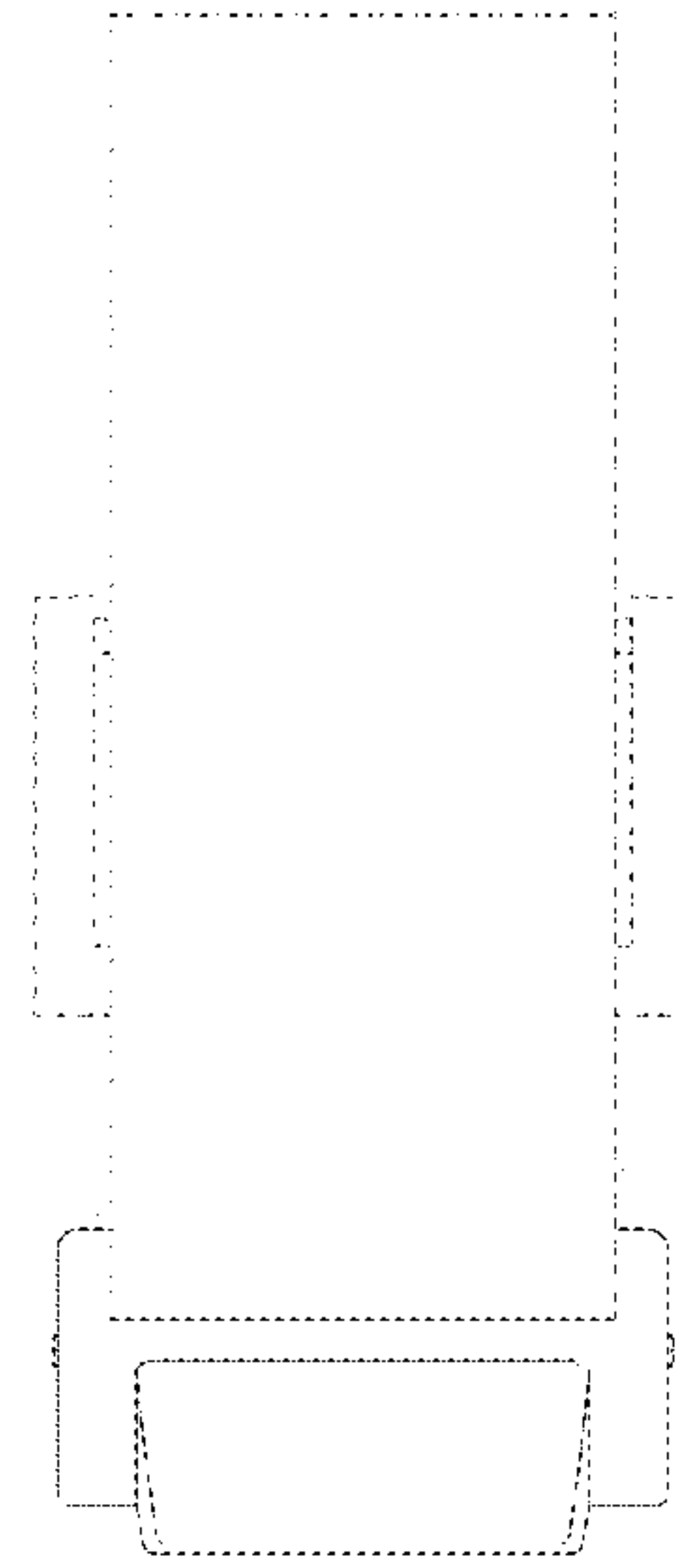

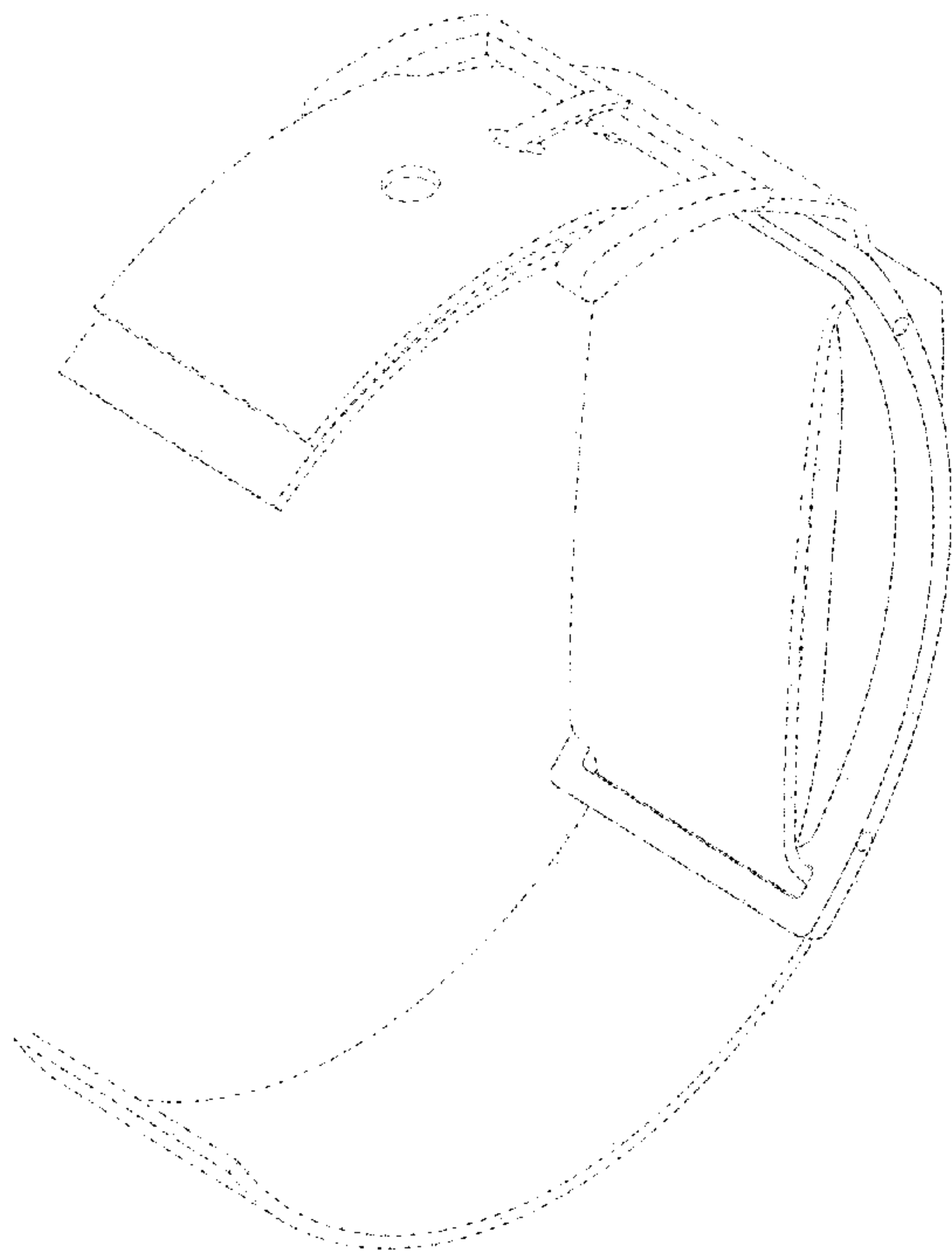

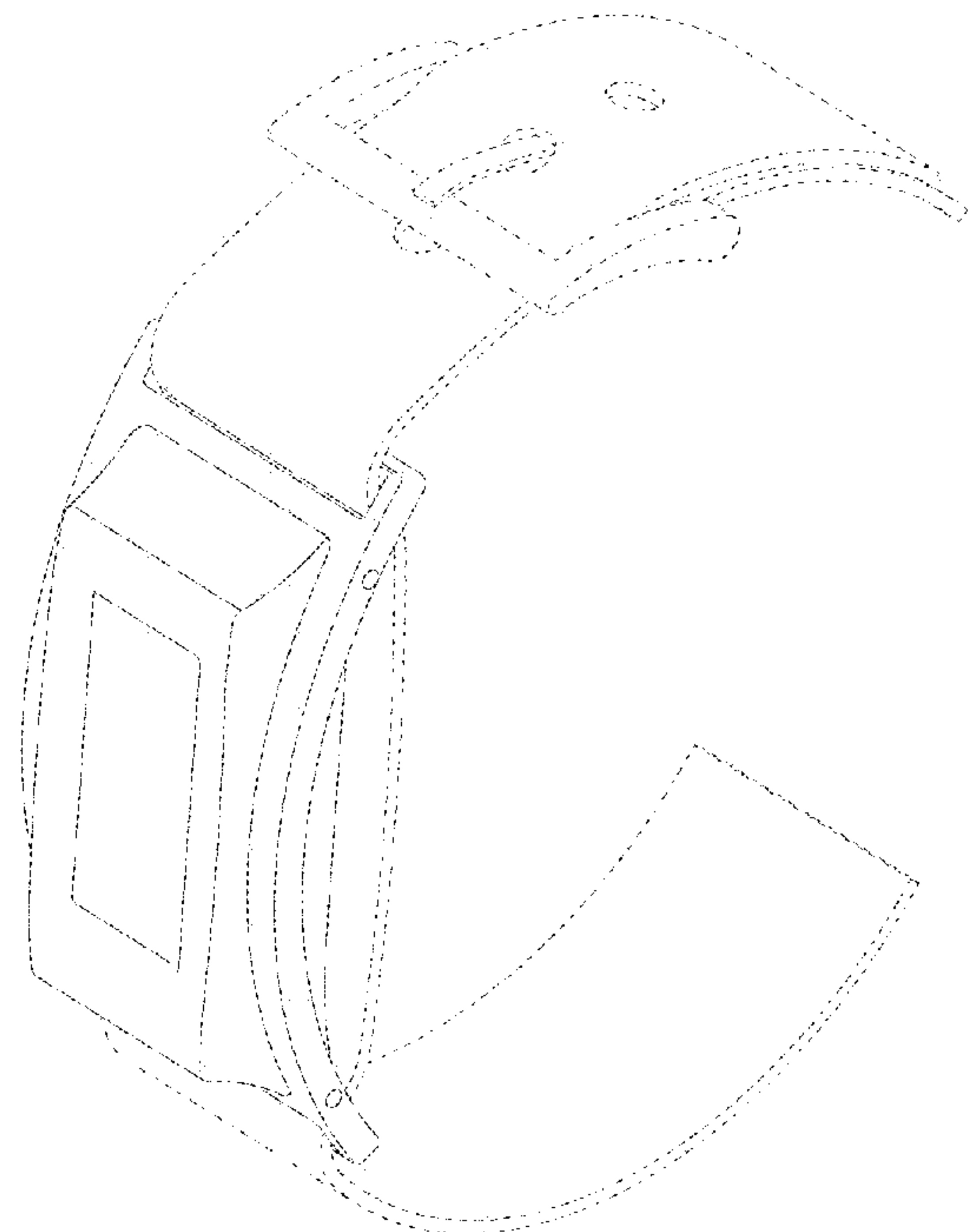
