We claim the ornamental design for a display screen with animated graphical user interface, as shown and described.

DESCRIPTION

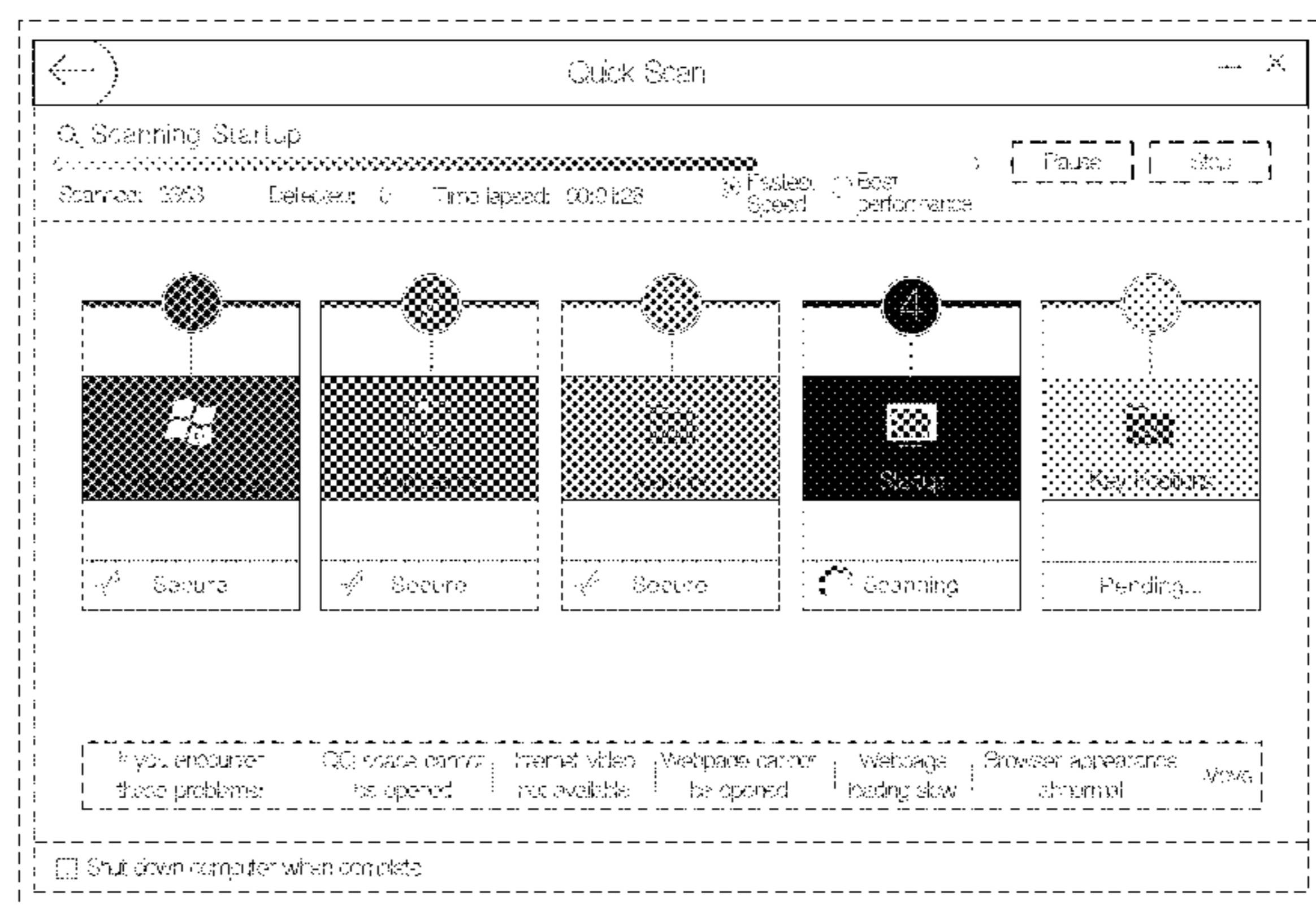
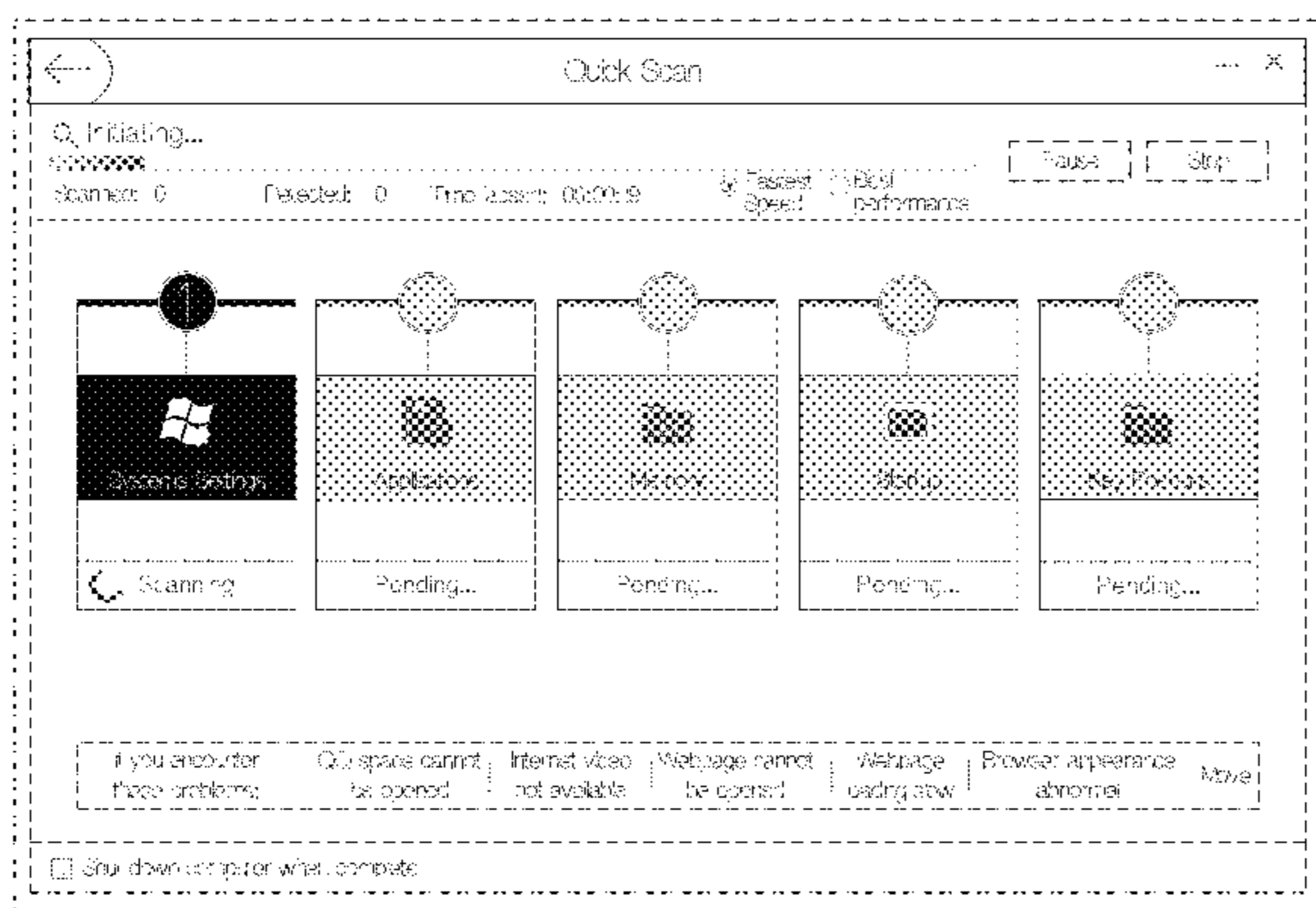
FIG. 1 is a first image for a display screen with animated graphical user interface; and,

FIG. 2 is a second image thereof.

The broken lines in the drawings illustrate portions of a display screen with animated graphical user interface that forms no part of the claimed design. The dotted lines representational of the words and numbers illustrate portions of the animated graphical user interface and forms no part of the claimed design.

The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1-2. The process or period in which one image transitions to another image forms no part of the claimed design.

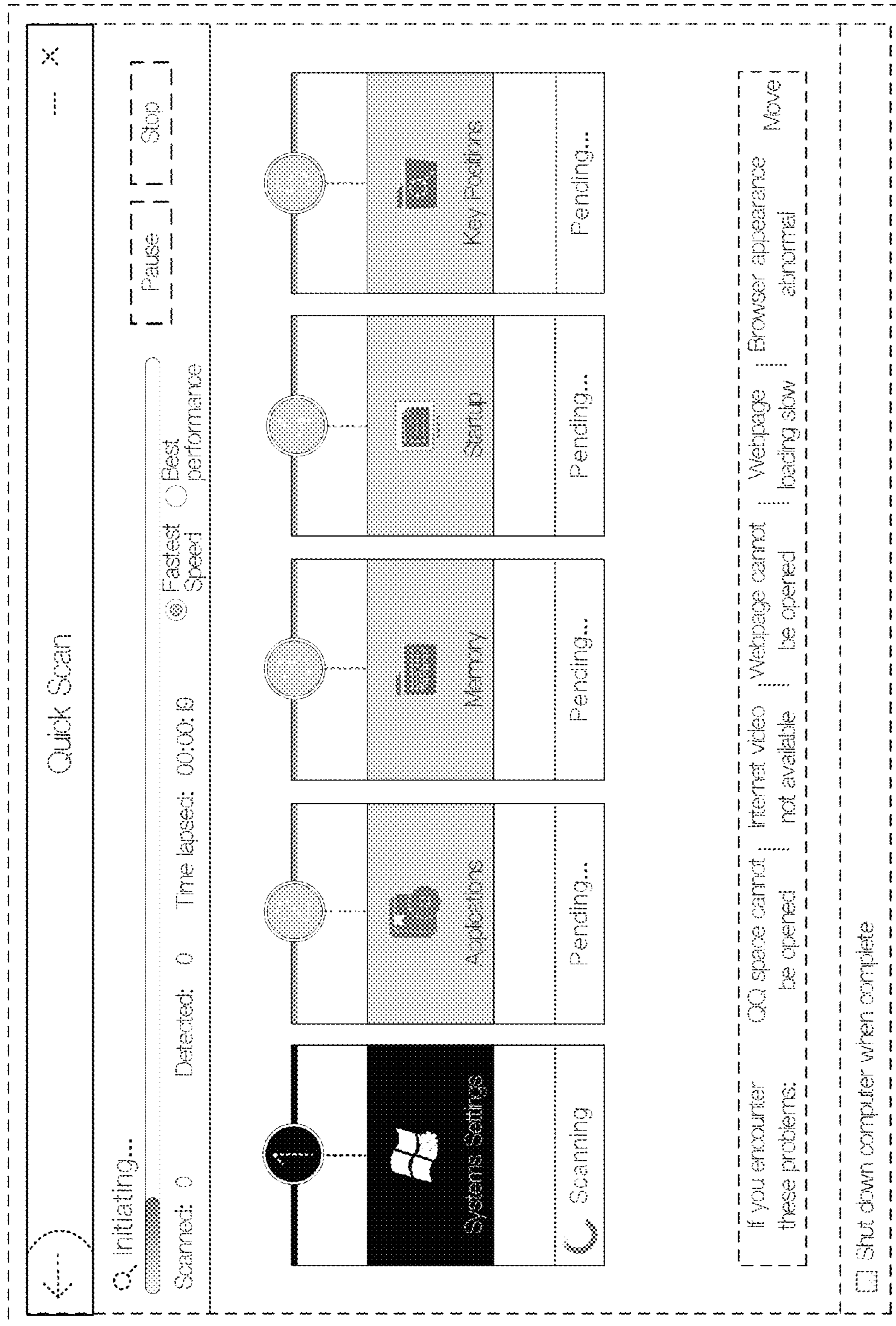

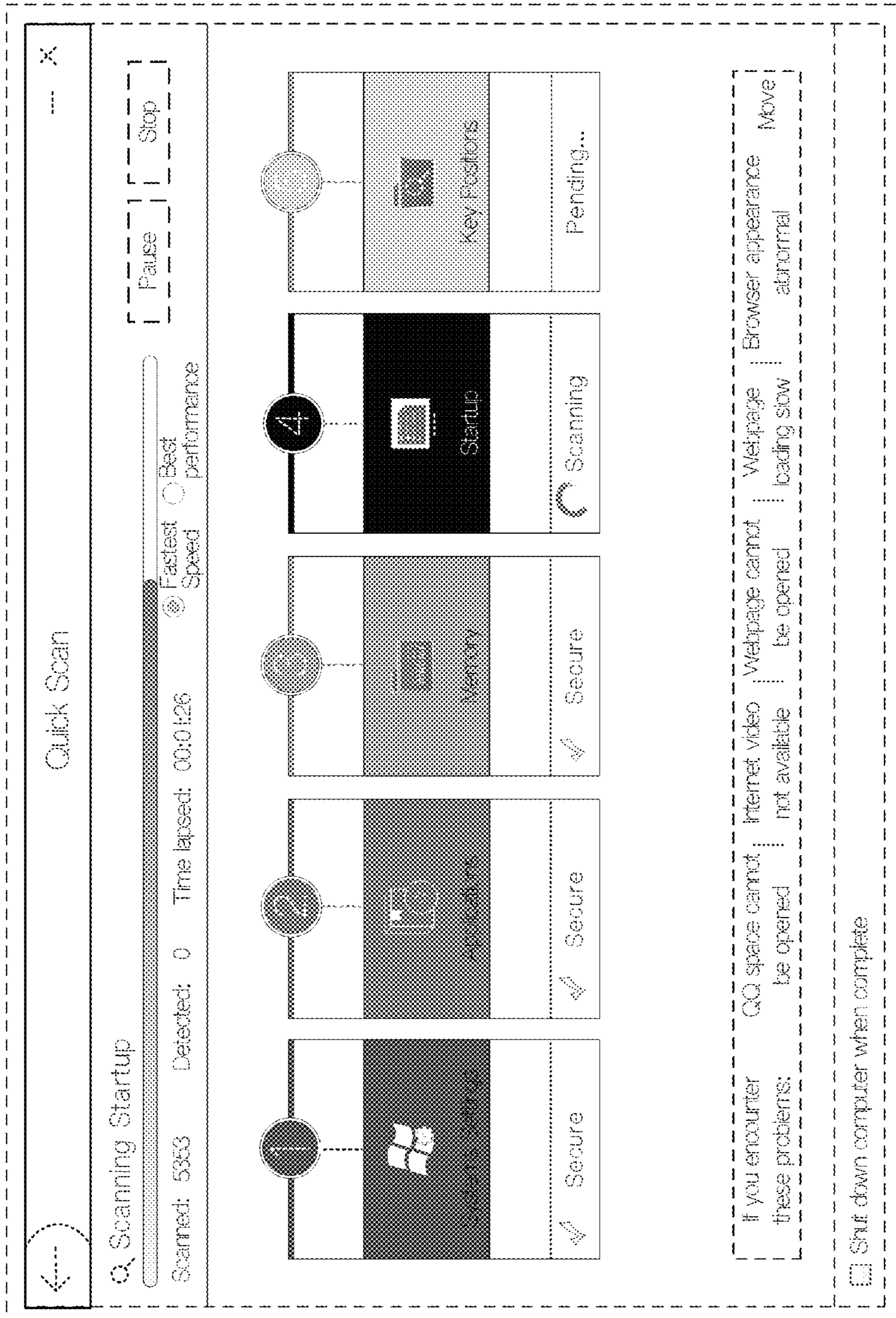
