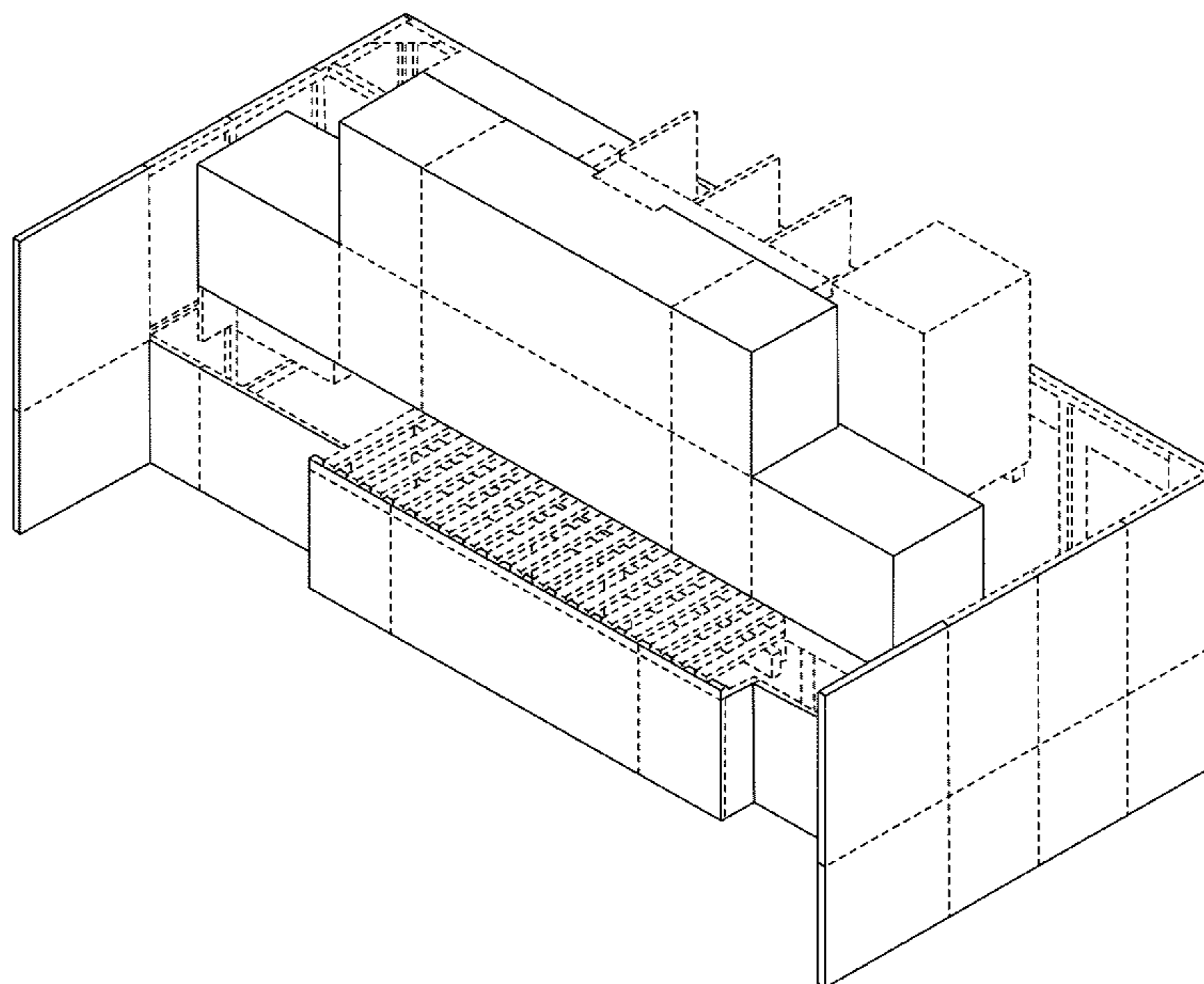
(57) **CLAIM**

The ornamental design for a bending machine, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of our bending machine. FIG. 2 is a front view of our bending machine. FIG. 3 is a back view of our bending machine. FIG. 4 is a right side view of our bending machine. FIG. 5 is a left side view of our bending machine. 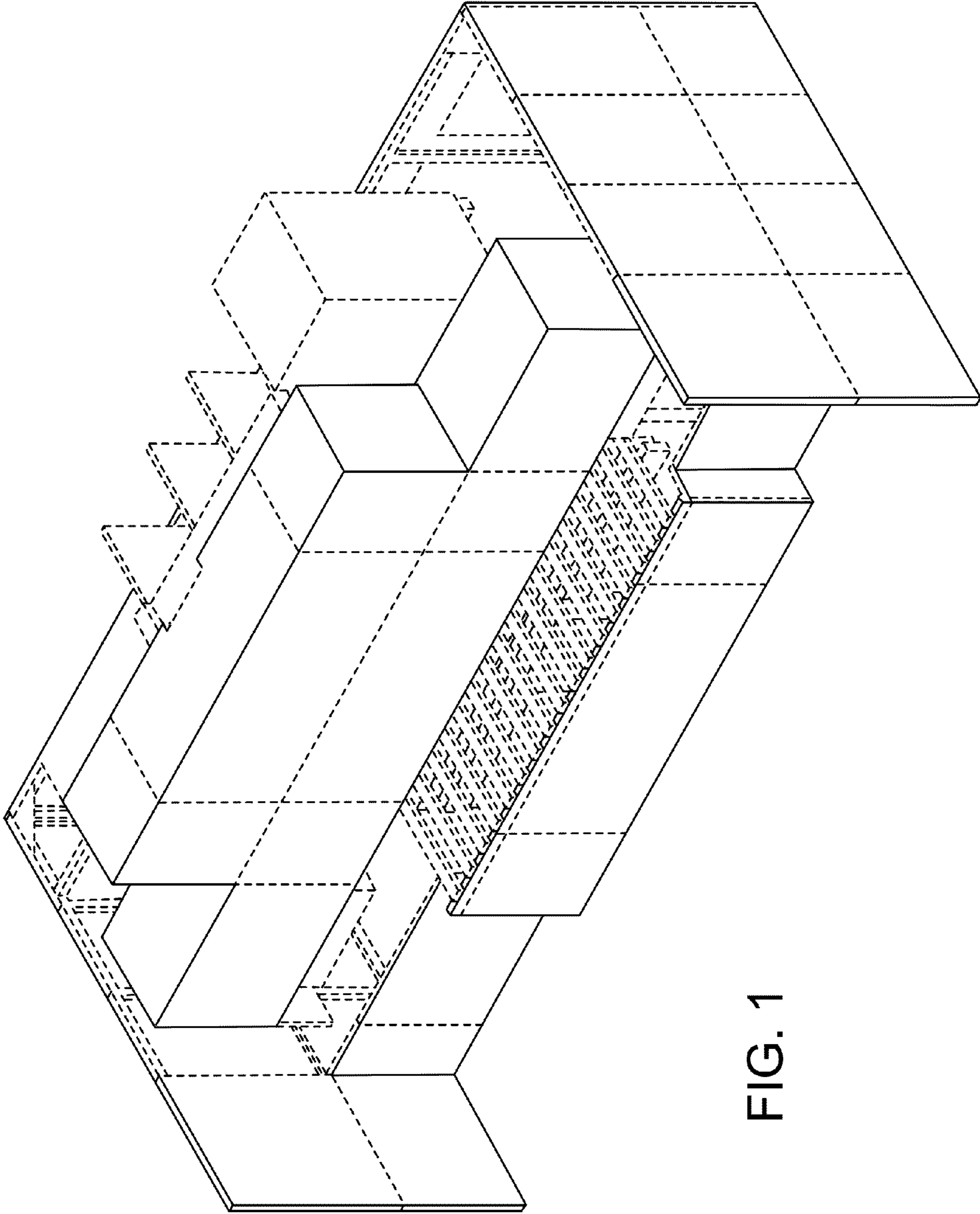

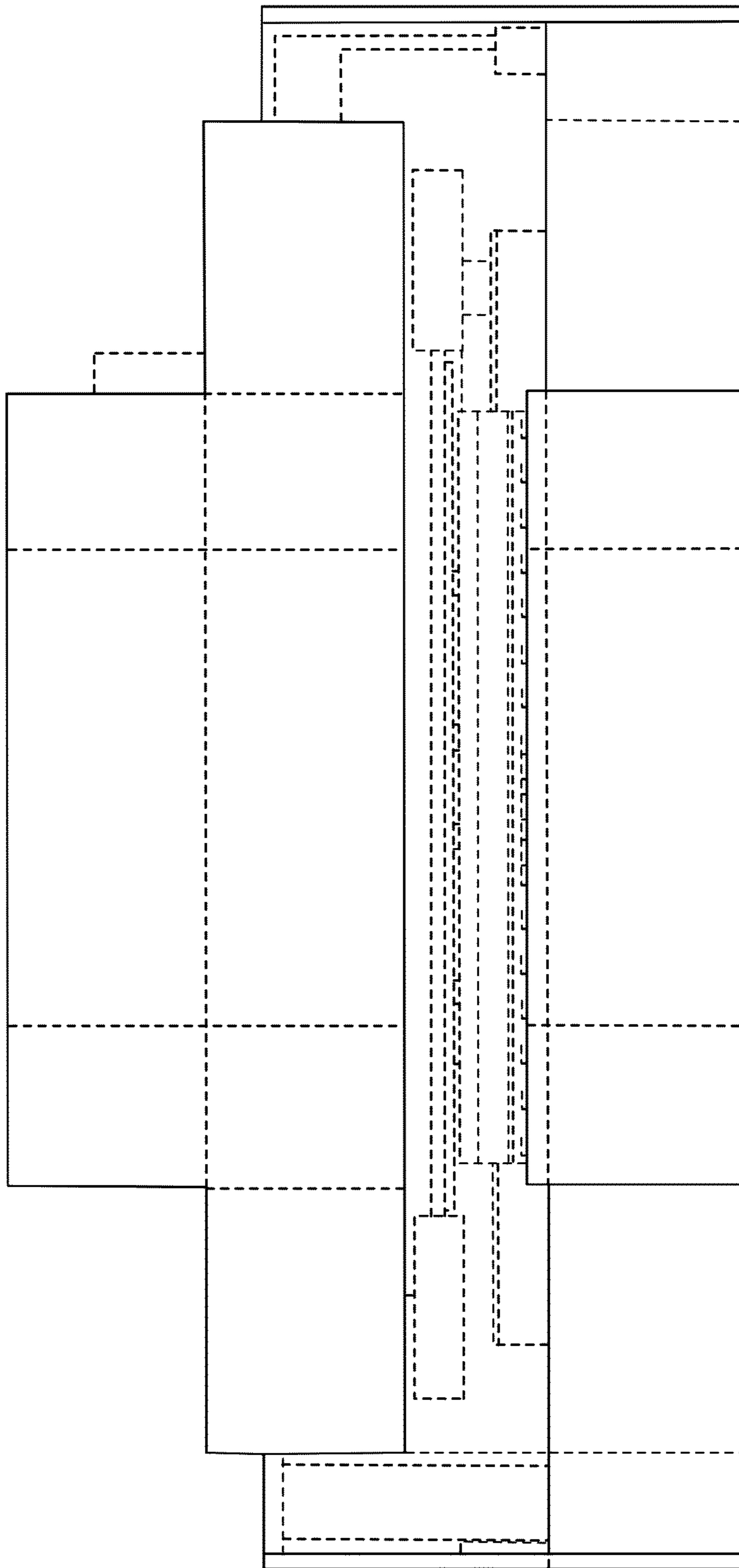

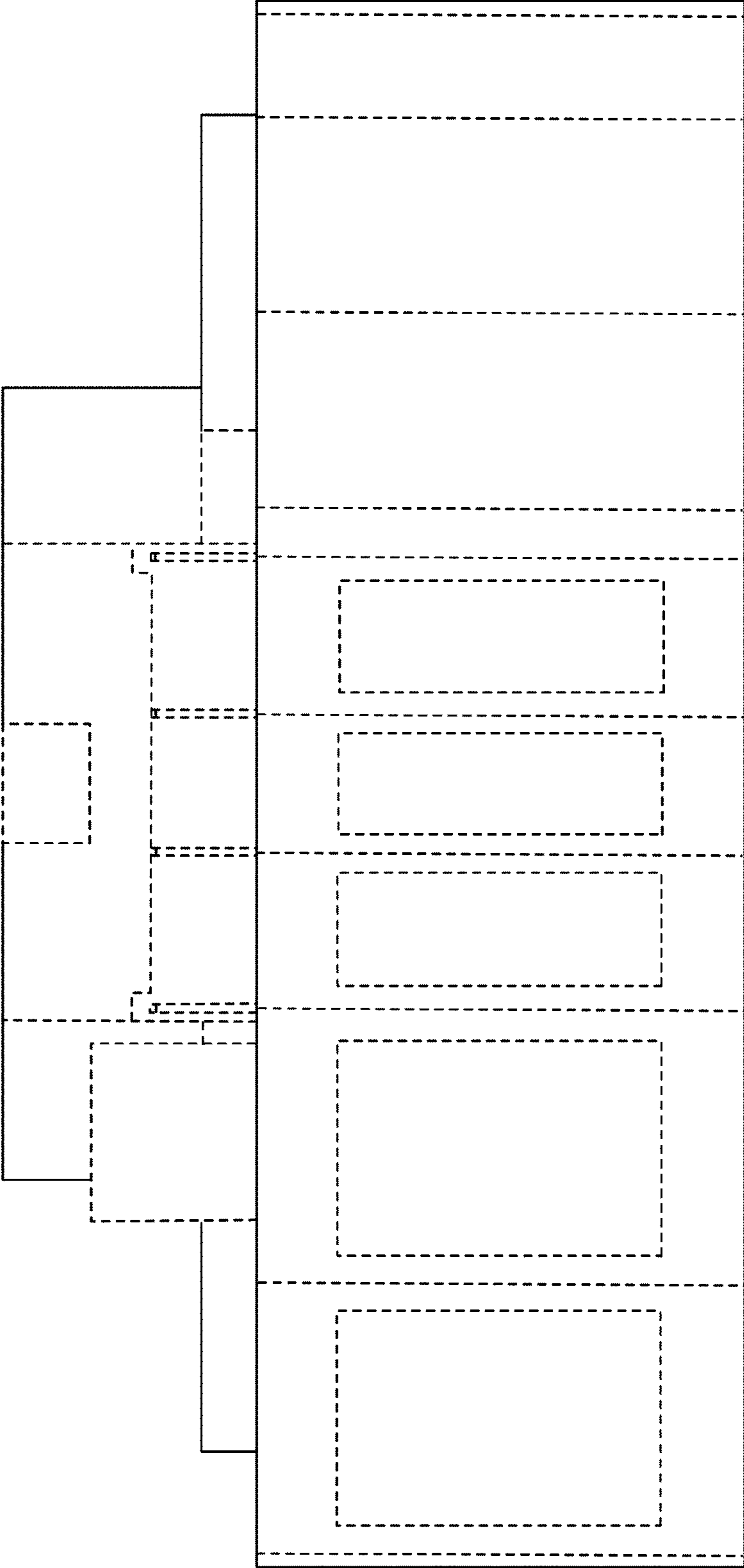

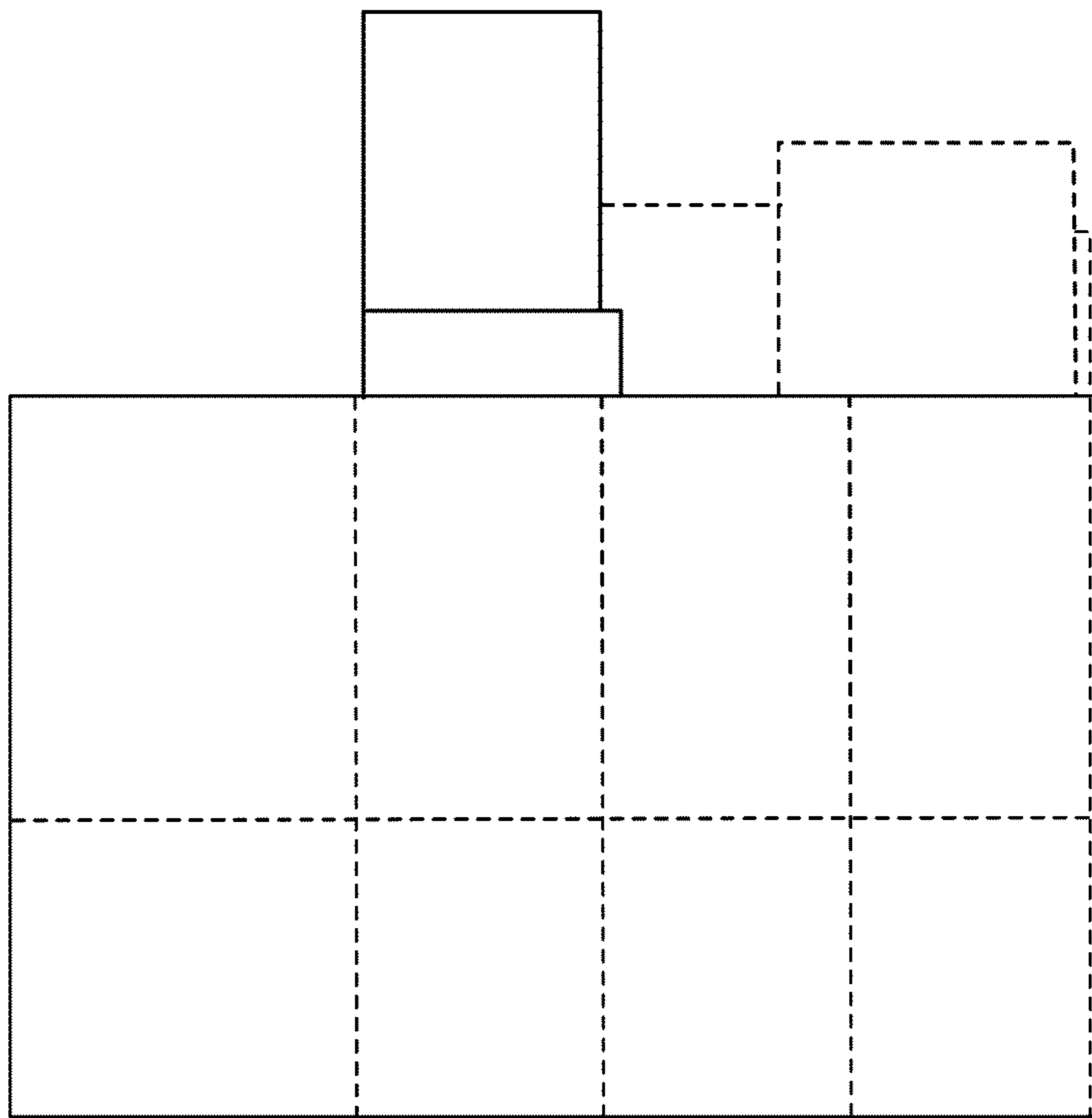

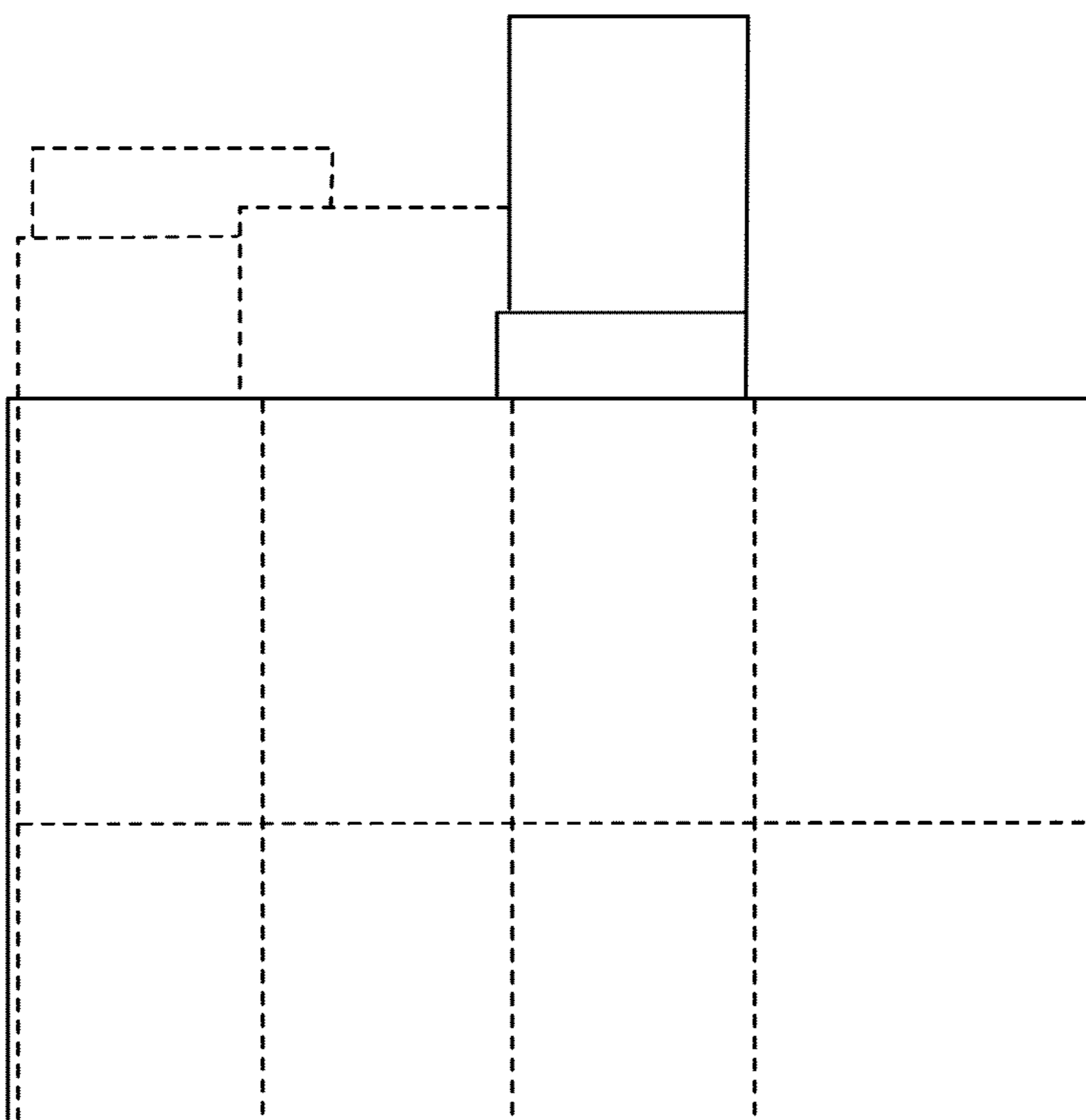

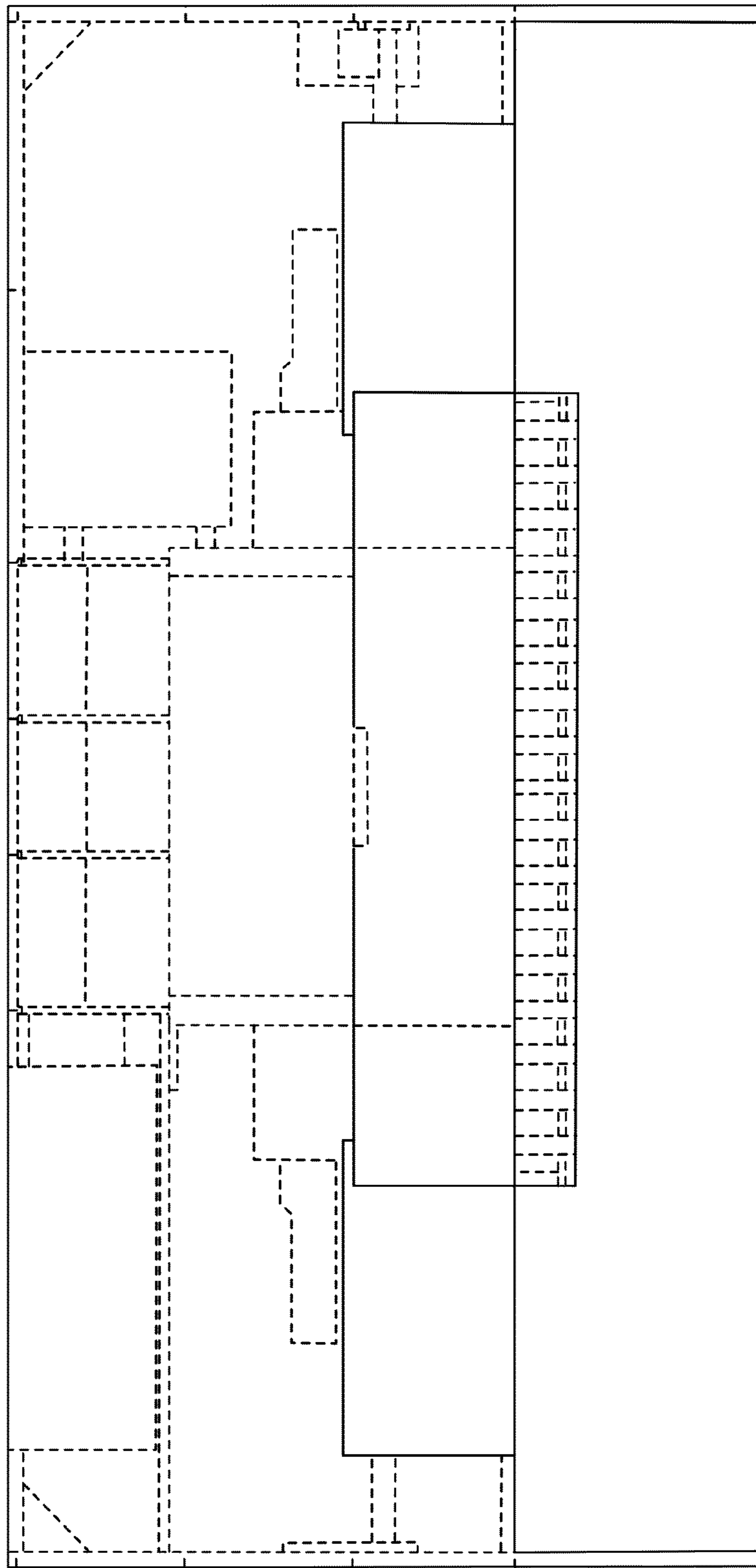

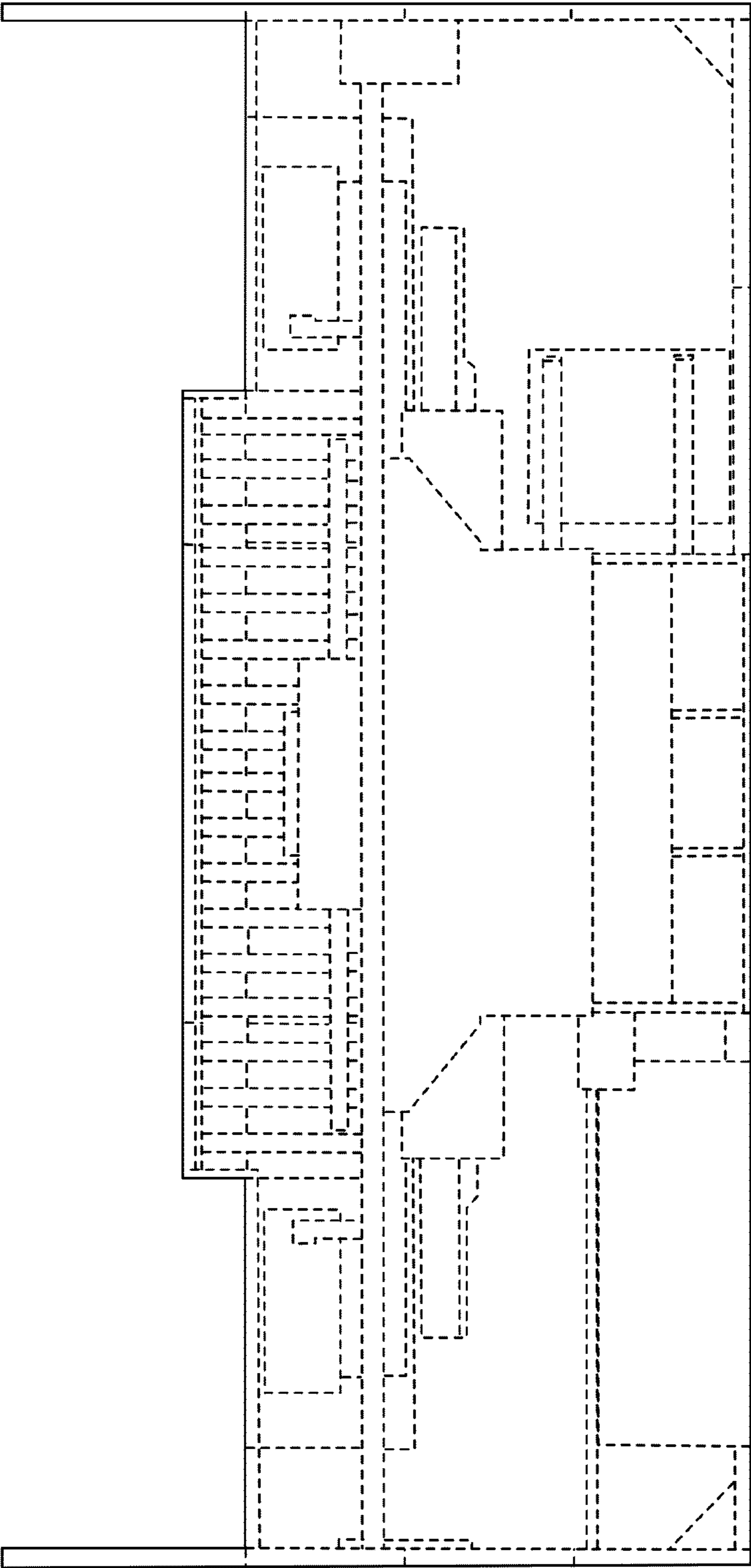
