I claim the ornamental design for eyewear, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of eyewear showing my new design;

FIG. 4 is a top plan view thereof;

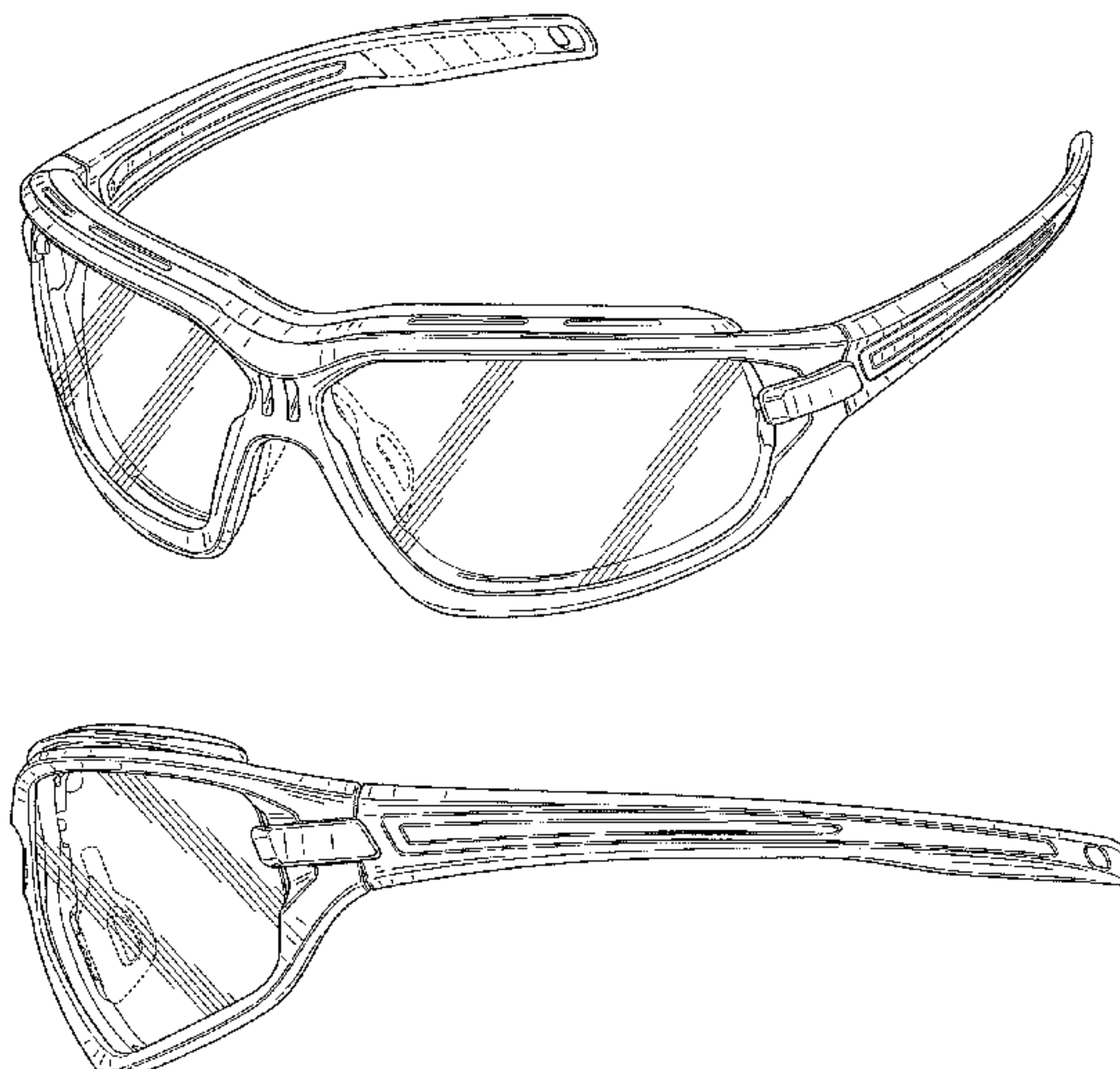
FIG. 5 is a bottom plan view thereof;

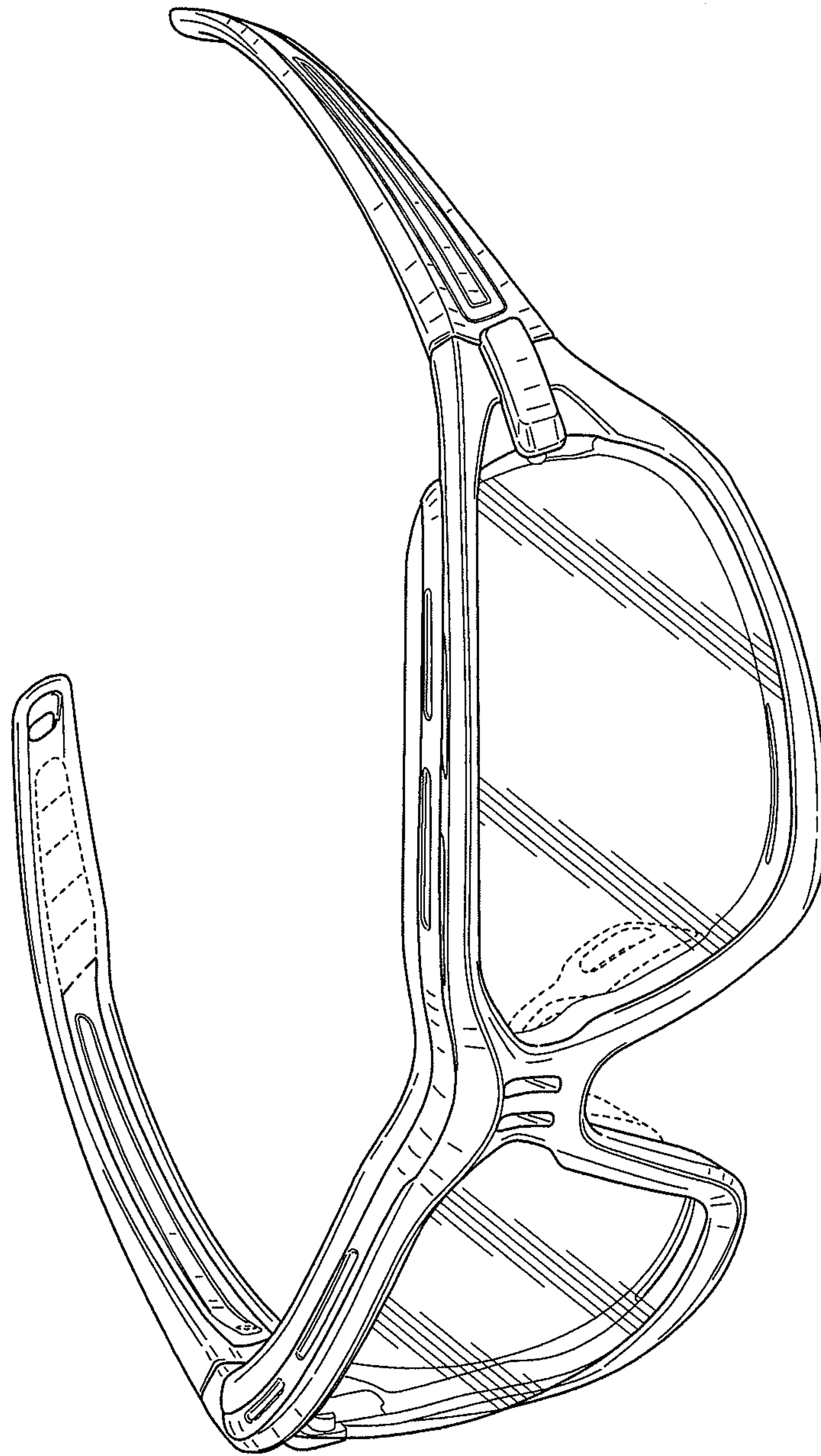

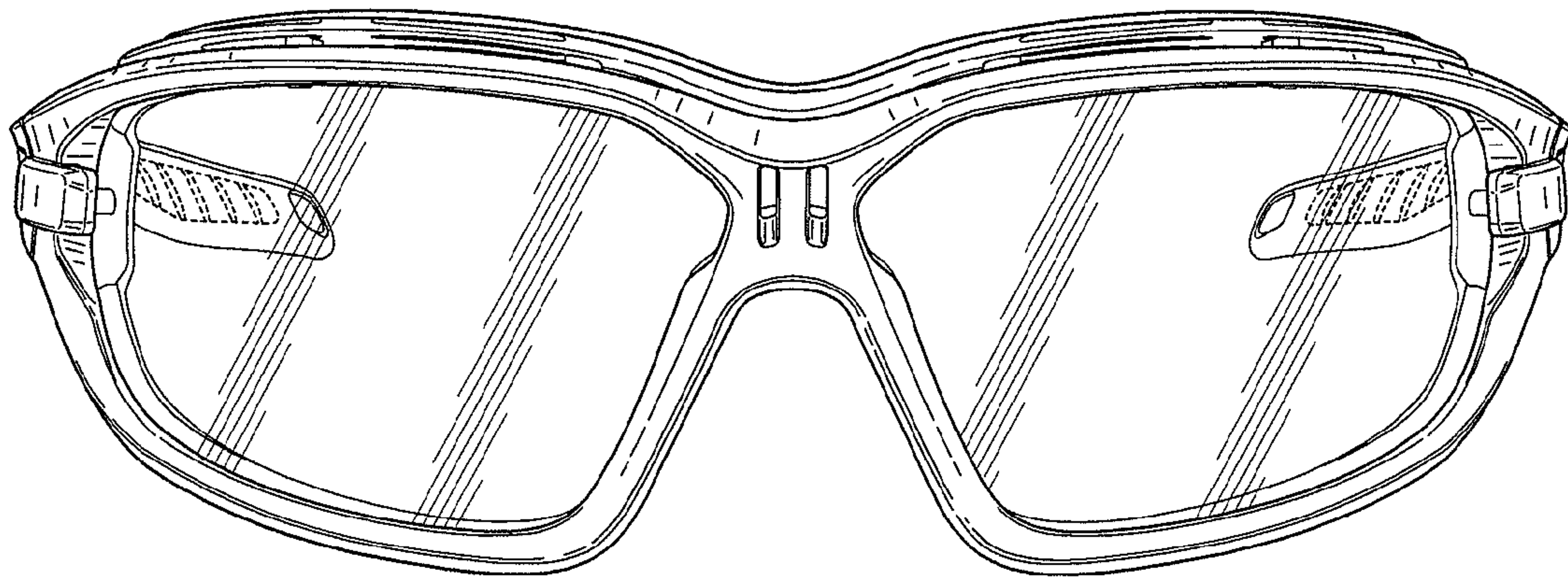

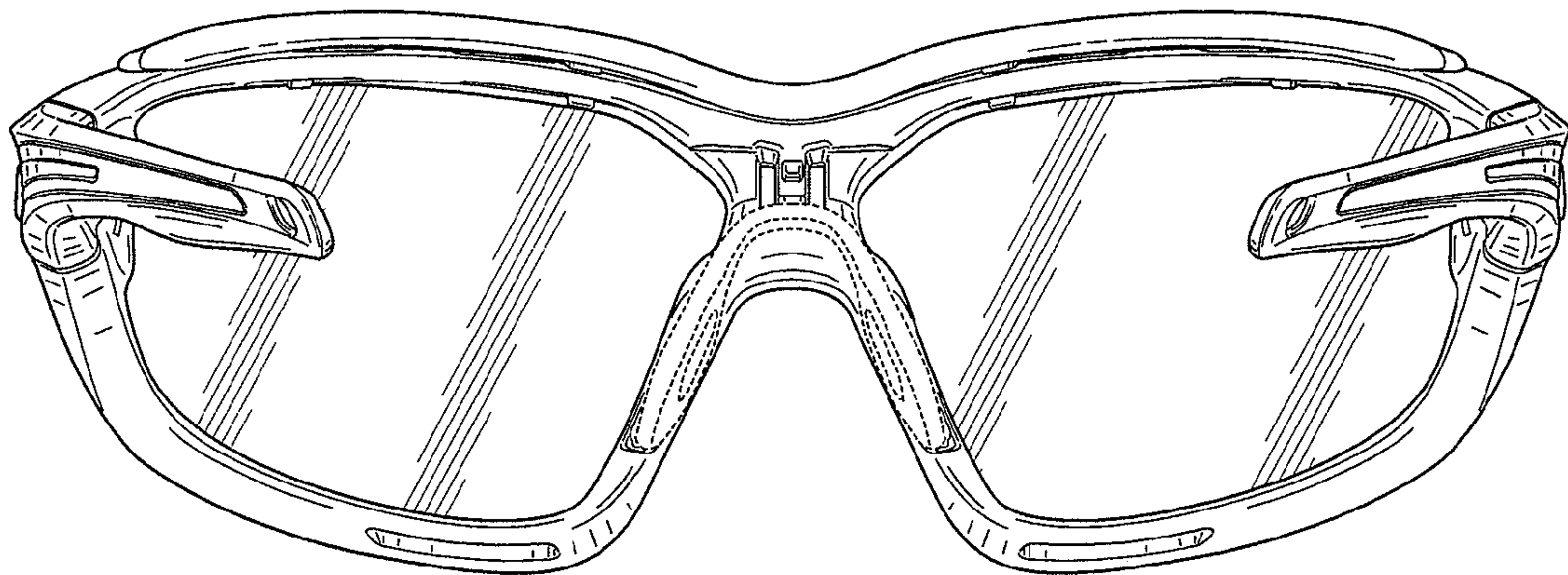

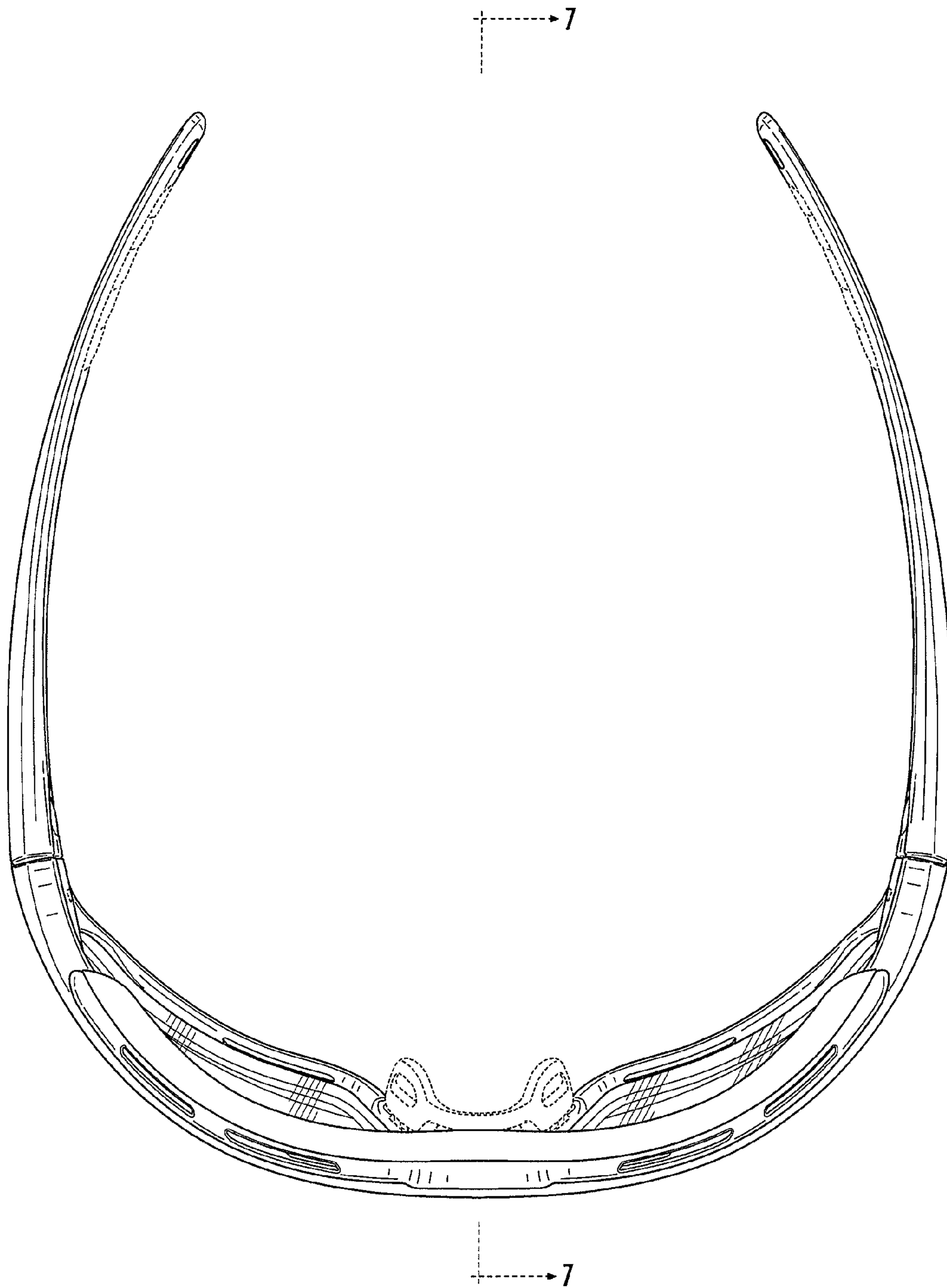

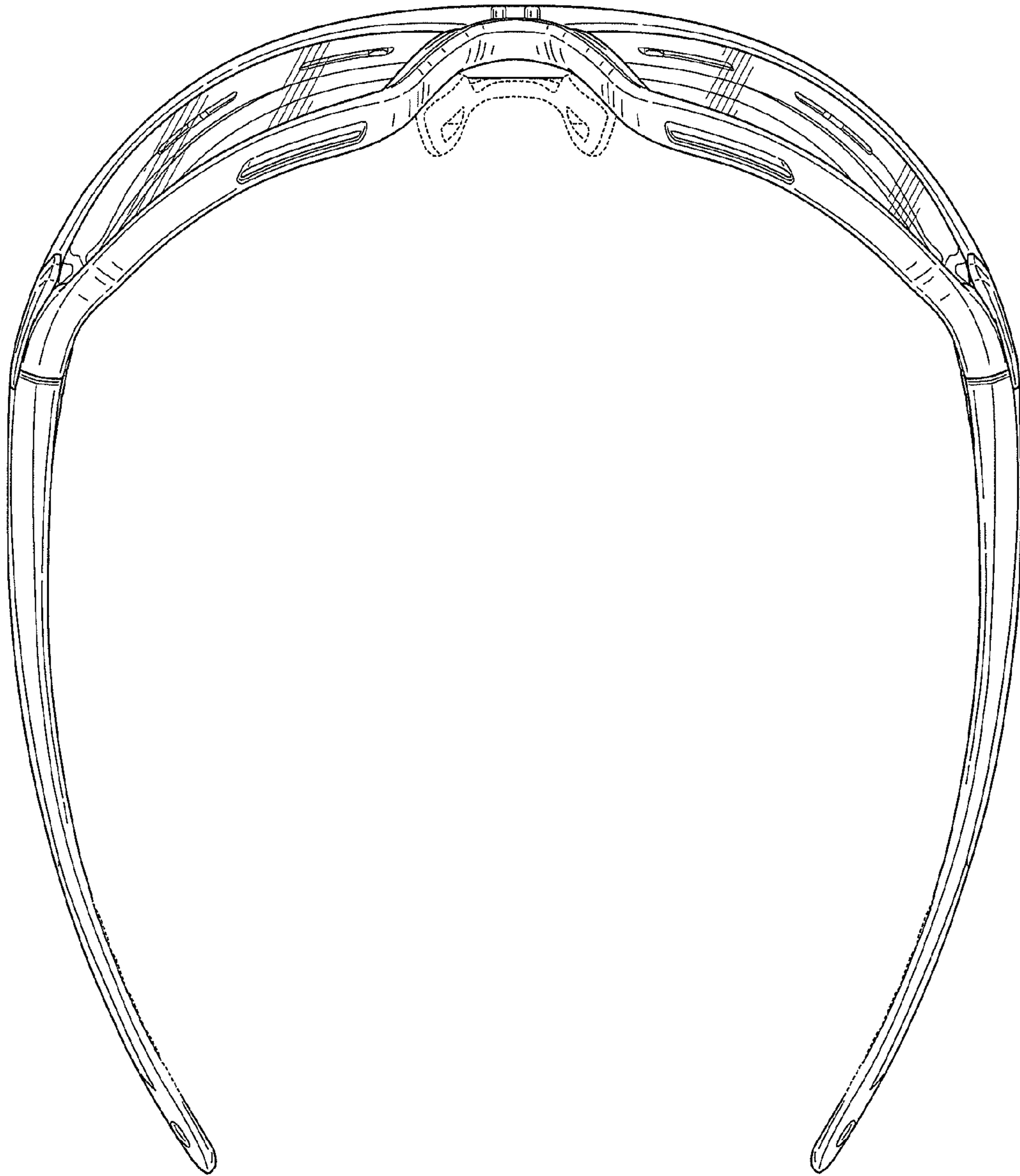

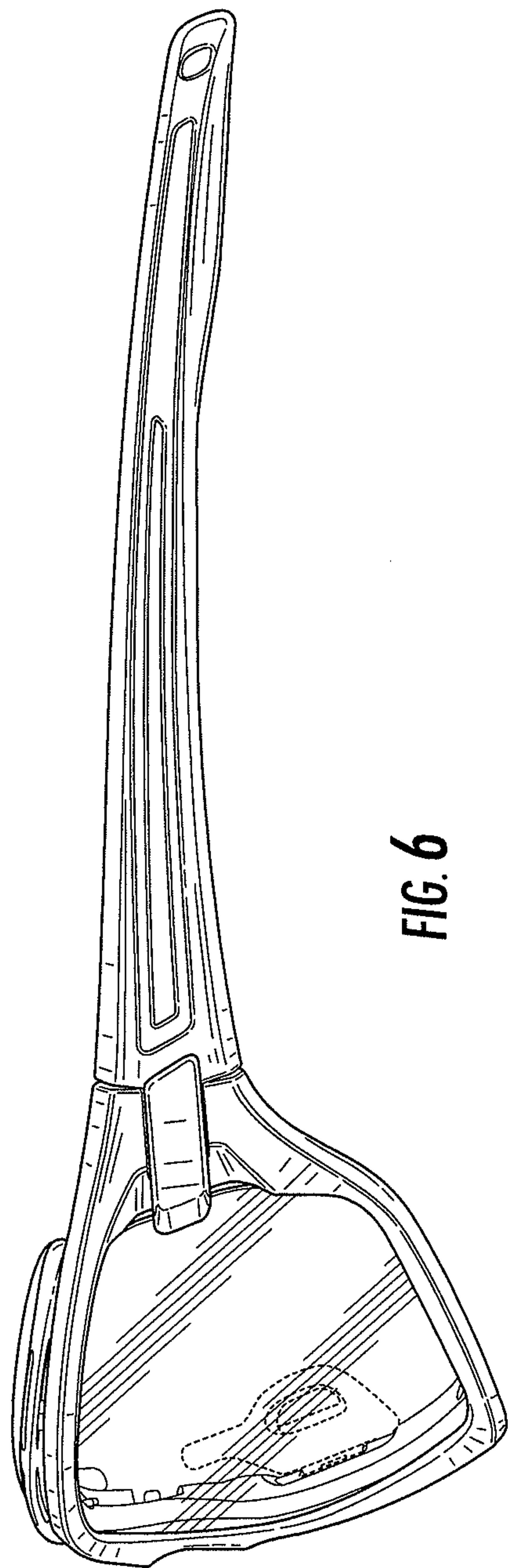

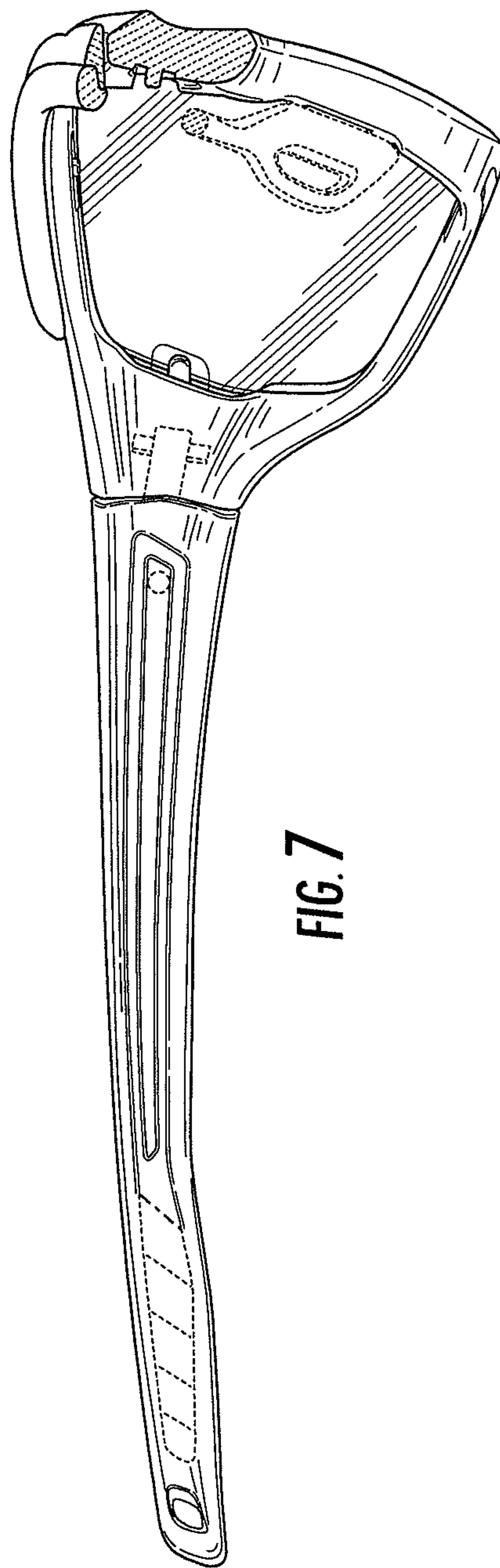
