We claim, the ornamental design for a toner cartridge, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a toner cartridge showing our new design;

FIG. 11 is an enlarged view of portion 11 encircled in FIG. 2;
FIG. 12 is an enlarged view of portion 12 encircled in FIG. 2;

FIG. 13 is an enlarged view of portion 12 encircled in FIG. 2.

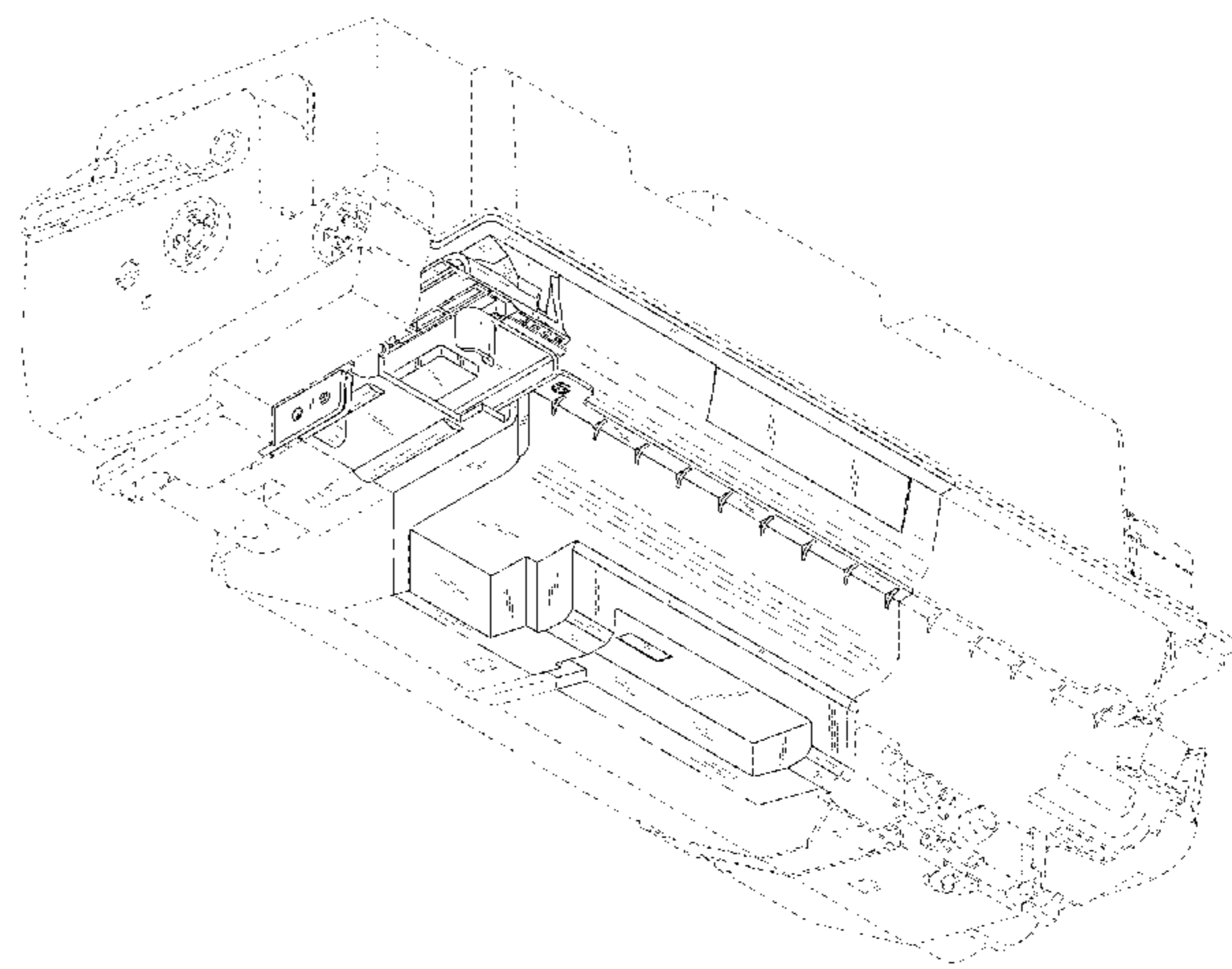
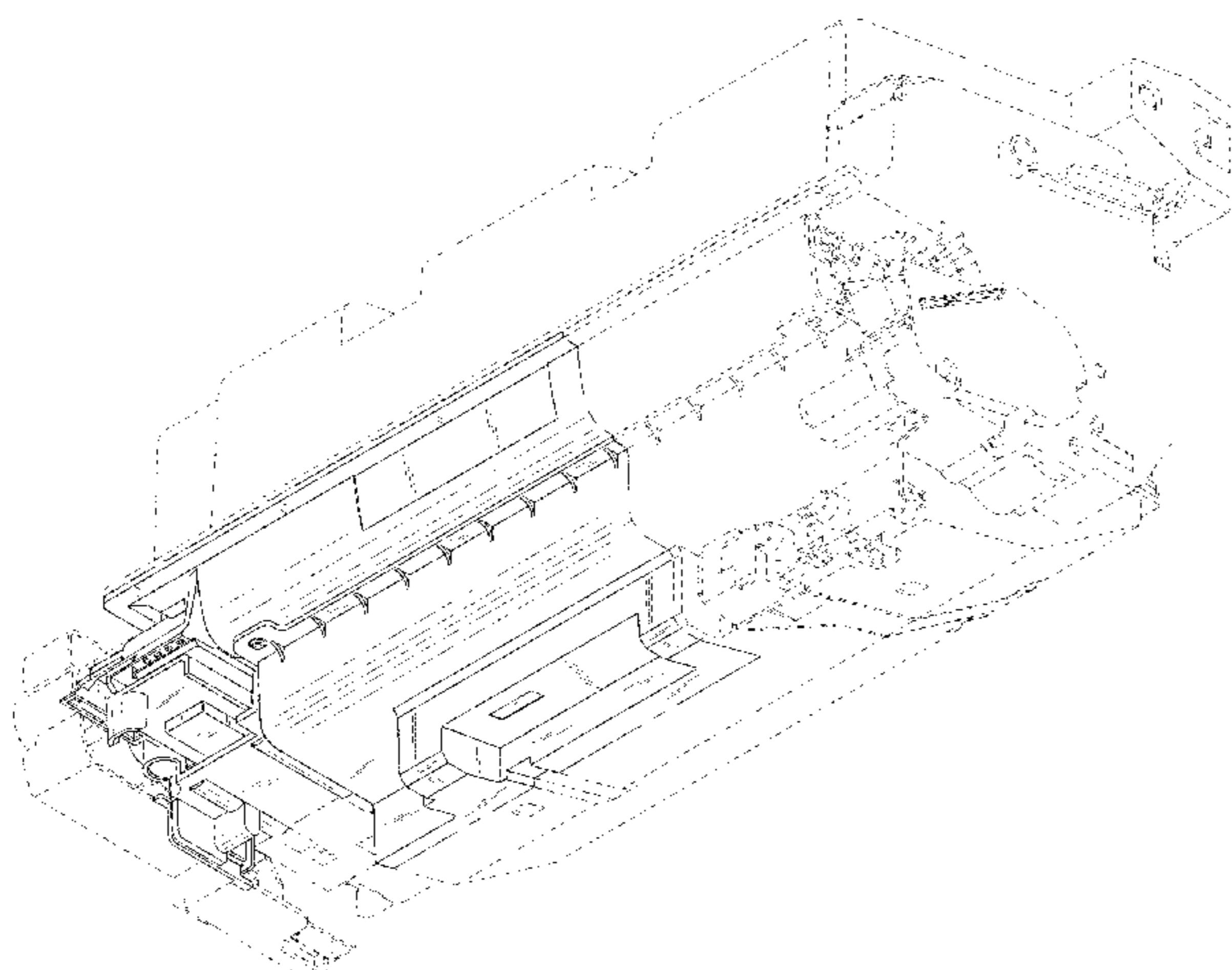

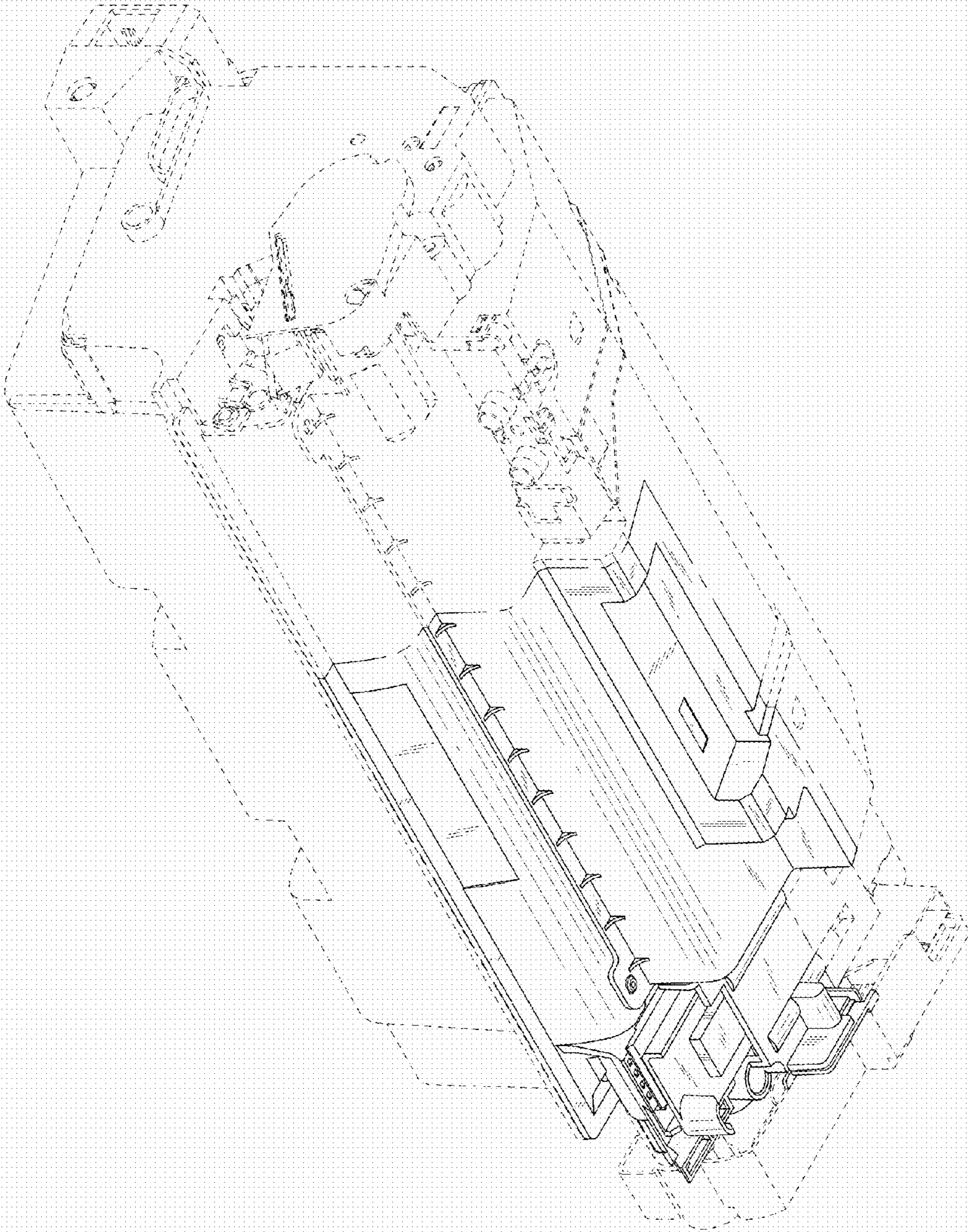

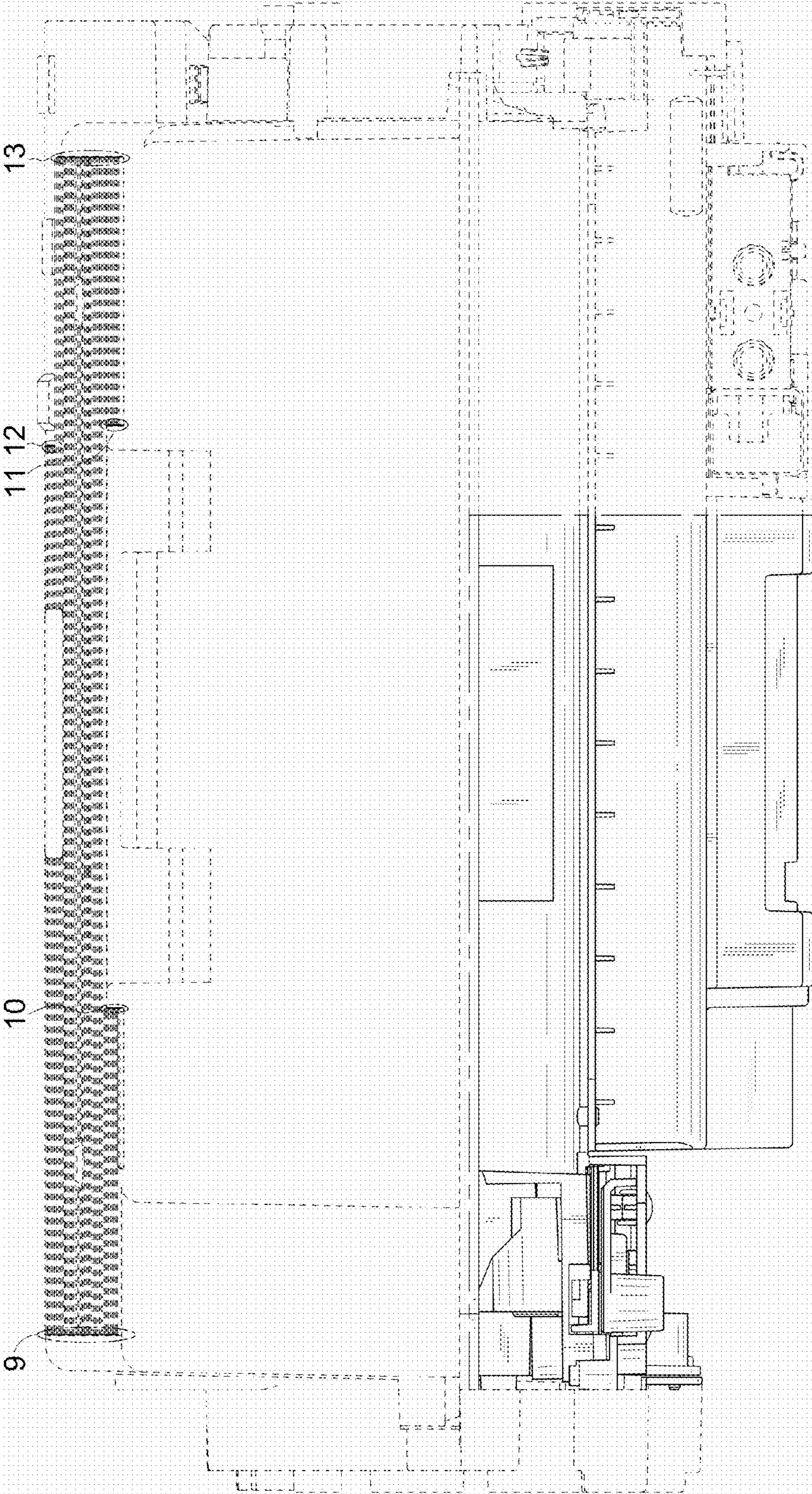

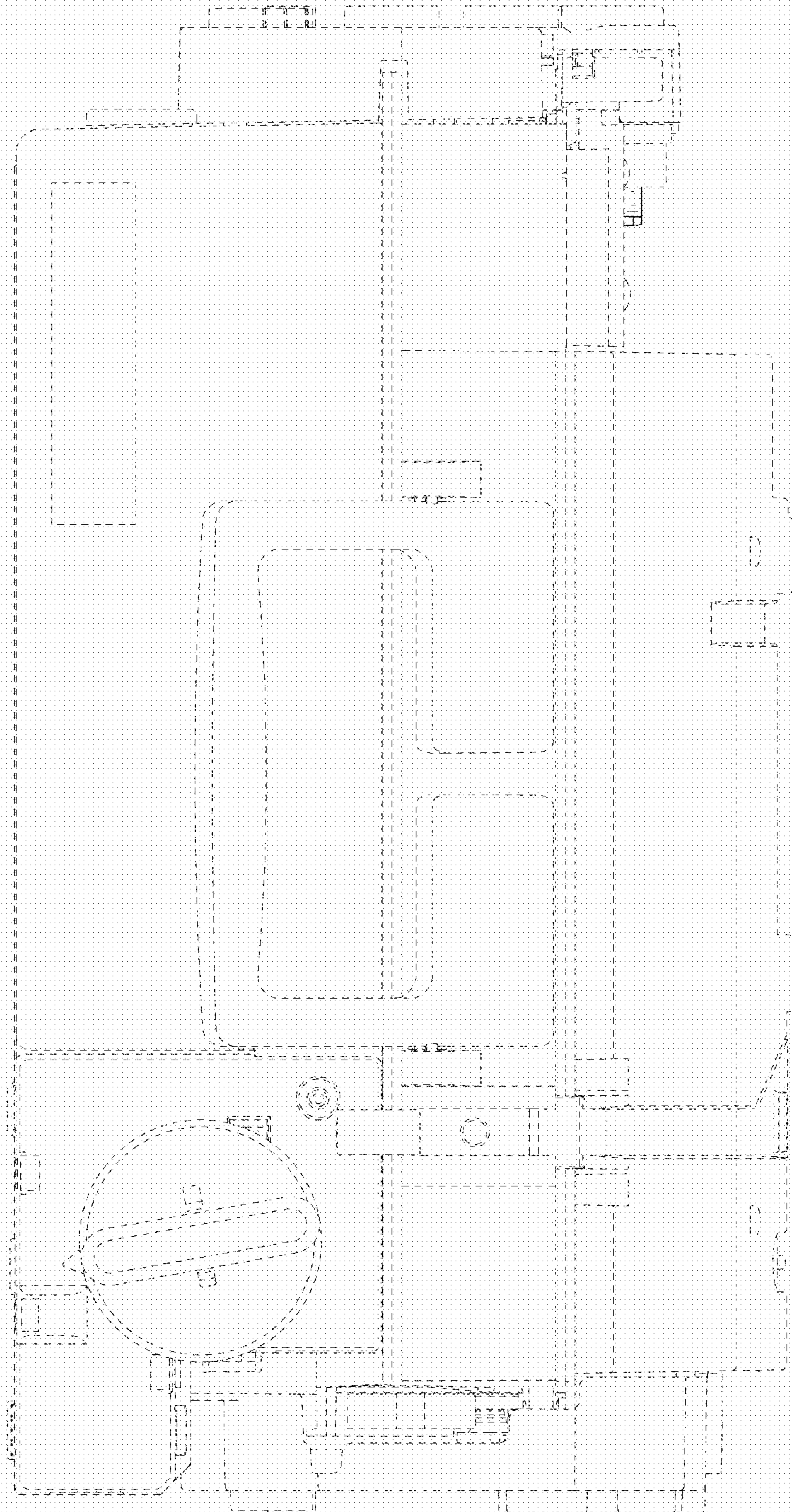

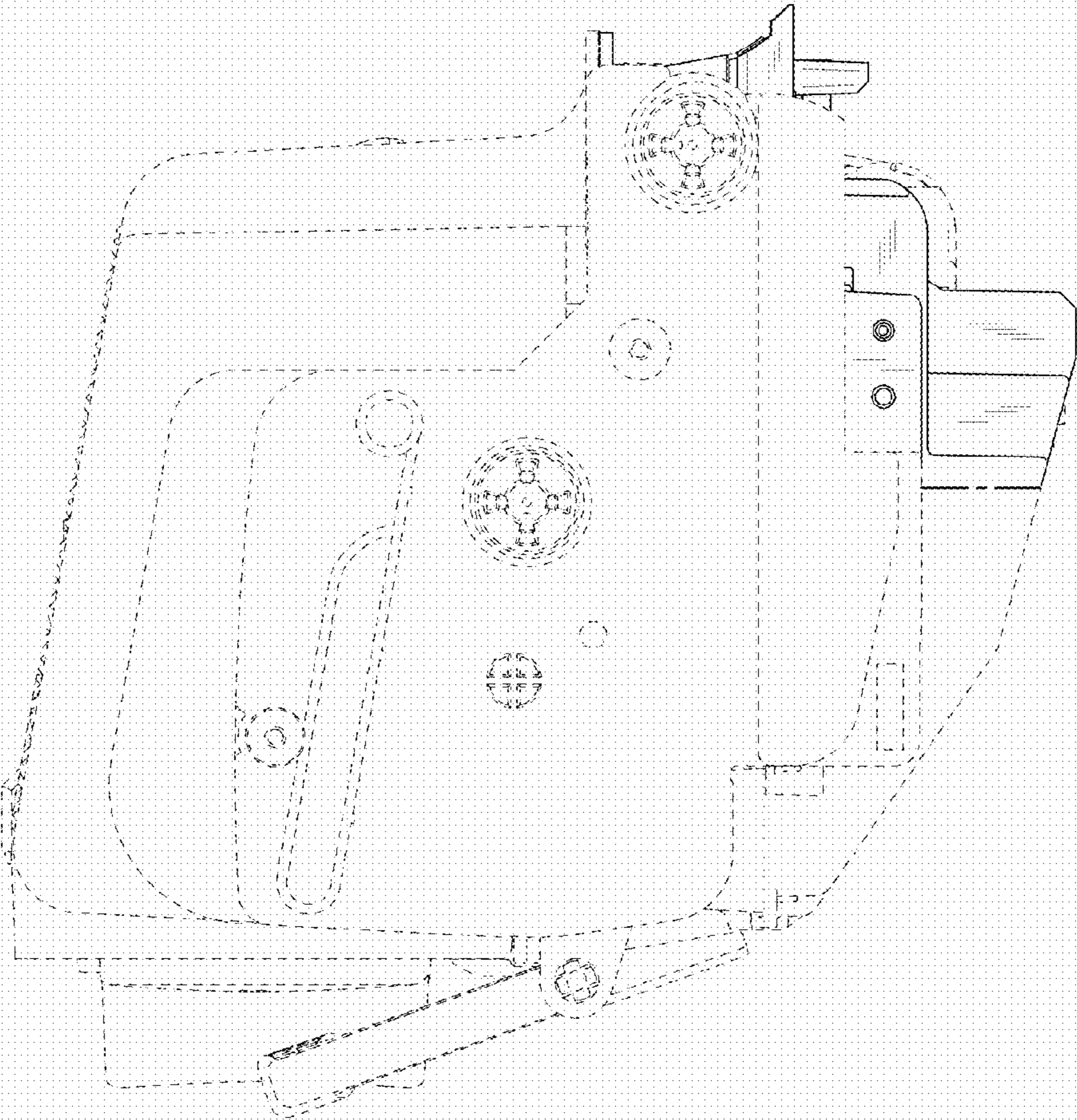

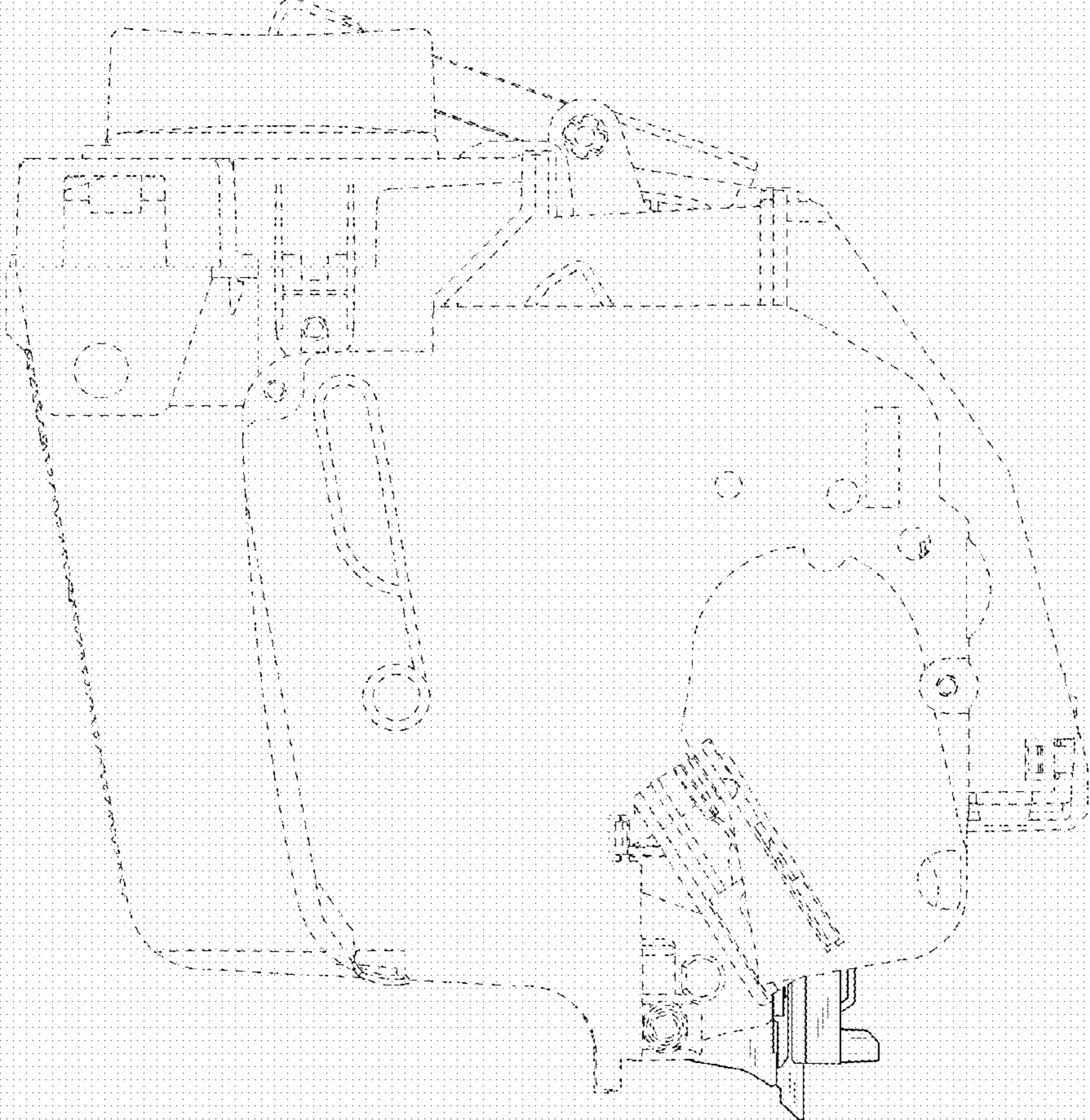

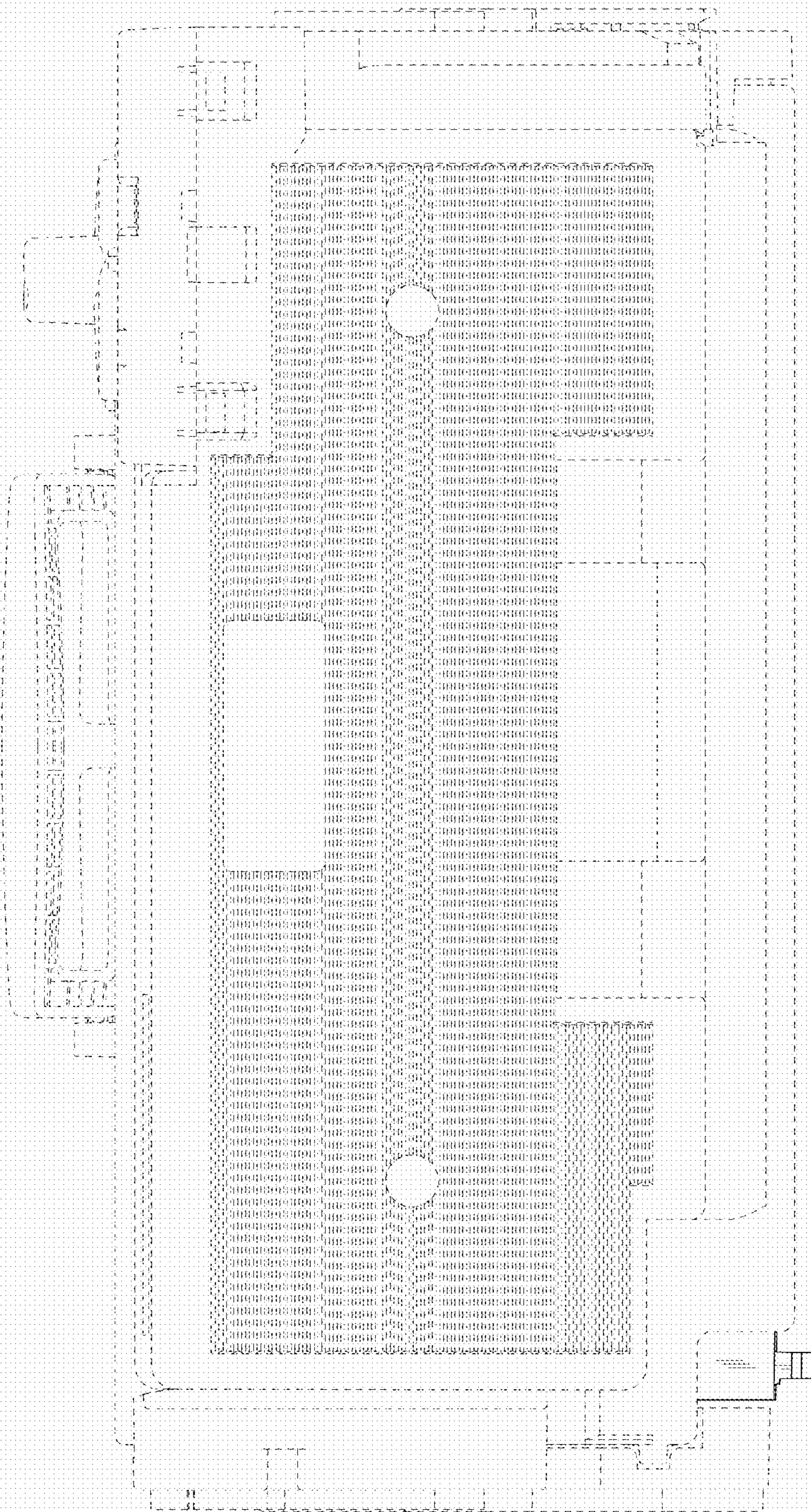

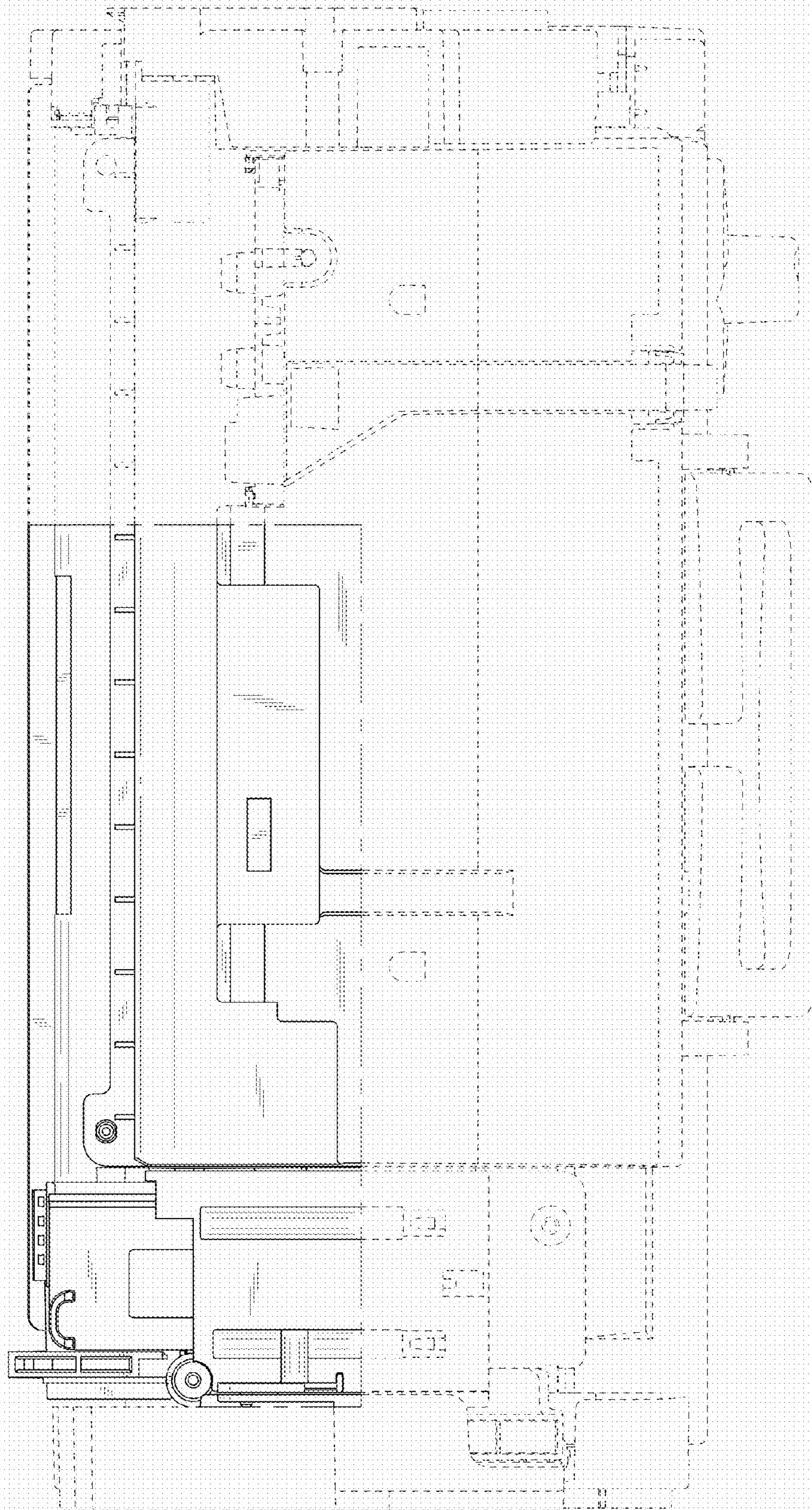

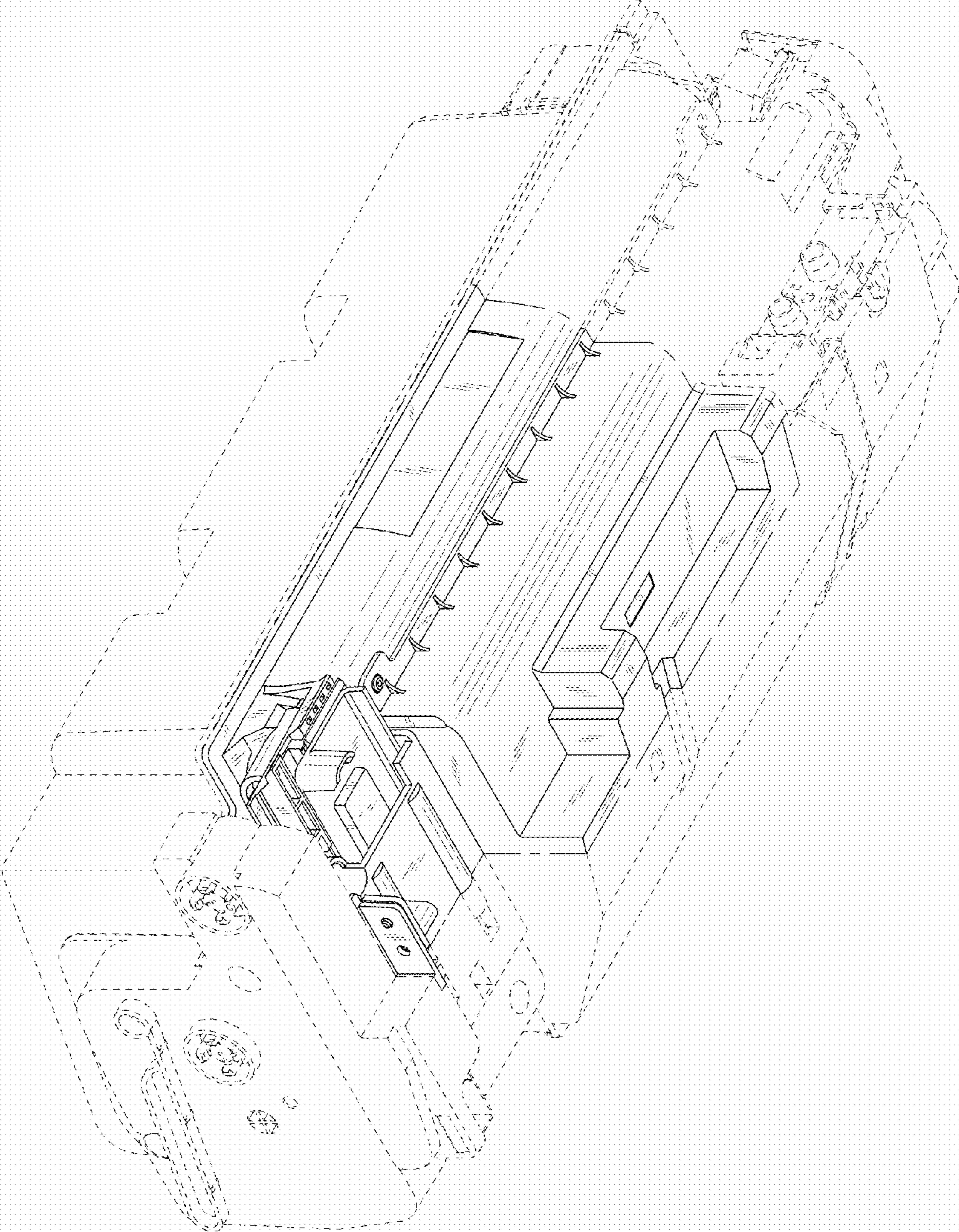

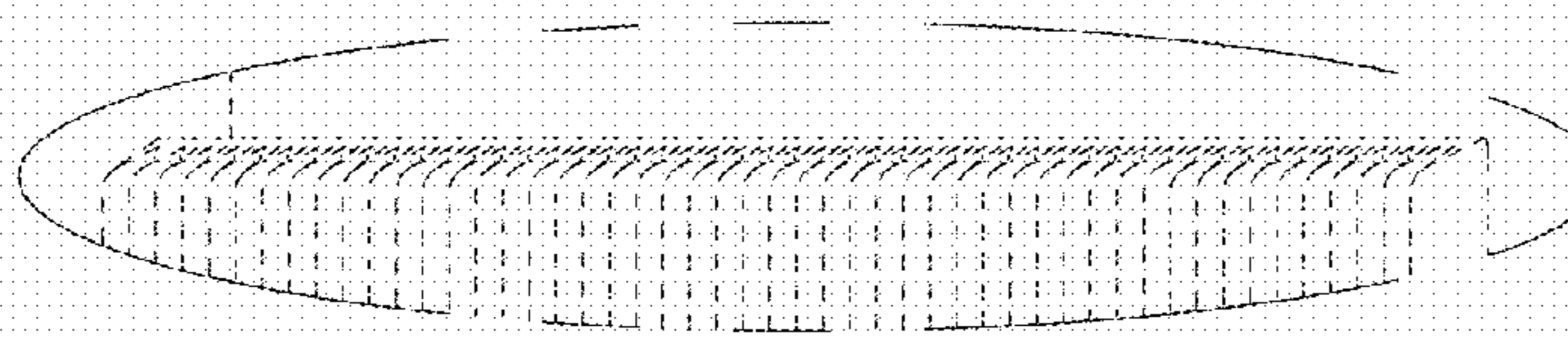

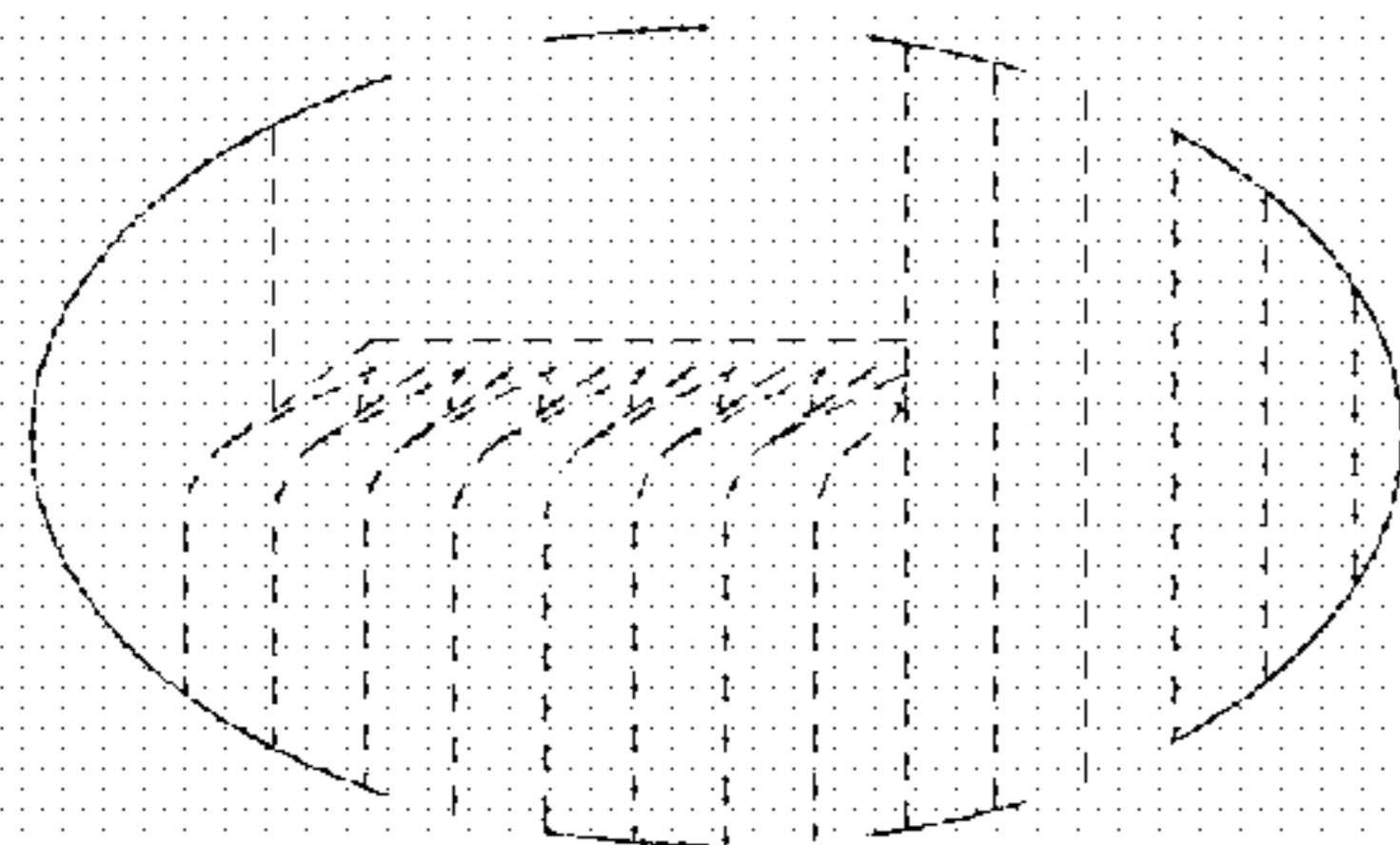

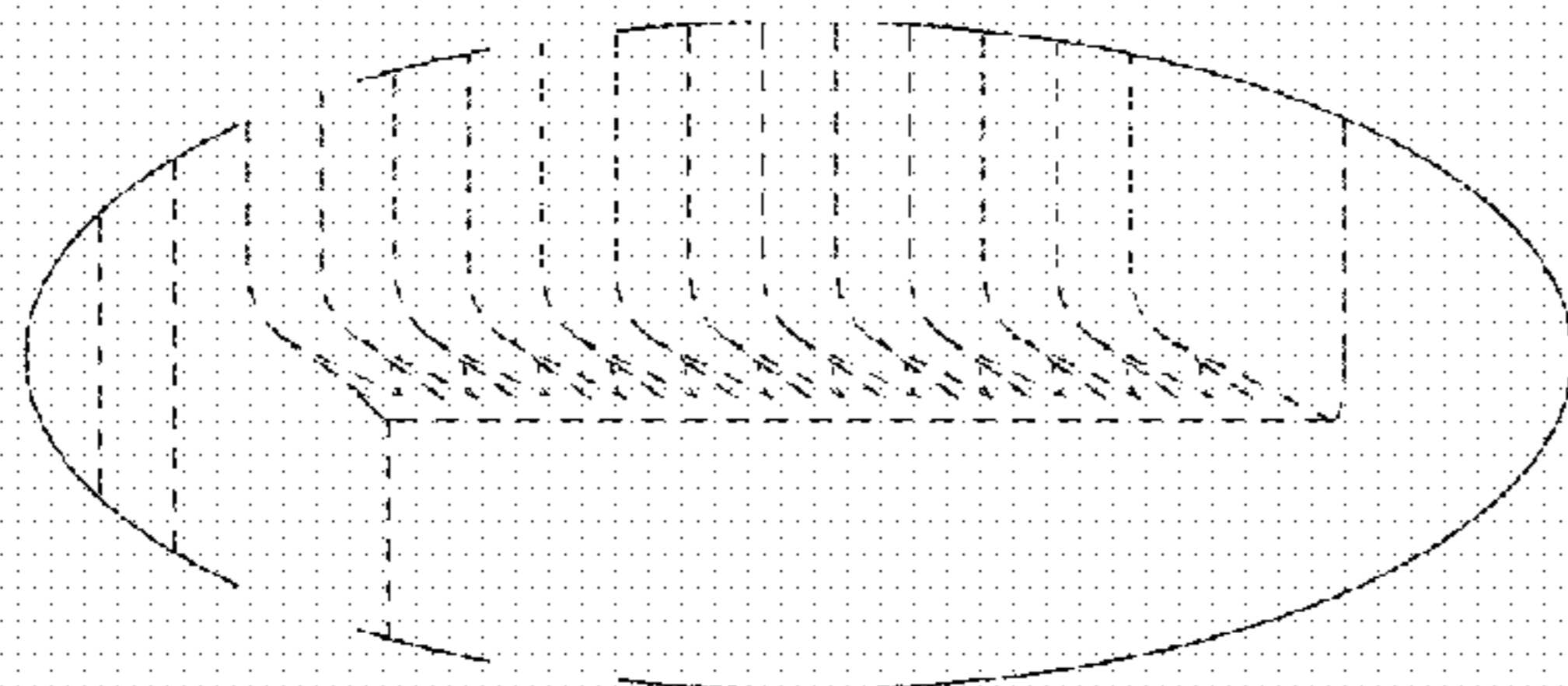
