**DESCRIPTION**

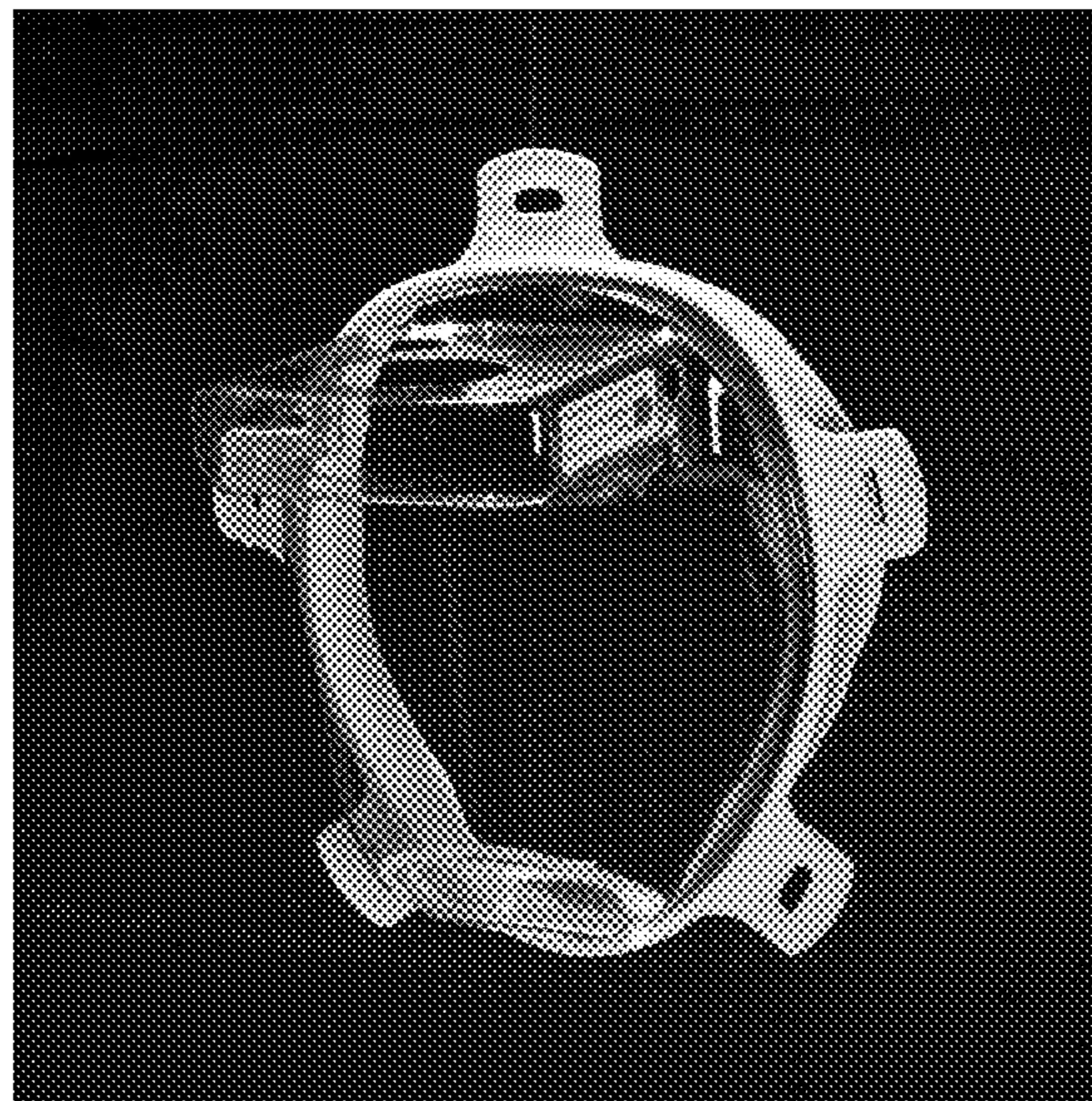

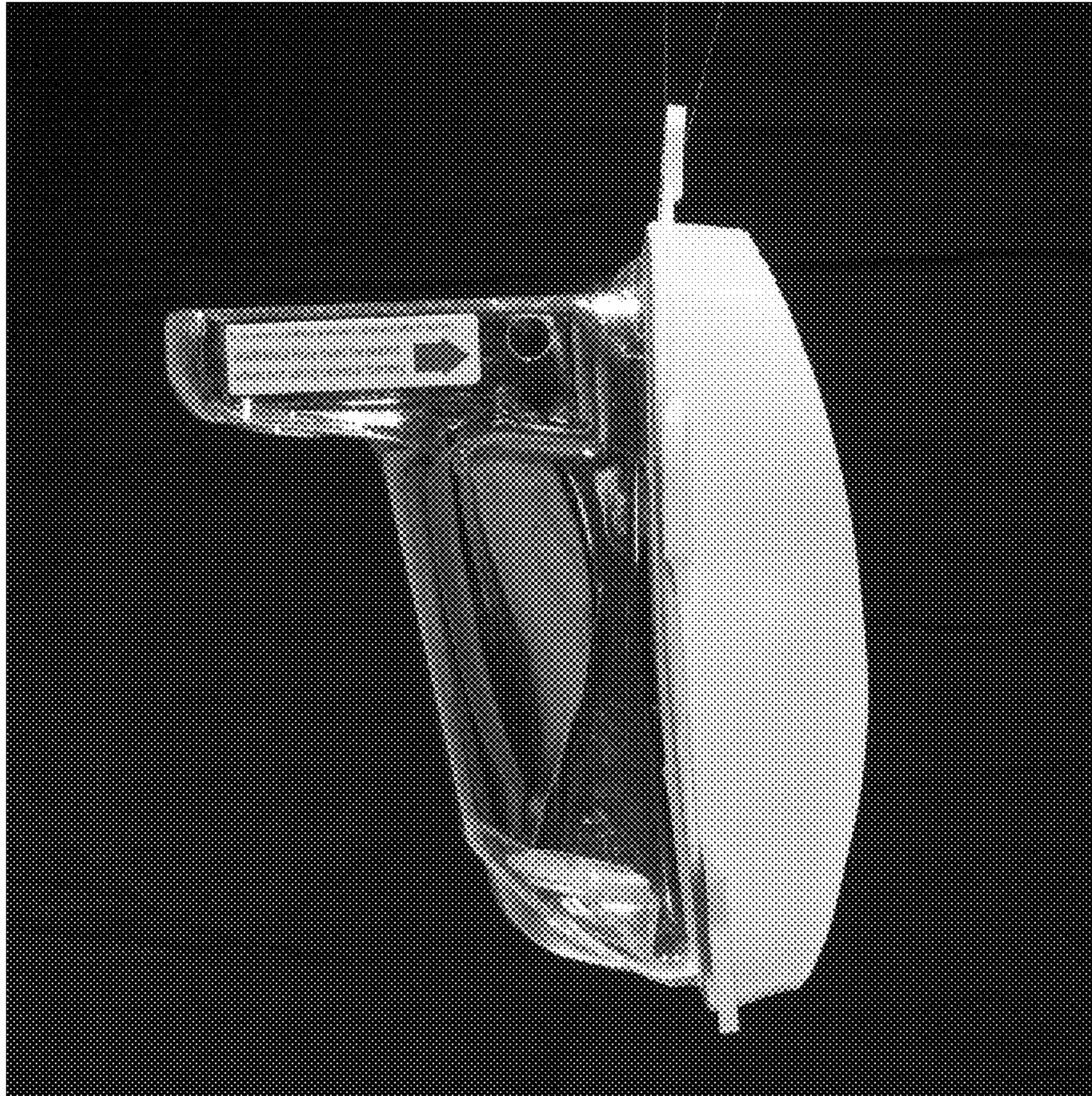

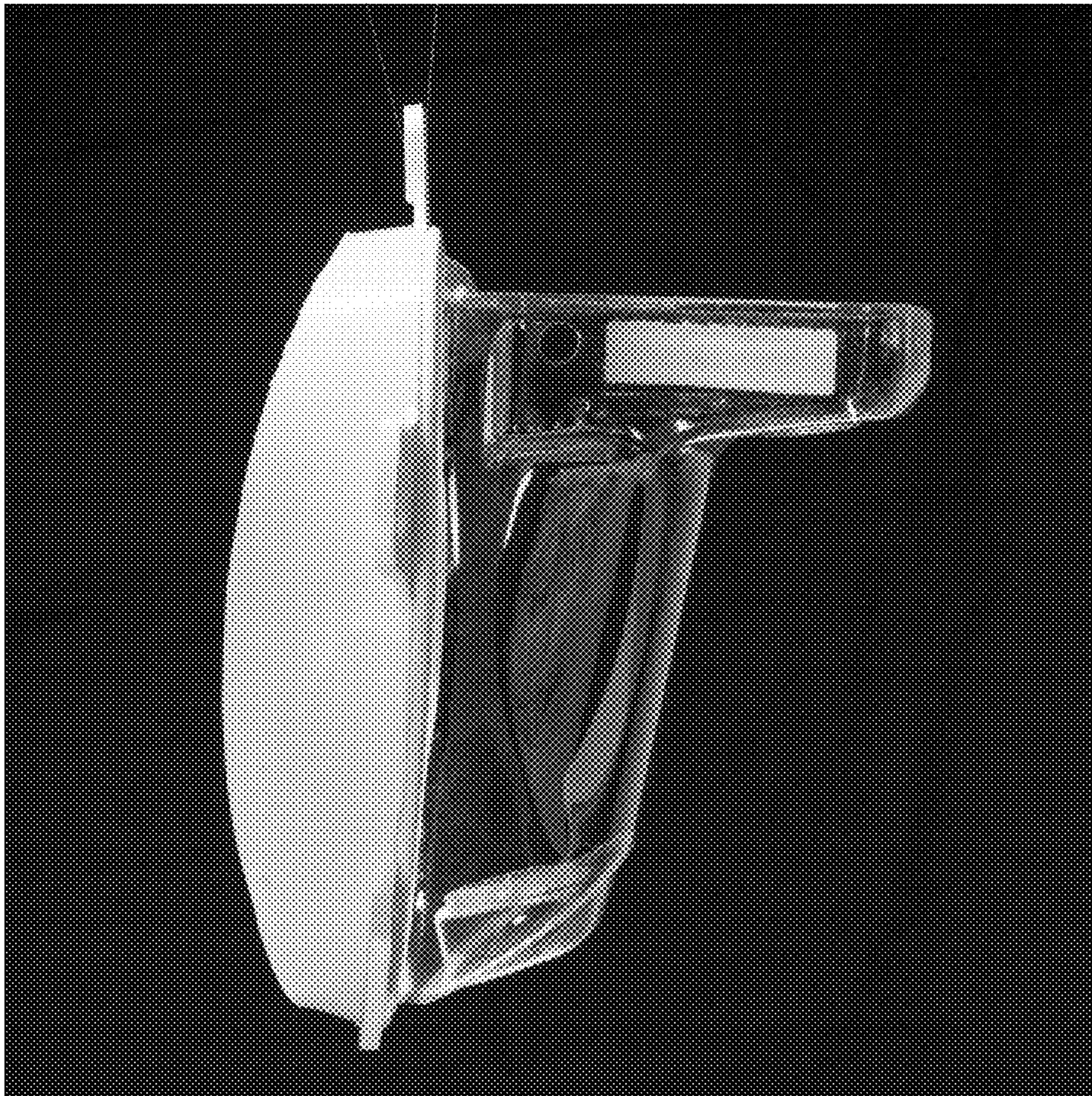

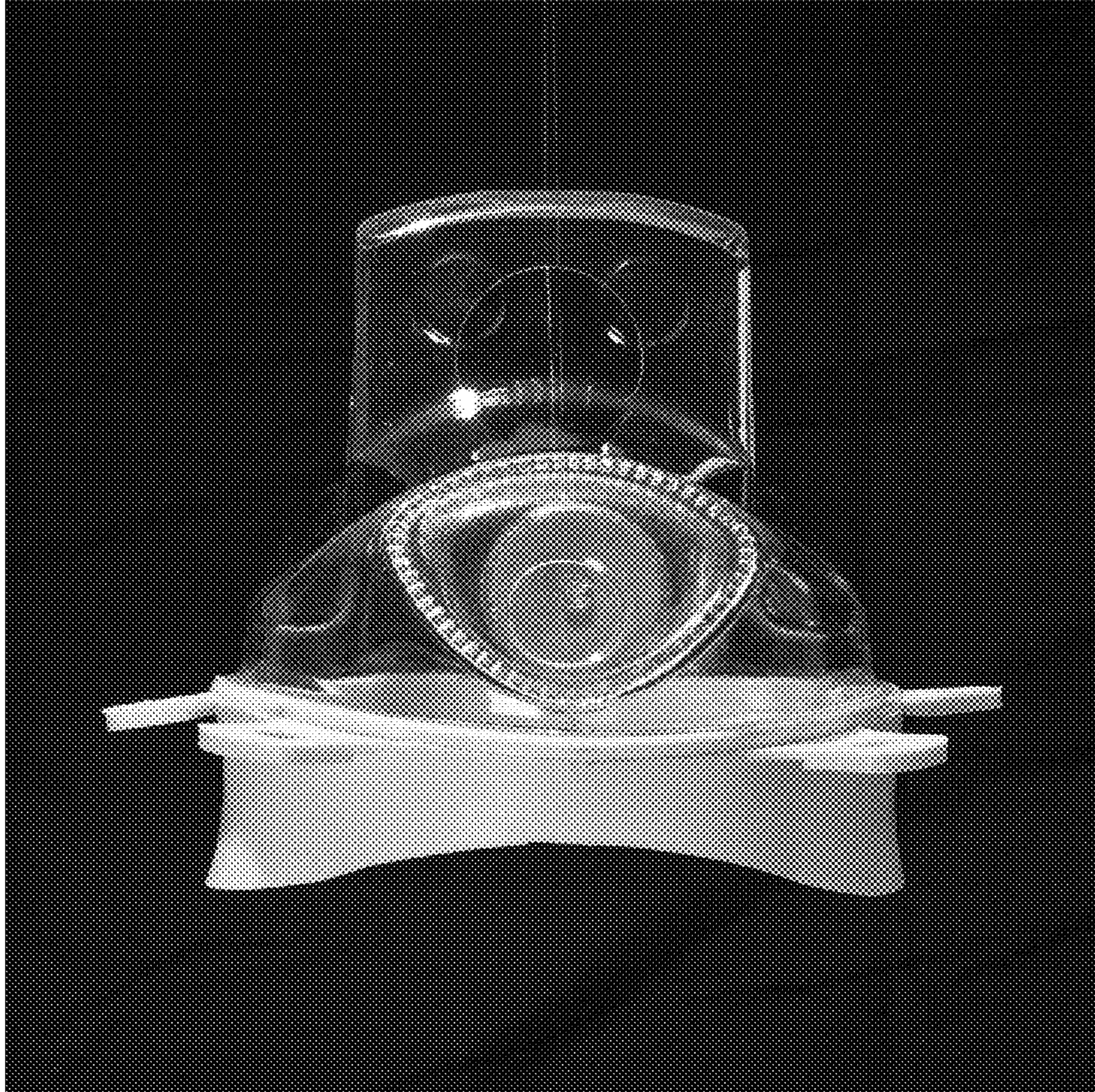

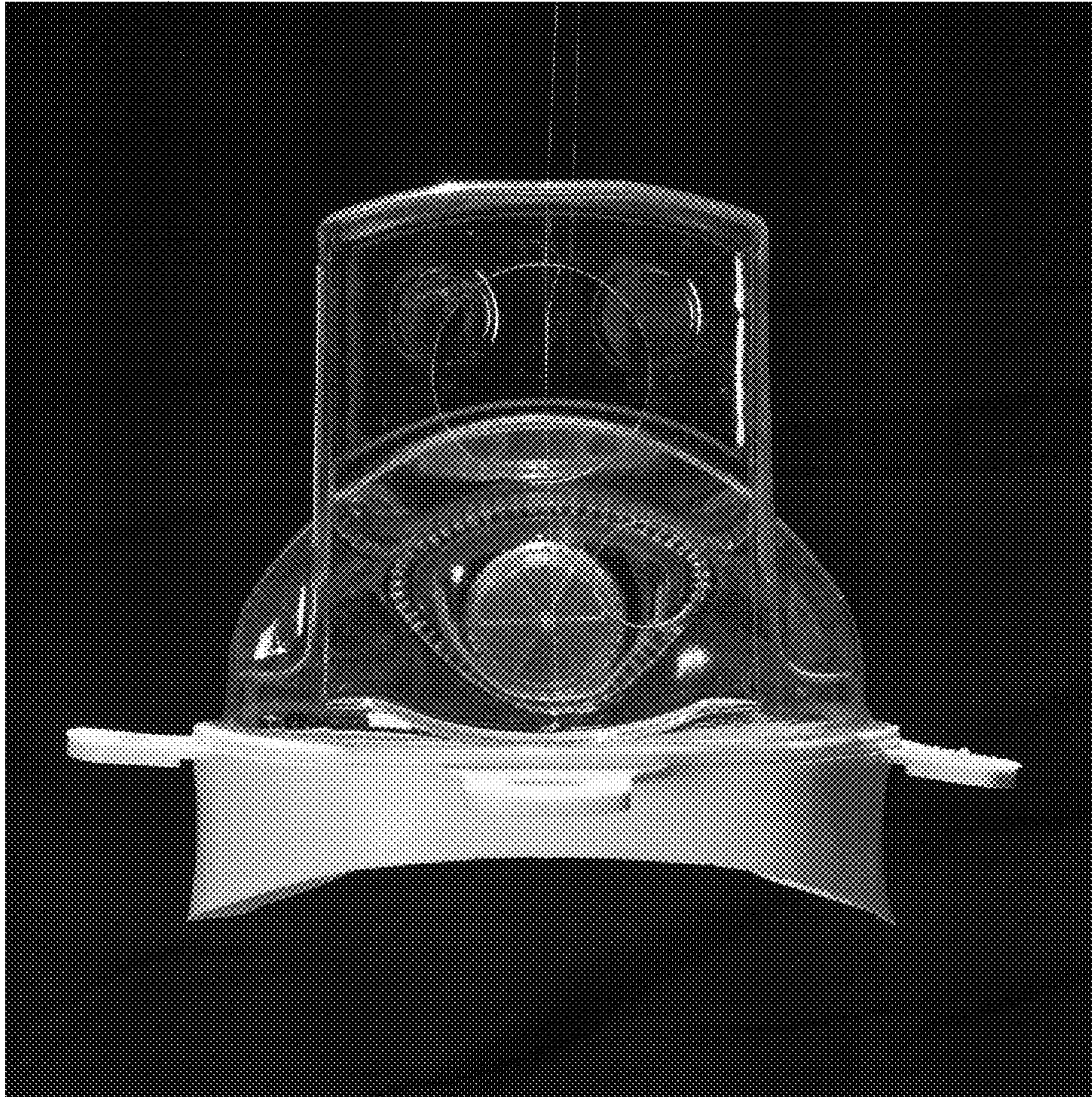
